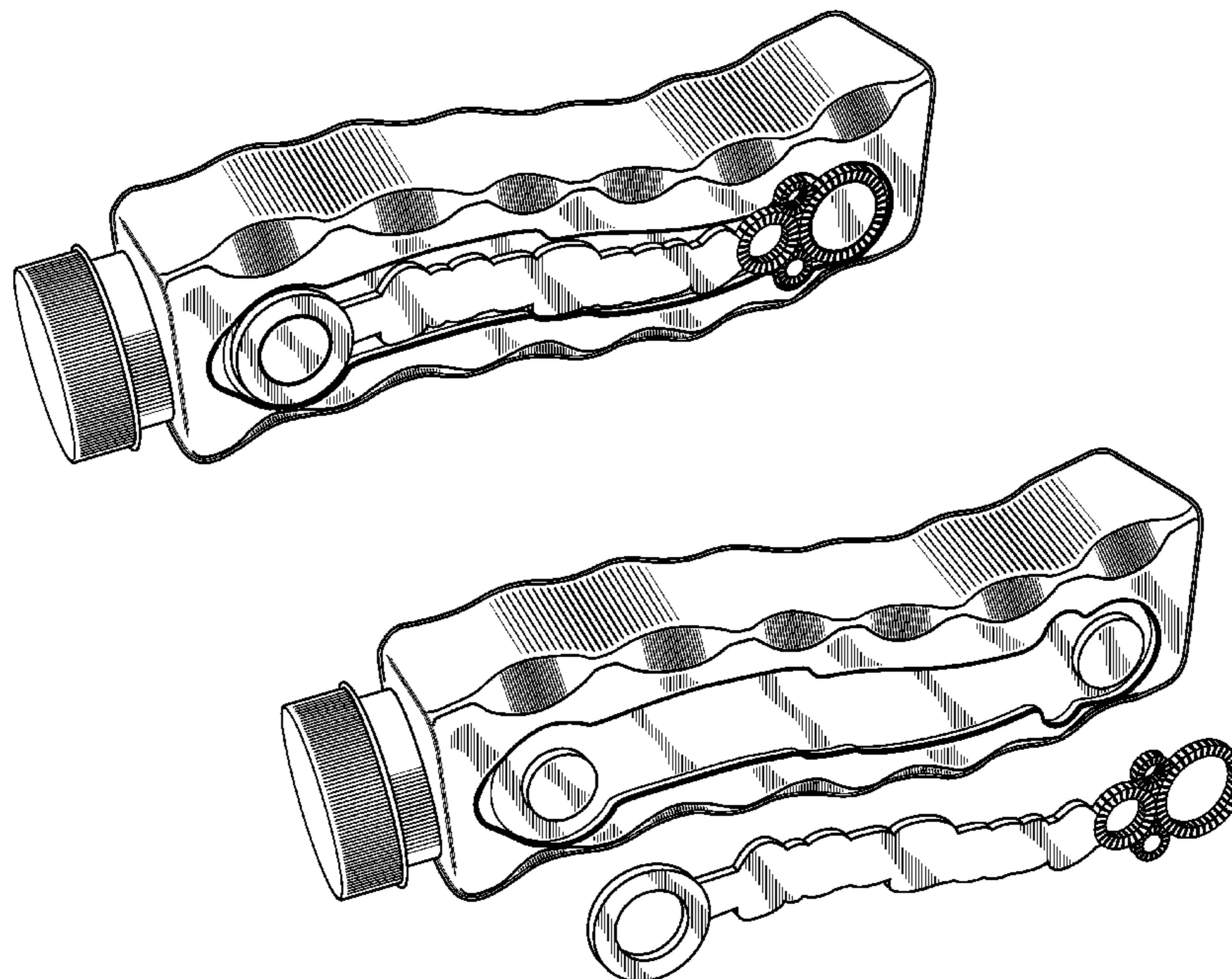

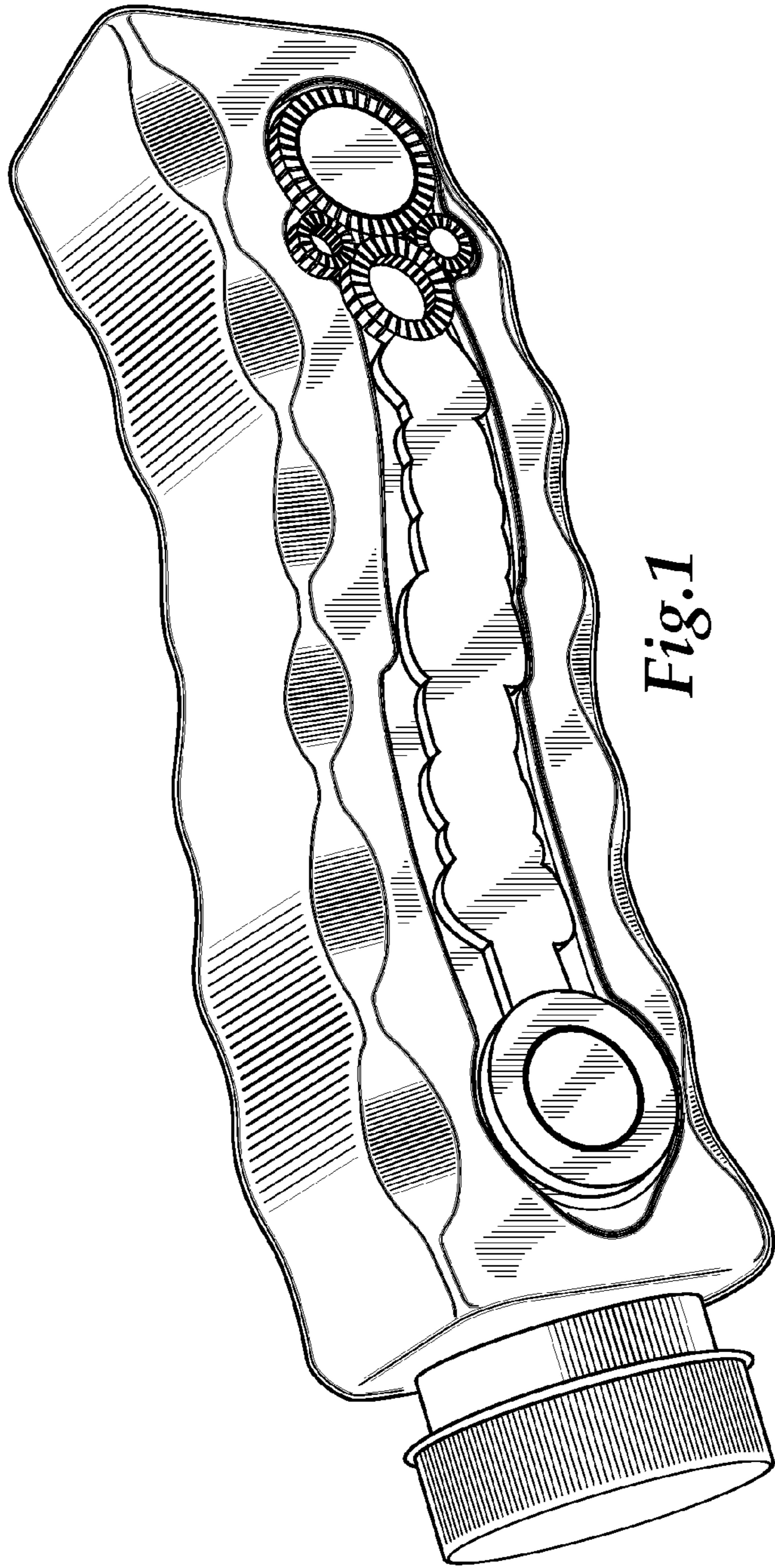
The ornamental design for a combined bottle and bubble wand, as shown and described.

**DESCRIPTION**

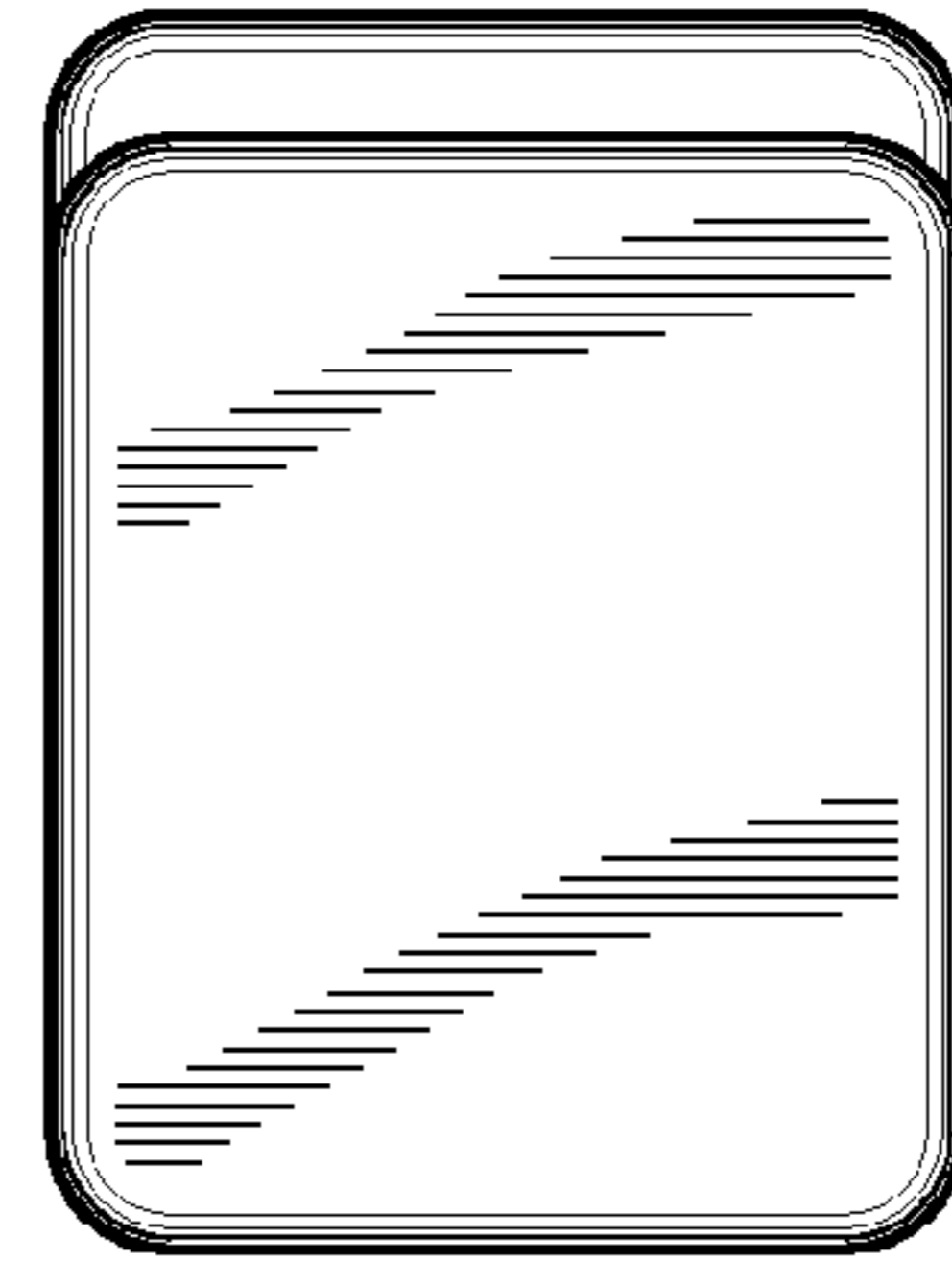
FIG. 1 is a front perspective view of a combined bottle and bubble wand showing my new design;

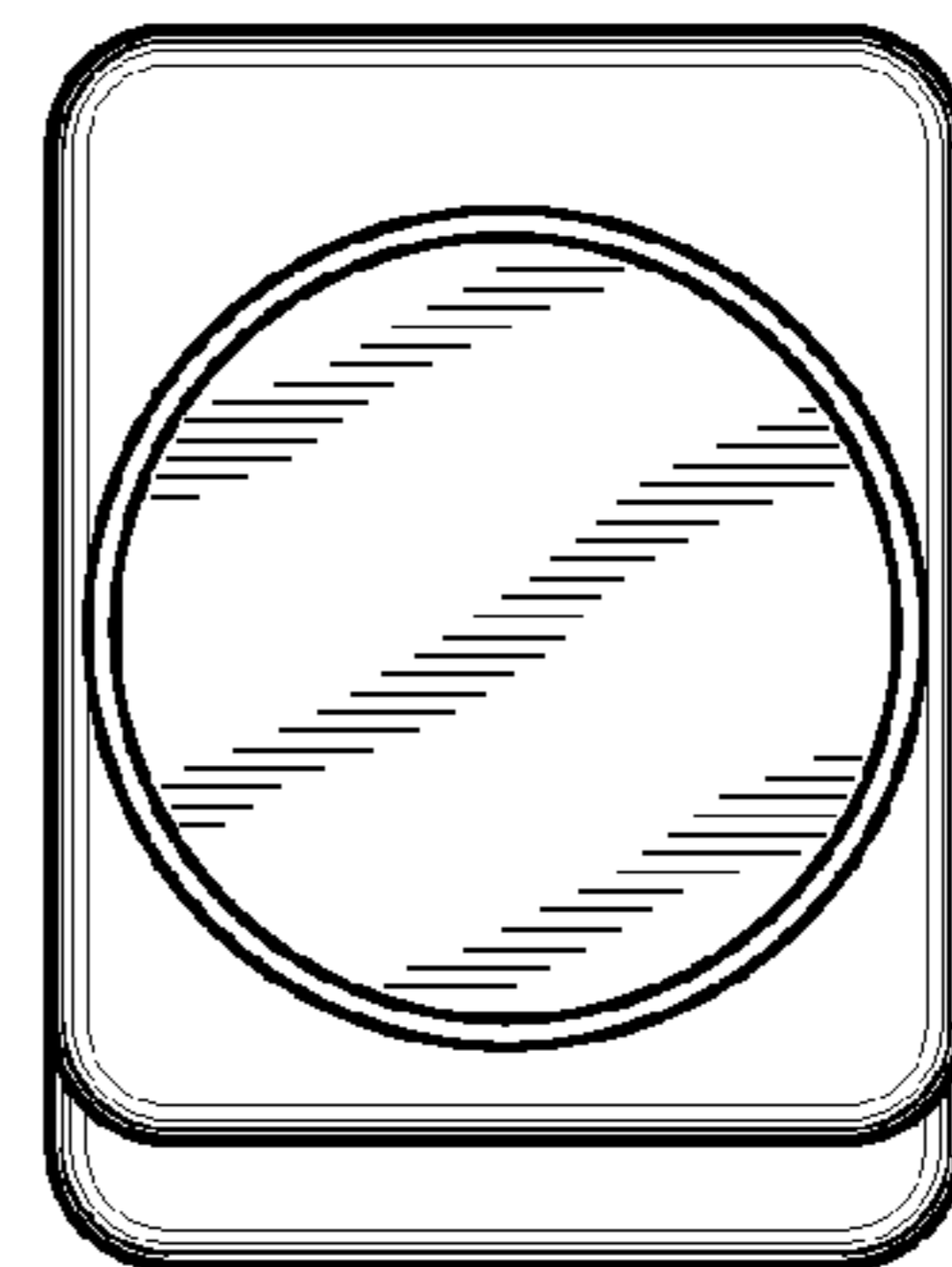




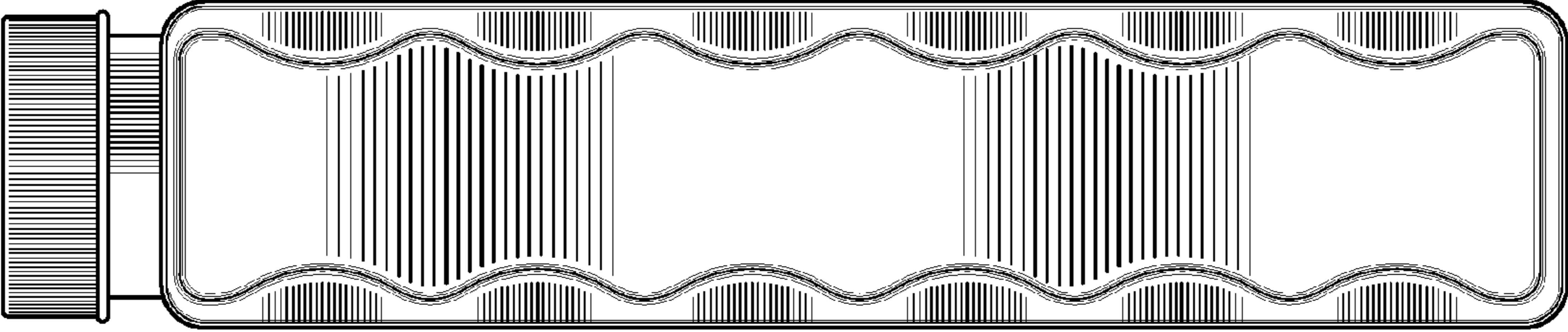

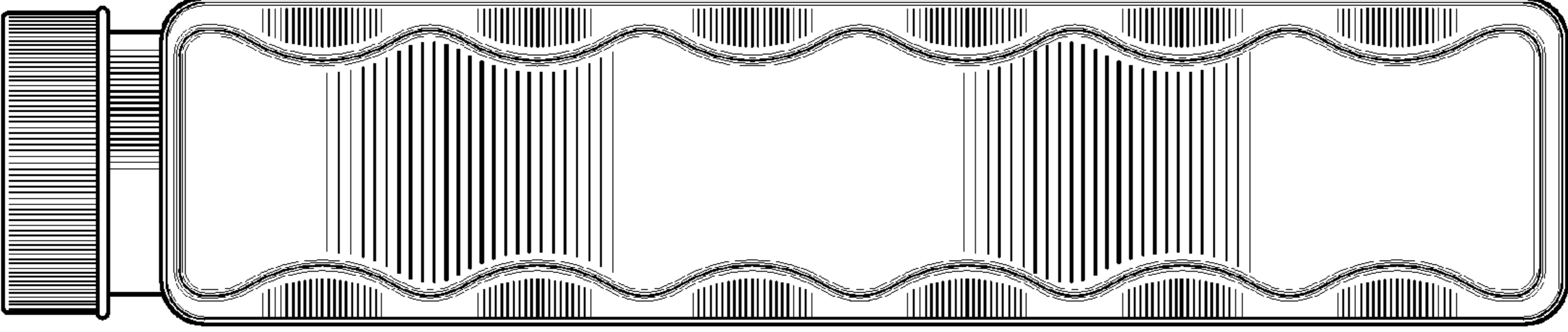

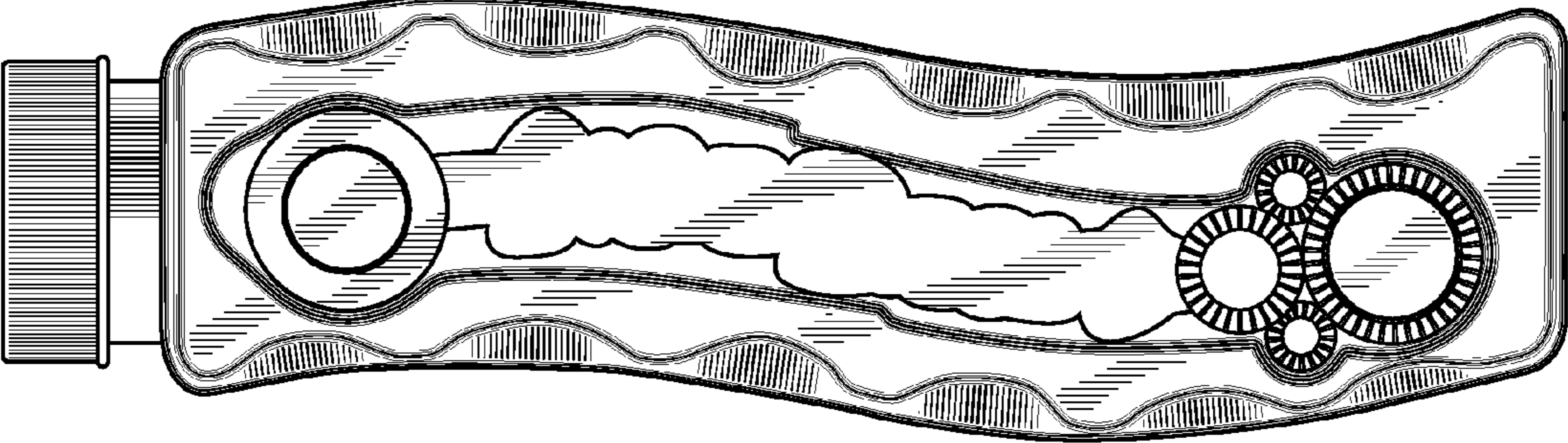

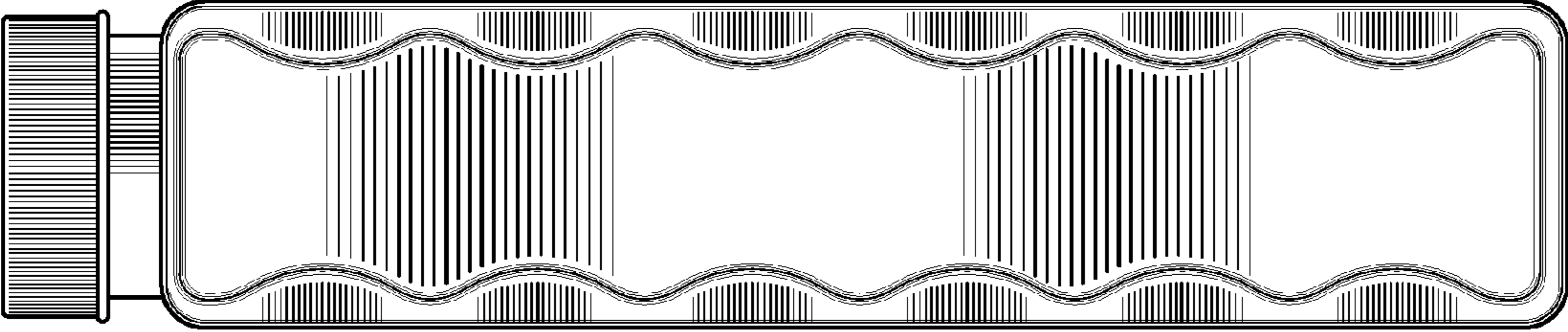

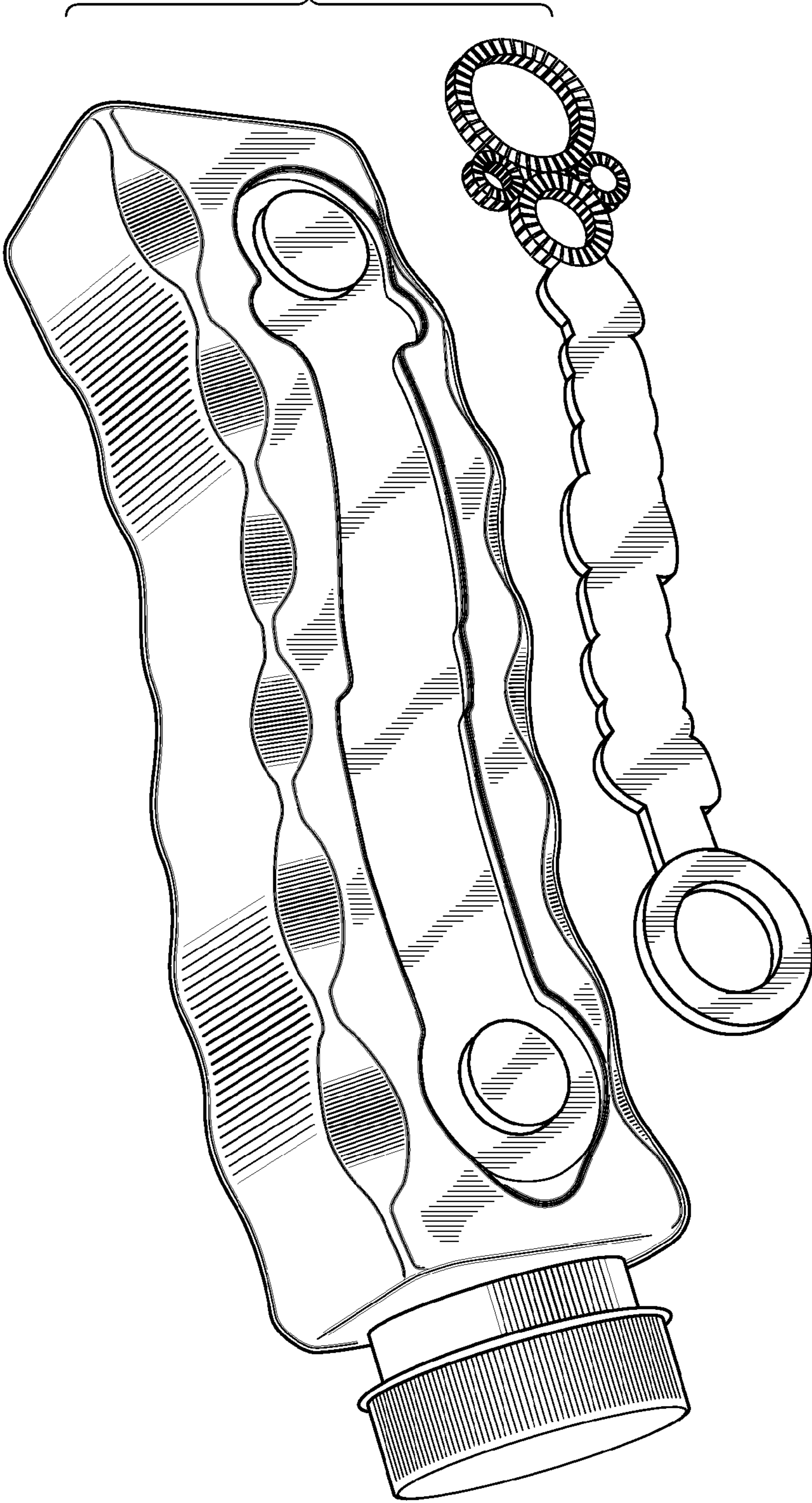


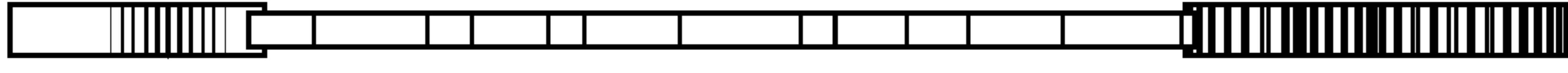

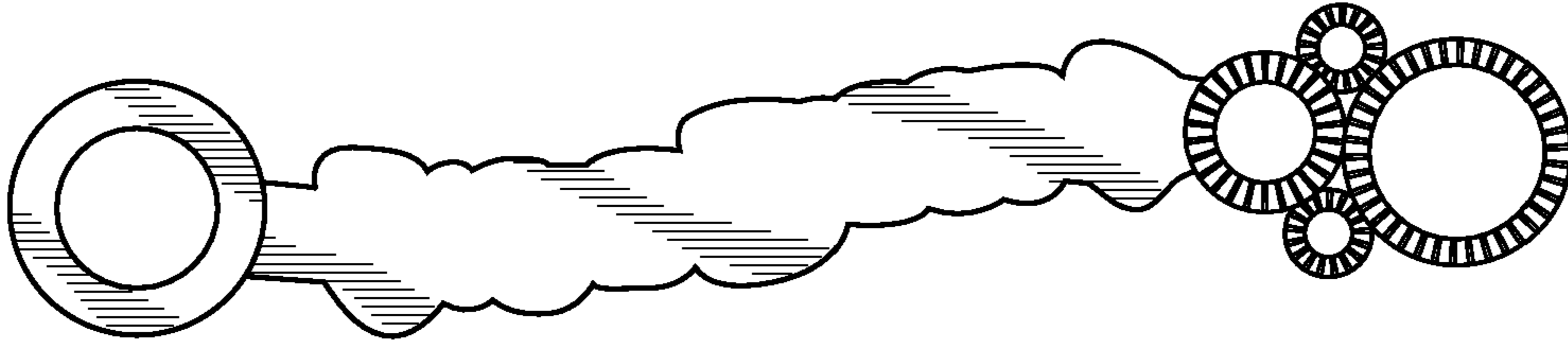

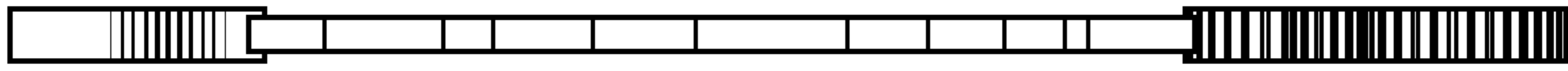




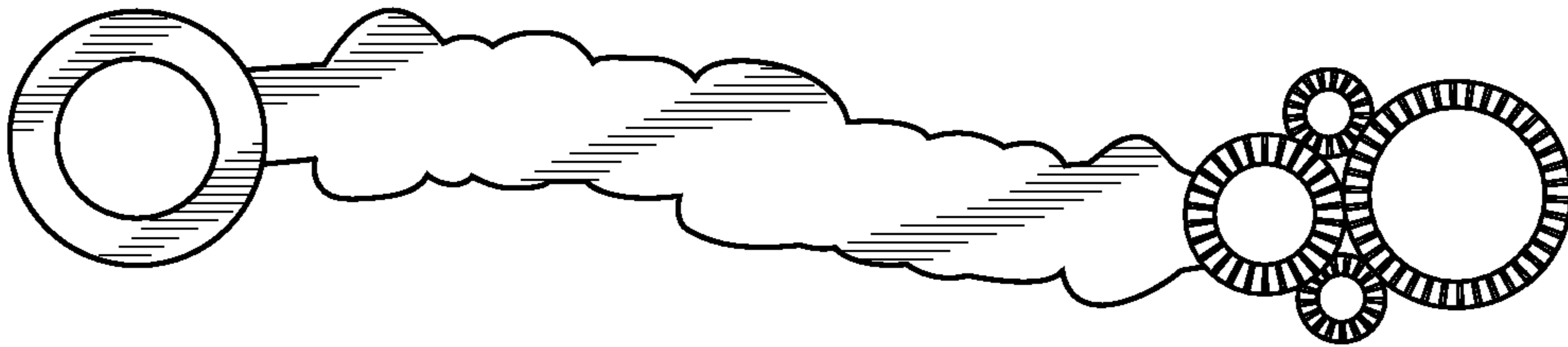

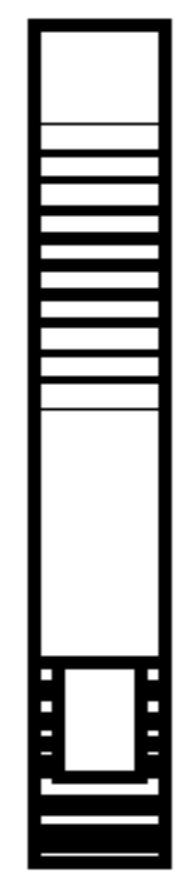
