FIG. 6 is a left-side elevational view thereof;

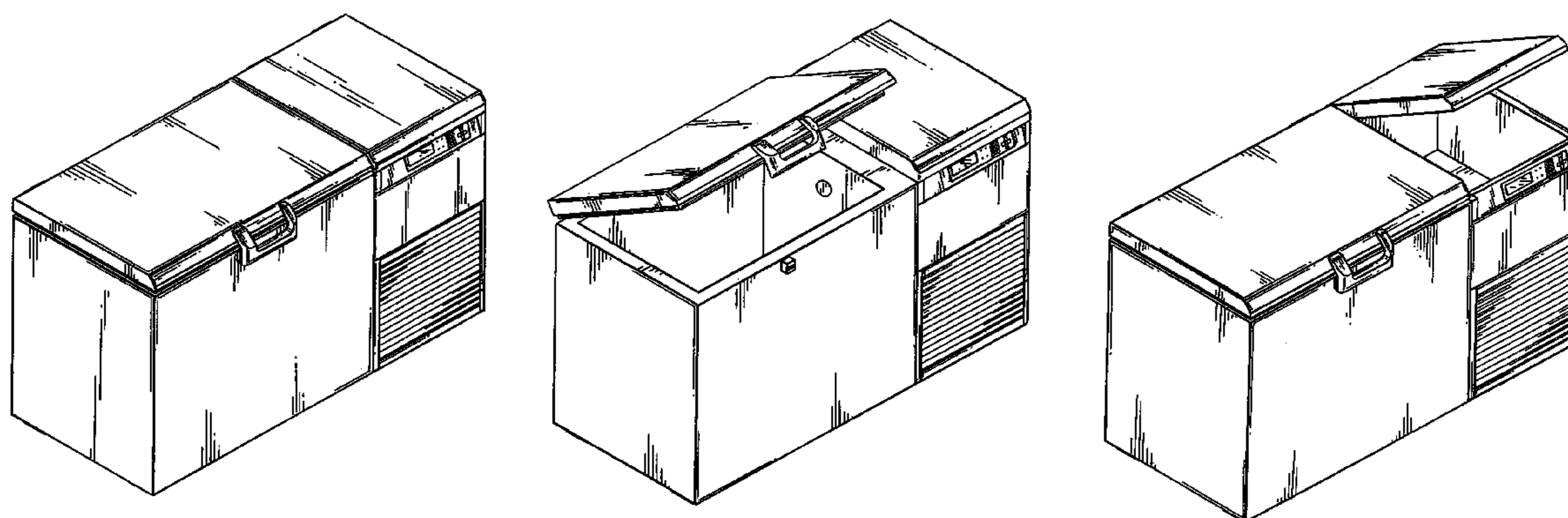
FIG. 7 is a perspective view of FIG. 1;

open position; and,

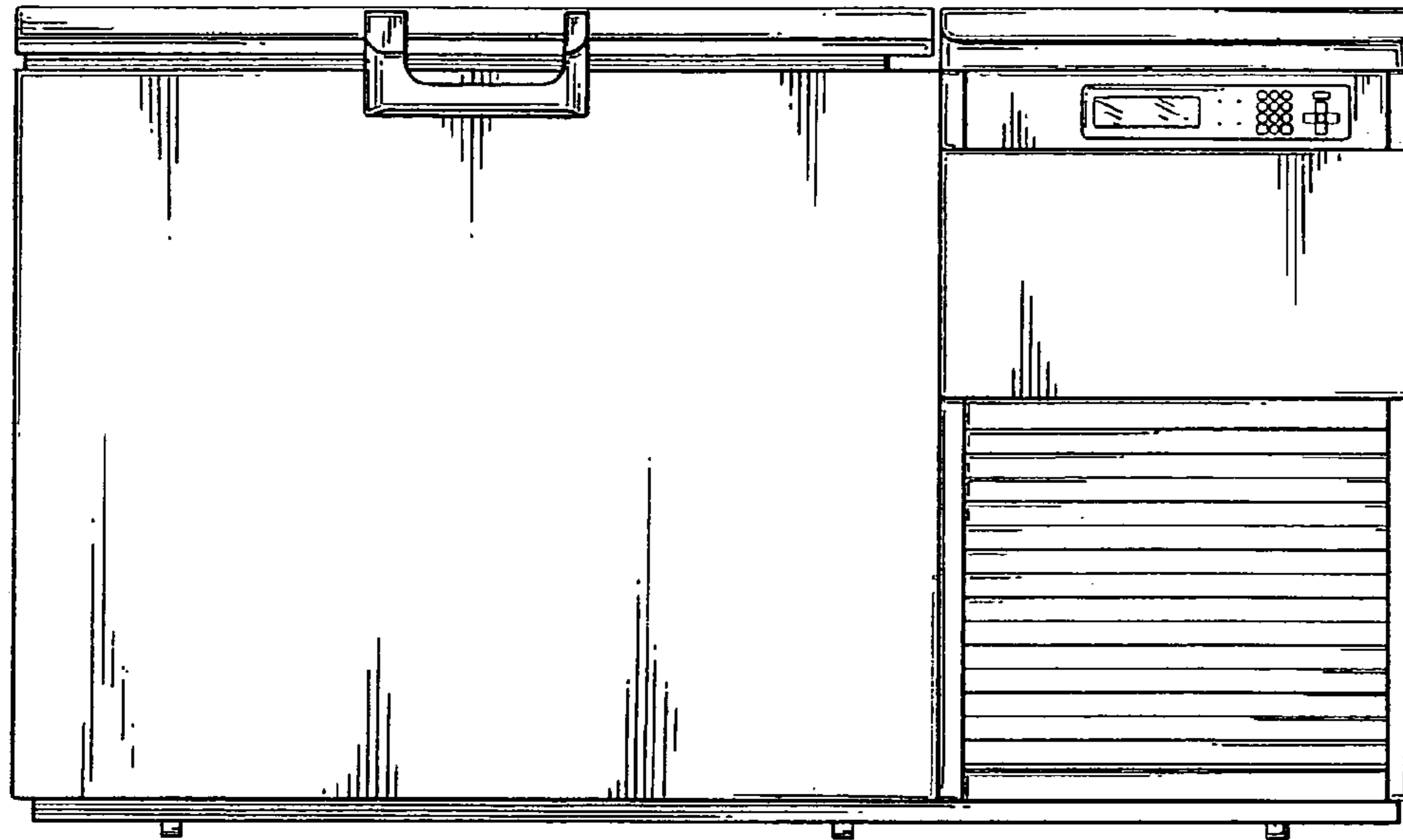
FIG. 9 is a perspective view of FIG. 7 with a second door in

FIGS. 7, 8 and 9 are shown on a reduced scale.

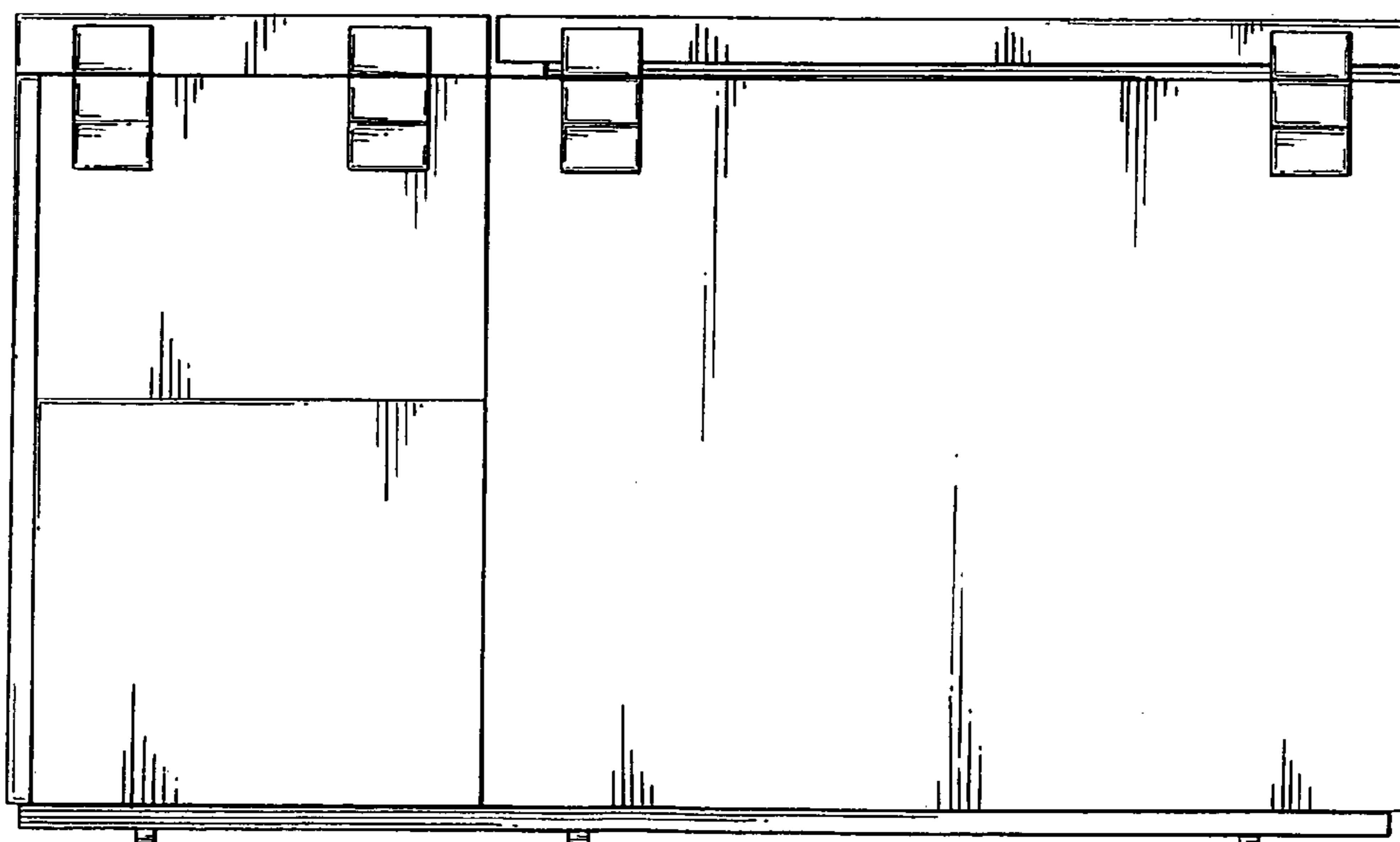

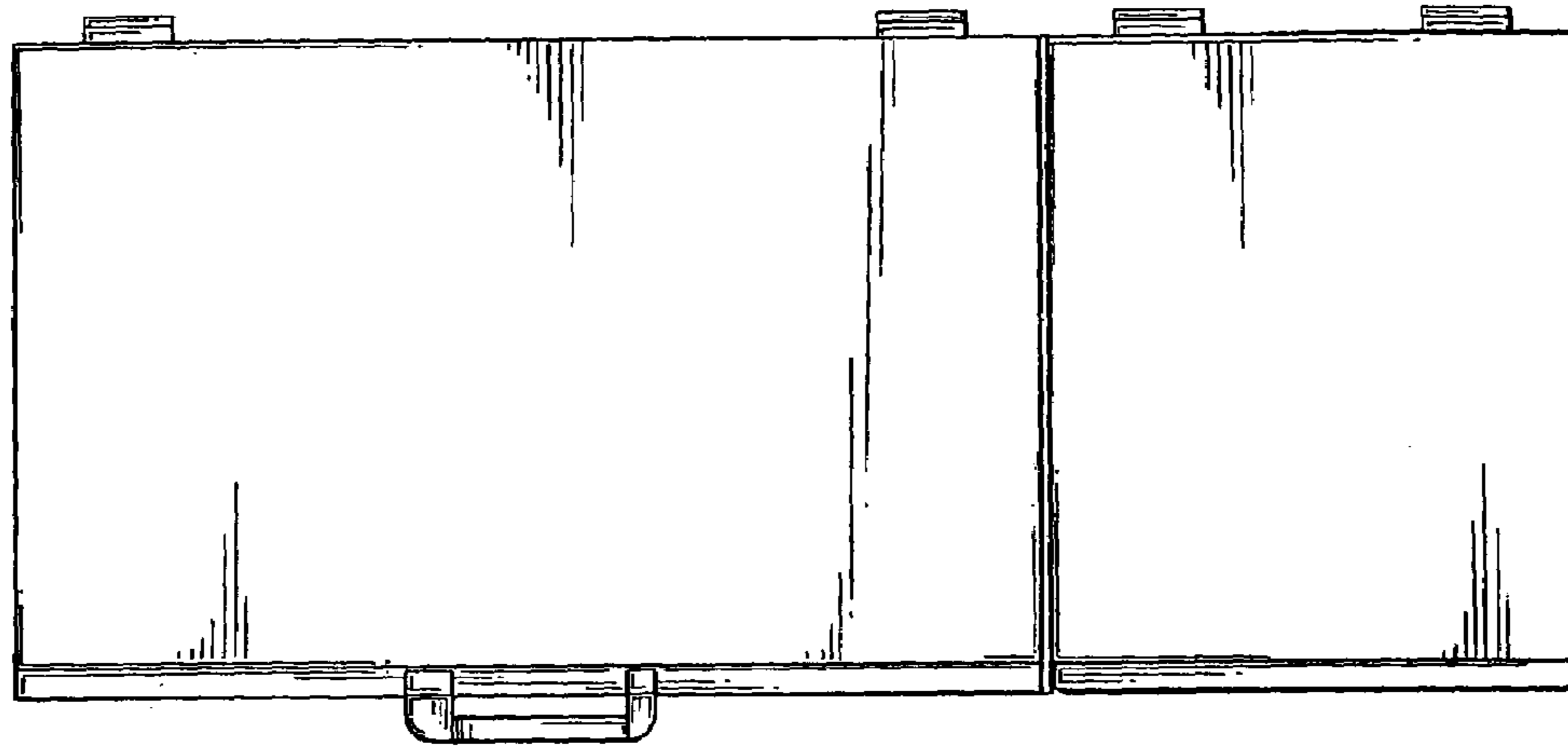

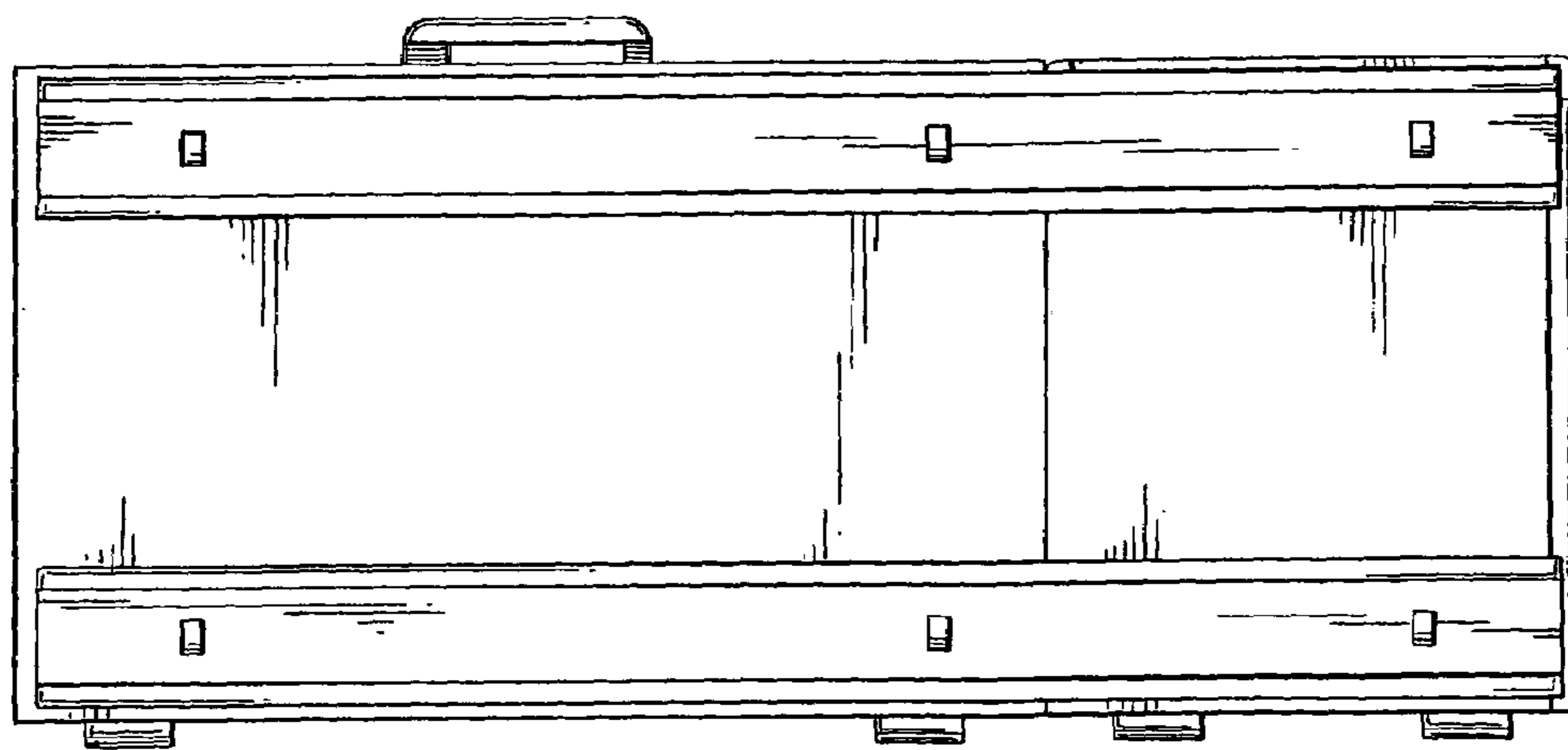

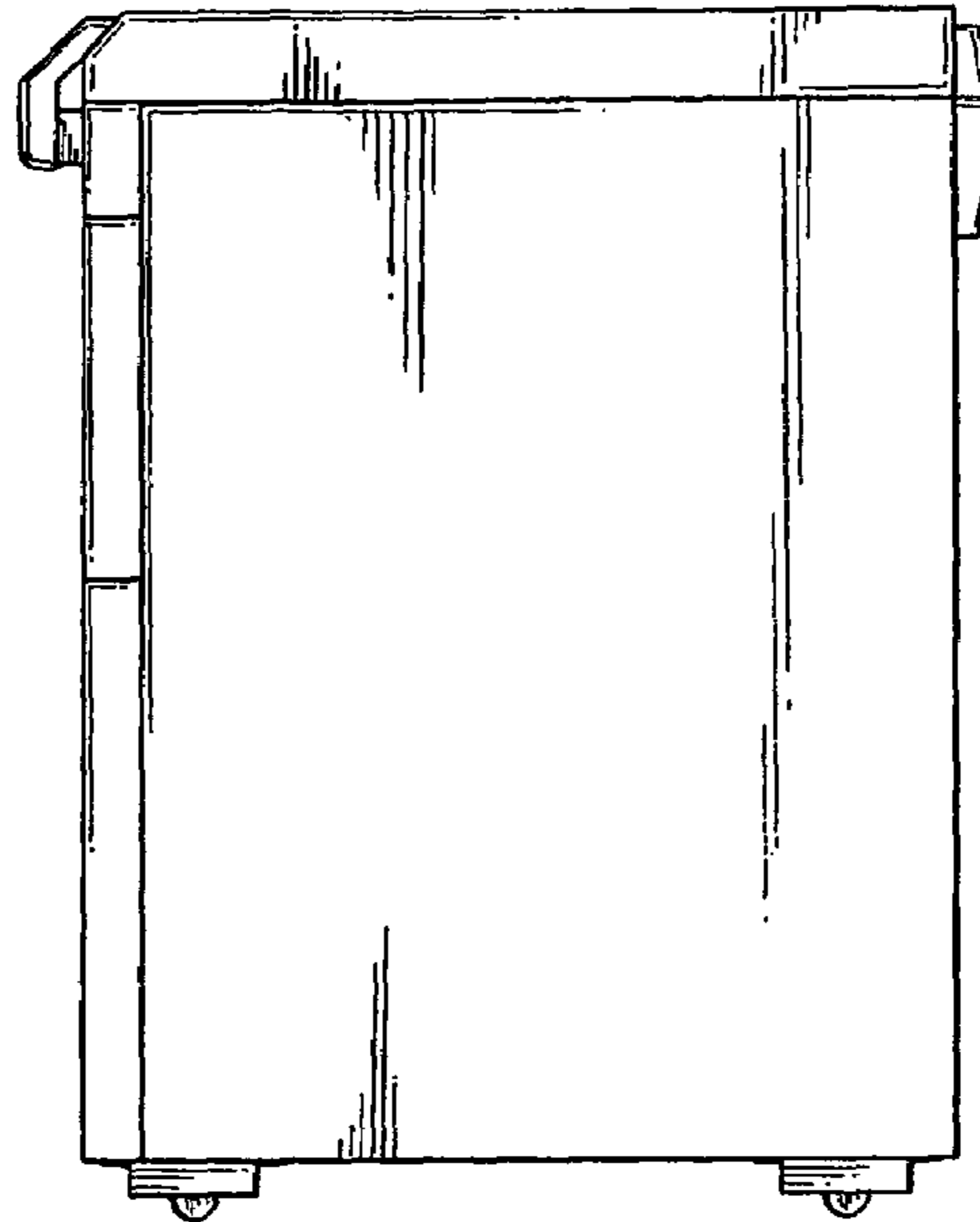

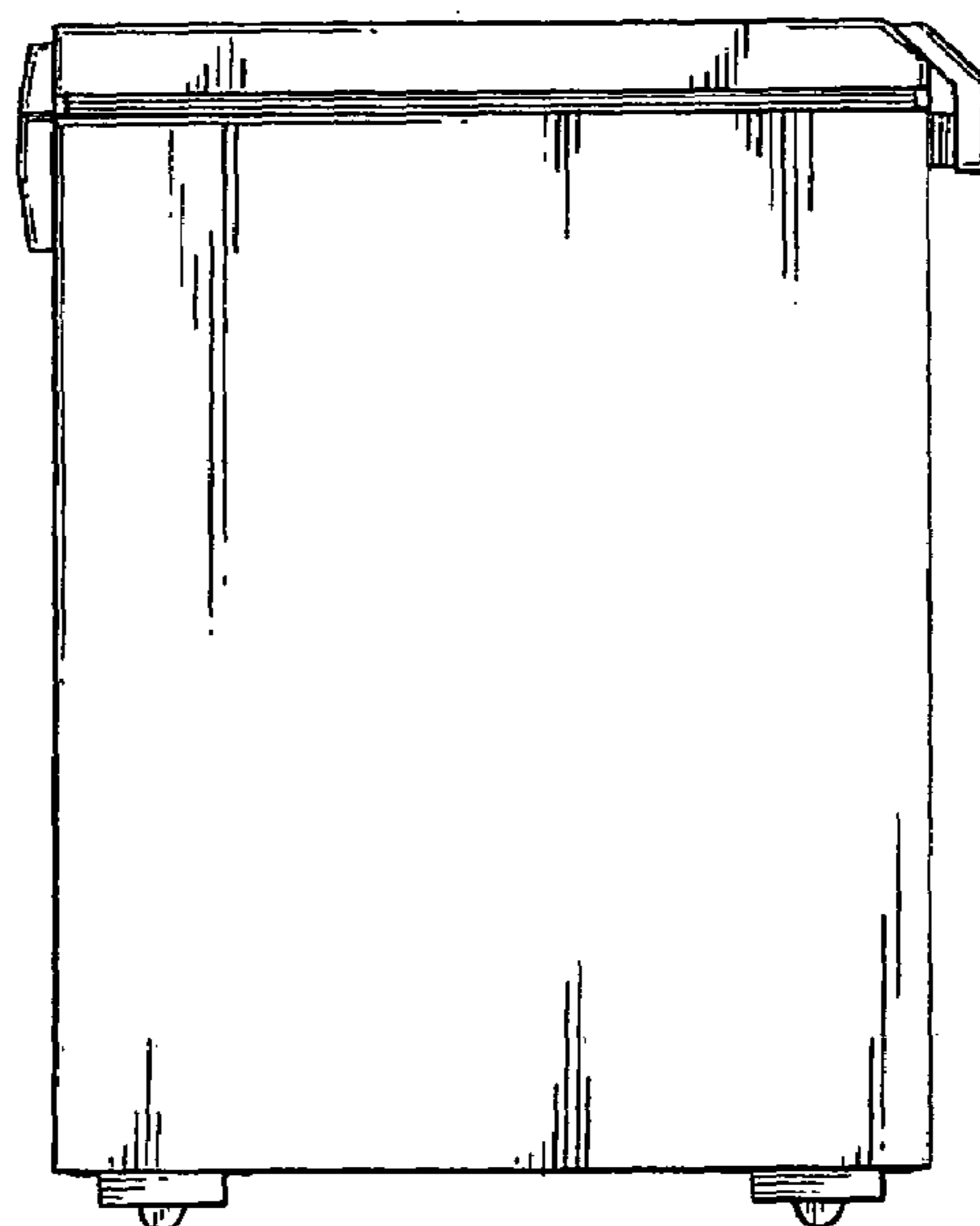

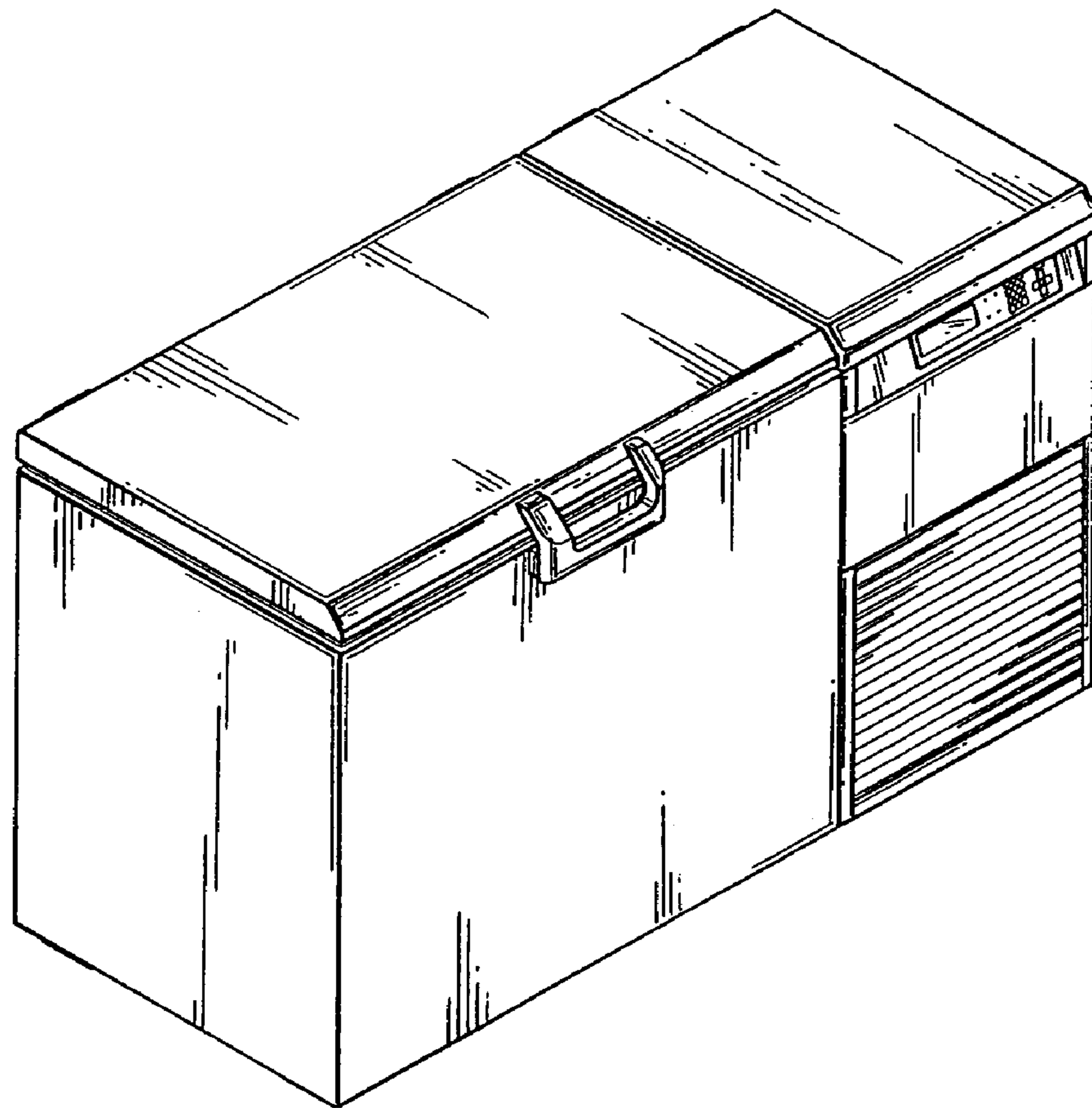

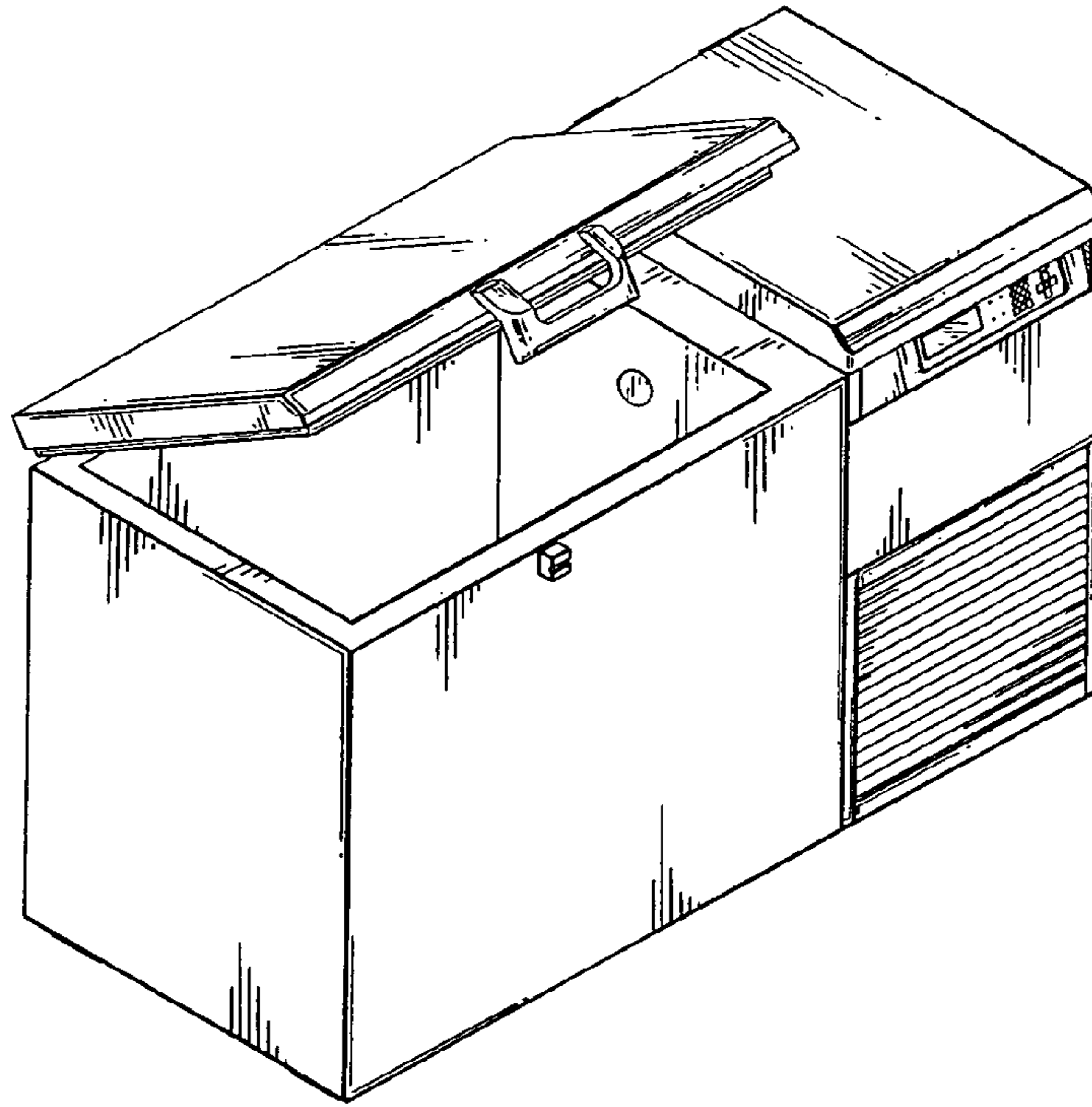
