FIG. 6 is a front elevation thereof.

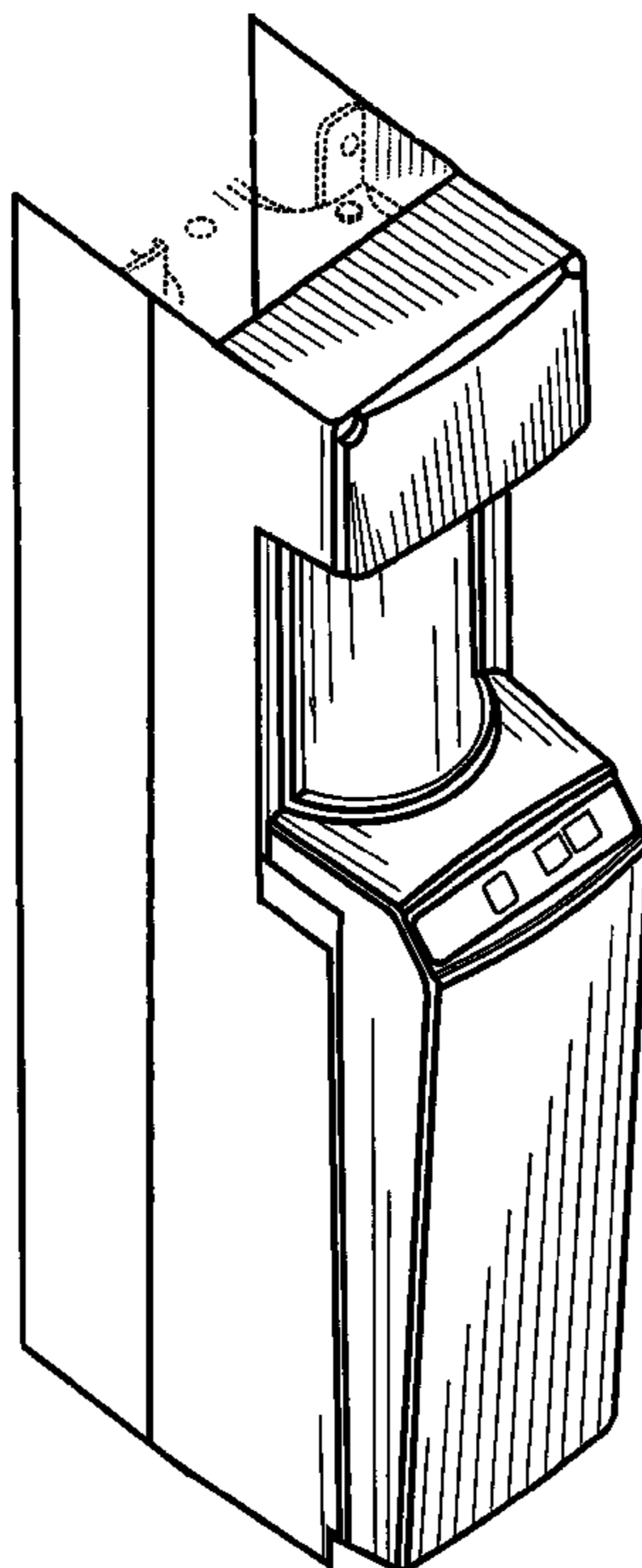

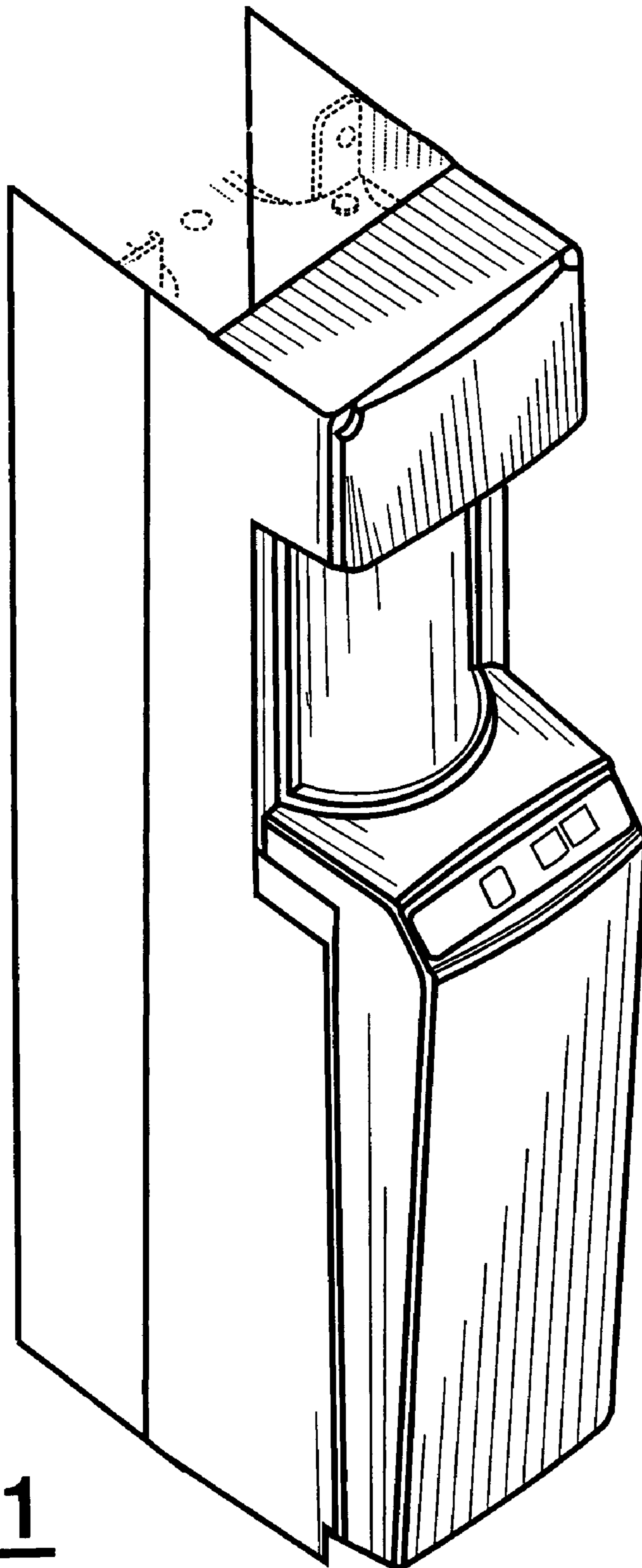

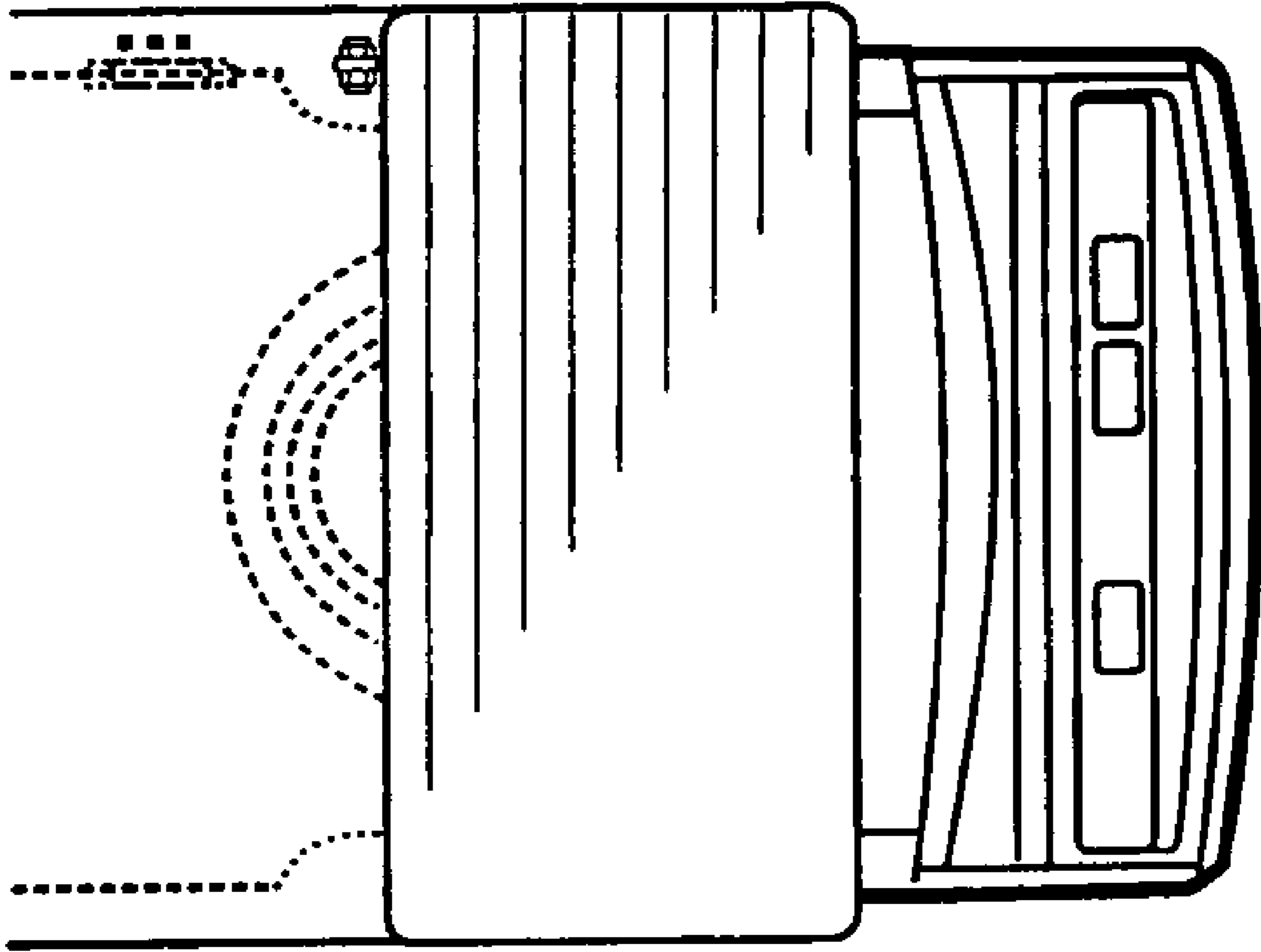

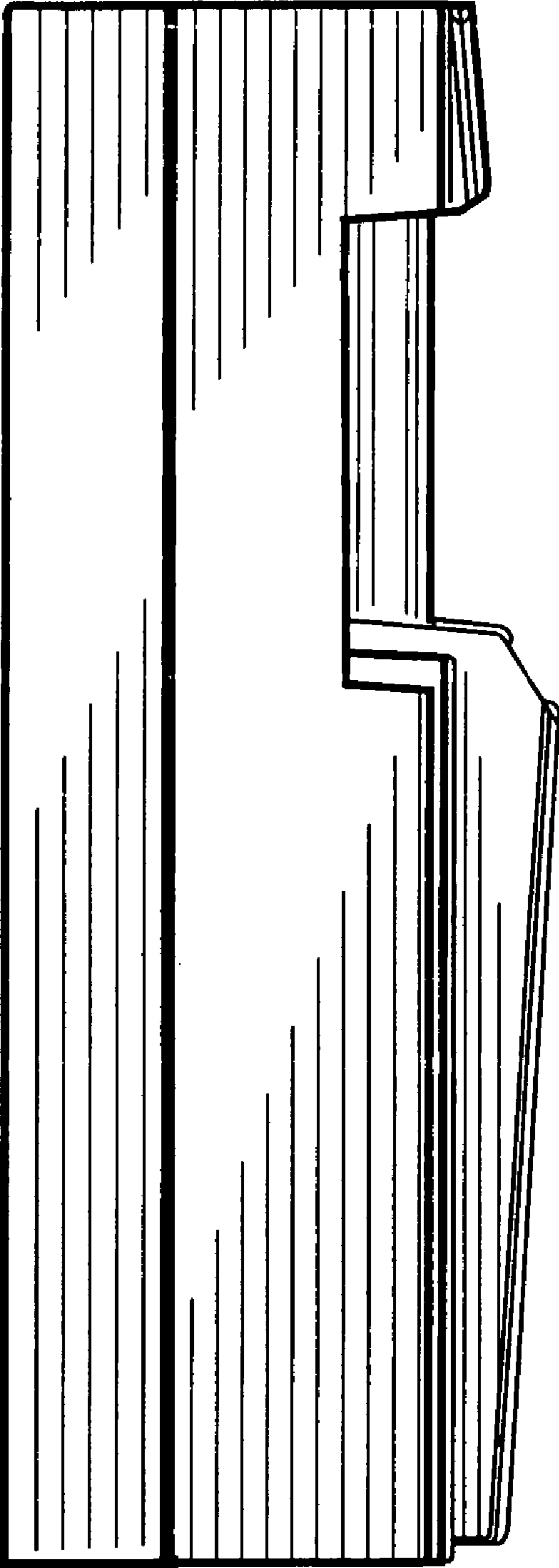

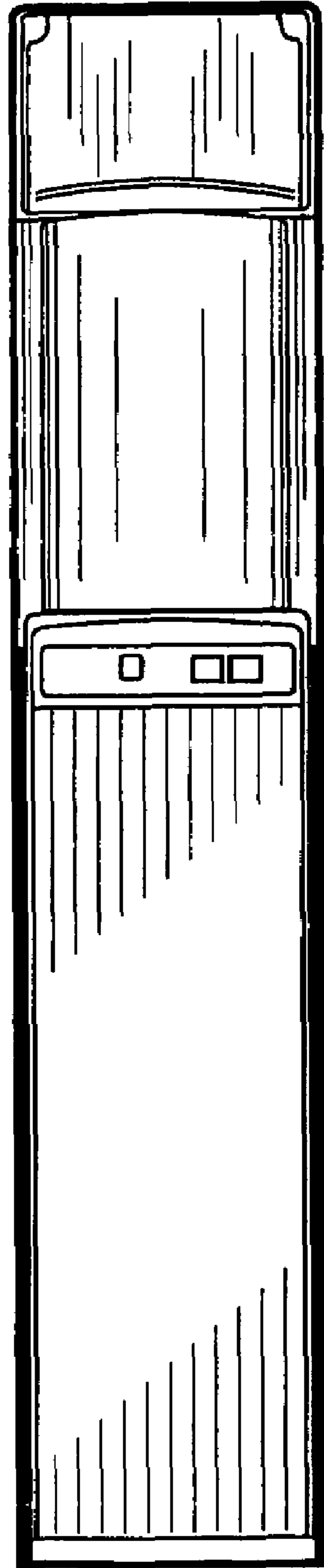

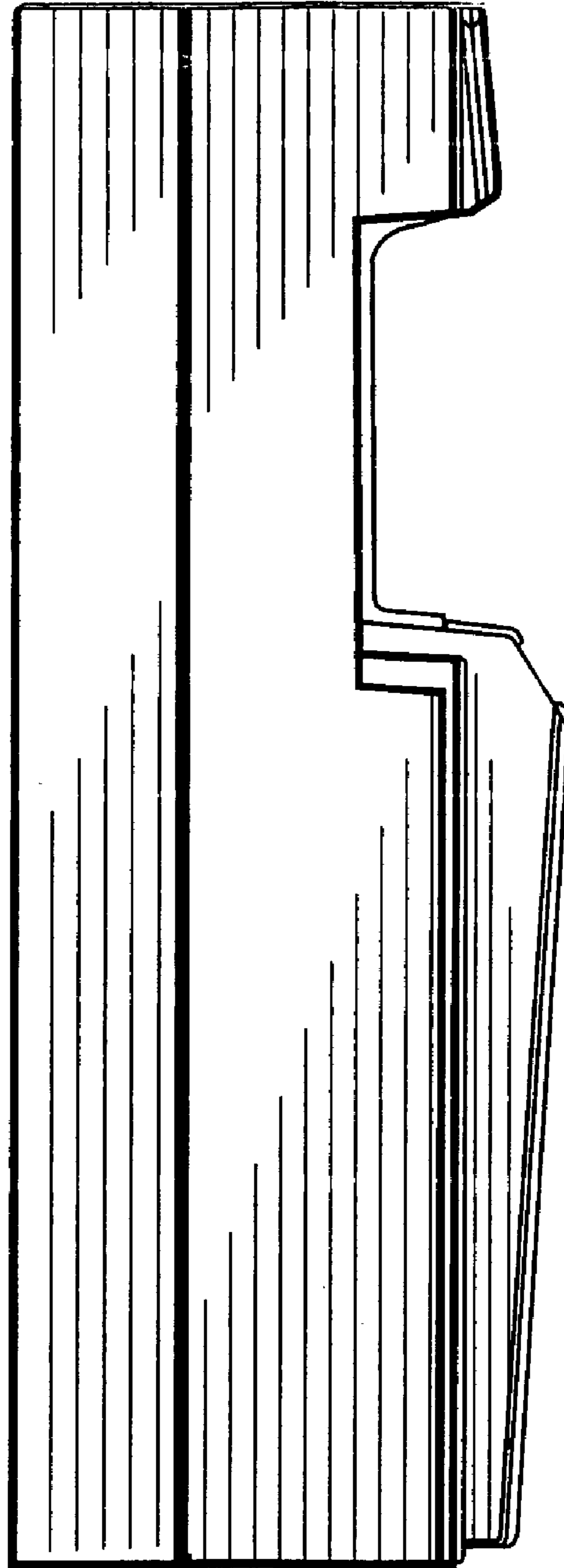

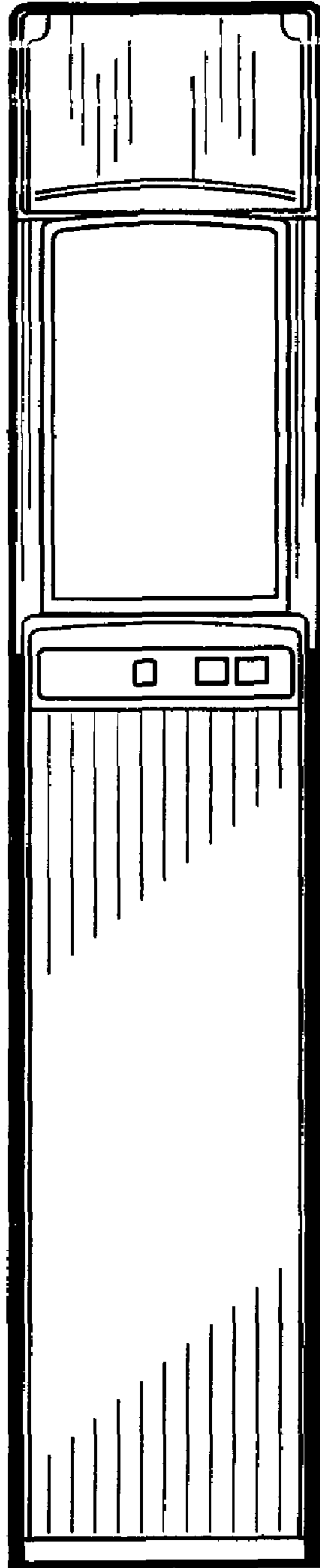
