FIG. 2 is a bottom plan thereof;

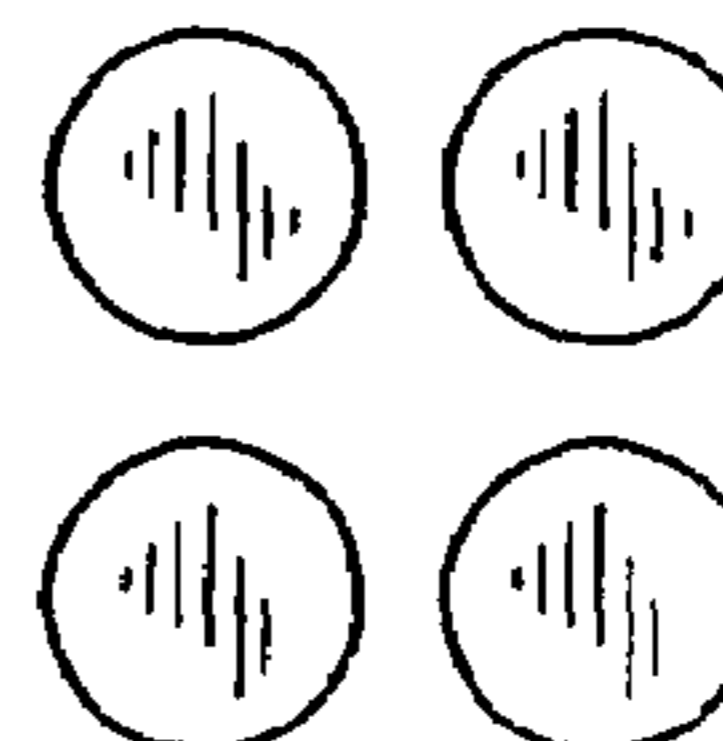
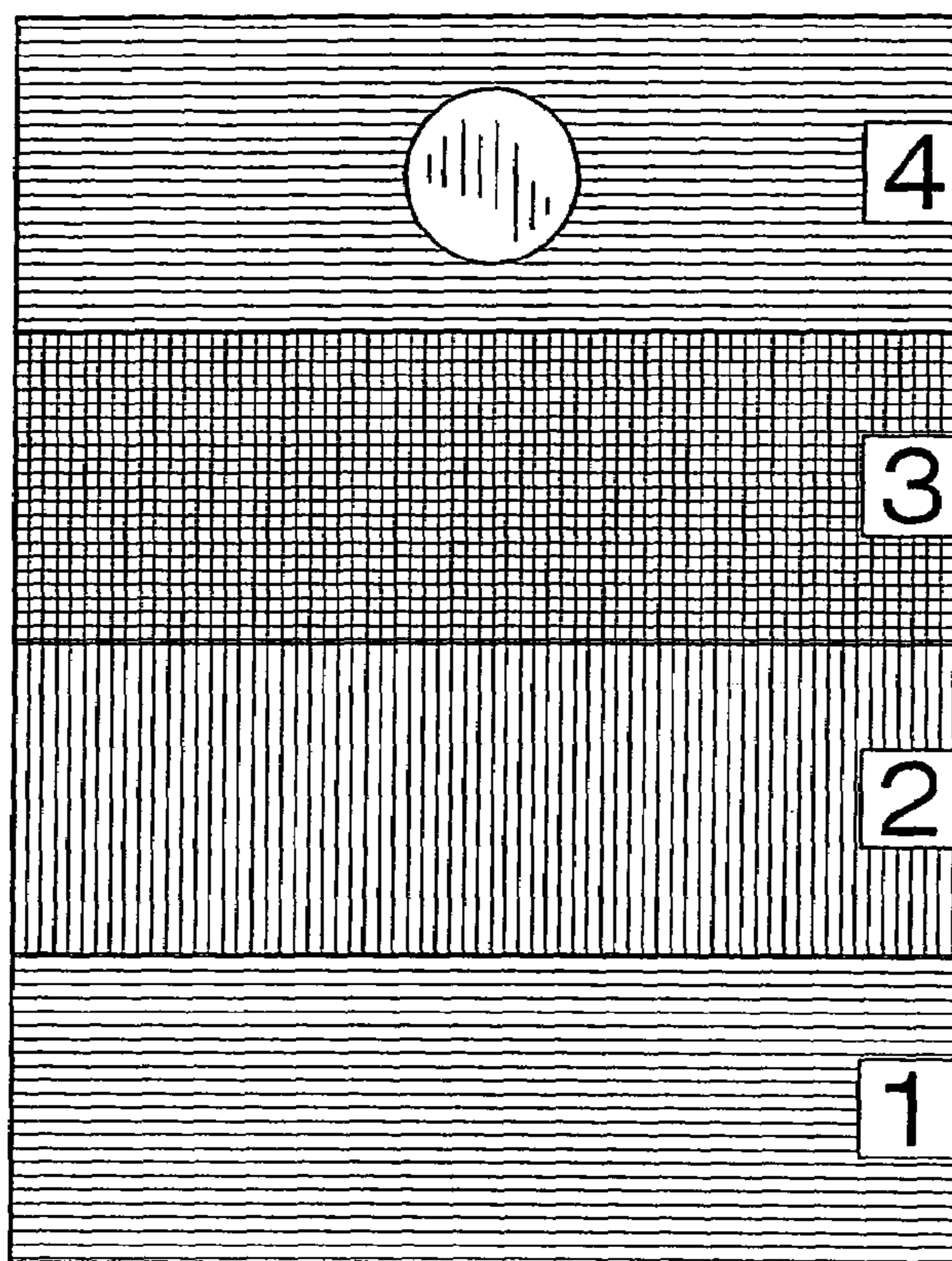
FIG. 3 is a side elevational view thereof;

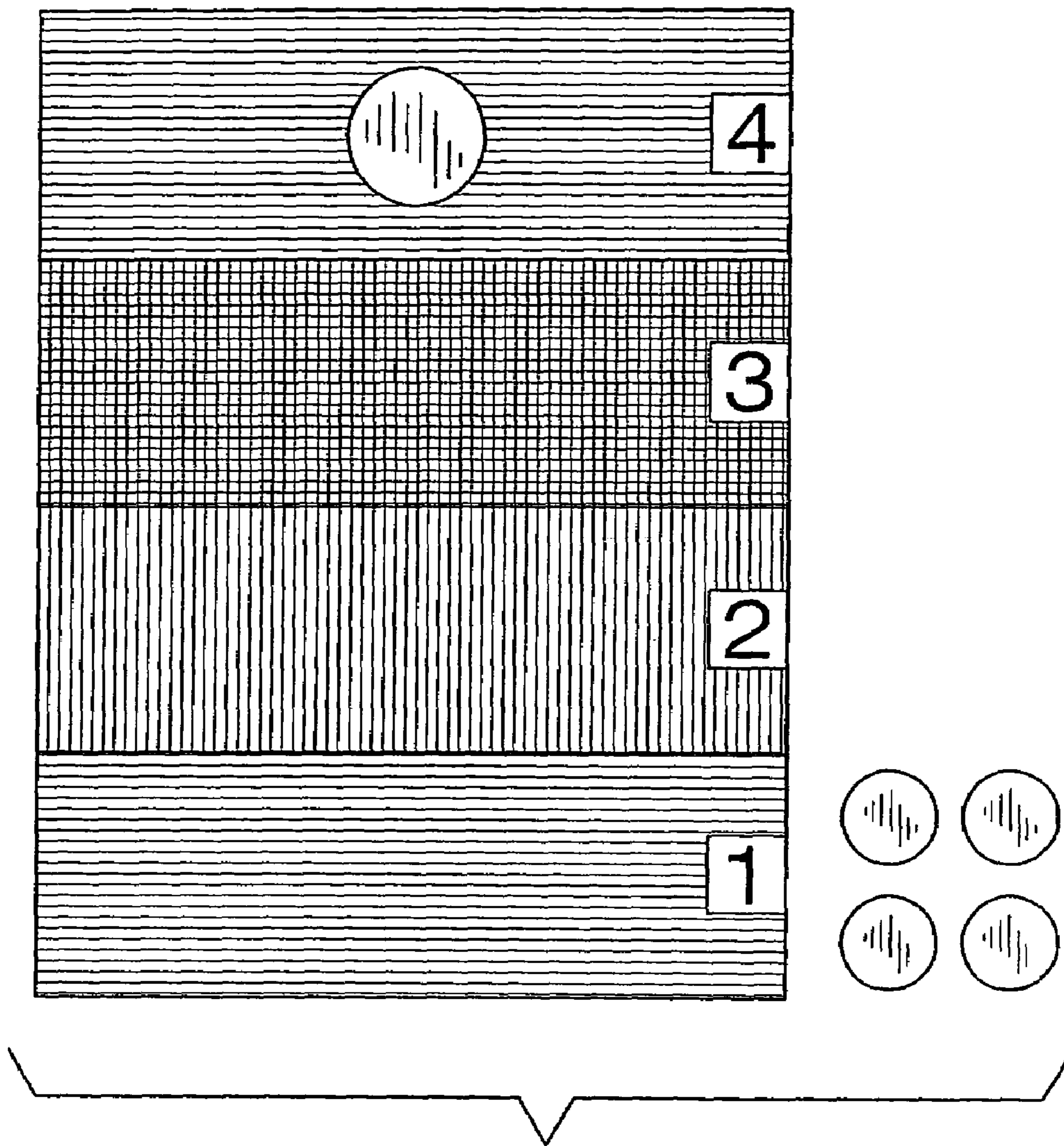

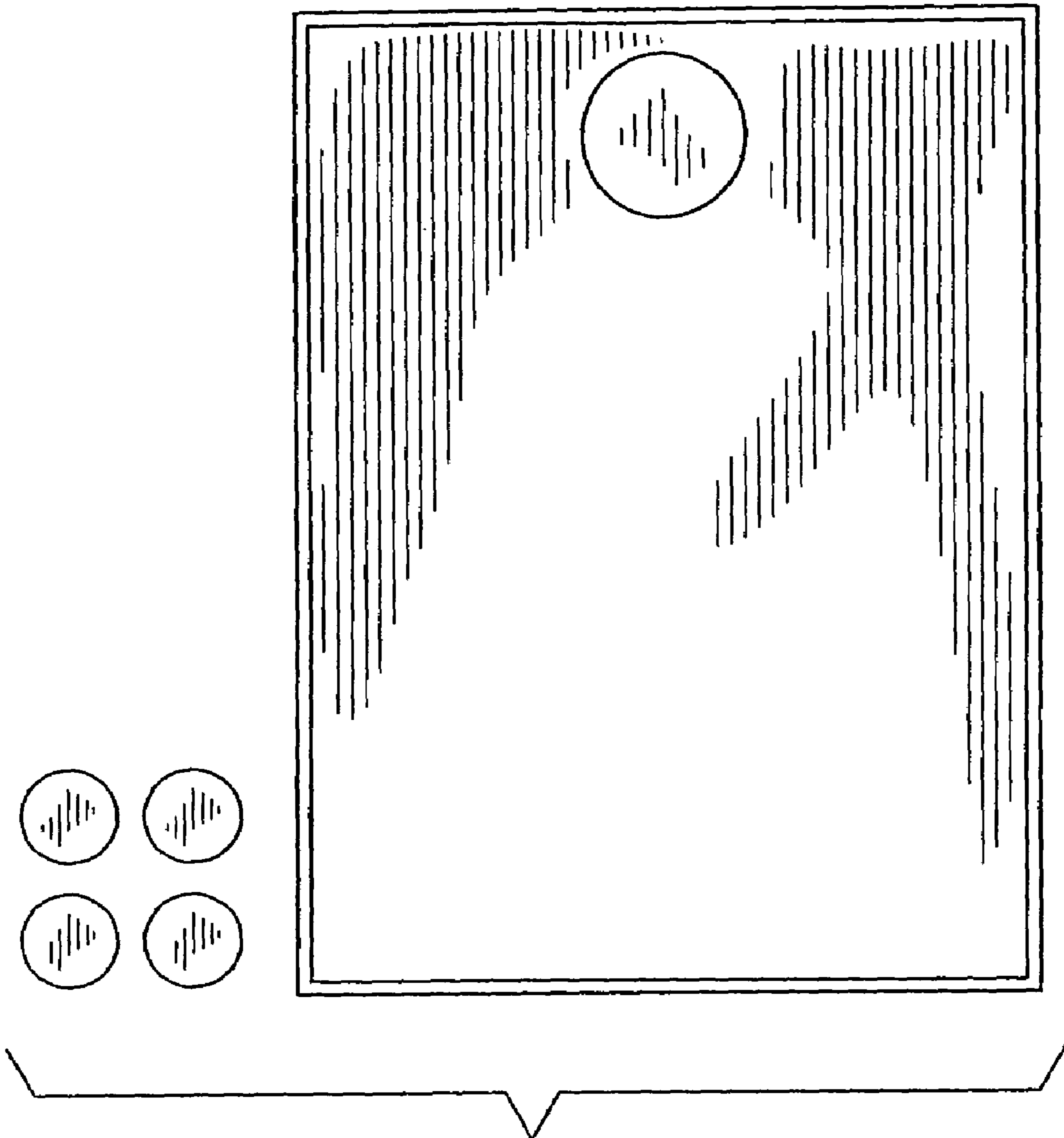
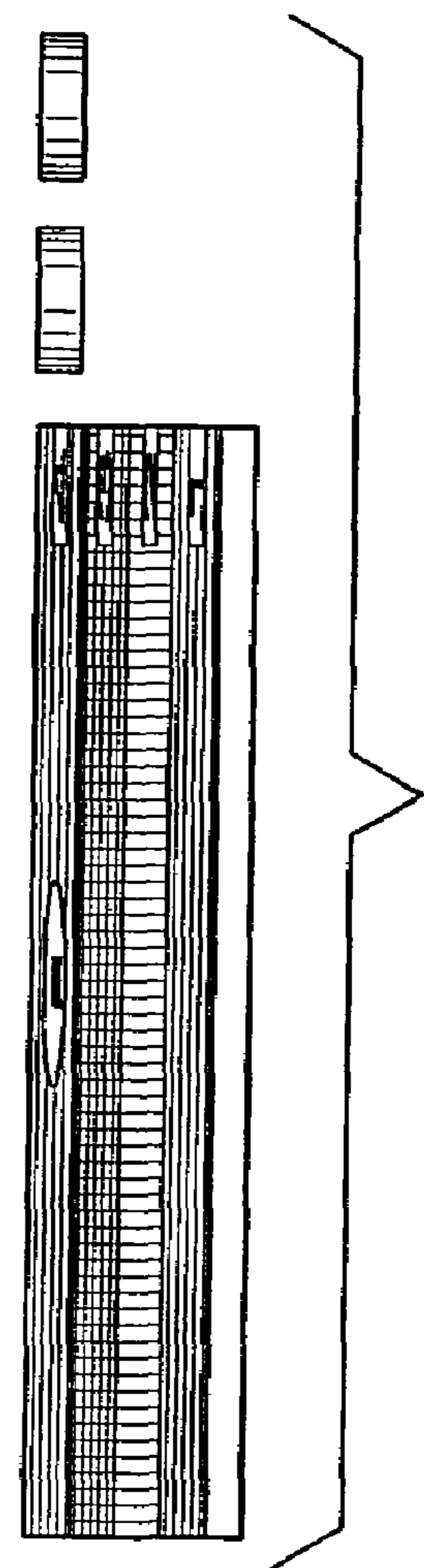
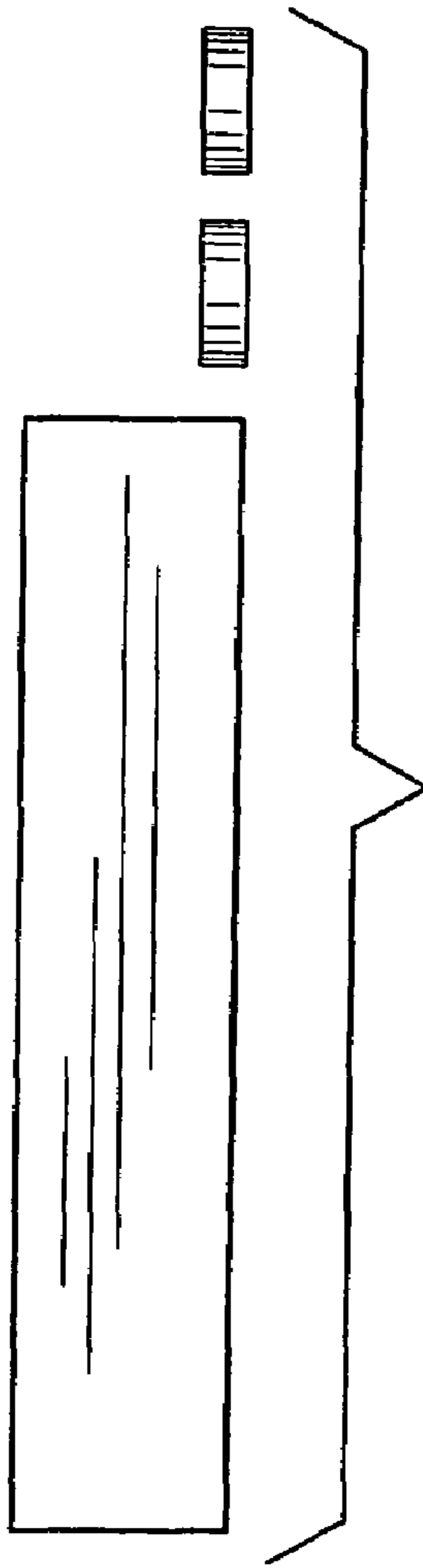
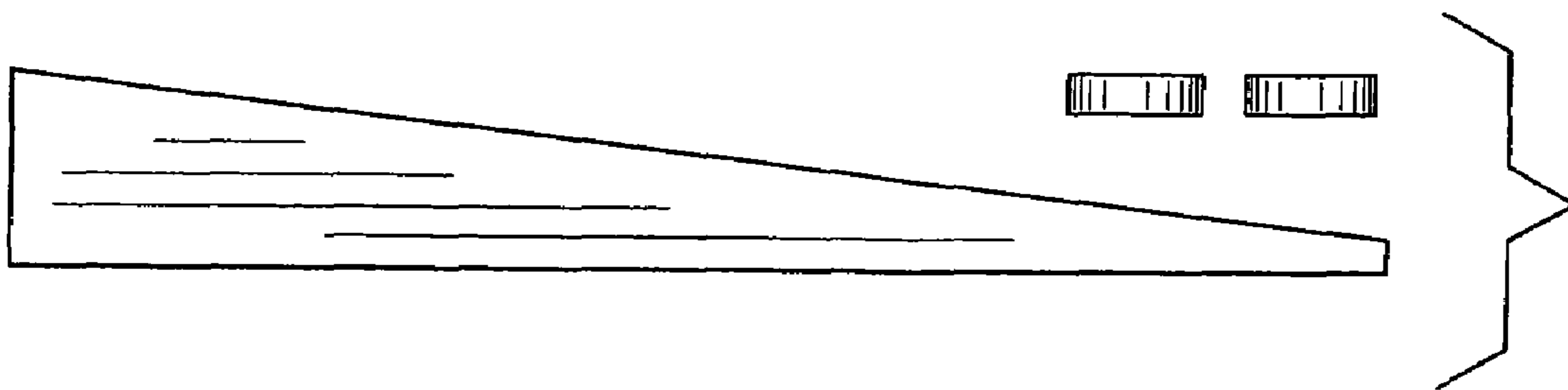

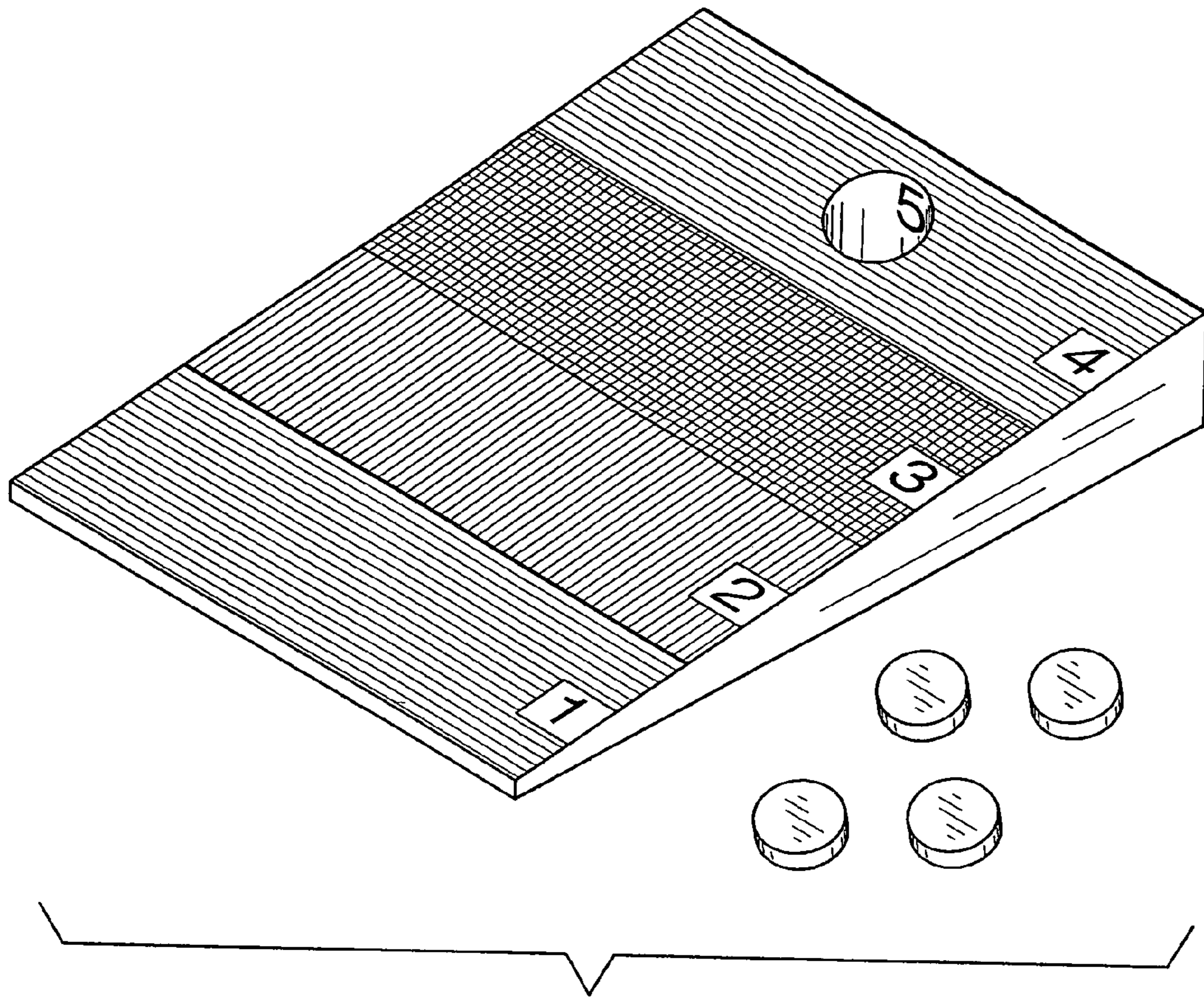
