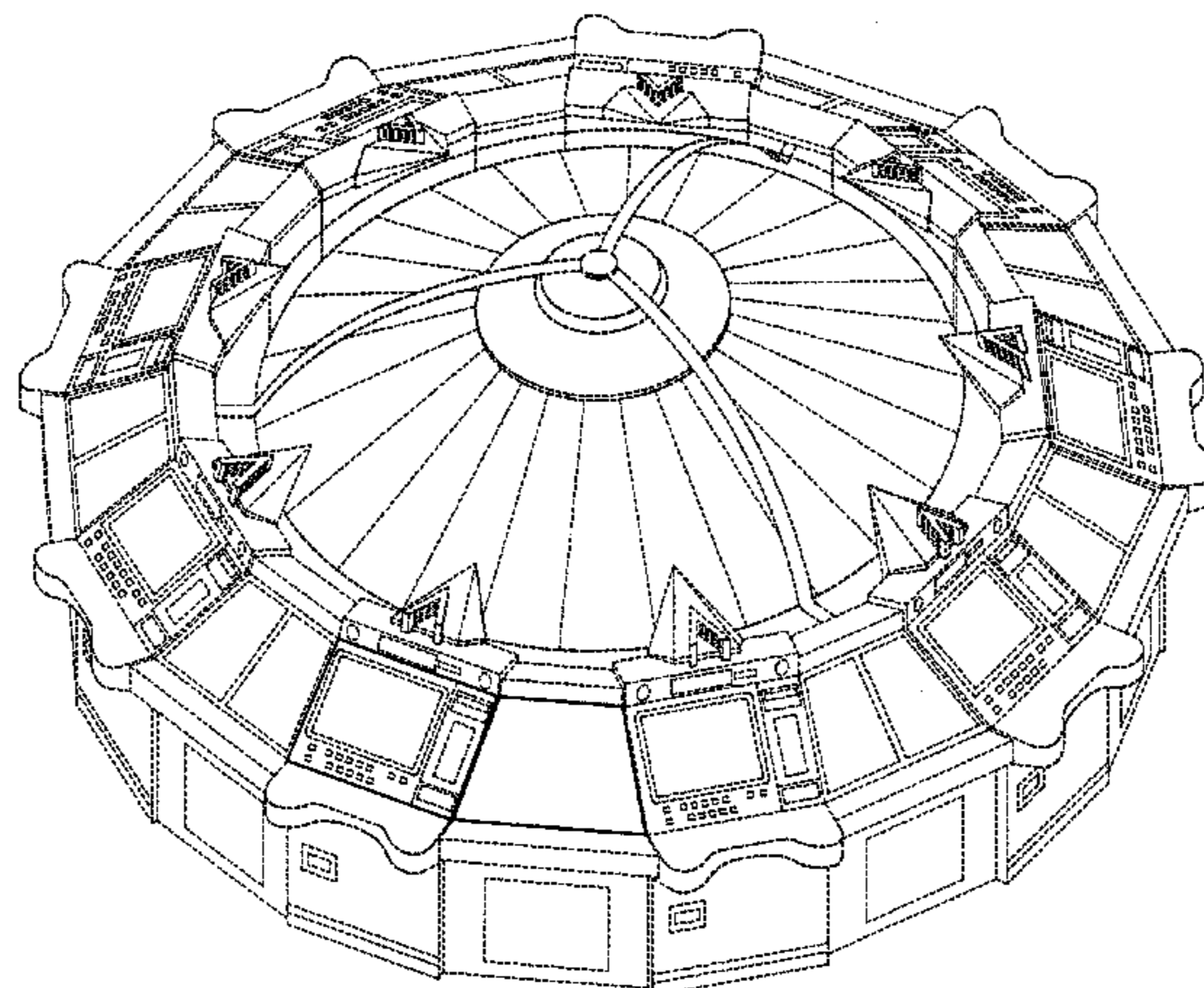

(57) **CLAIM**

The ornamental design for a gaming system having a gaming machine display and at least one spacer display, as shown and described.

**DESCRIPTION**

FIG. 6 is an elevated front view of the gaming machine display and spacer displays of the gaming system of our new design illustrated in FIG. 4, that portion shown in phantom is not part of the design sought to be patented and is provided for environmental purposes only.

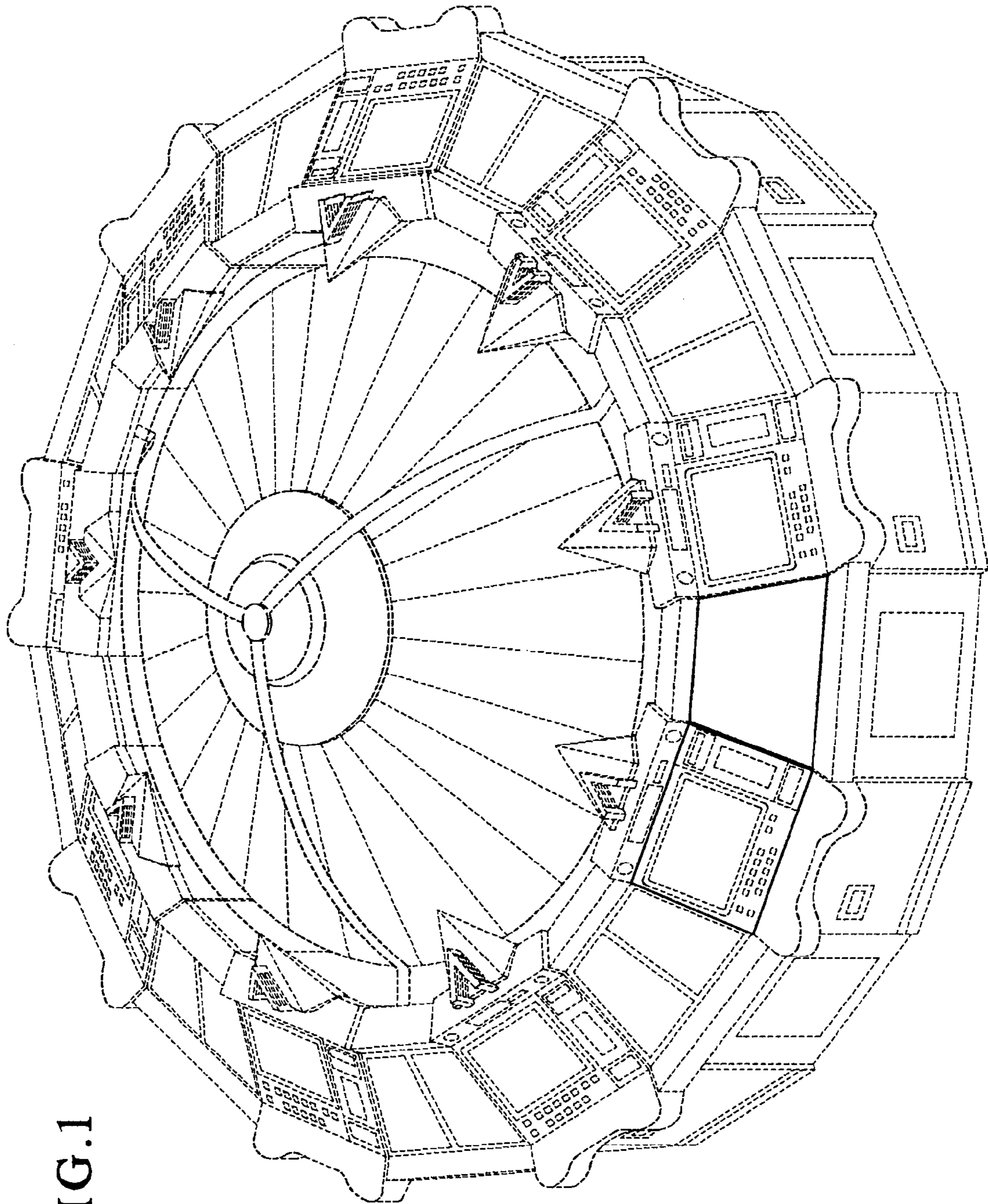

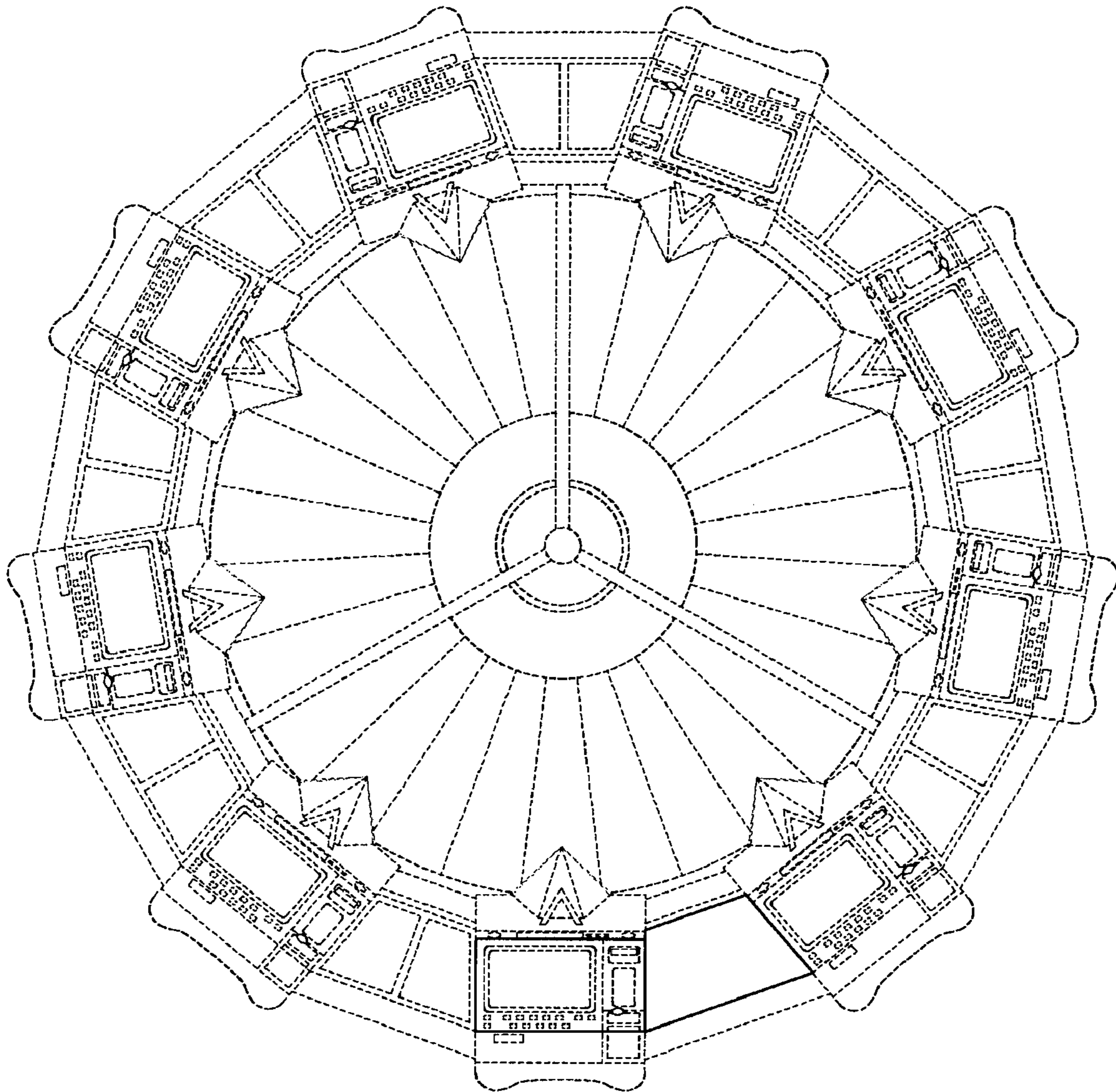
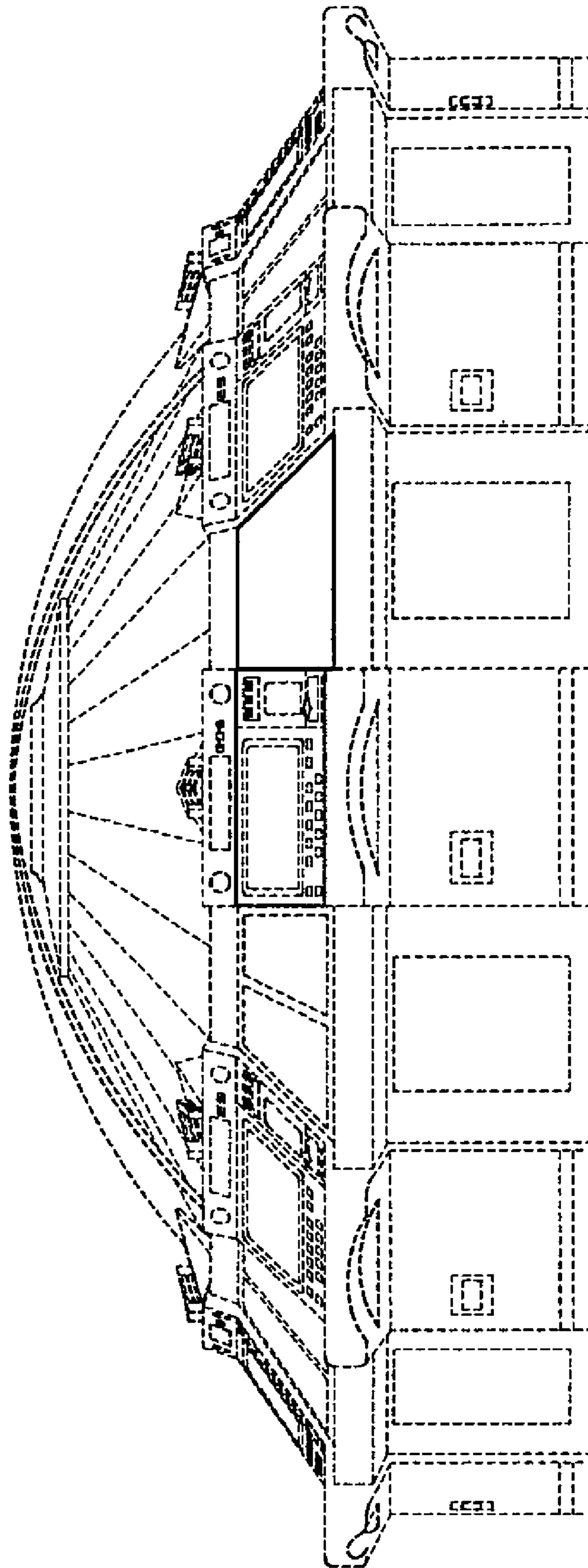

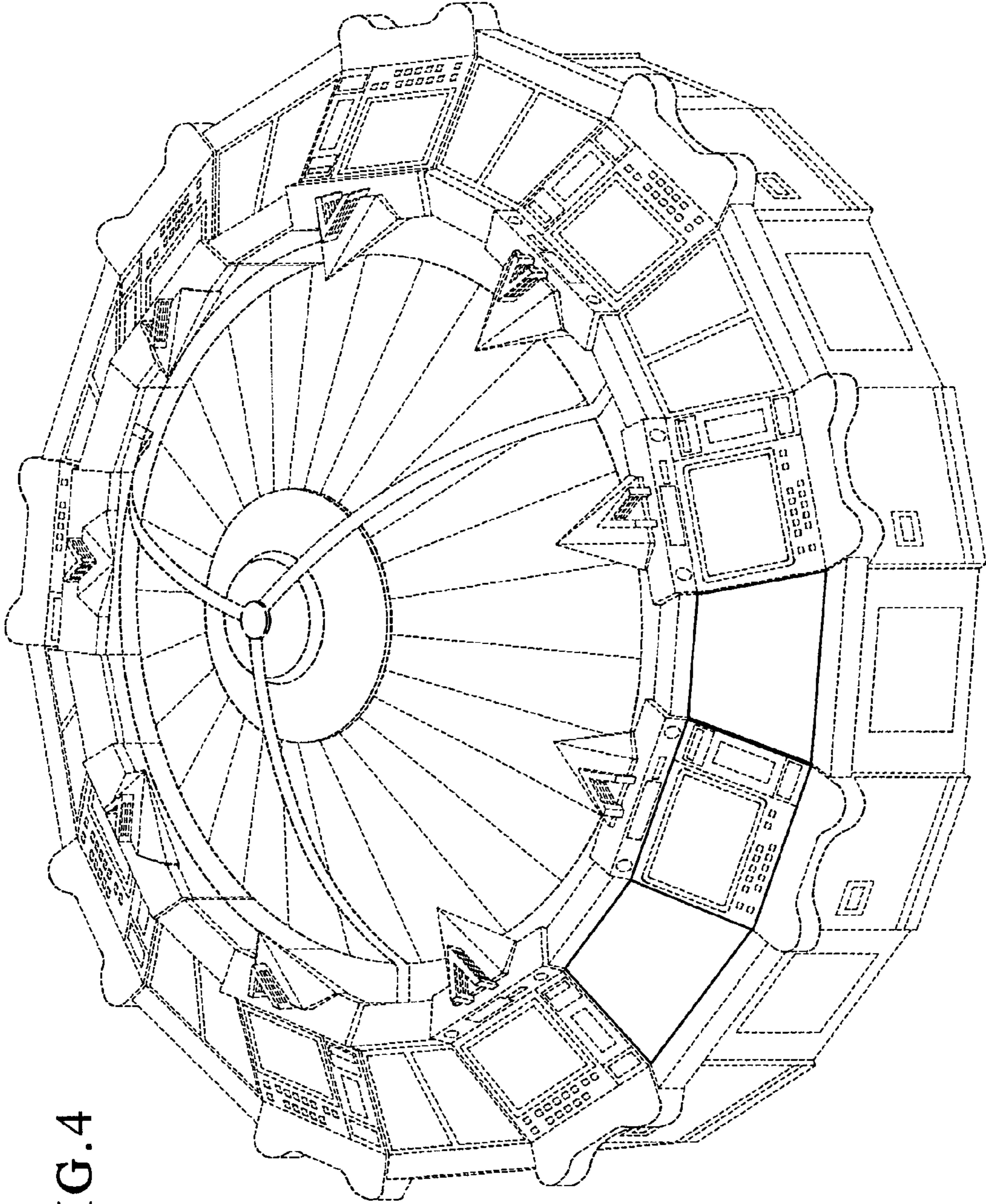

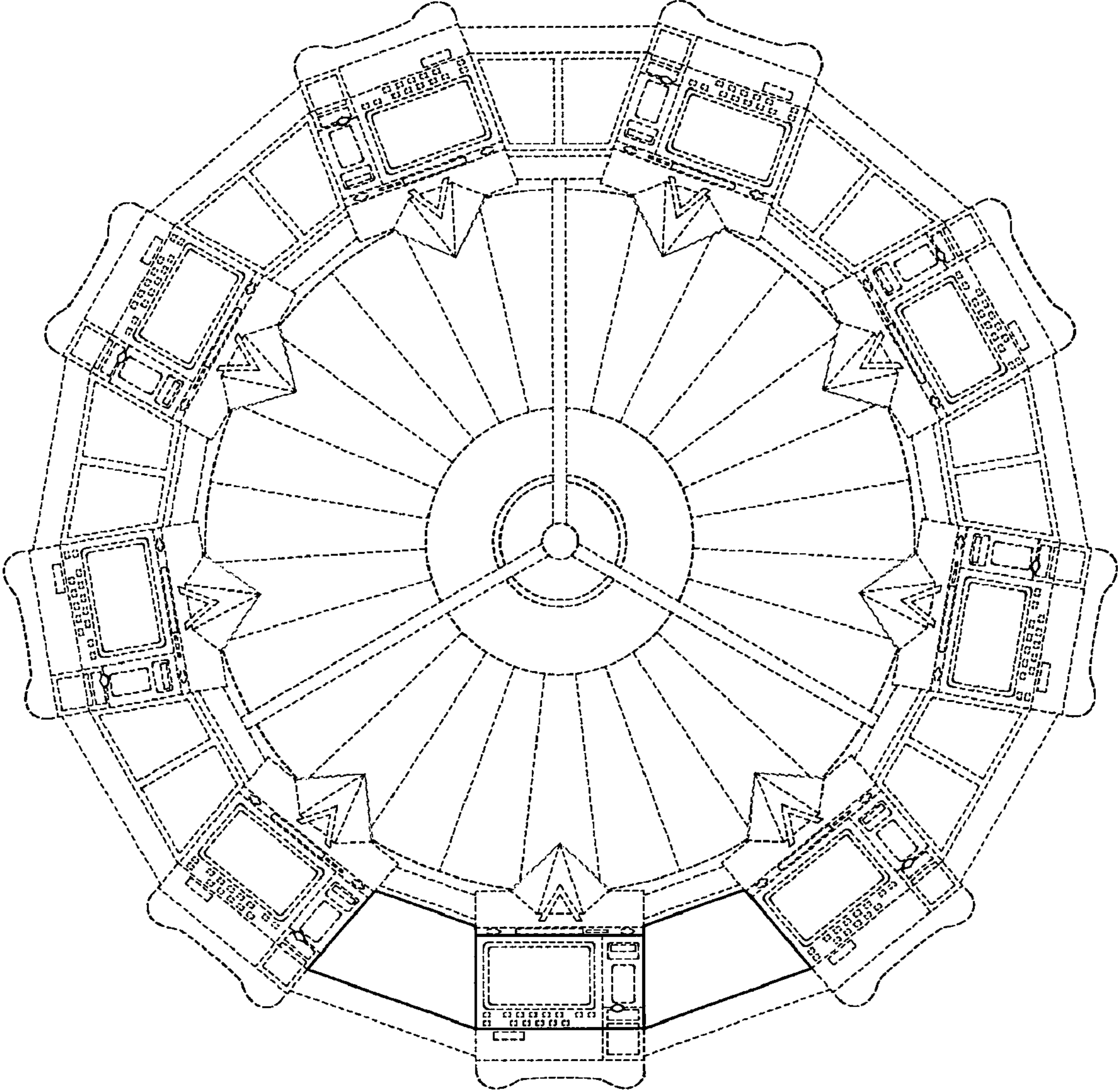
