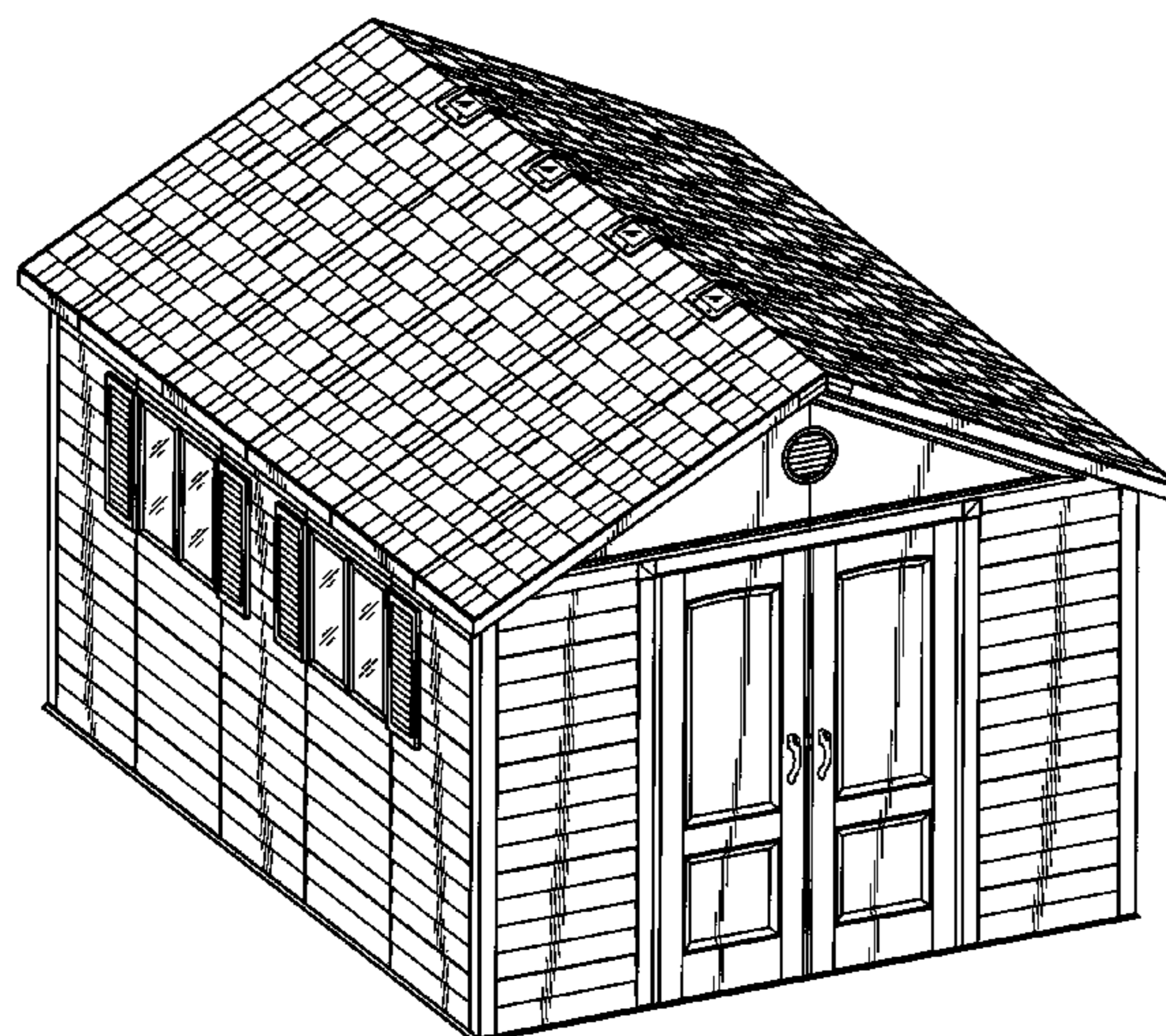
The ornamental design for a shed, as shown and described.

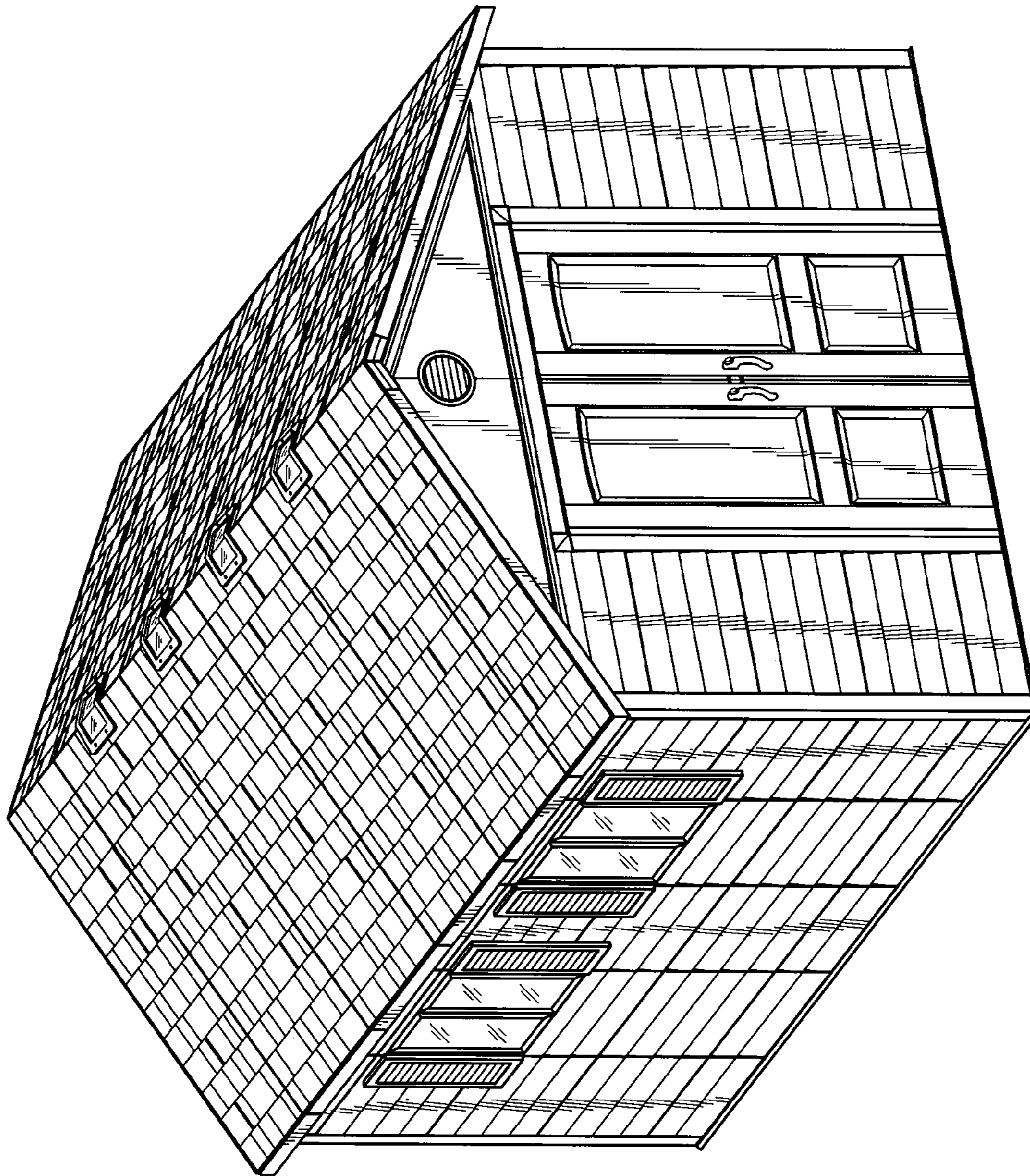

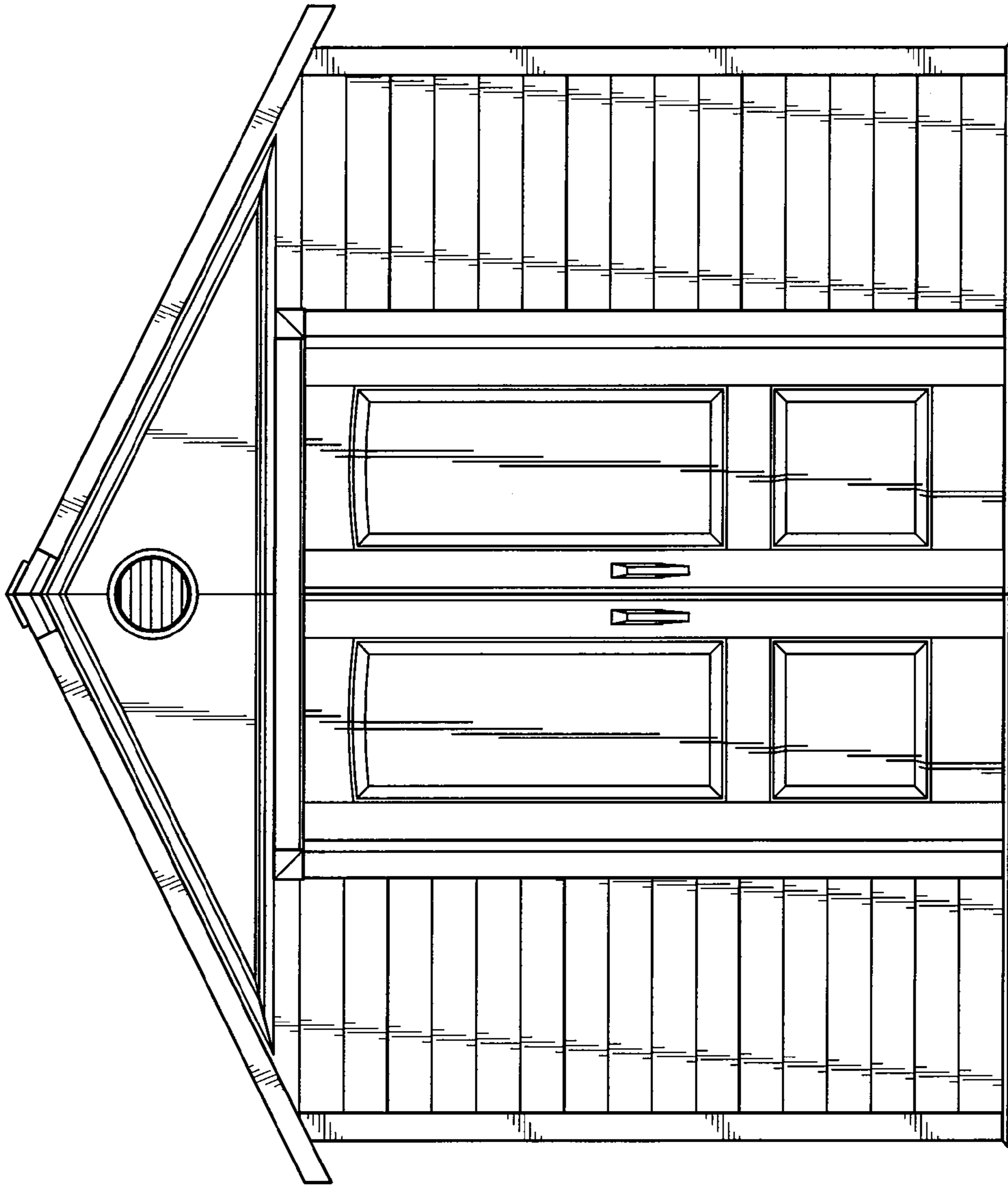
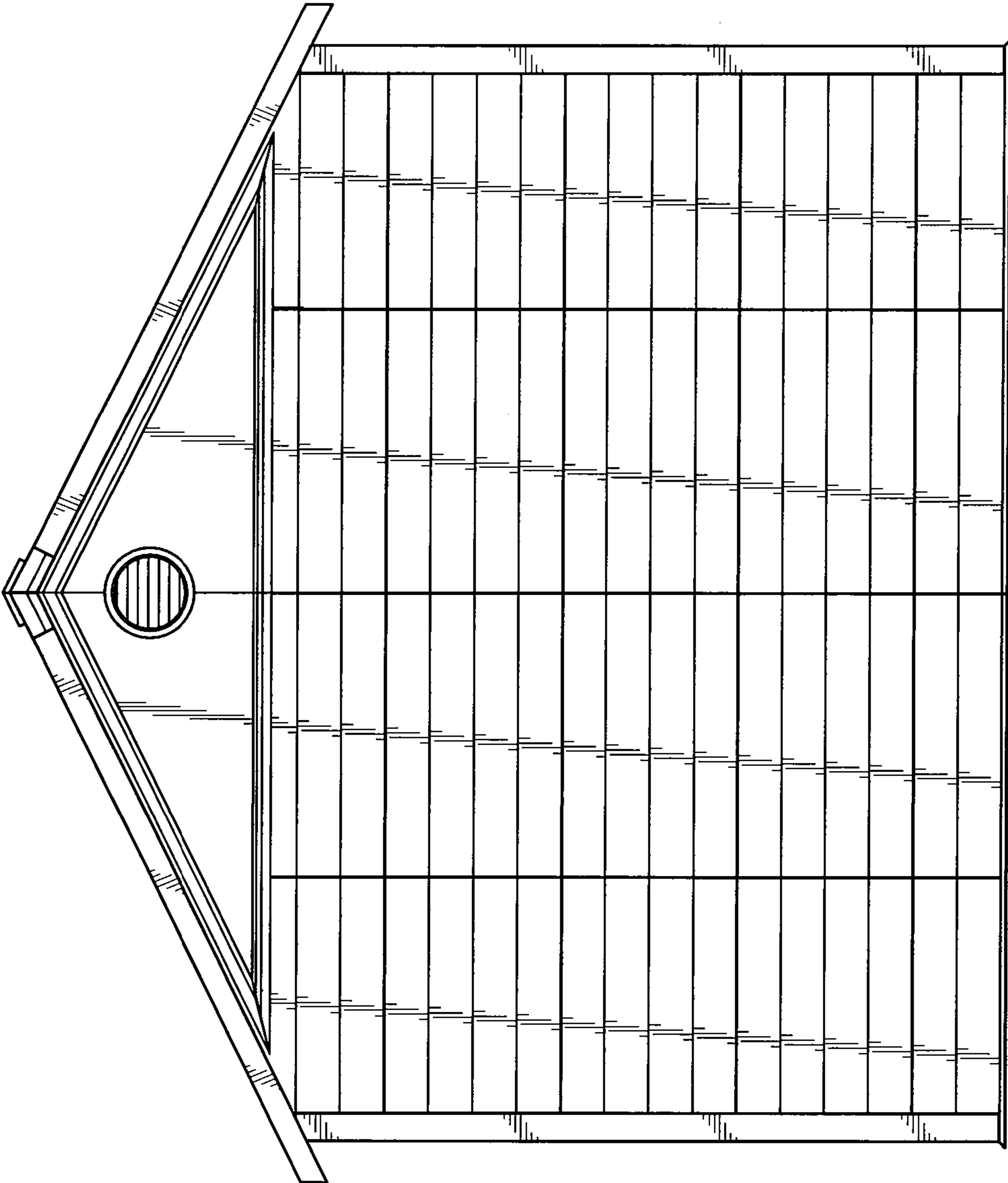

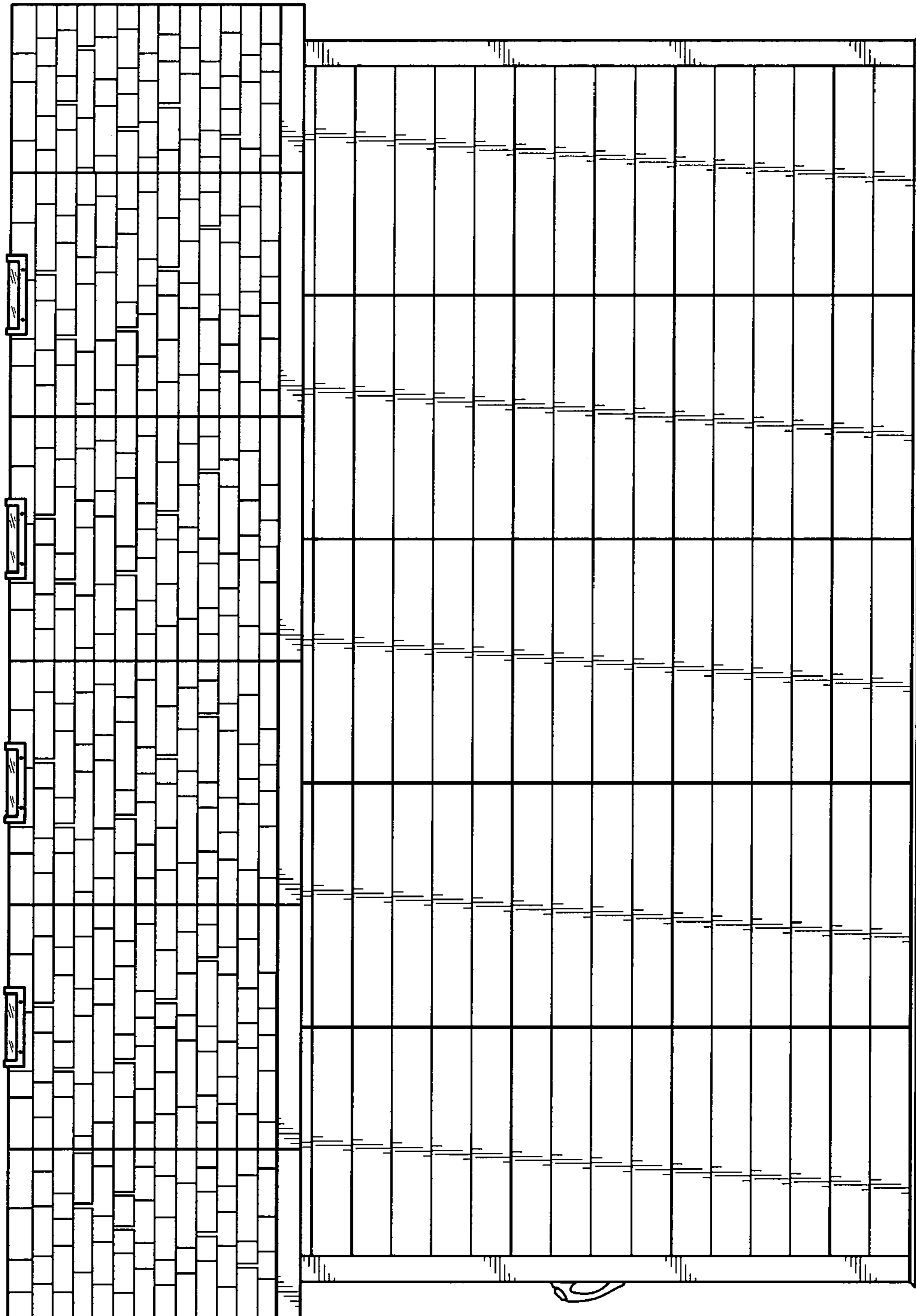

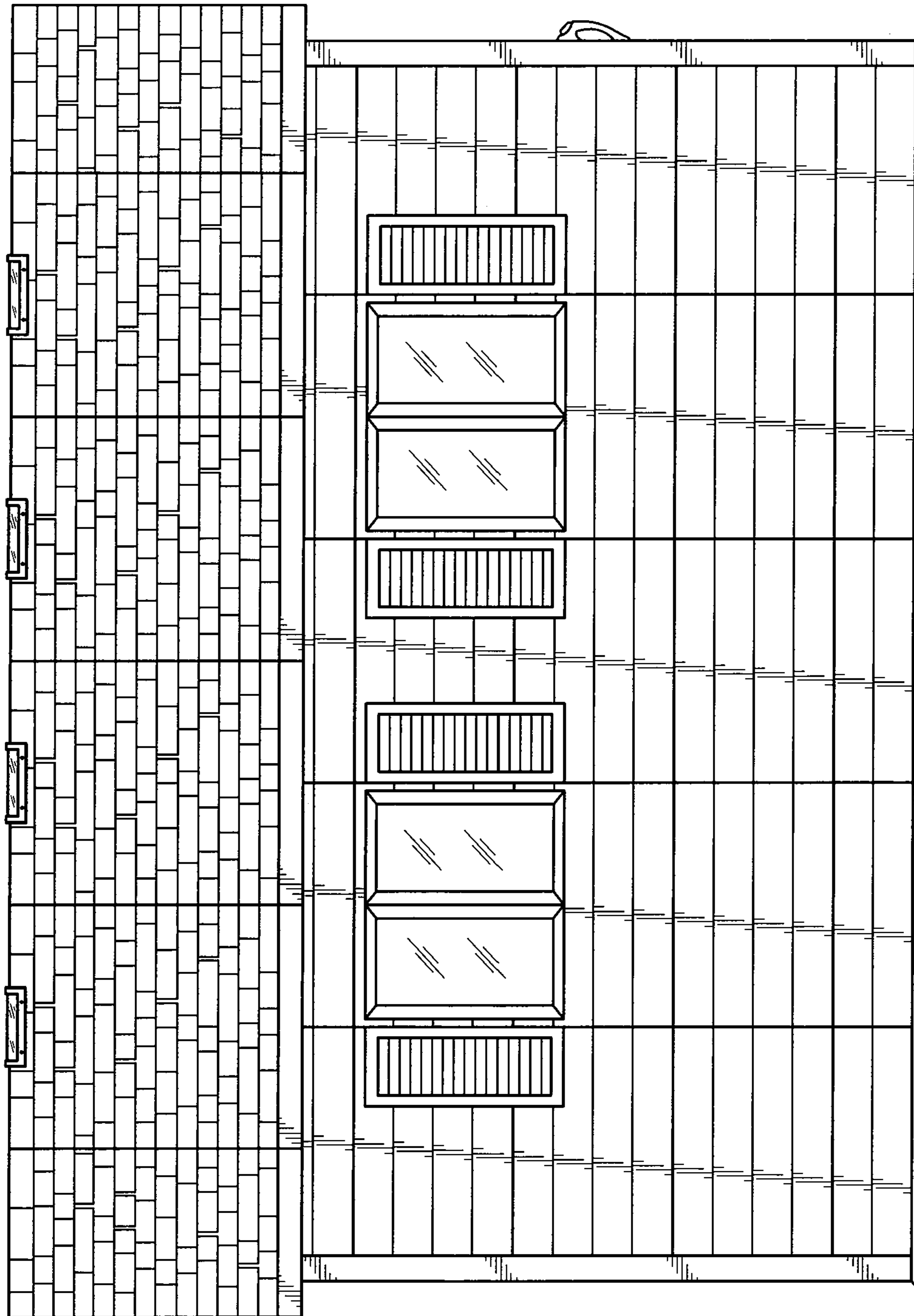

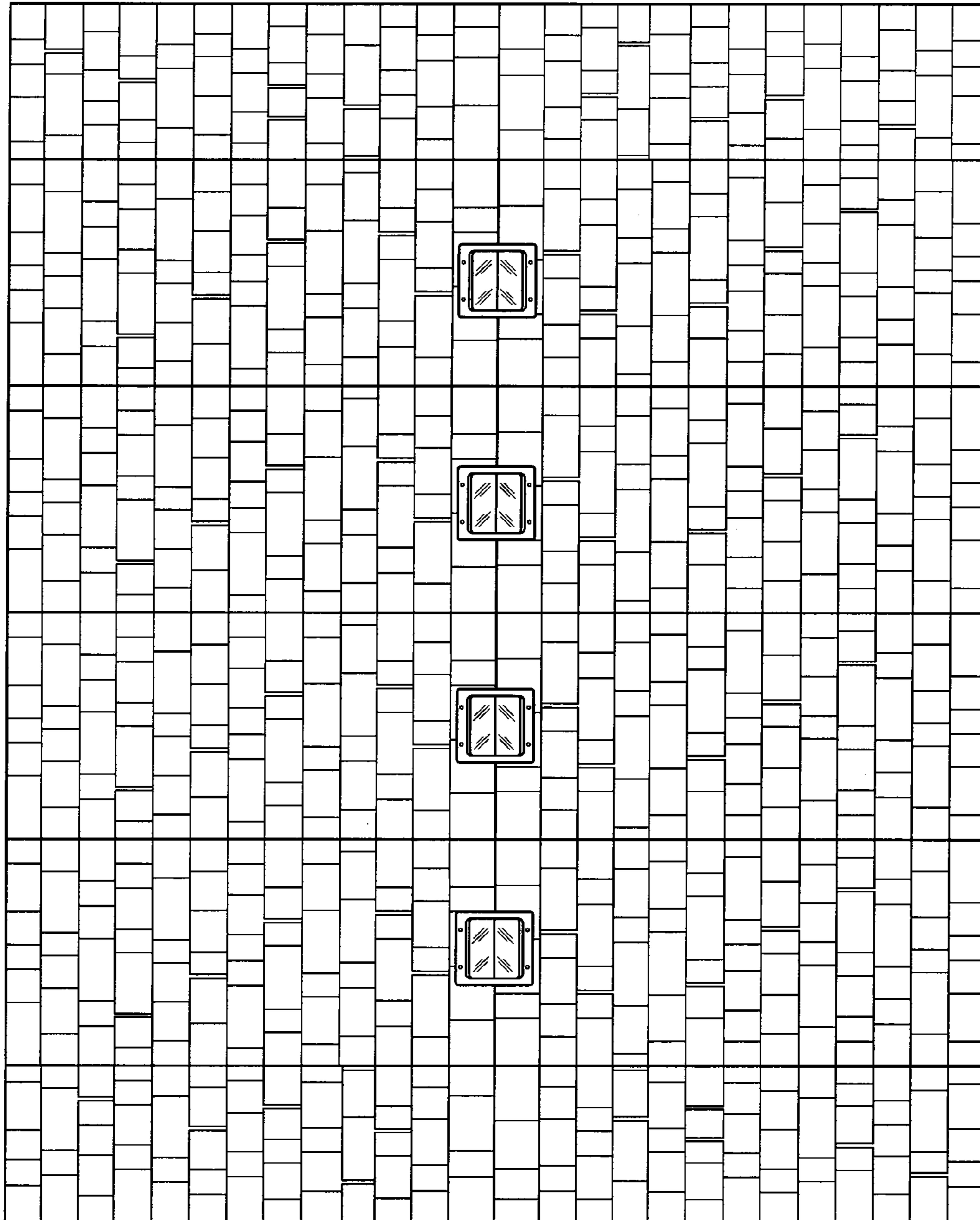
