(57) **CLAIM**

The ornamental design for a lampshade, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a lampshade comprising a first embodiment of the new, original and ornamental design, the rear, left-hand and right-hand side views being a mirror image thereof.

FIG. 2 is a bottom view of a lampshade comprising the first embodiment of the new, original and ornamental design.

FIG. 3 is a top view of a lampshade comprising the first embodiment of the new, original and ornamental design.

FIG. 4 is a front view of a lampshade comprising a second embodiment of the new, original and ornamental design, the rear, left-hand and right-hand side views being a mirror image thereof.

FIG. 5 is a bottom view of a lampshade comprising the second embodiment of the new, original and ornamental design.

FIG. 6 is a top view of a lampshade comprising the second embodiment of the new, original and ornamental design.

FIG. 7 is a front view of a lampshade comprising a third embodiment of the new, original and ornamental design, the rear, left-hand and right-hand side views being a mirror image thereof.

FIG. 8 is a bottom view of a lampshade comprising the third embodiment of the new, original and ornamental design.

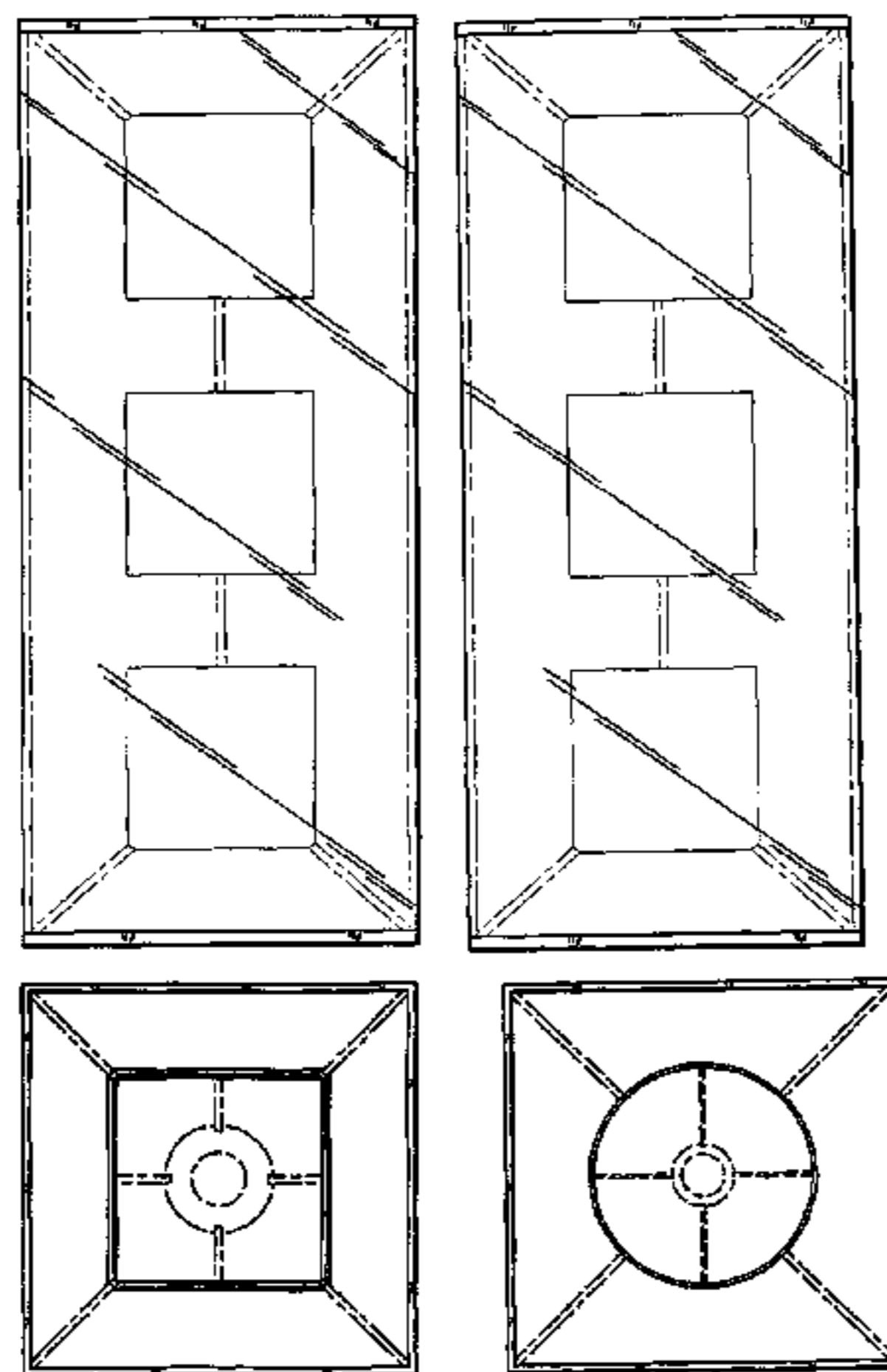
FIG. 9 is a top view of a lampshade comprising the third embodiment of the new, original and ornamental design.

FIG. 10 is a front view of a lampshade comprising a fourth embodiment of the new, original and ornamental design, the rear, left-hand and right-hand side views being a mirror image thereof.

FIG. 12 is a top view of a lampshade comprising the fourth embodiment of the new, original and ornamental design.

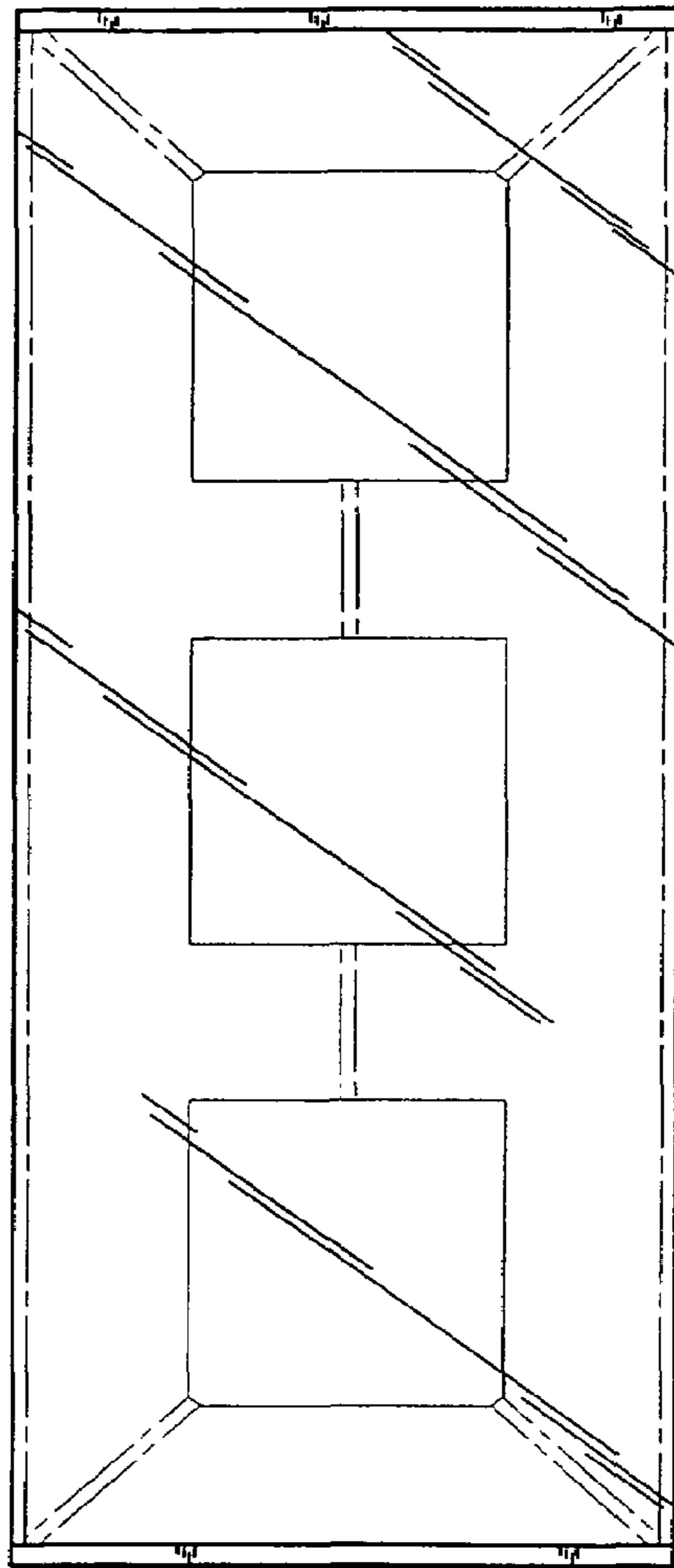

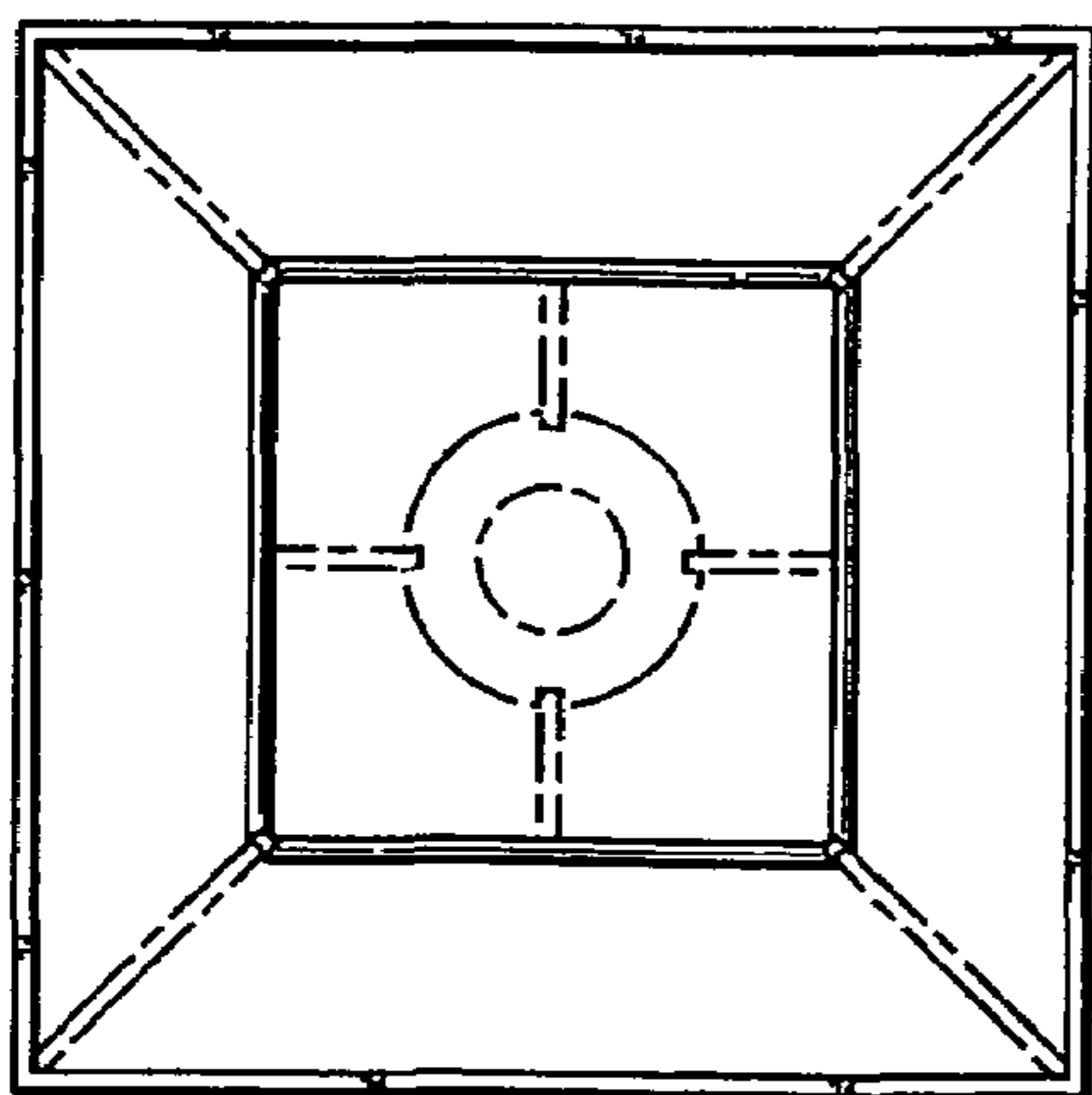

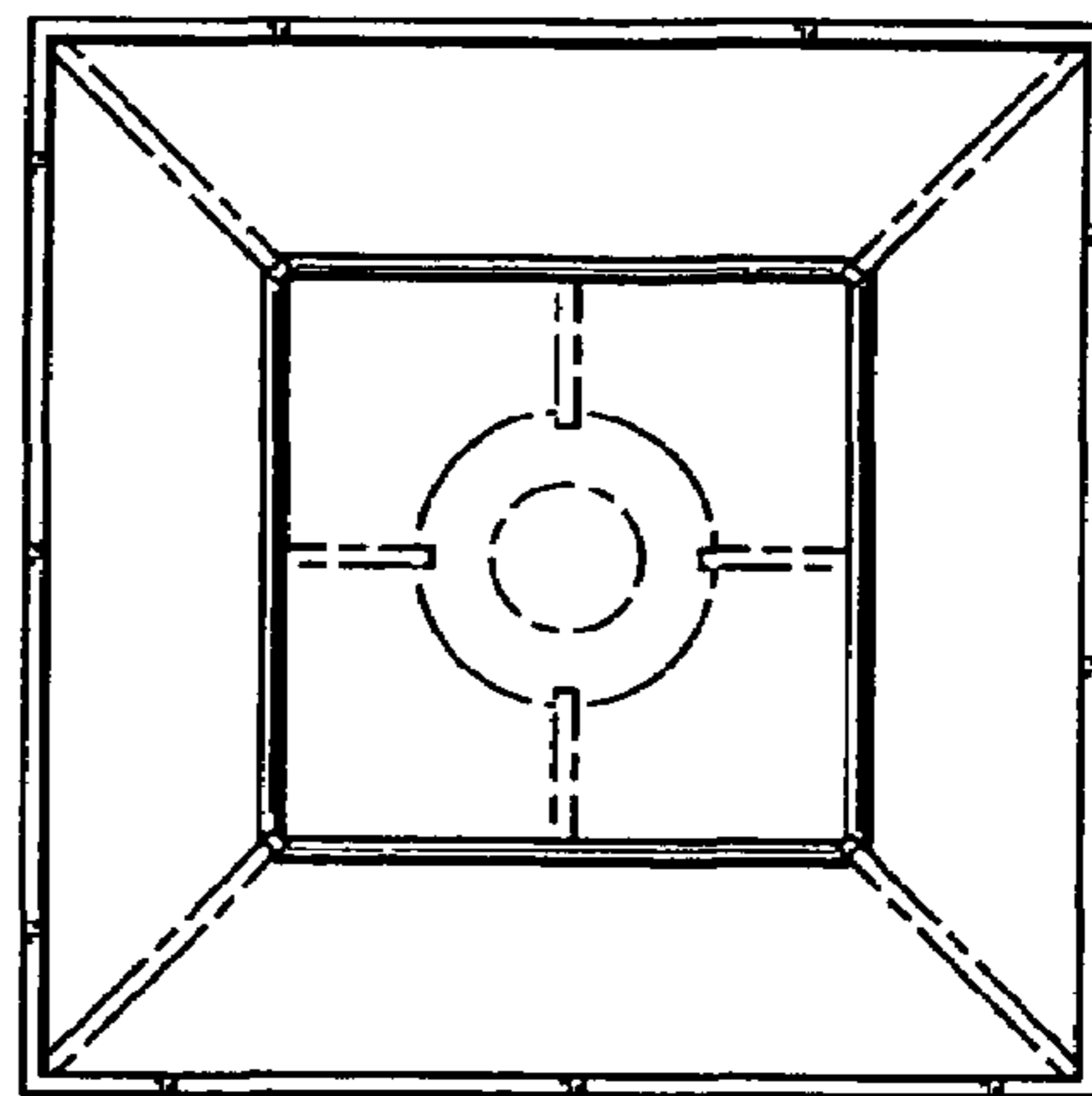

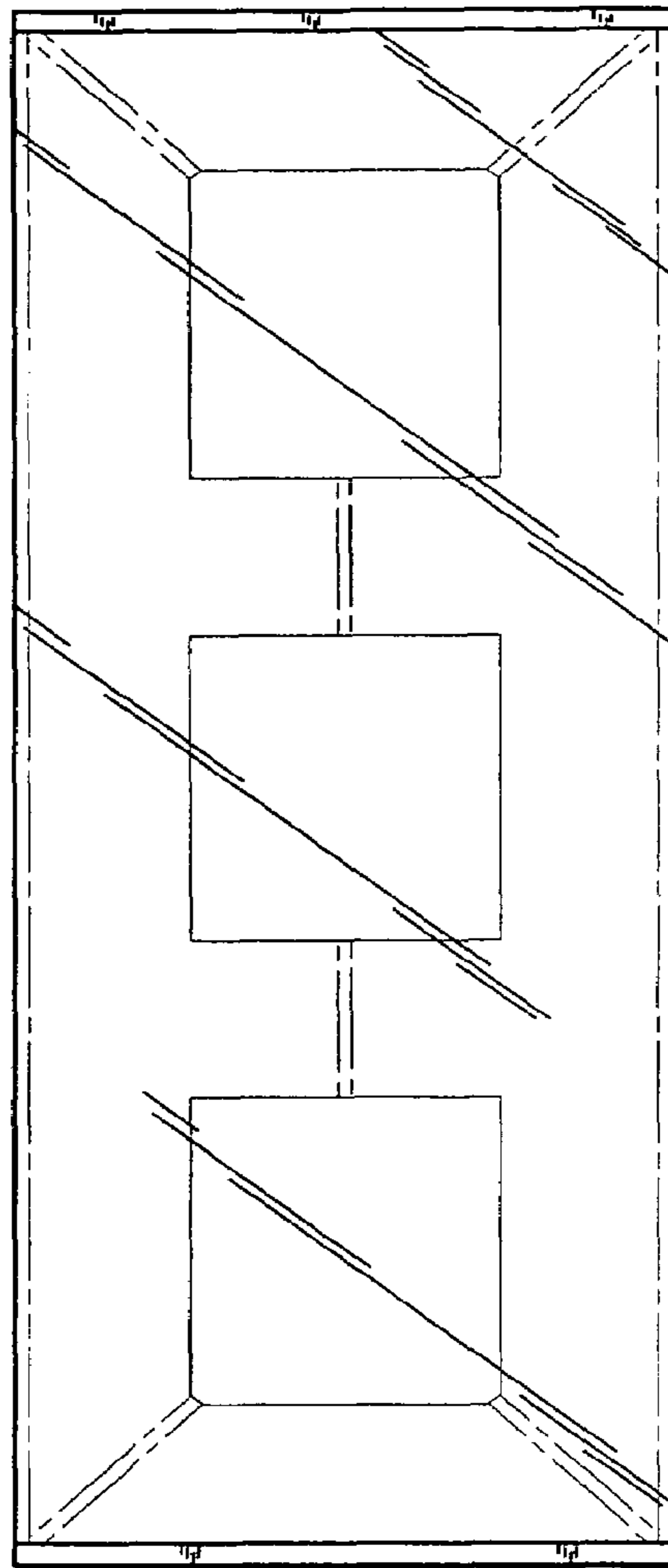

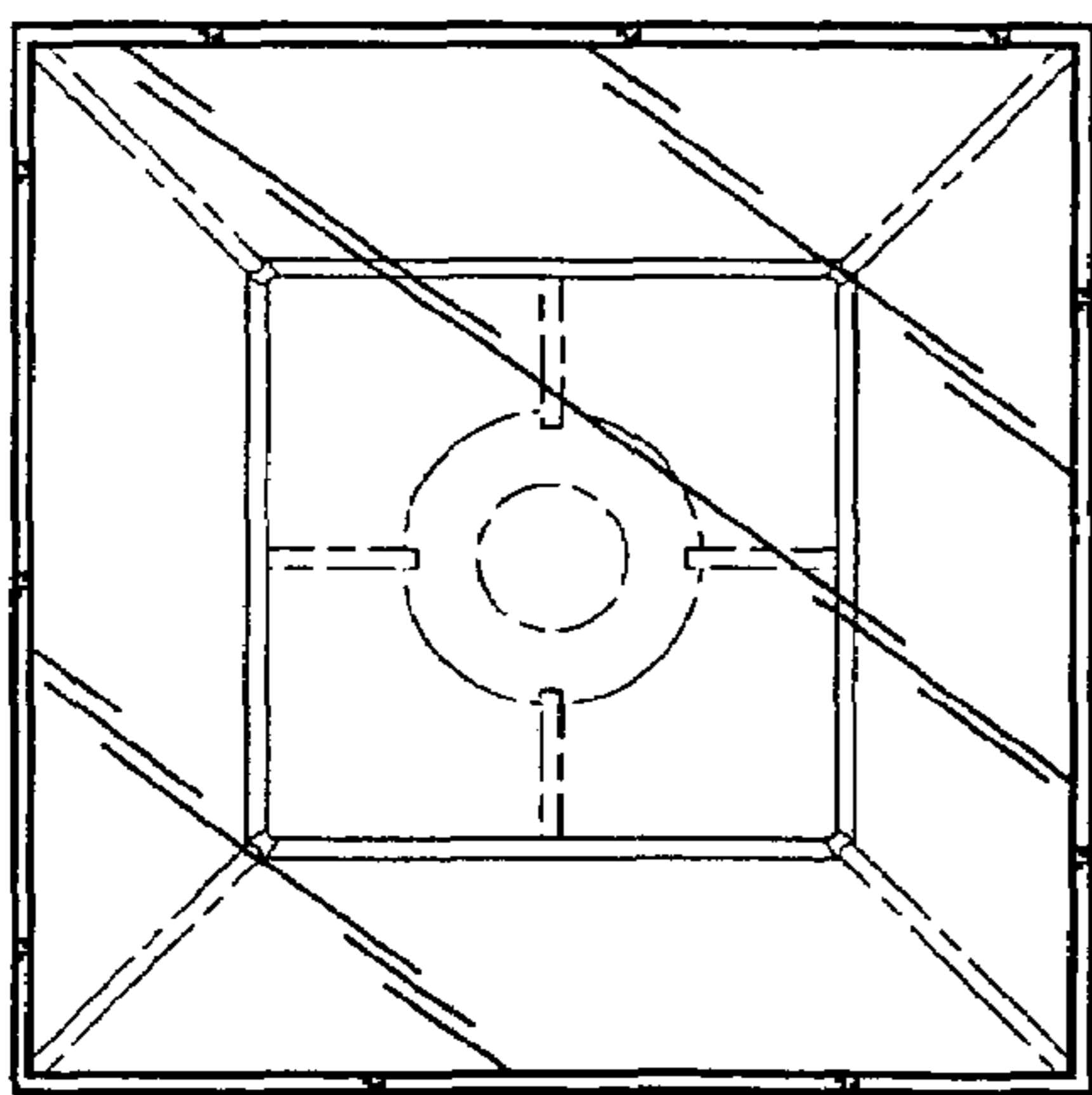

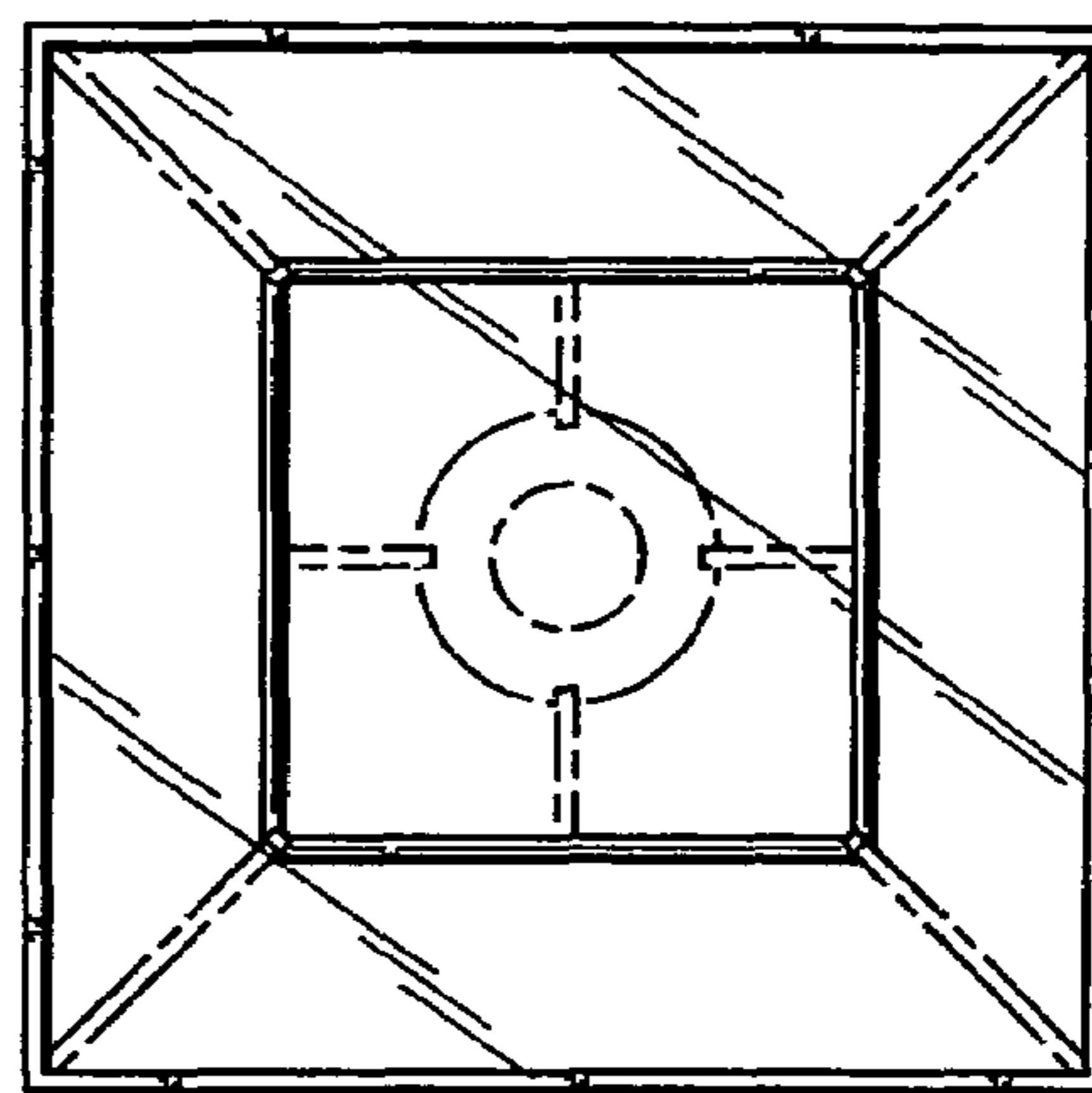

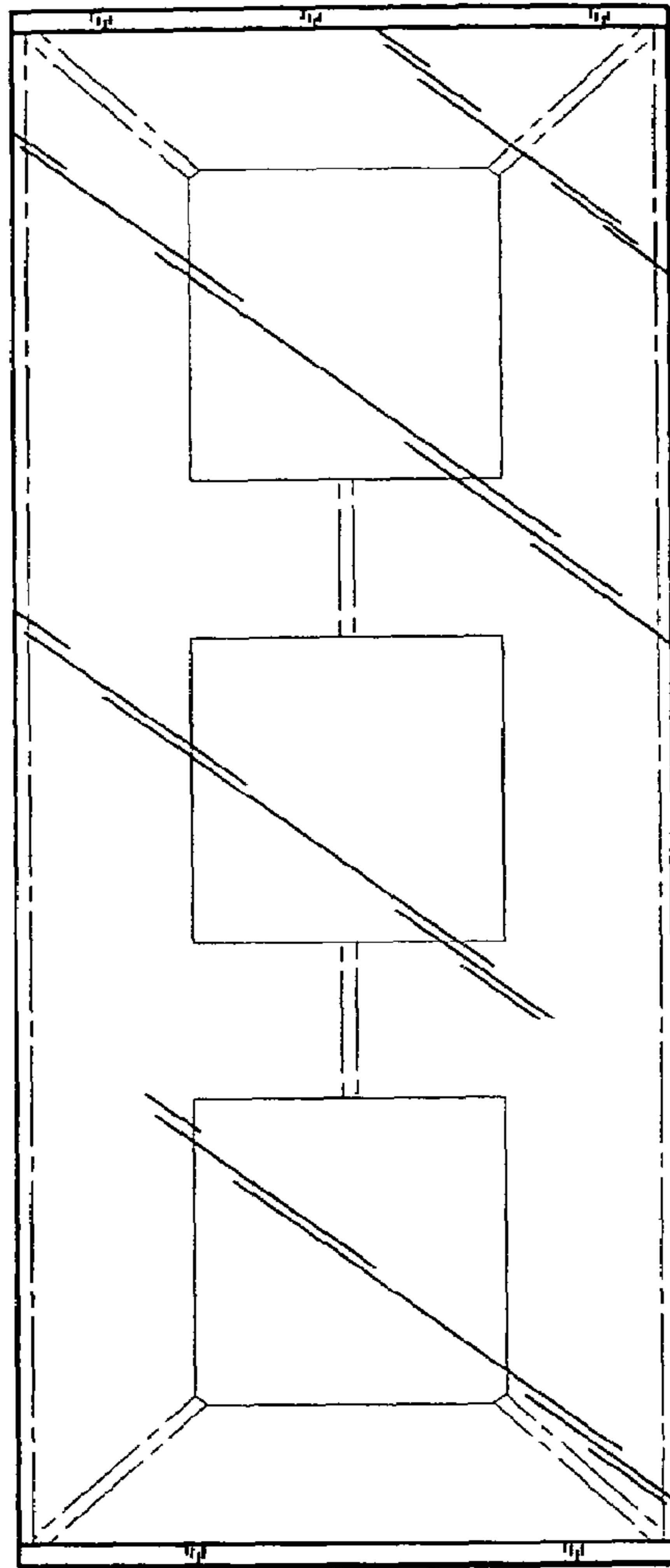

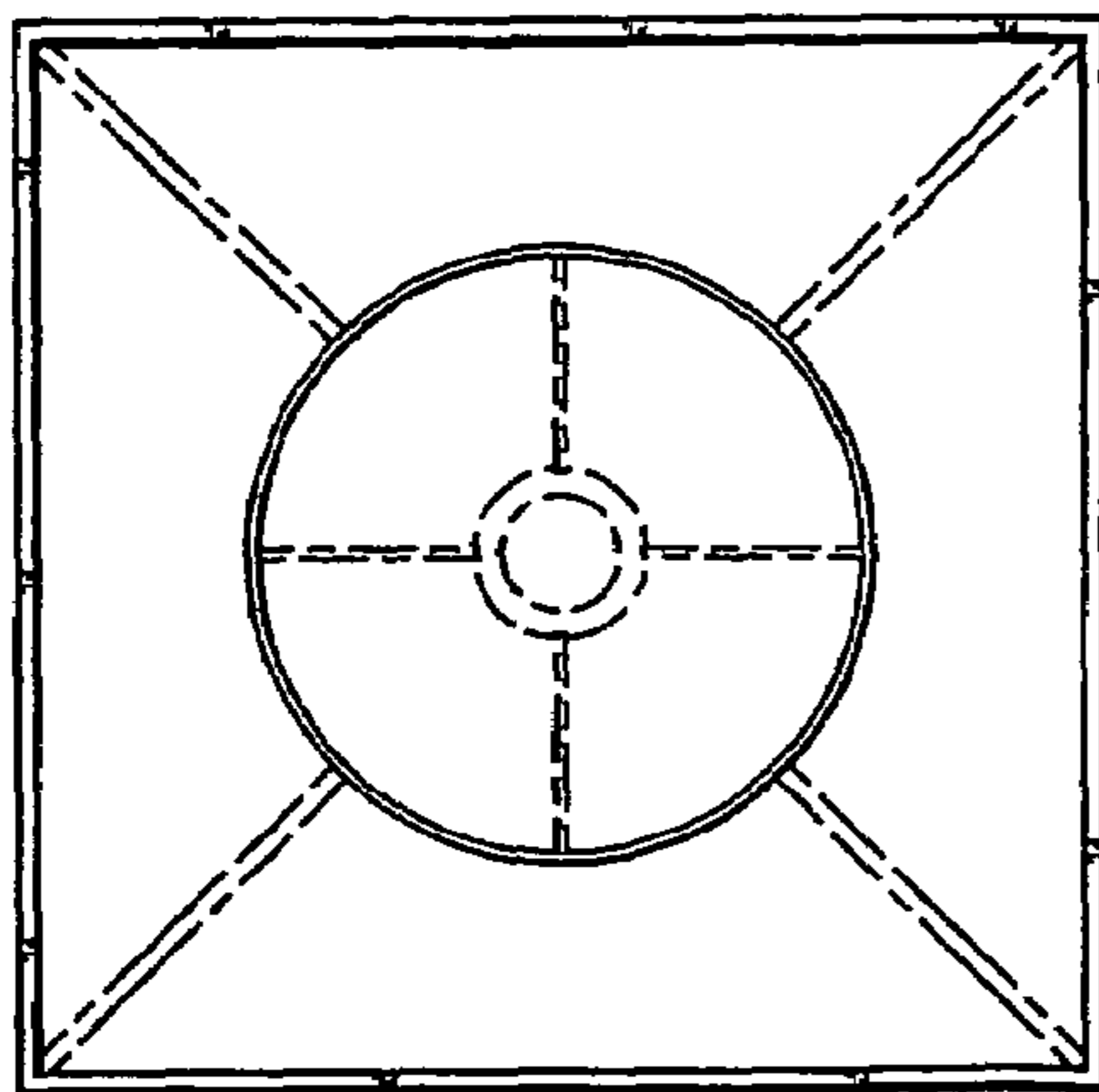

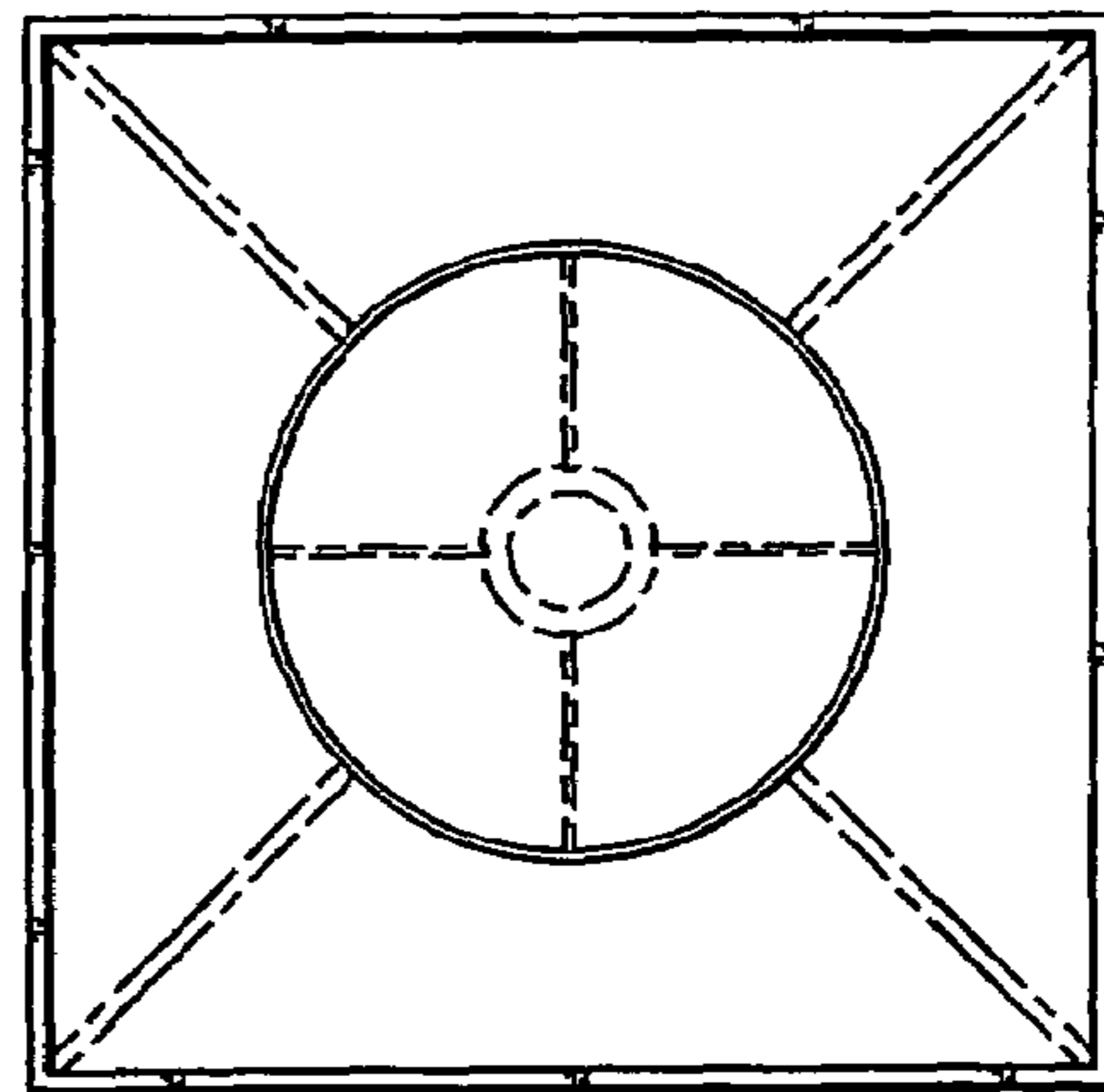

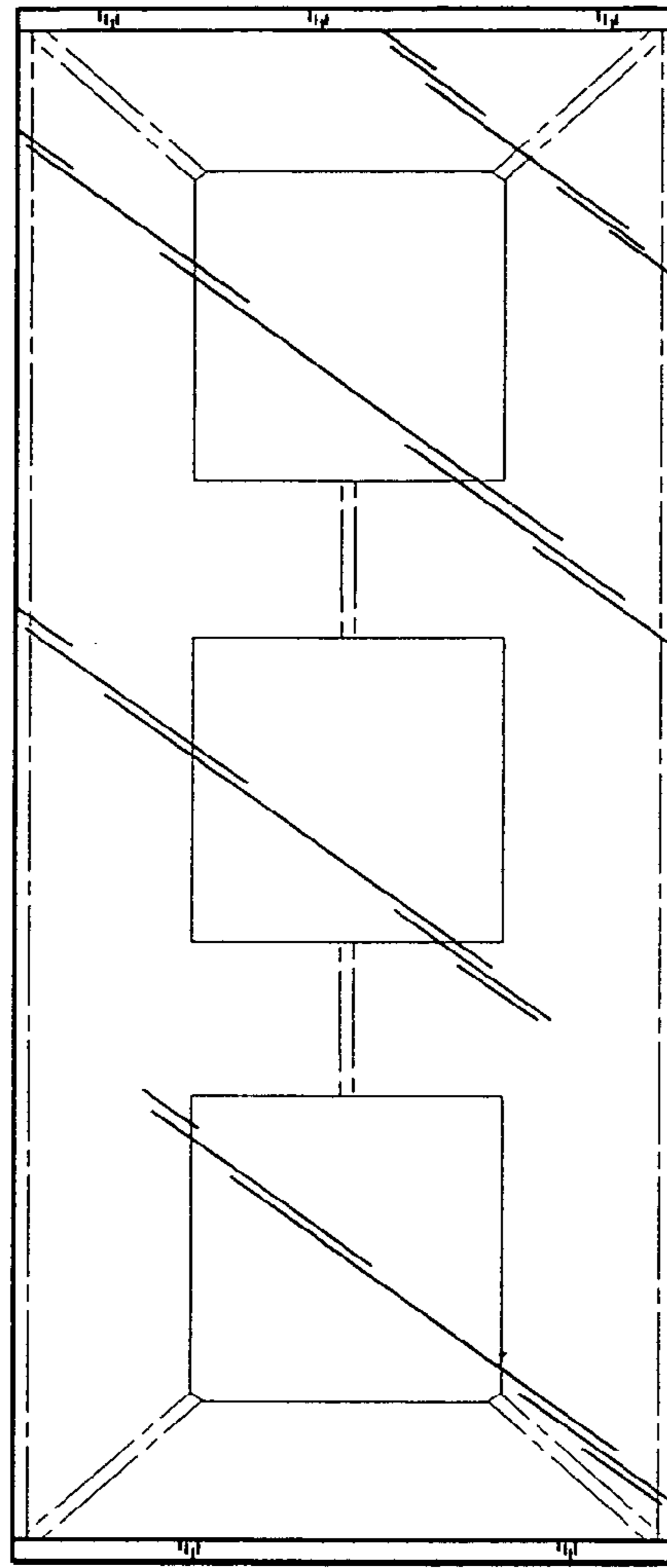

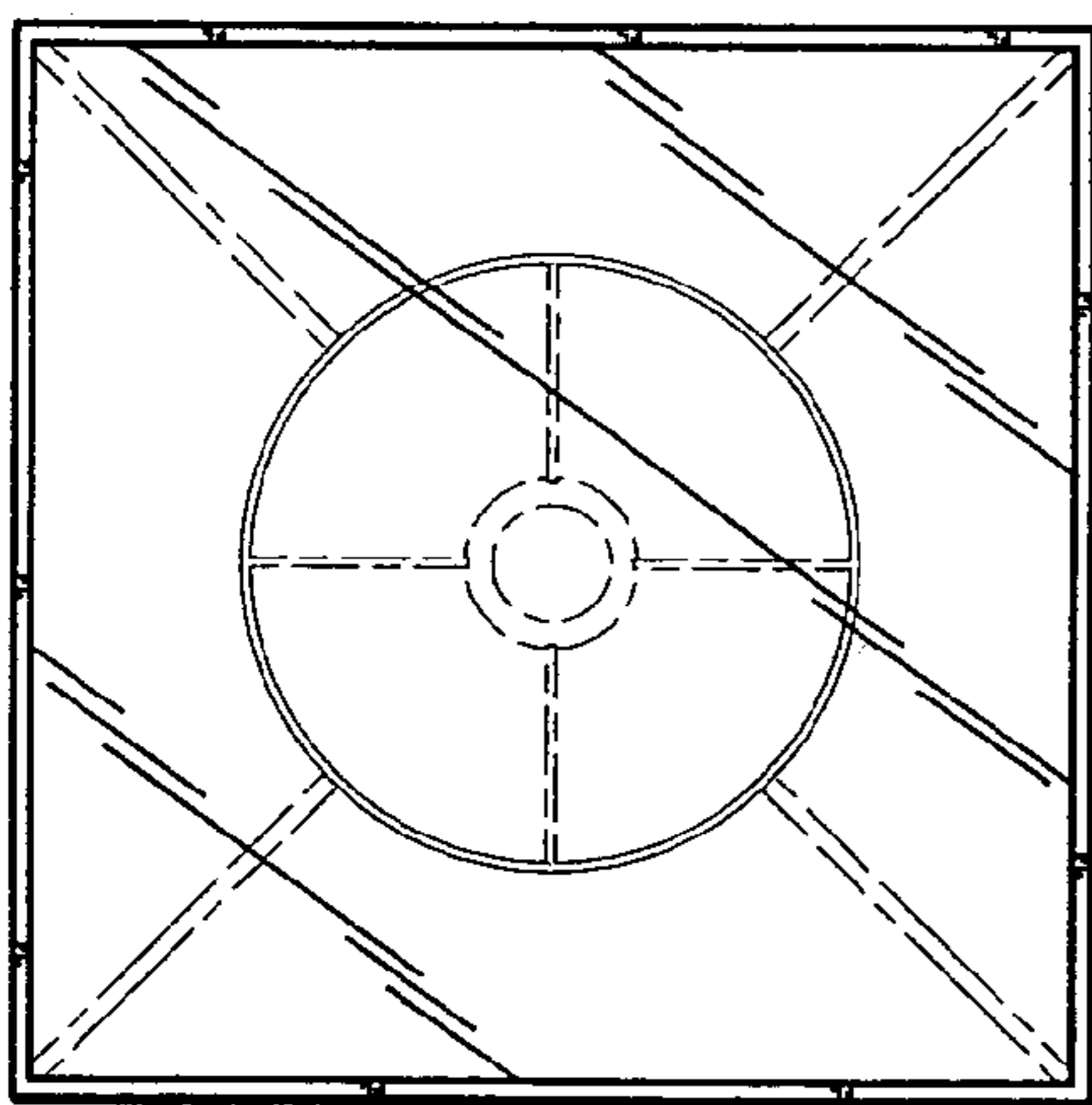

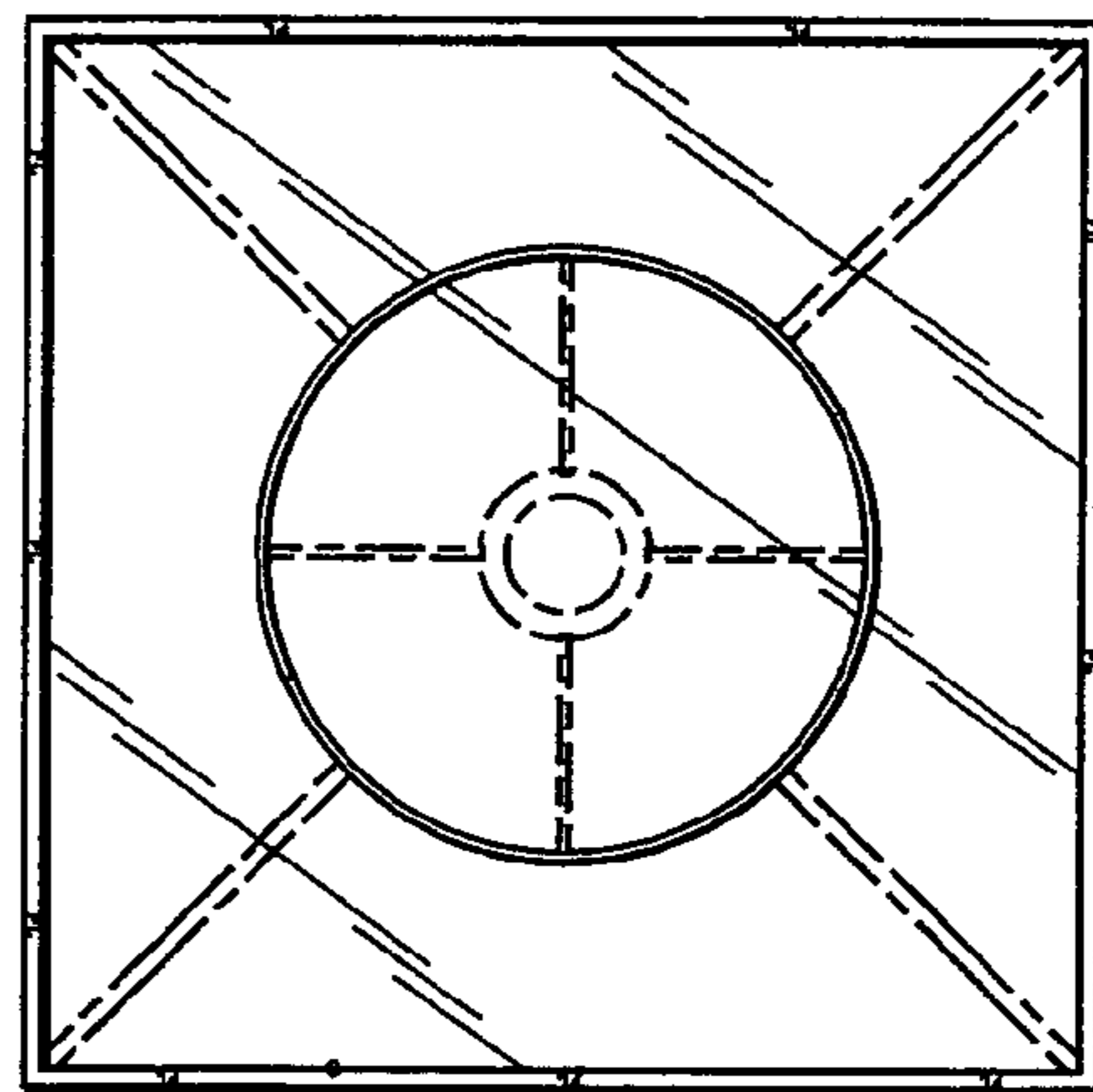
