(57) **CLAIM**

The ornamental design for a scrubber, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a scrubber of the present invention showing our new design;

FIG. 2 is a top plan view of the scrubber of FIG. 1;

FIG. 3 is a front elevational view of the scrubber of FIG. 1, the rear elevational view being a mirror image thereof;

FIG. 4 is a left end view of the scrubber of FIG. 1;

FIG. 5 is a right end view of the scrubber of FIG. 1;

FIG. 6 is a bottom plan view of the scrubber of FIG. 1;

FIG. 7 is a perspective view of a second embodiment of a scrubber of the present invention showing our new design;

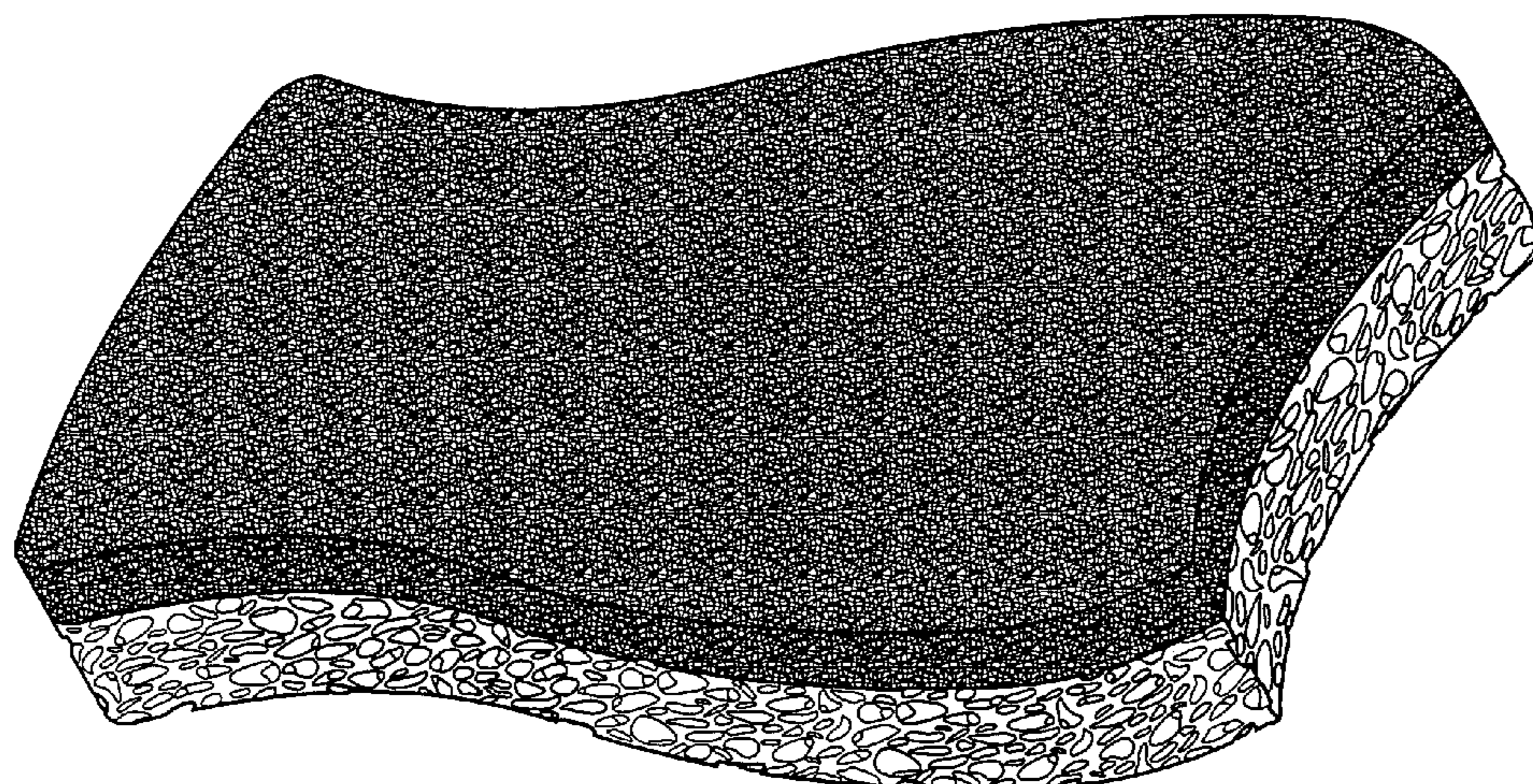
FIG. 8 is a front elevational view of the scrubber of FIG. 7, the rear elevational view being a mirror image thereof;

FIG. 9 is a left end view of the scrubber of FIG. 7;

FIG. 11 is a right end view of the scrubber of FIG. 7.

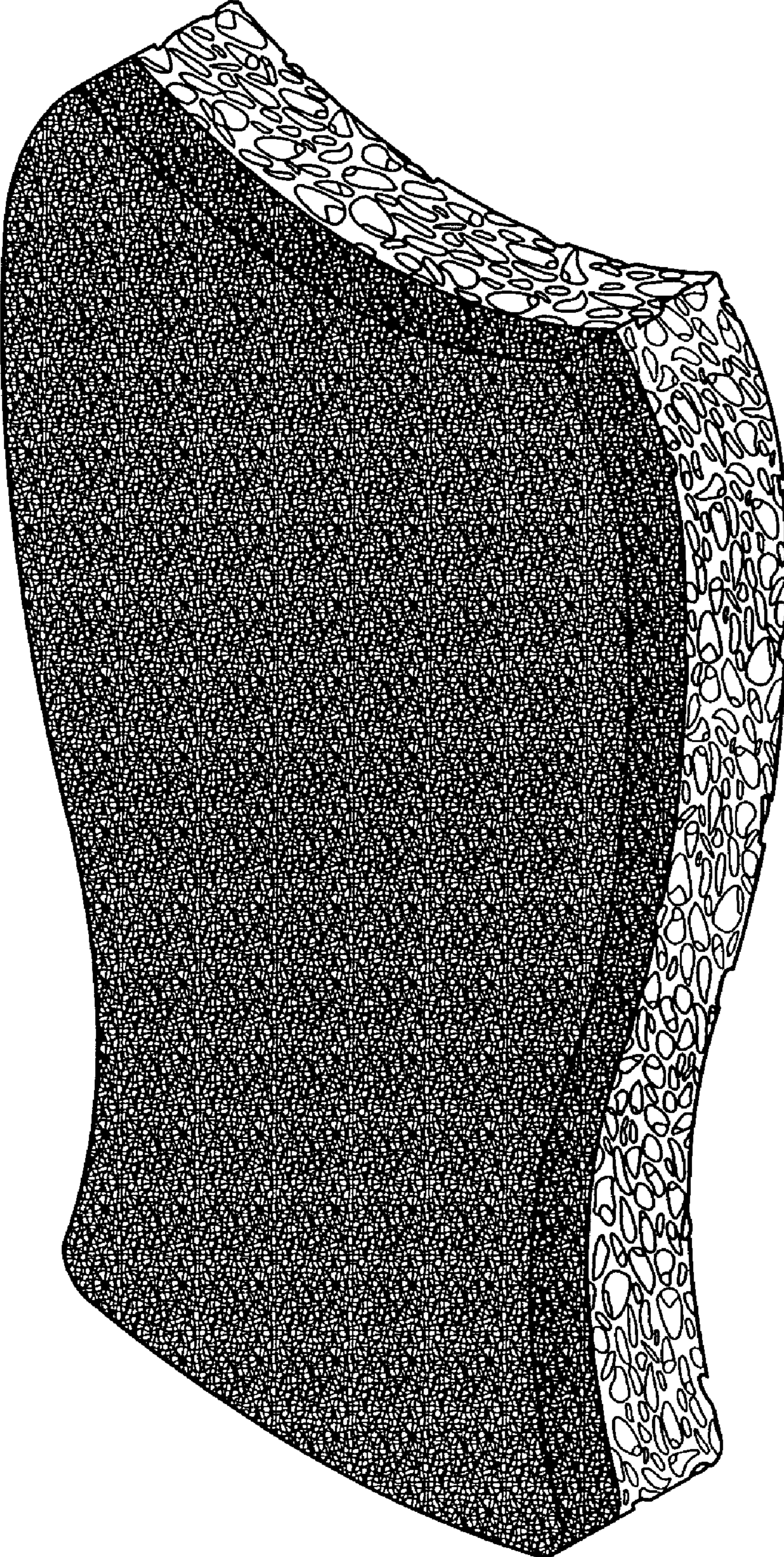

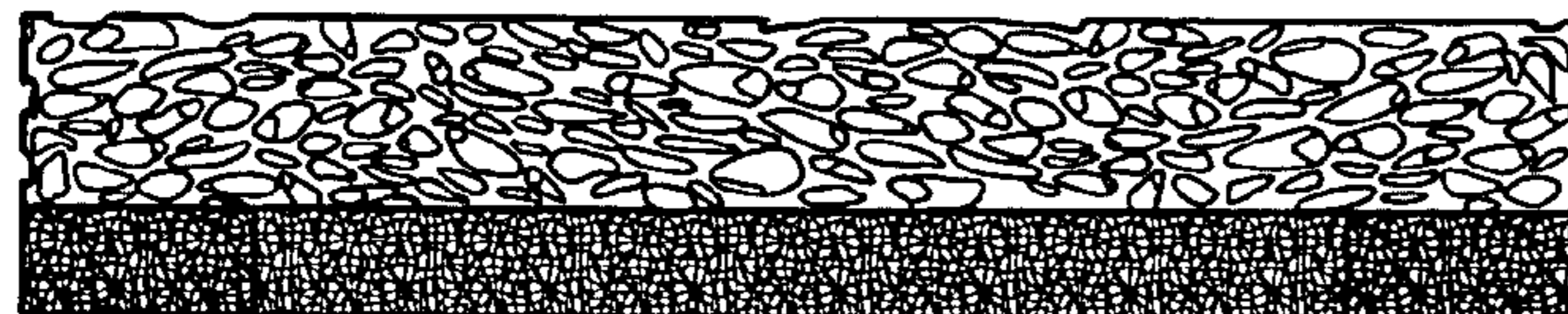

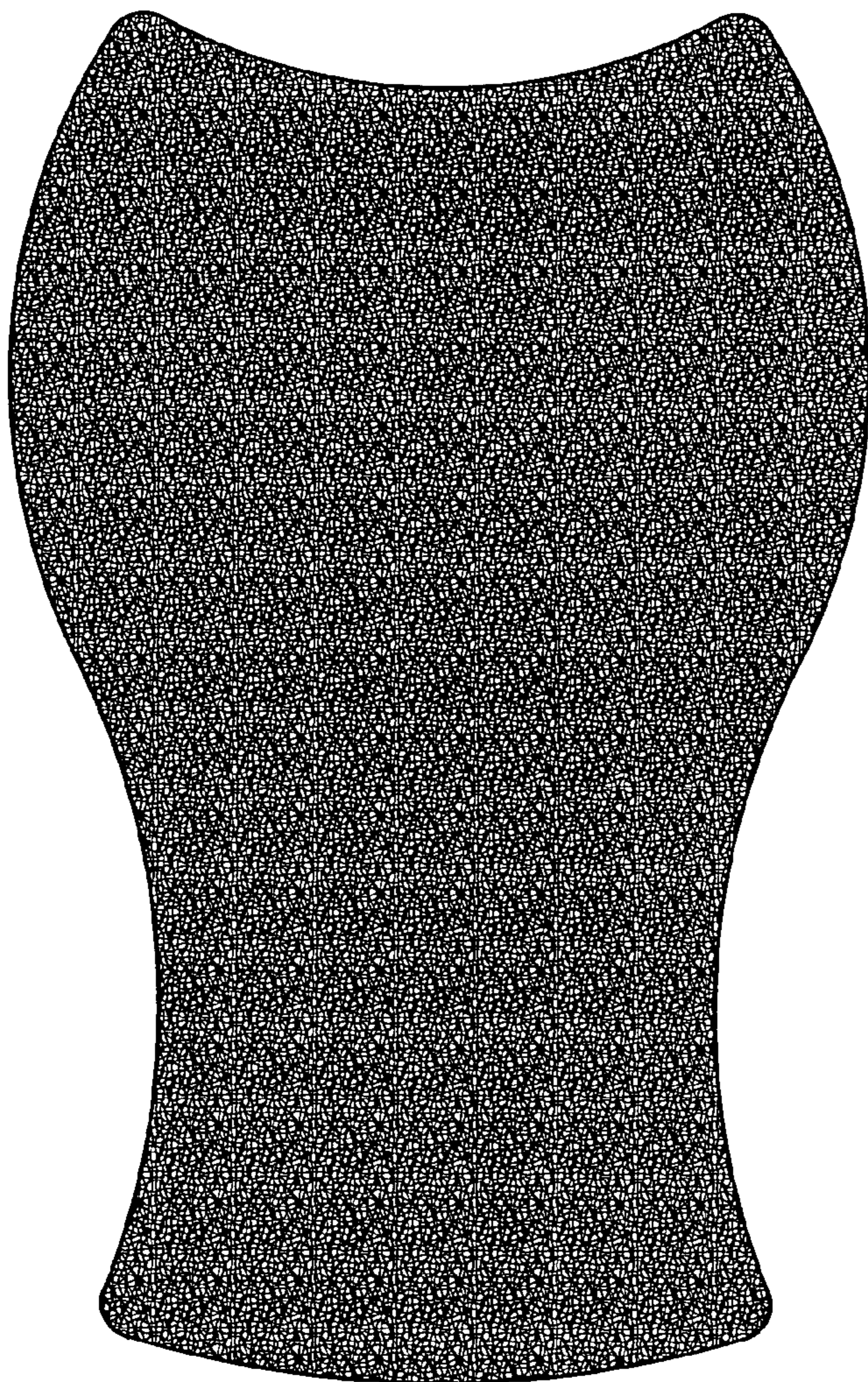

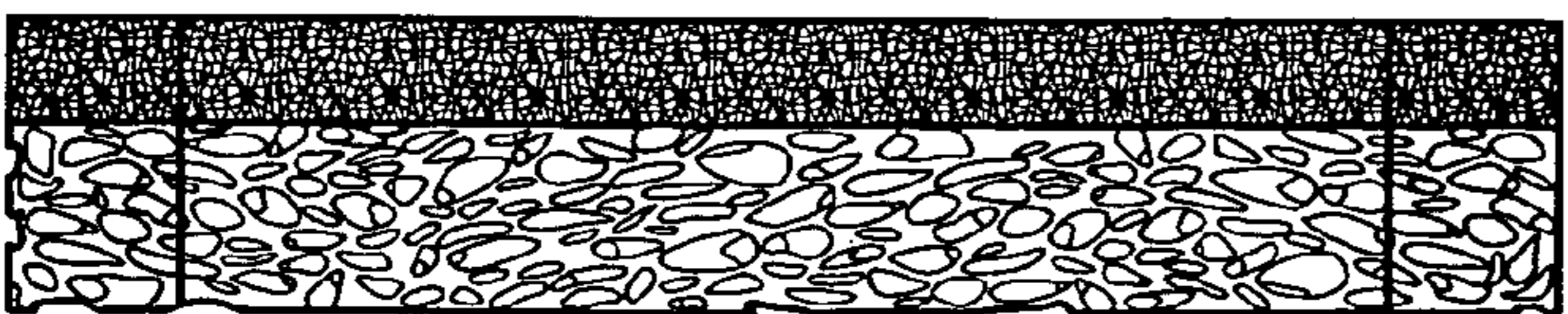

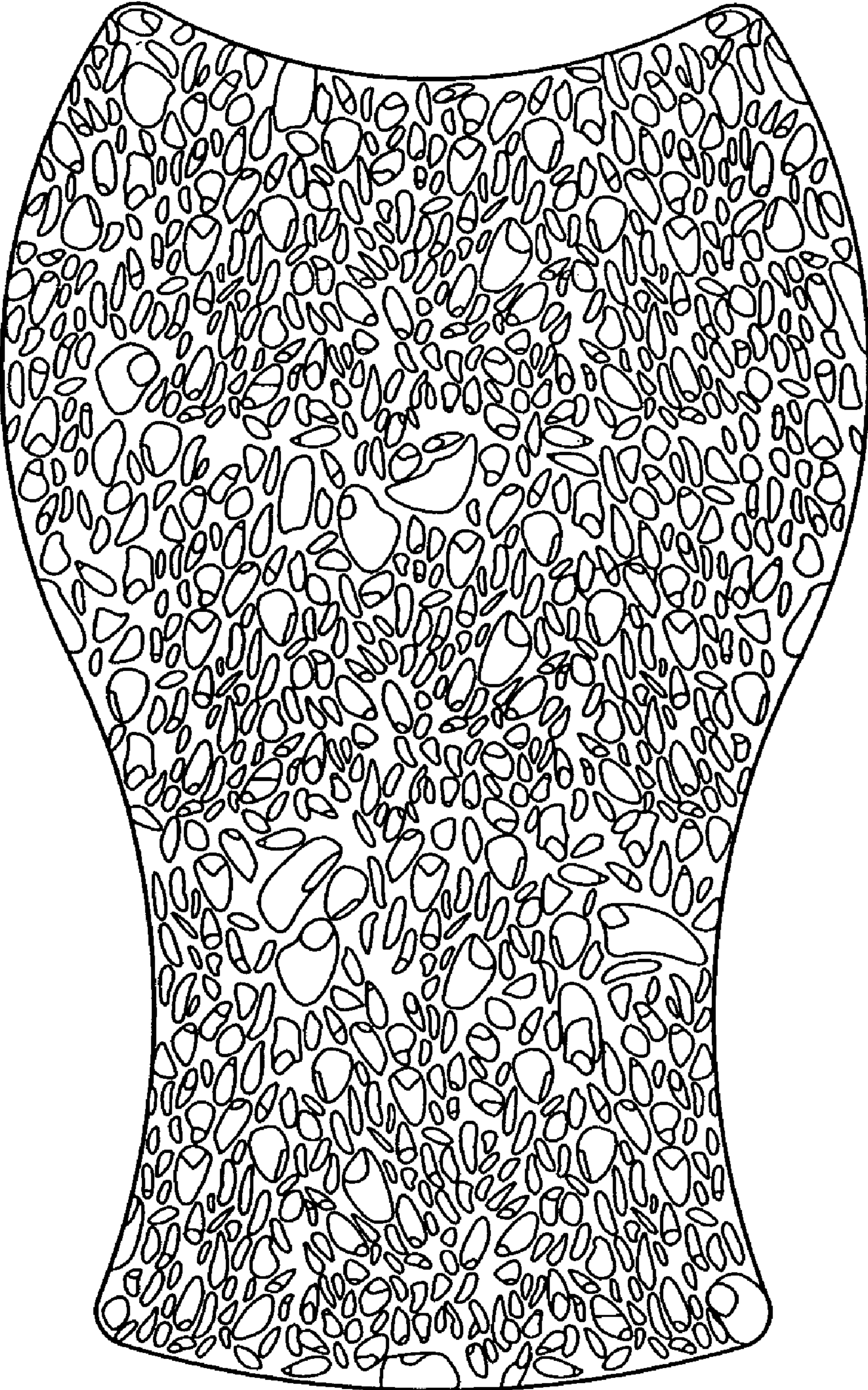

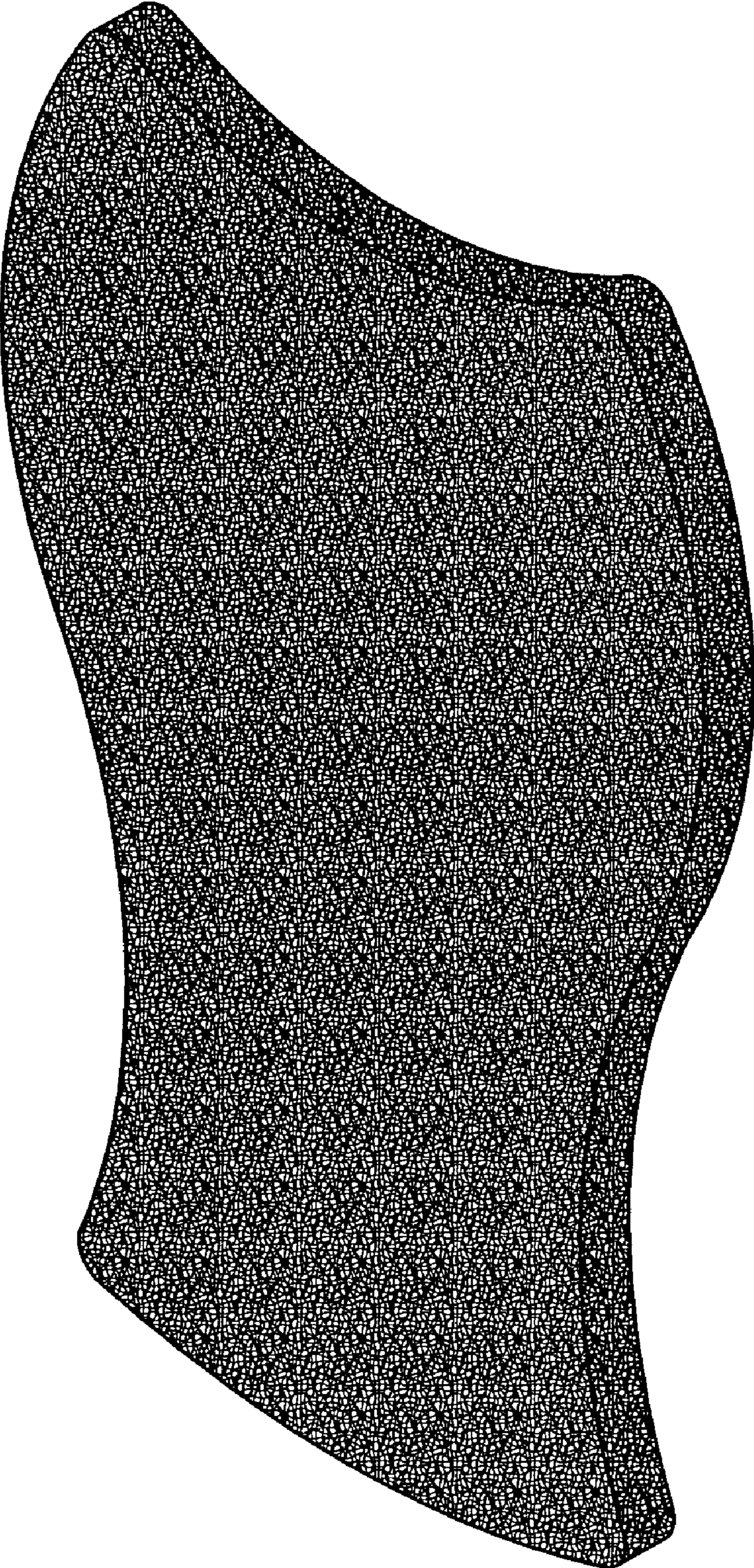

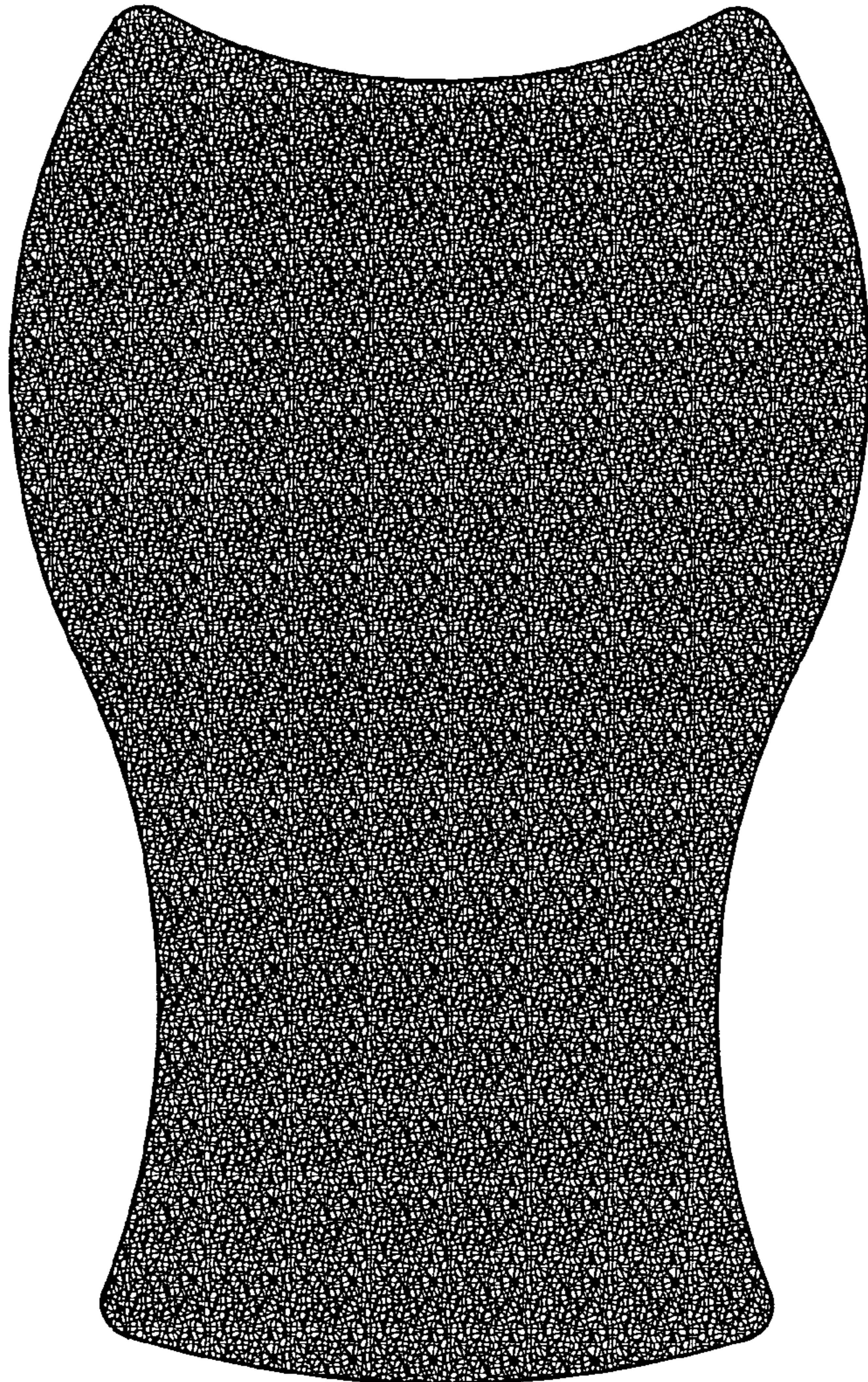
