(57) **CLAIM**

The ornamental design for a container for fly fishing tackle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a container for fly fishing tackle showing my new design;

FIG. 2 is a front elevational view of the container for fly fishing tackle illustrated in FIG. 1;

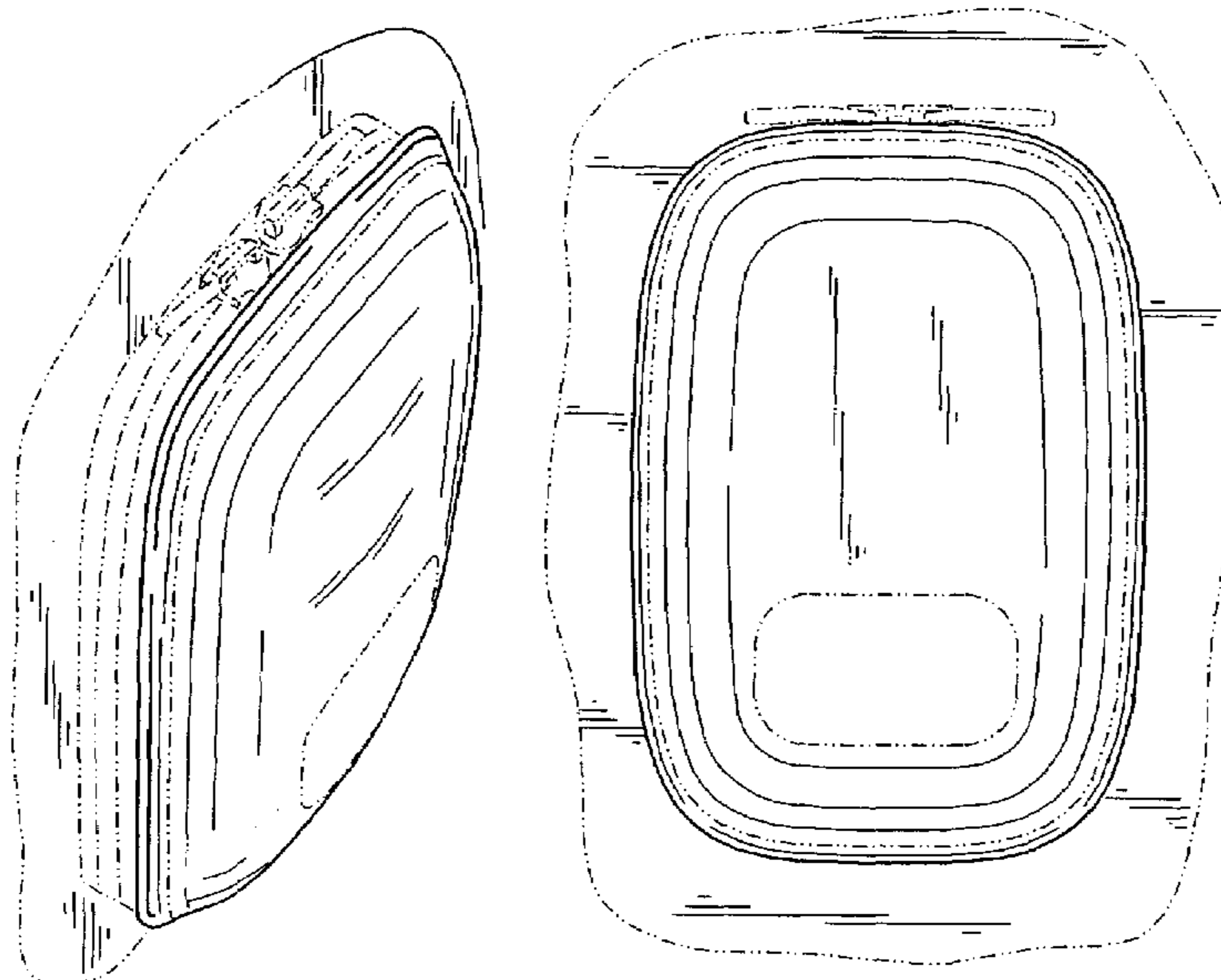
FIG. 3 is a left-side elevational view of the container for fly fishing tackle illustrated in FIGS. 1-2, the right-side elevational view being a mirror image thereof;

FIG. 4 is a top plan view of the container for fly fishing tackle illustrated in FIGS. 1-3; and,

FIG. 5 is a bottom plan view of the container for fly fishing tackle illustrated in FIGS. 1-4, the rear elevational view being plain and unornamented.

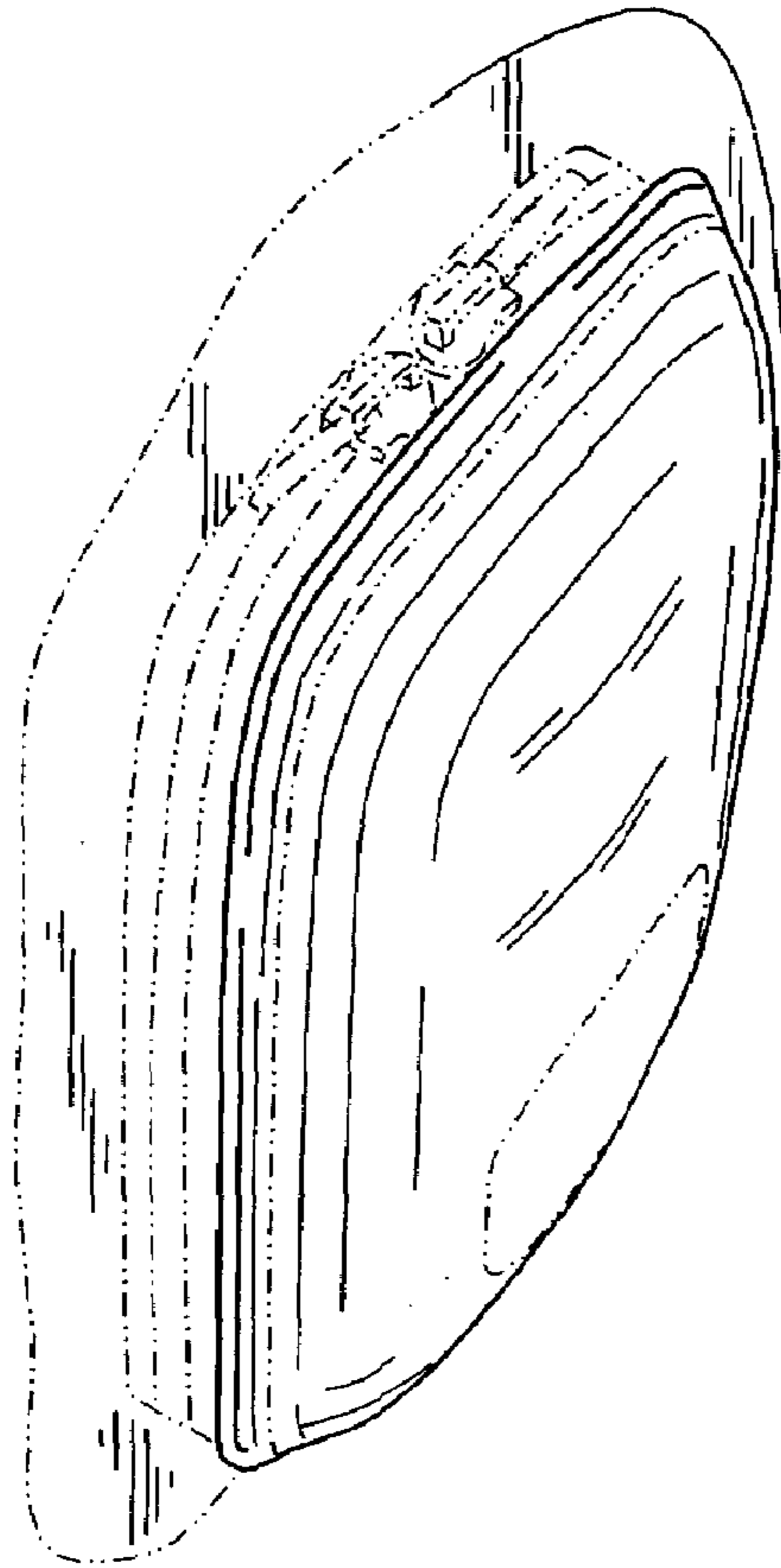
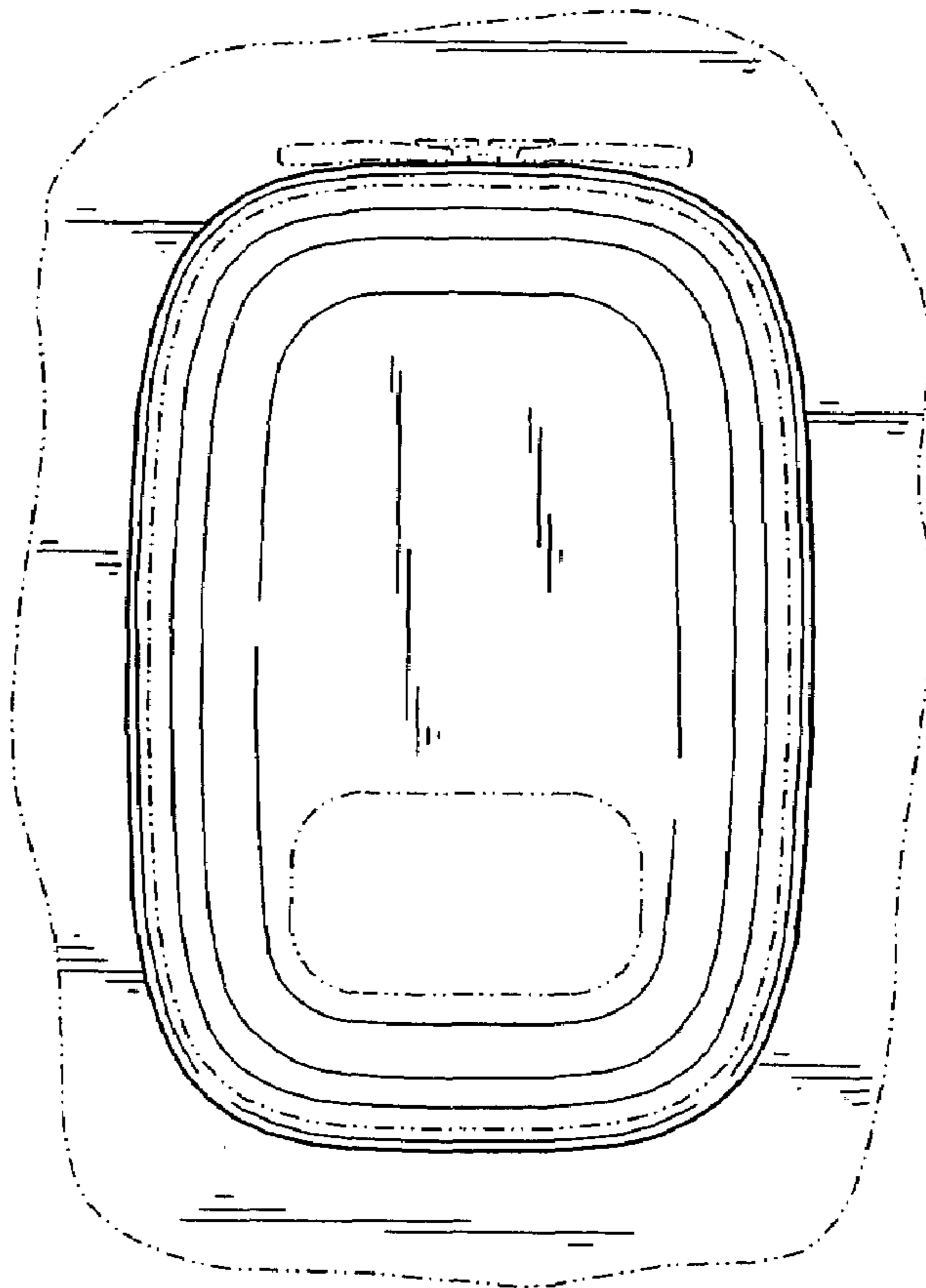

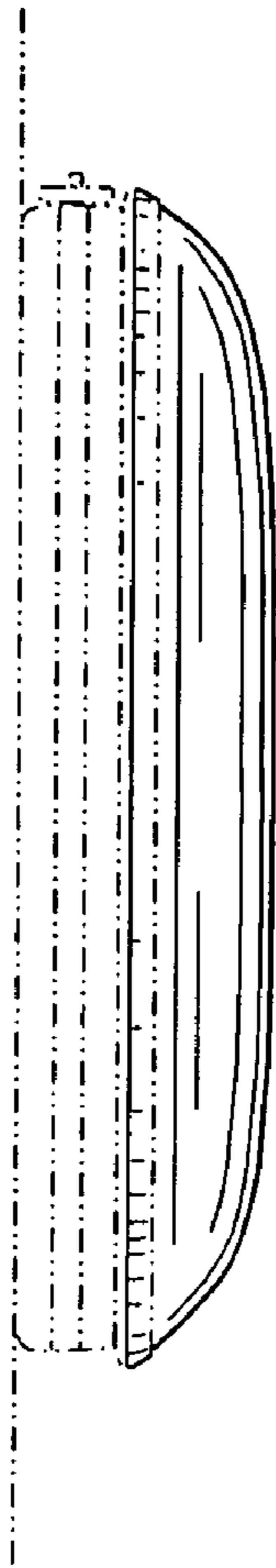

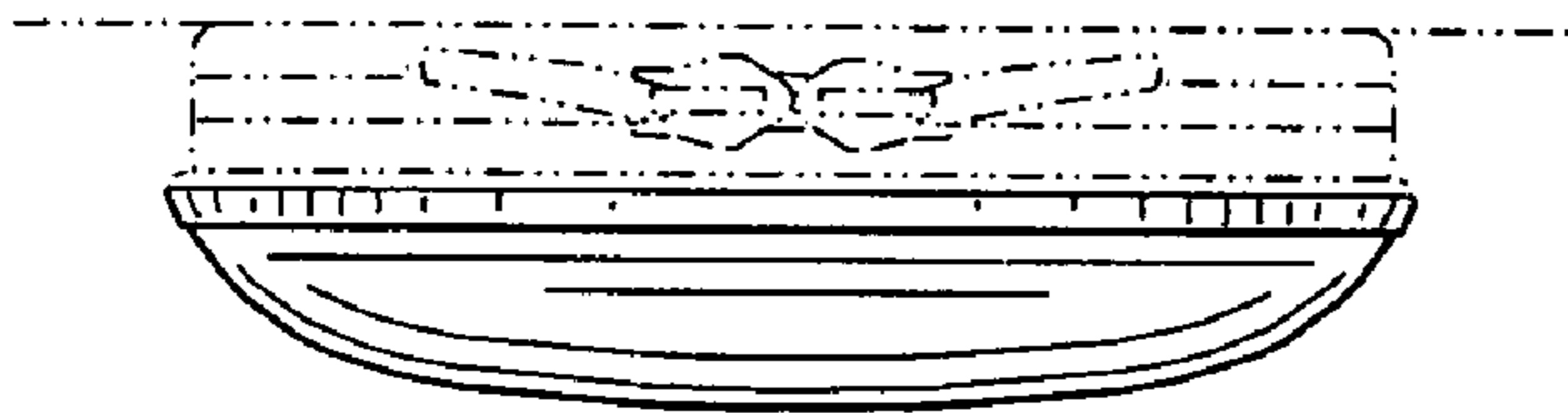
