(57) **CLAIM**

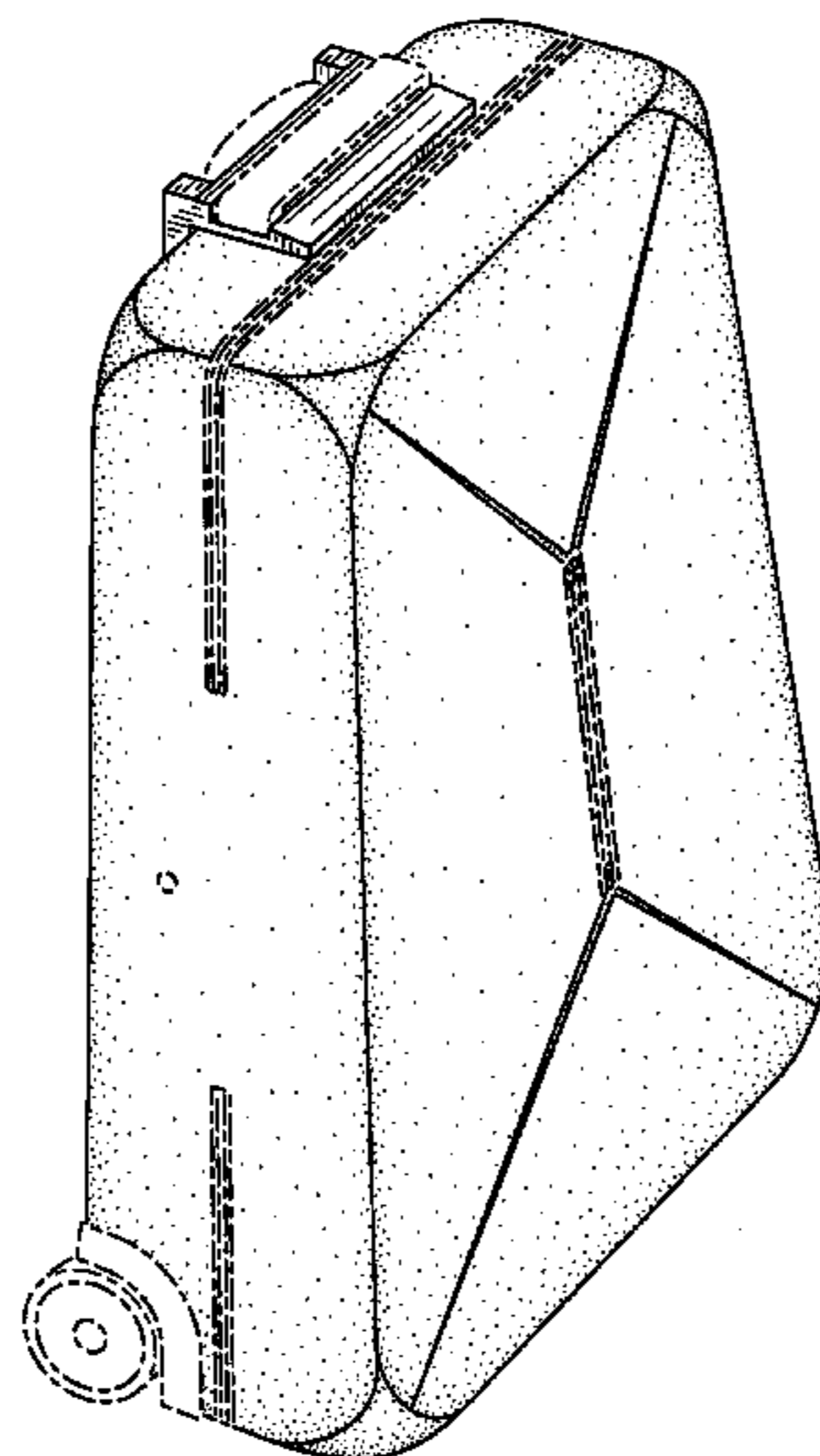
The ornamental design for luggage, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the luggage, illustrating our new design;
FIG. 2 is a front elevational view of the luggage;
FIG. 3 is a rear elevational view of the luggage;
FIG. 4 is an elevational view of one side of the luggage;
FIG. 5 is an elevational view of the other side of the luggage;
FIG. 6 is a top plan view of the luggage; and,
FIG. 7 is a bottom plan view of the luggage.

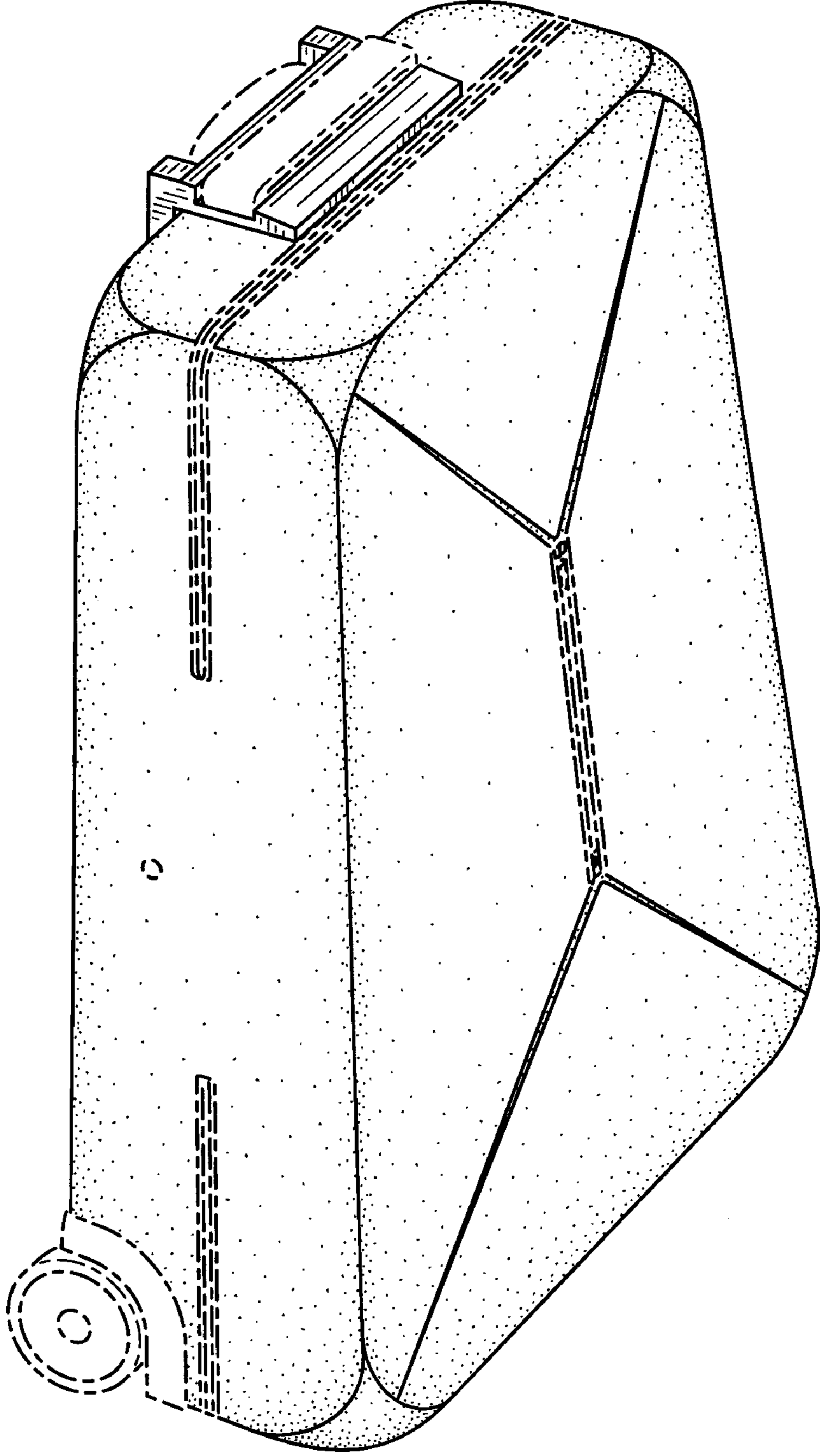

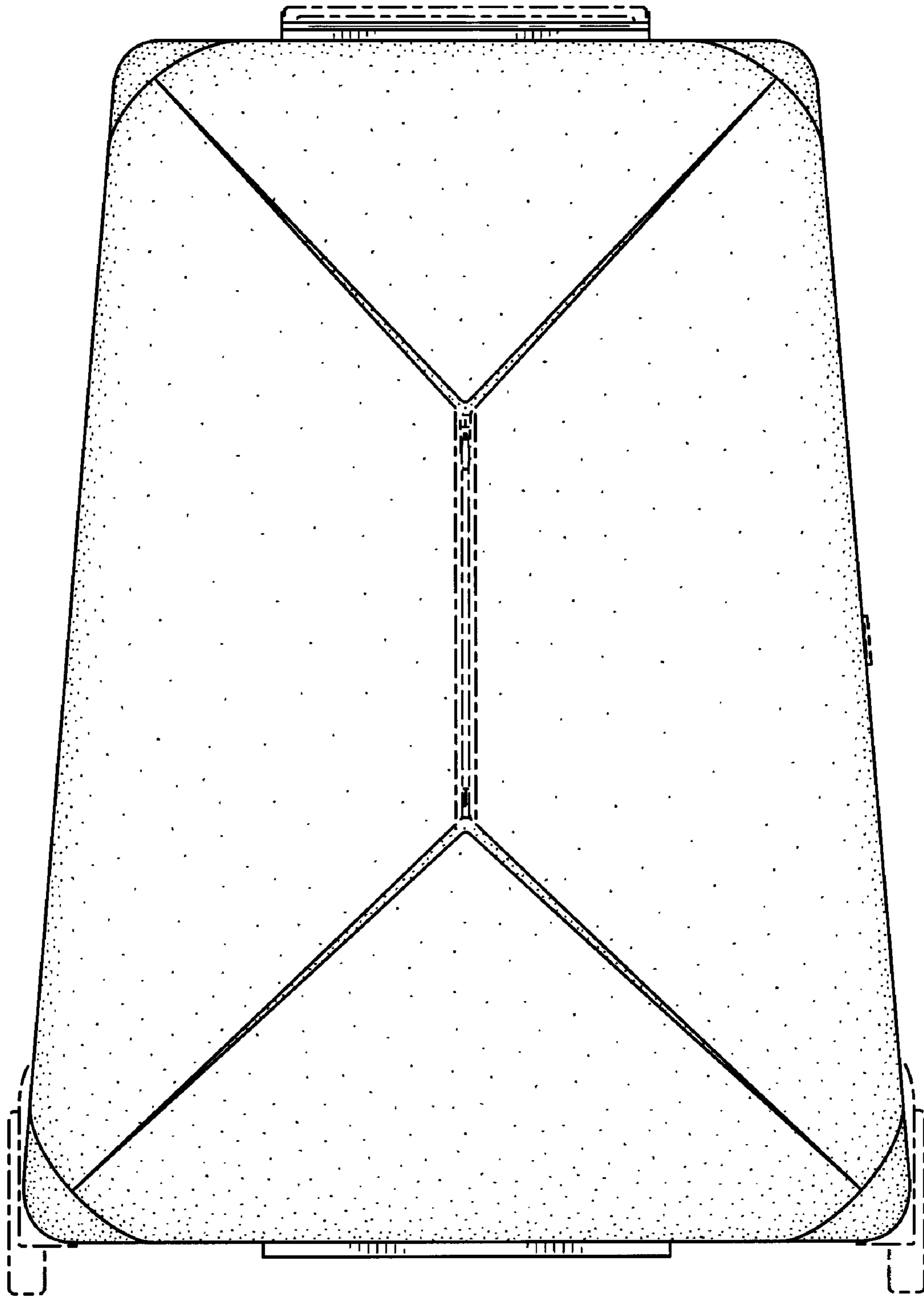

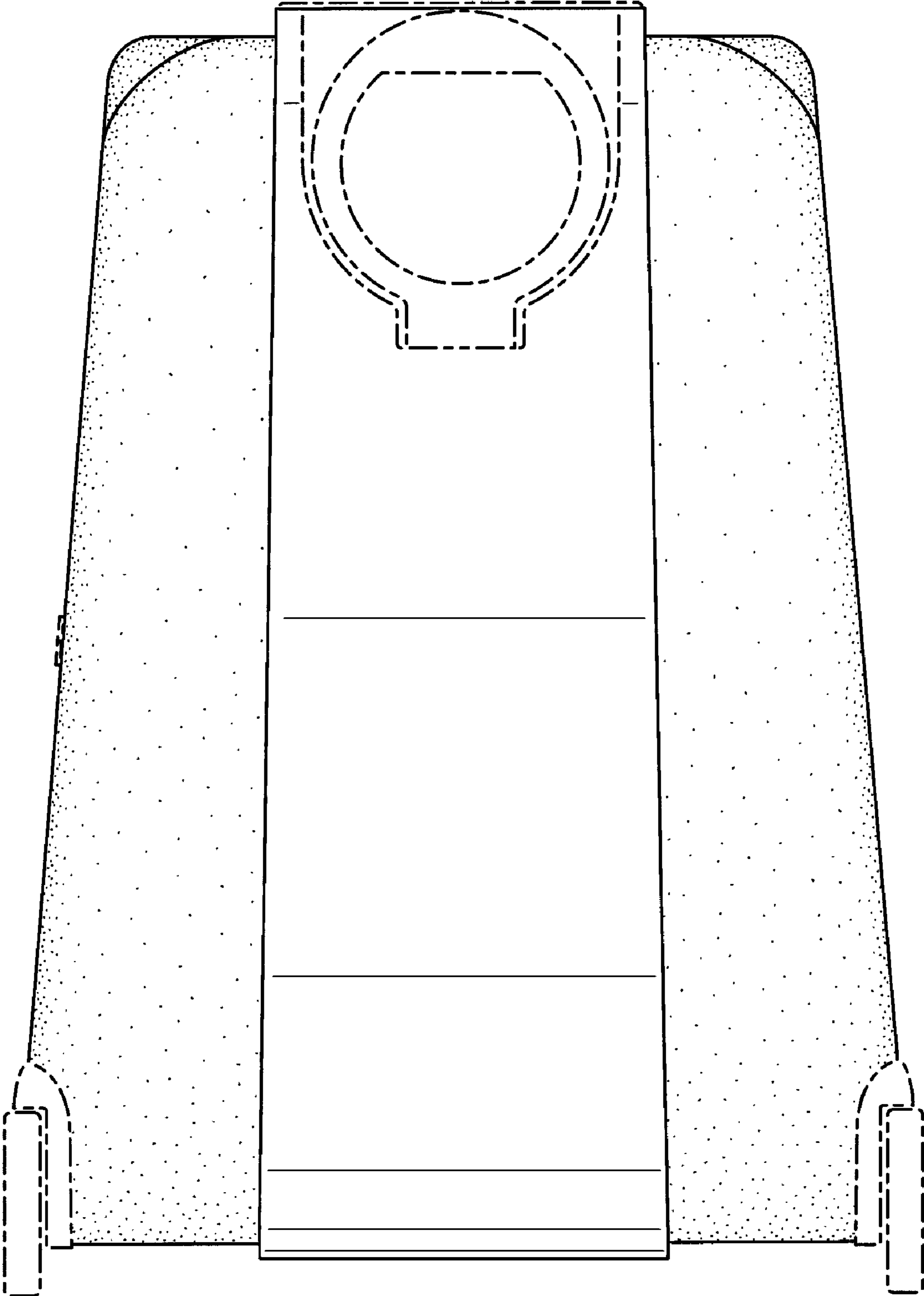

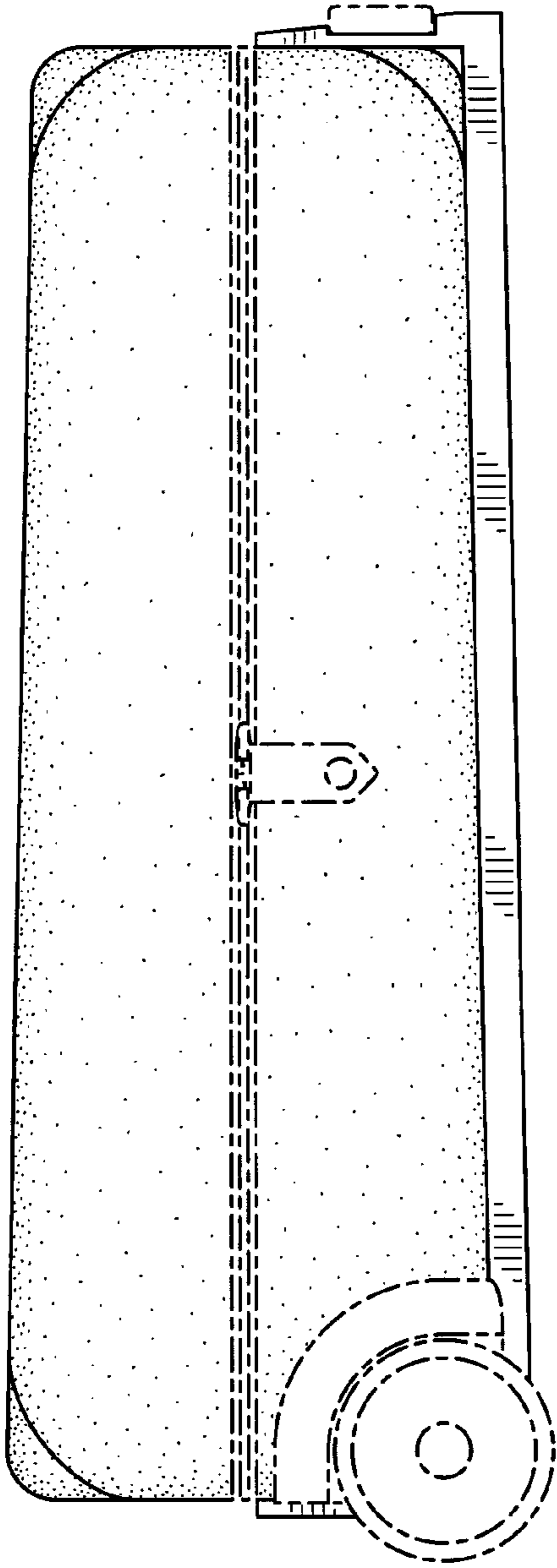

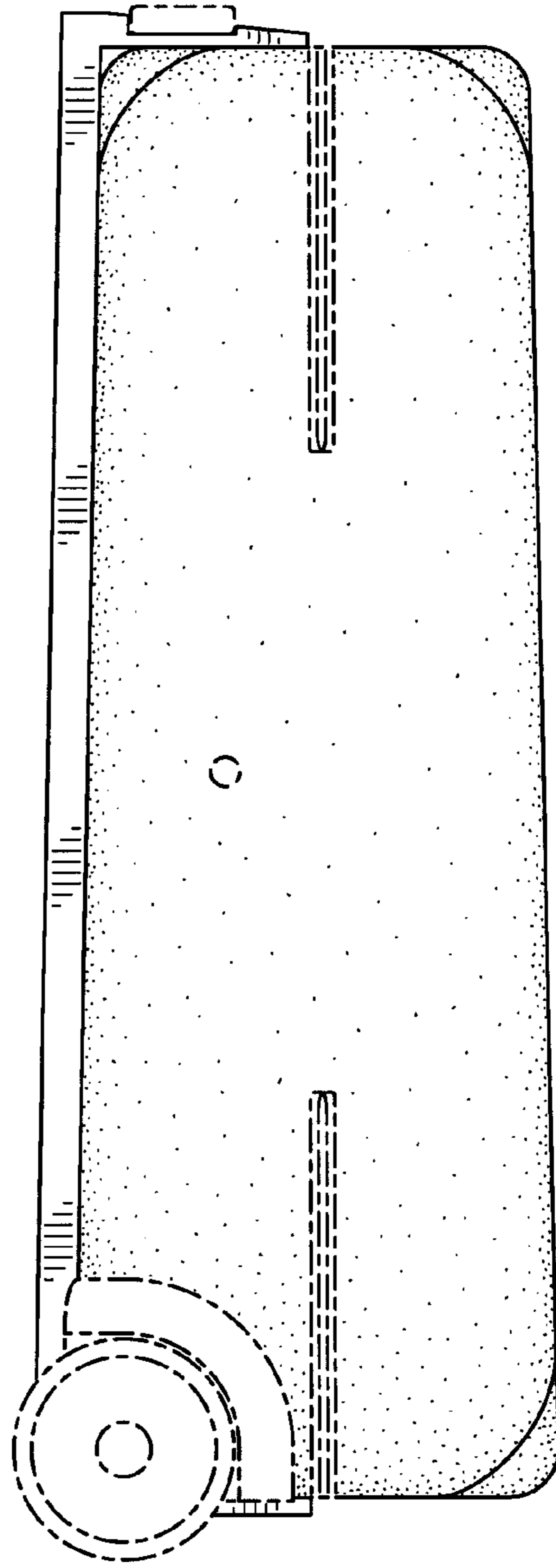

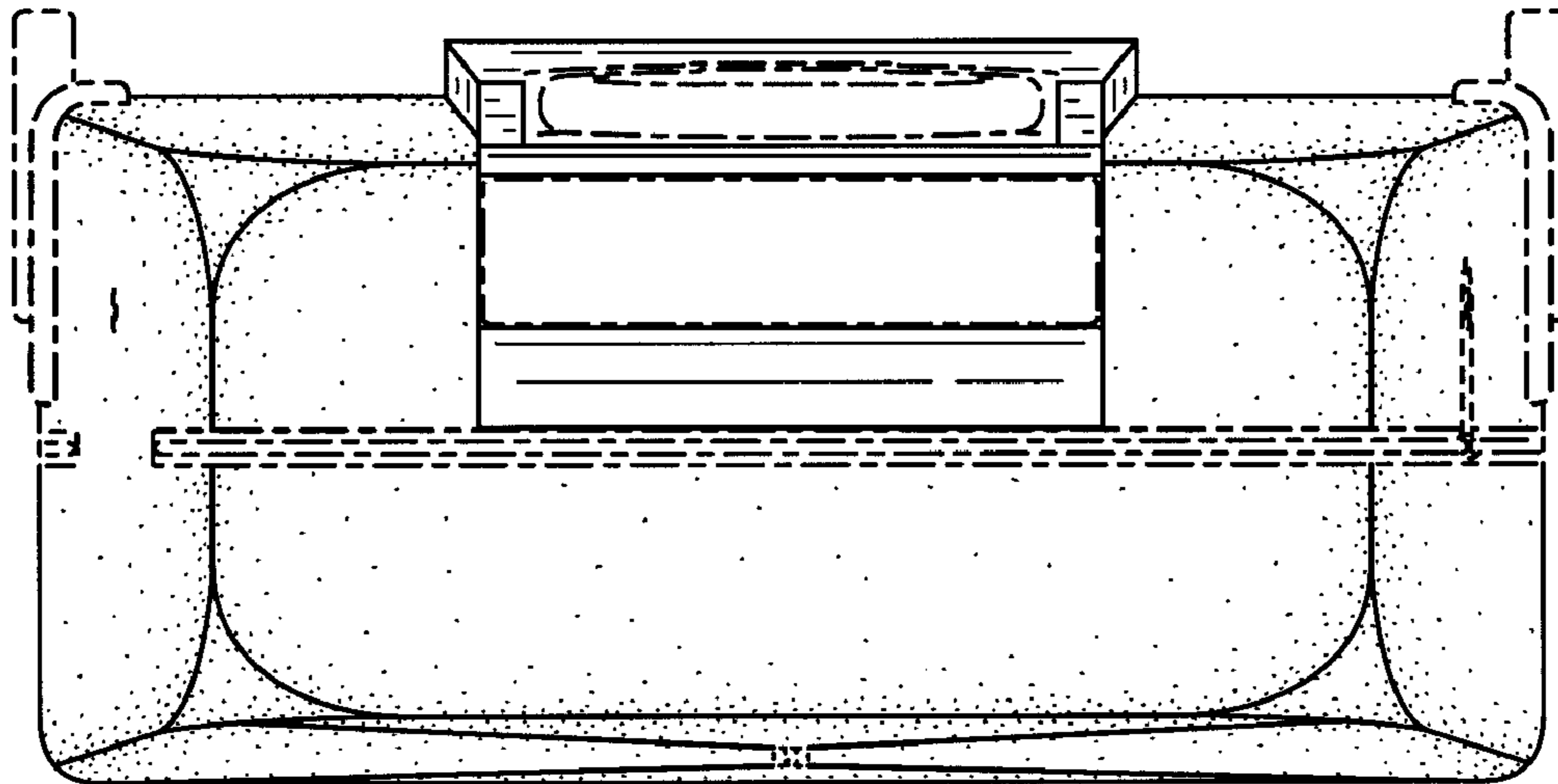

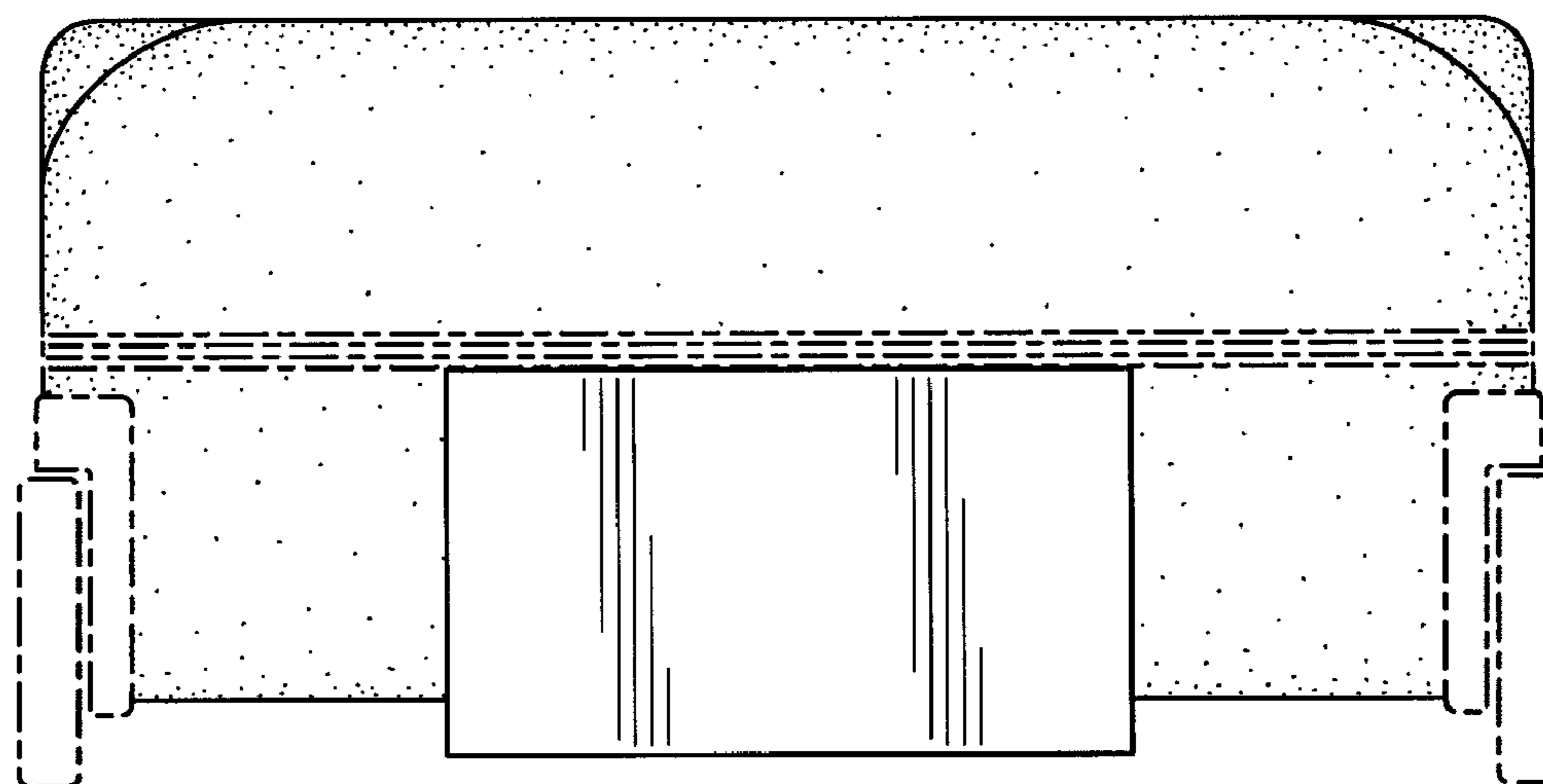
