FIG. 2 is a side elevational view of the design;

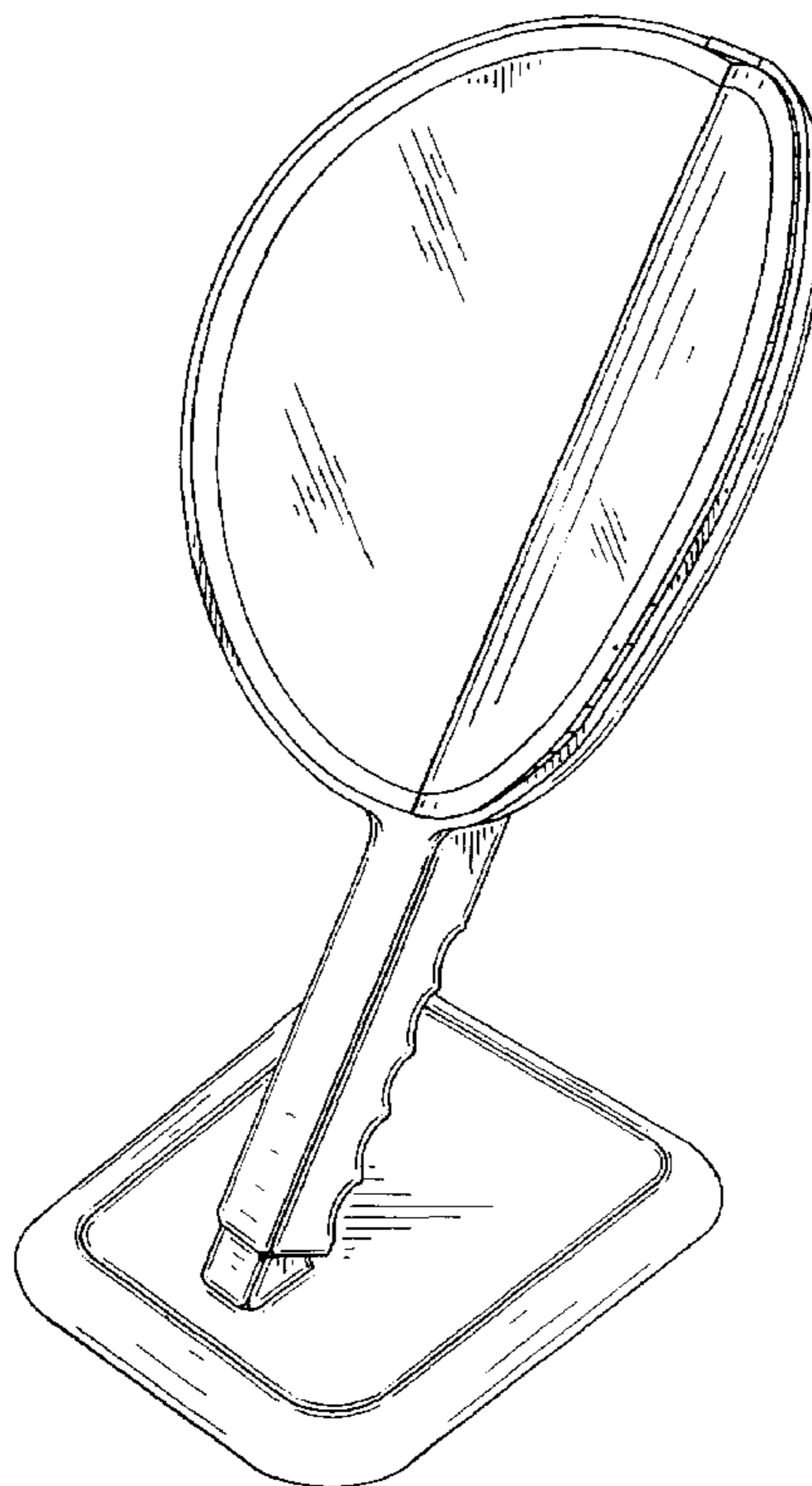
FIG. 3 is a front elevational view of the design;

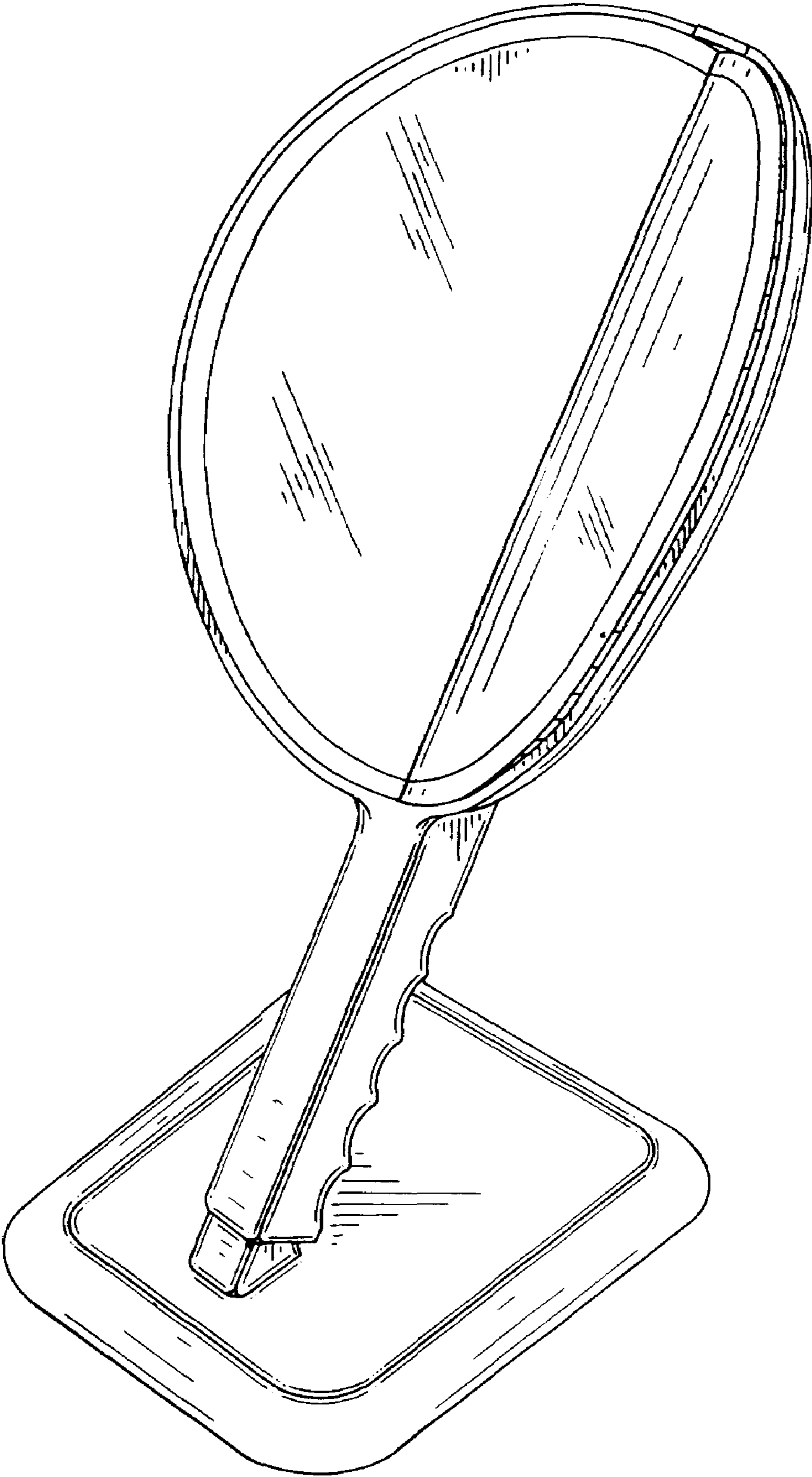
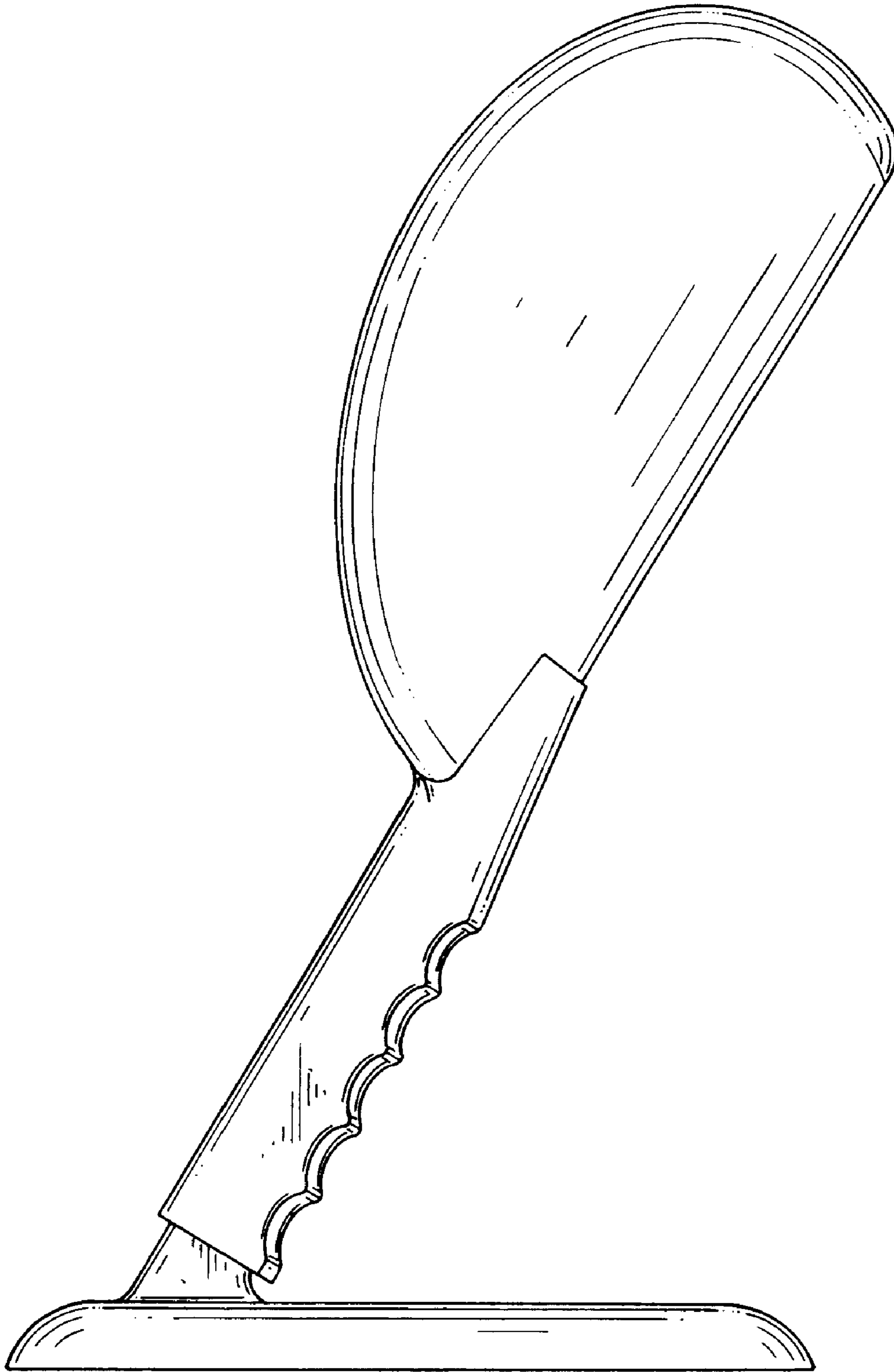
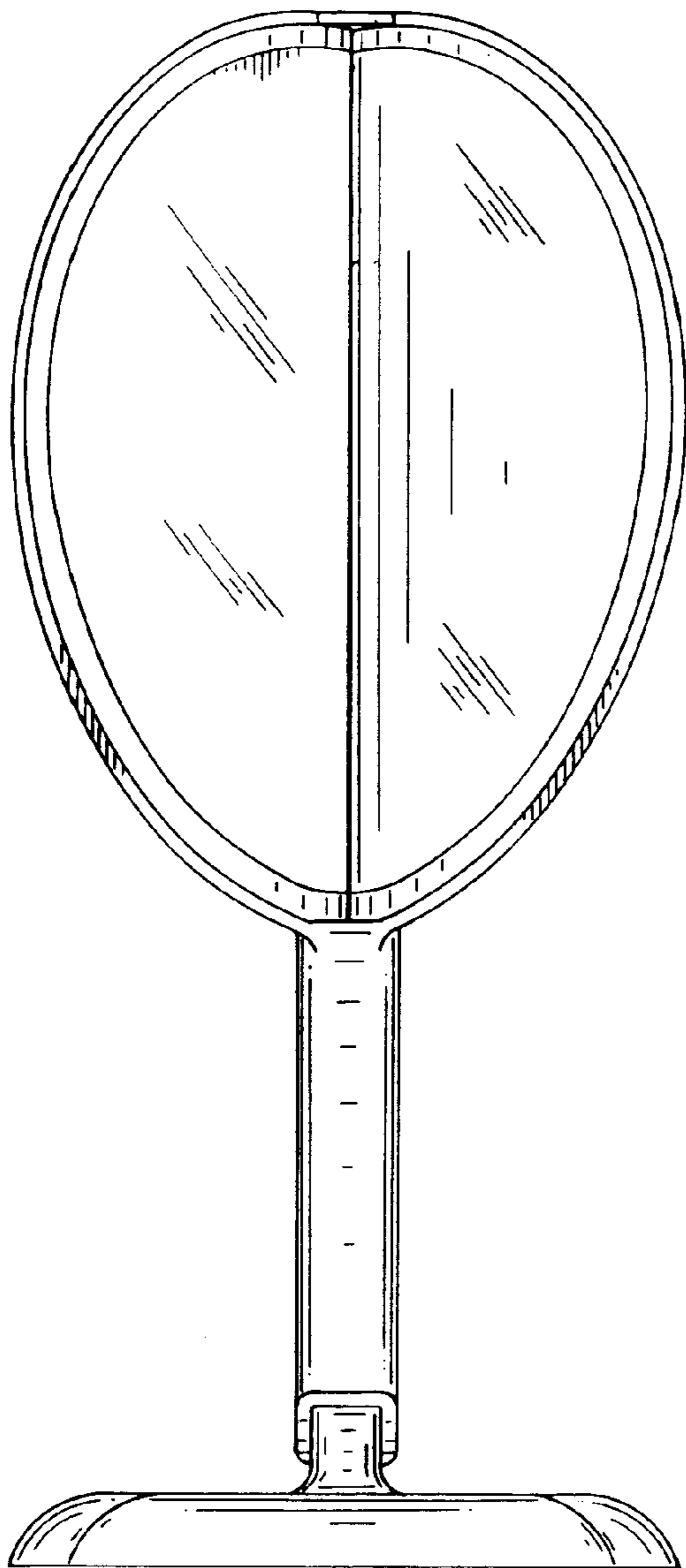


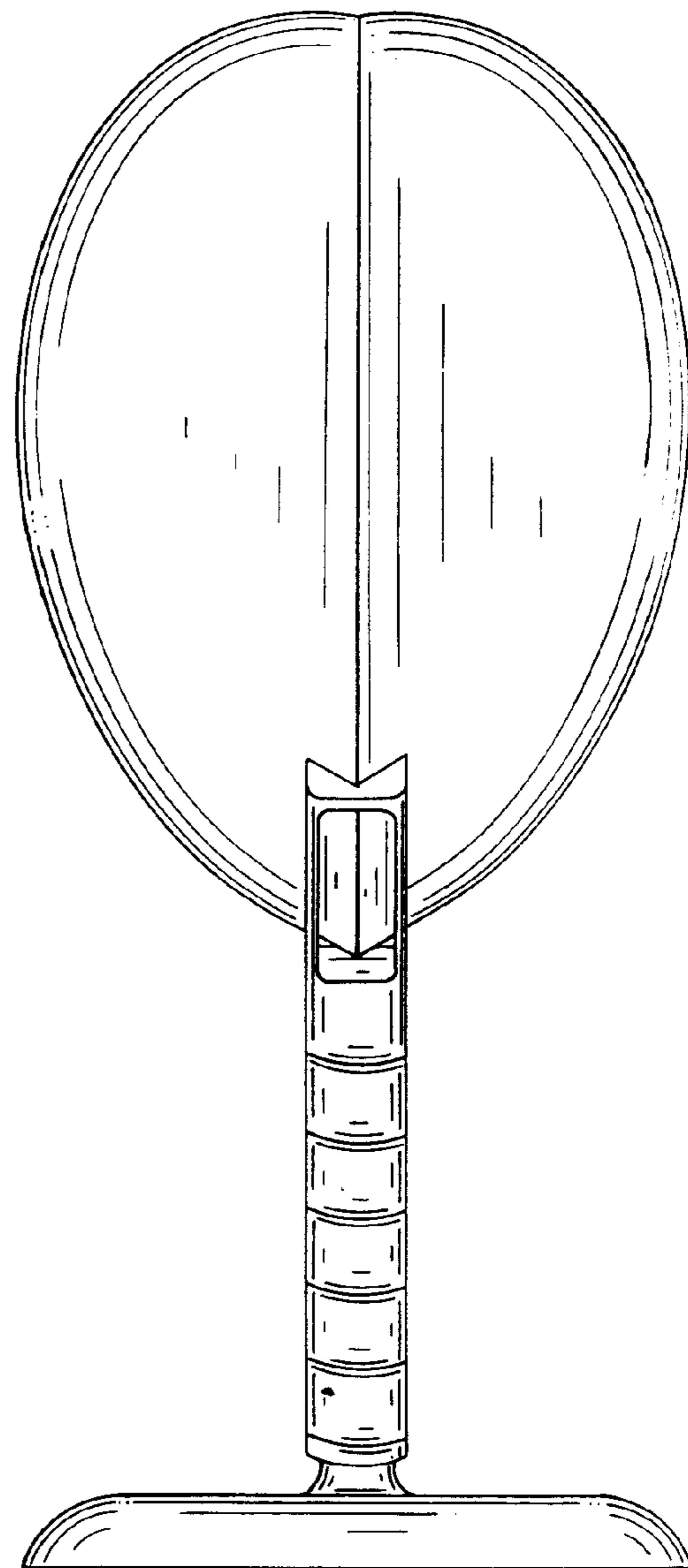

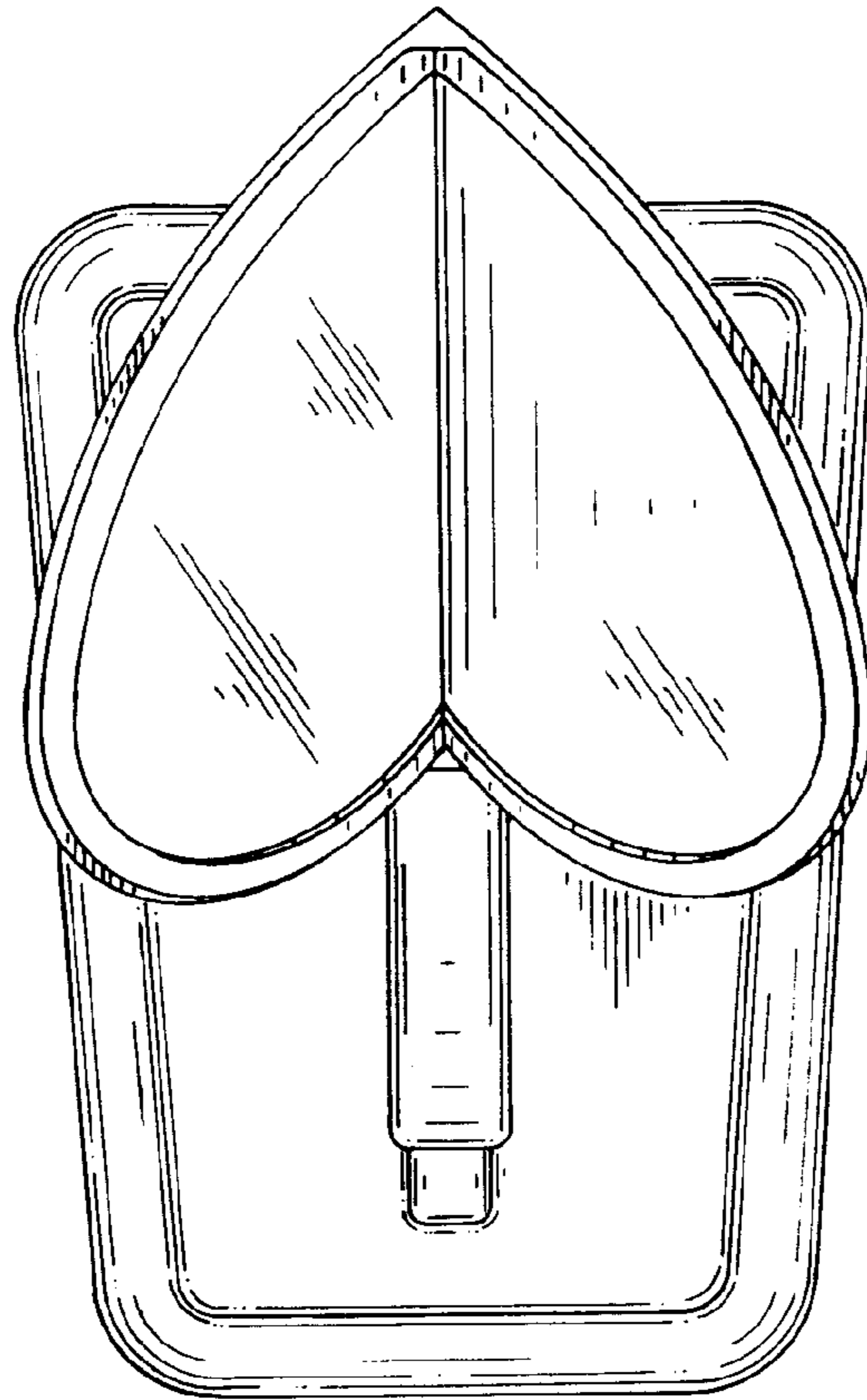

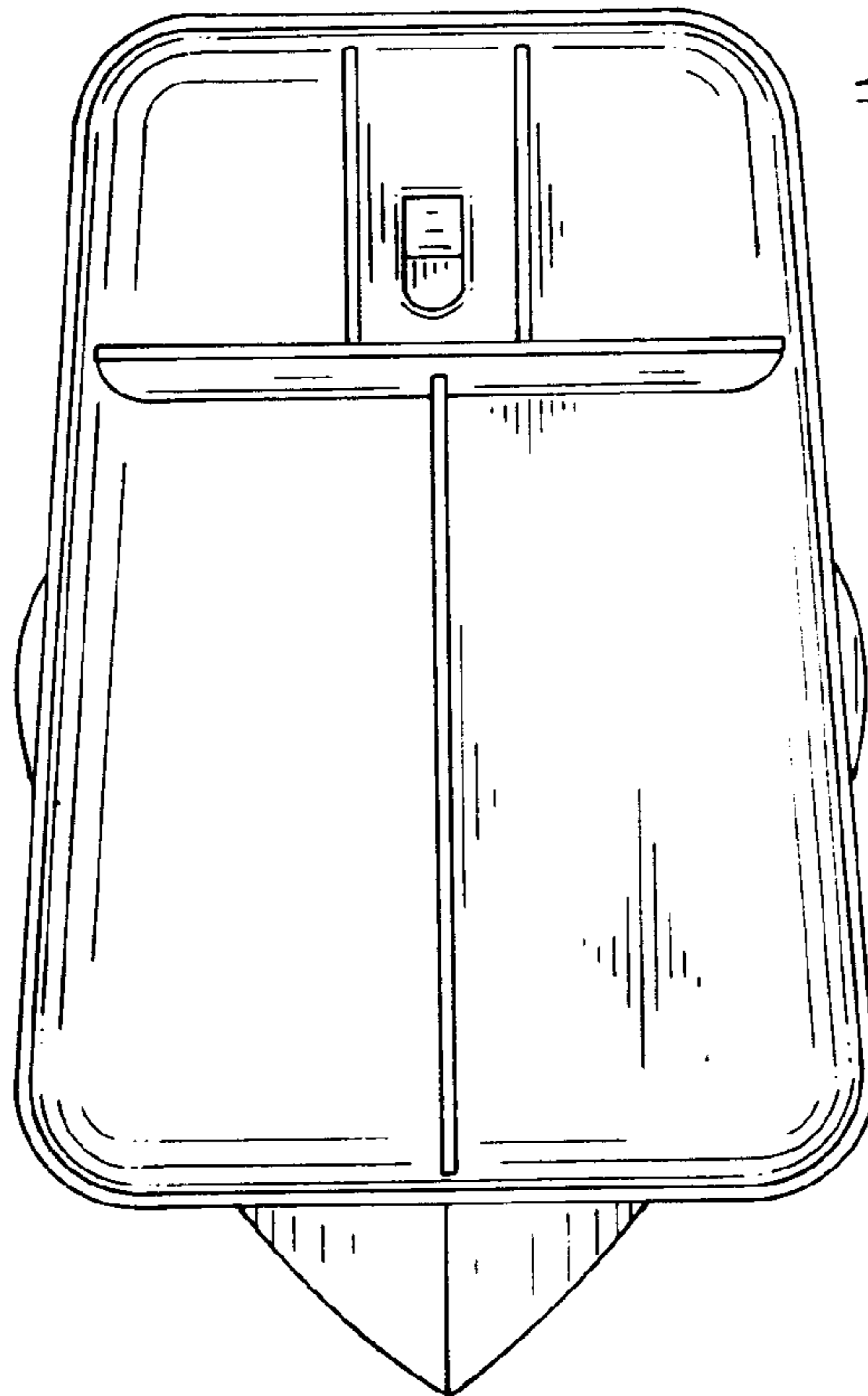
