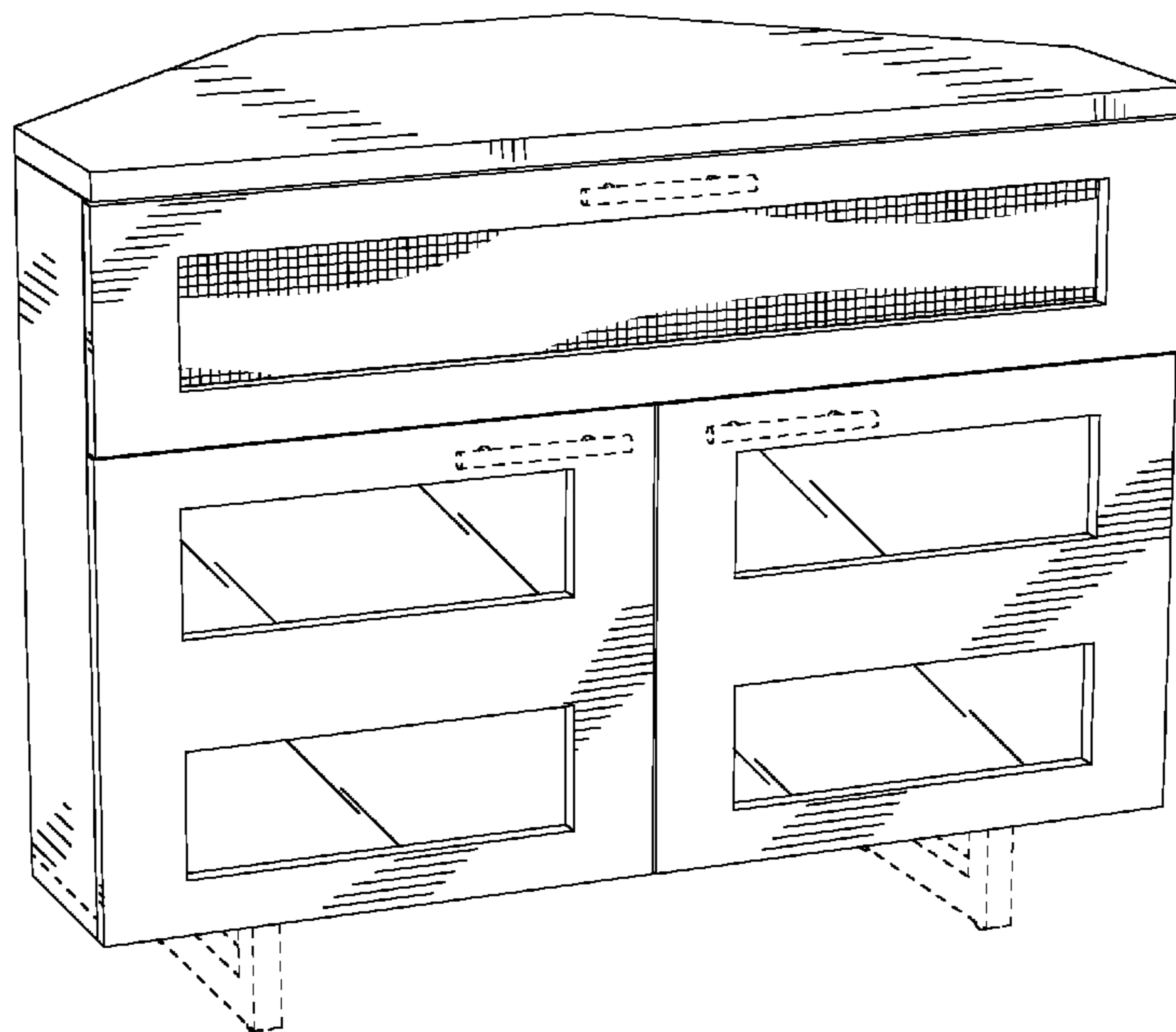

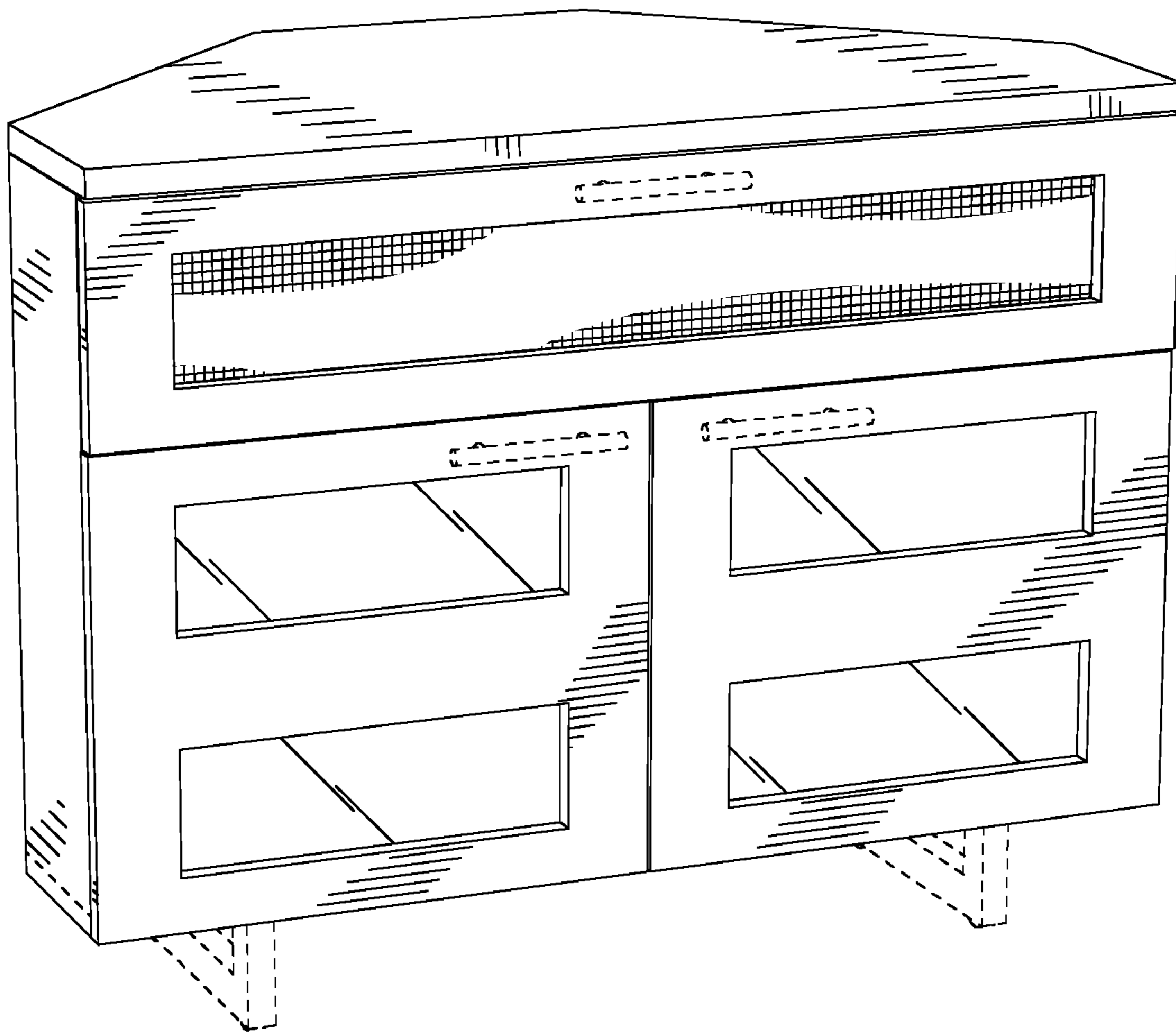
The ornamental design for an enclosed cabinet for audio/video components, as shown and described.

**DESCRIPTION**

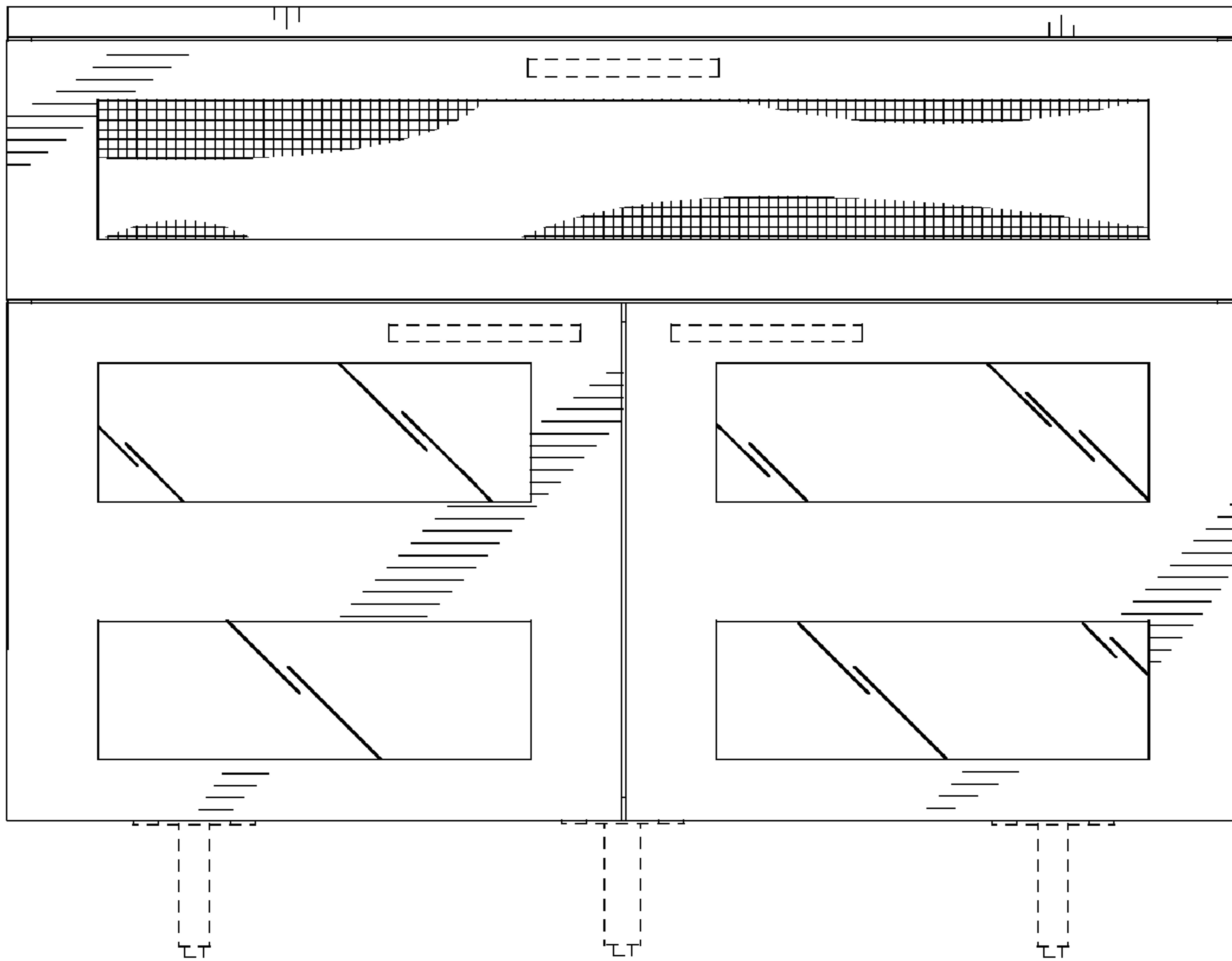
FIG. 1 is a perspective view of a first embodiment of an ornamental design for an enclosed cabinet for audio/video components showing our new design;  
FIG. 2 is a front orthographic view thereof;  
FIG. 3 is a top orthographic view thereof; and,  
FIG. 4 is a left side orthographic view thereof, the right side view being a mirror image.

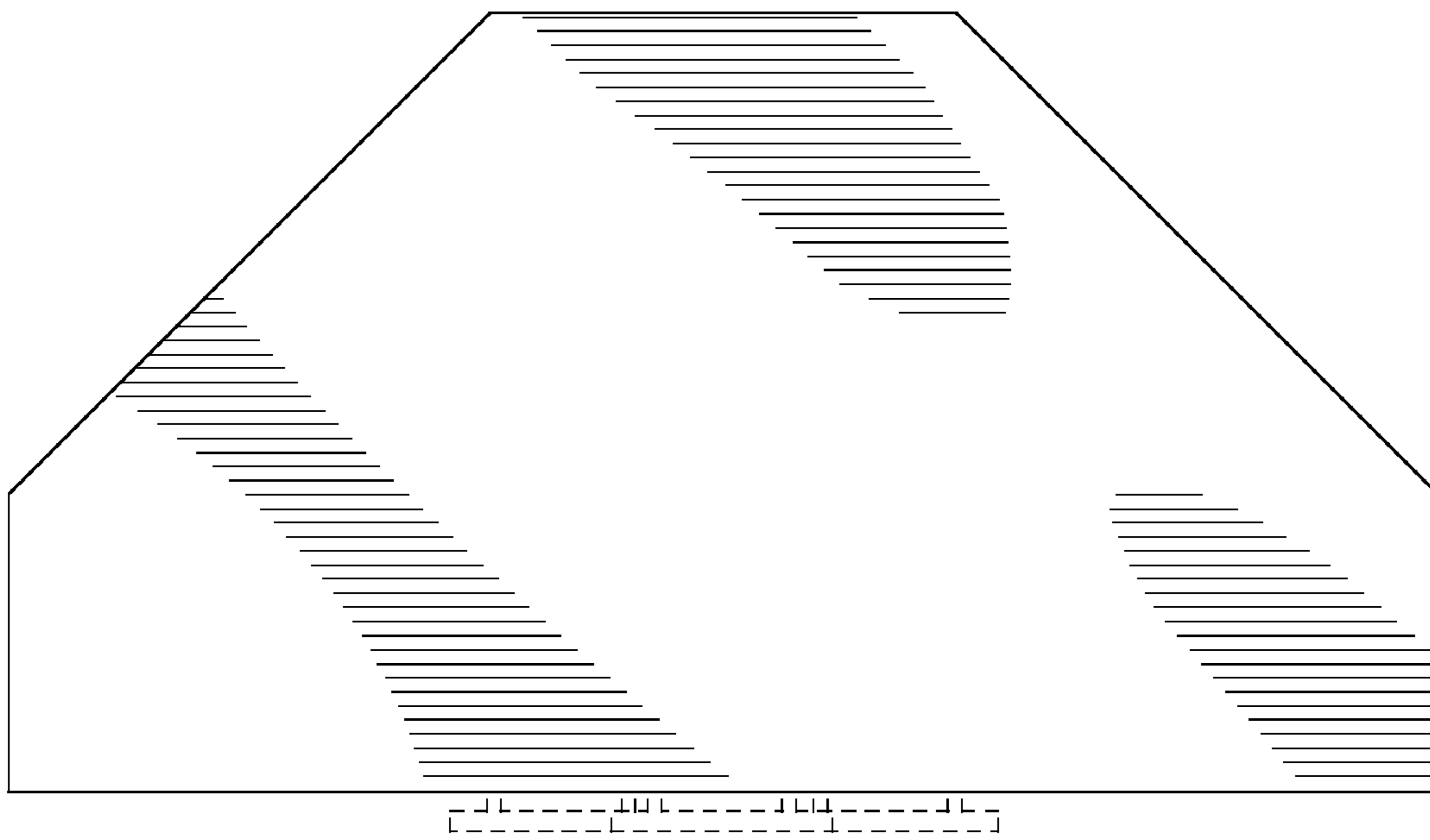




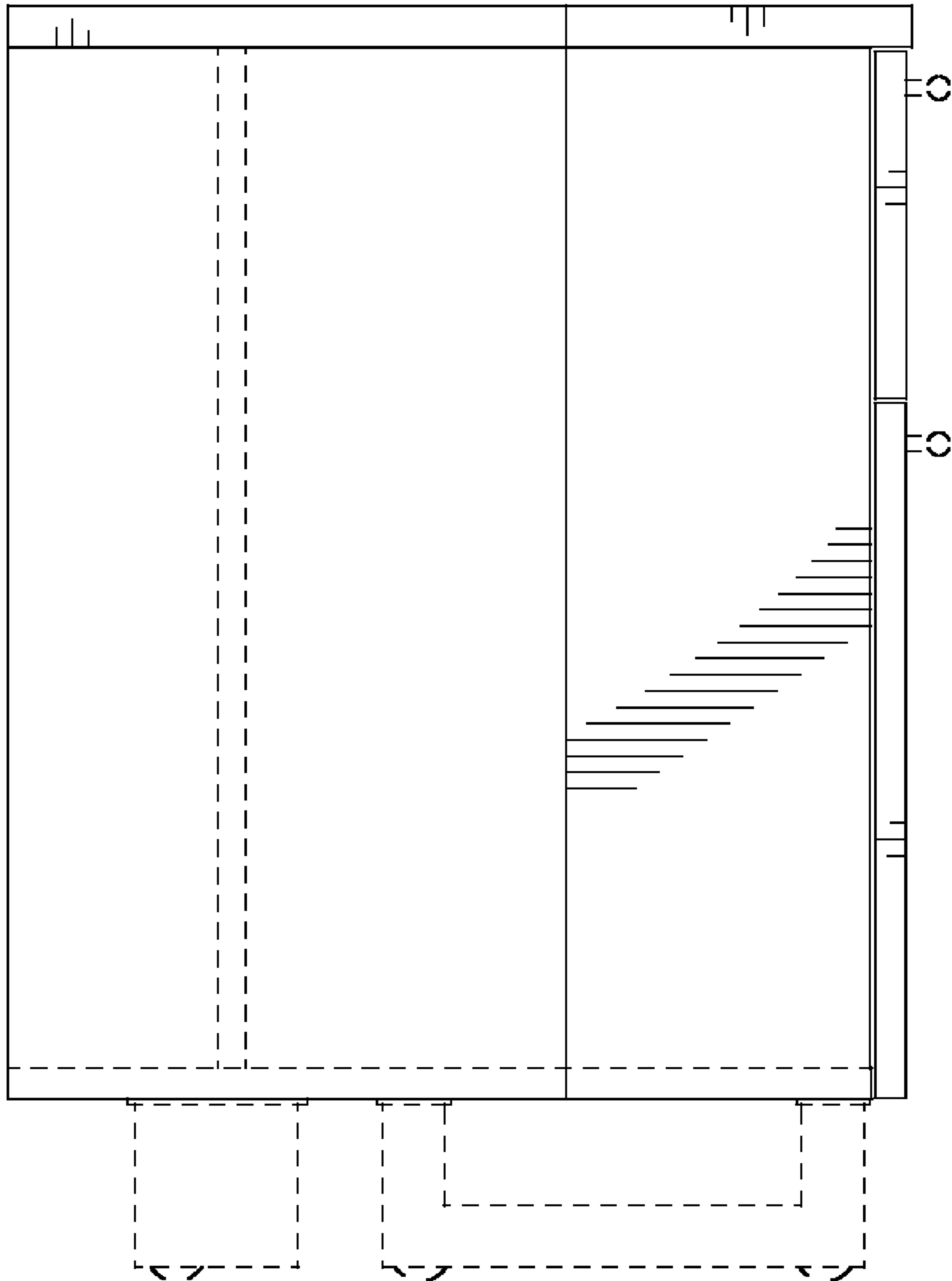
