FIG. 27 is a left side elevational view thereof;

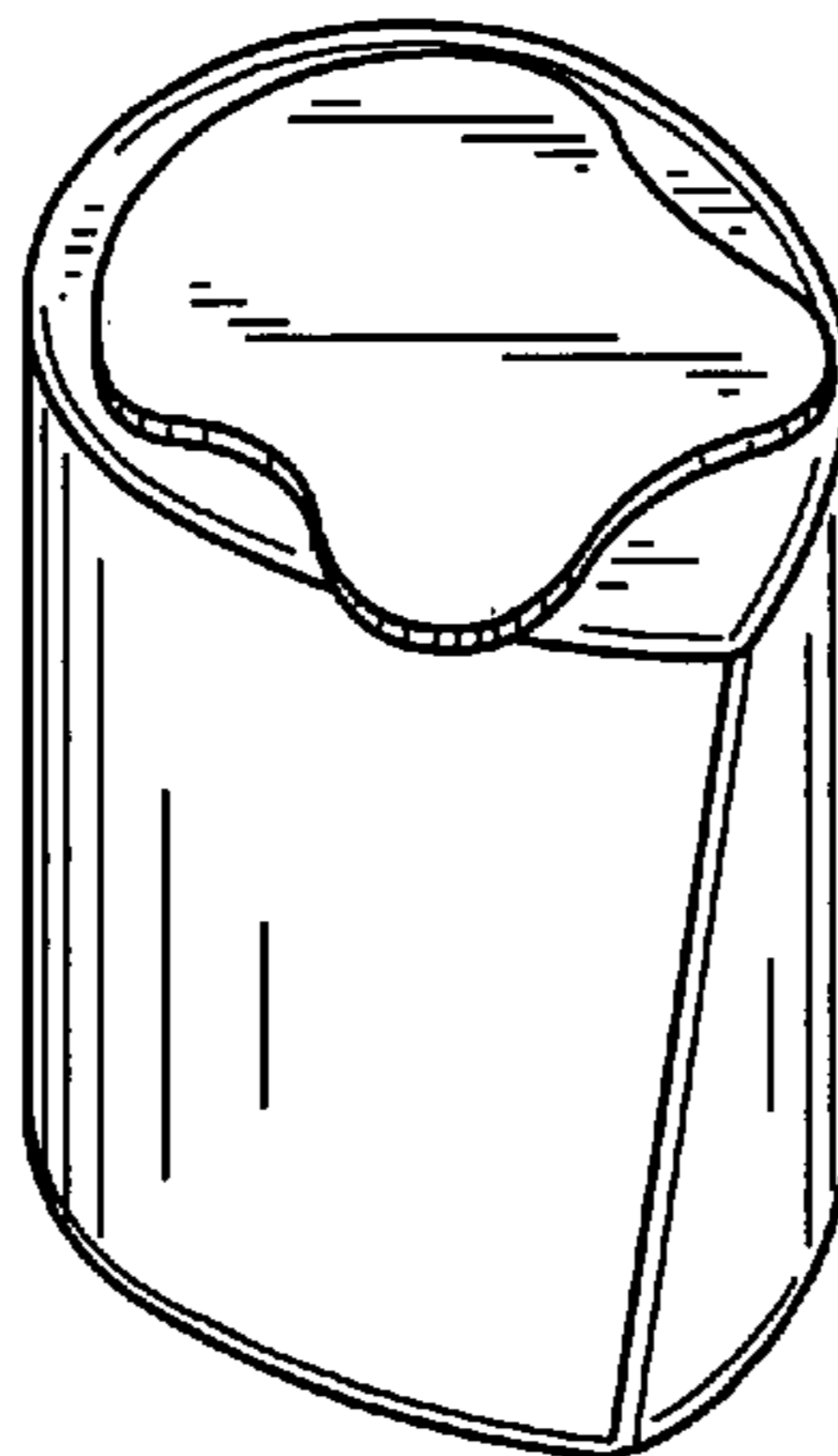
FIG. 28 is a right side elevational view thereof;

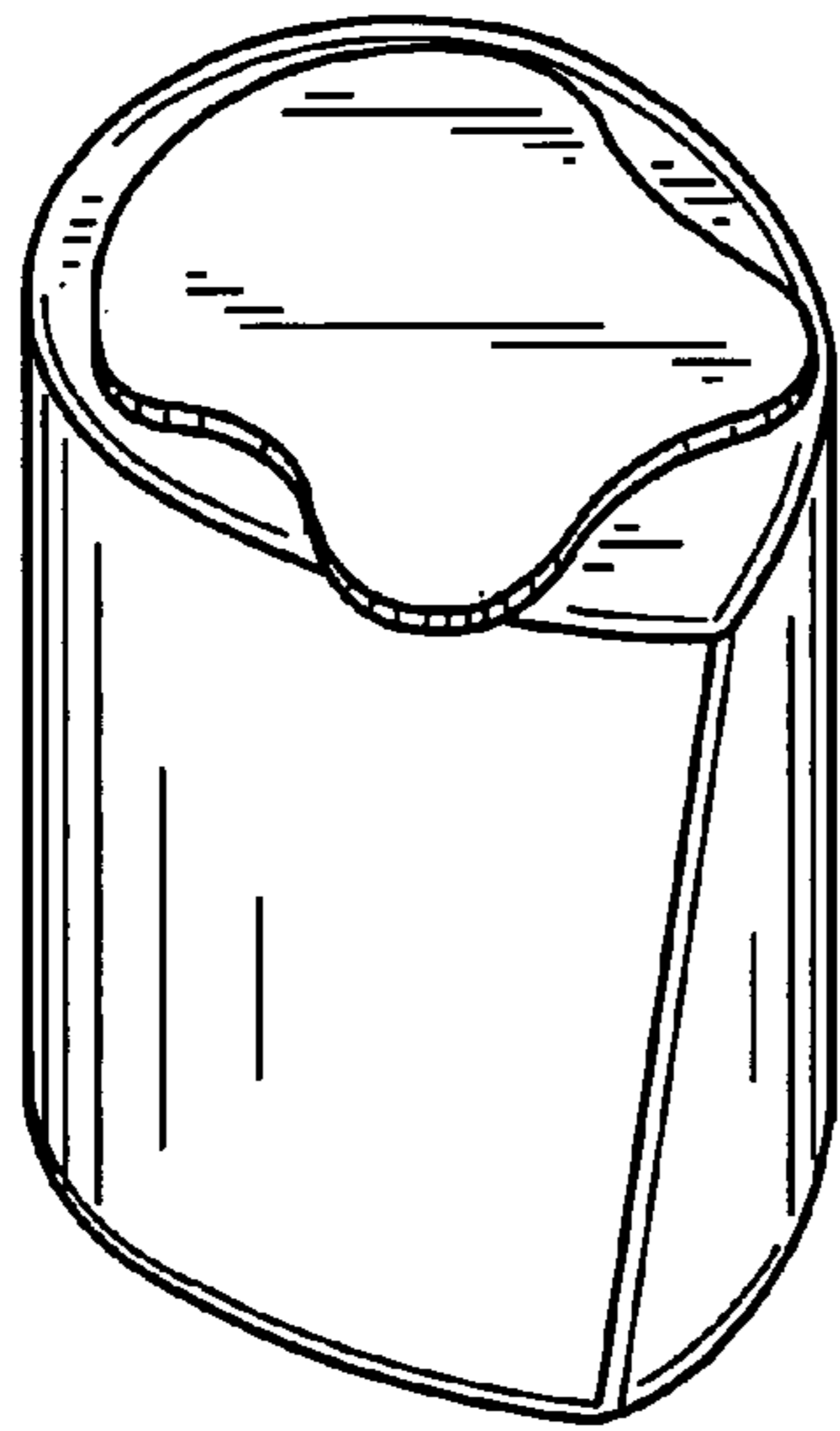

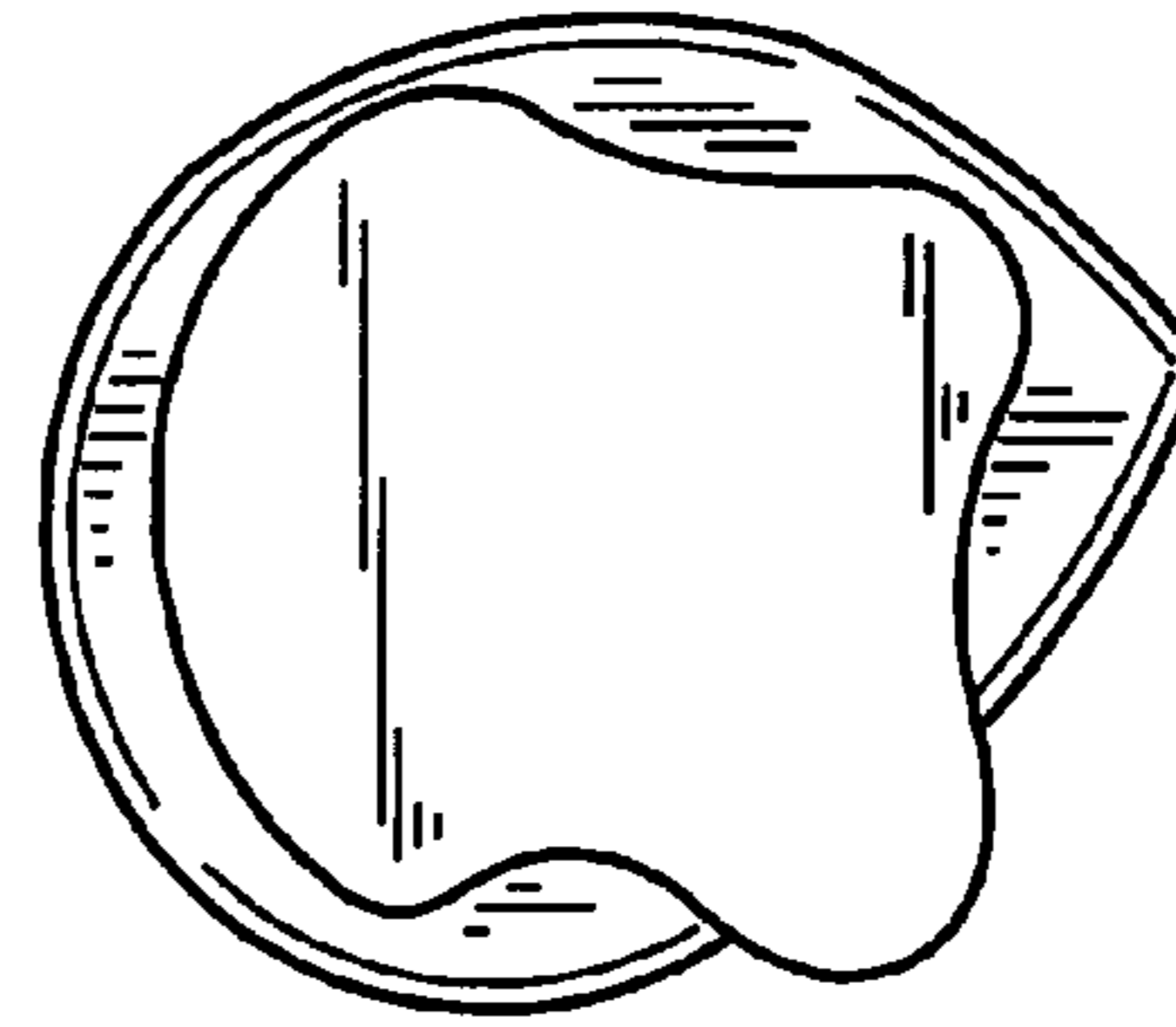

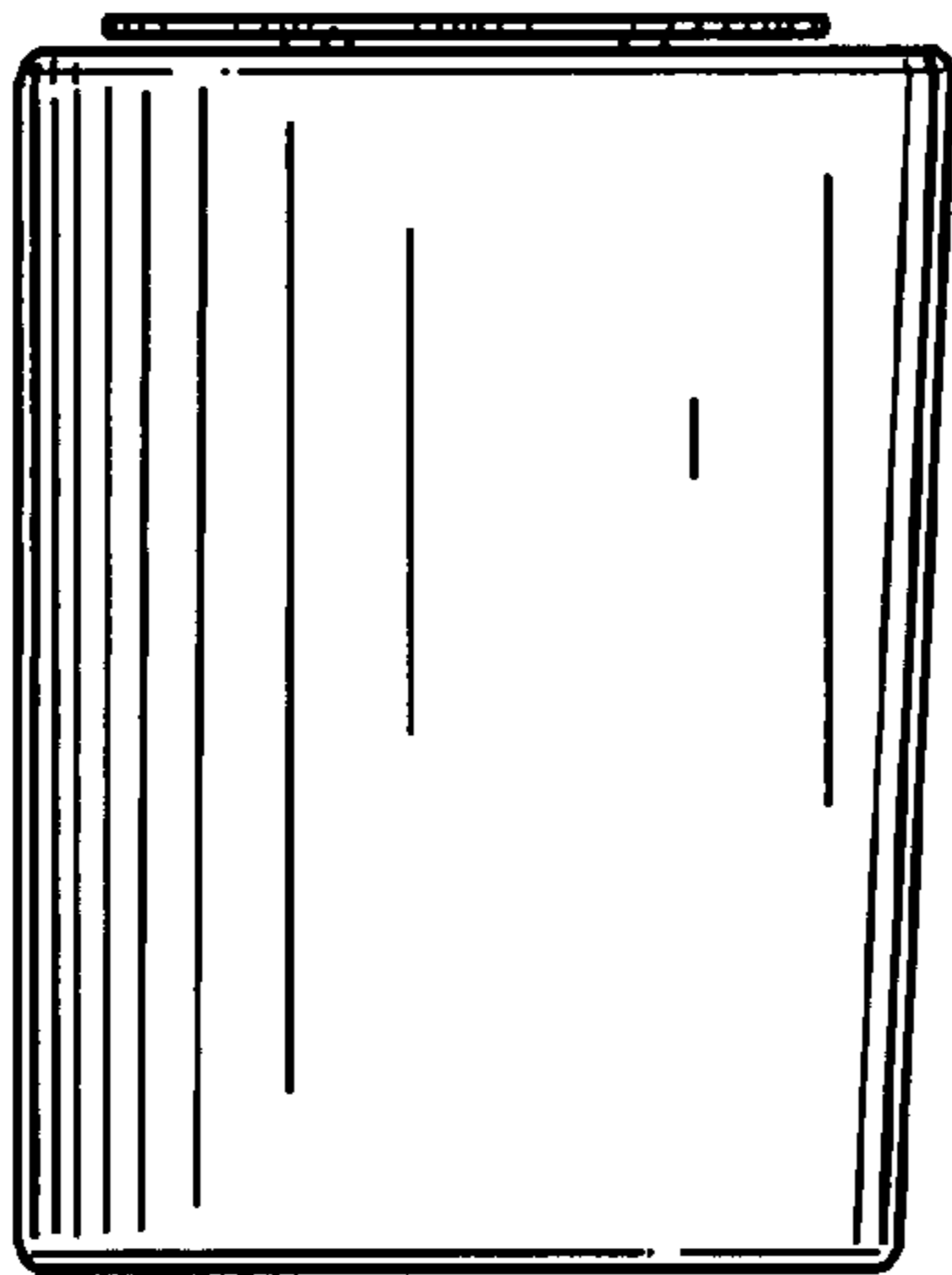

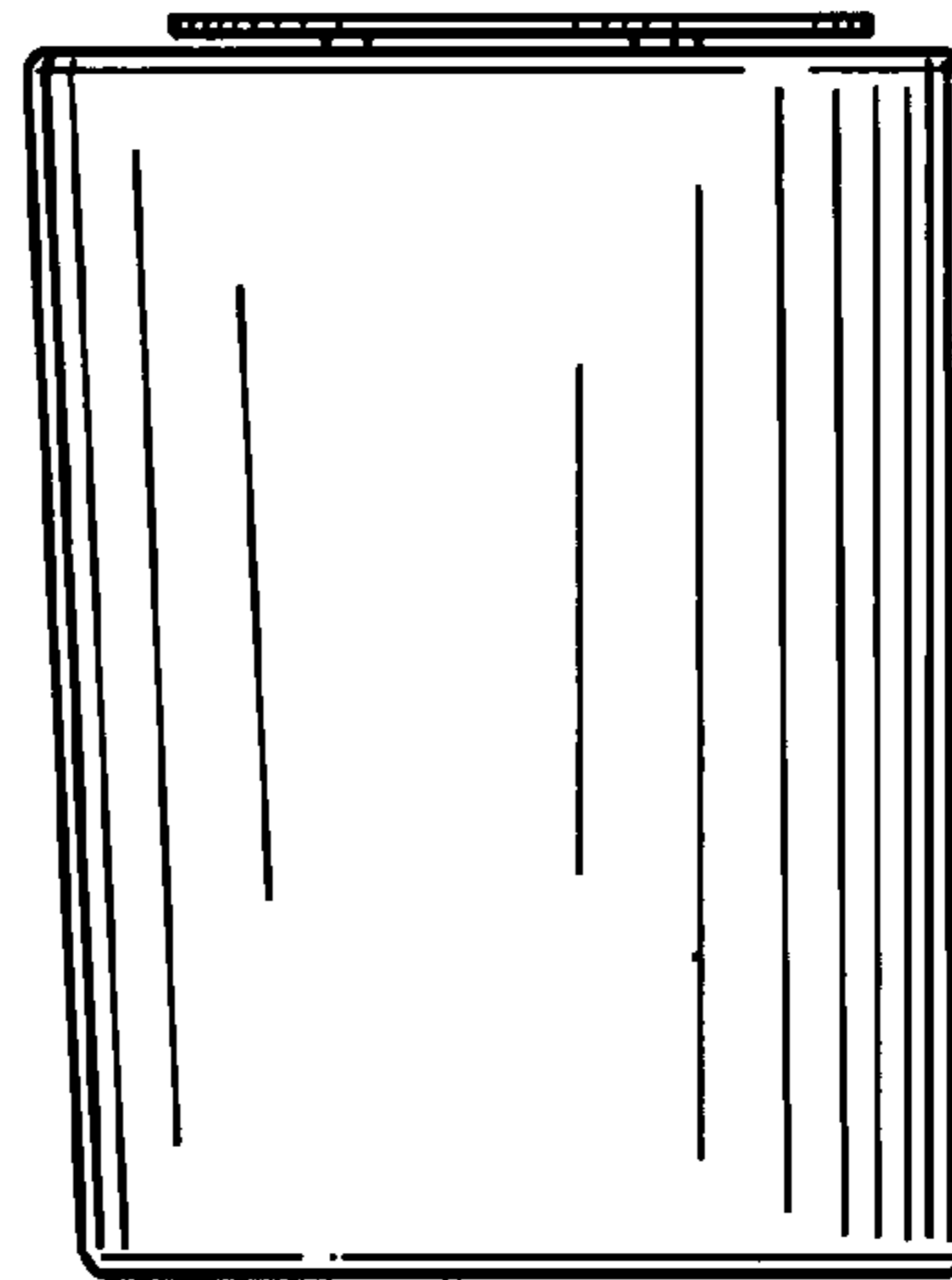

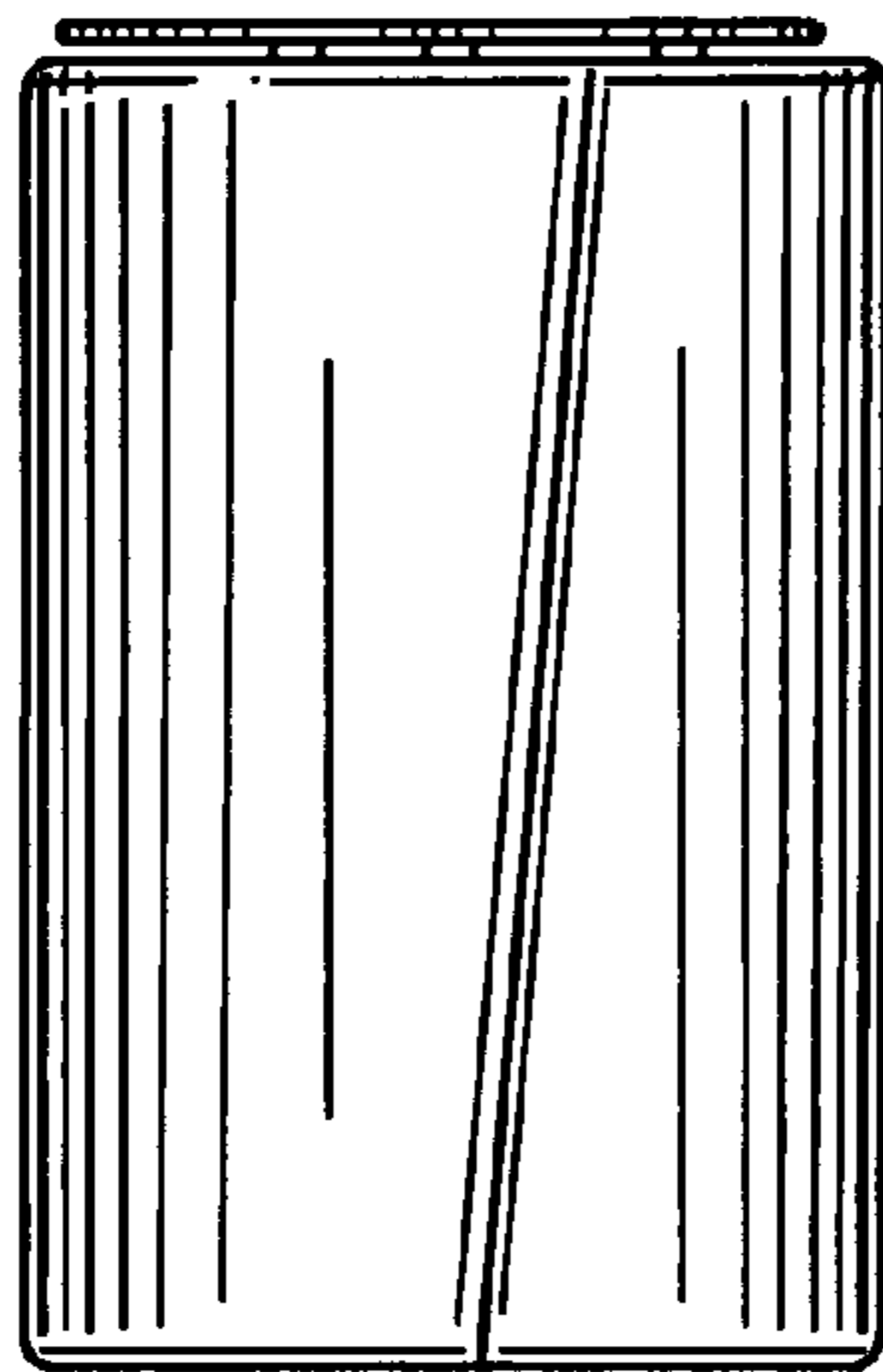

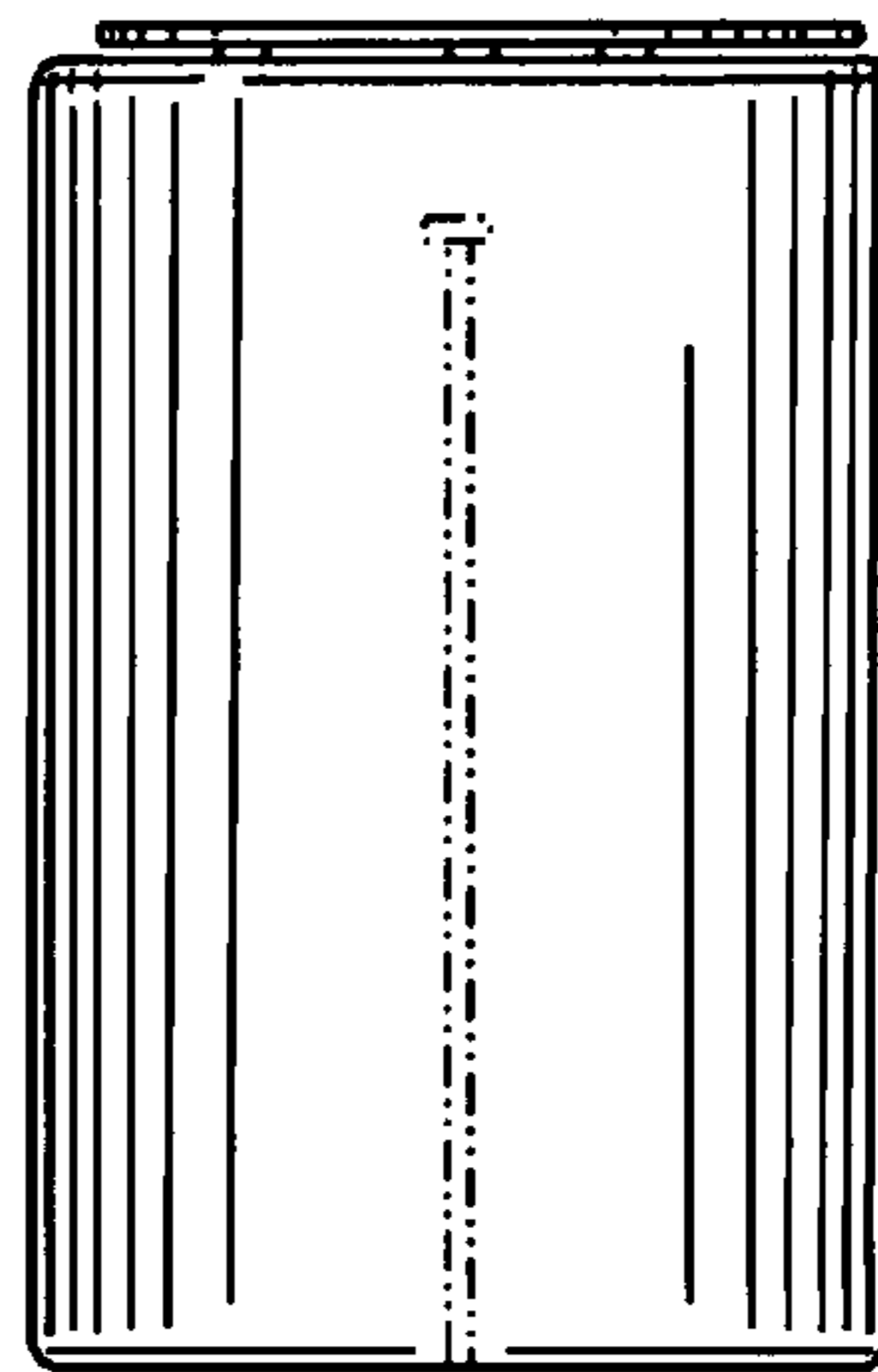

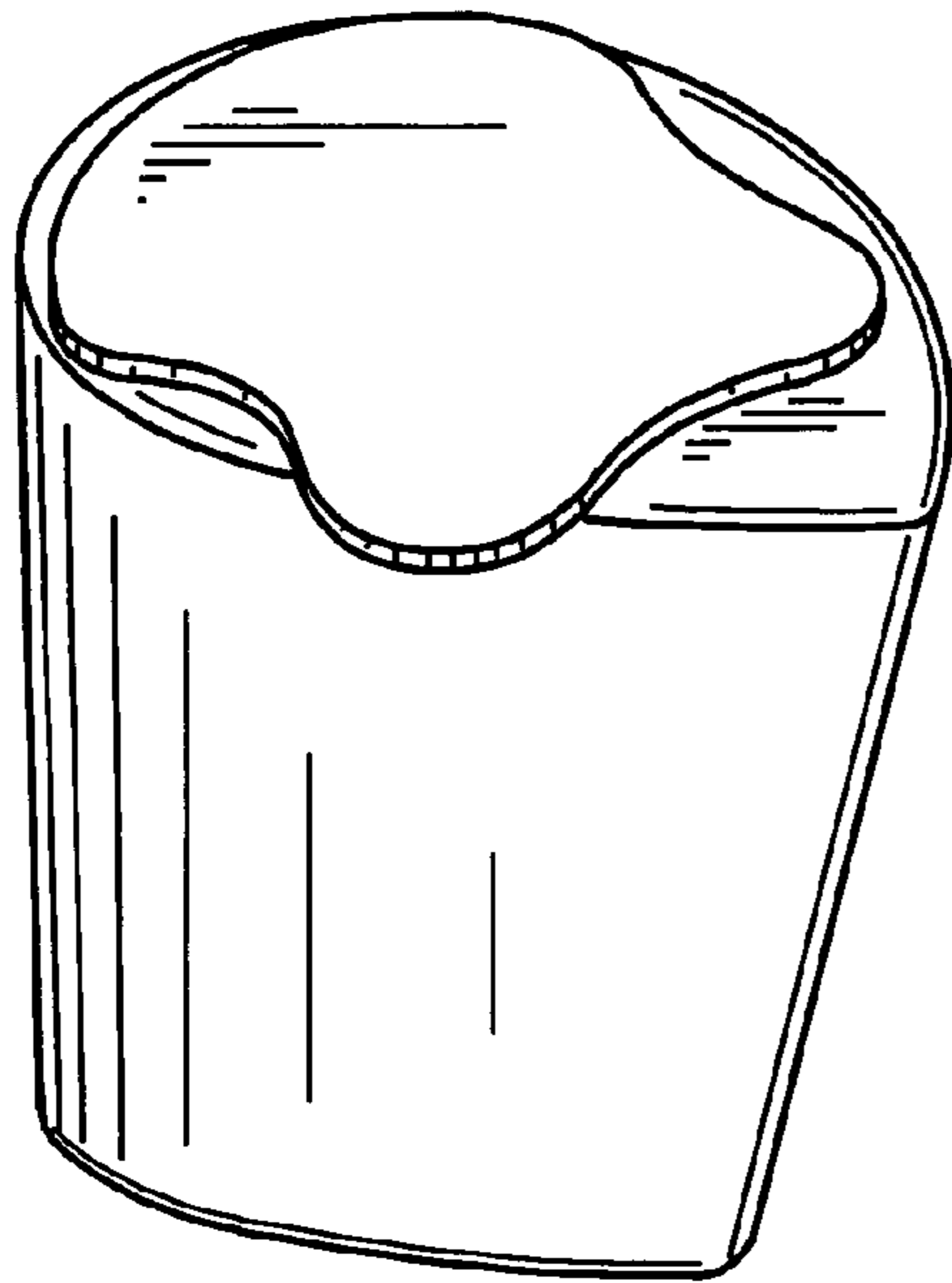

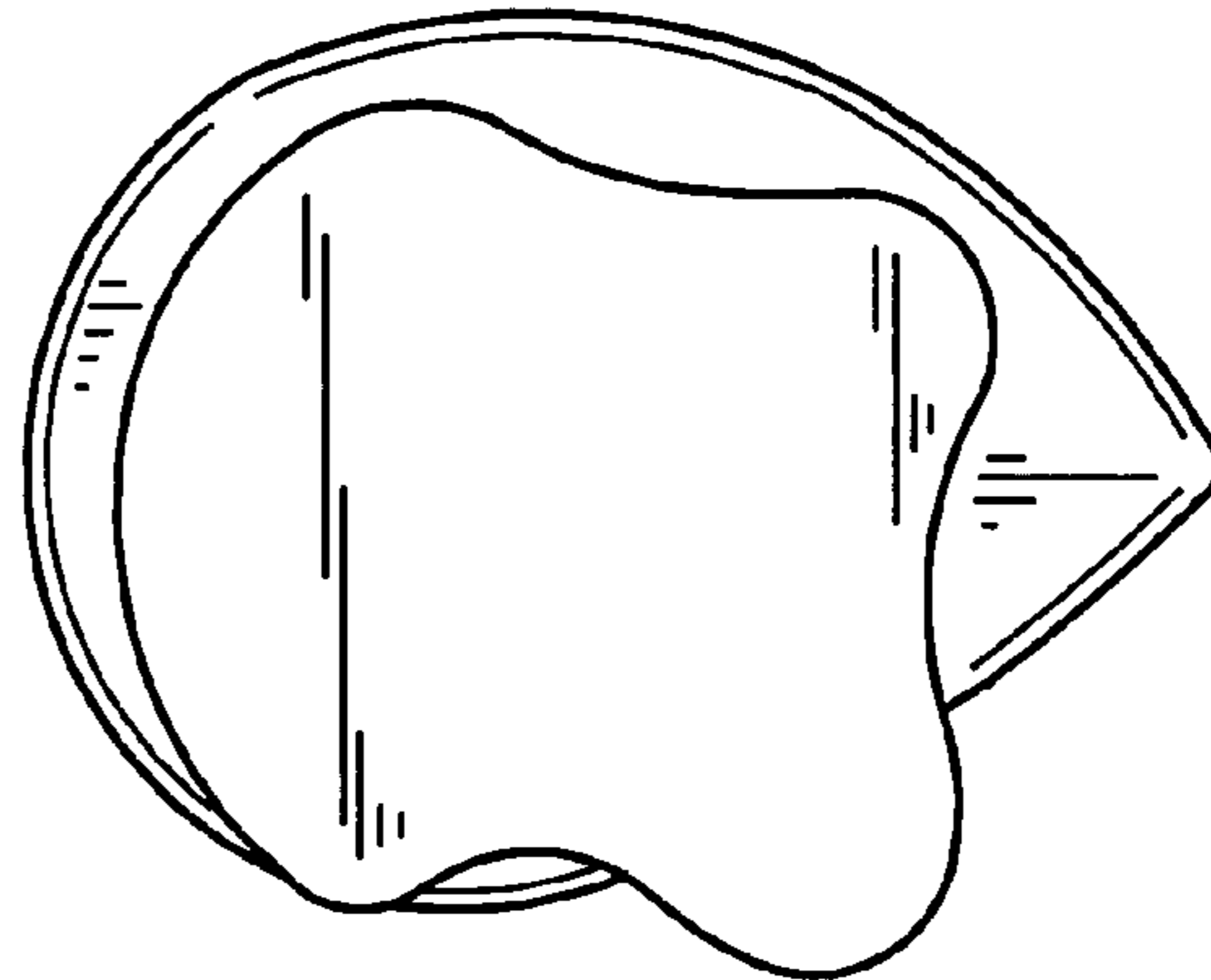

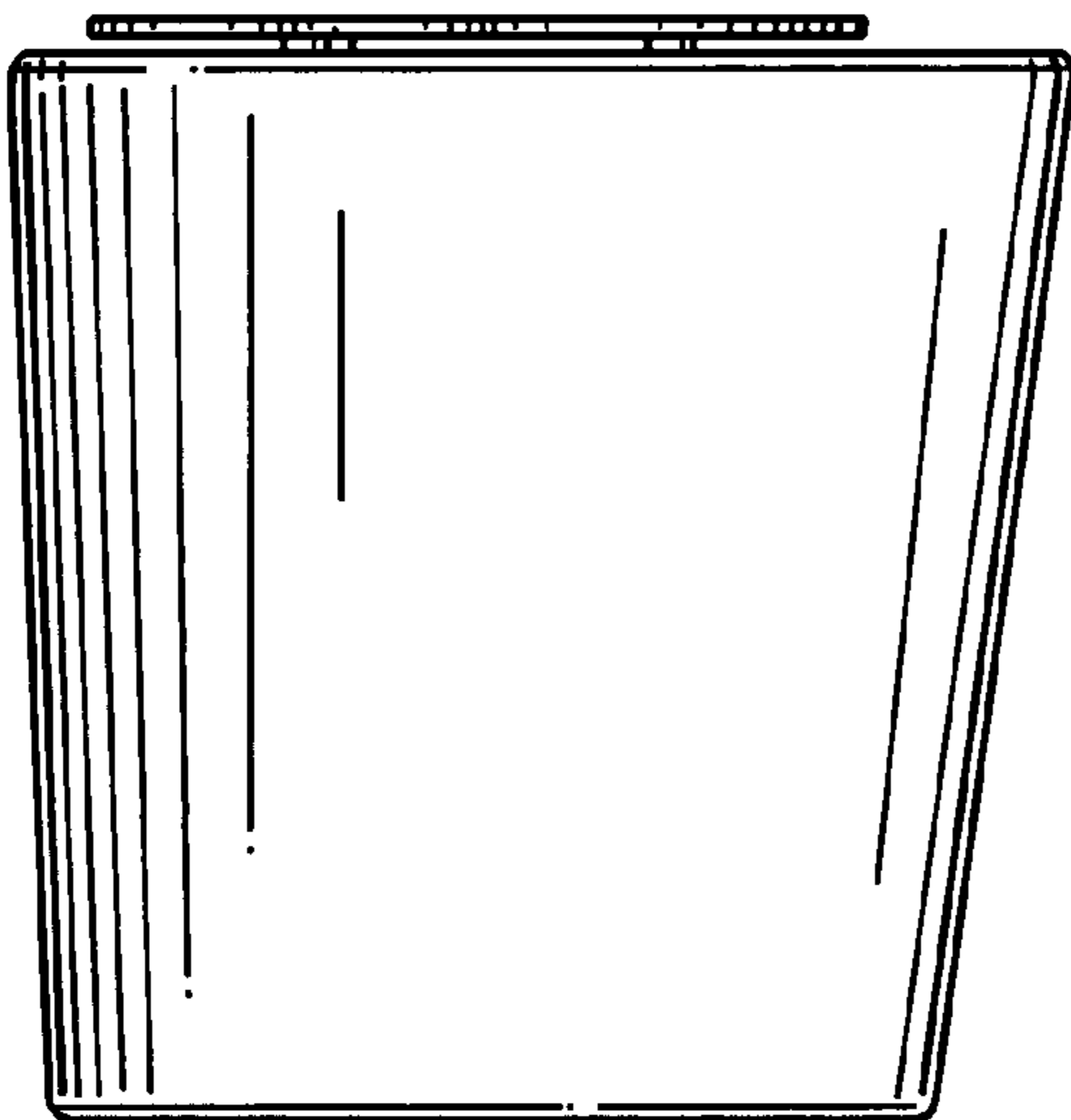

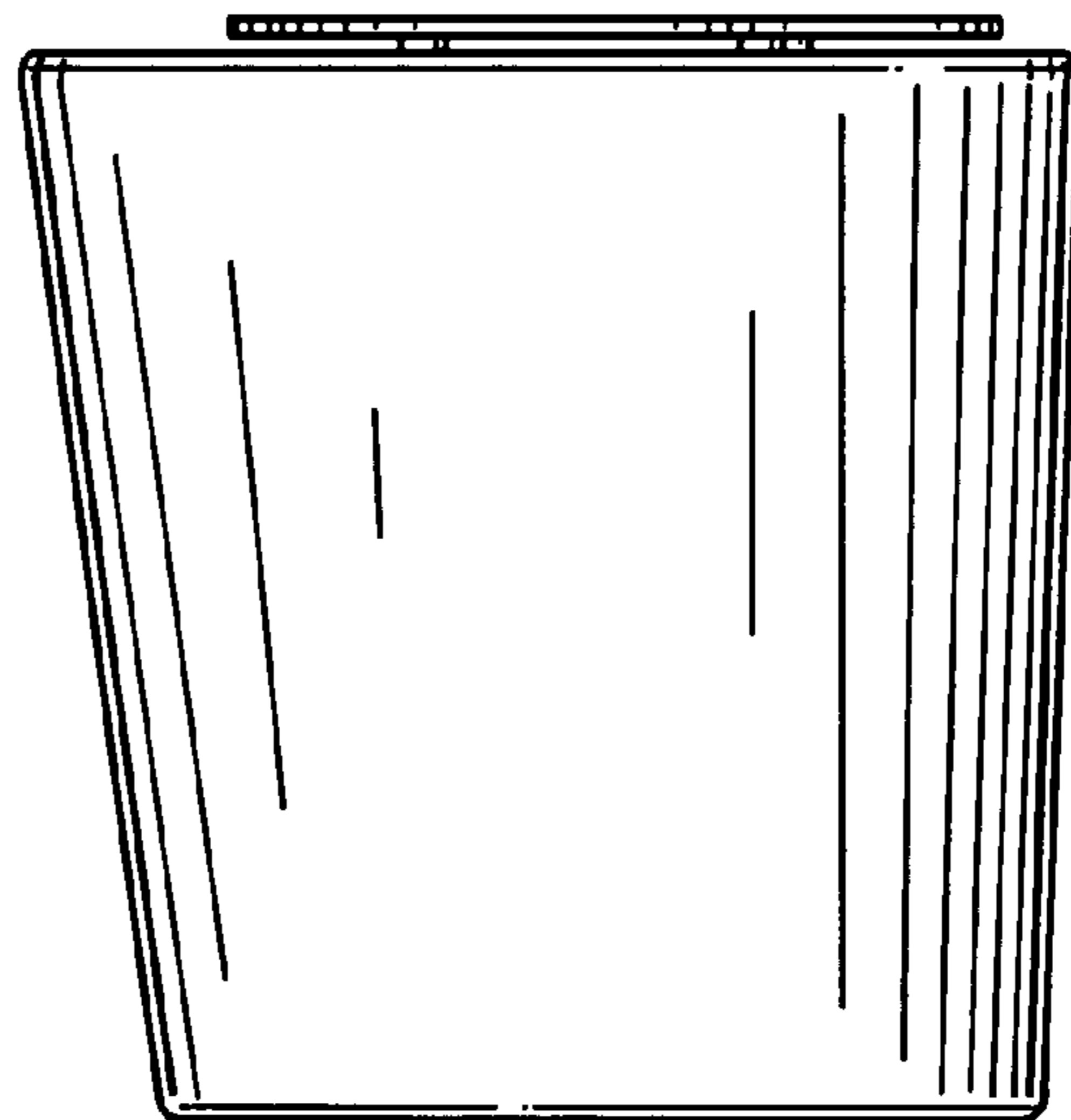

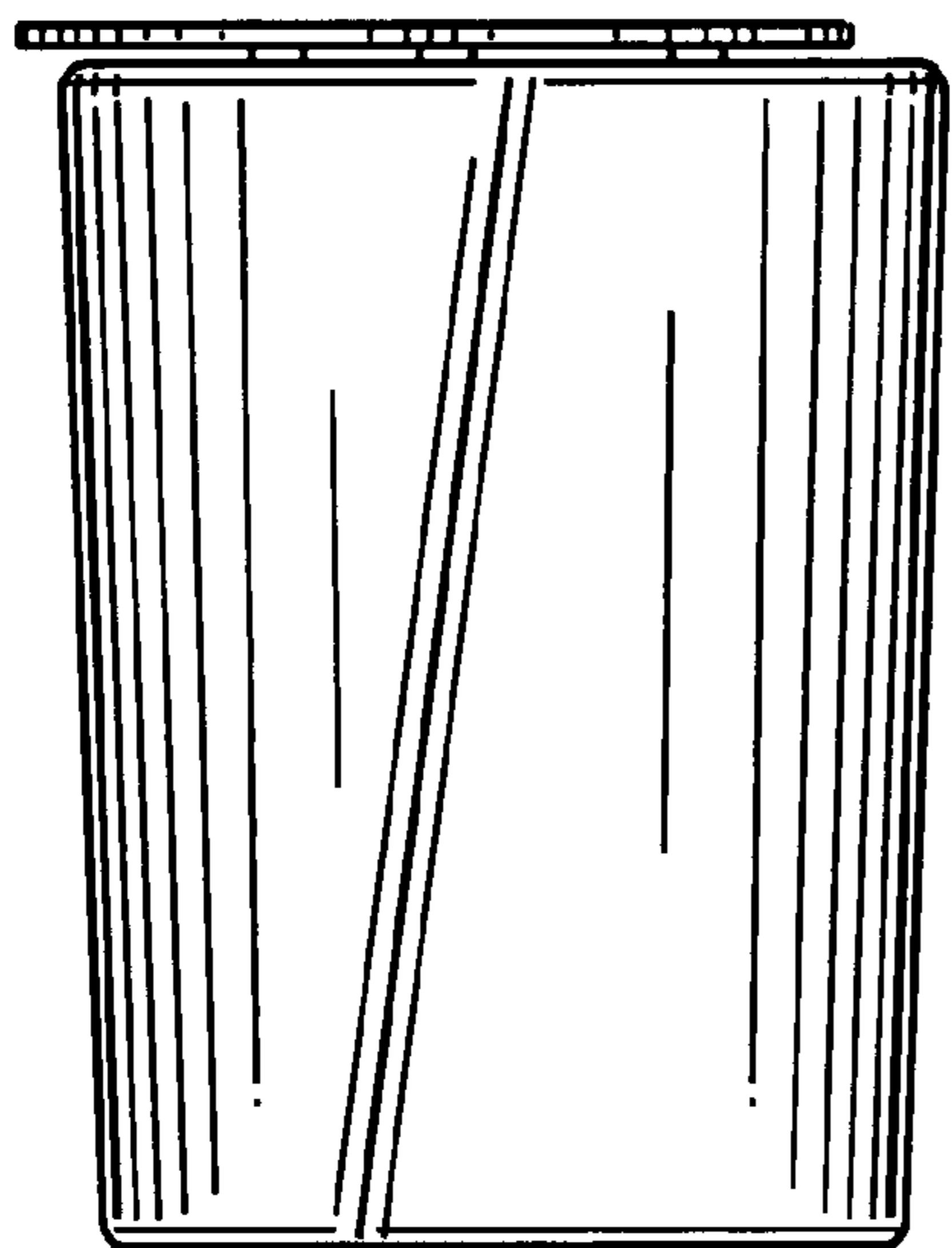

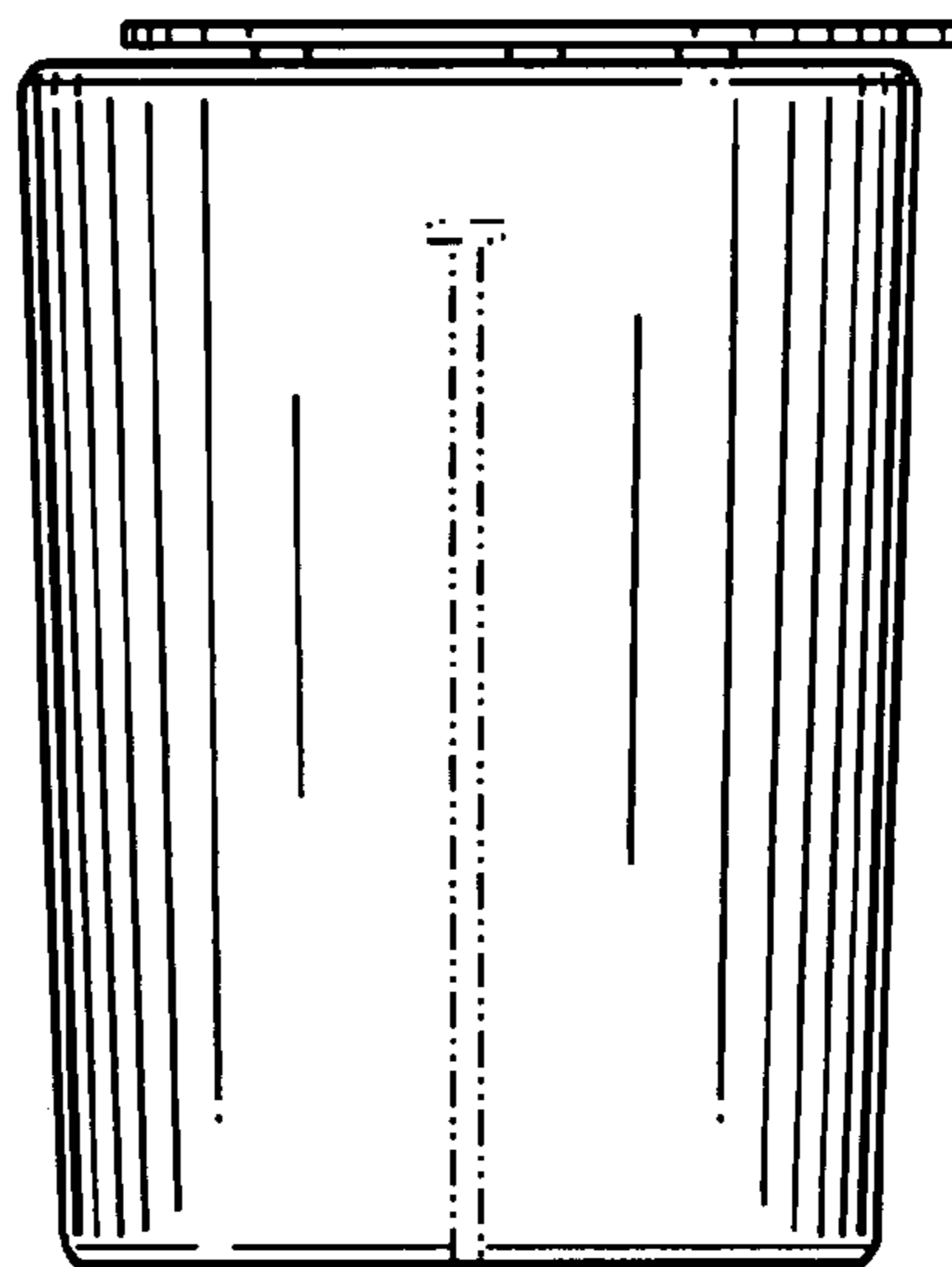

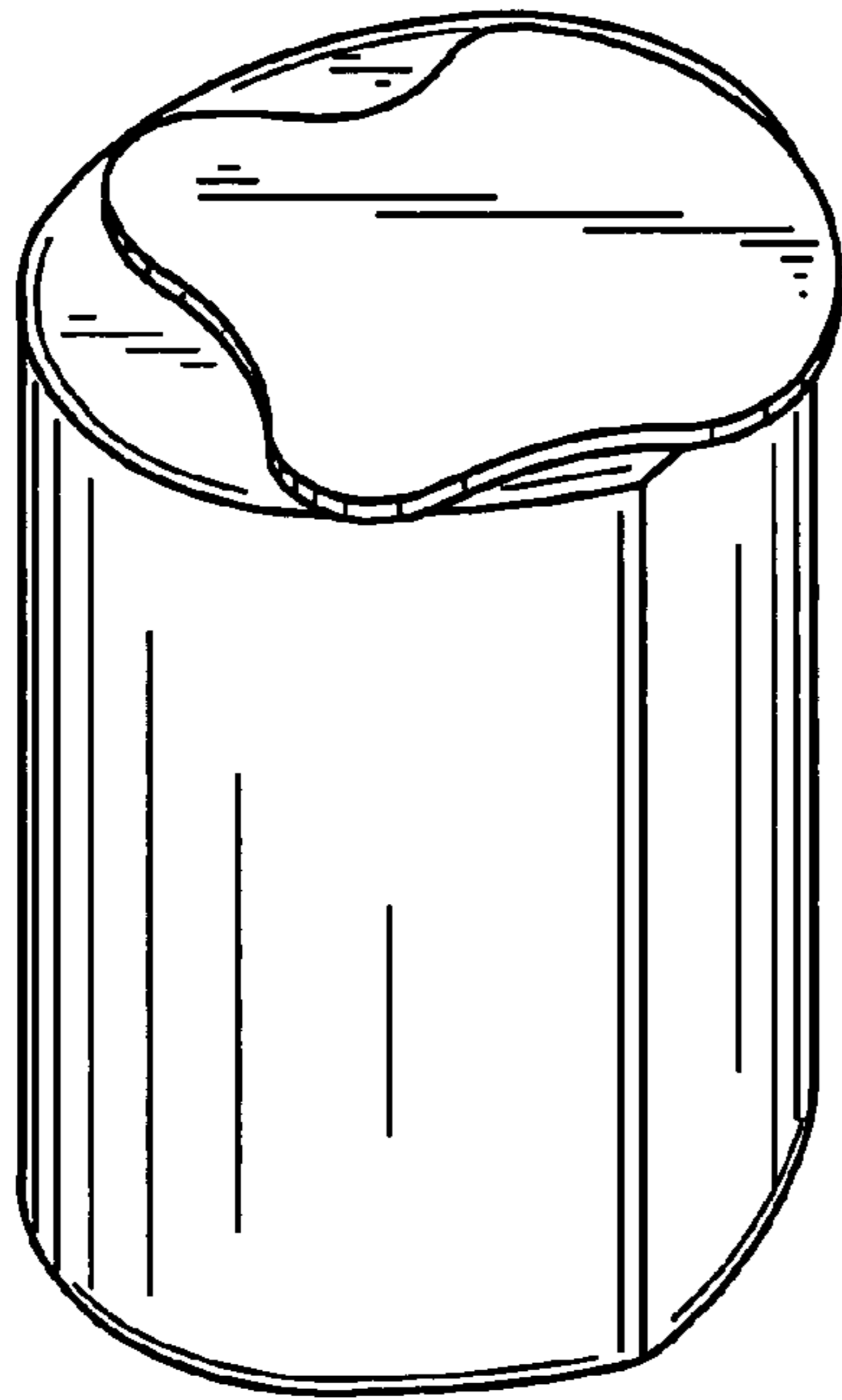

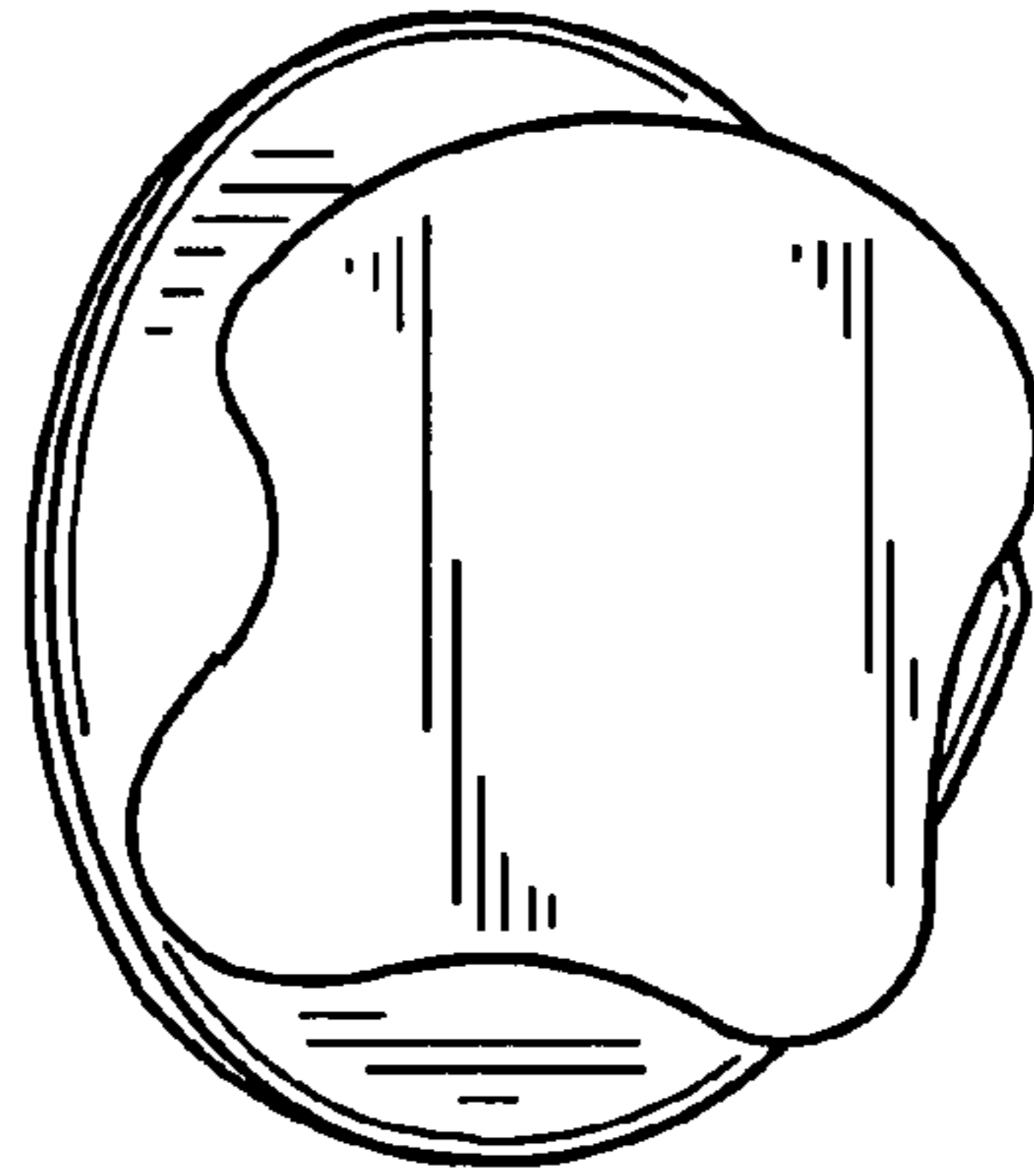

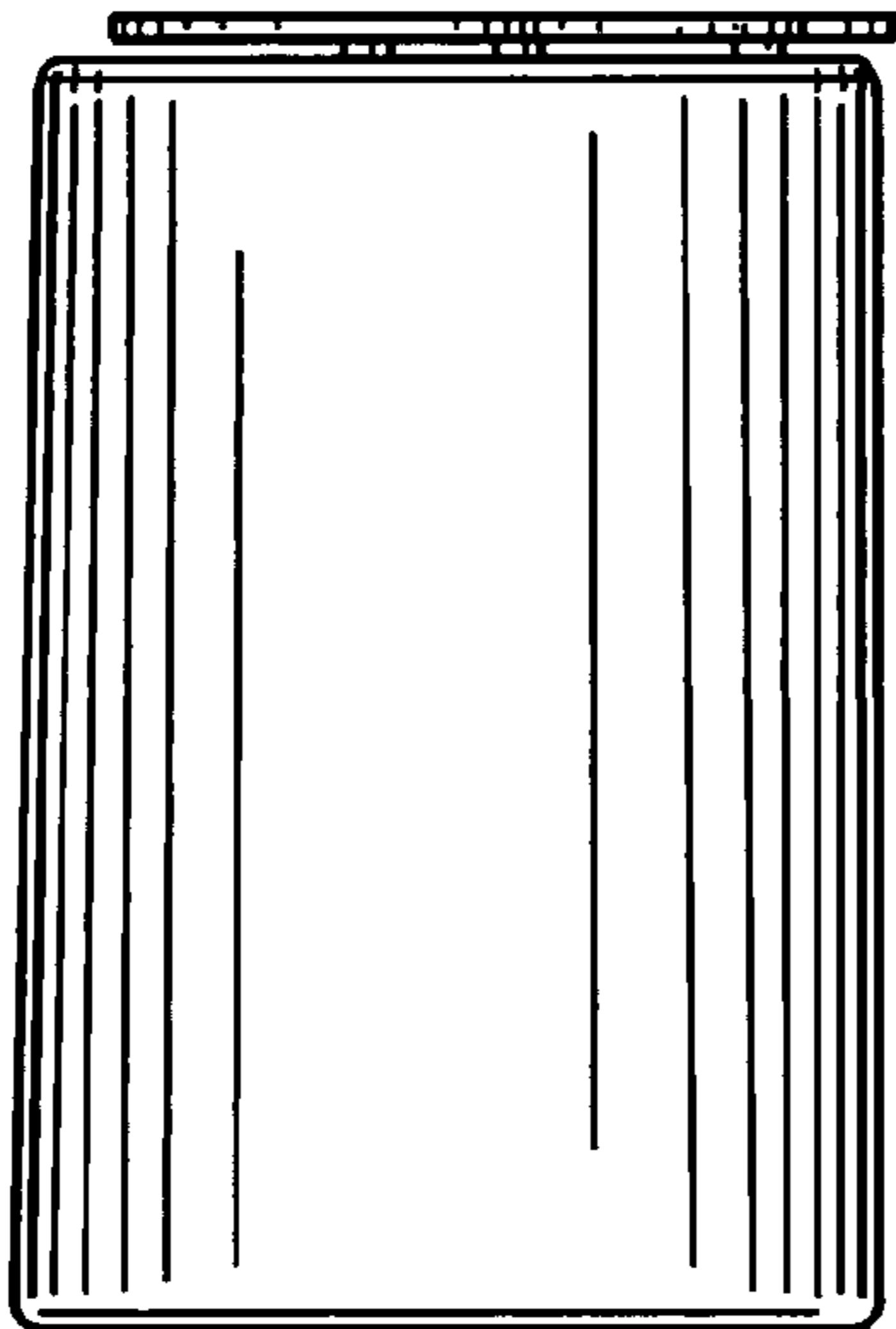

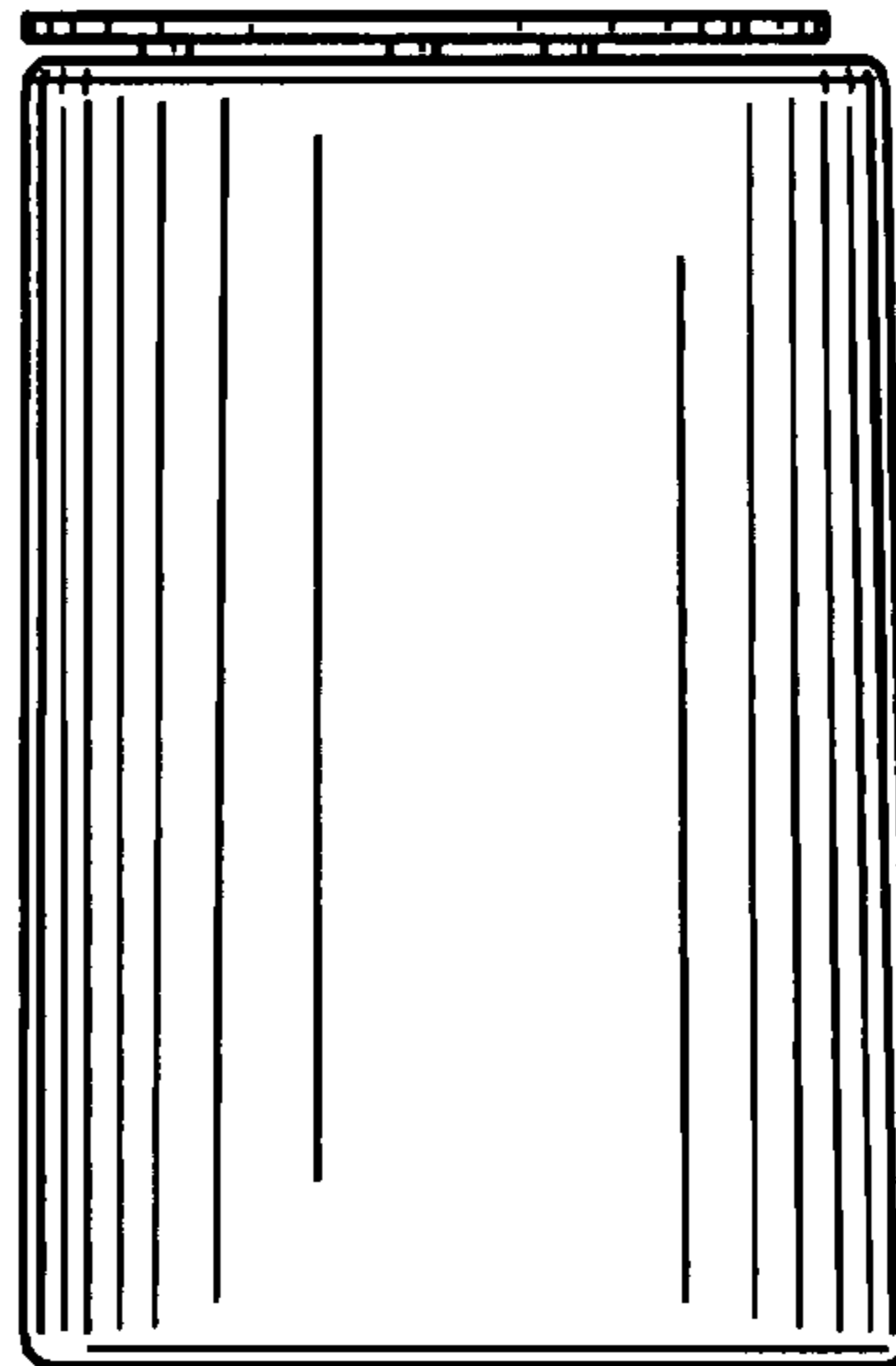

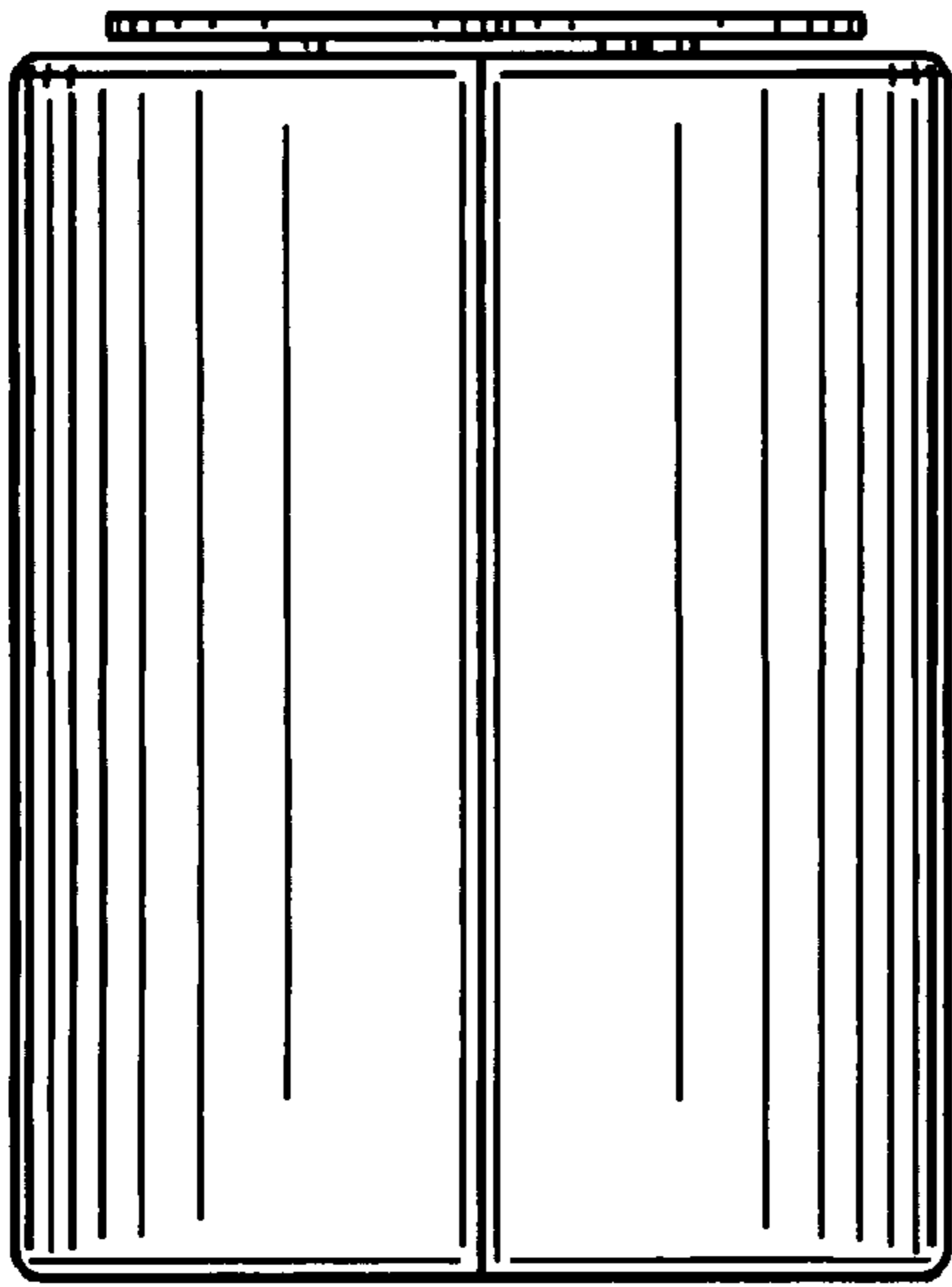

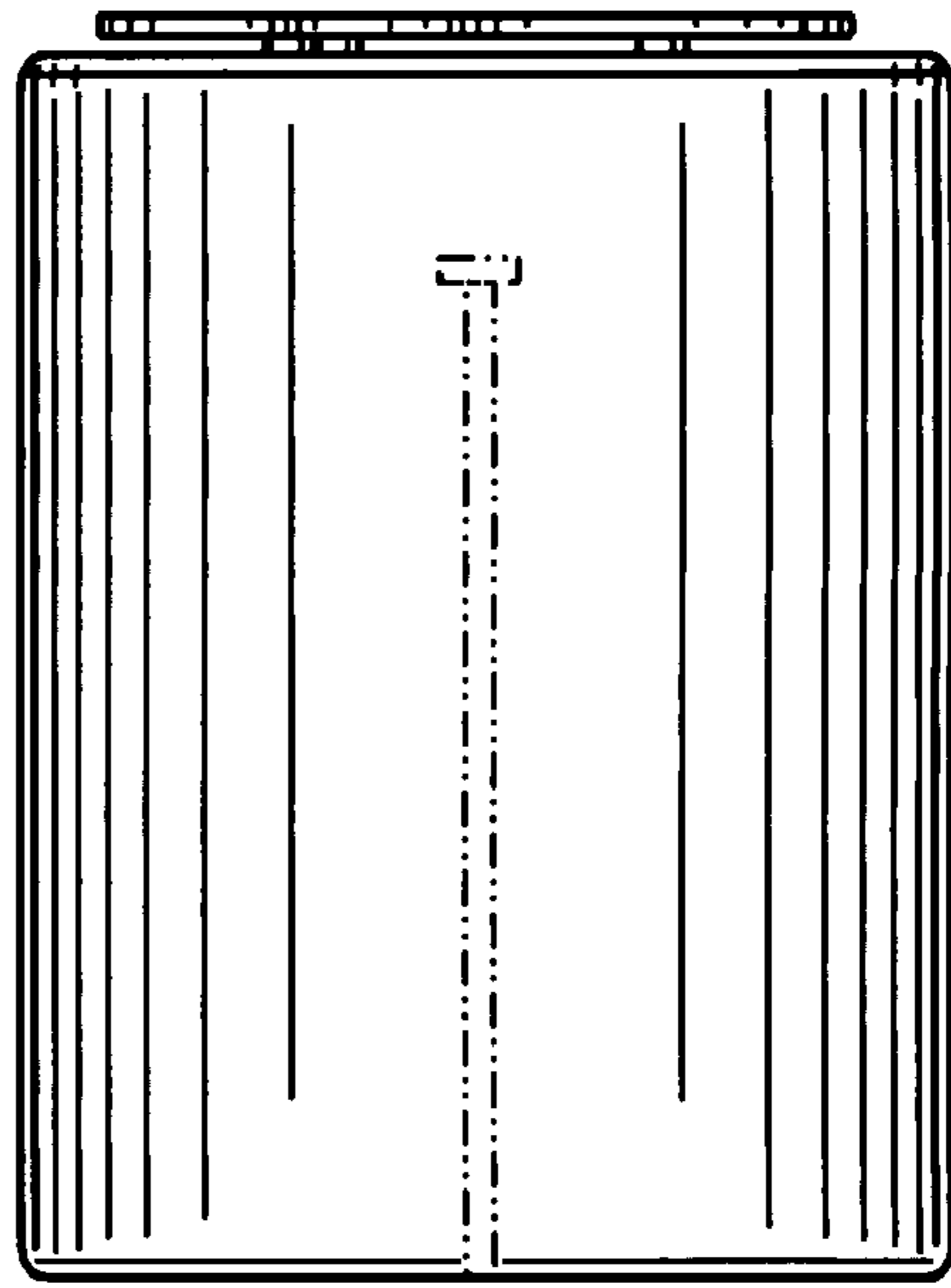

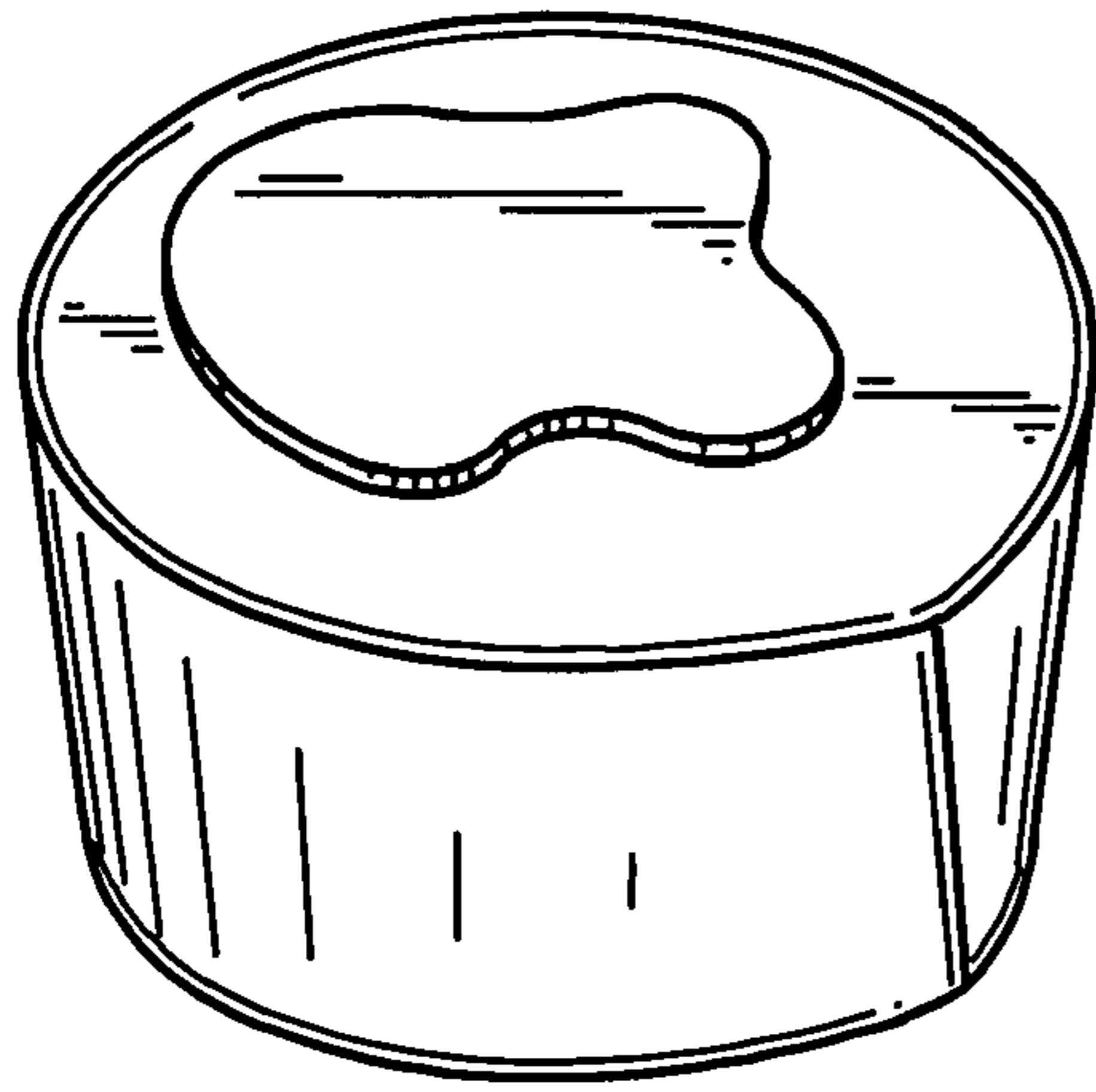

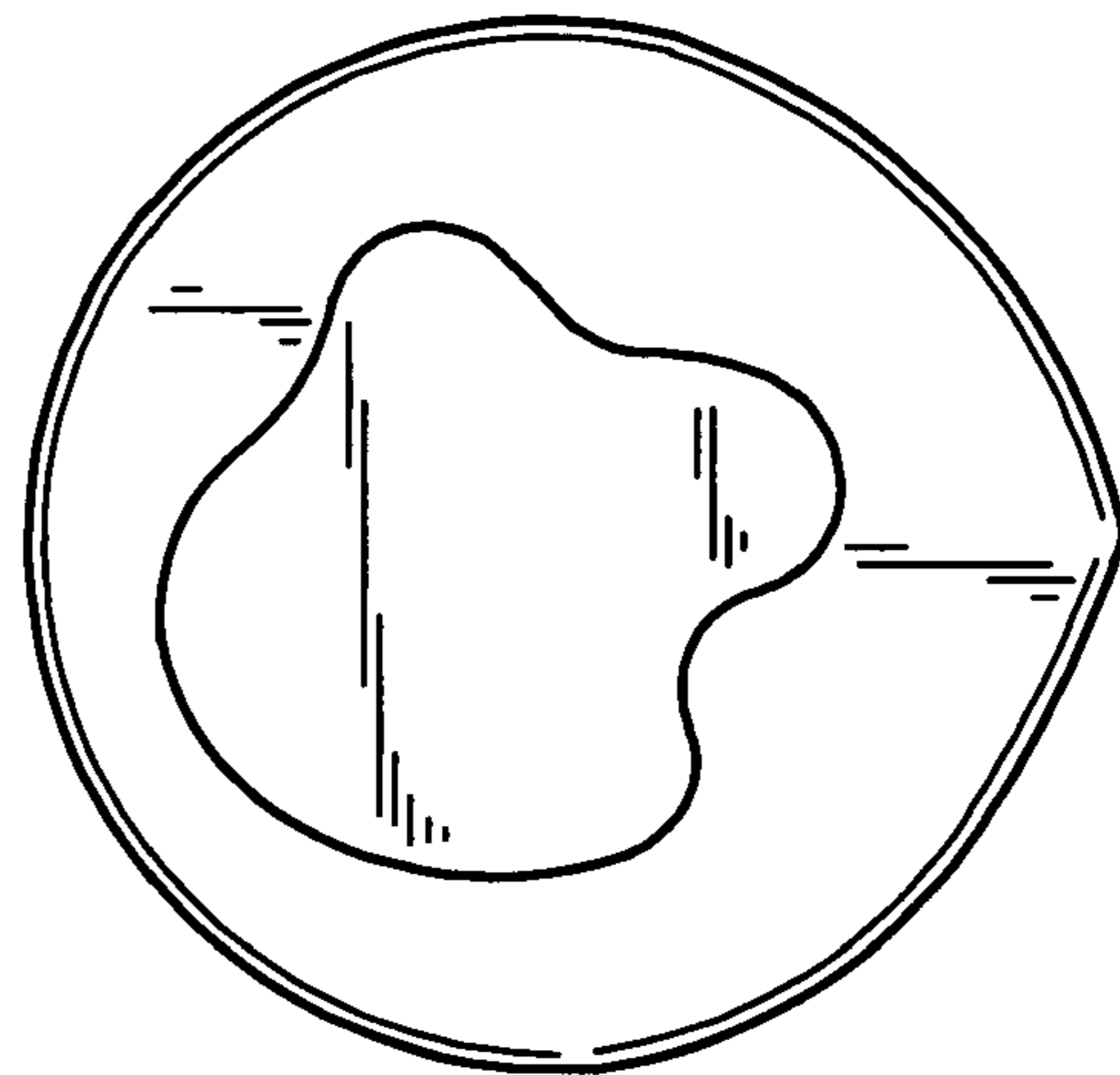

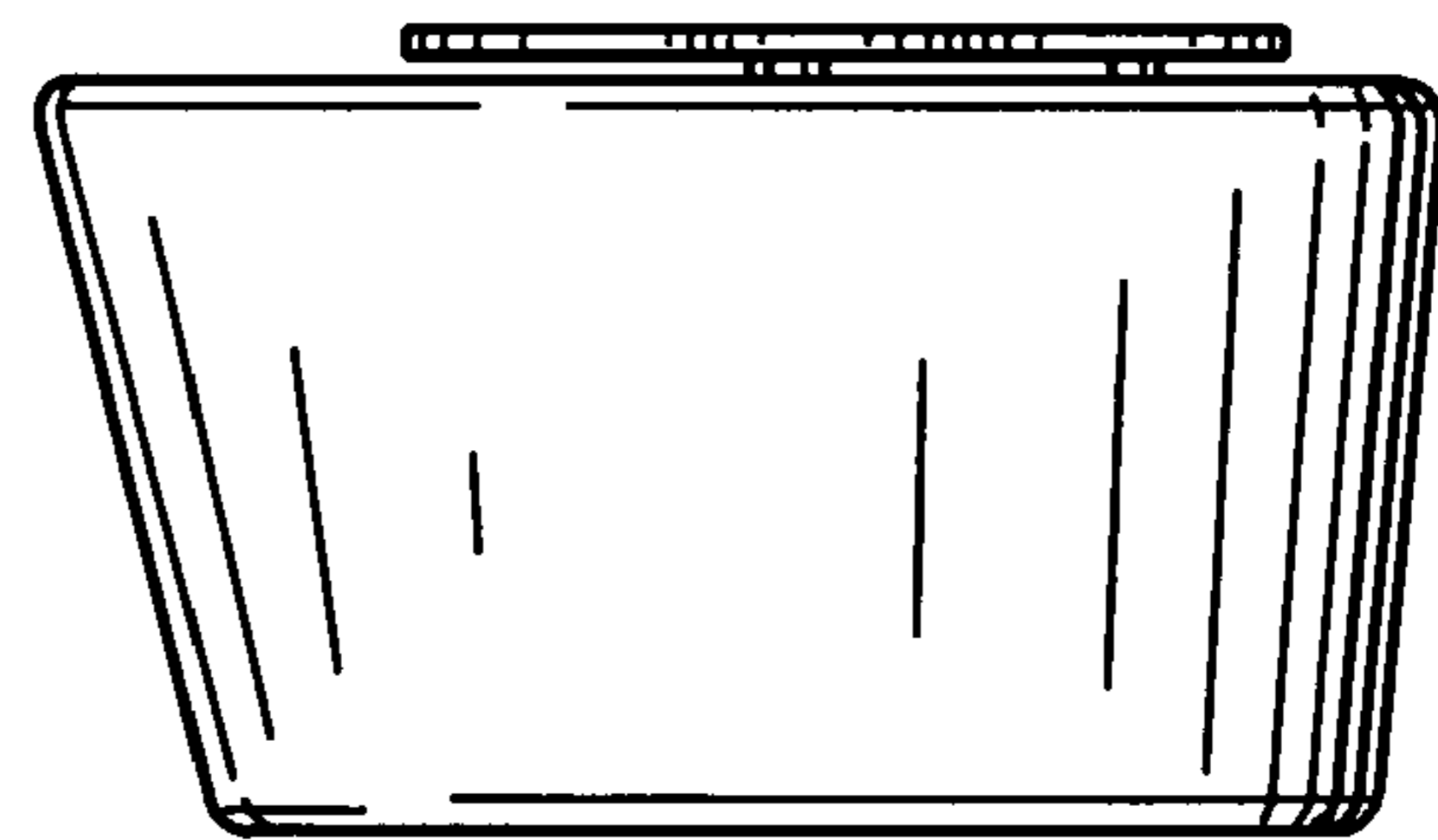
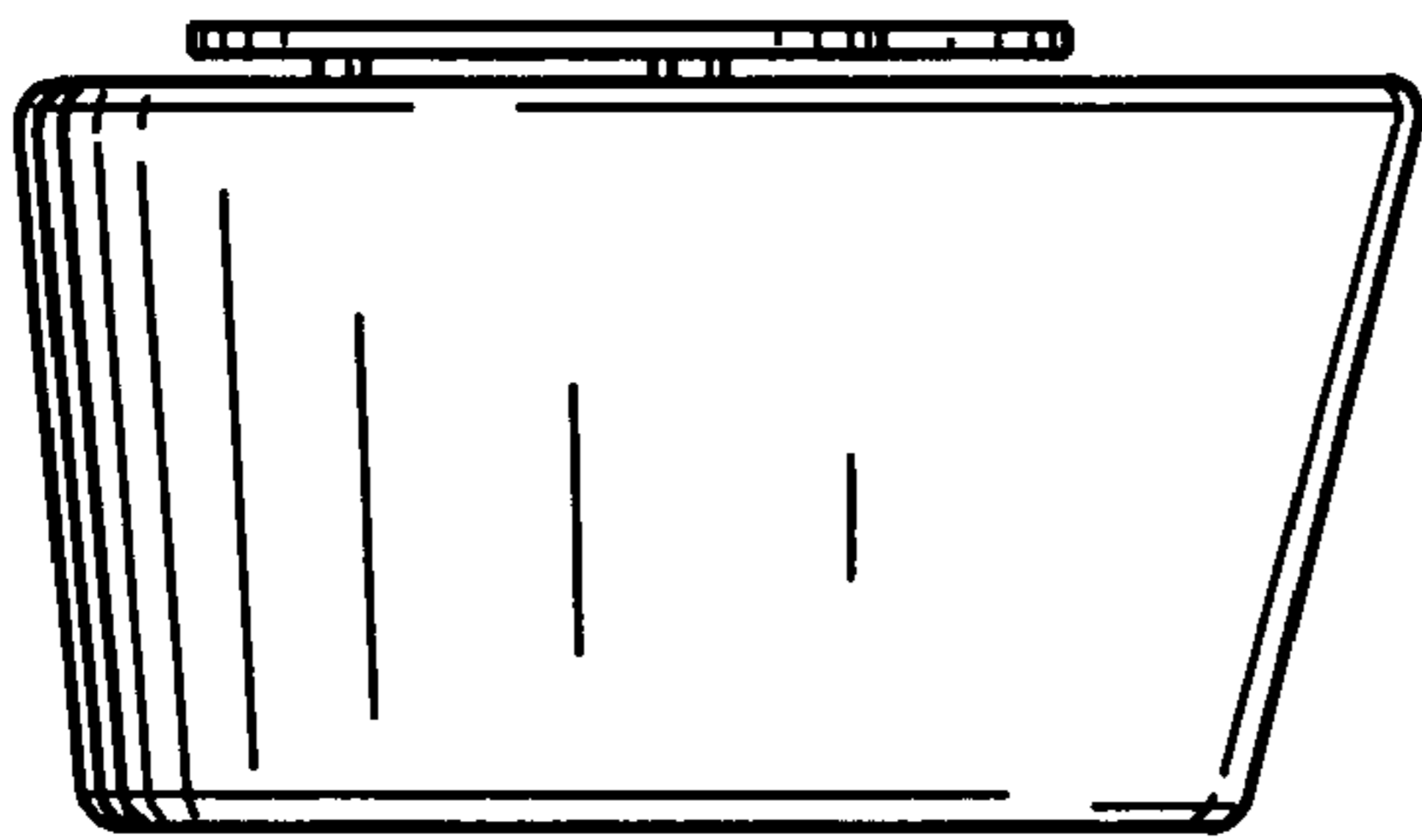

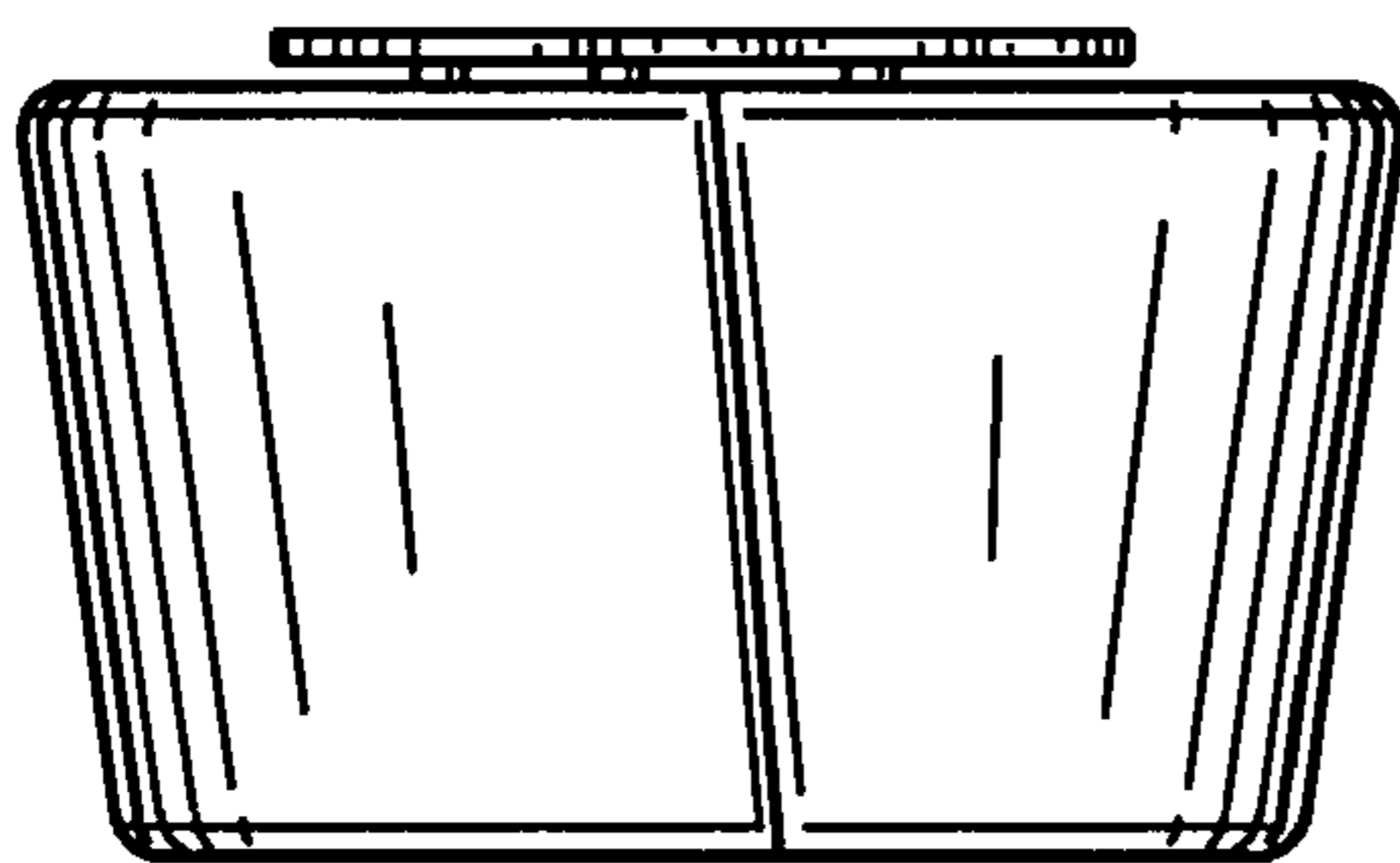

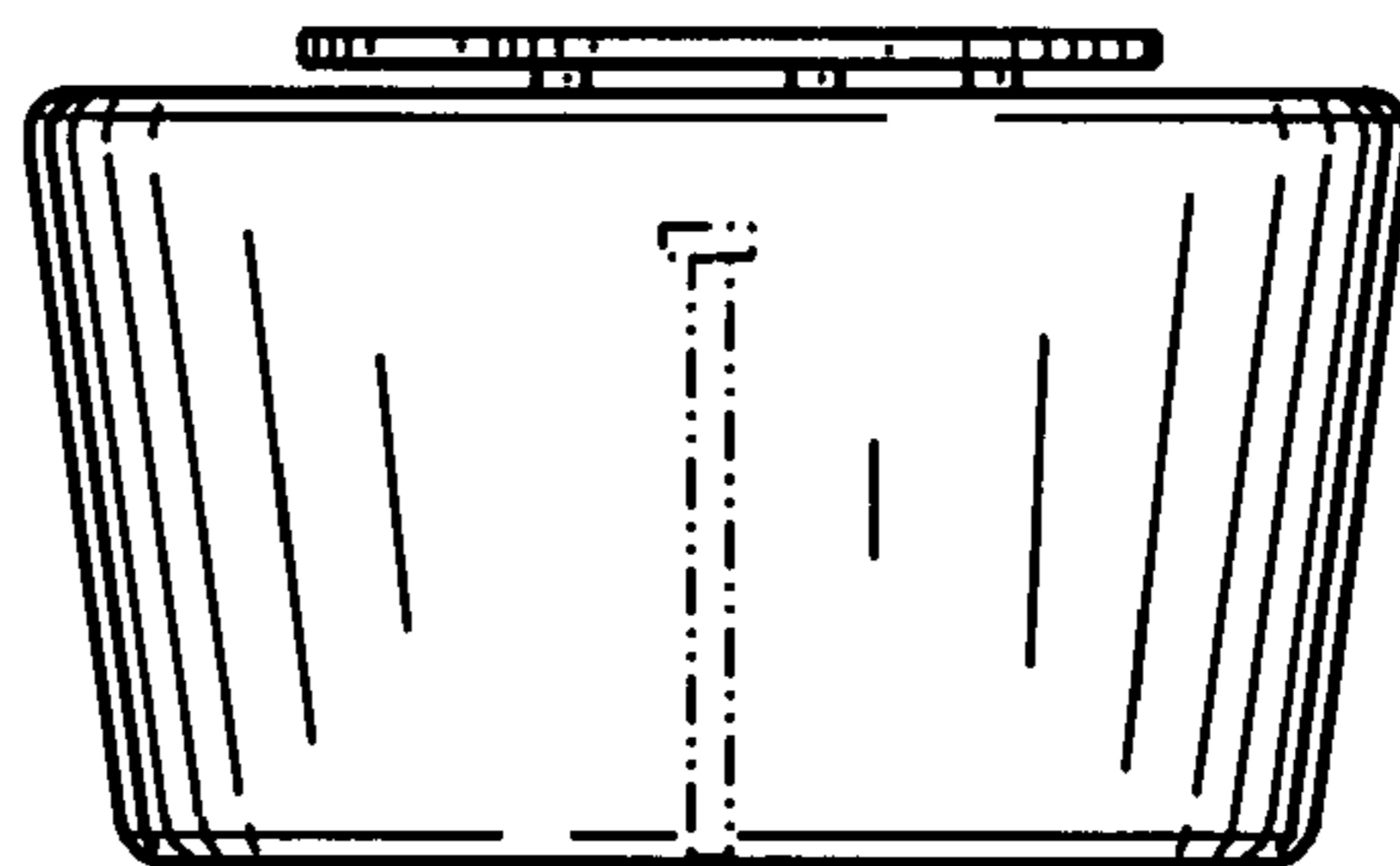

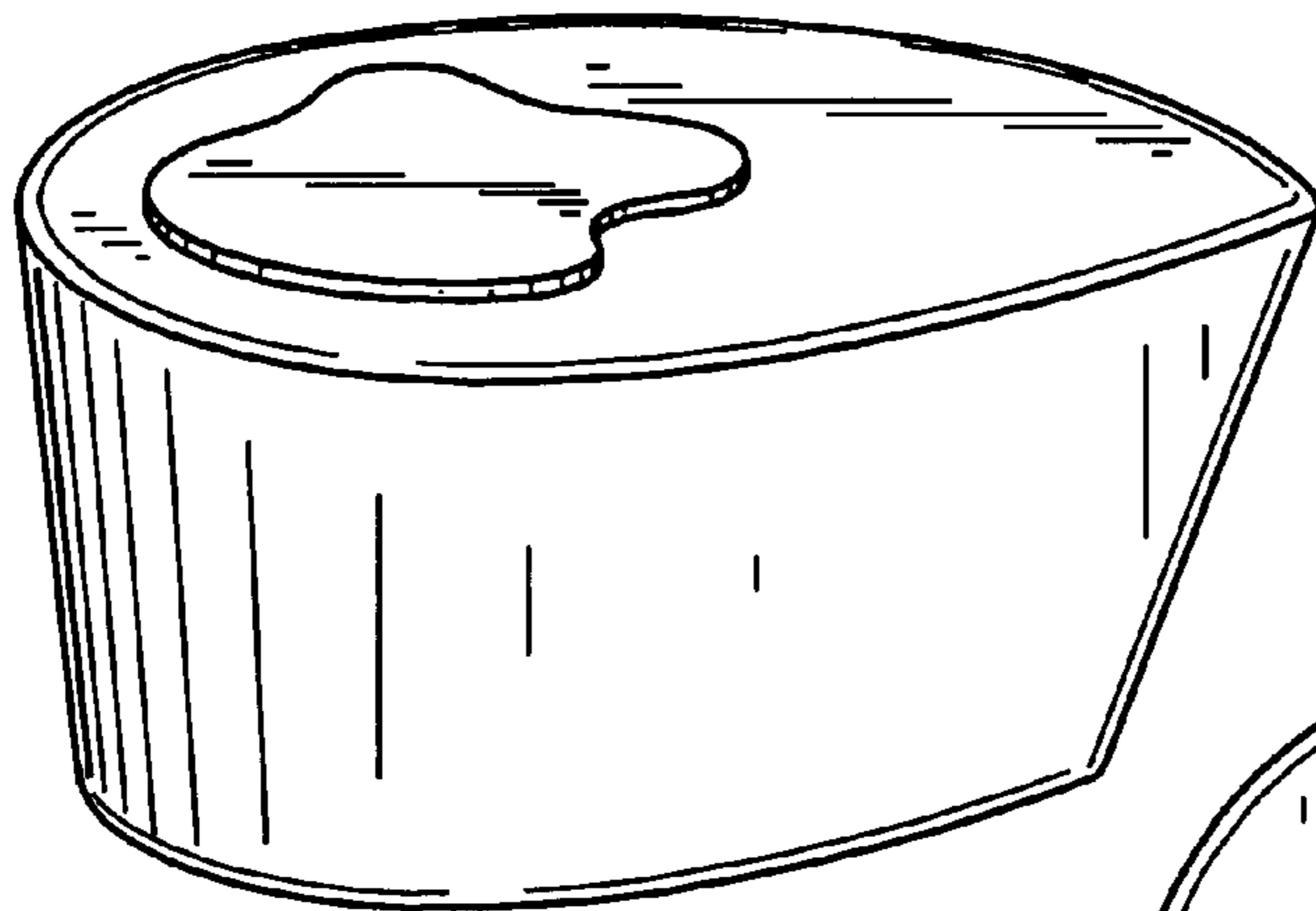

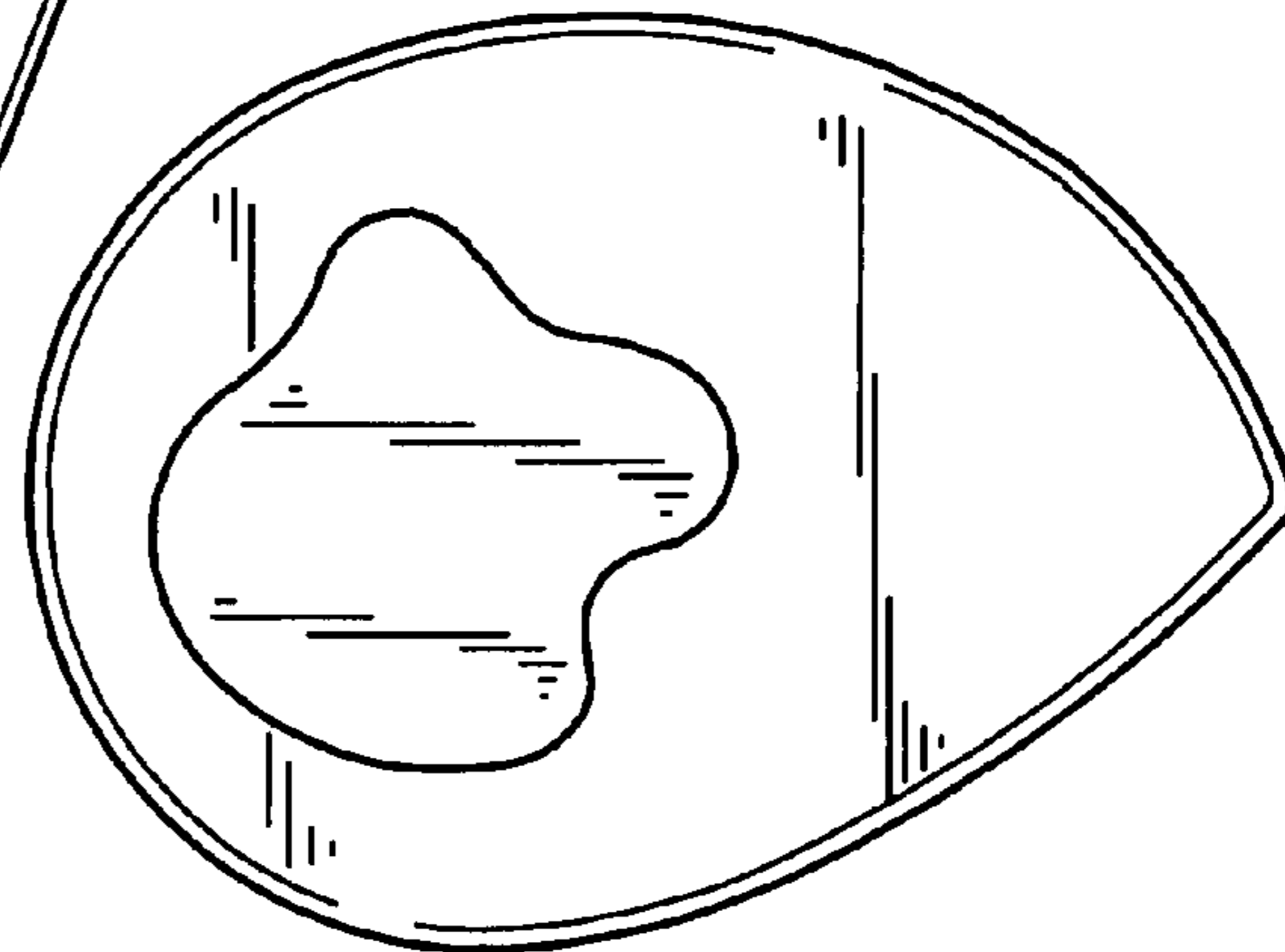

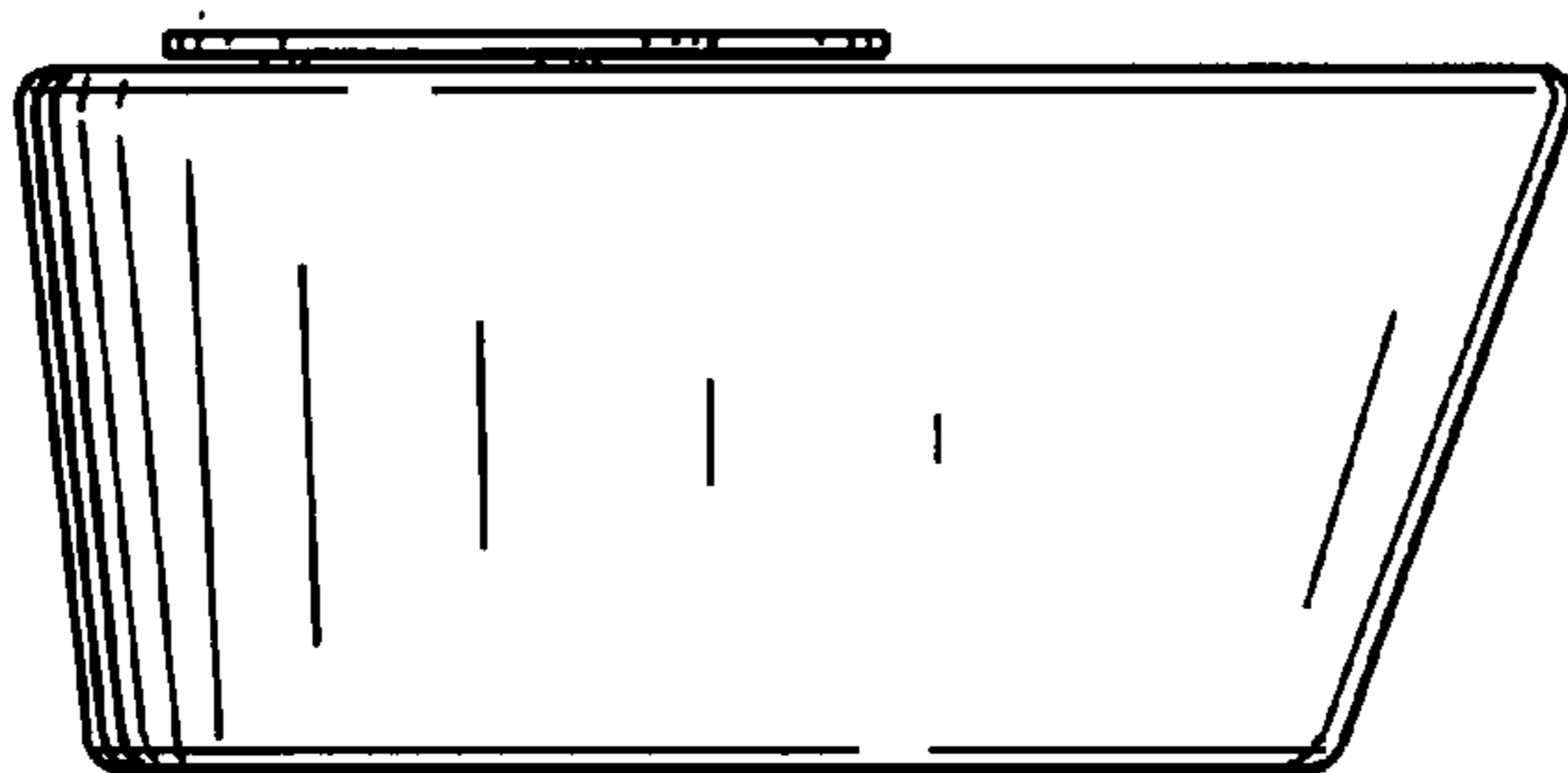

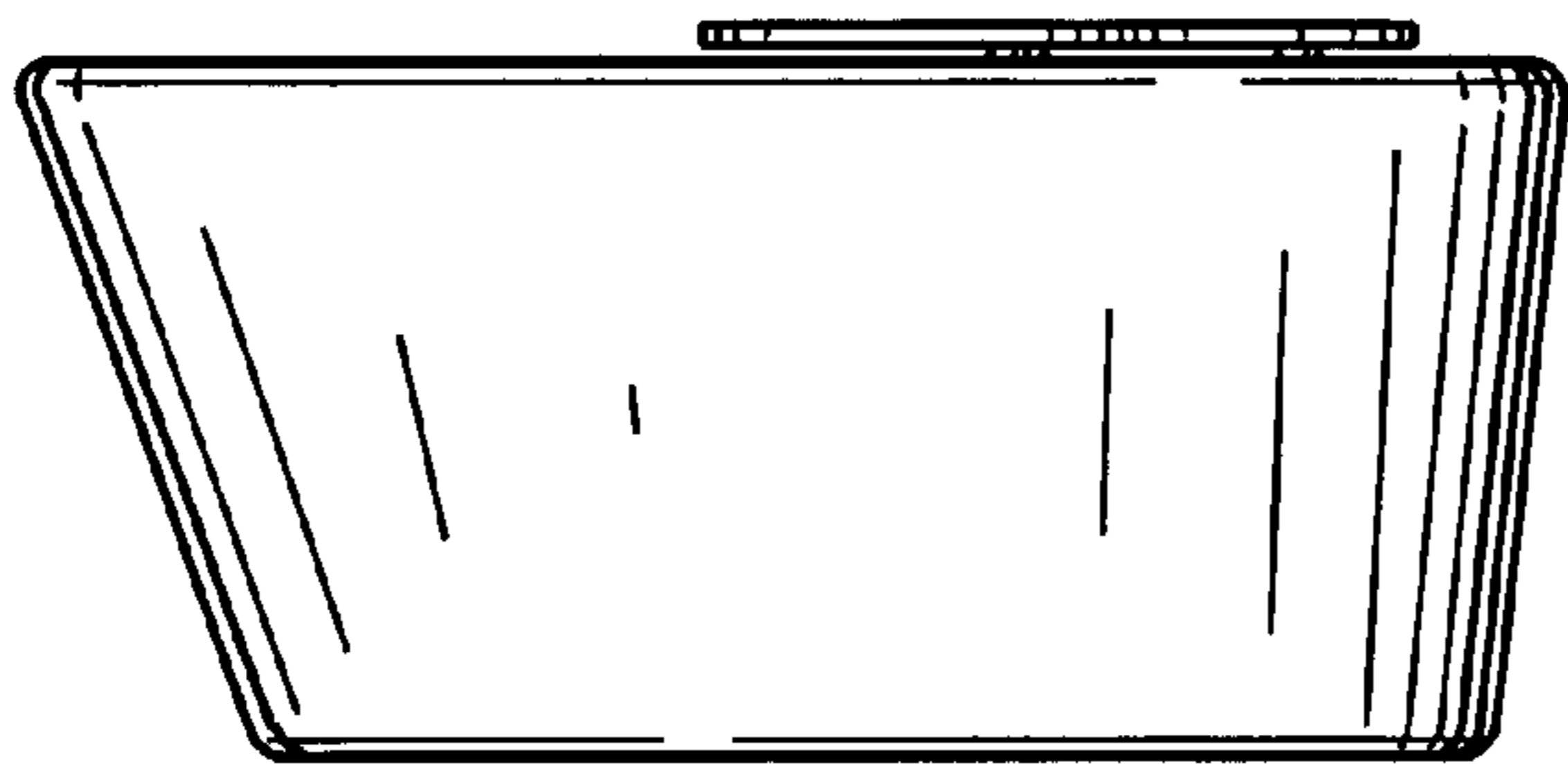

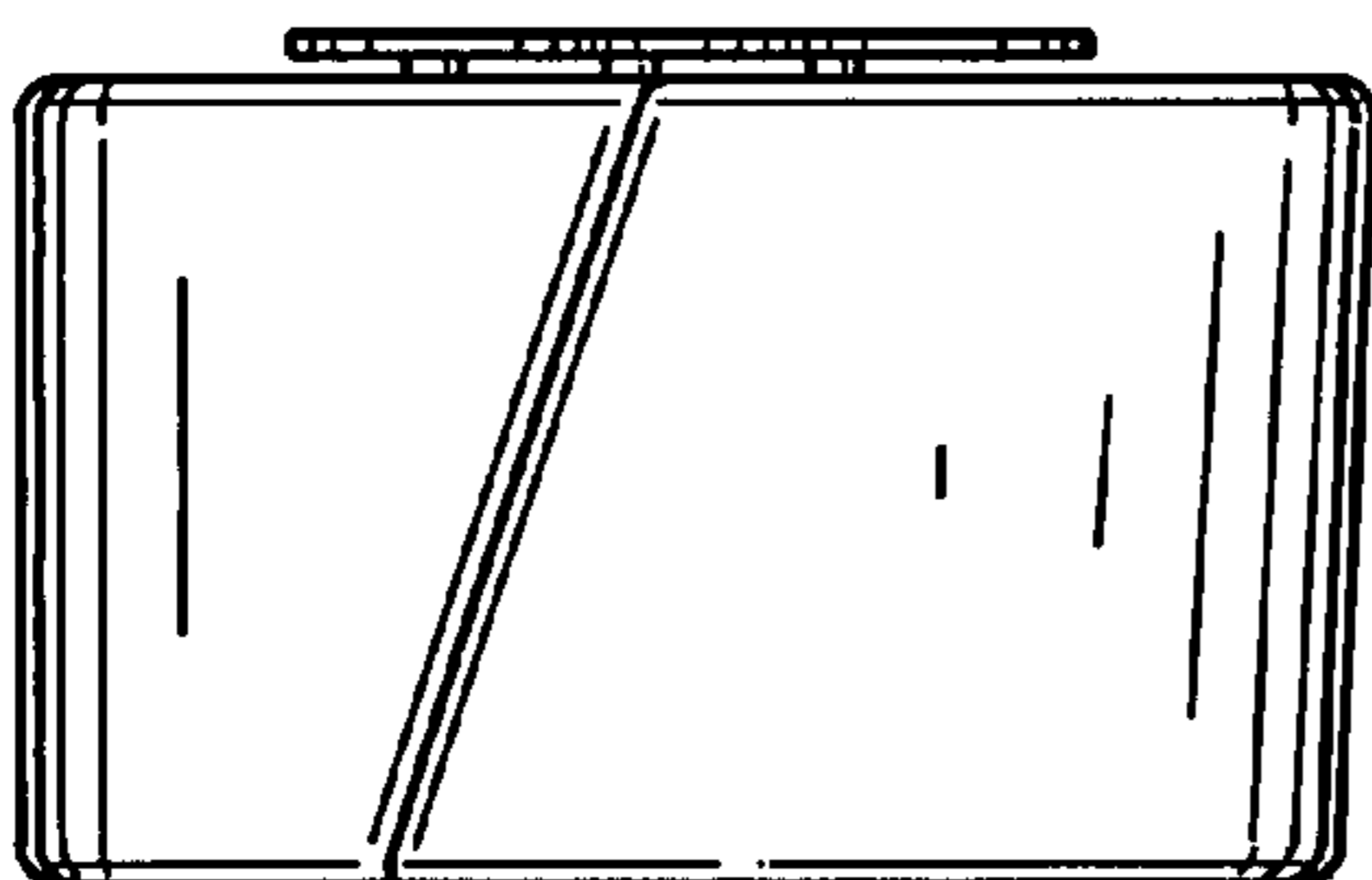
