The ornamental design for a cup containing a disc object, as shown and described.

**DESCRIPTION**

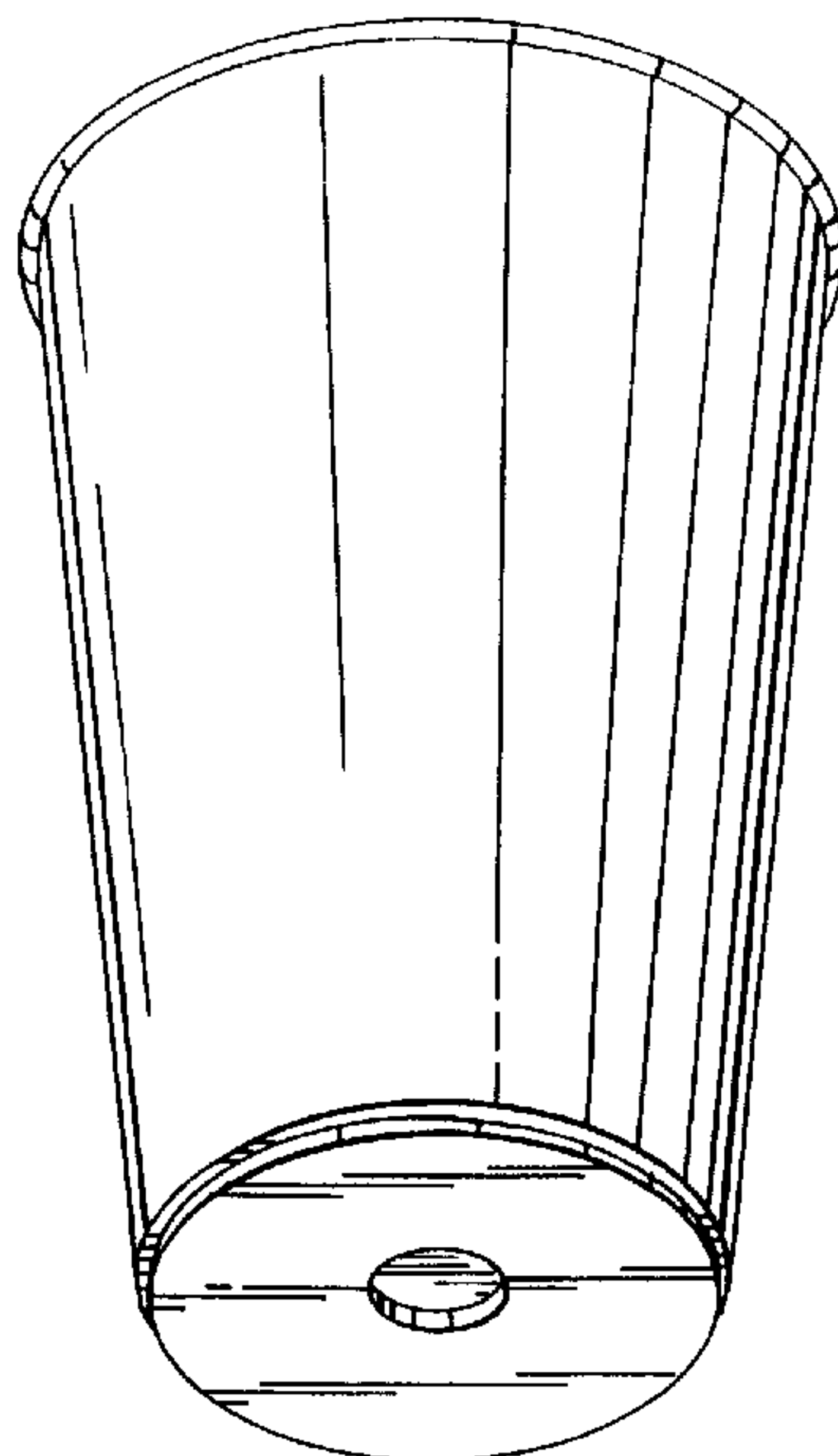

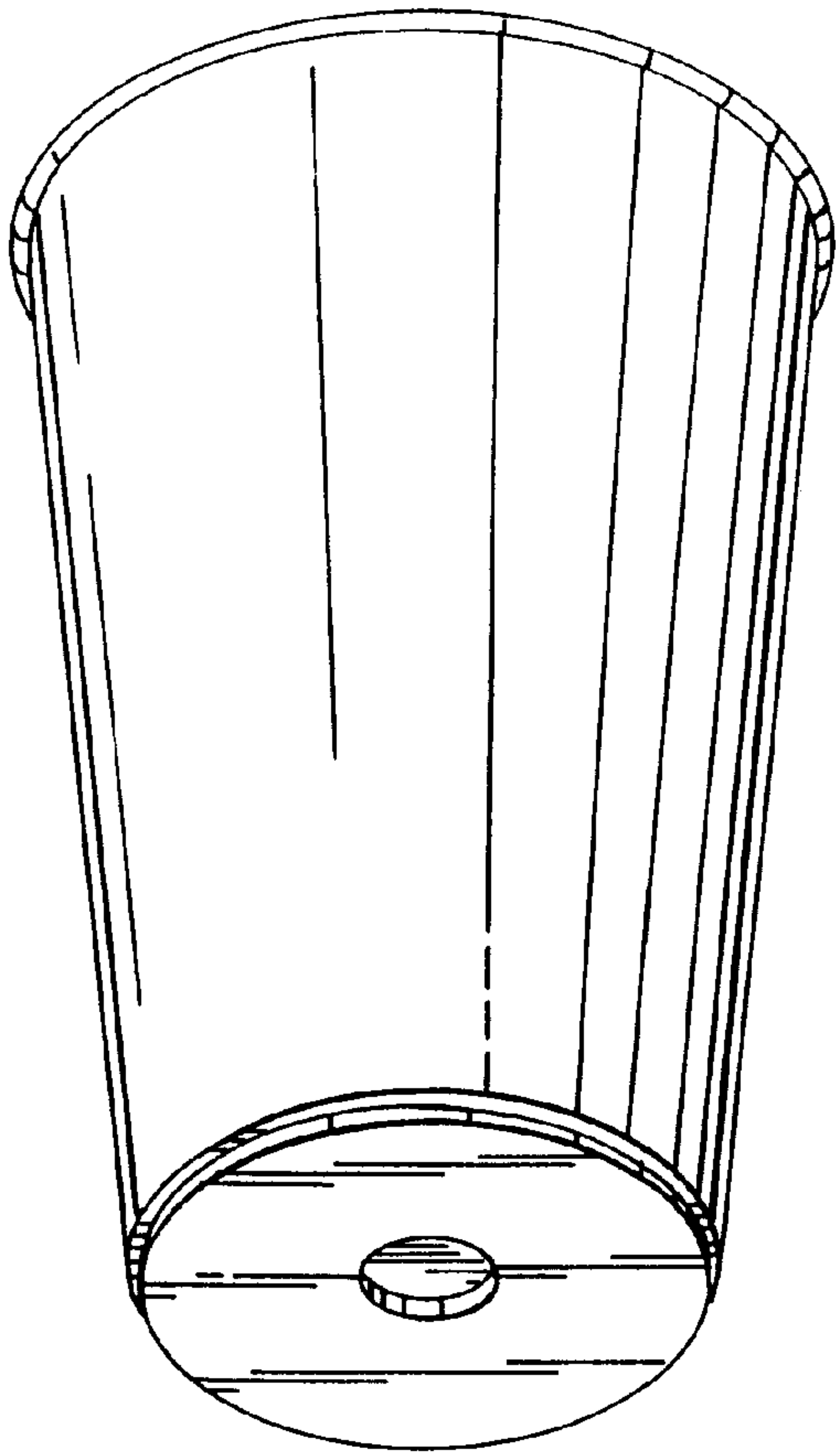

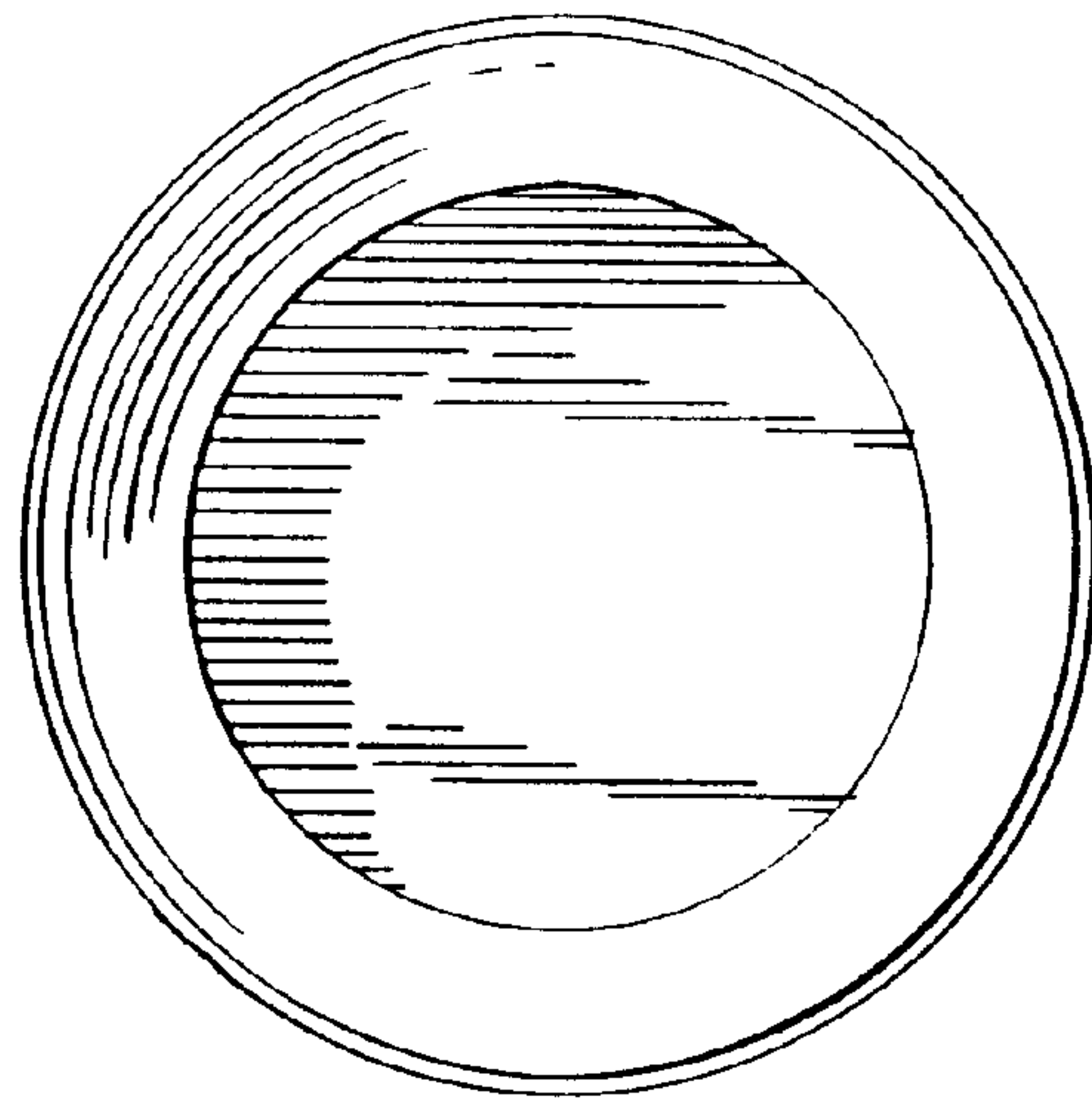

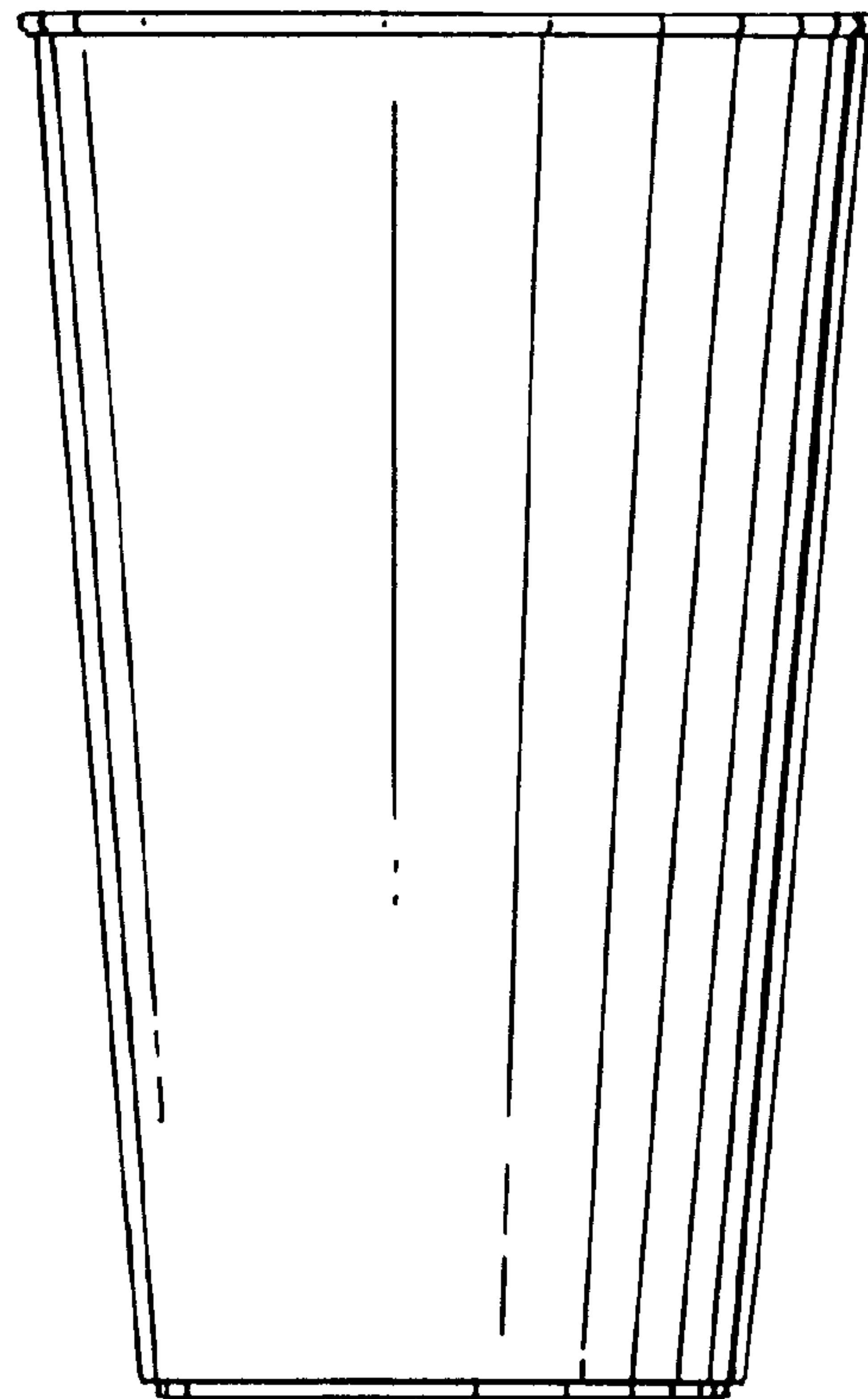

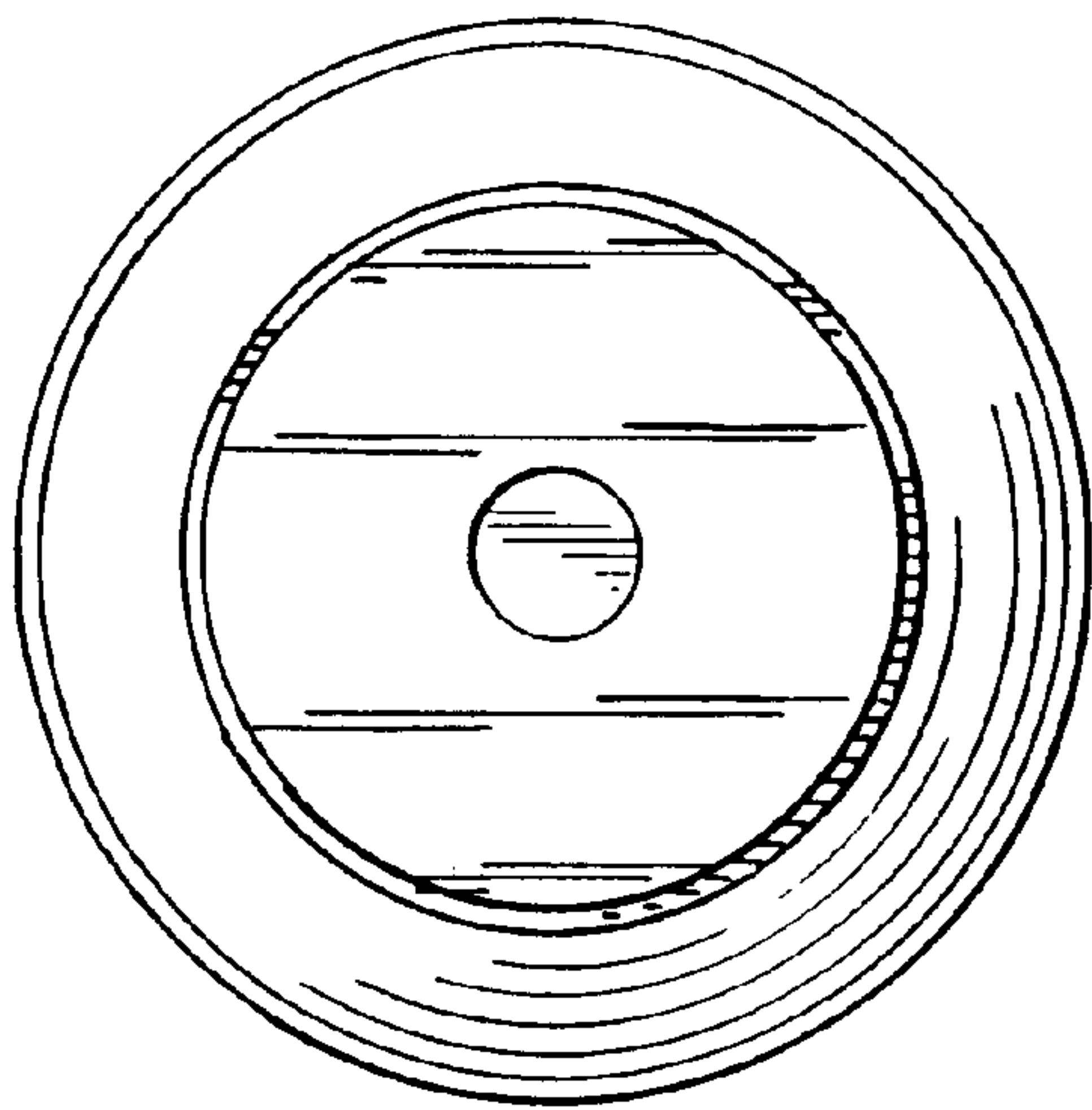
