DESCRIPTION

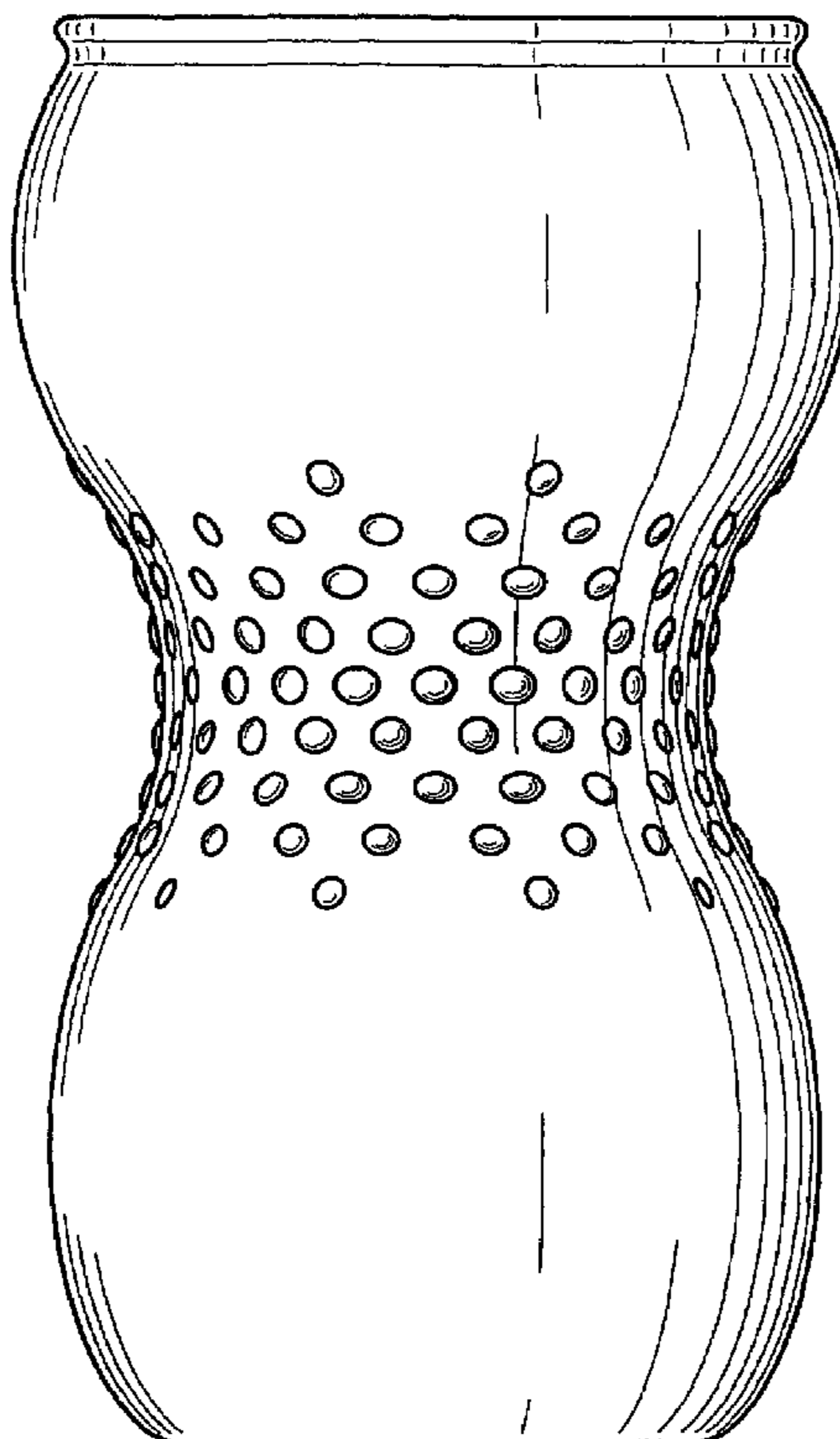
FIG. 1 is a top front perspective view of a drinking glass showing our new design;

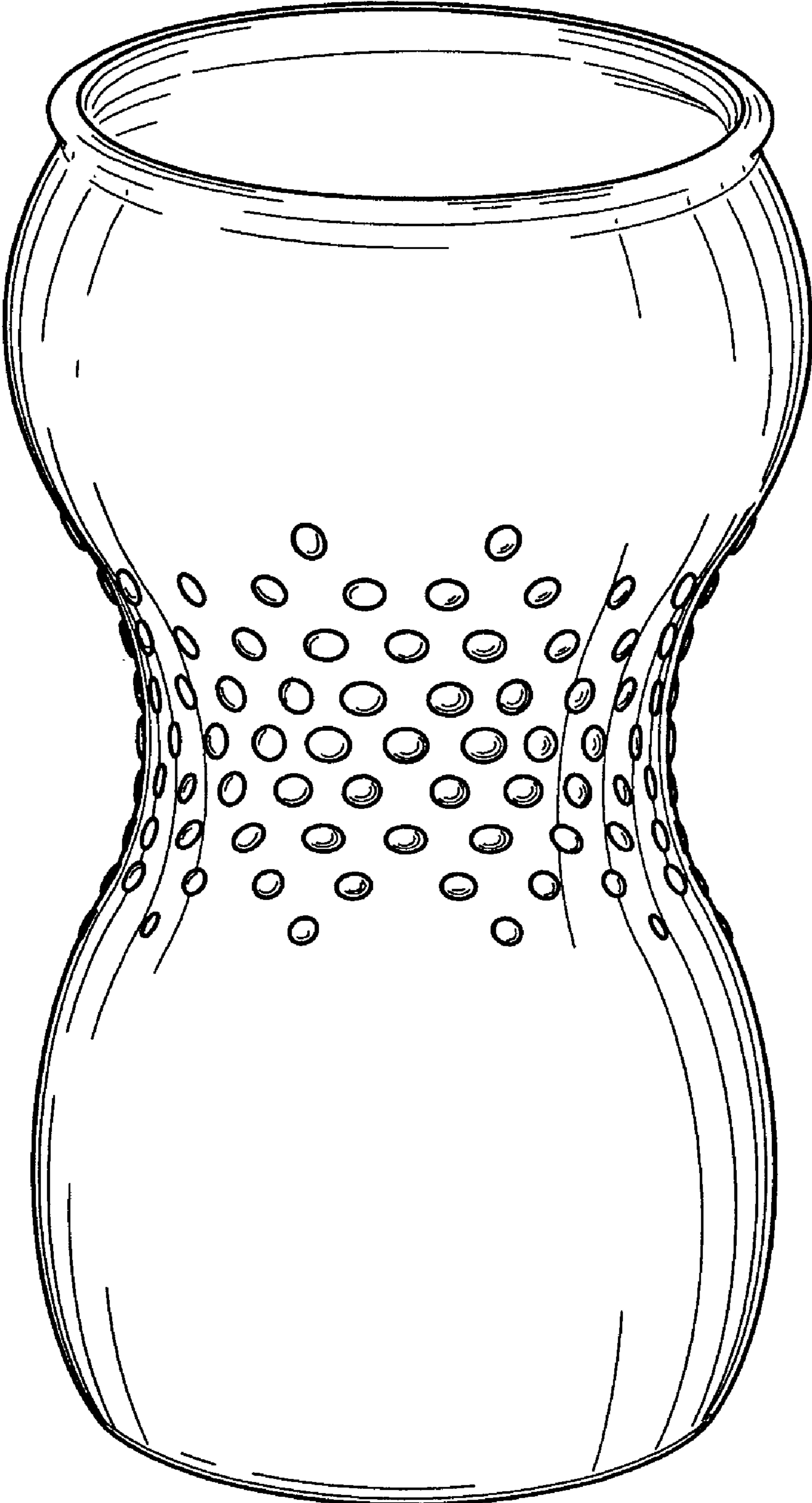

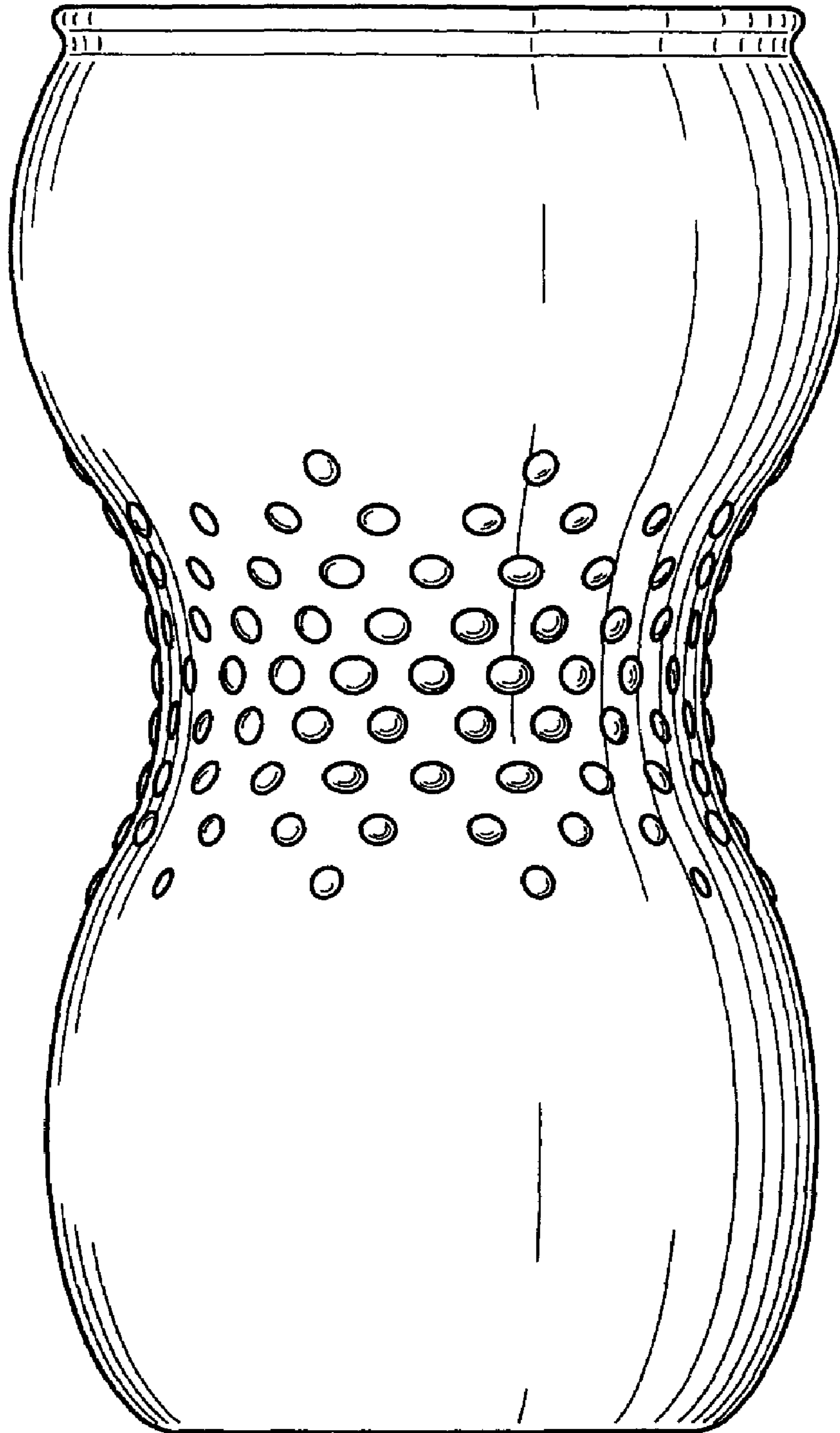

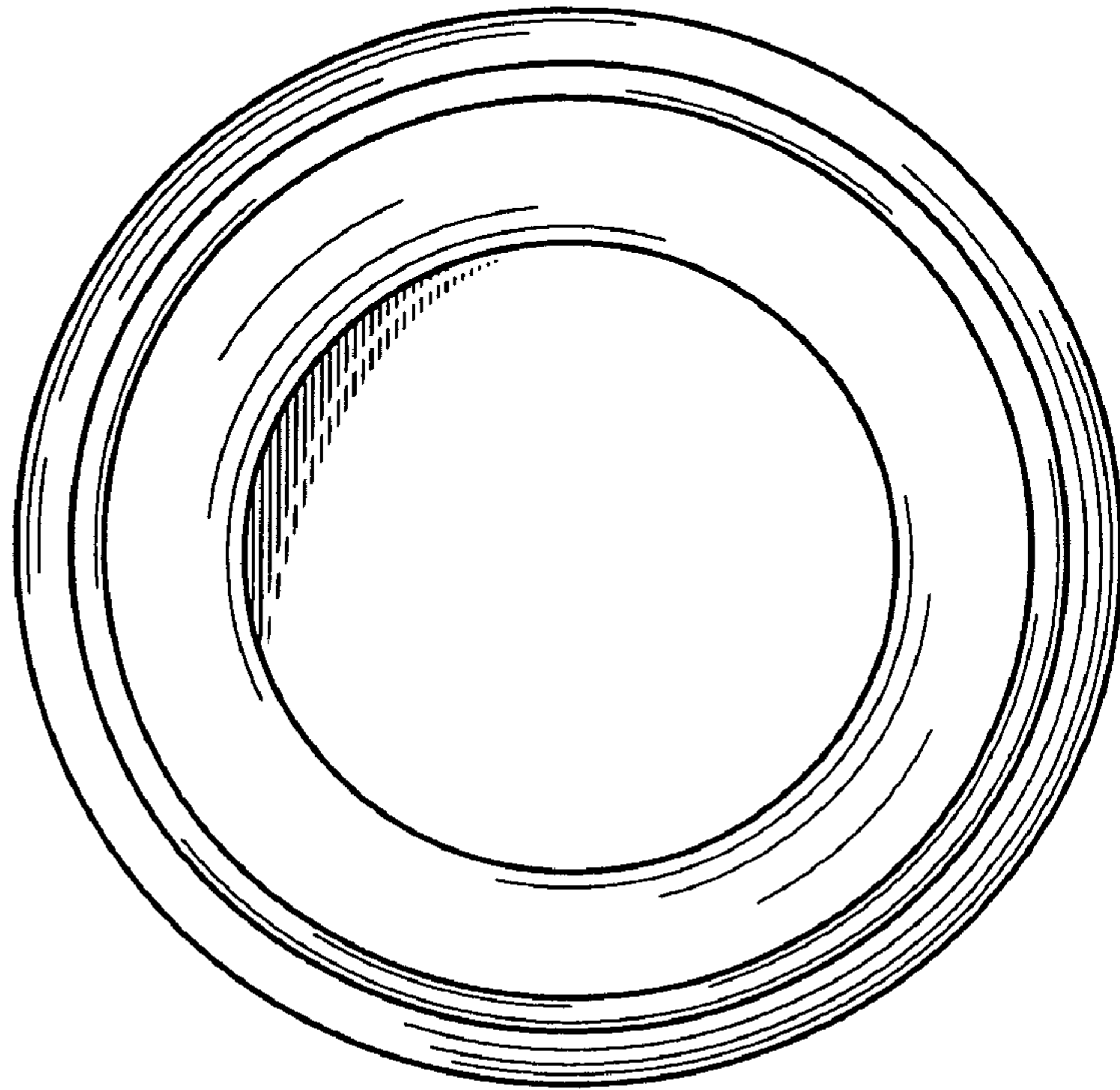
