DESCRIPTION

FIG. 8 is a bottom plan view thereof;

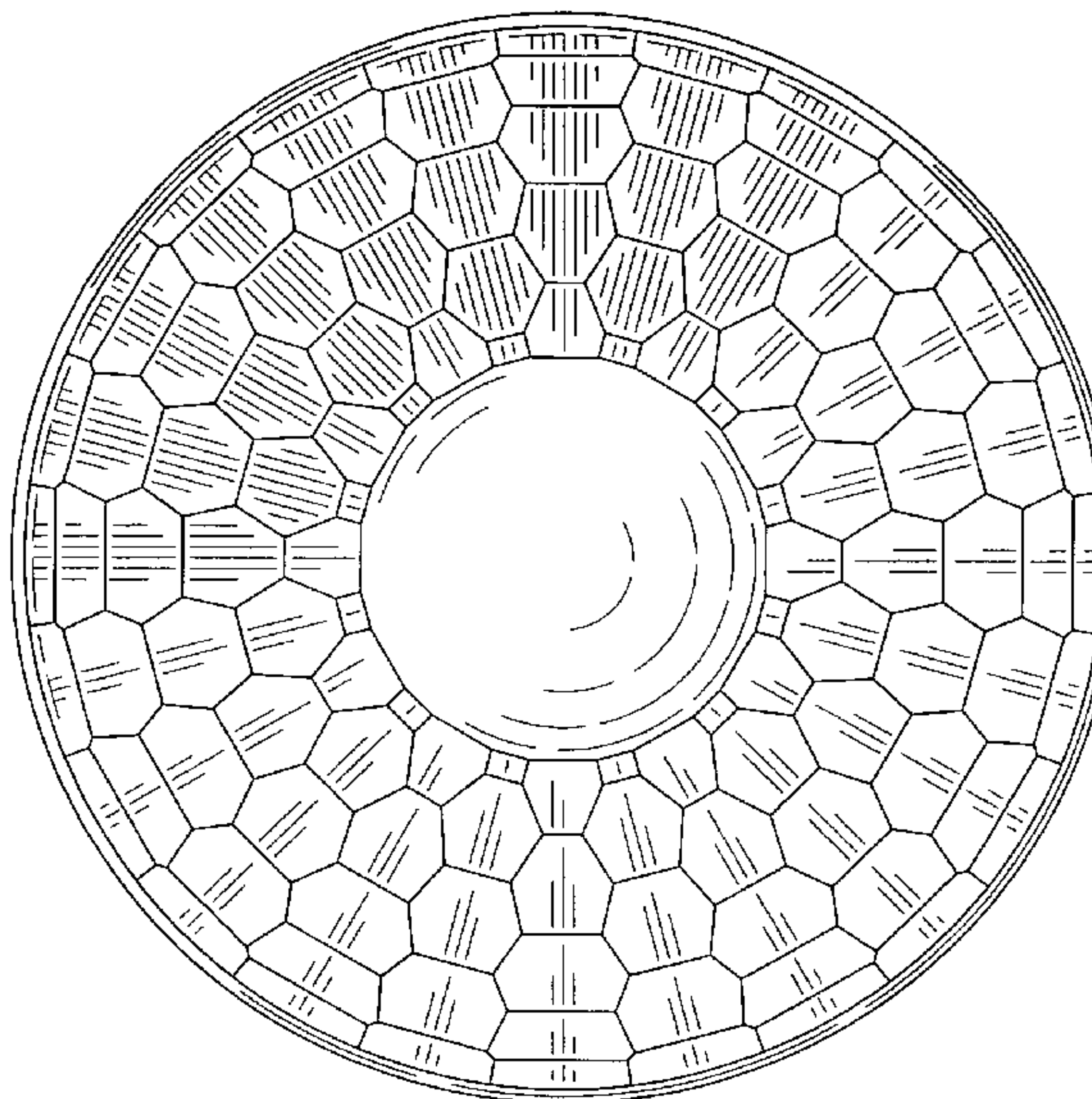
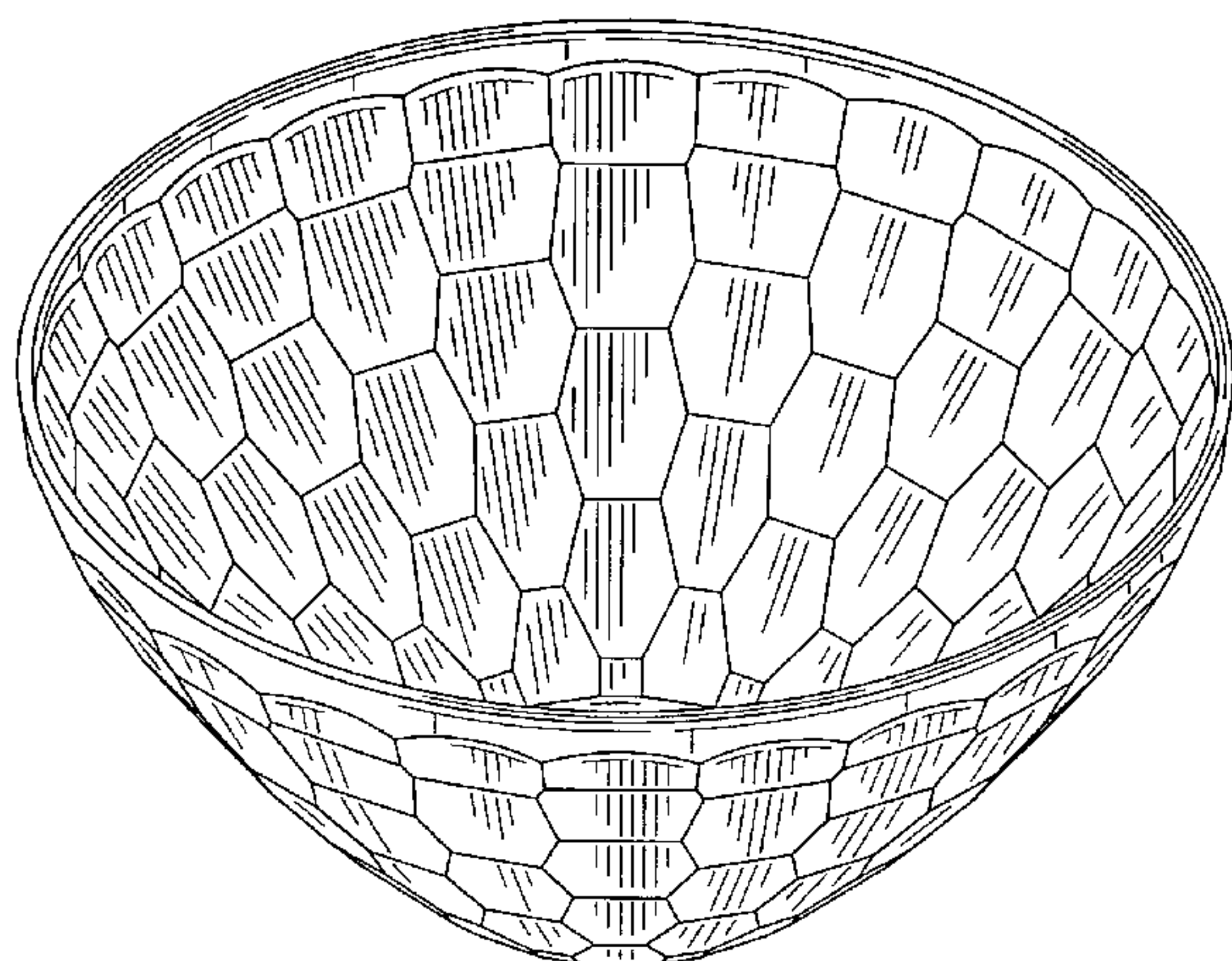
FIG. 9 is a top, front perspective view of a third embodiment of a bowl showing the new design;

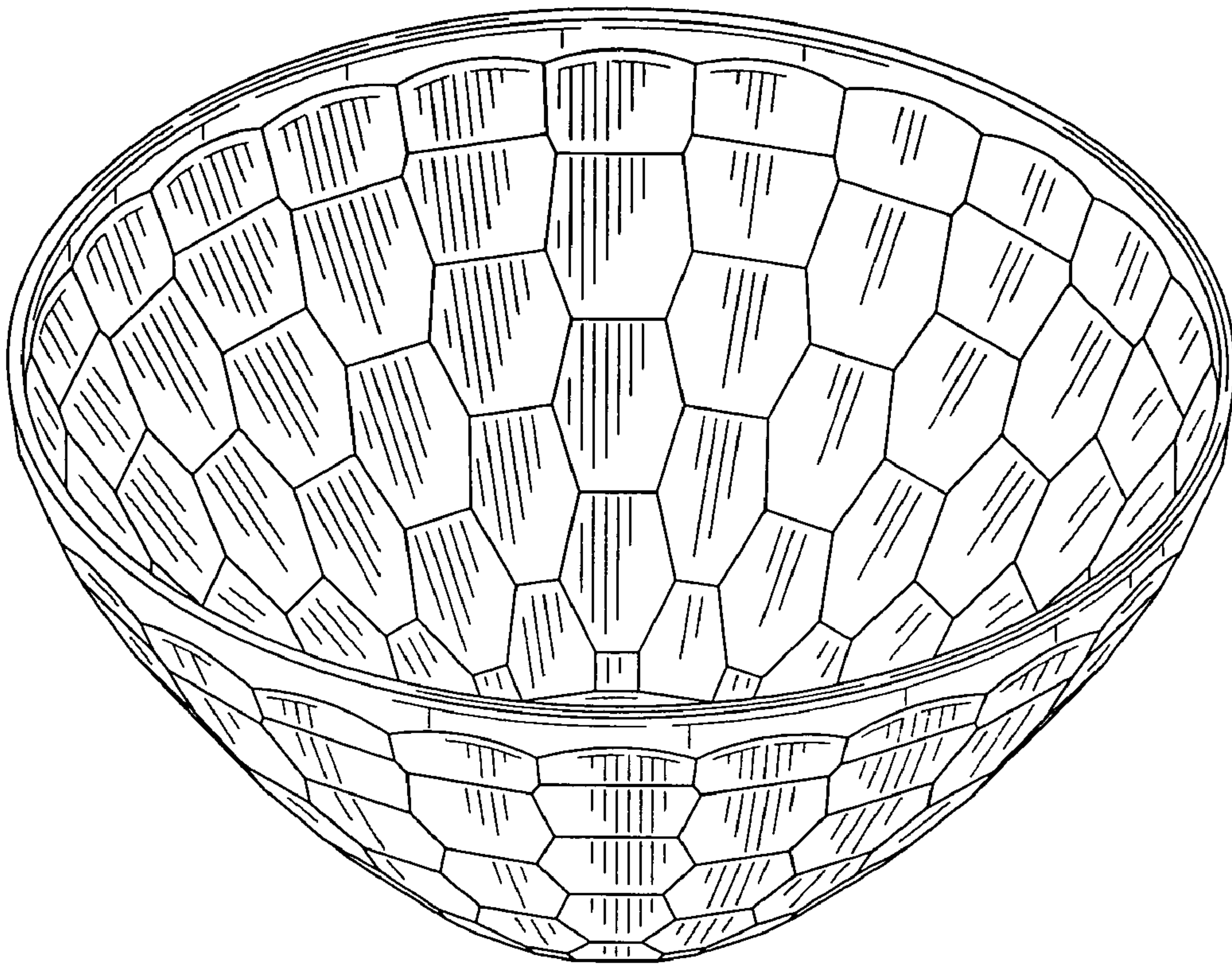

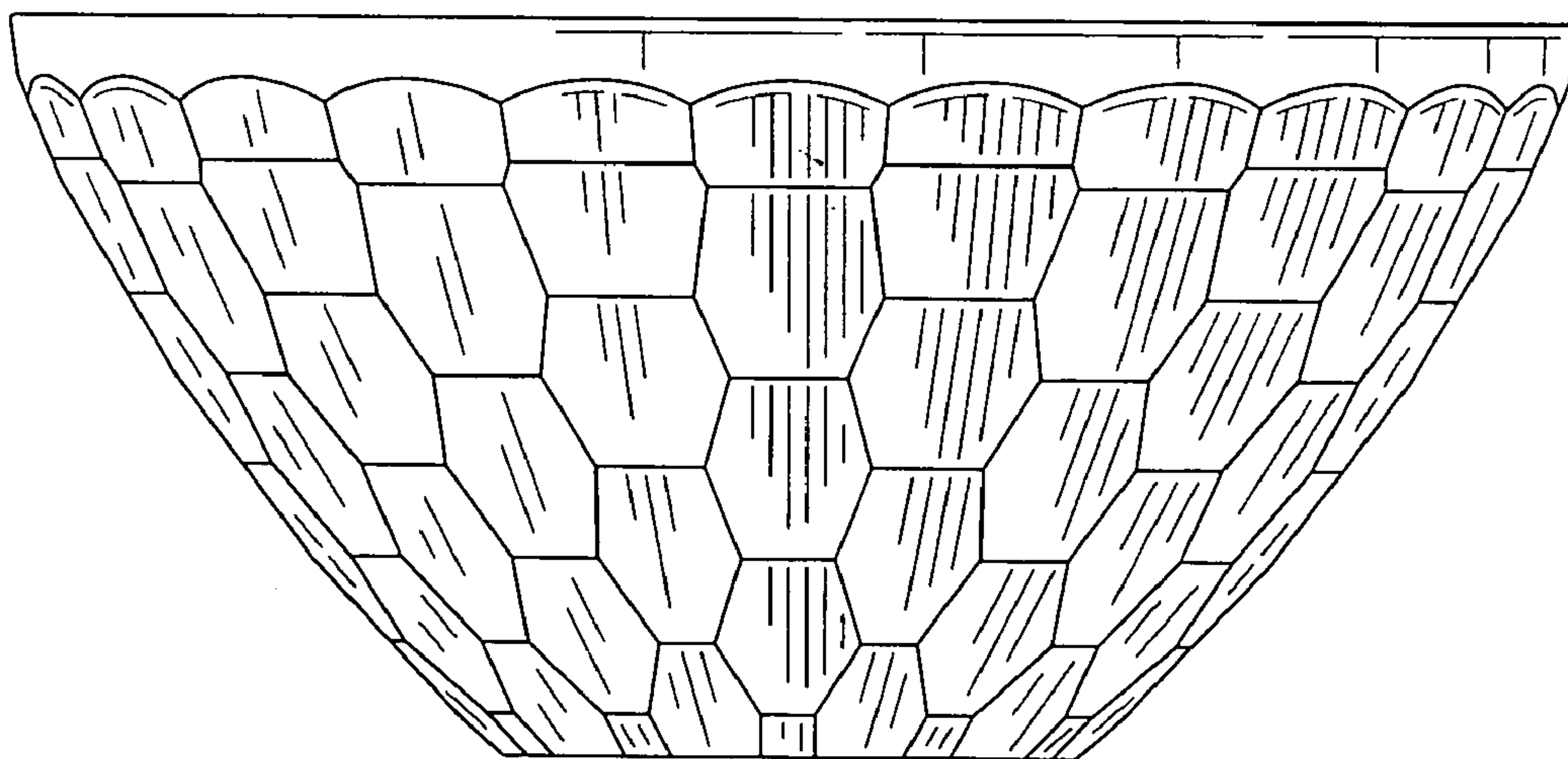

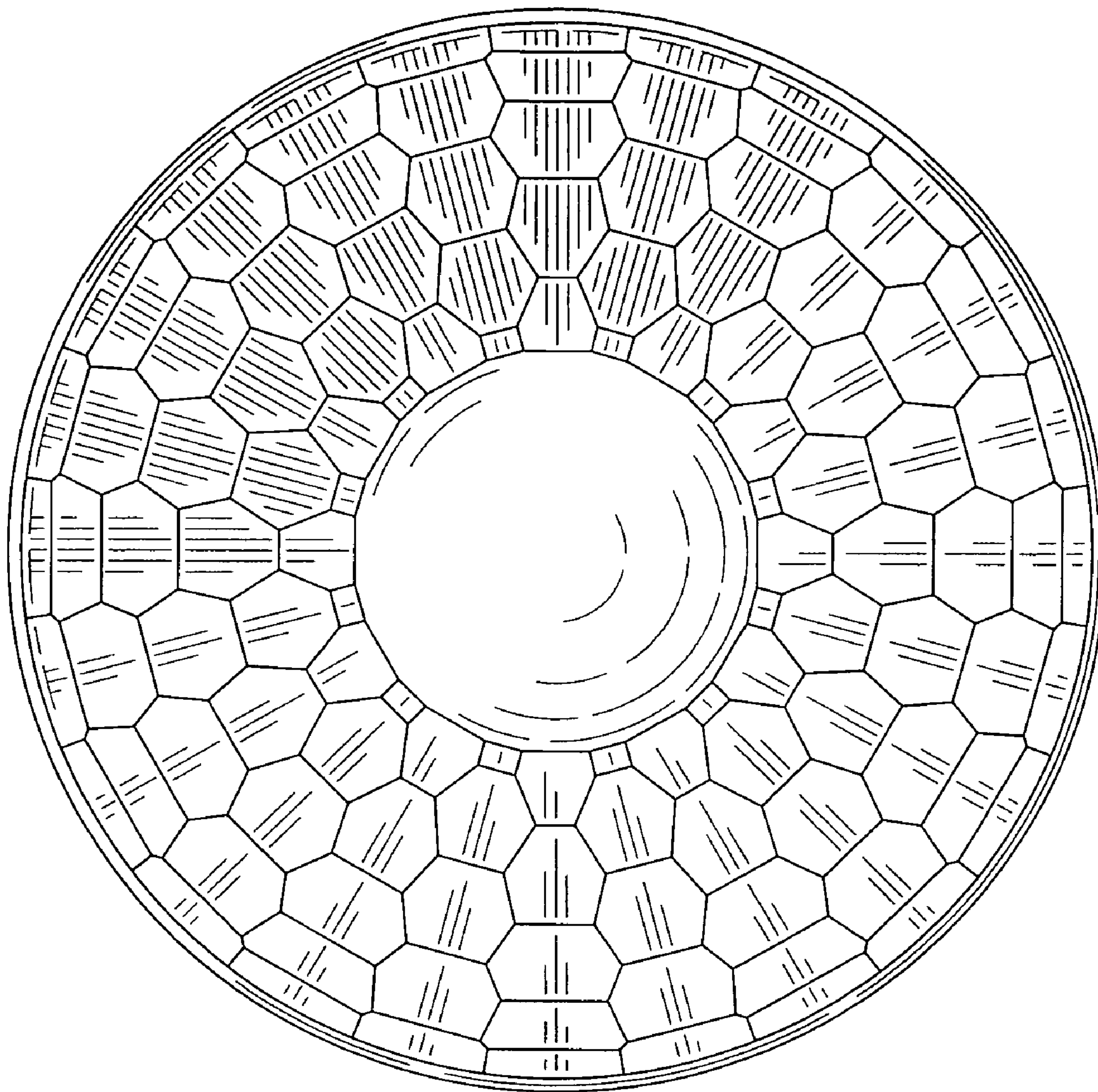

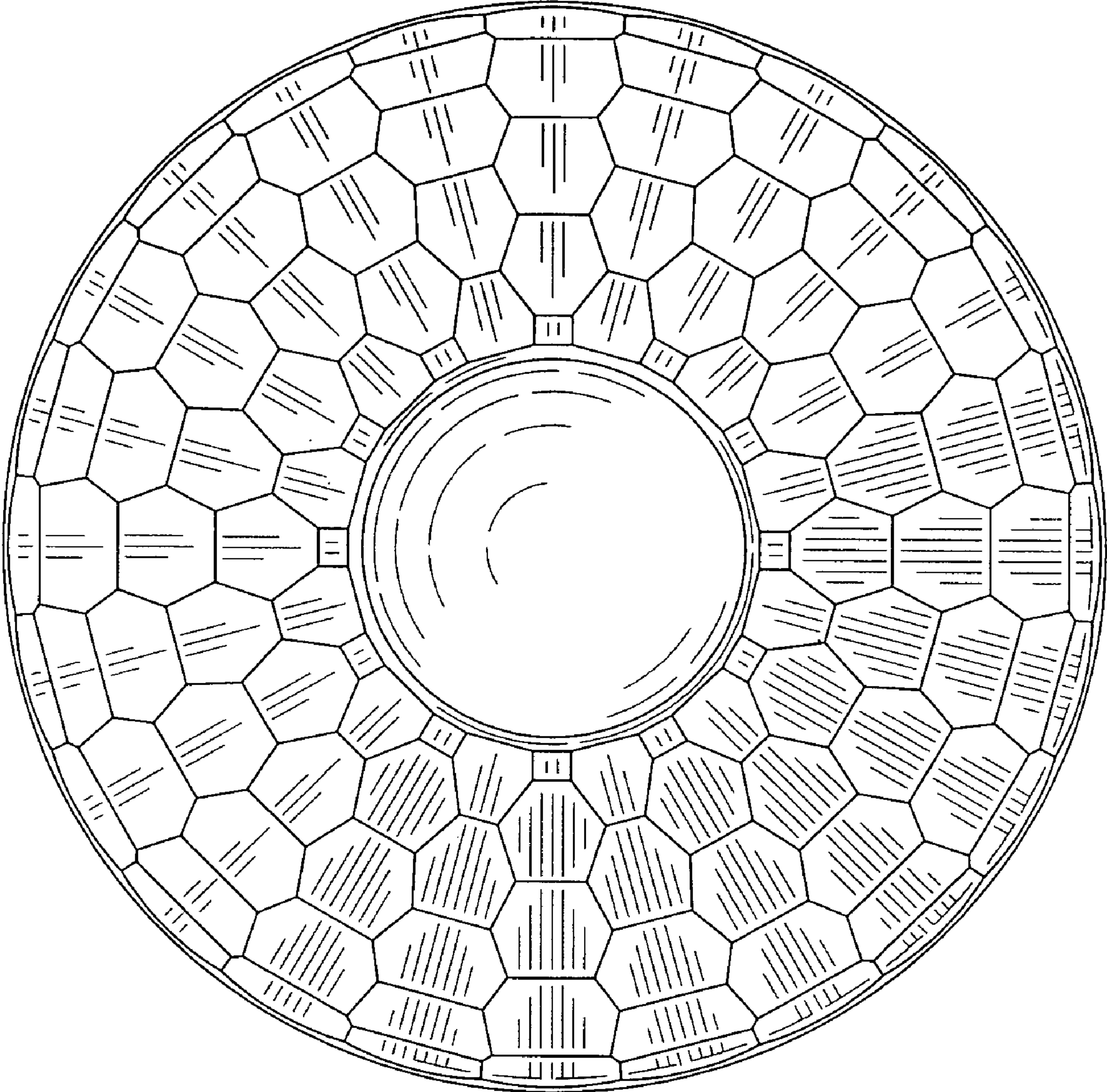

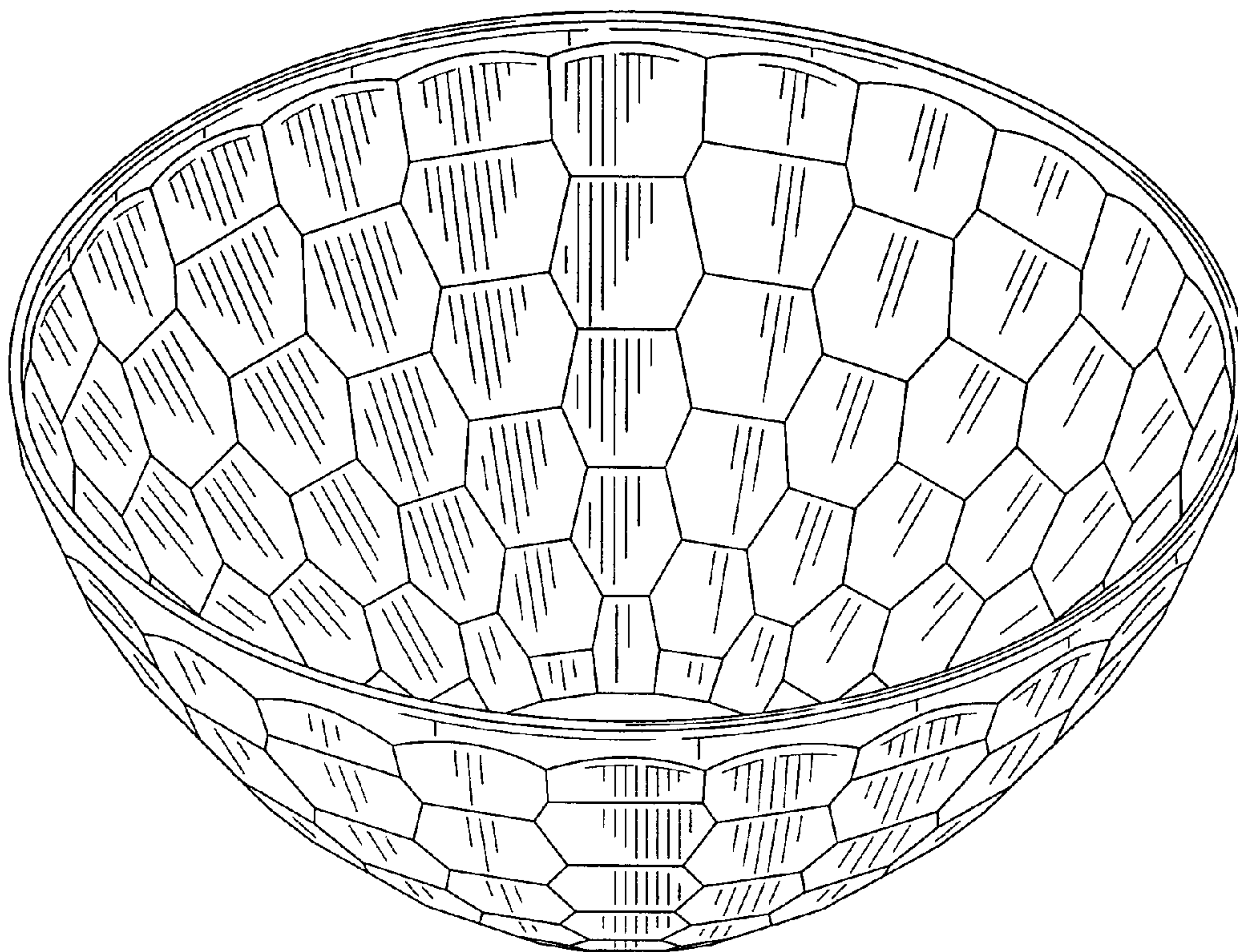

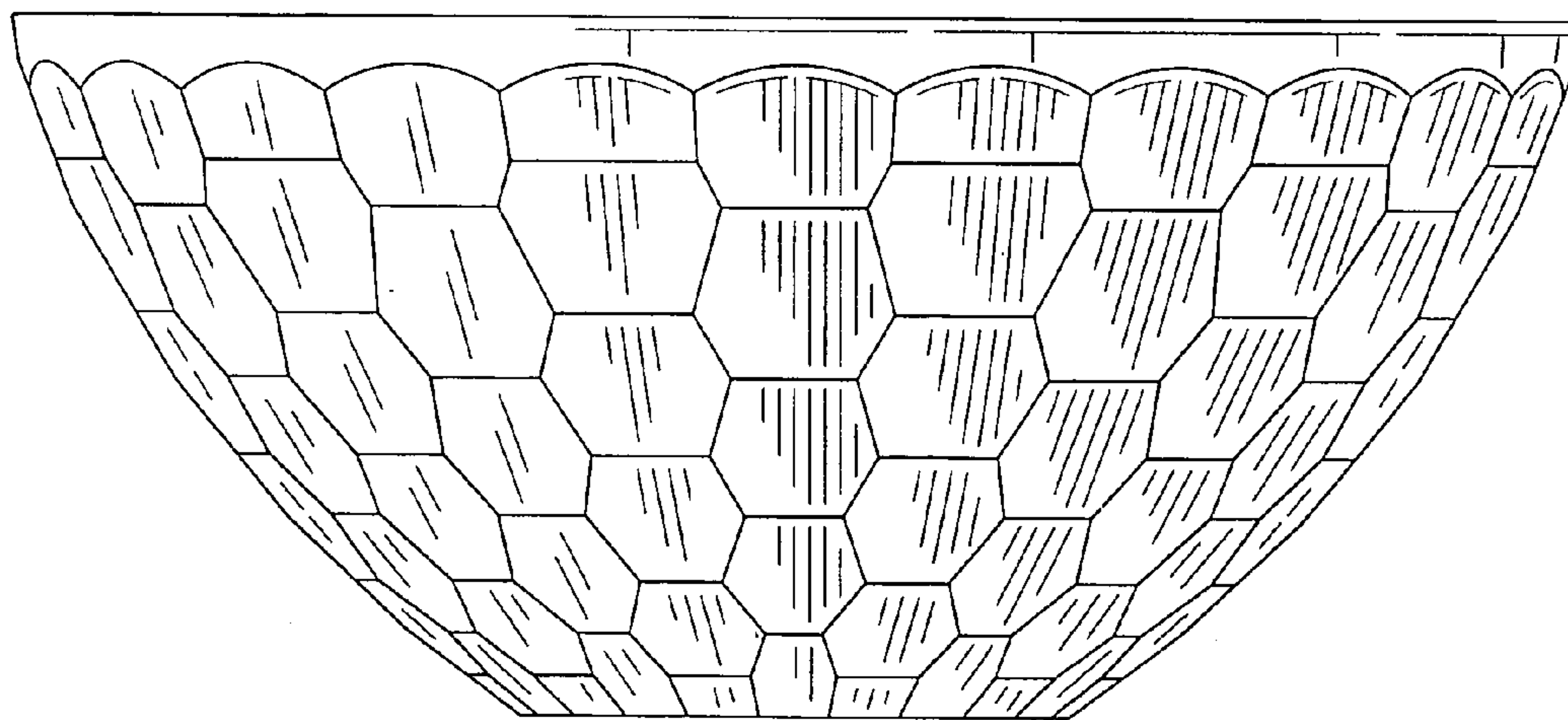

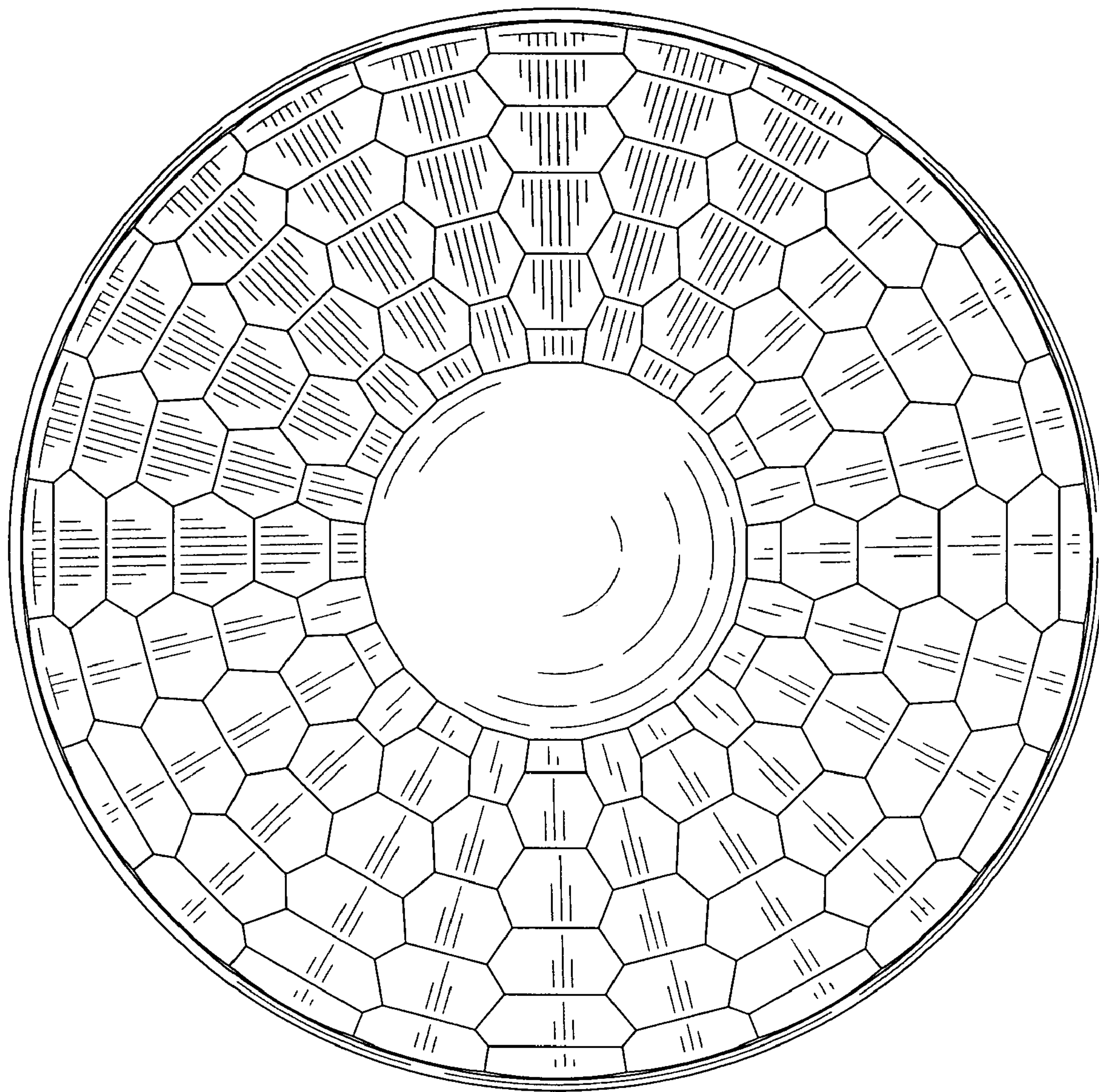

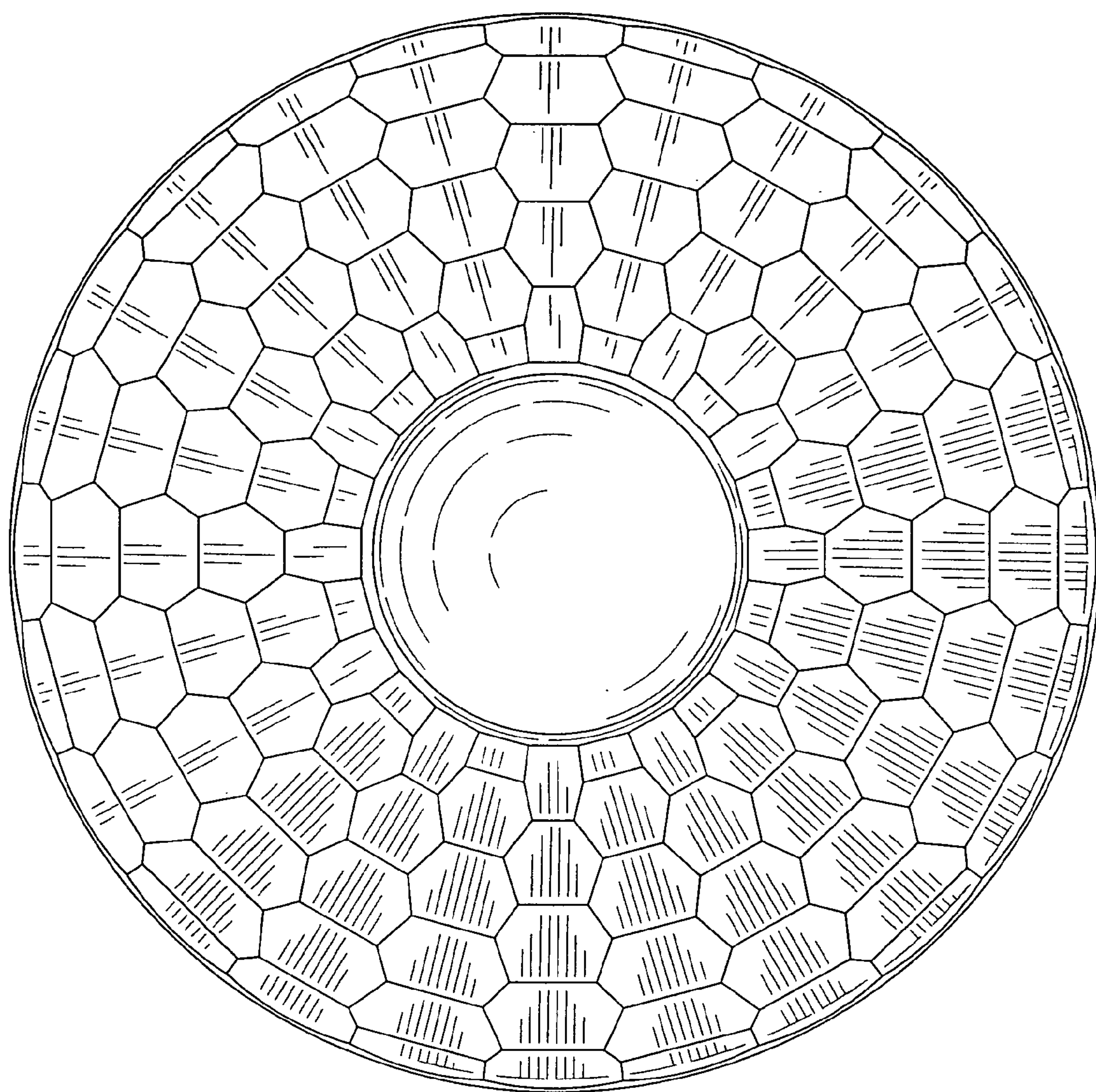

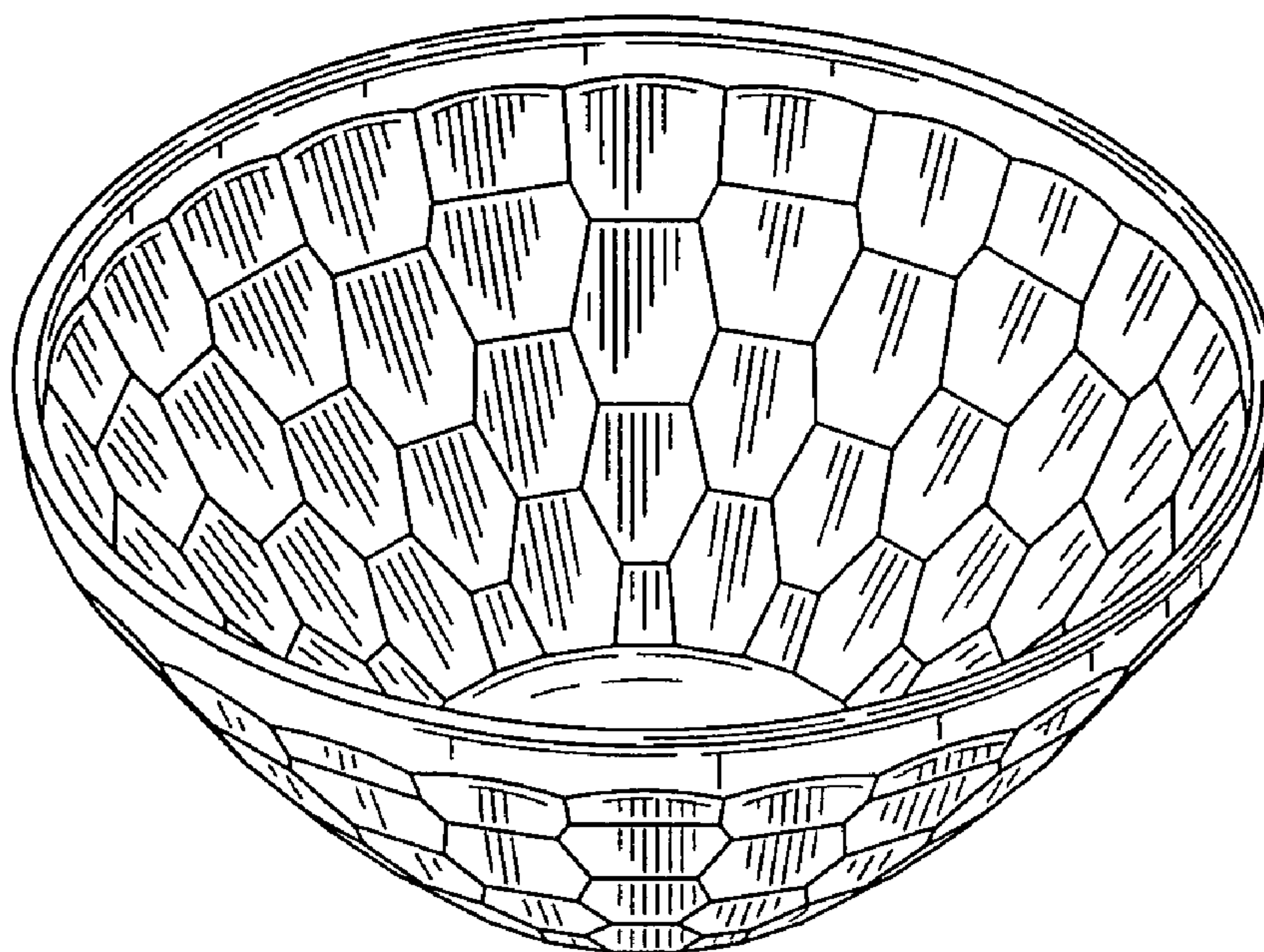

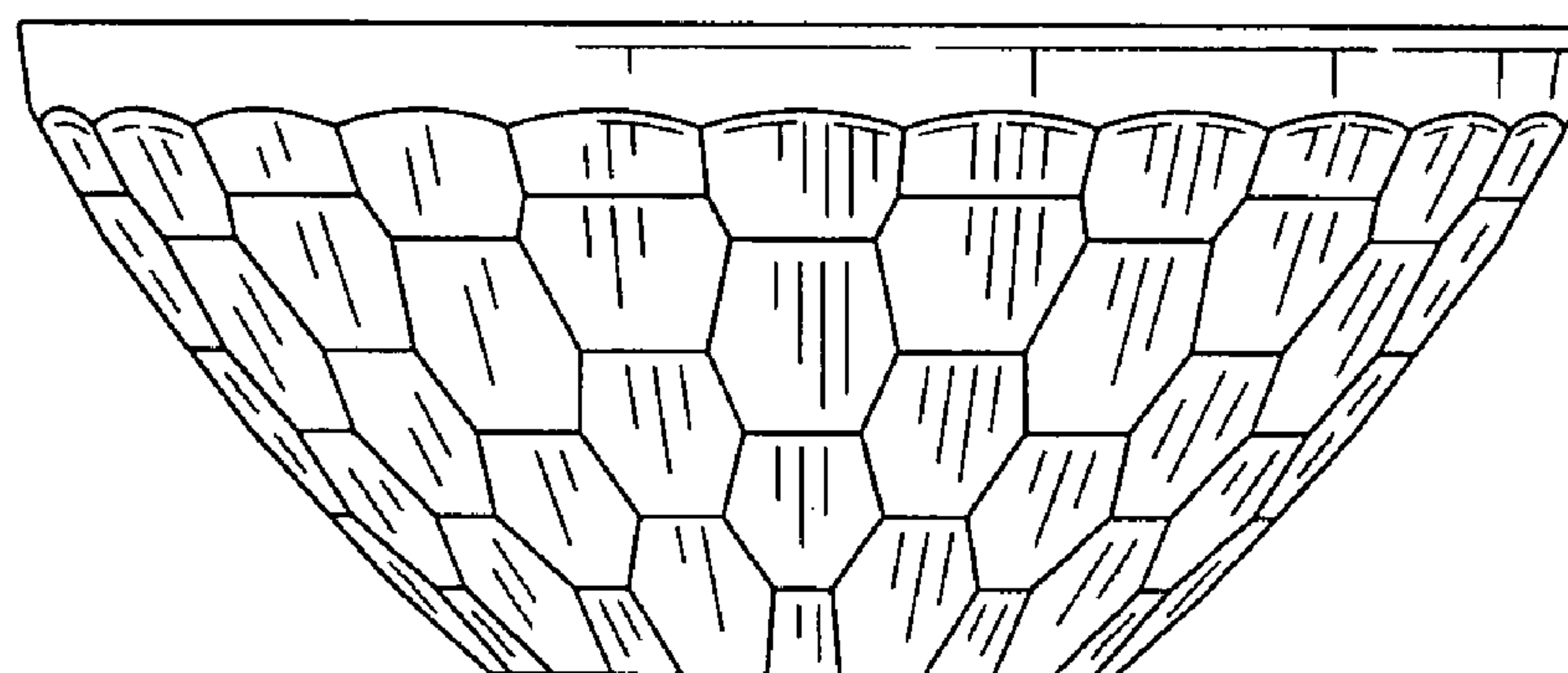

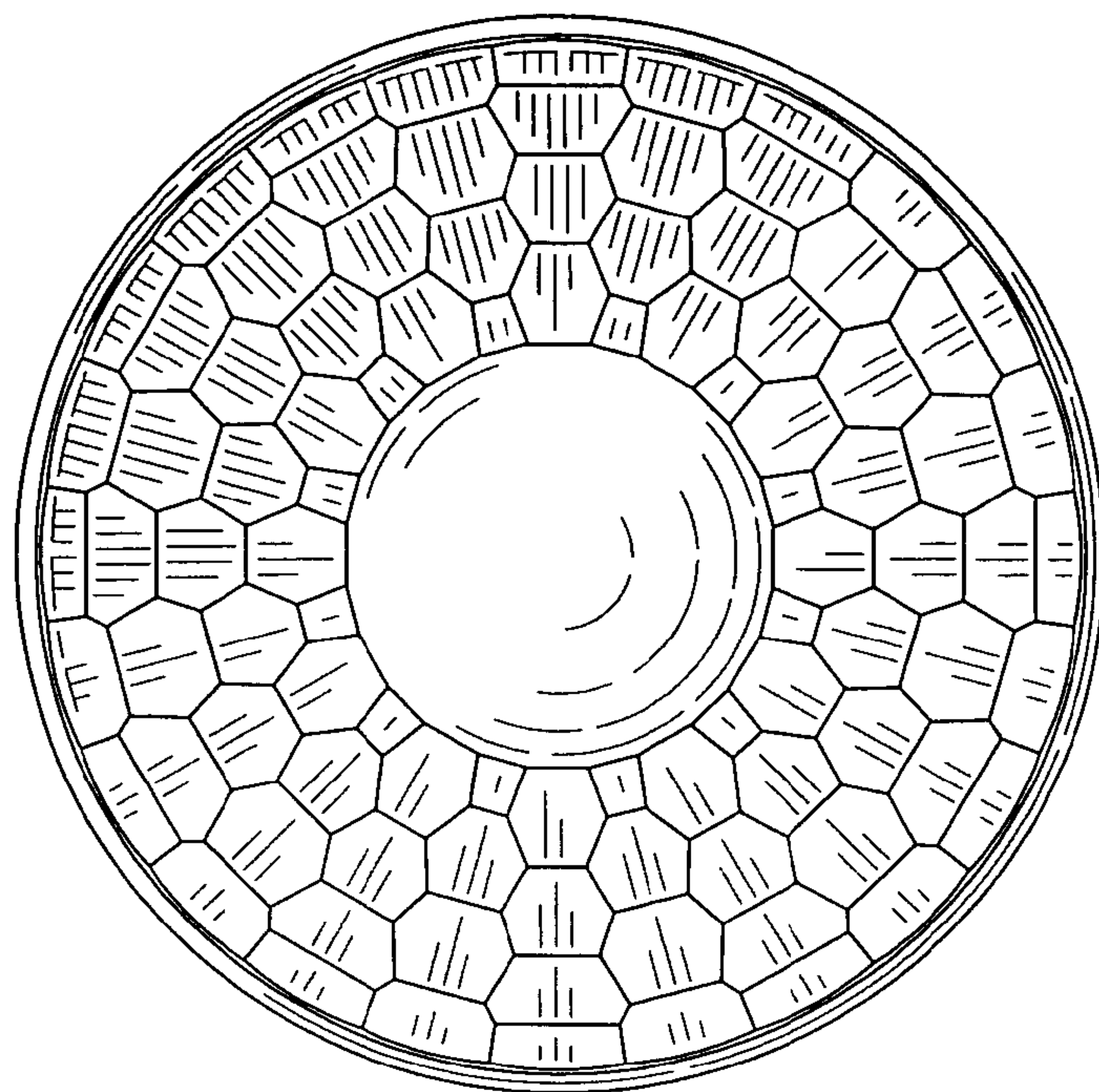

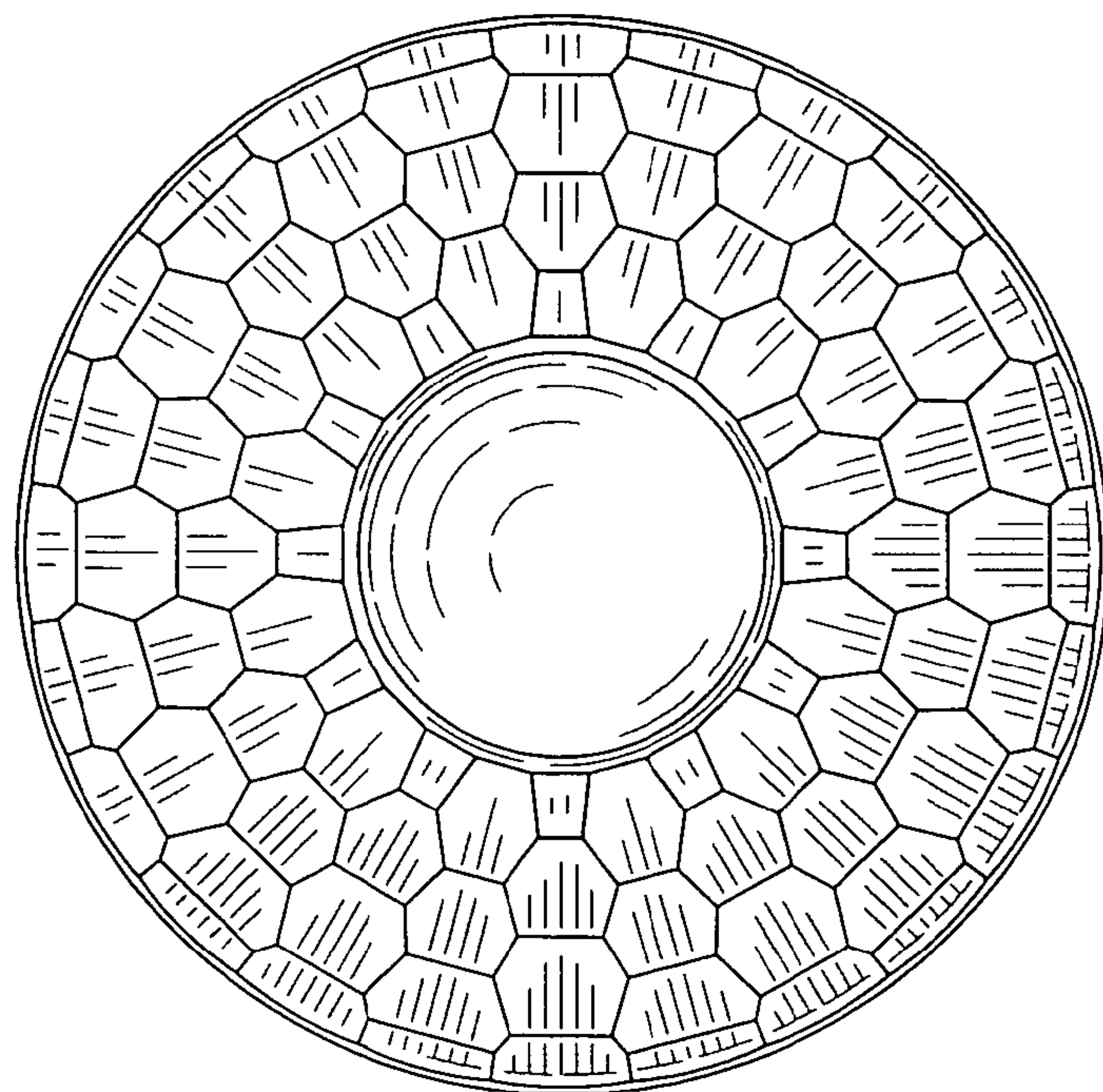
