DESCRIPTION

FIGS. 1 through 5 depict one embodiment of the chopstick of this invention where

FIG. 1 is a top plan view of a chopstick of this invention.

FIG. 2 is a side view of the chopstick of FIG. 1 with the opposite side being a mirror image.

FIG. 3 is a left end view of the chopstick of FIG. 1.

FIG. 4 is a right end view of the chopstick of FIG. 1.

FIG. 5 is a bottom plan view of the chopstick of FIG. 1.

FIGS. 6 through 10 depict another embodiment of the chopstick of this invention where

FIG. 6 is a top plan view of a chopstick of this invention.

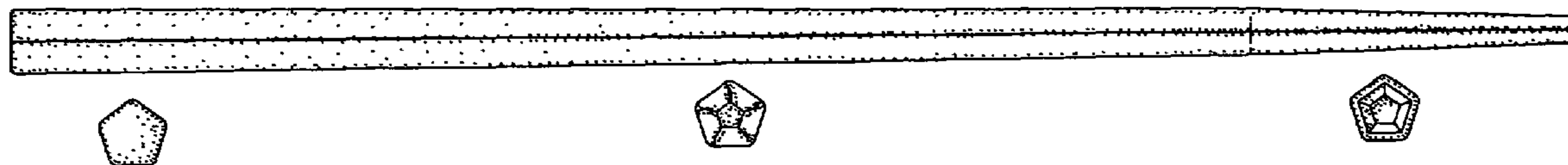
FIG. 7 is a side view of the chopstick of FIG. 6 with the opposite side being a mirror image.

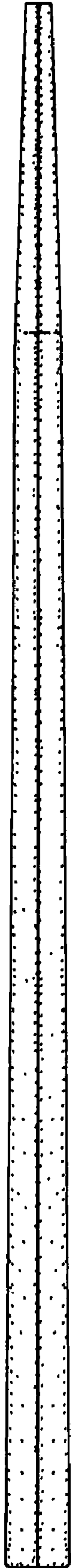

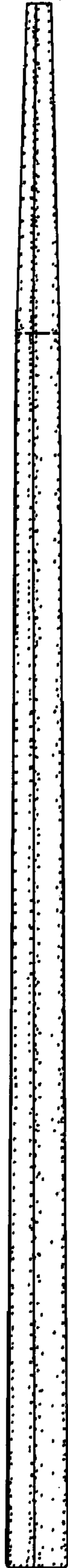

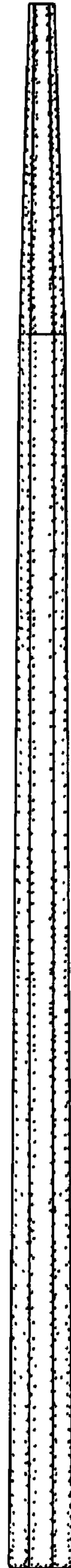

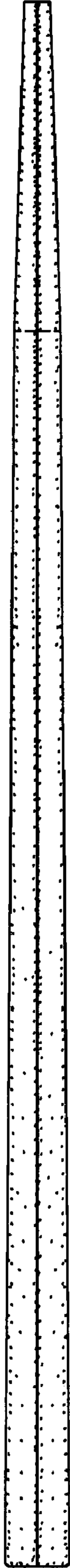

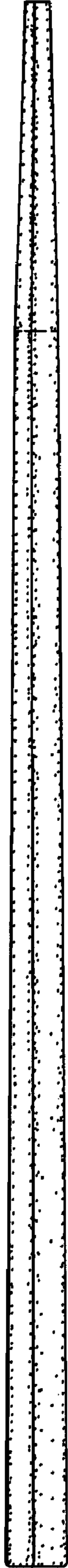
