FIG. 1 is a perspective view of an adjustable wrench;

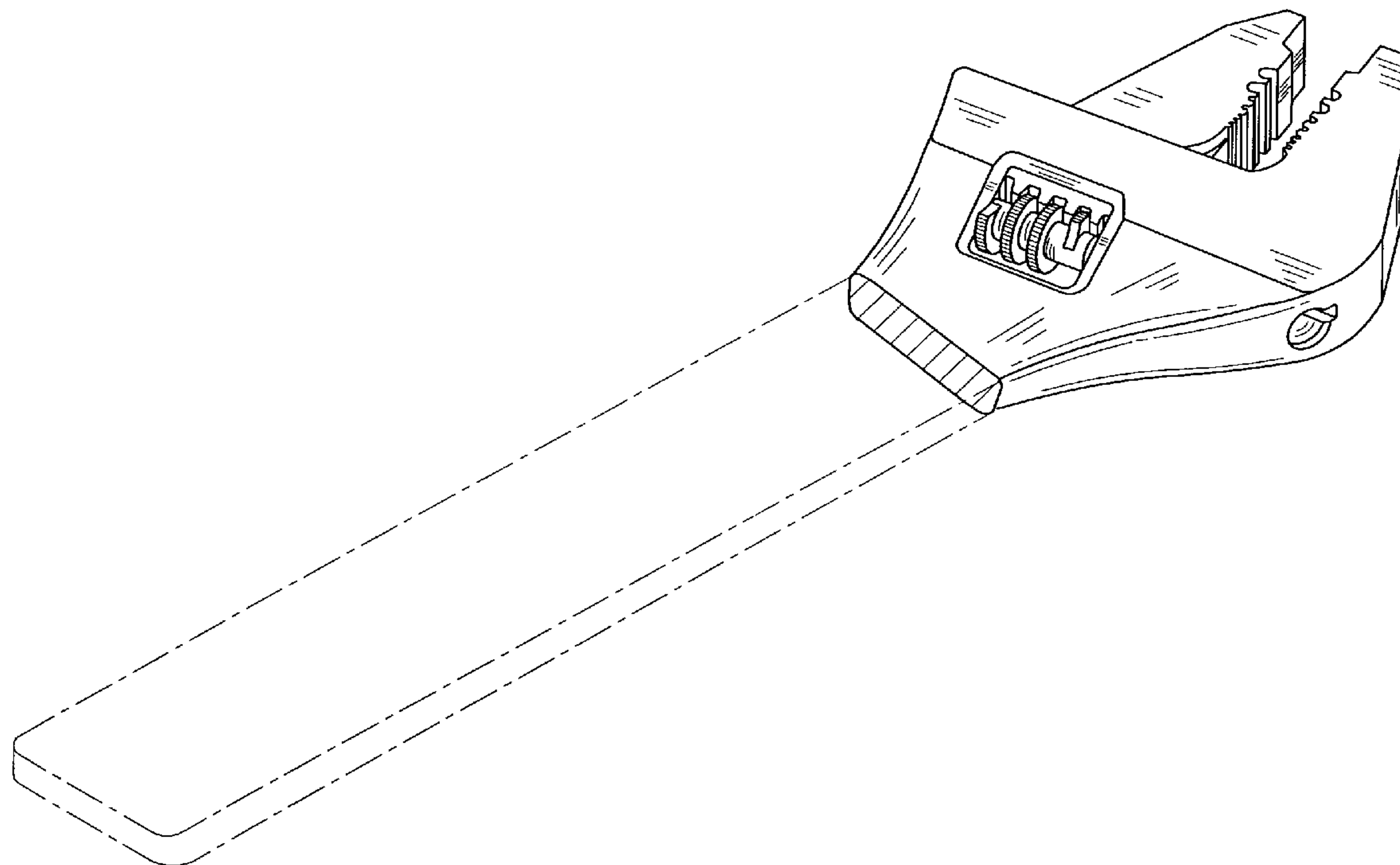
FIG. 2 is a front view thereof;

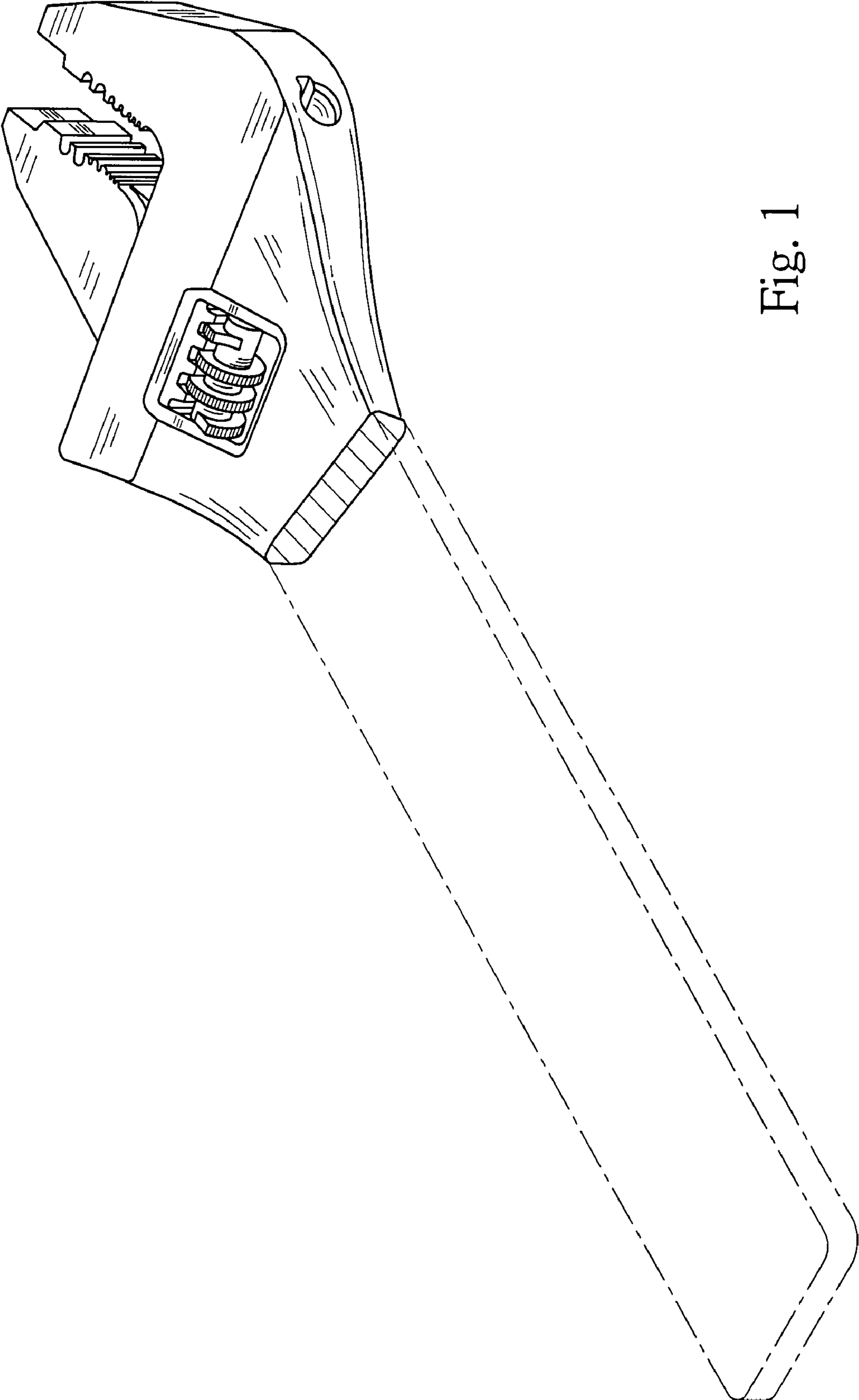

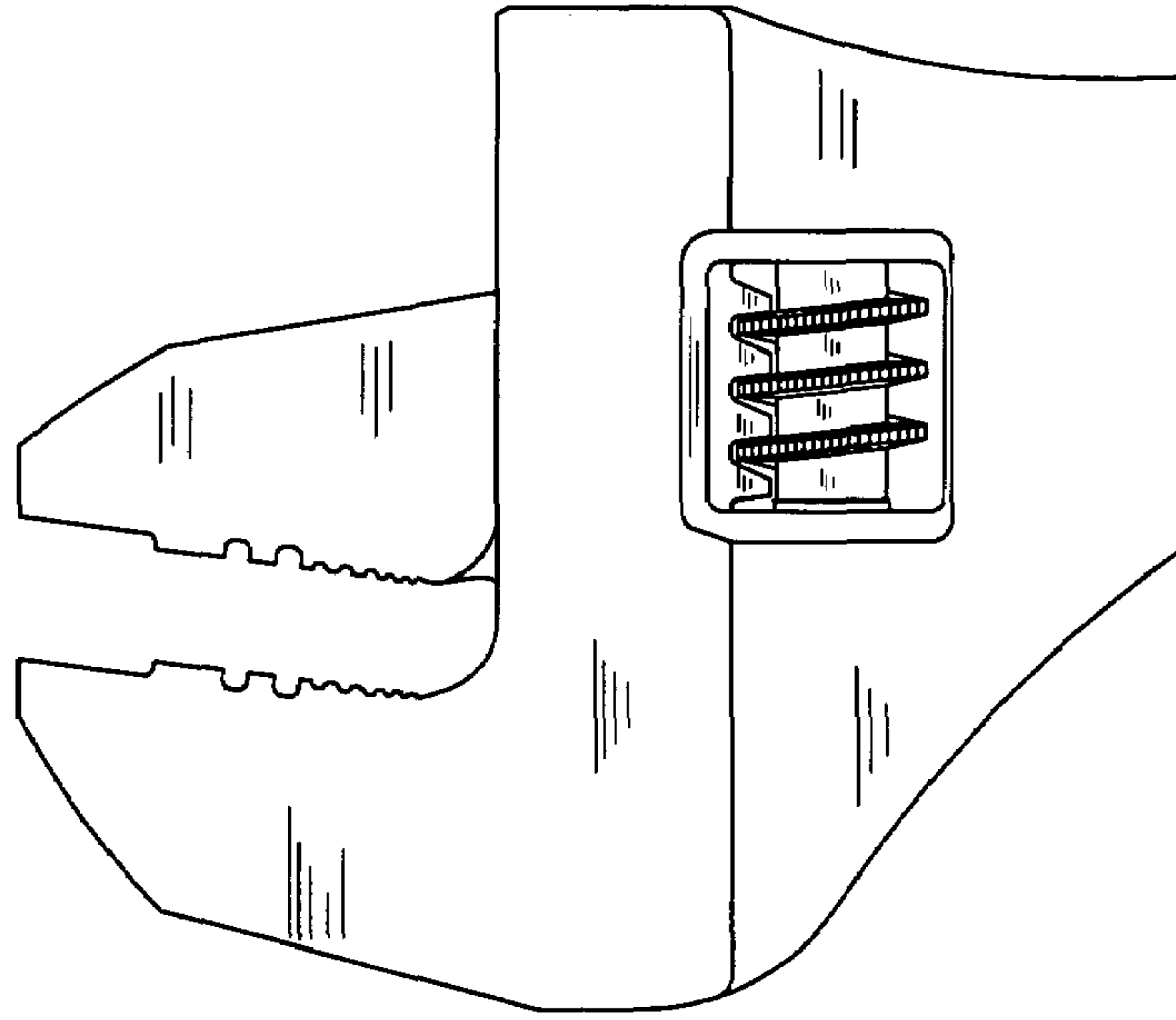

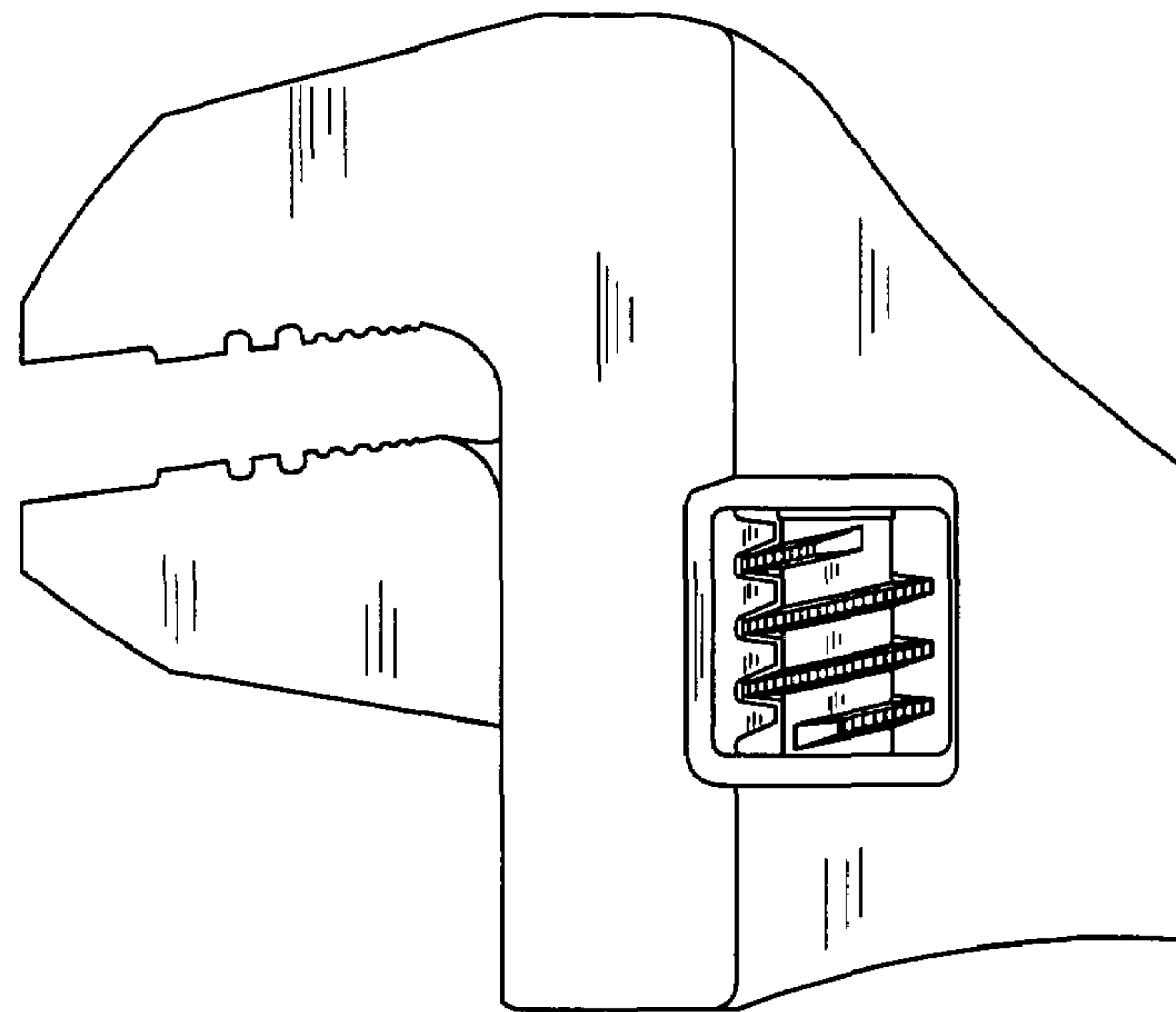

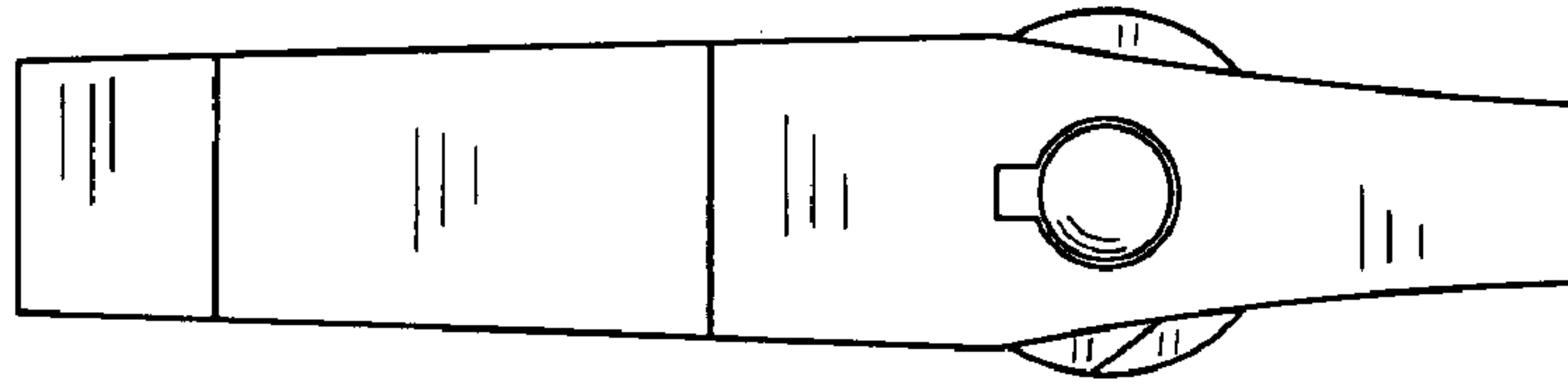

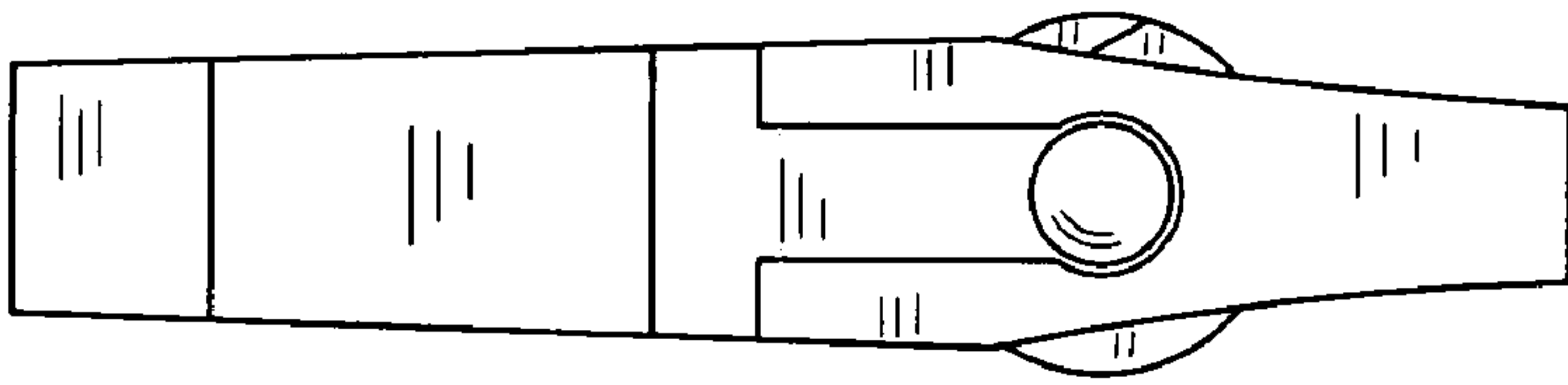
