FIG. 1; and

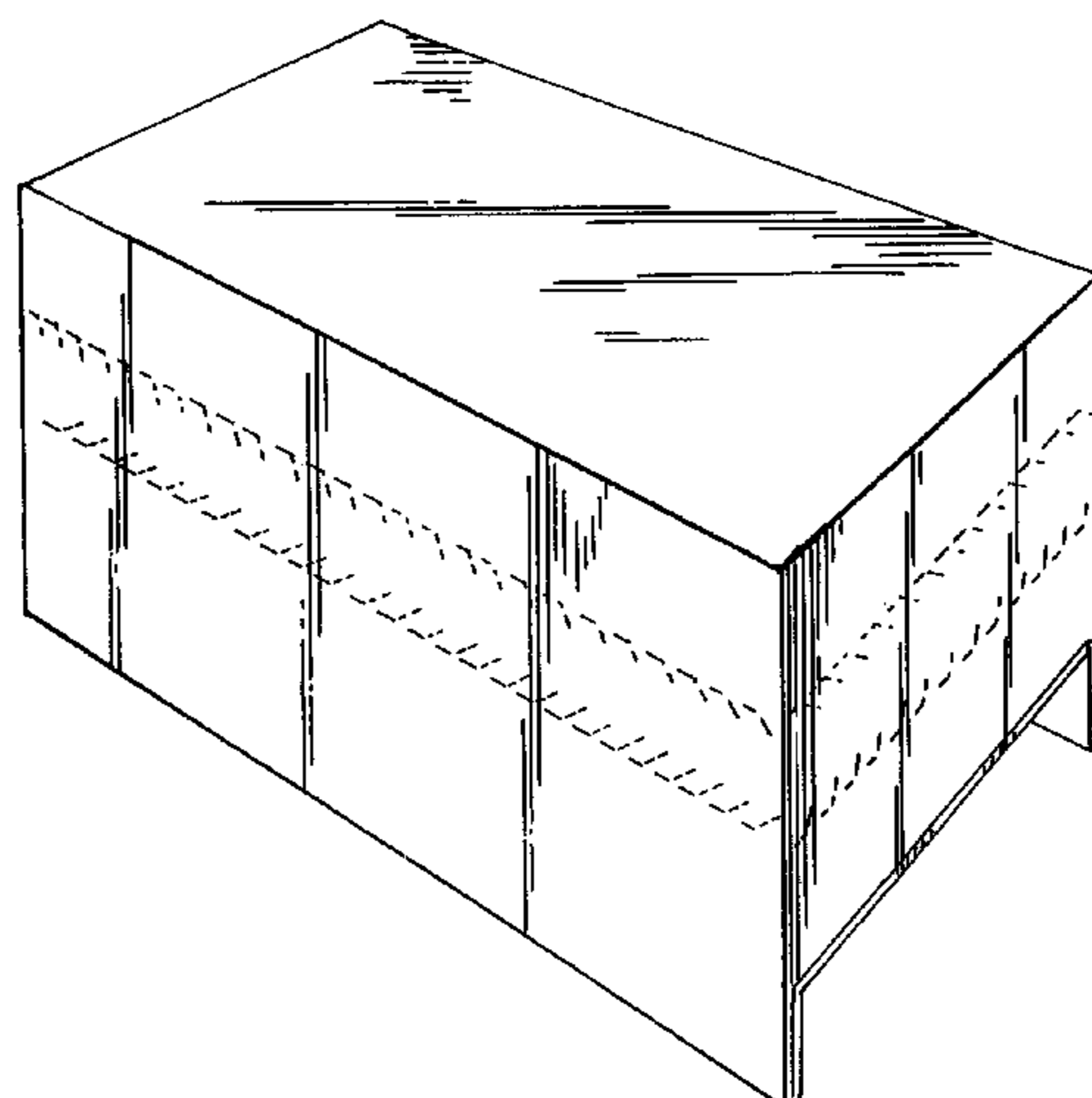
FIG. 5 is a right side elevation of the joined tray and lid of

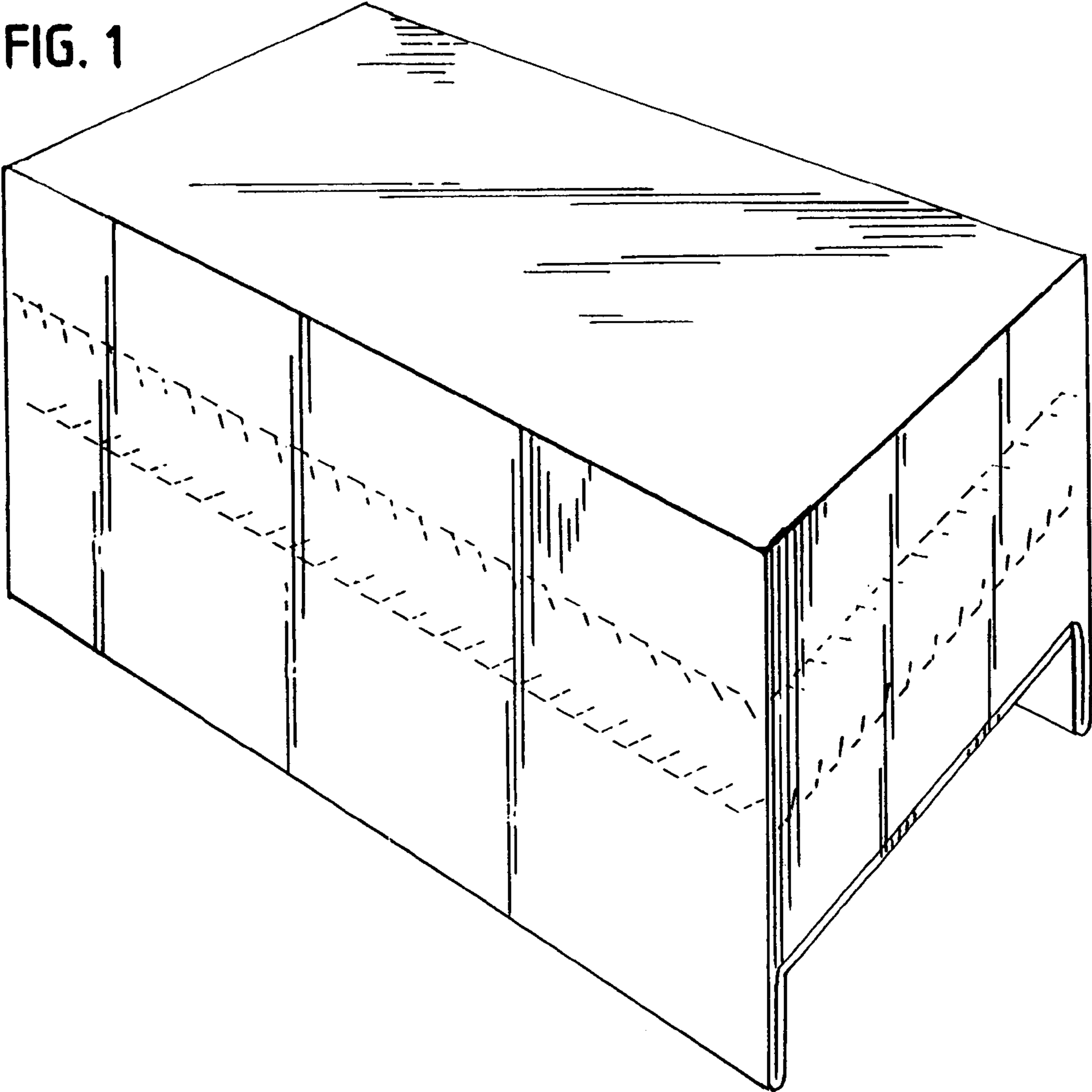

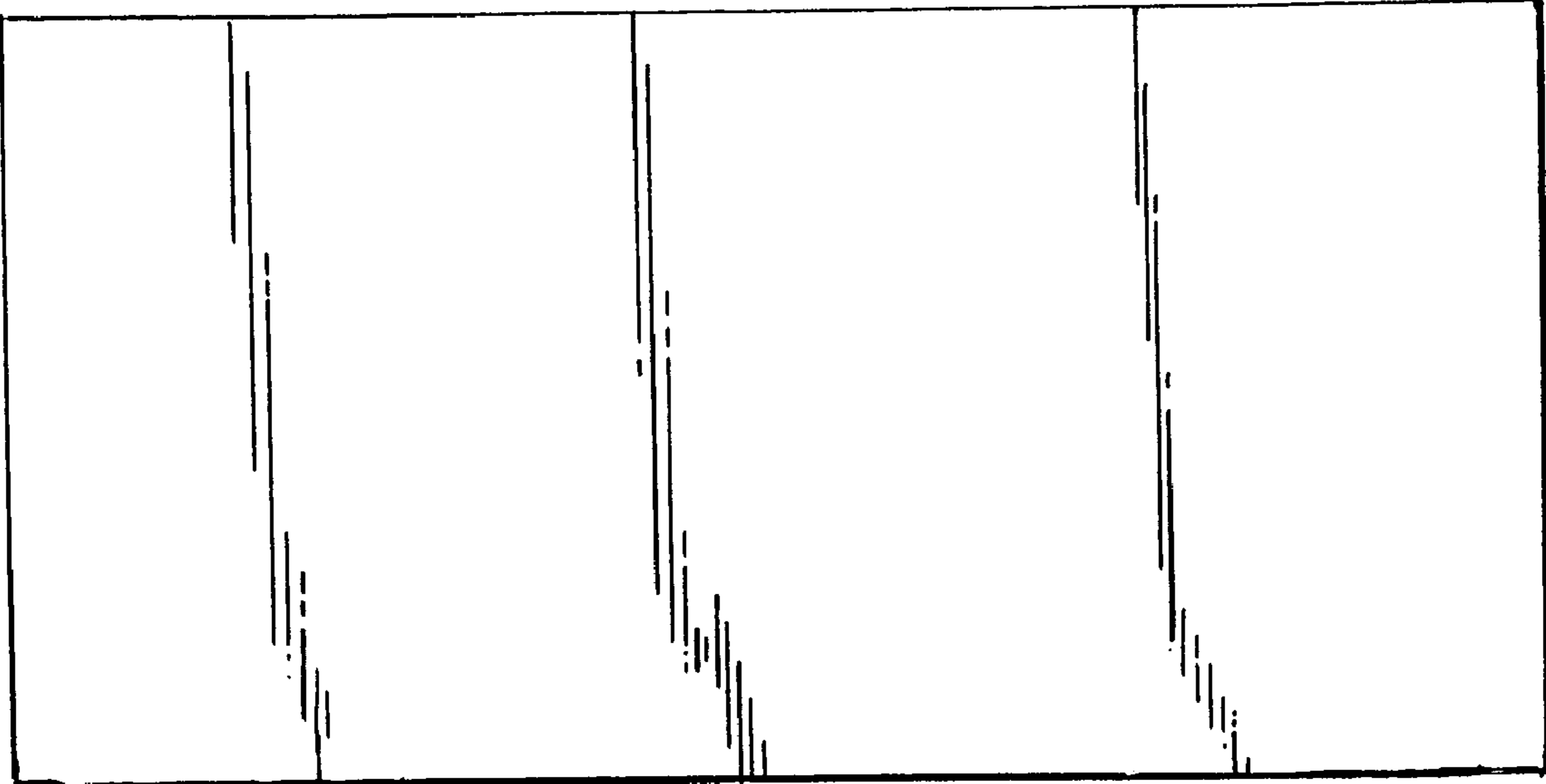

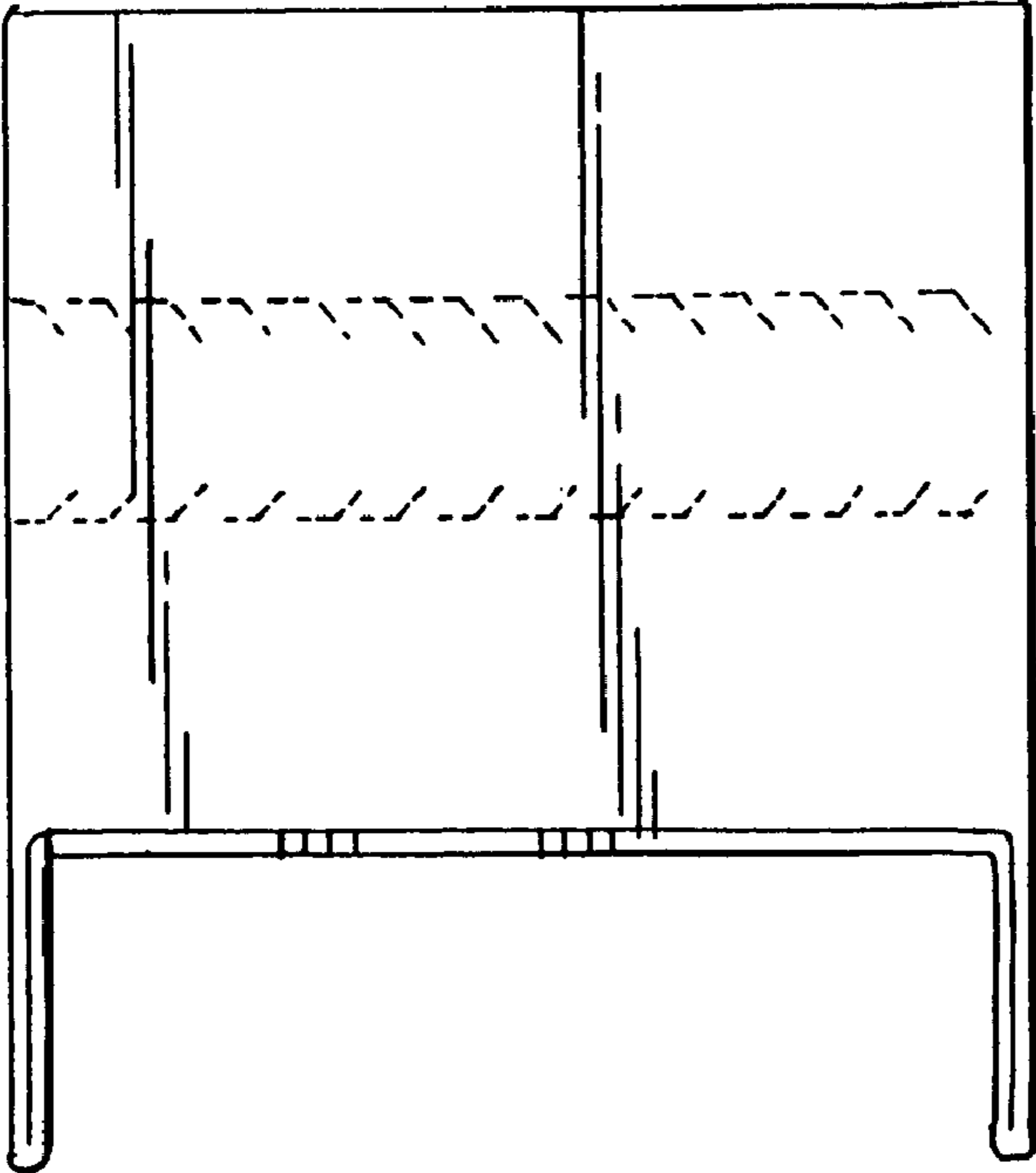

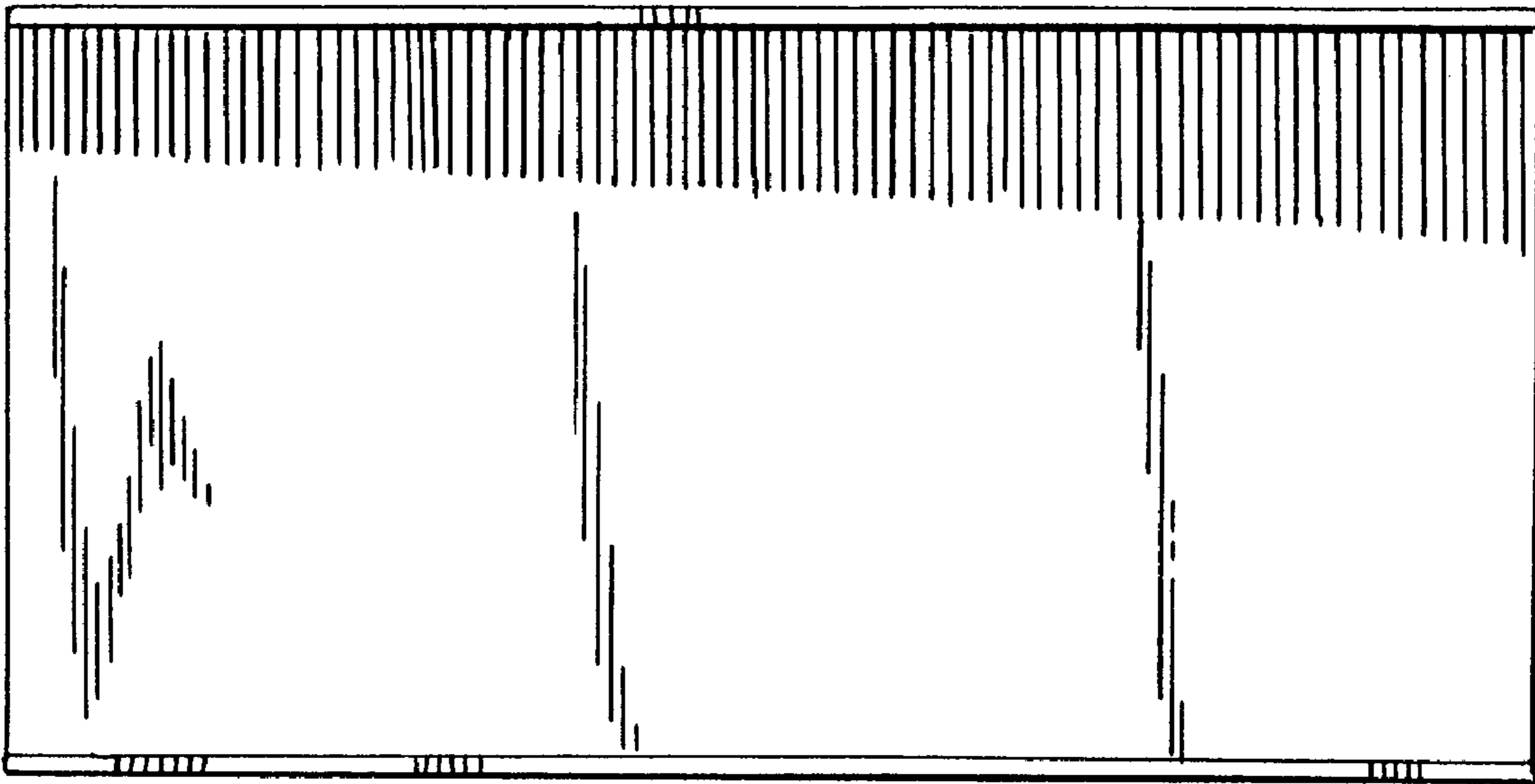

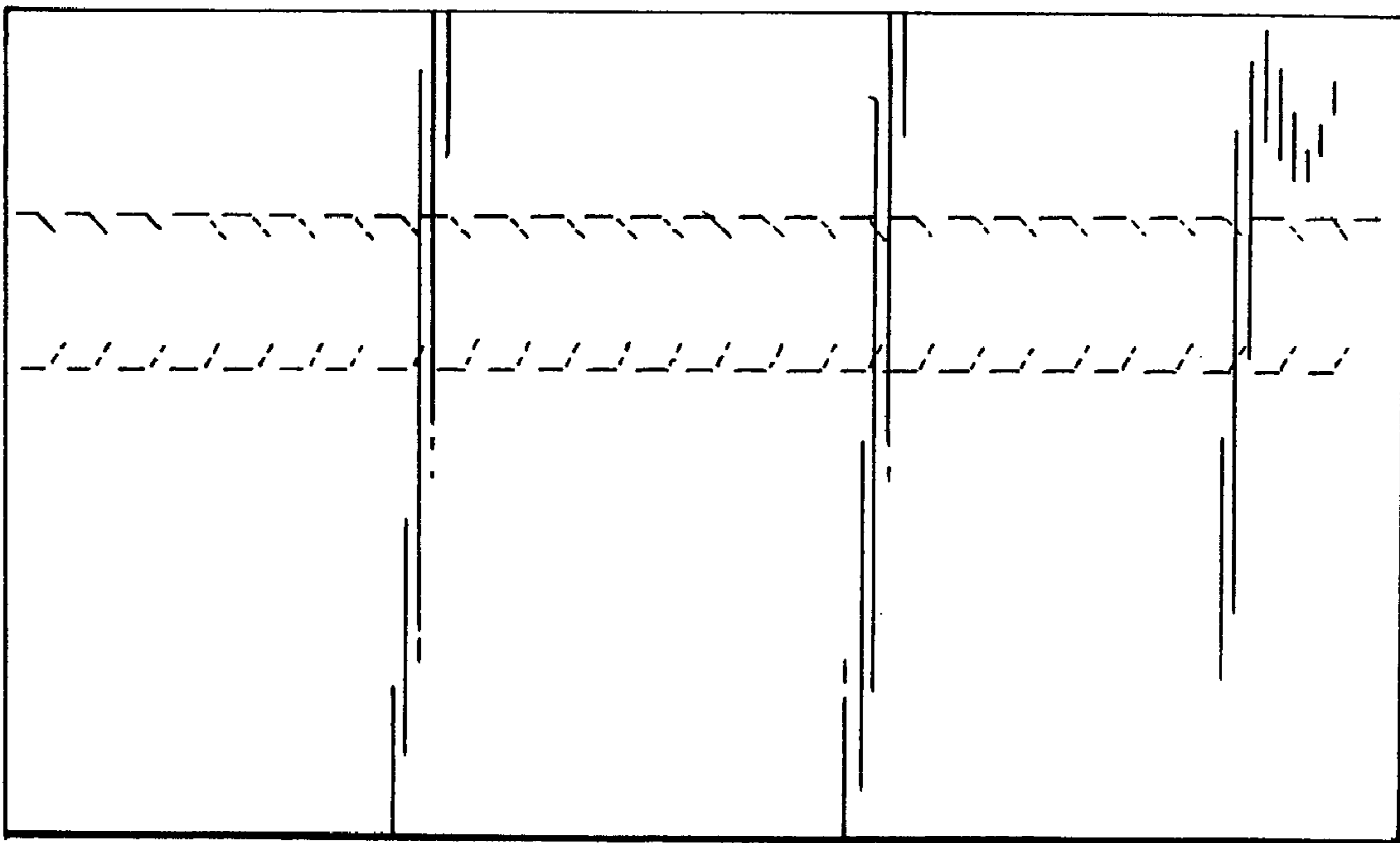

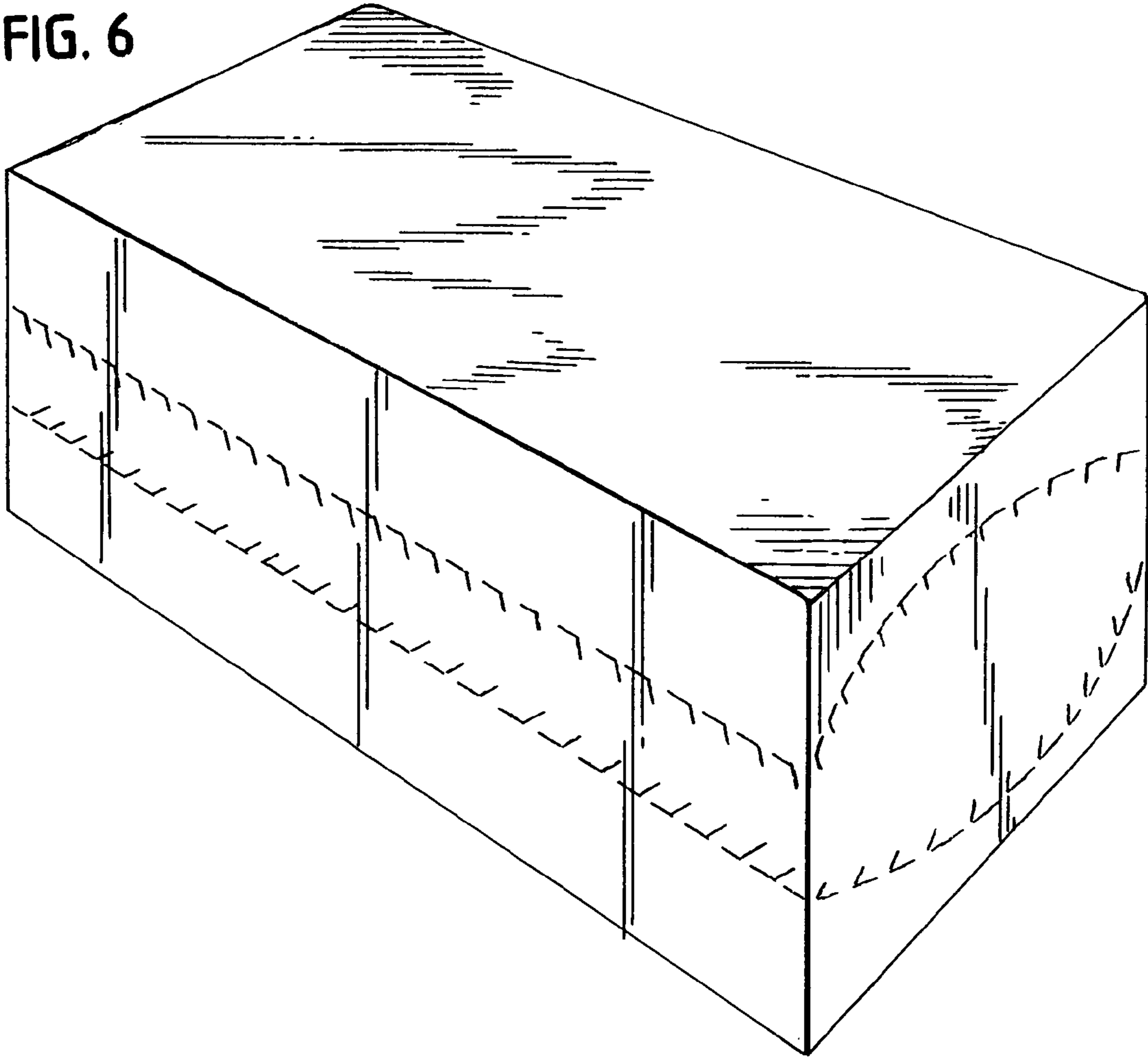
