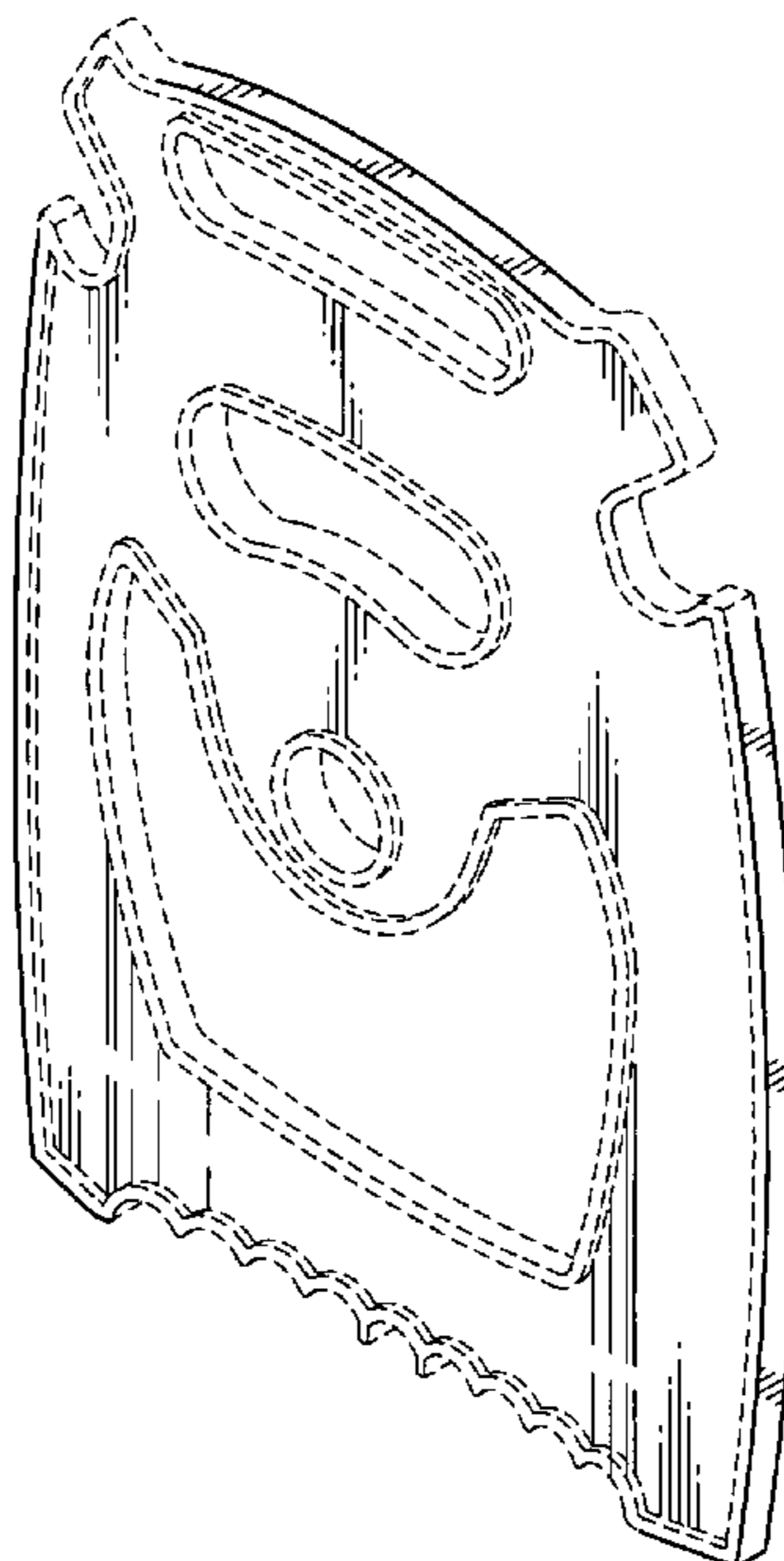
FIG. 1 is a perspective view of a bungee cord pallet of the new design;

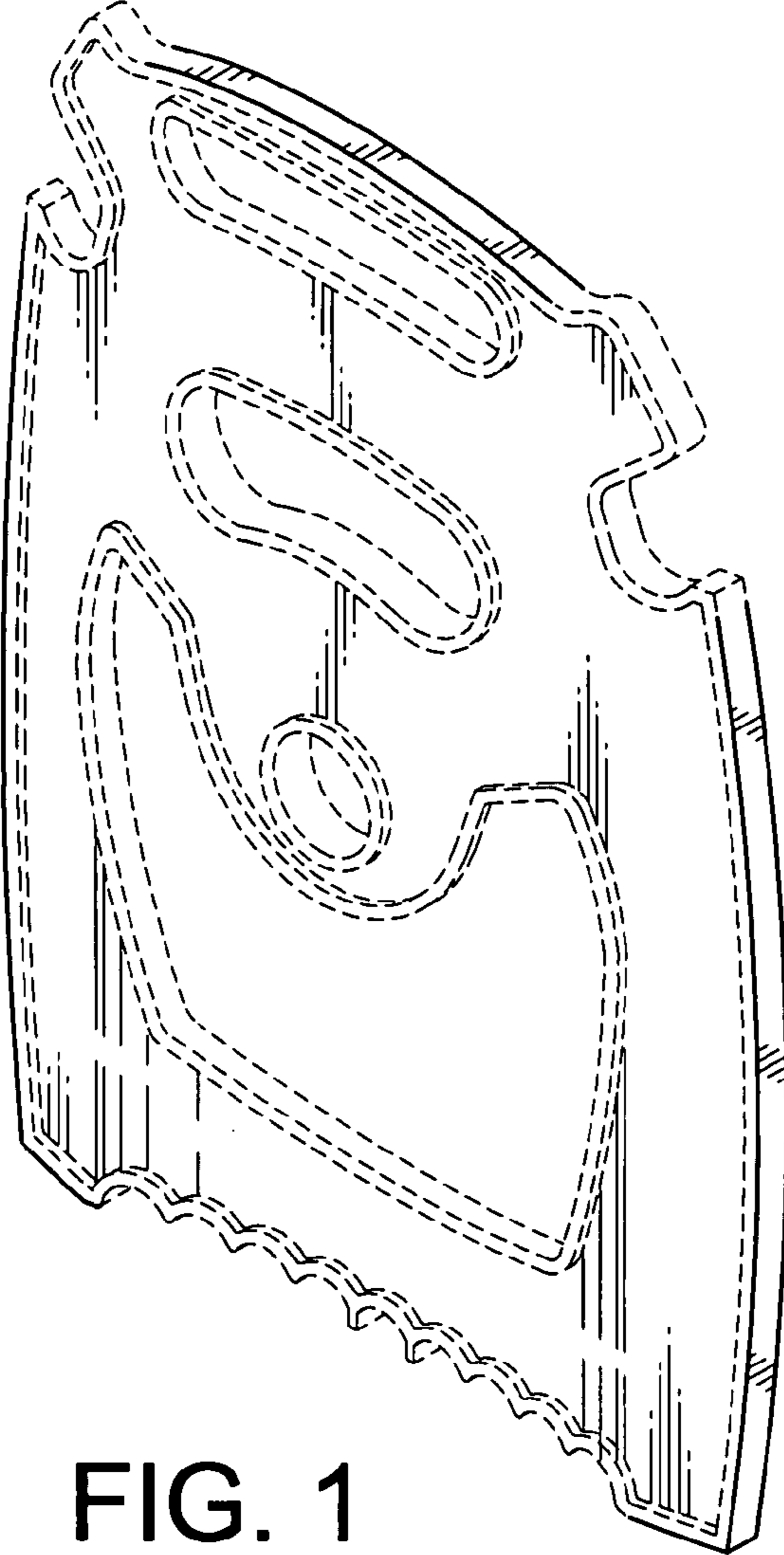

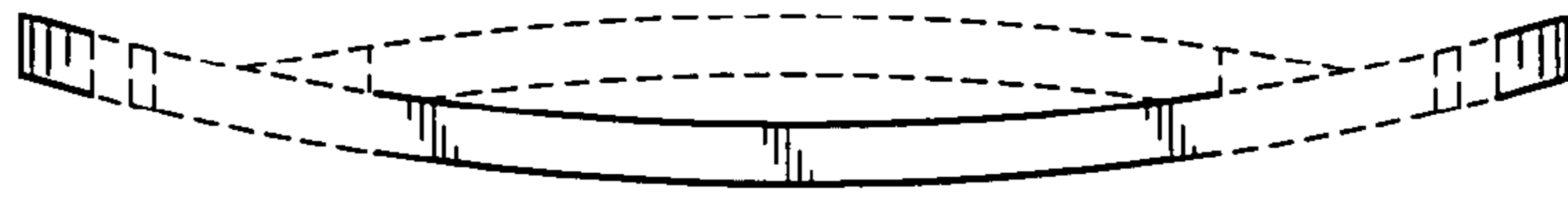

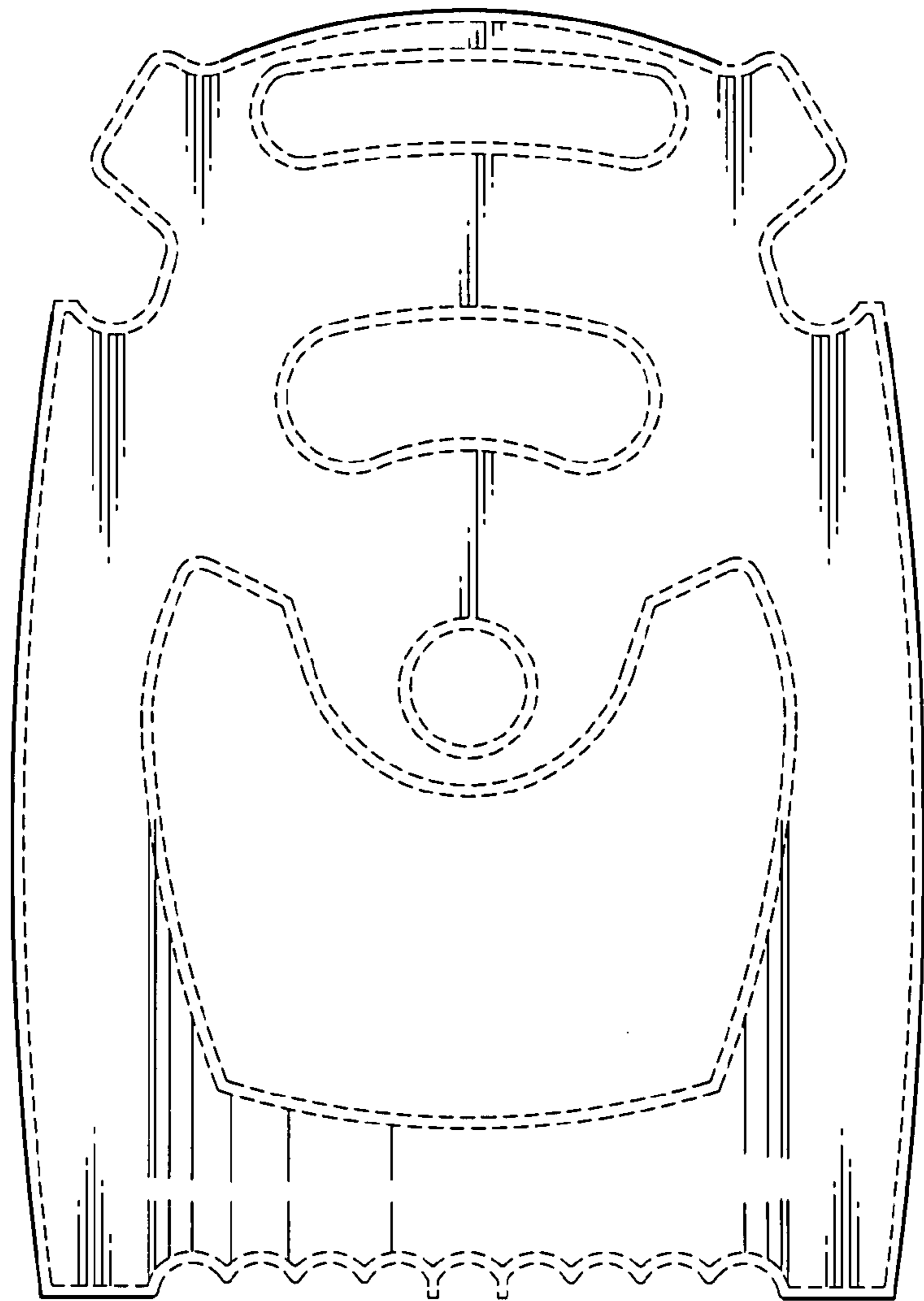

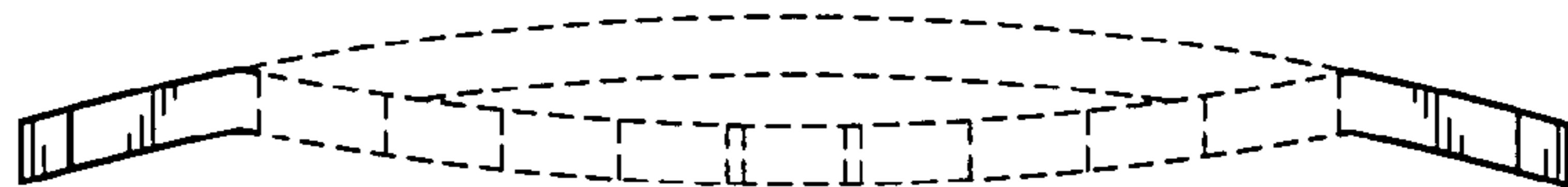

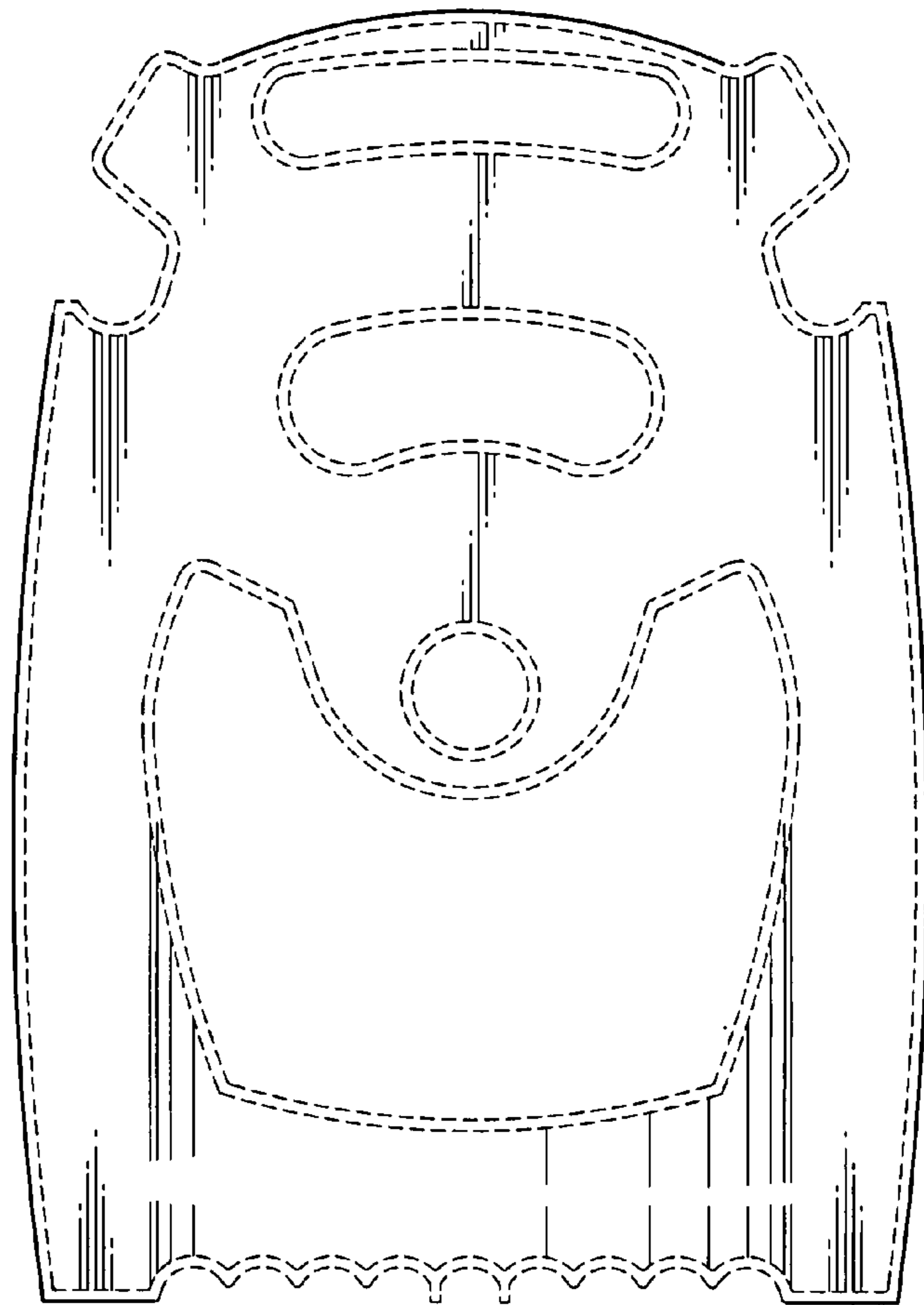
