The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, left side perspective view of a first Embodiment of a bottle in accordance with my new design;

FIG. 2 is a front elevational view thereof, the rear elevational view being identical except for the pour spout thread;

FIG. 3 is a right side elevational view thereof, the left side elevational view being identical except for the pour spout thread;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a top, front, left side perspective view of a second Embodiment of a bottle in accordance with my new design;

FIG. 7 is a front elevational view thereof, the rear elevational view being identical except for the pour spout thread;

FIG. 8 is a right side elevational view thereof, the left side elevational view being identical except for the pour spout thread;

FIG. 9 is a top plan view thereof;

FIG. 10 is a bottom plan view thereof;

FIG. 11 is a top, front, left side perspective view of a third Embodiment of a bottle in accordance with my new design;

FIG. 12 is a front elevational view thereof, the rear elevational view being identical except for the unclaimed cap;

FIG. 13 is a right side elevational view thereof, the left side elevational view being identical except for the unclaimed cap;

FIG. 14 is a top plan view thereof;

FIG. 15 is a bottom plan view thereof;

FIG. 16 is a top, front, left side perspective view of a fourth Embodiment of a bottle in accordance with my new design;

FIG. 17 is a front elevational view thereof, the rear elevational view being identical except for the unclaimed cap;

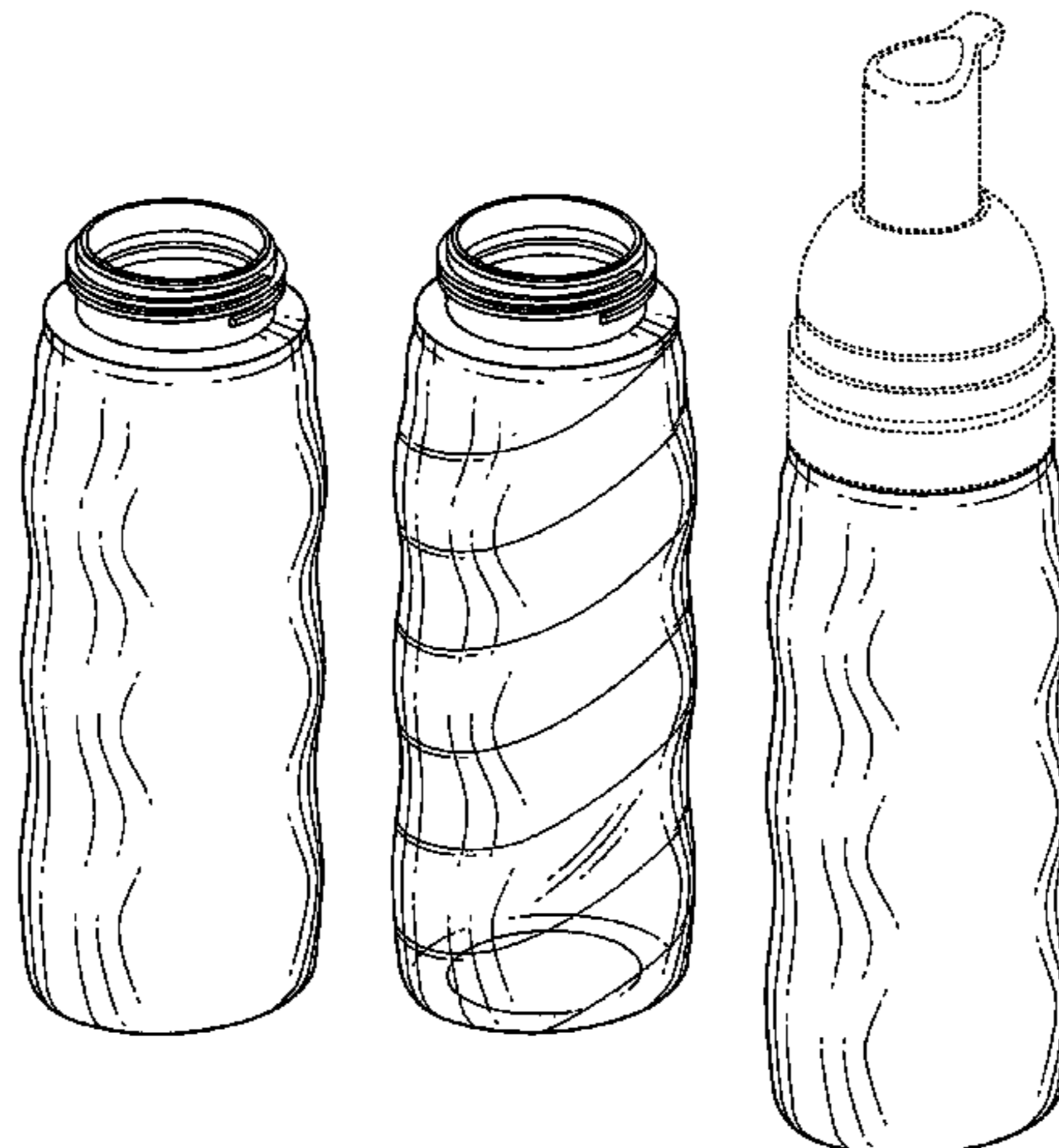
FIG. 18 is a right side elevational view thereof, the left side elevational view being identical except for the unclaimed cap;

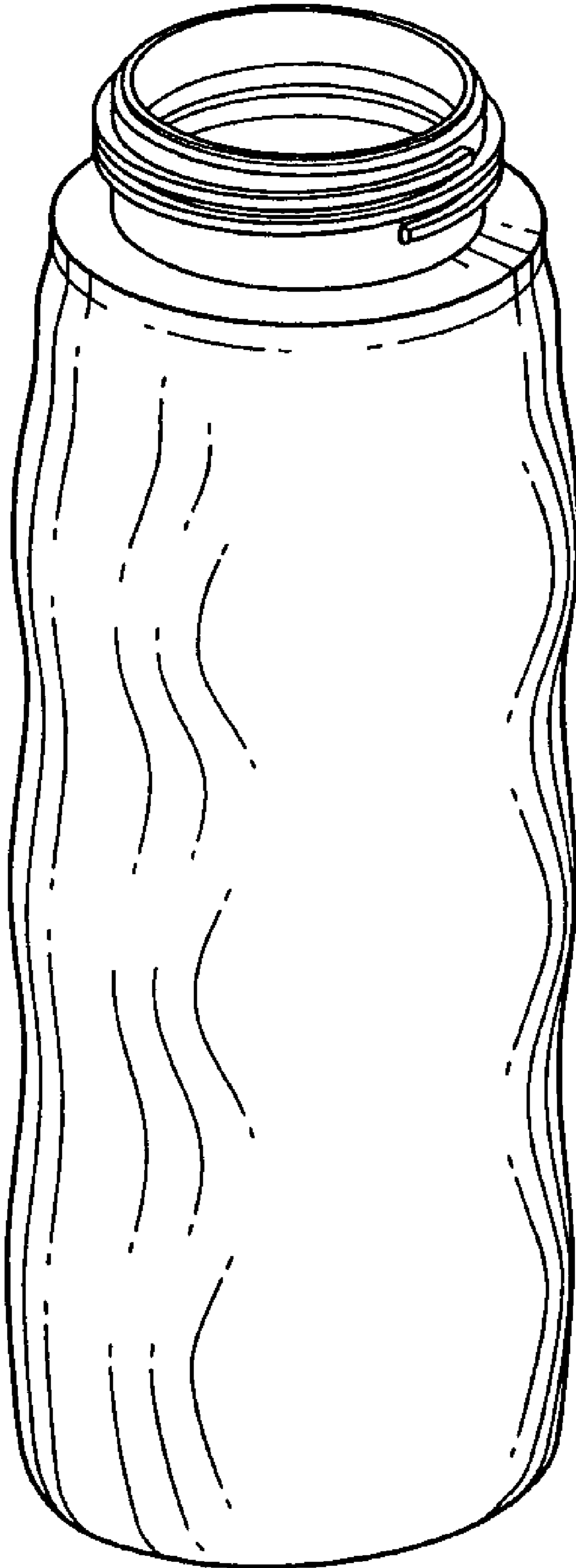

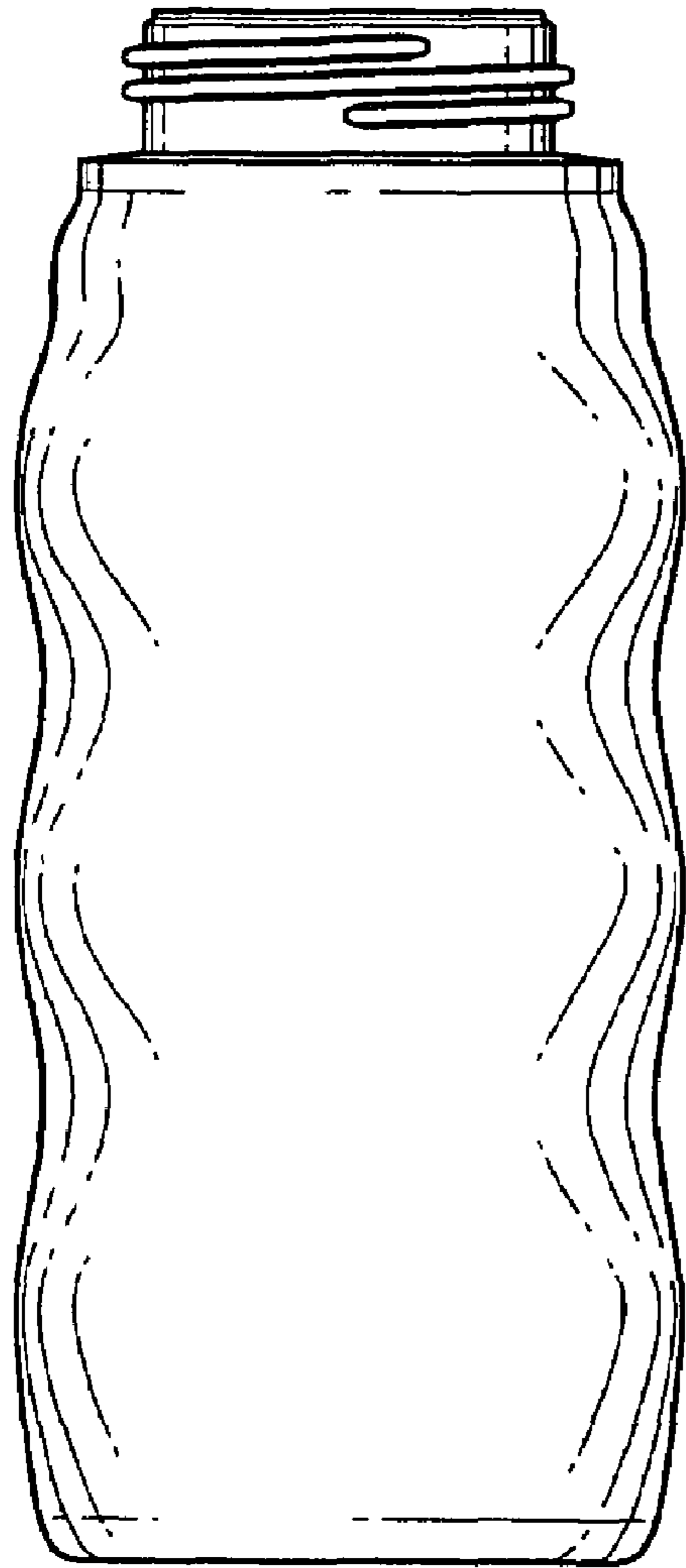

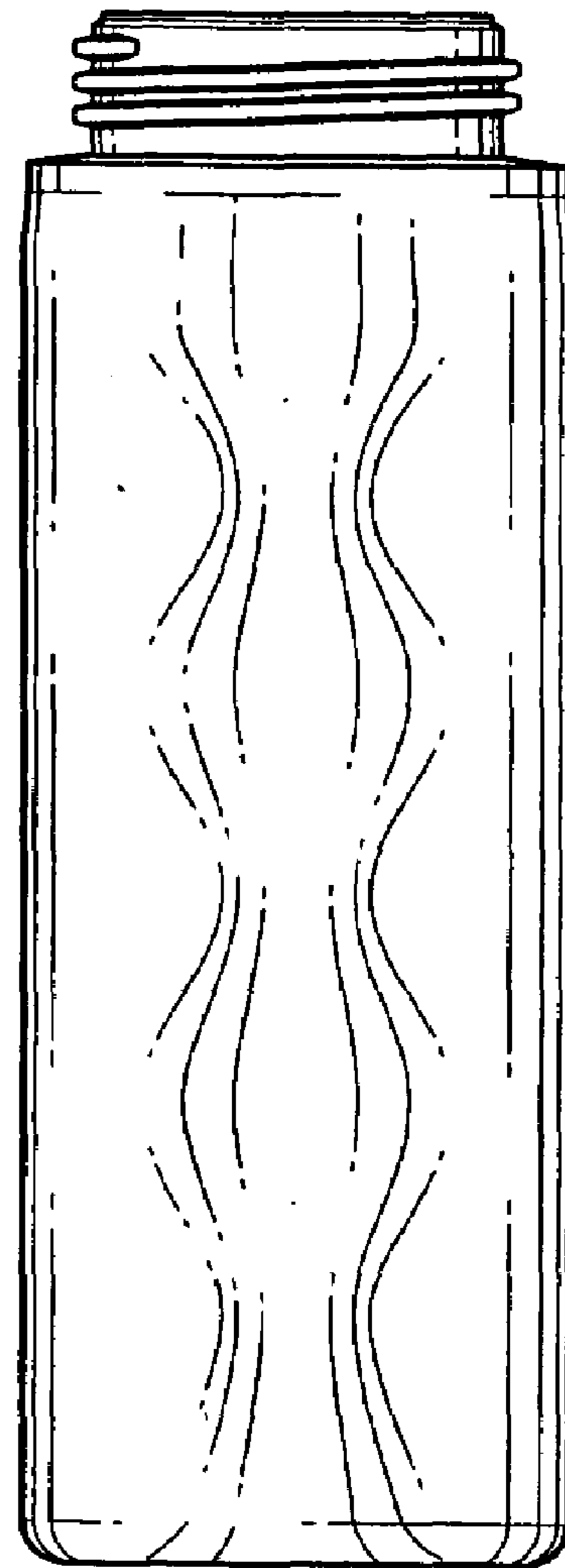
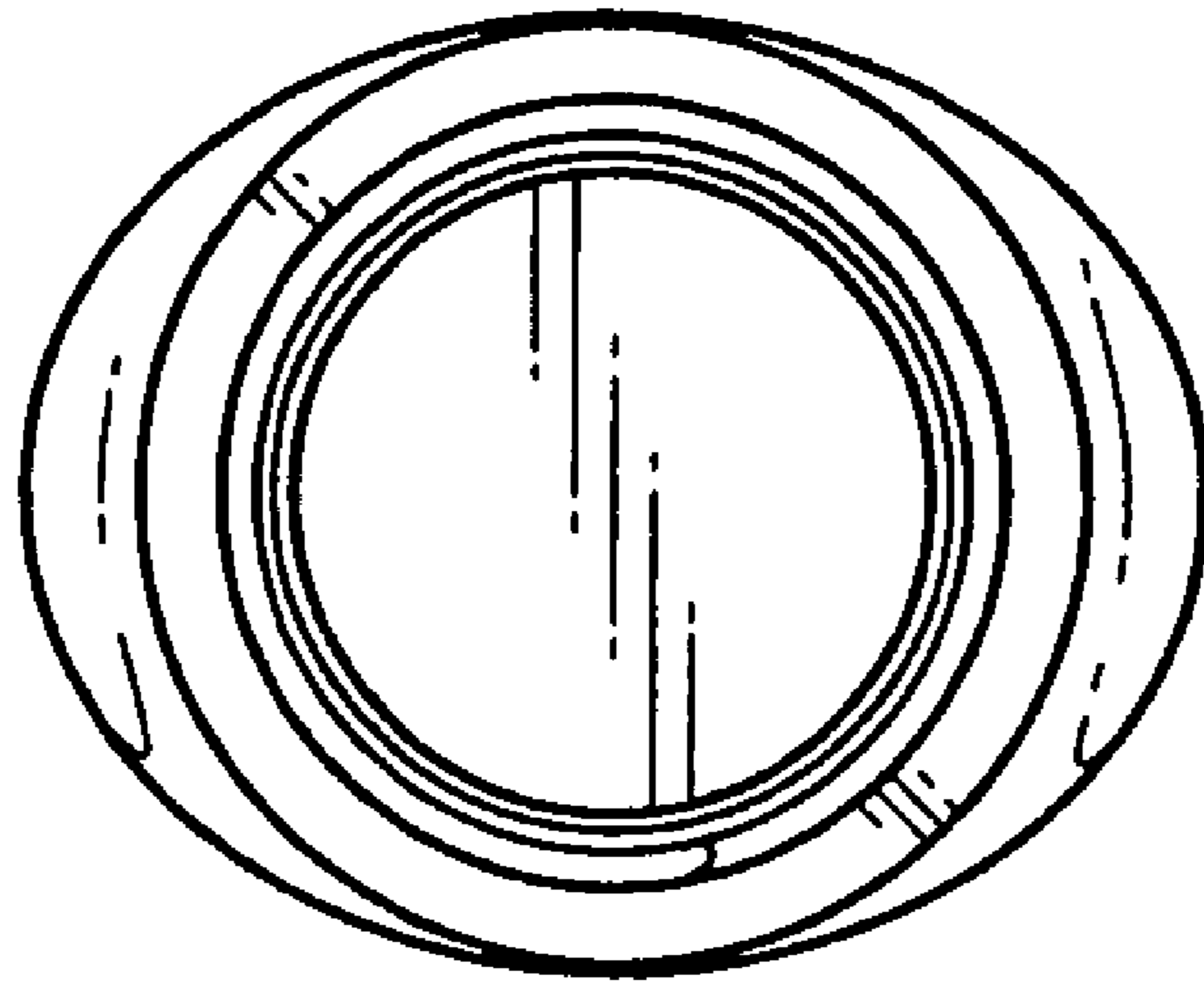
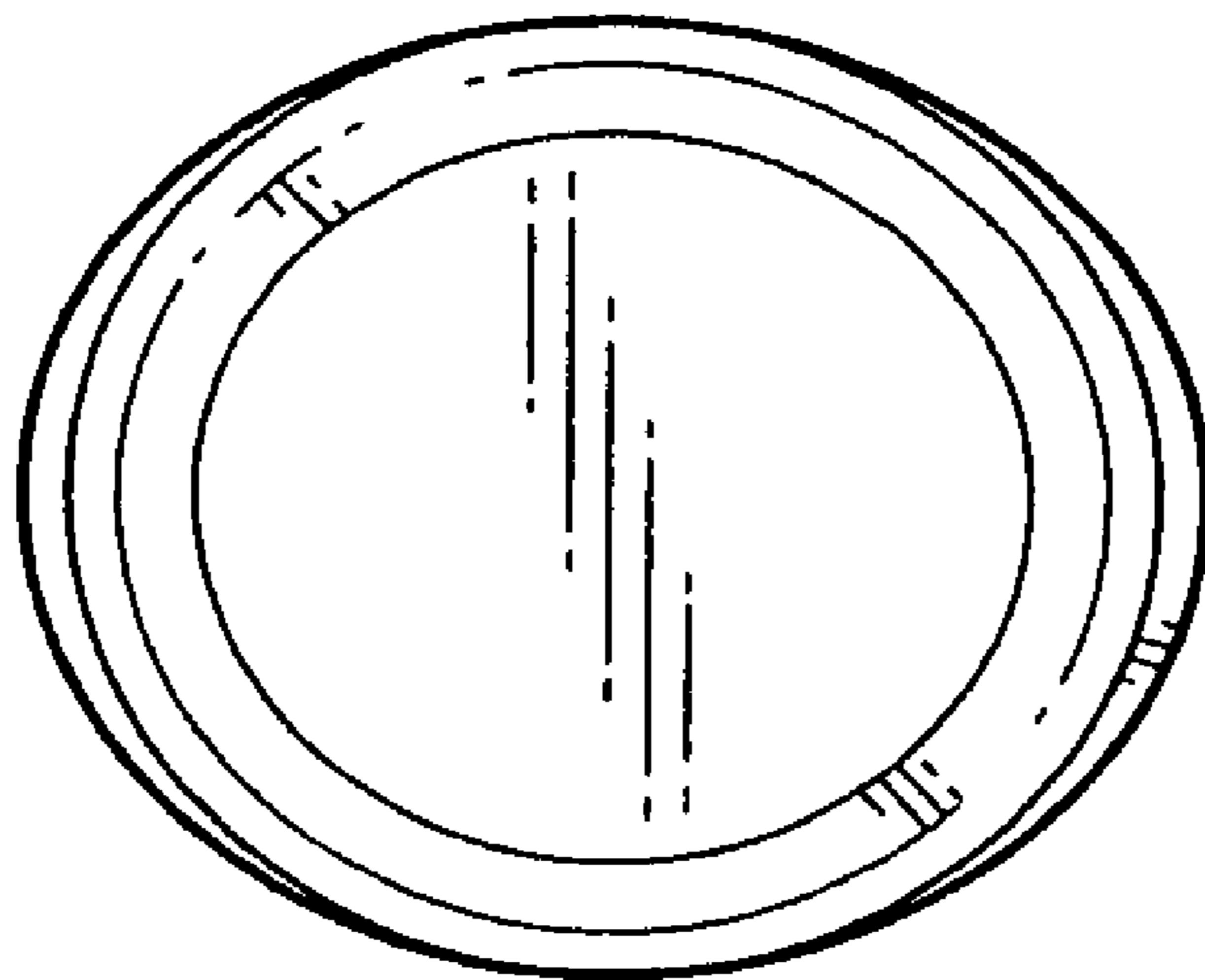


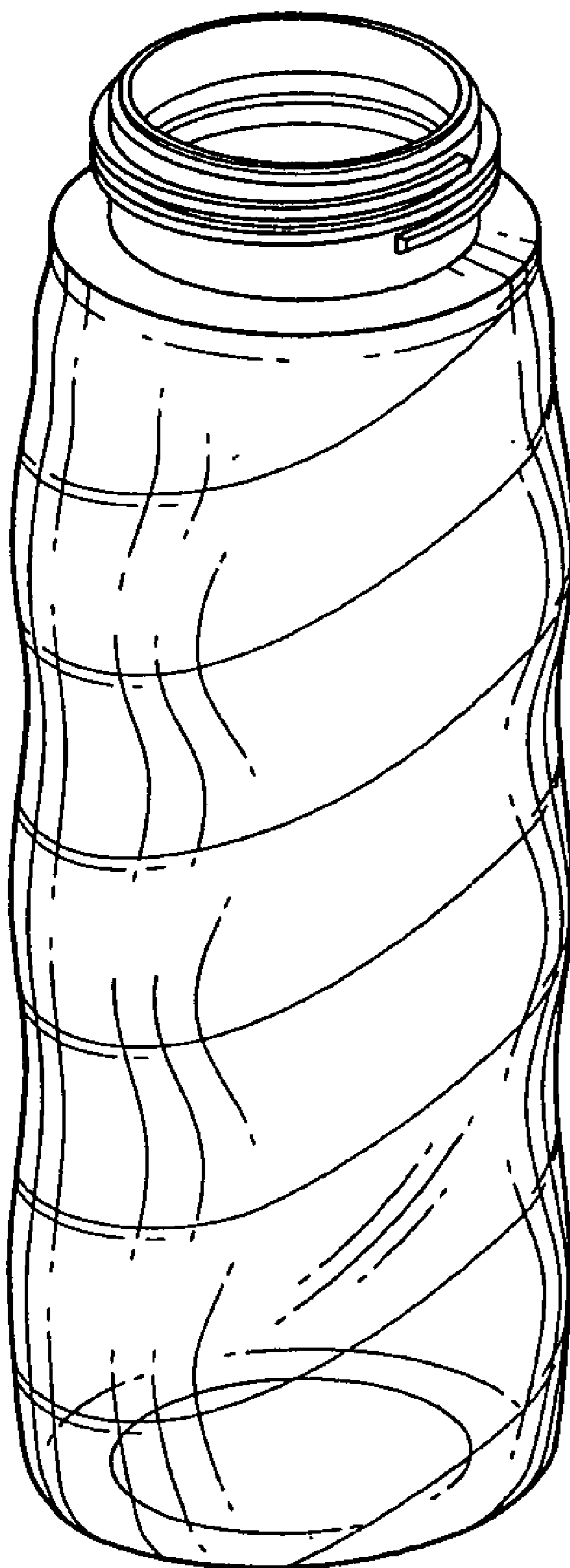

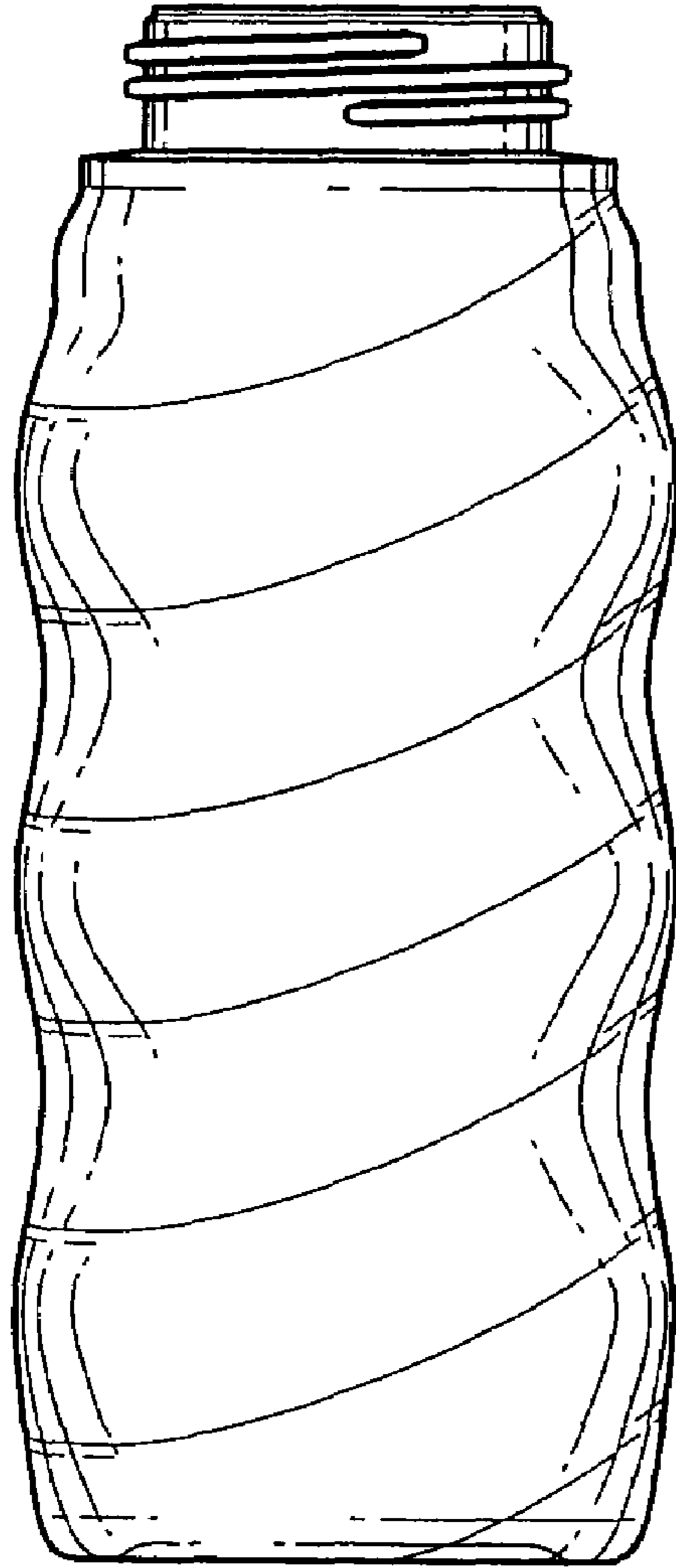

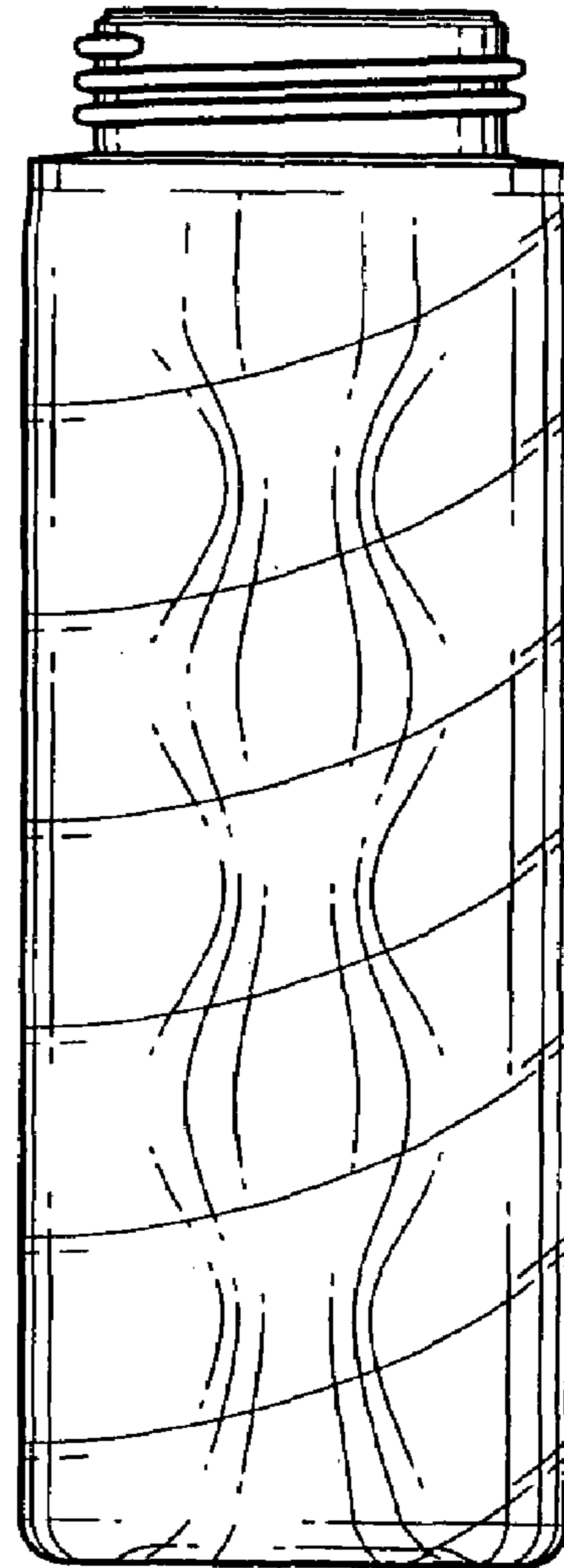

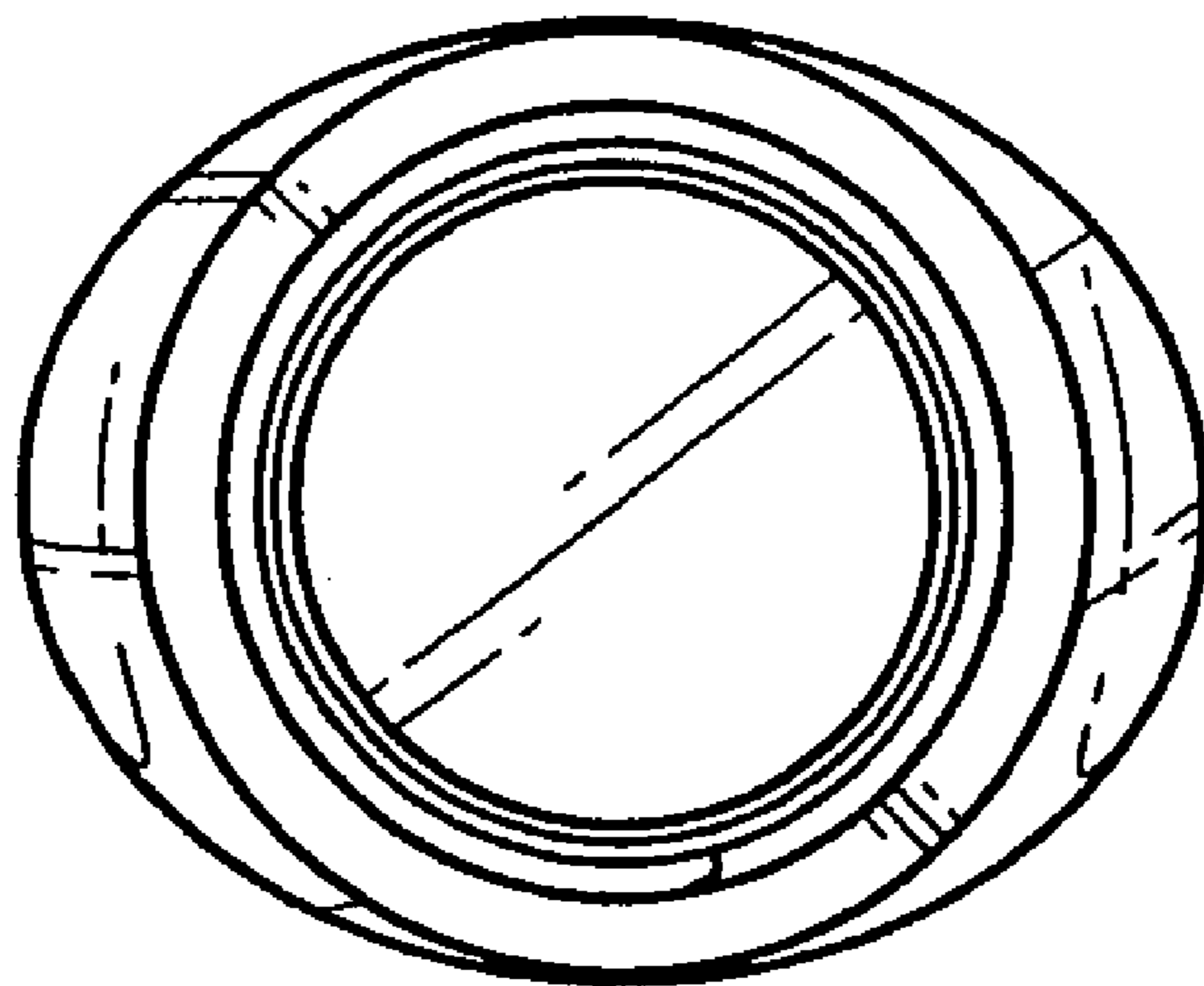

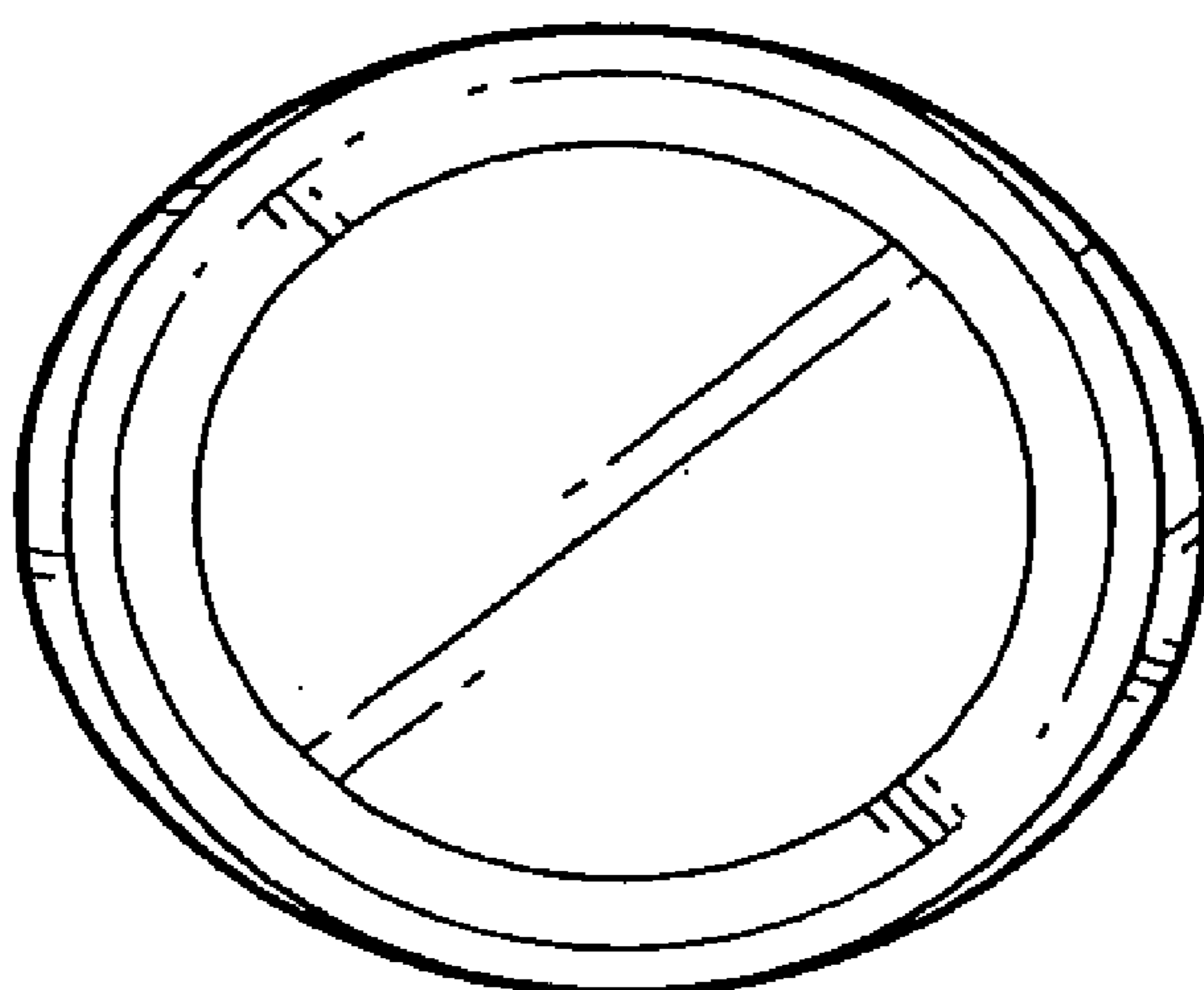

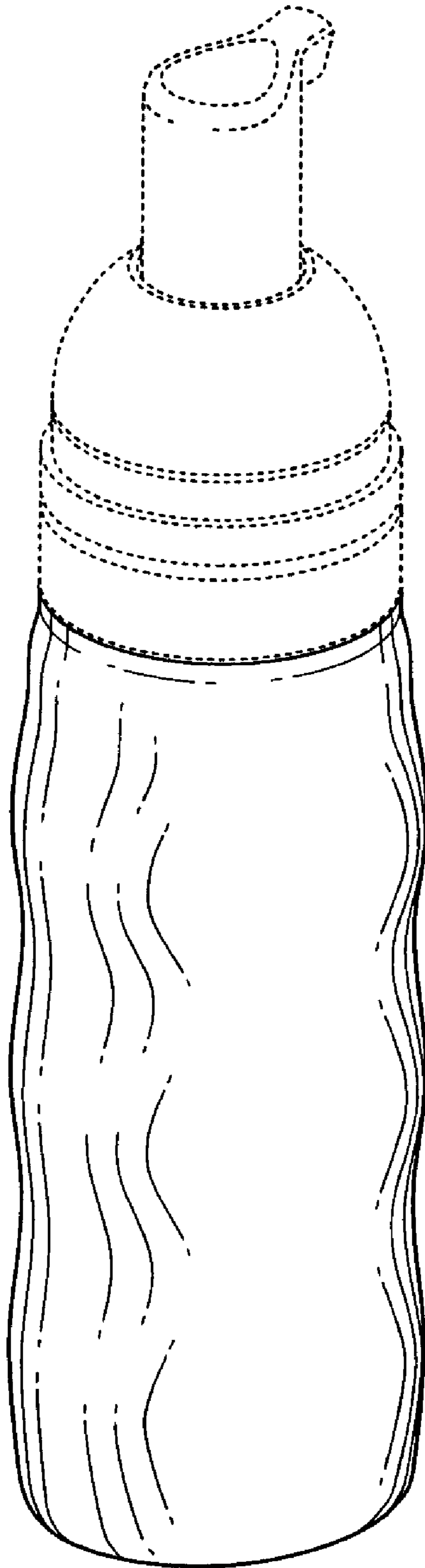

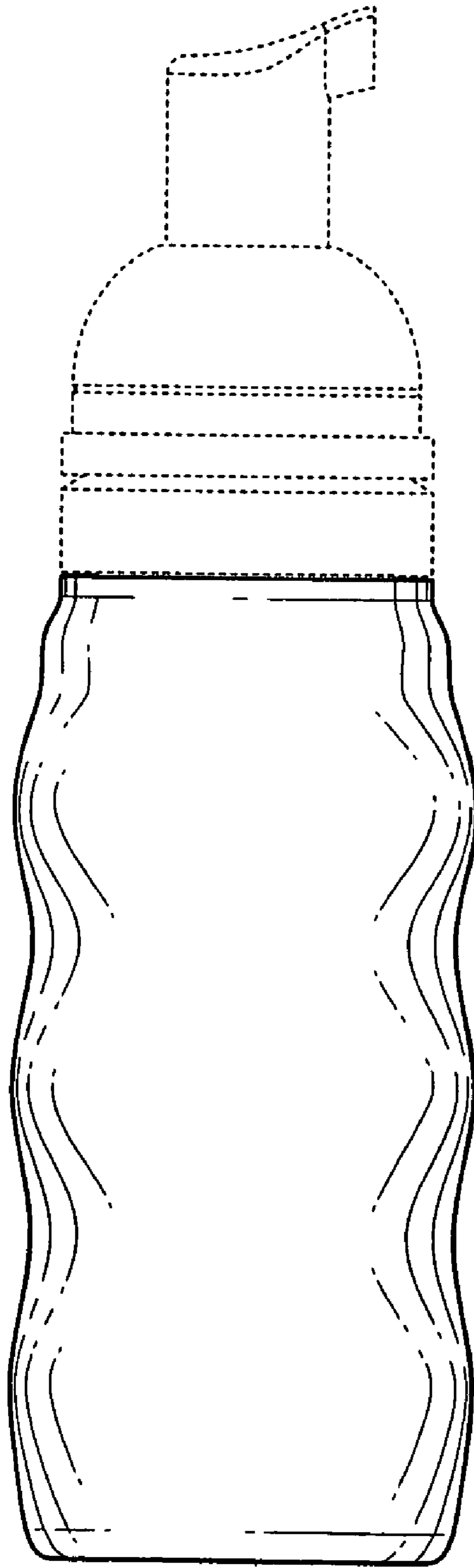

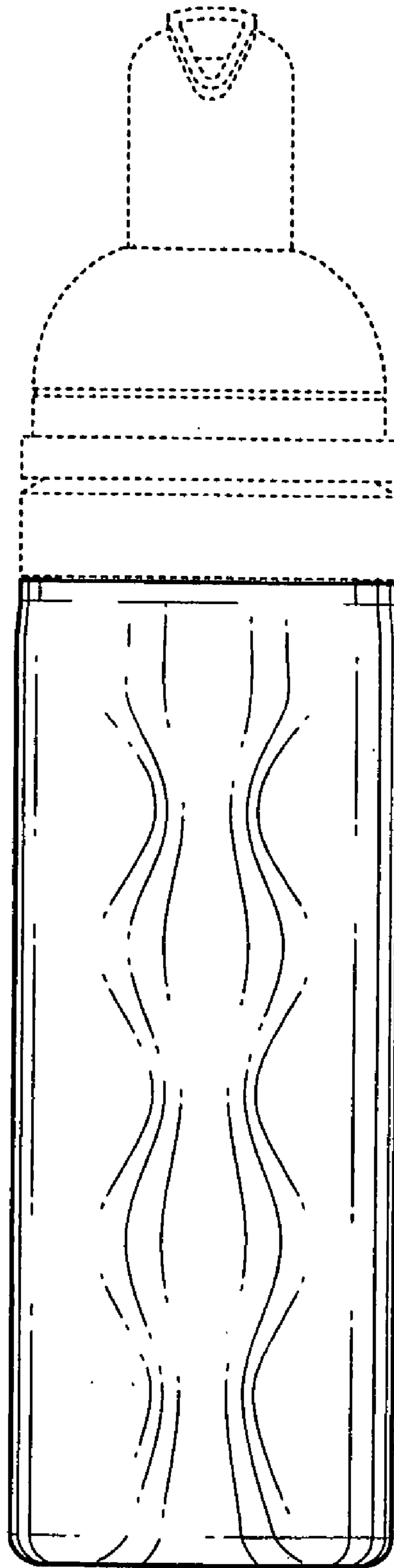




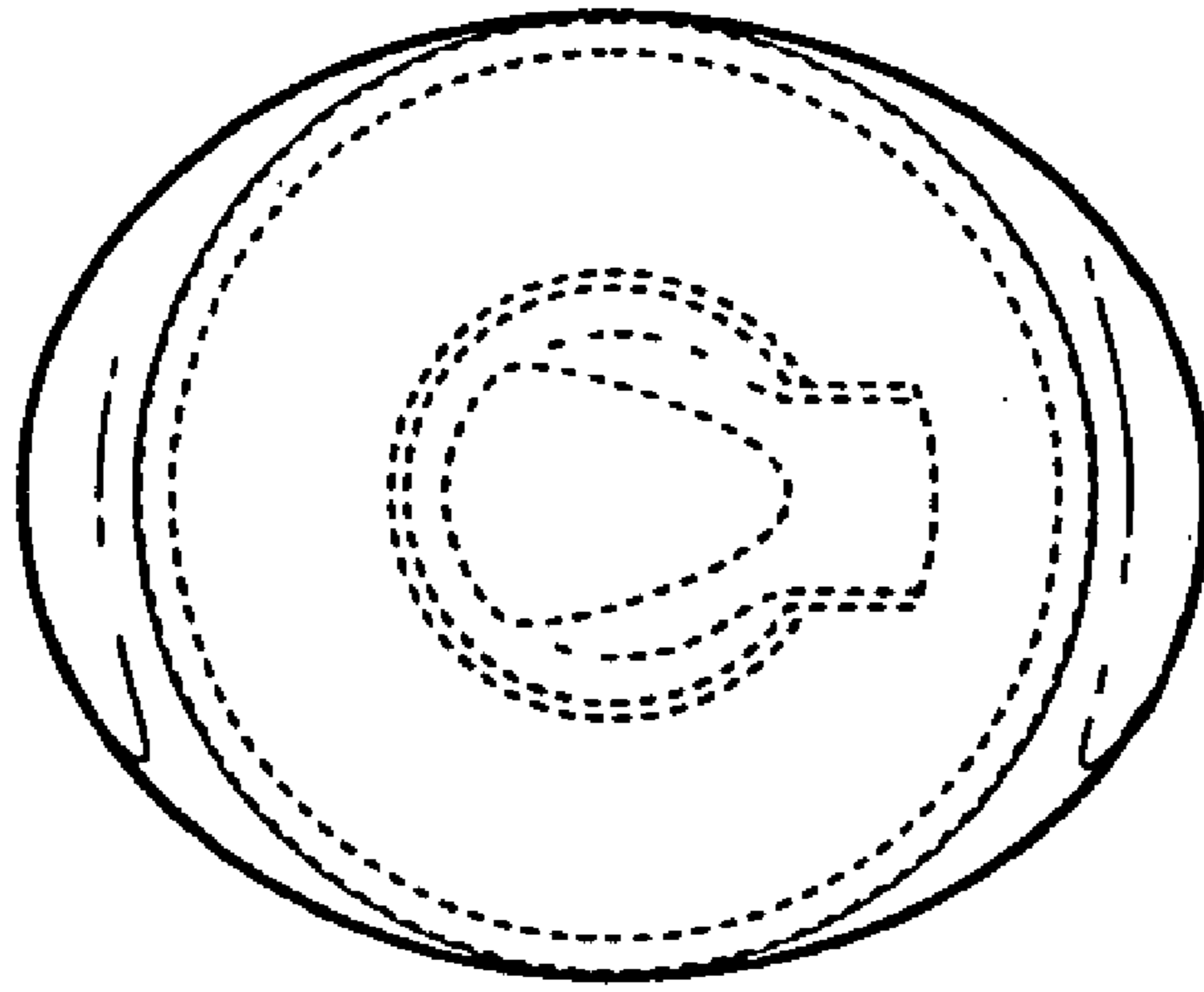

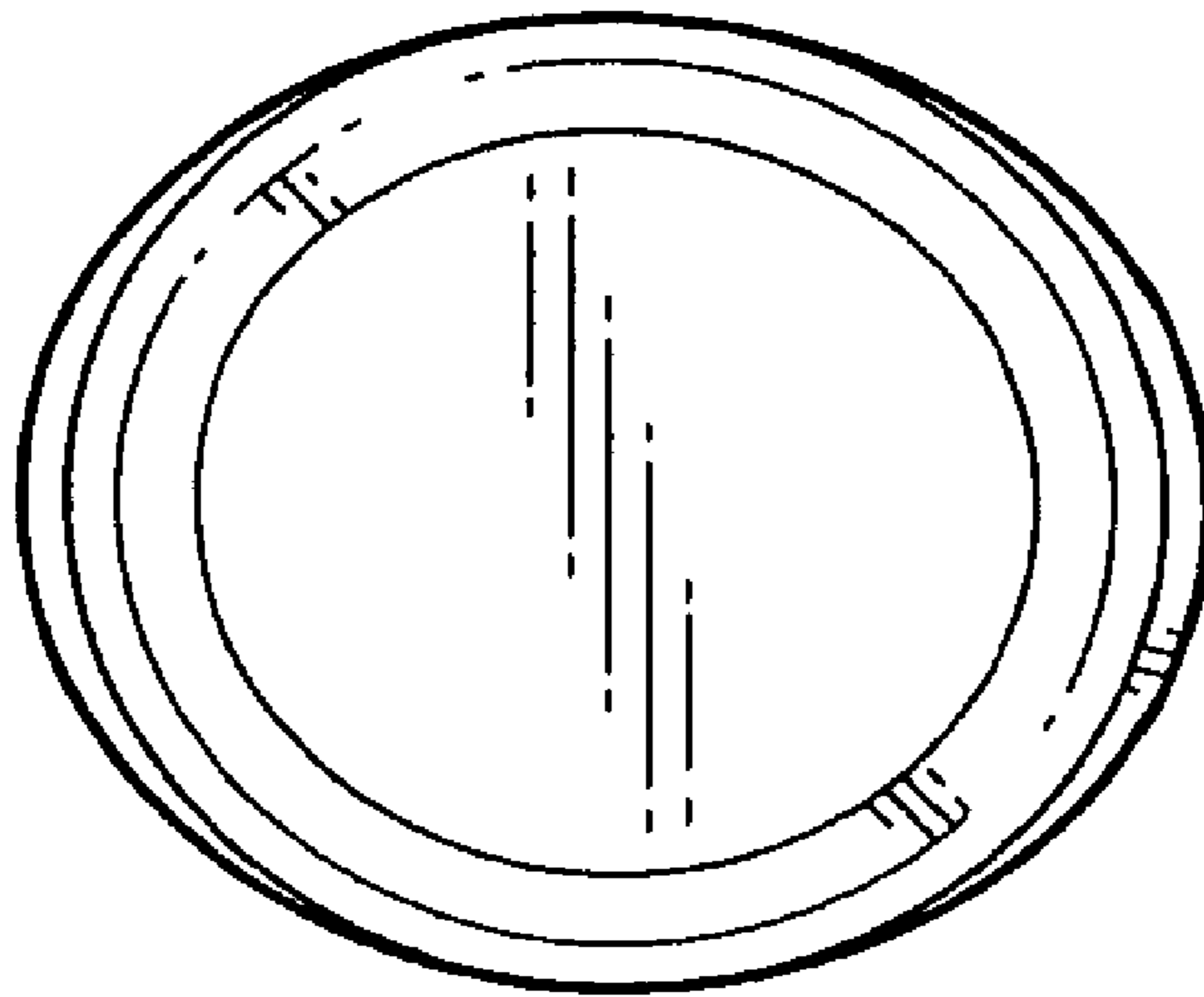

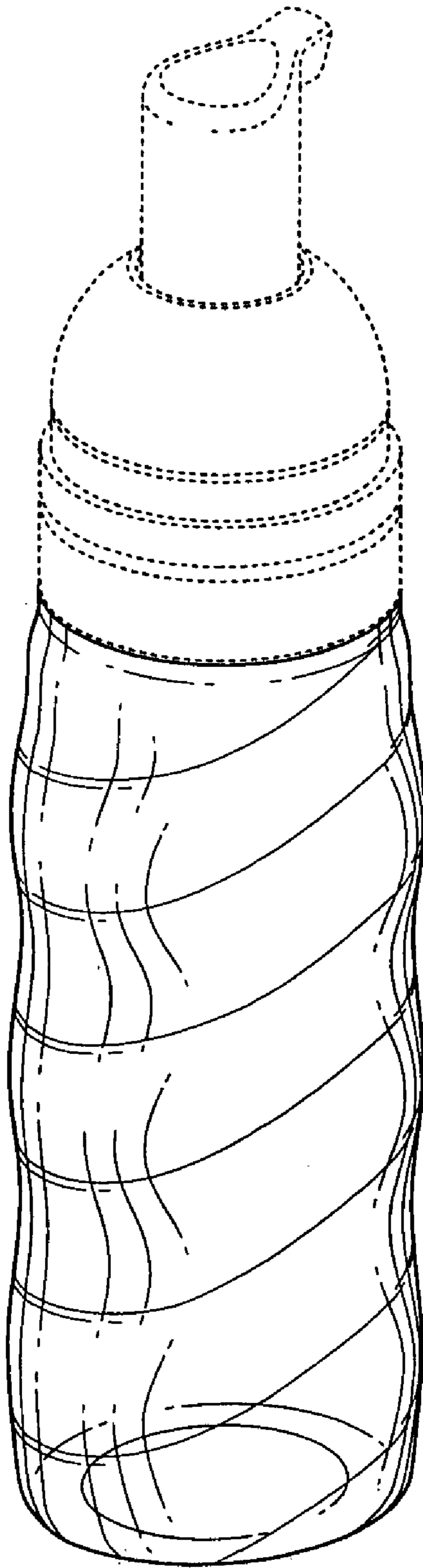

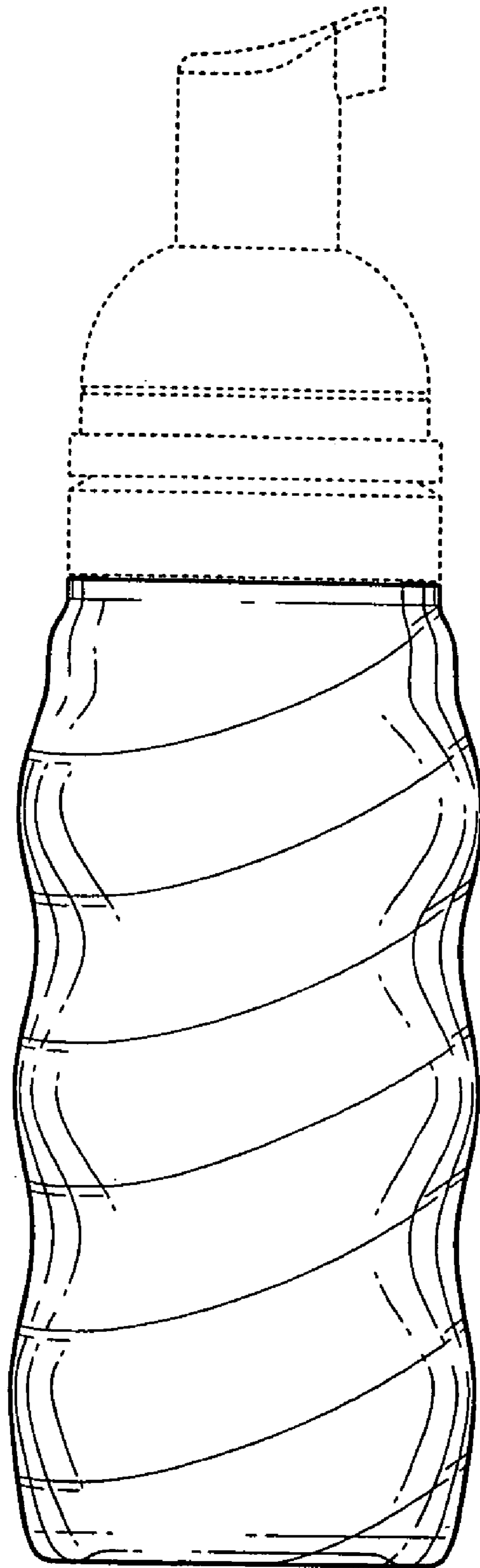

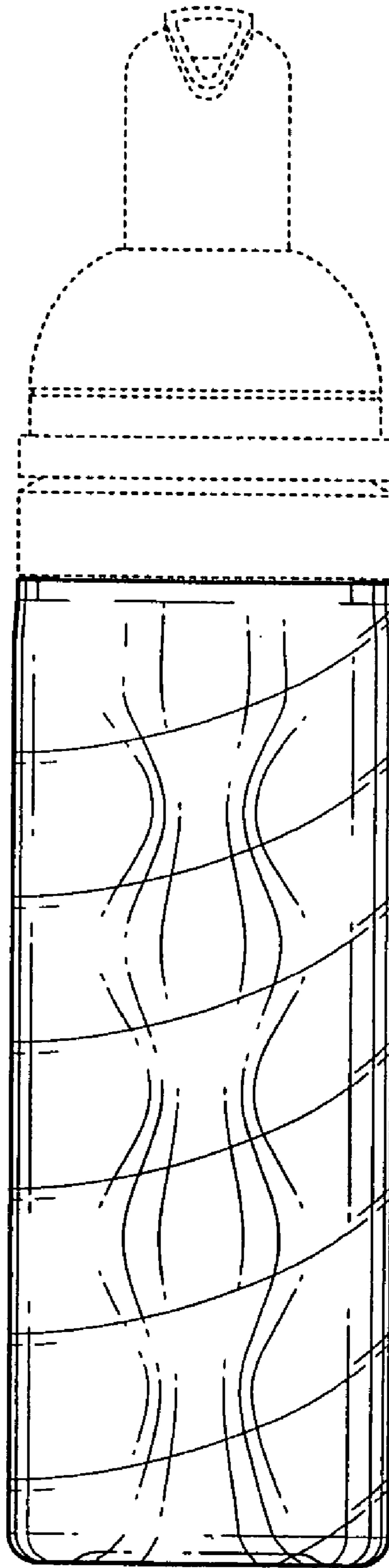

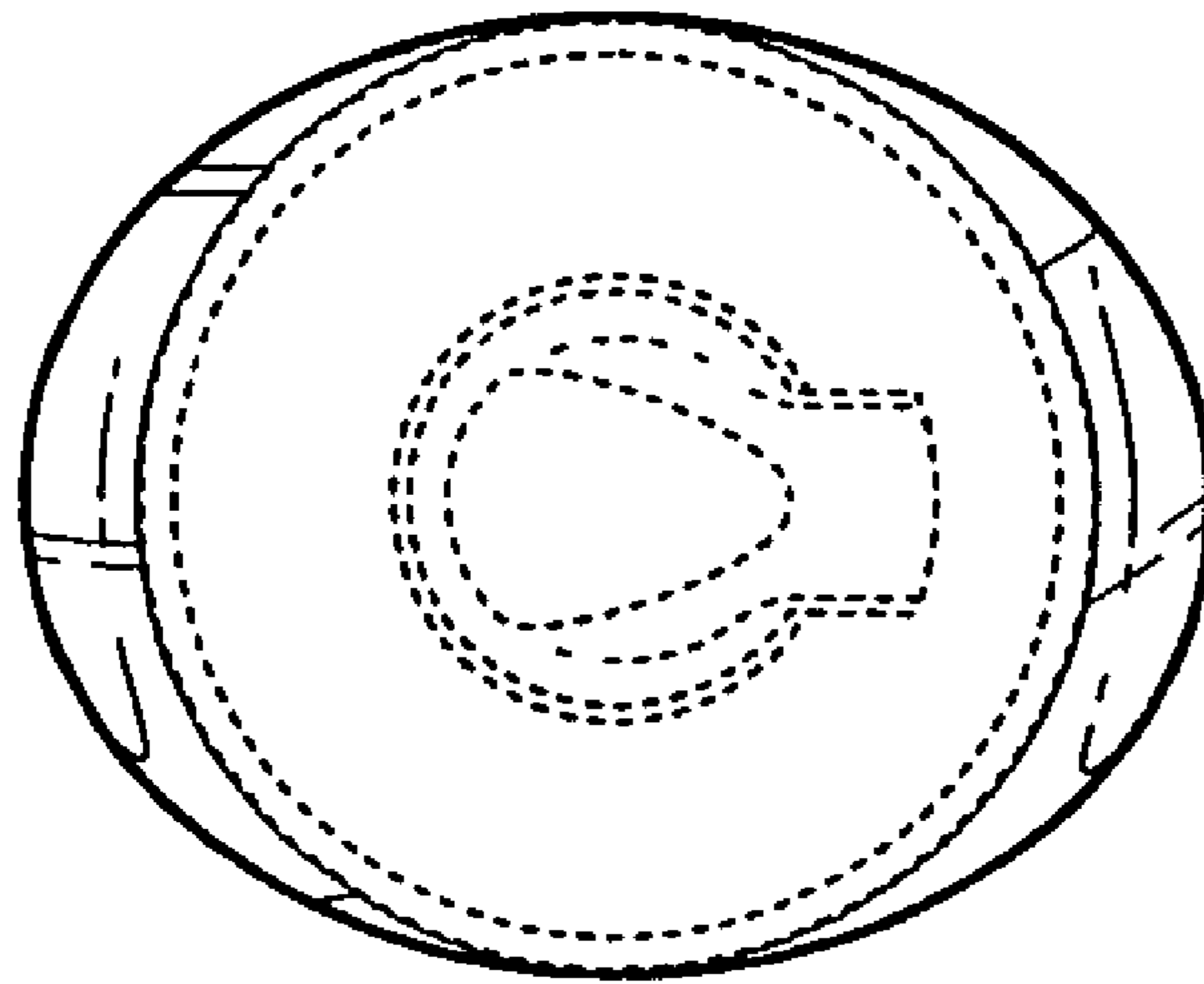

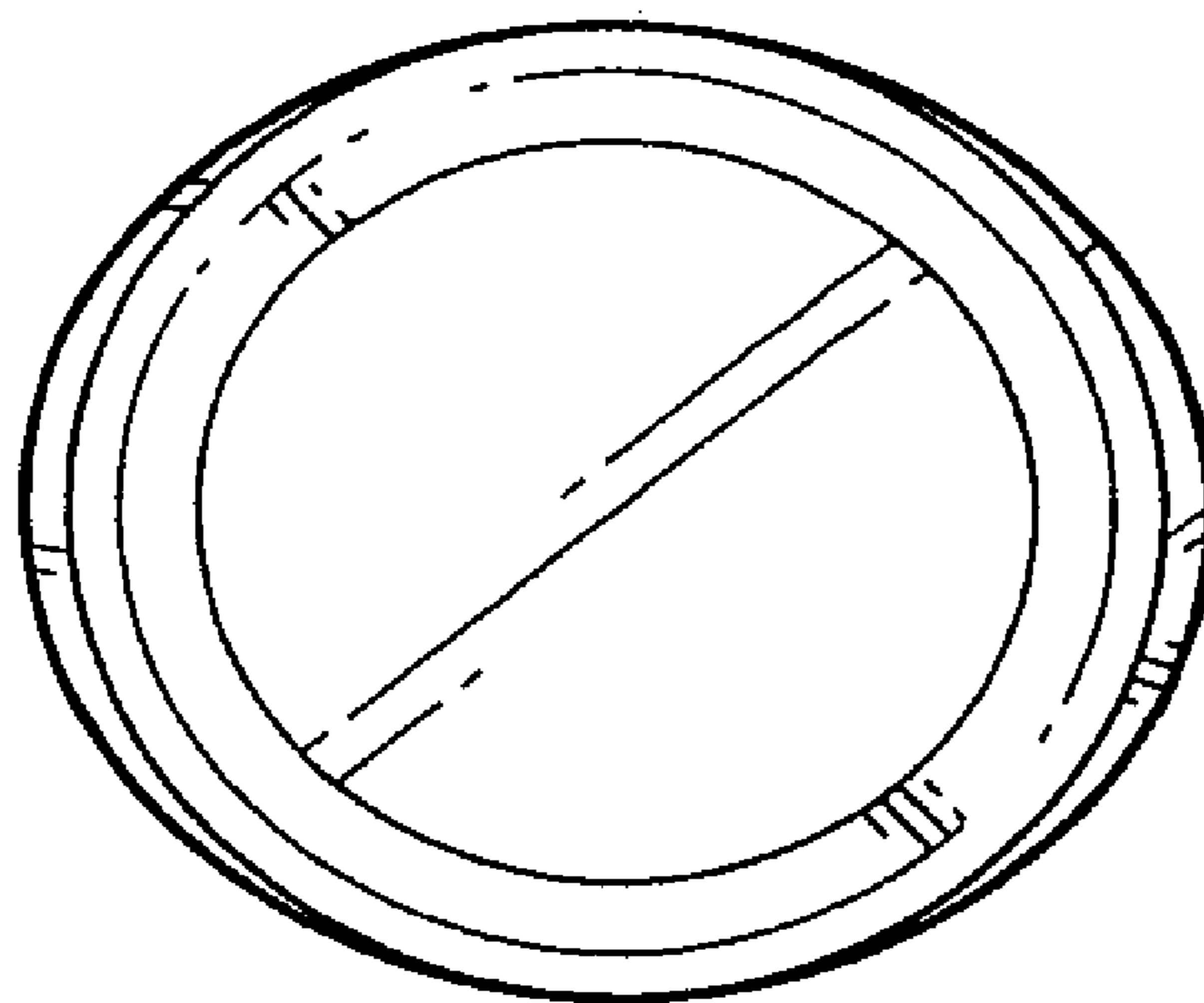
