FIG. 4 is a perspective view of the cat topical dispenser of FIG. 2; and,

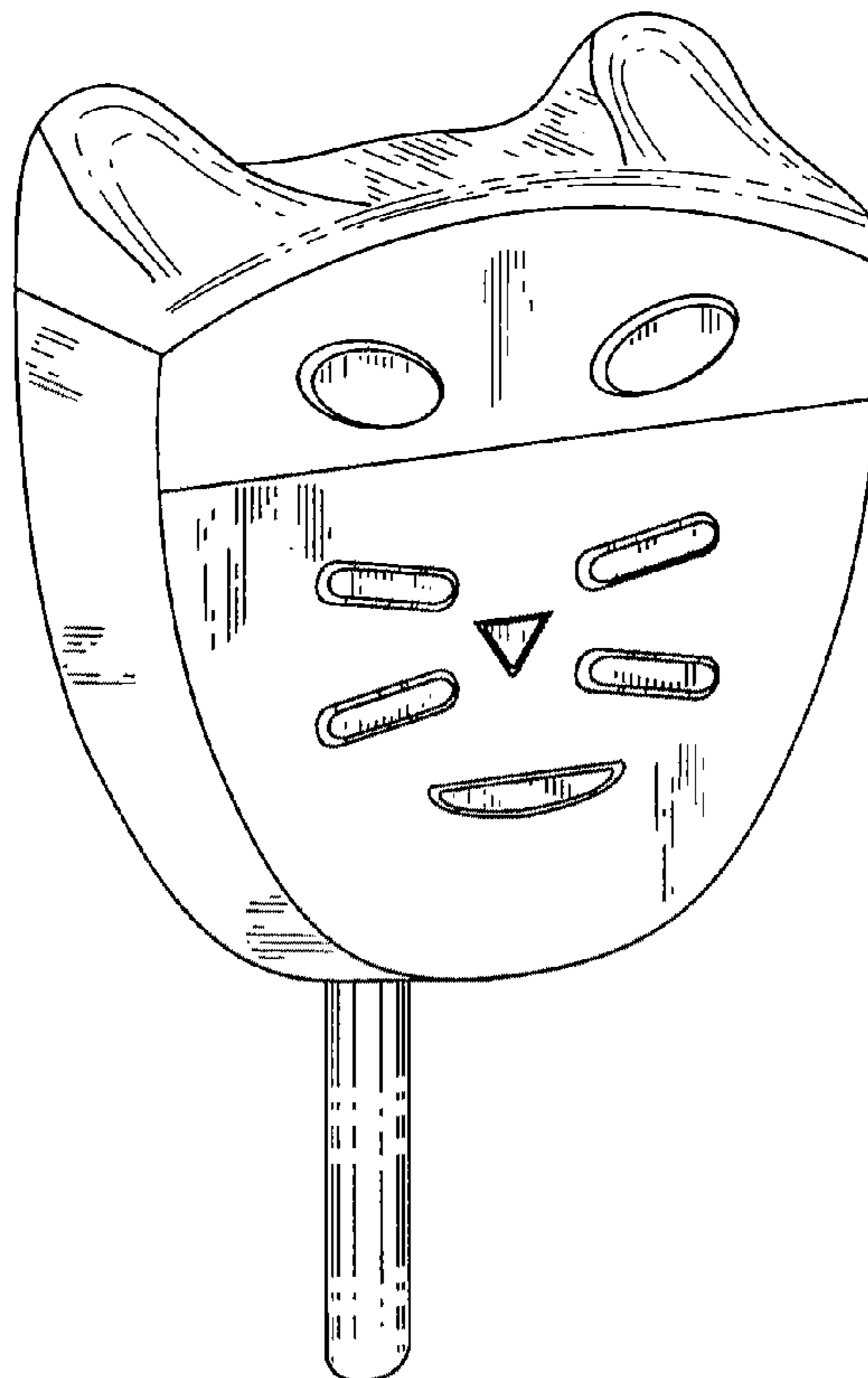
FIG. 5 is a perspective view of another embodiment of a cat topical dispenser.

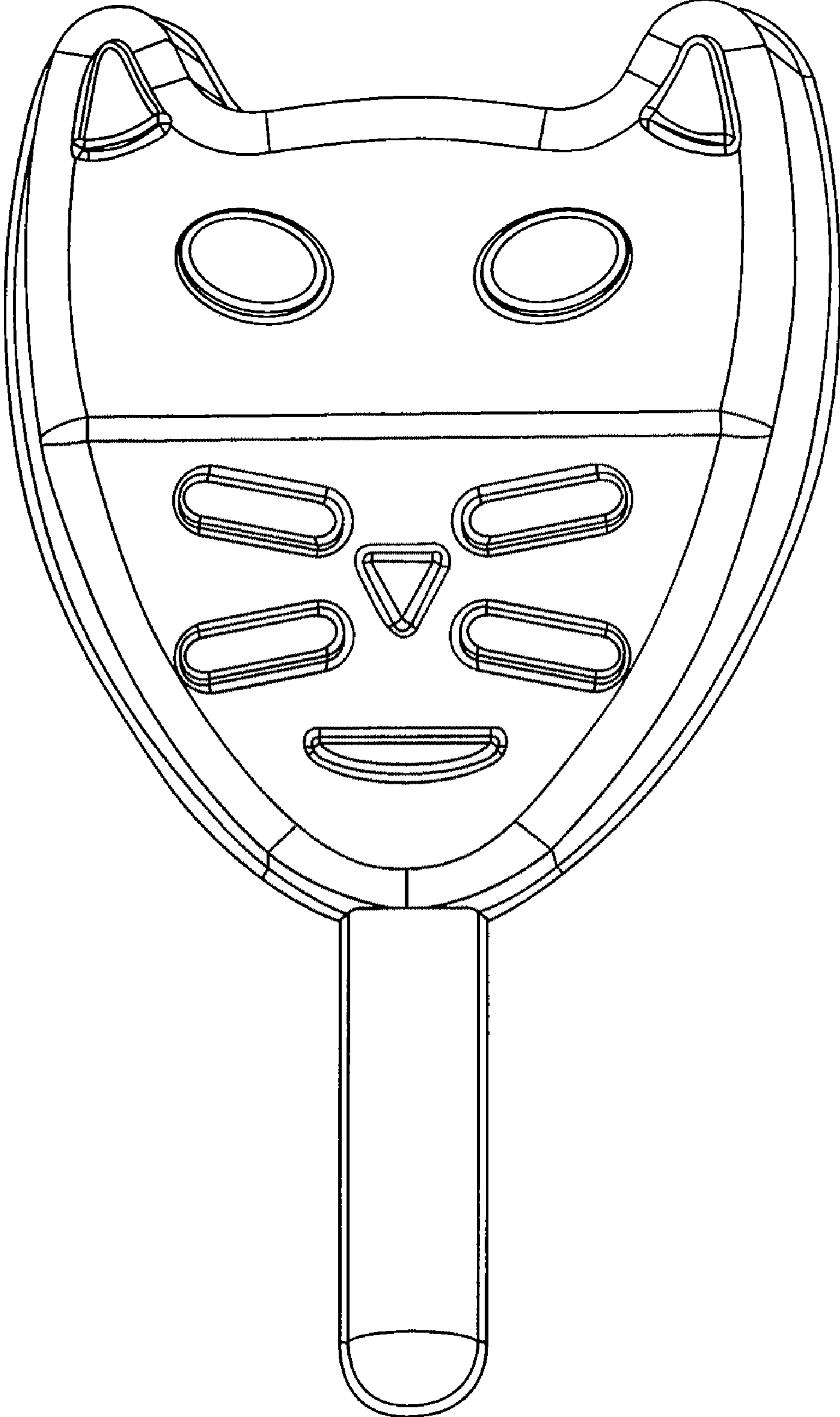

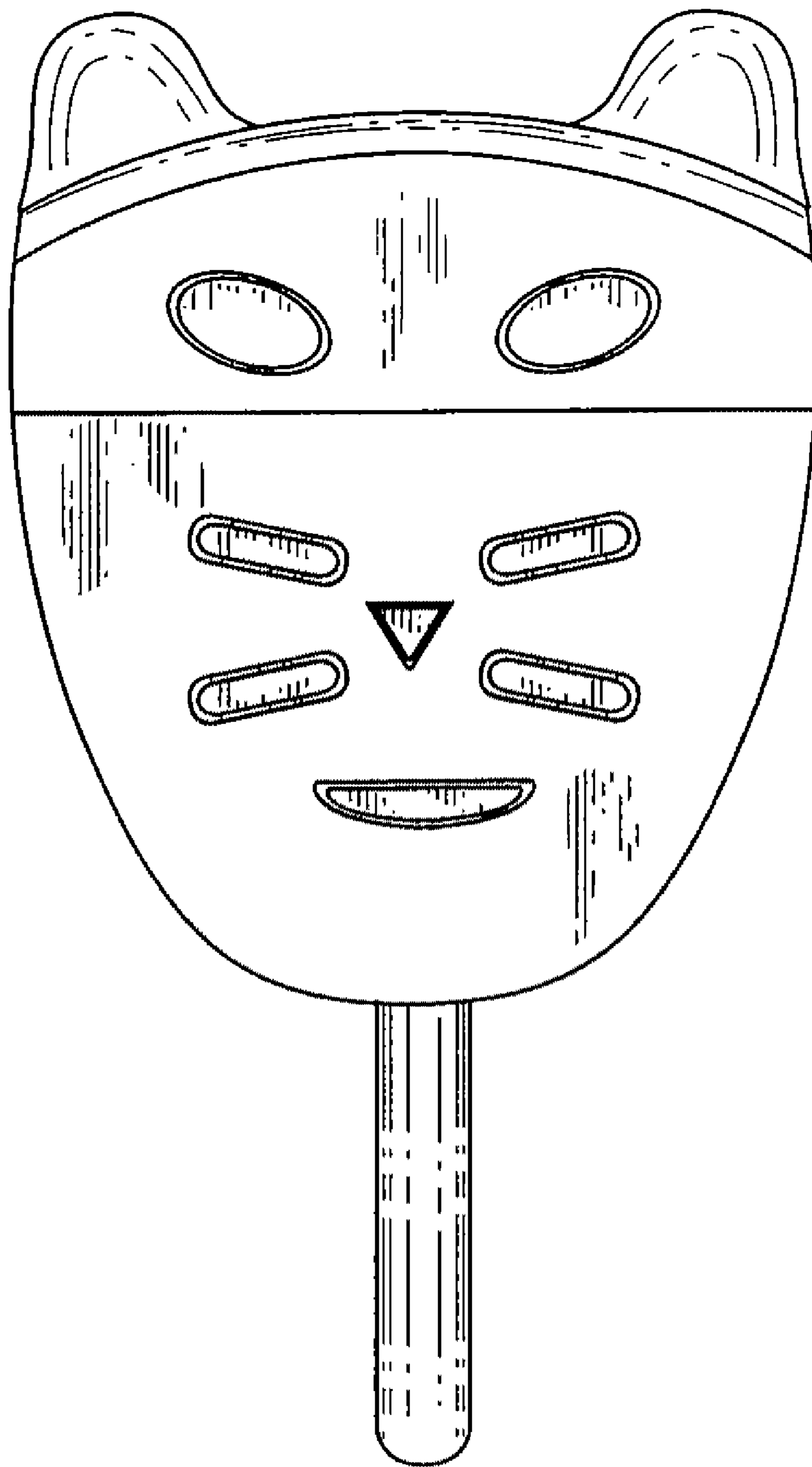

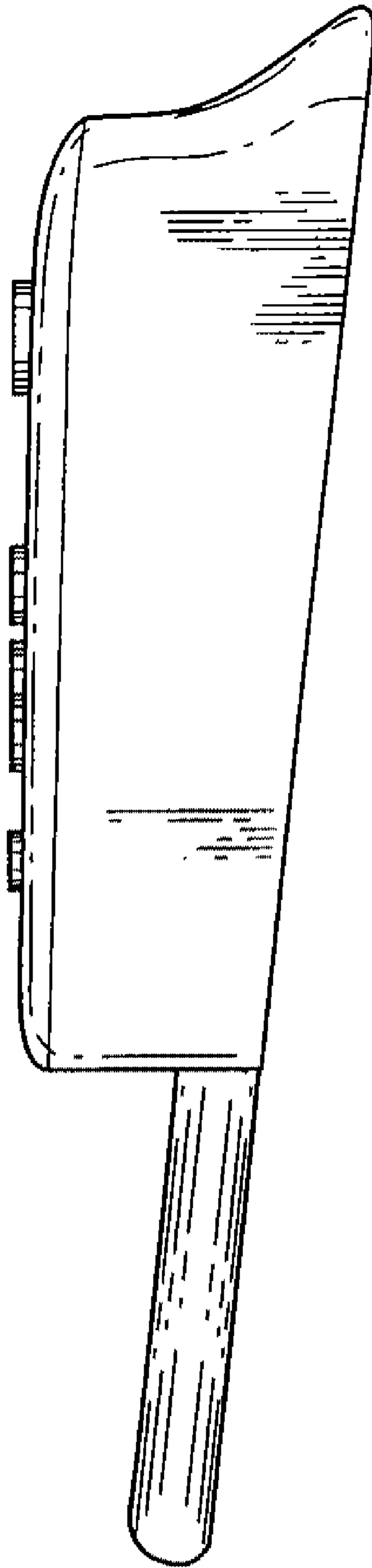




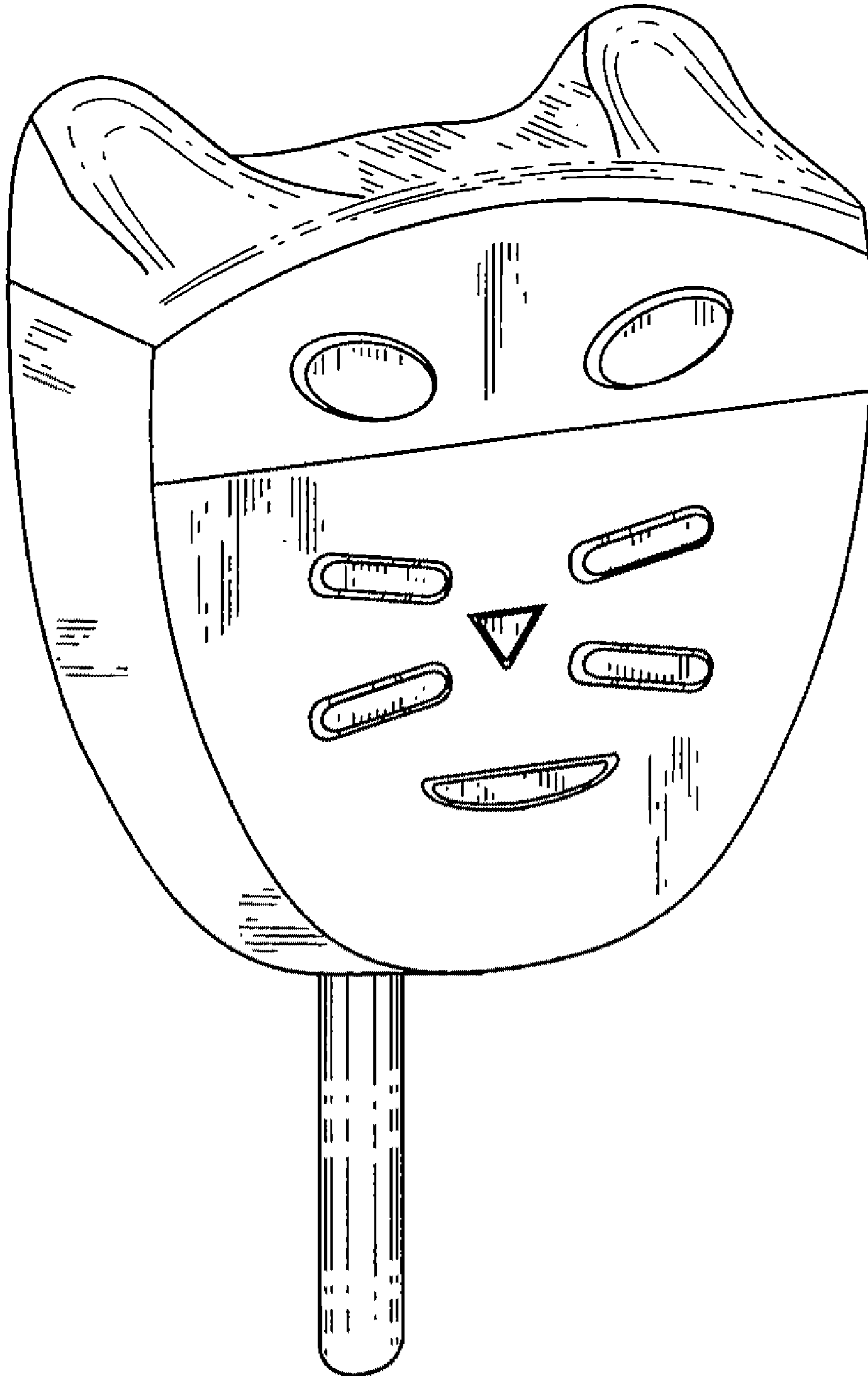

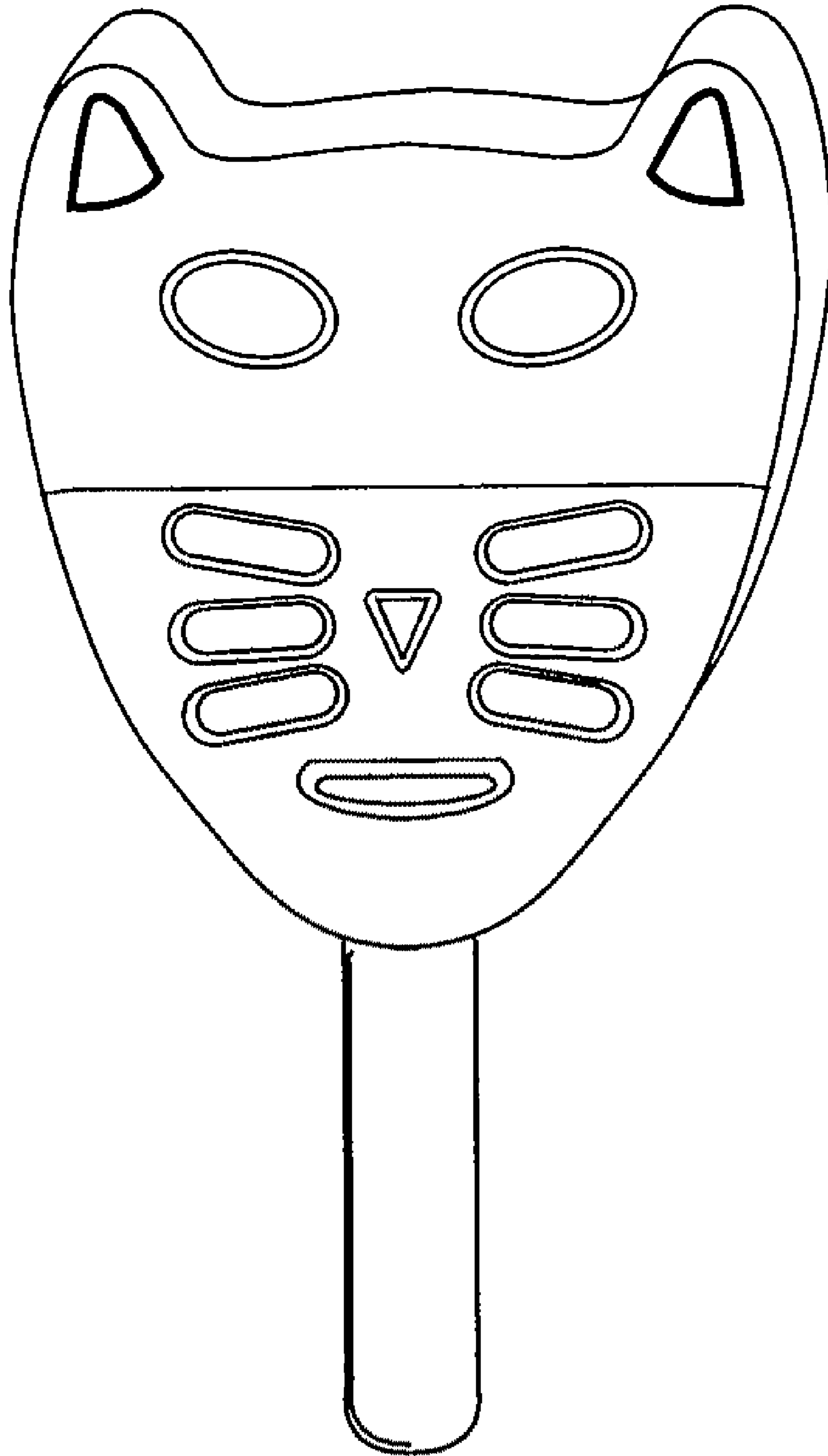
