FIG. 1 is a front view;

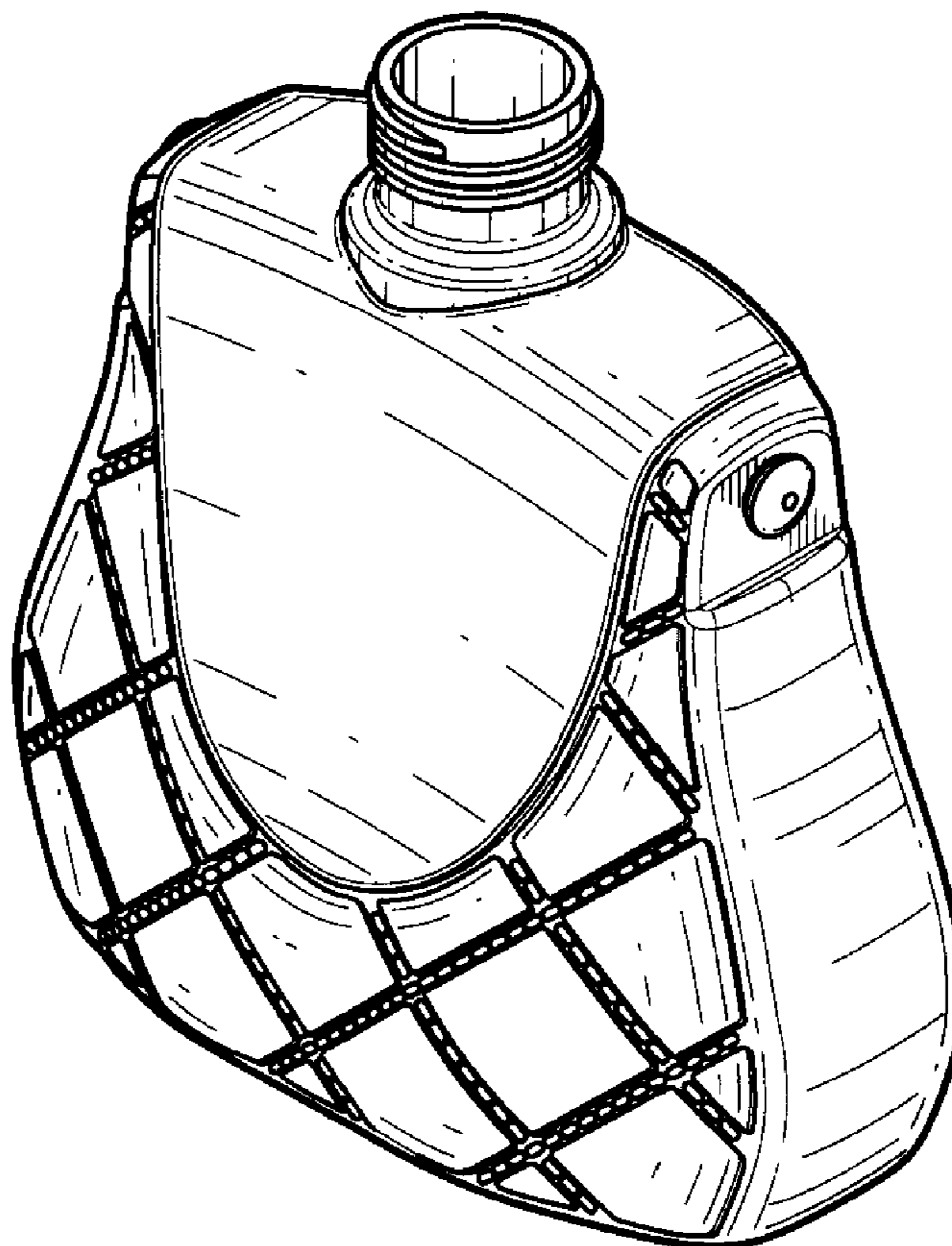
FIG. 2 is a bottom view;

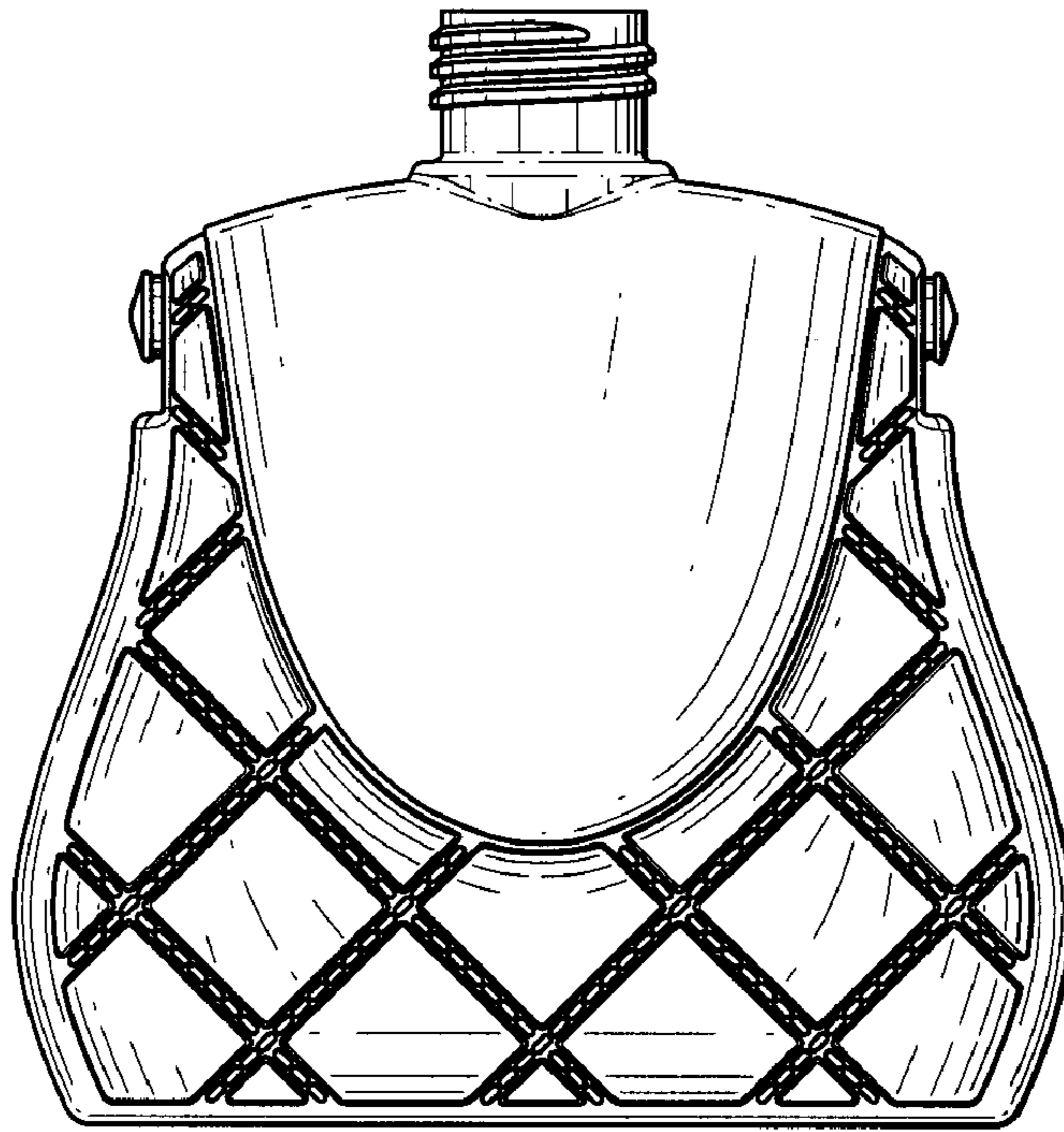

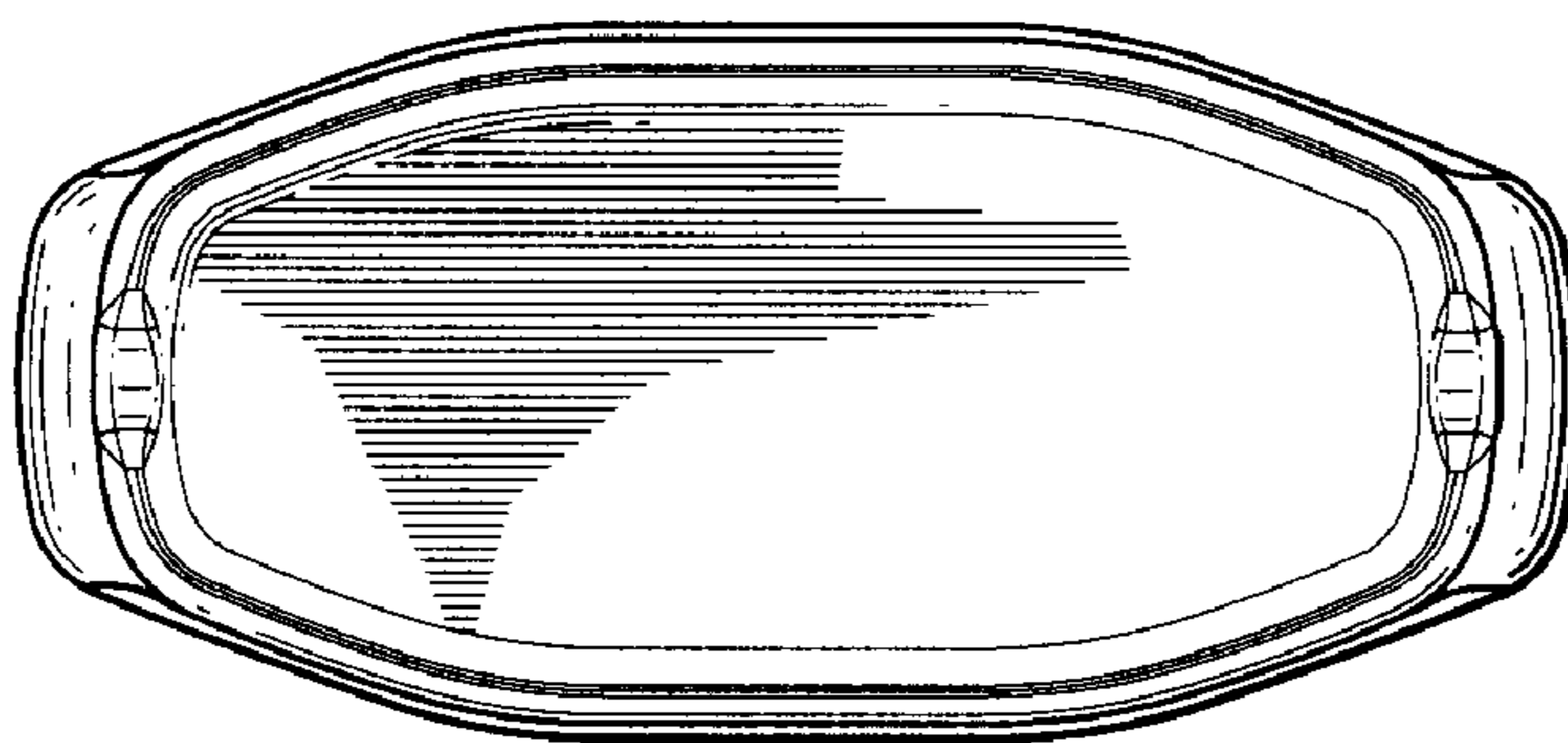

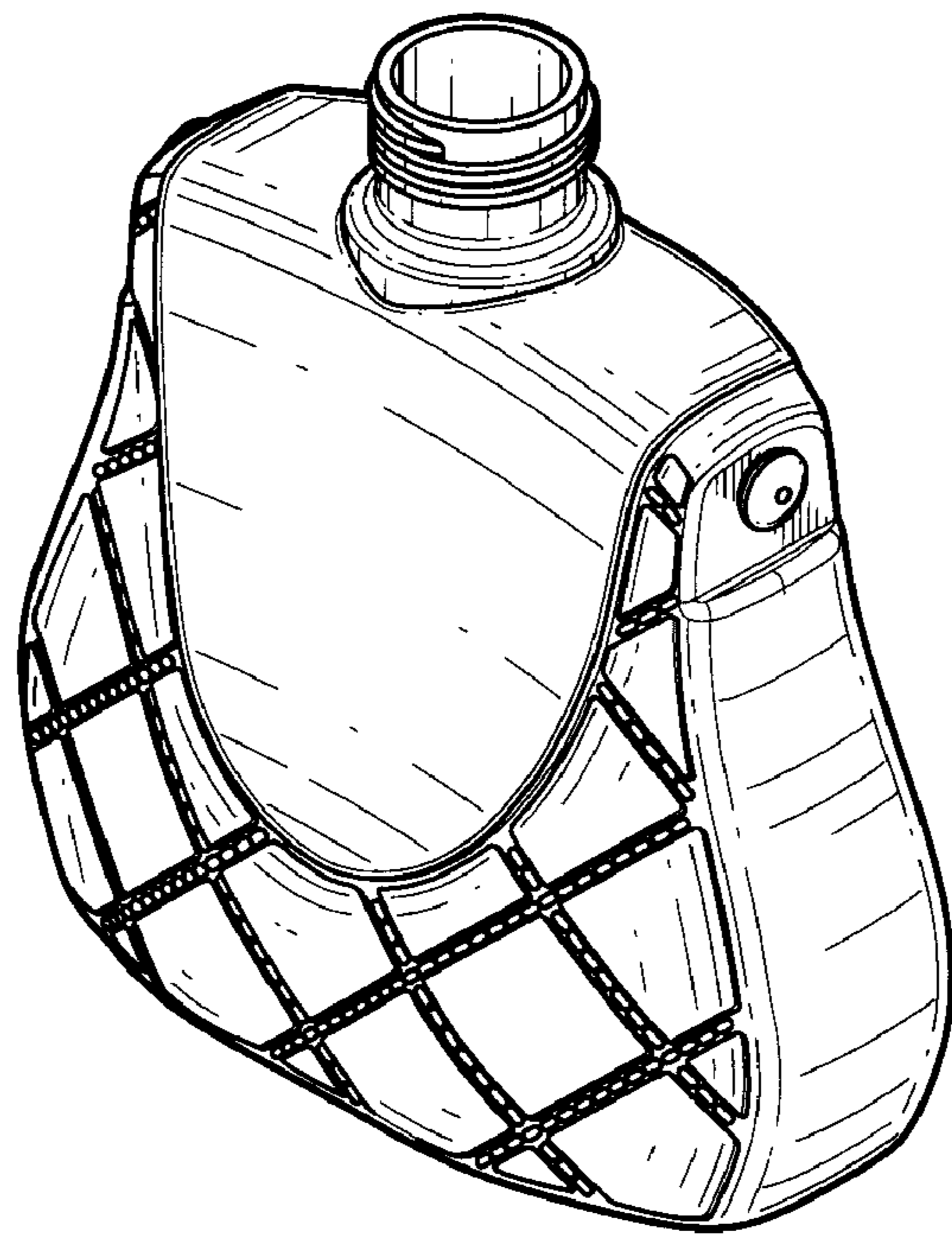

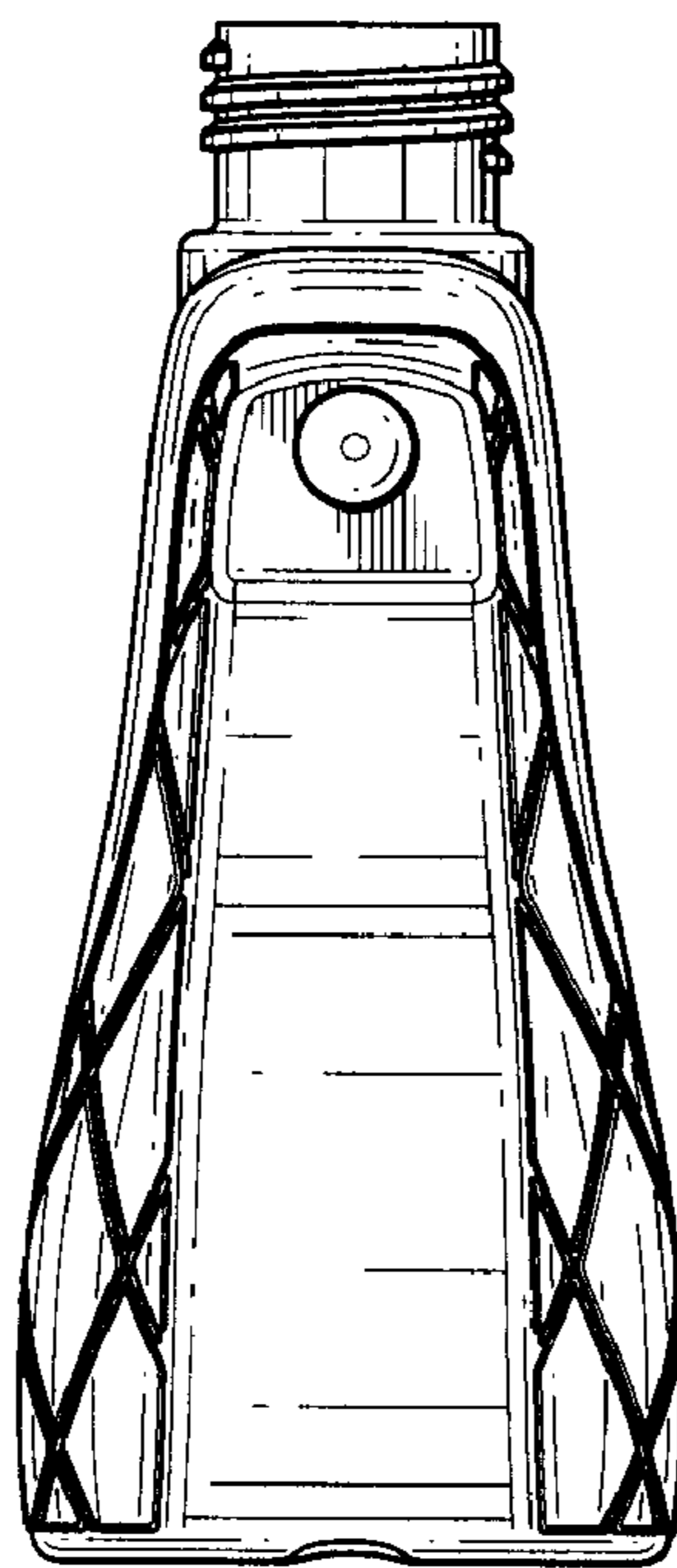
