FIG. 5 is a bottom elevation view of the packaging.

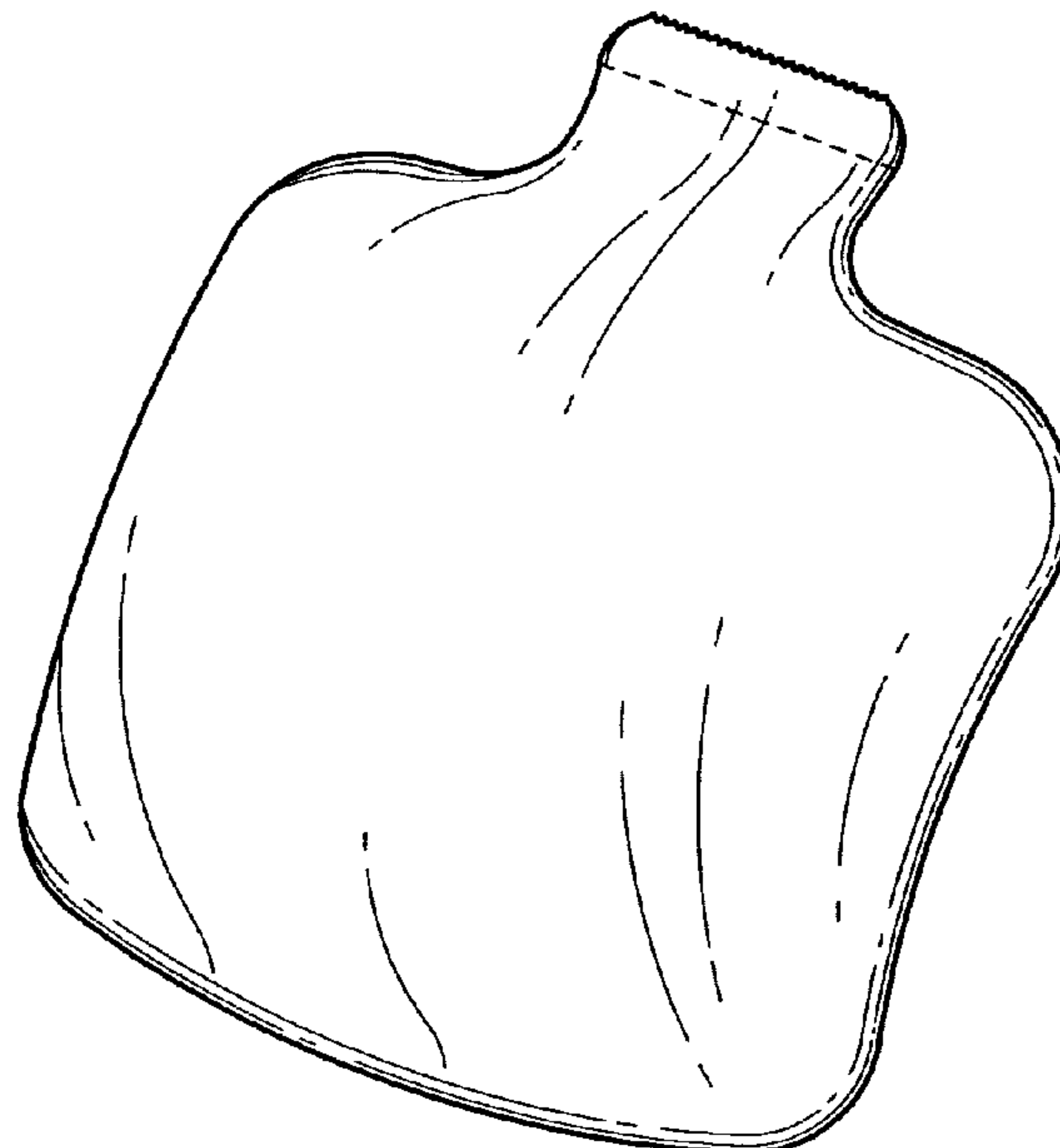
FIG. 6 is a side elevation view of the packaging.

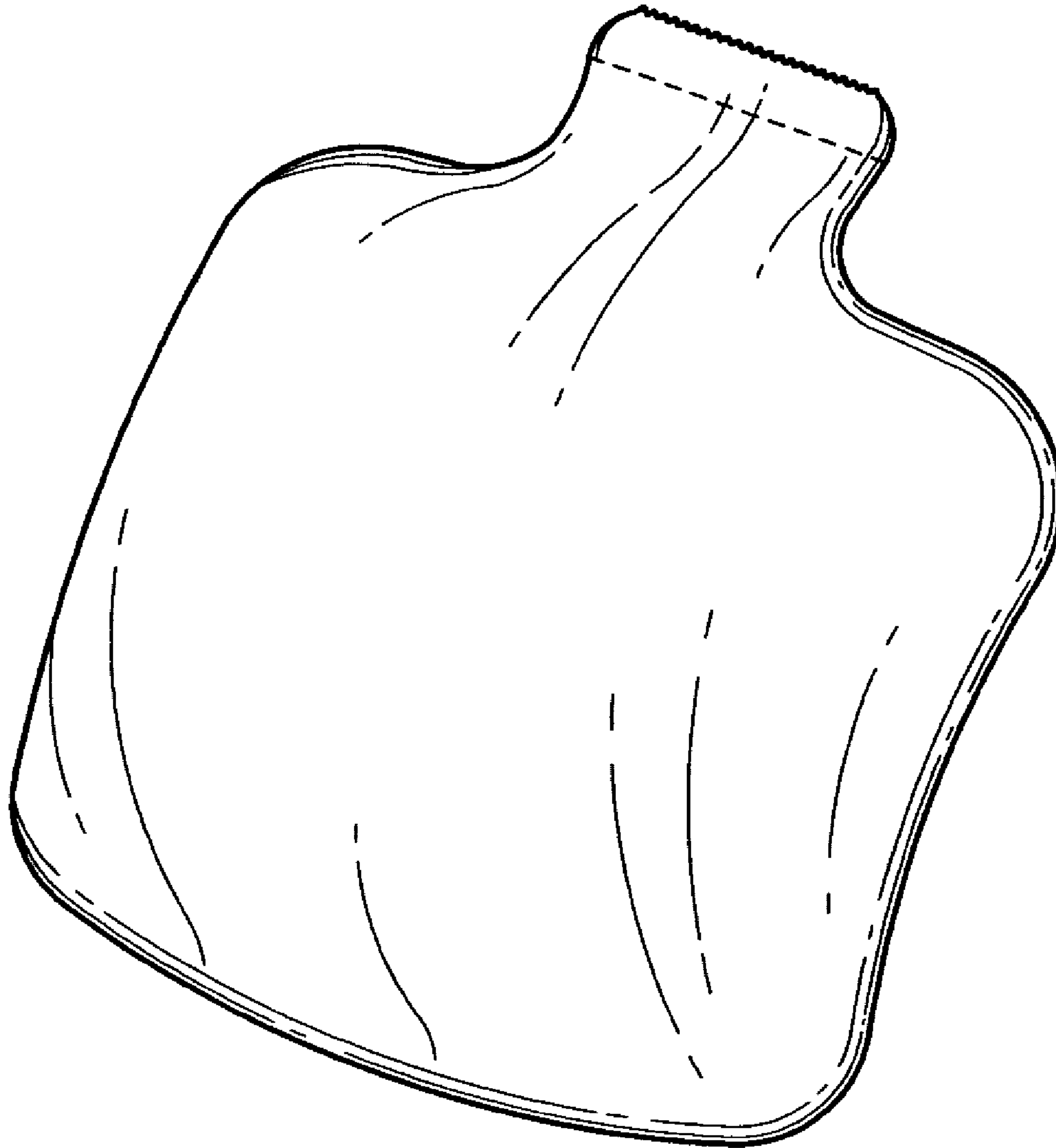

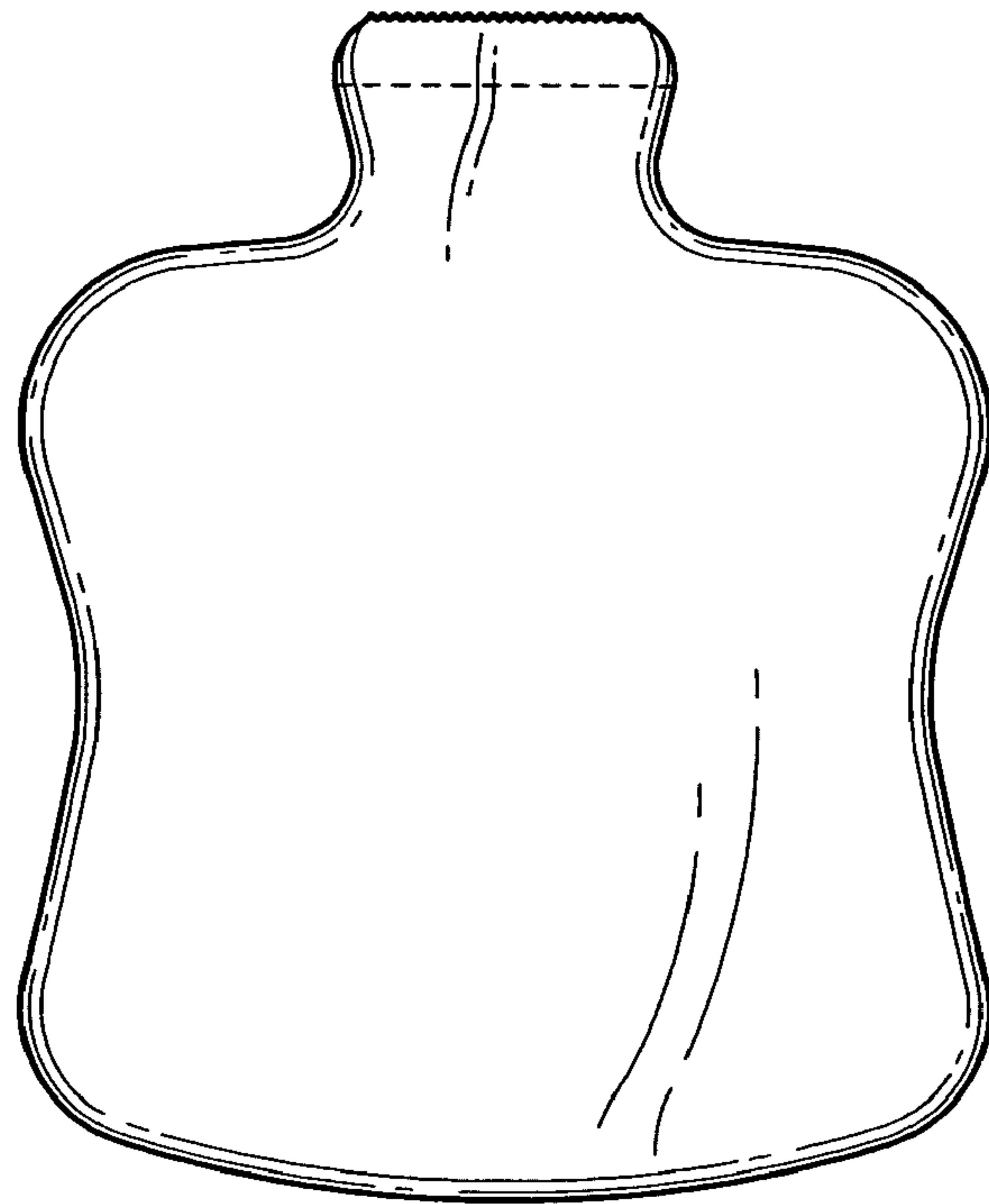

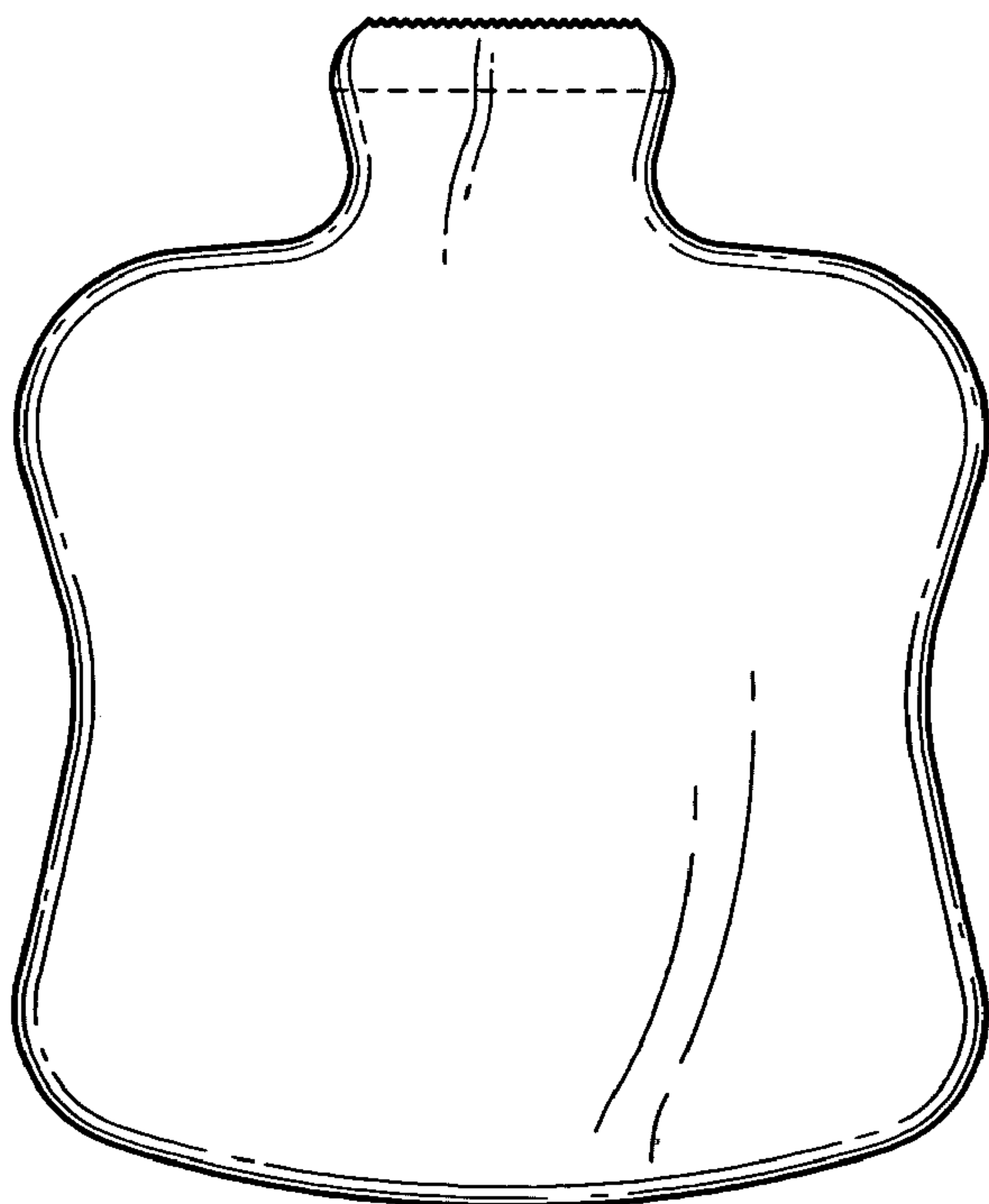

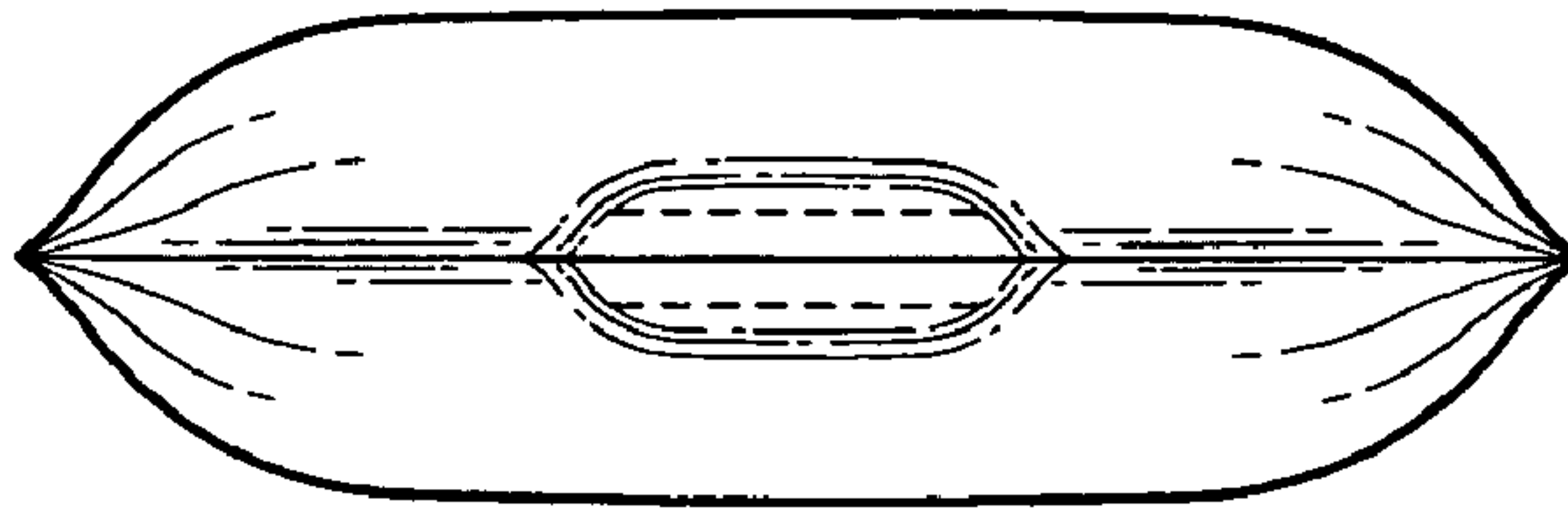

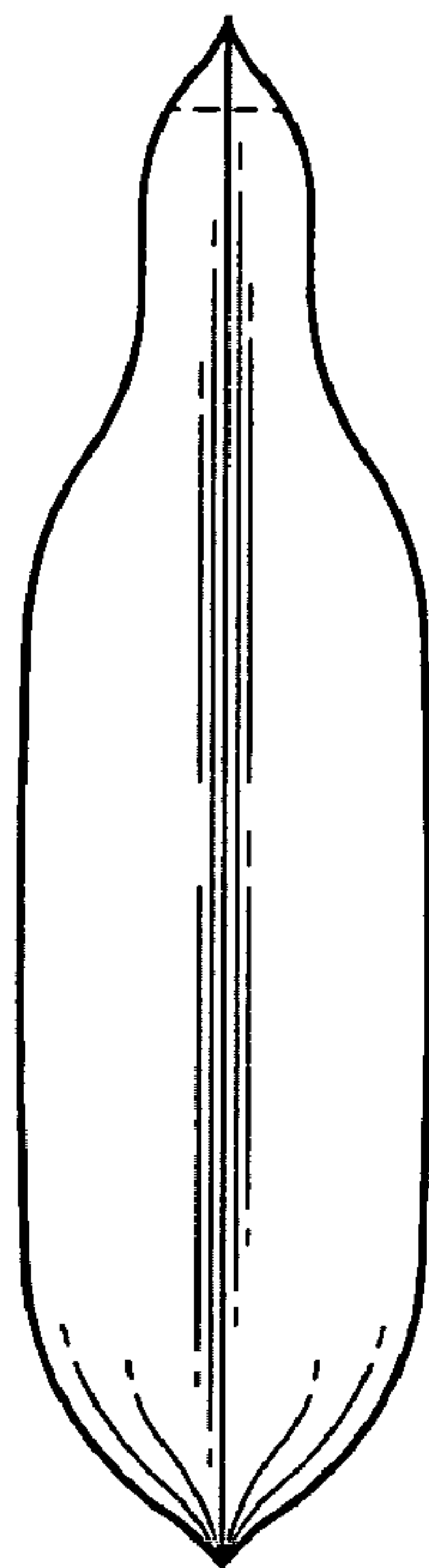
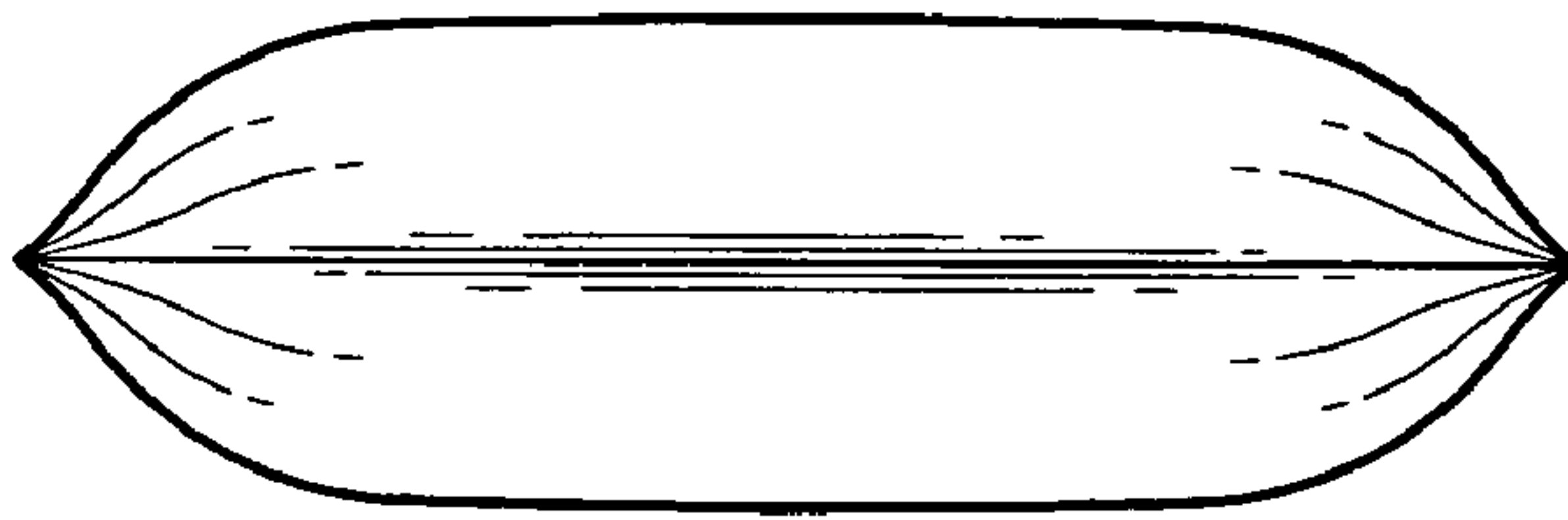

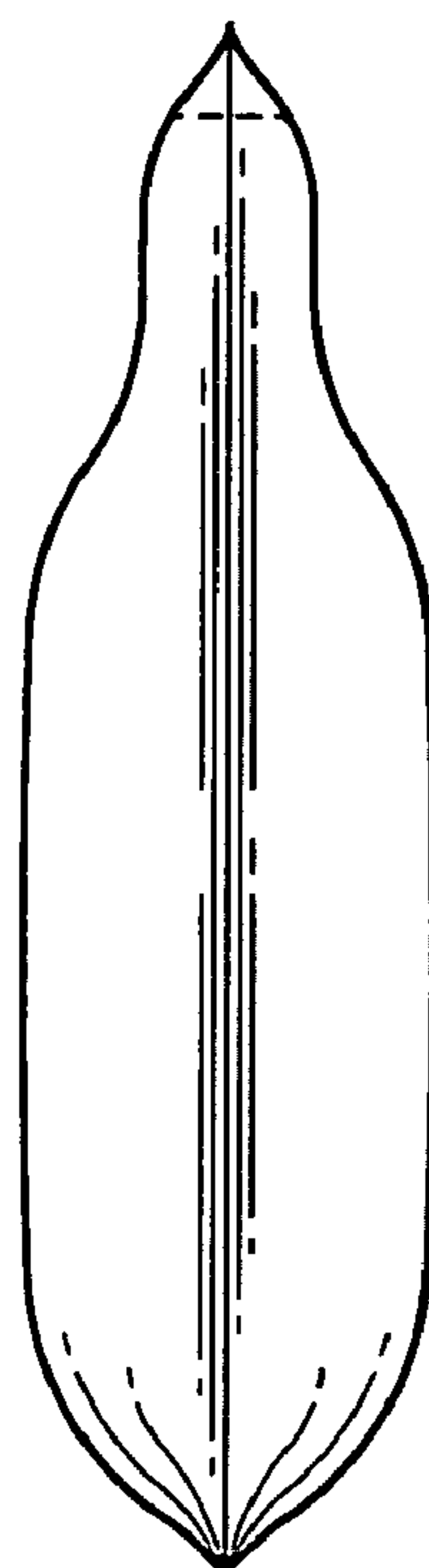

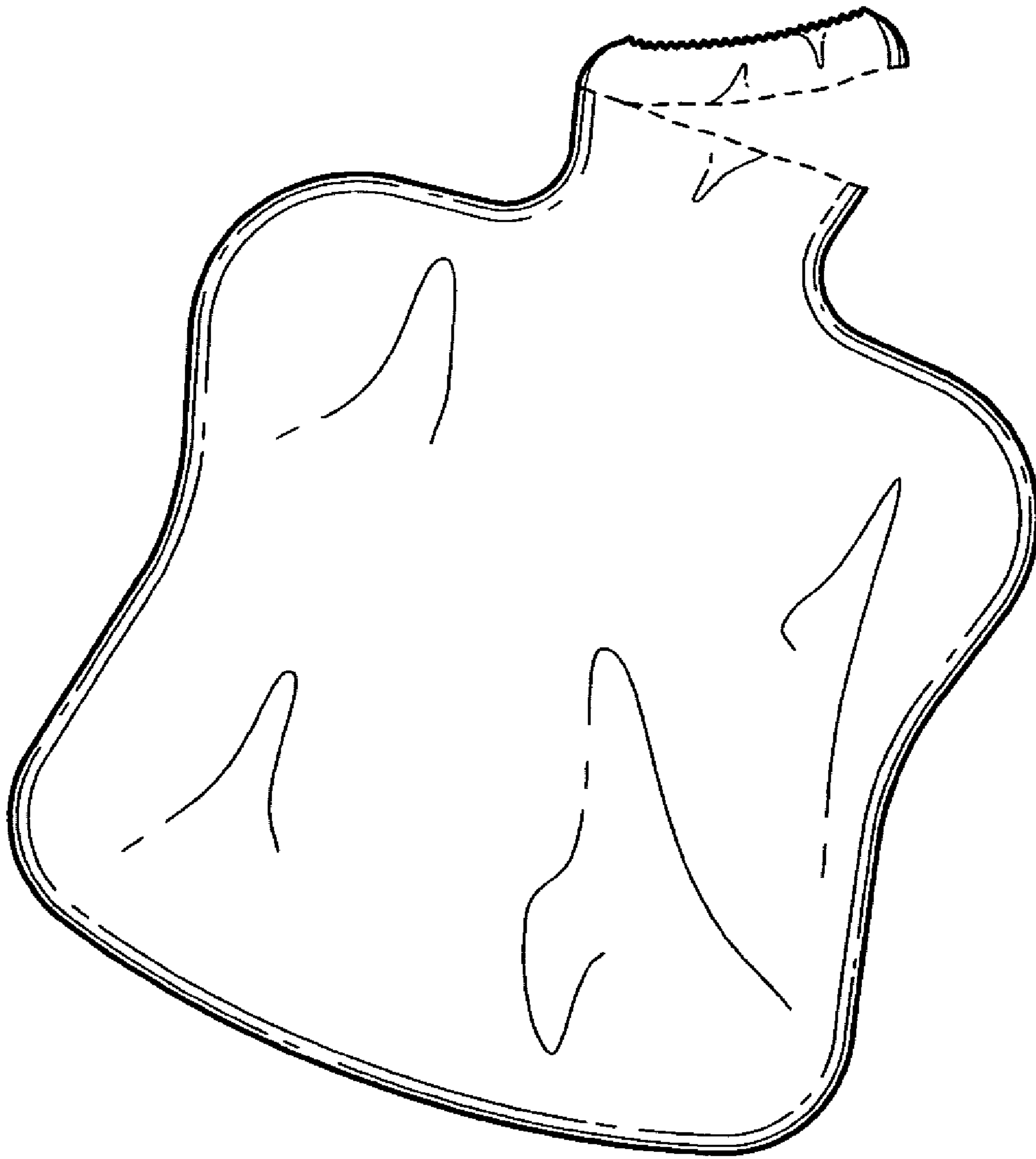
