(57) **CLAIM**

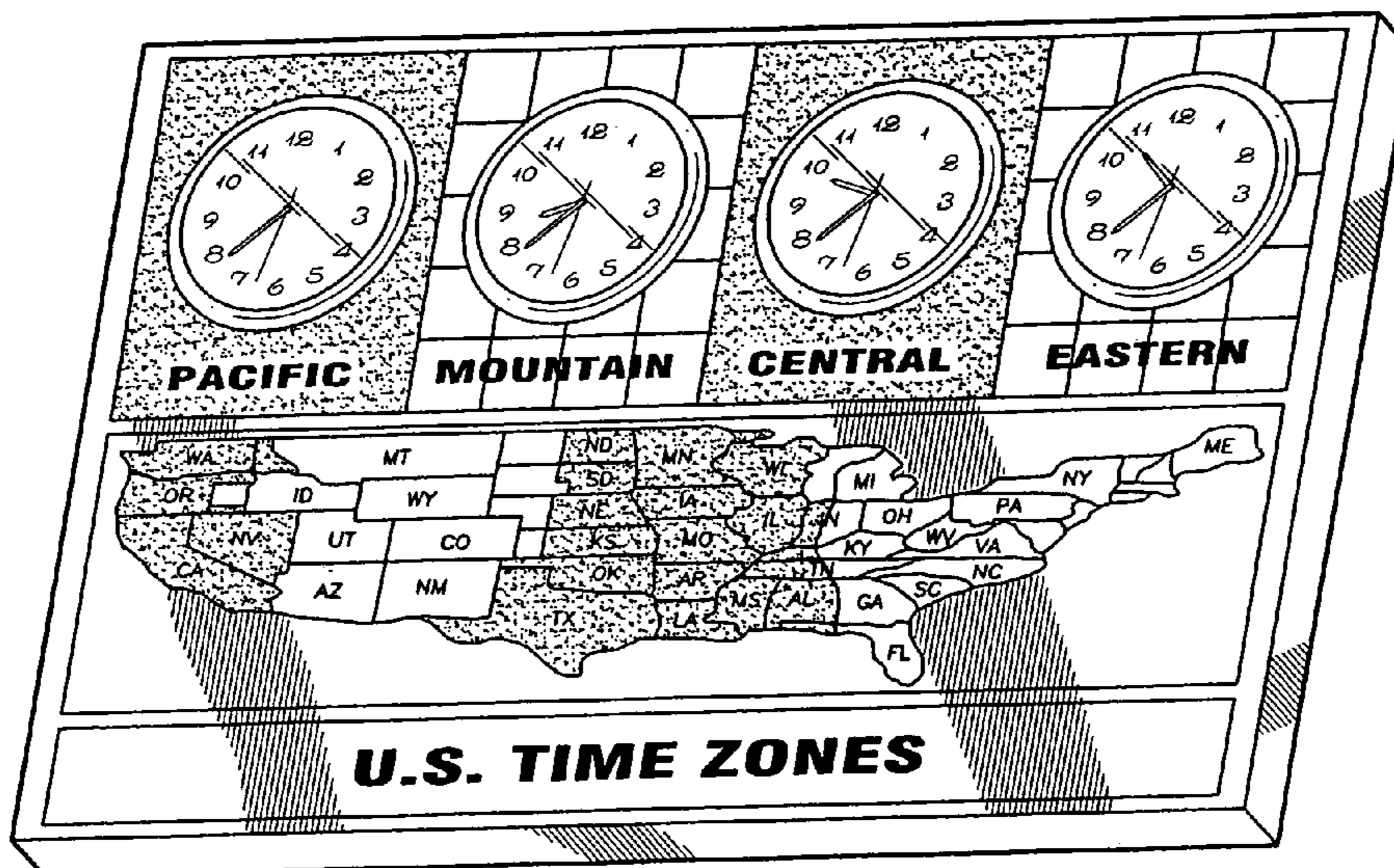
The ornamental design for a clock, as shown and described.

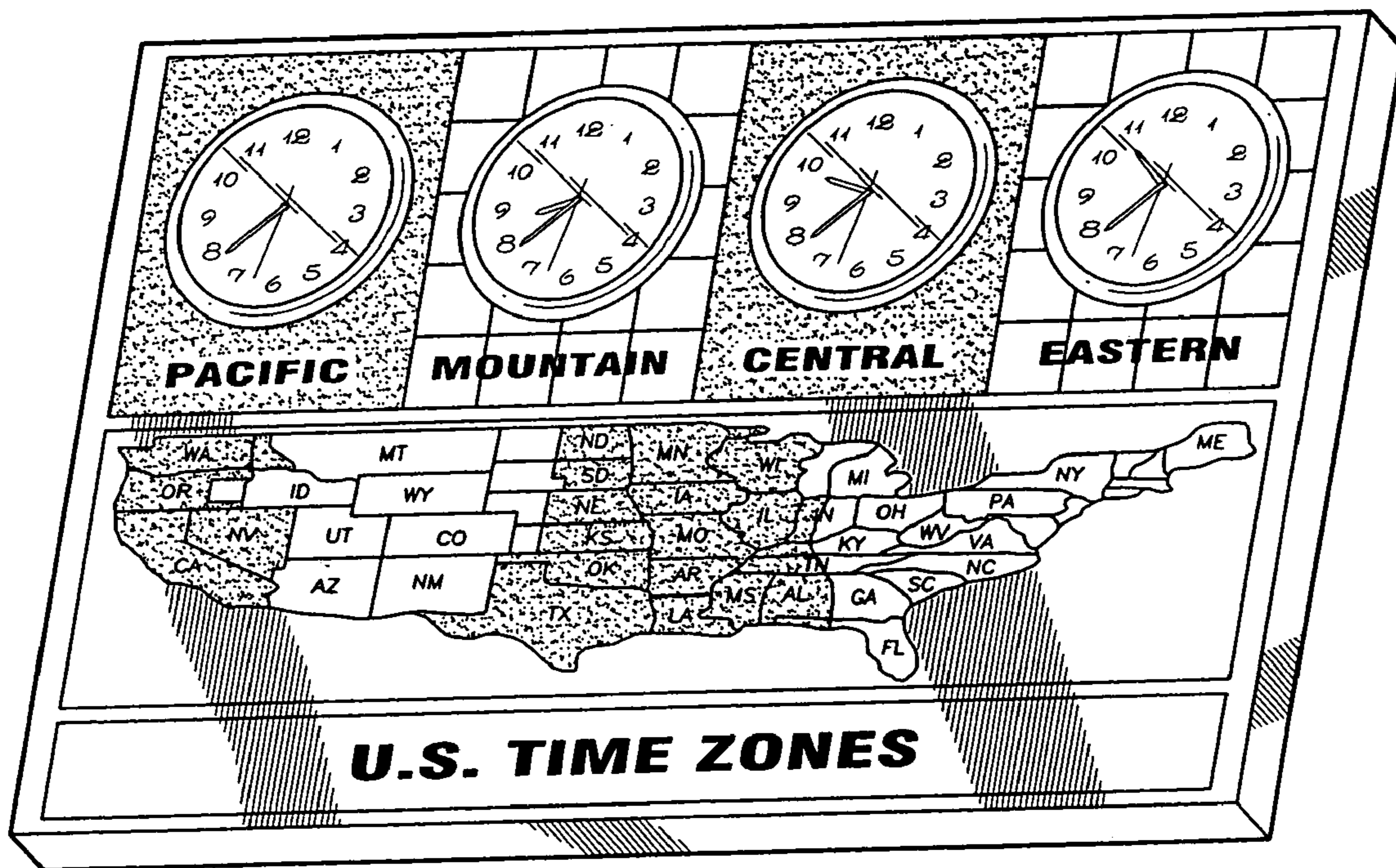

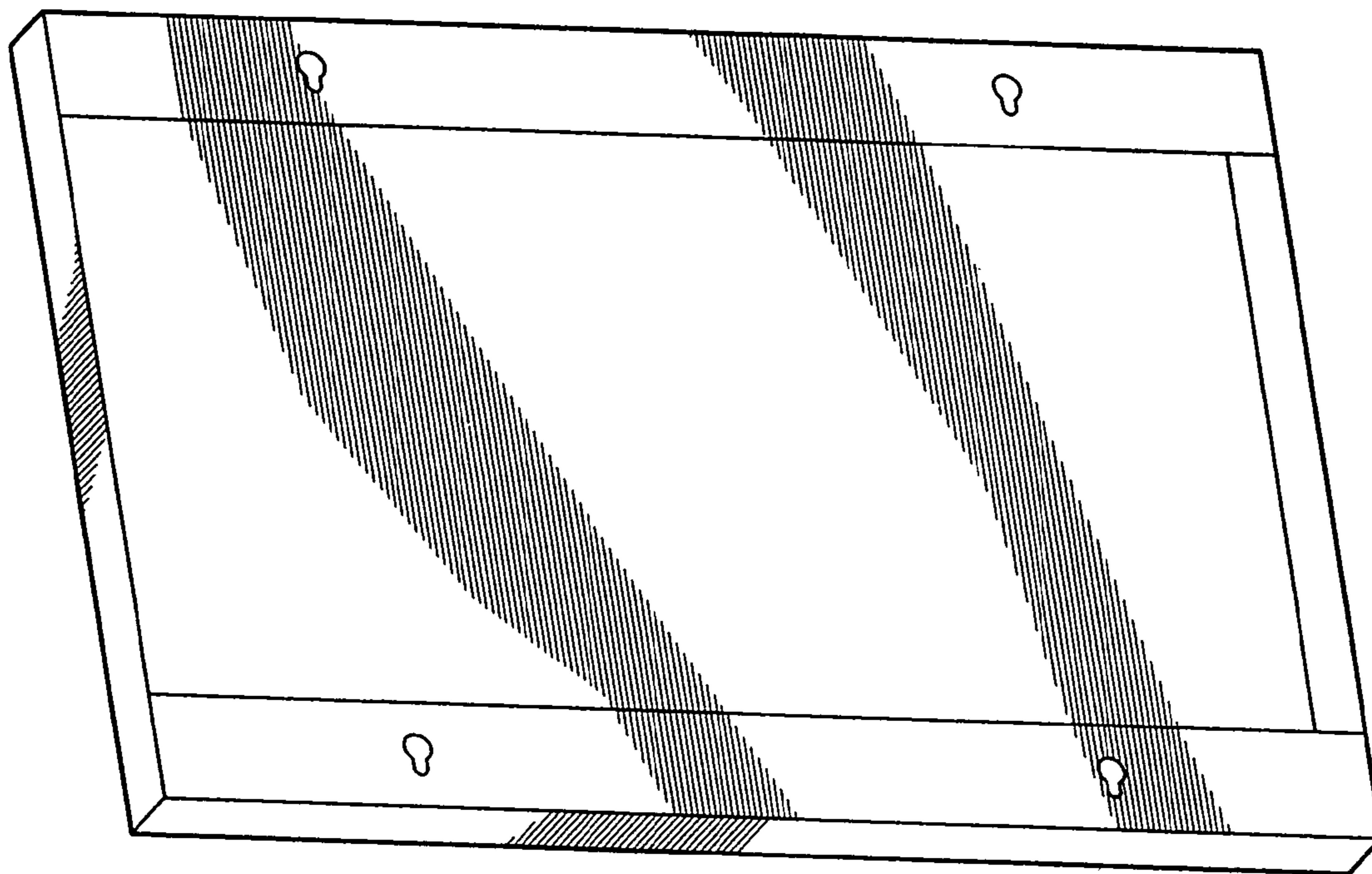
