The ornamental design for a wristwatch, as shown.

DESCRIPTION

FIG. 1 is a front and right side perspective view of a wristwatch showing my new design;

FIG. 2 is a front elevational view thereof;

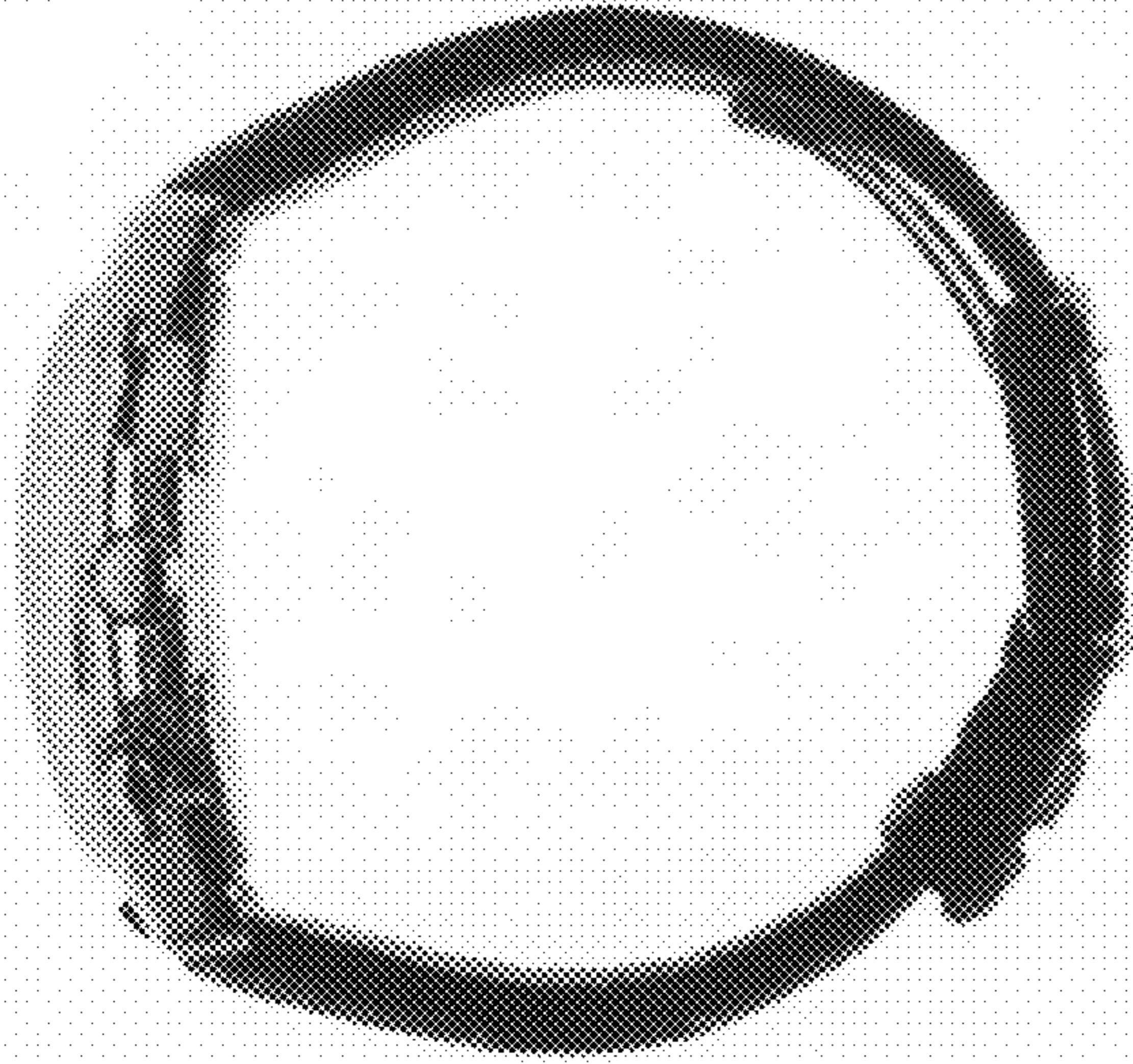

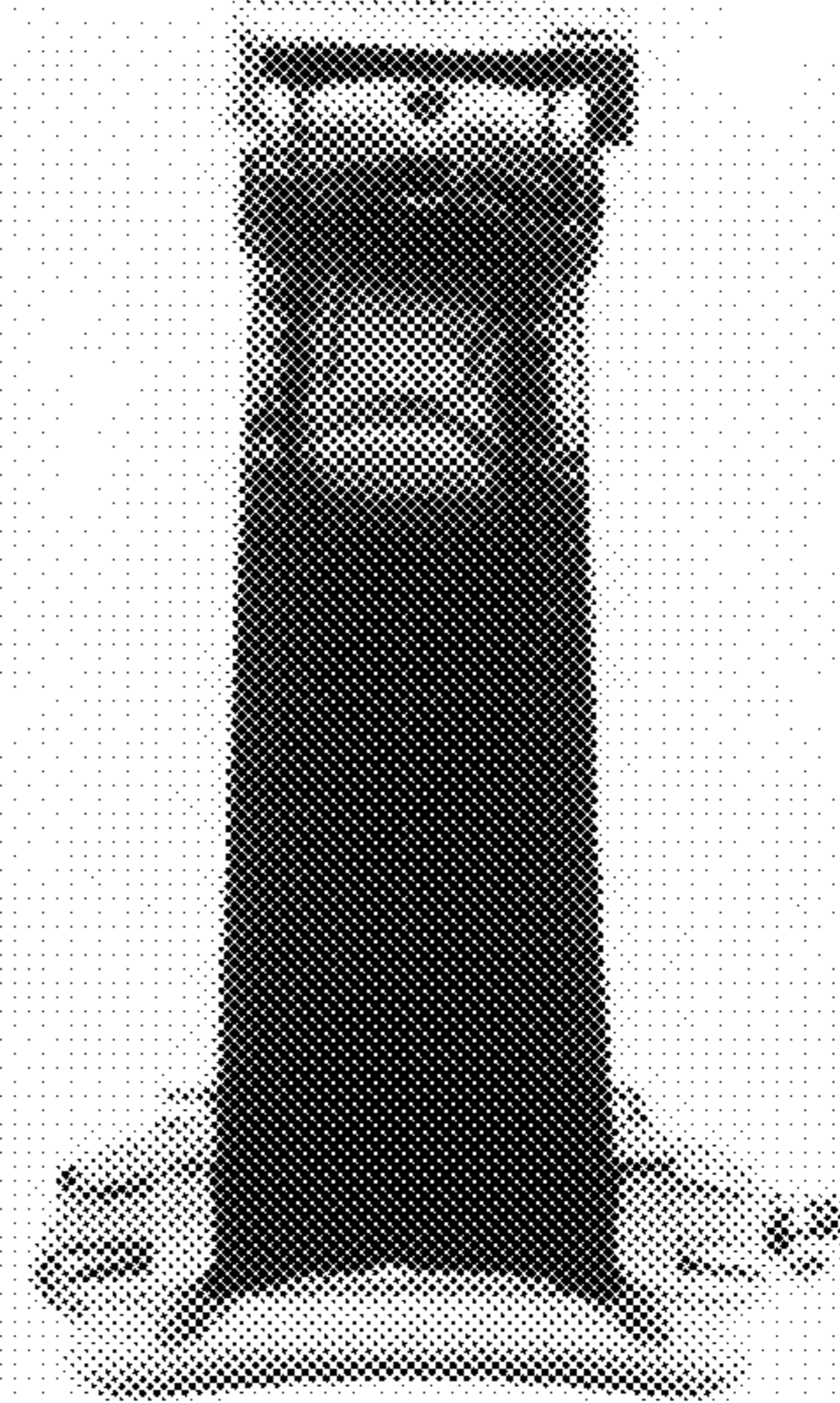

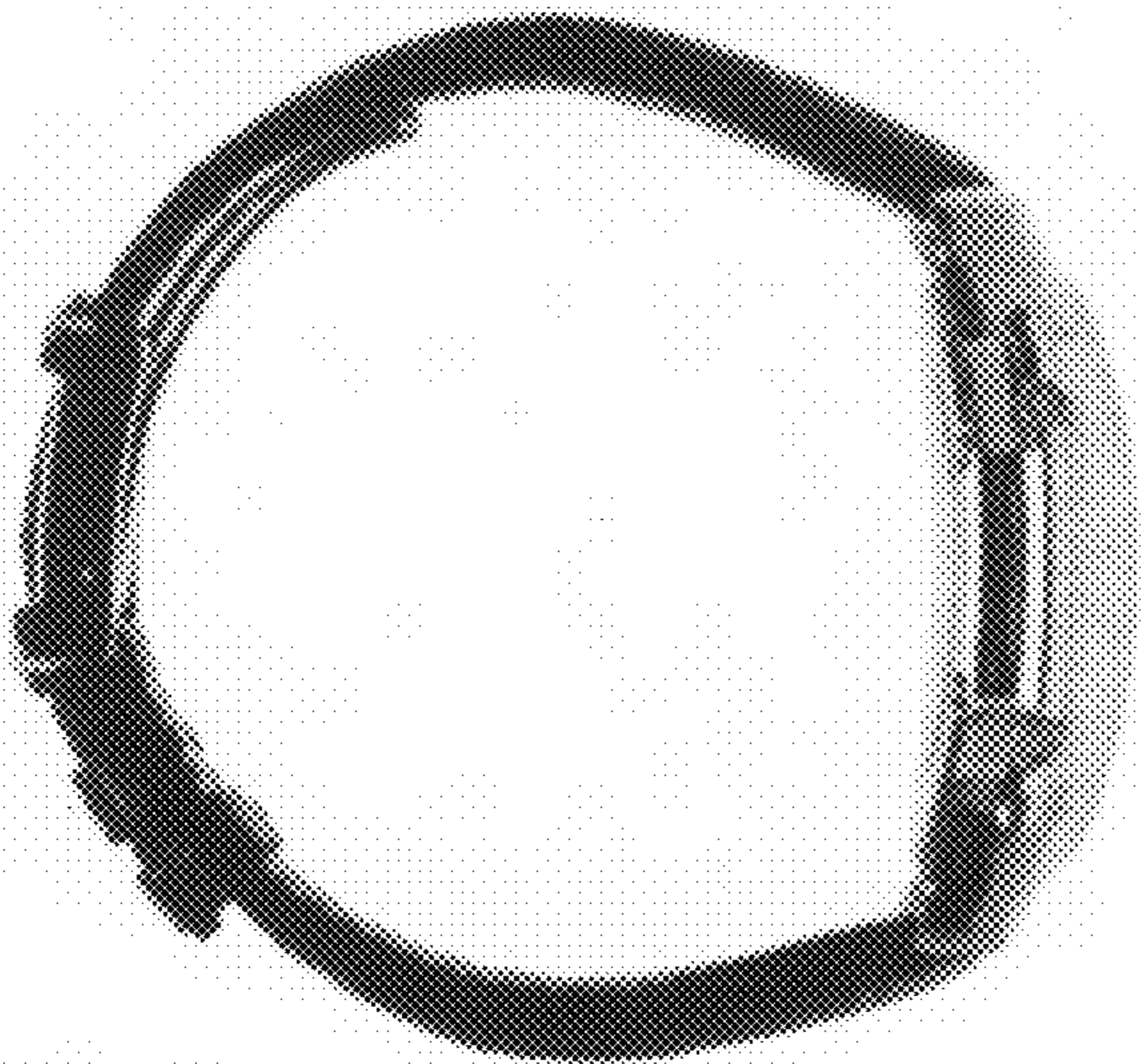

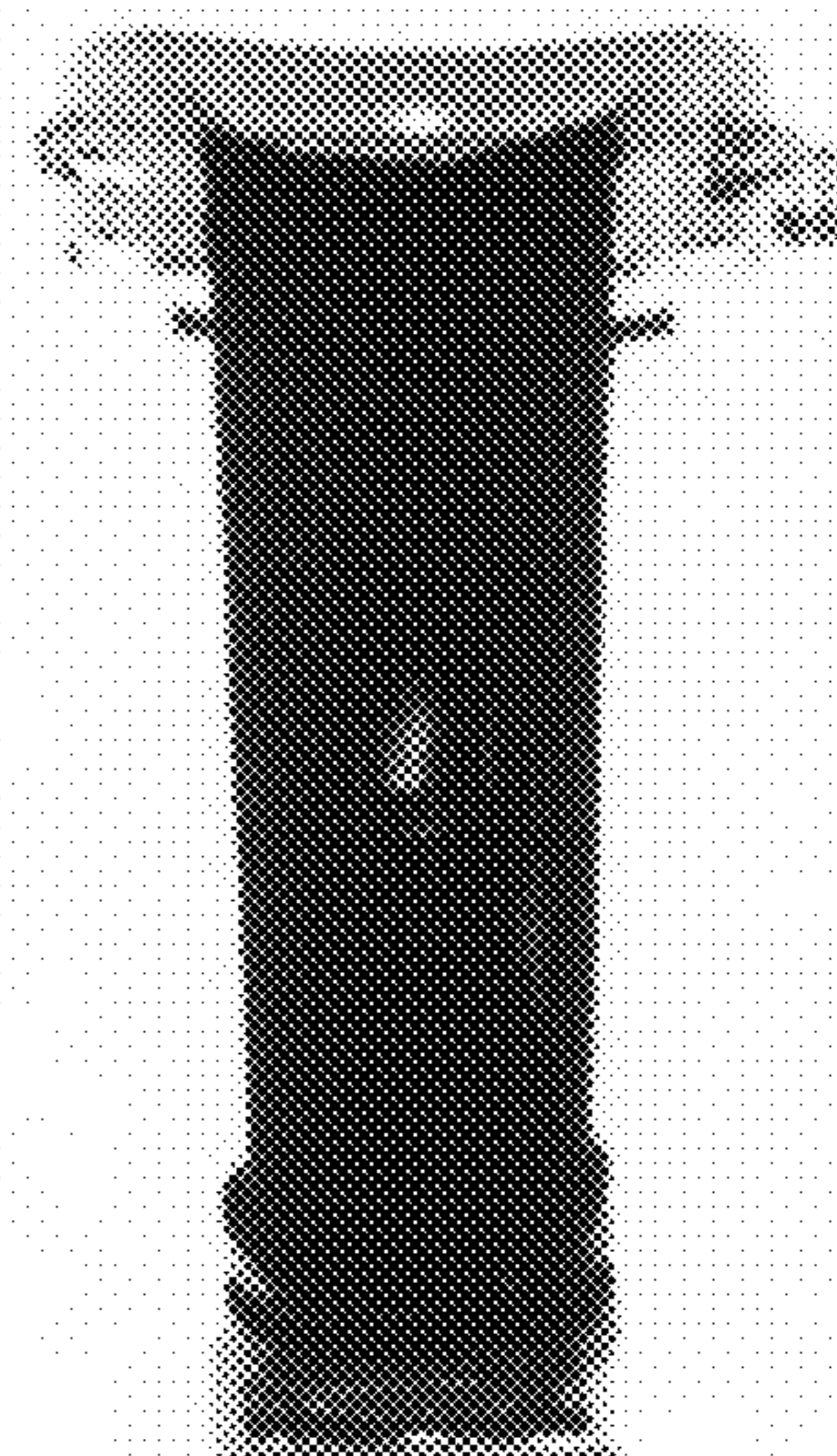
