FIG. 6 is a left side plan view of the Invention shown in FIG. 1;

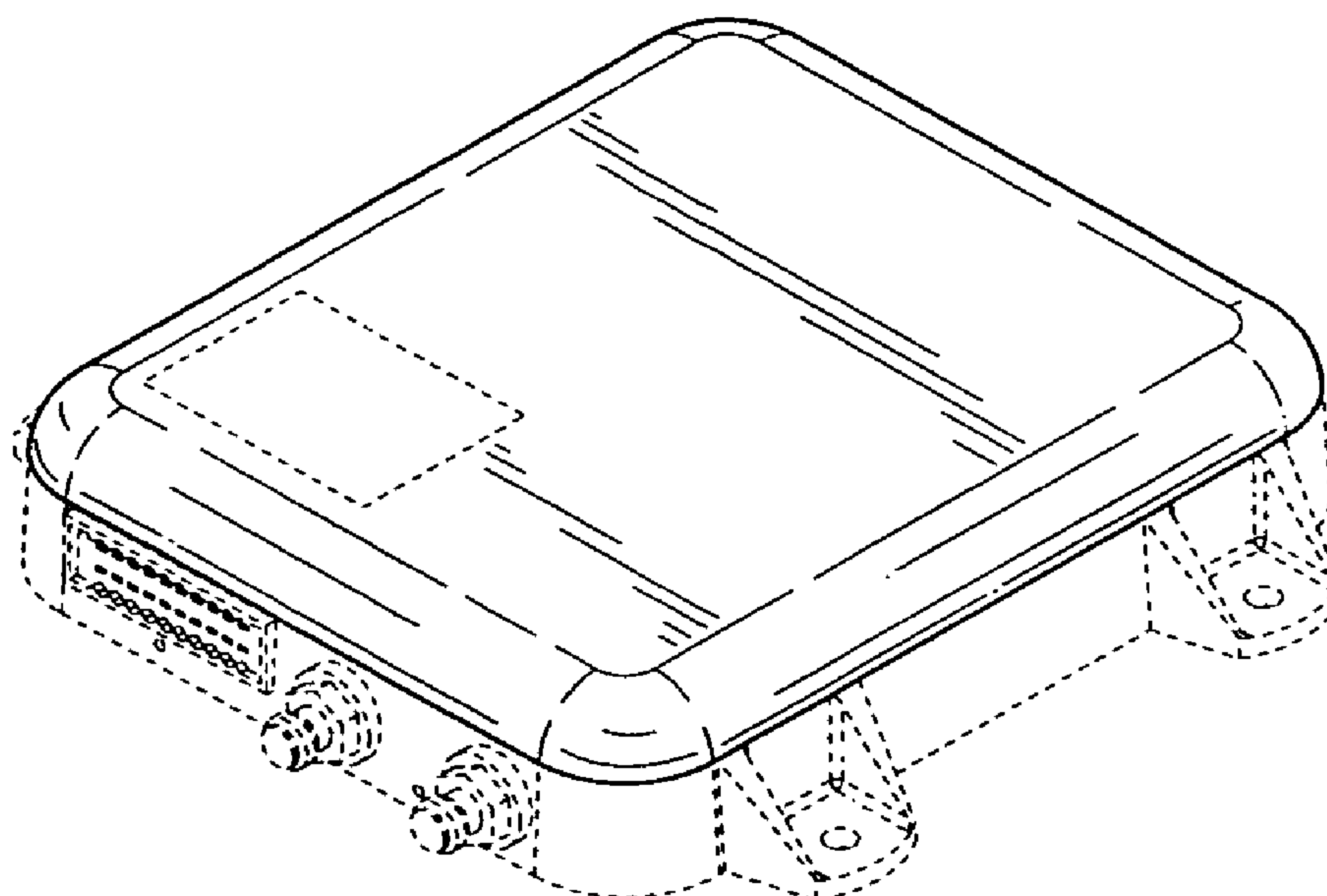
FIG. 7 is a top plan view of the Invention shown in FIG. 1; and,

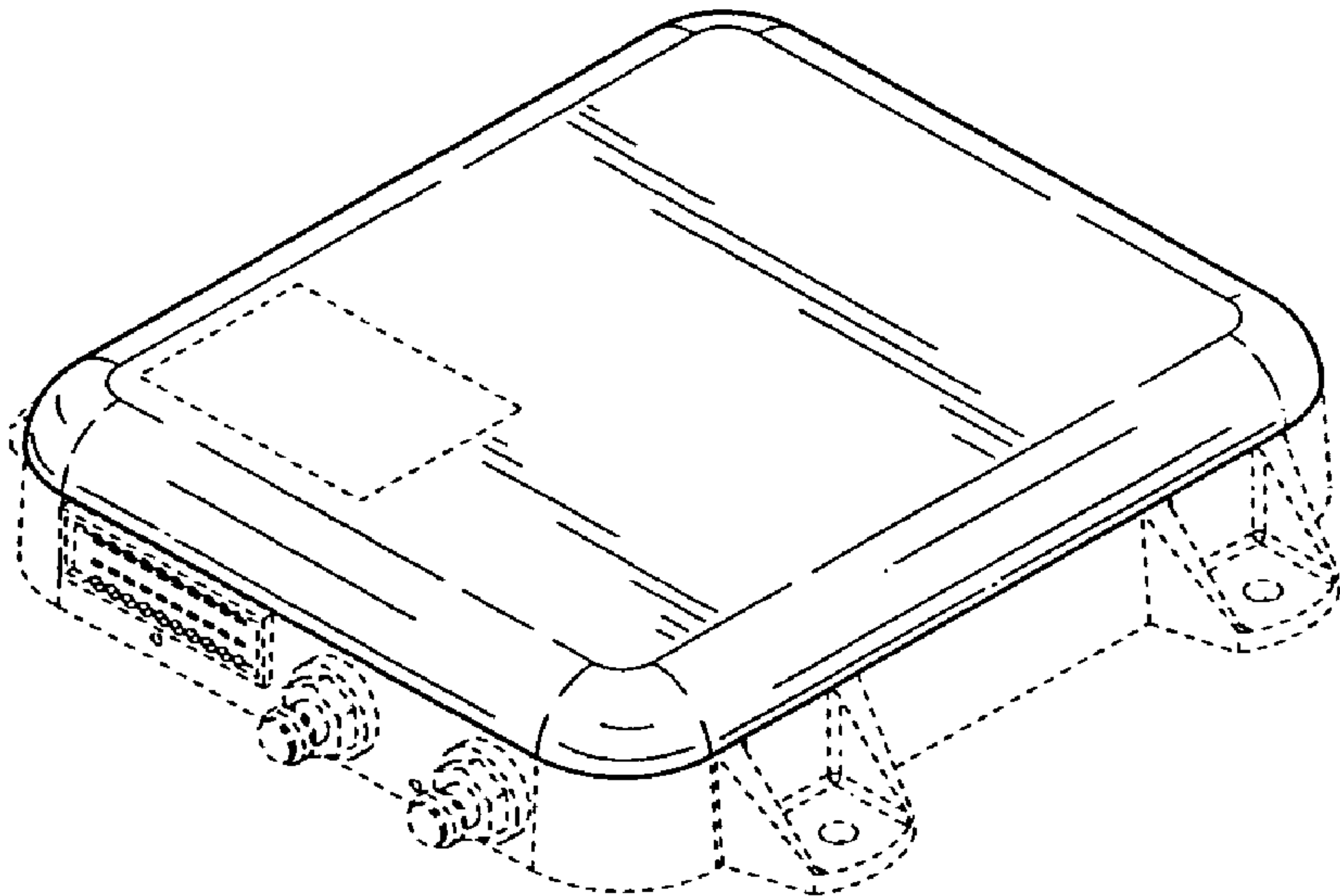

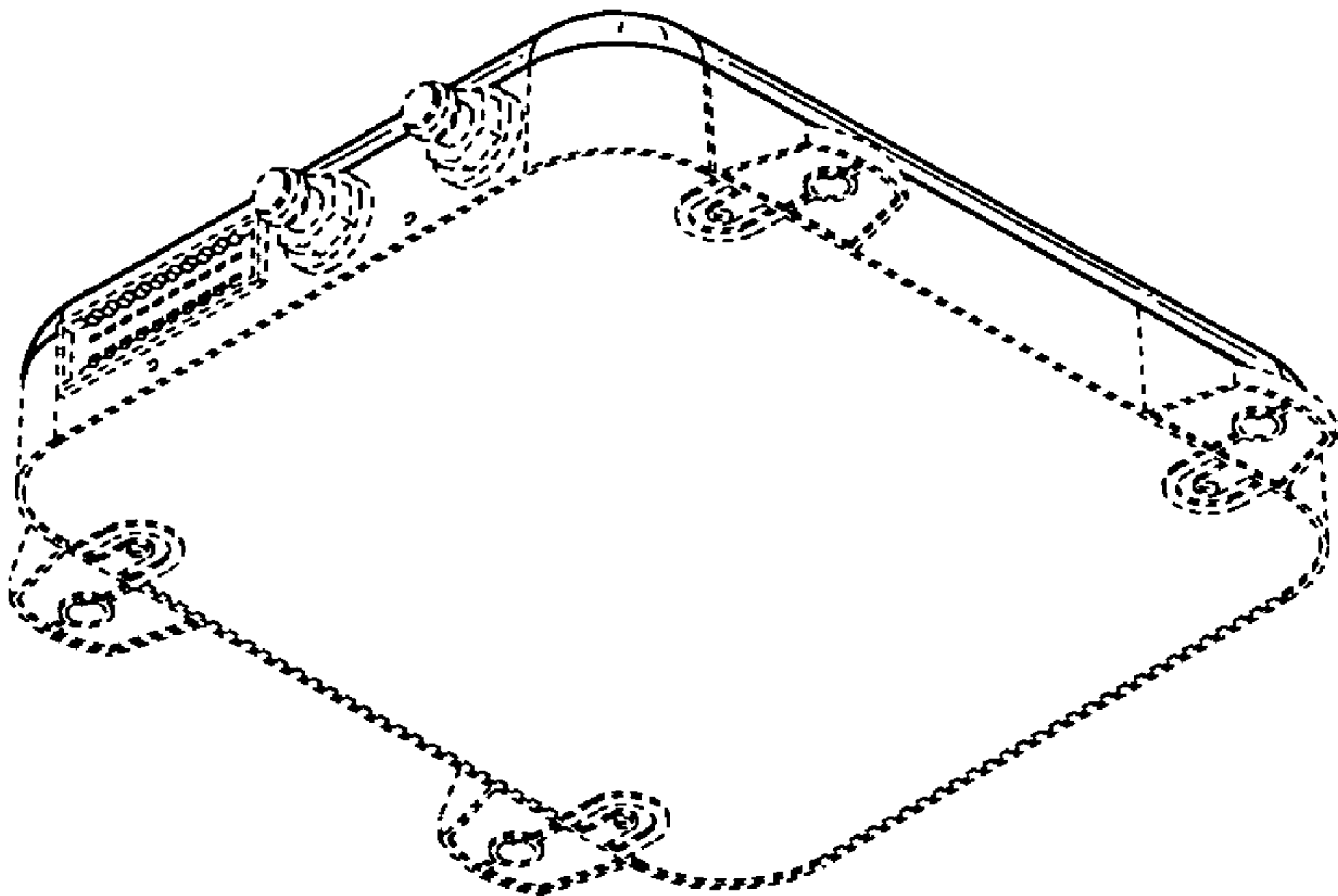

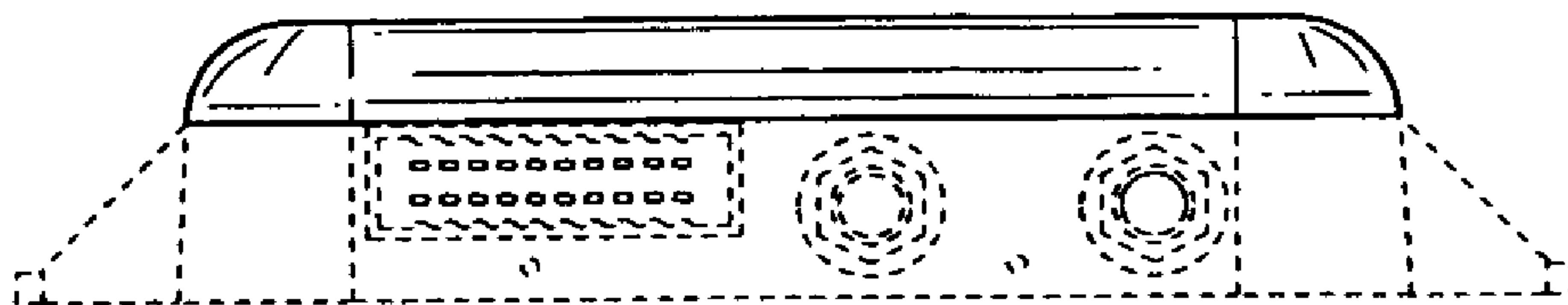

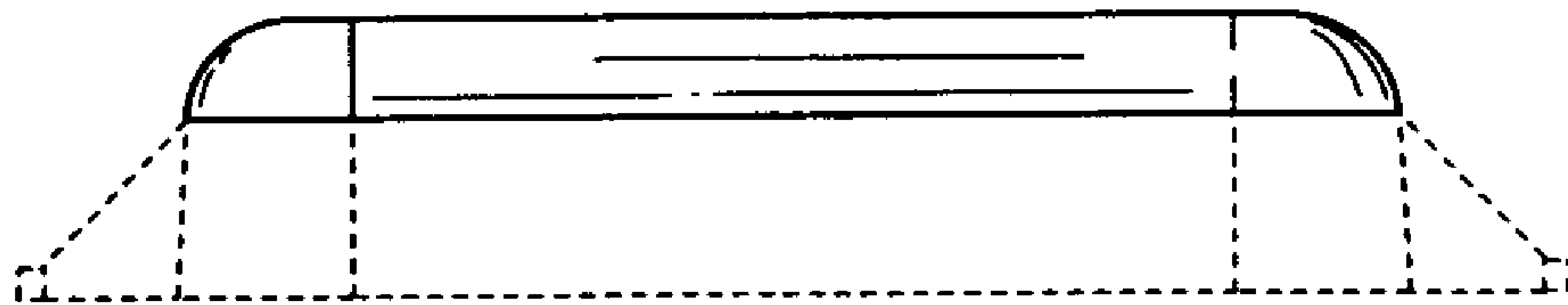

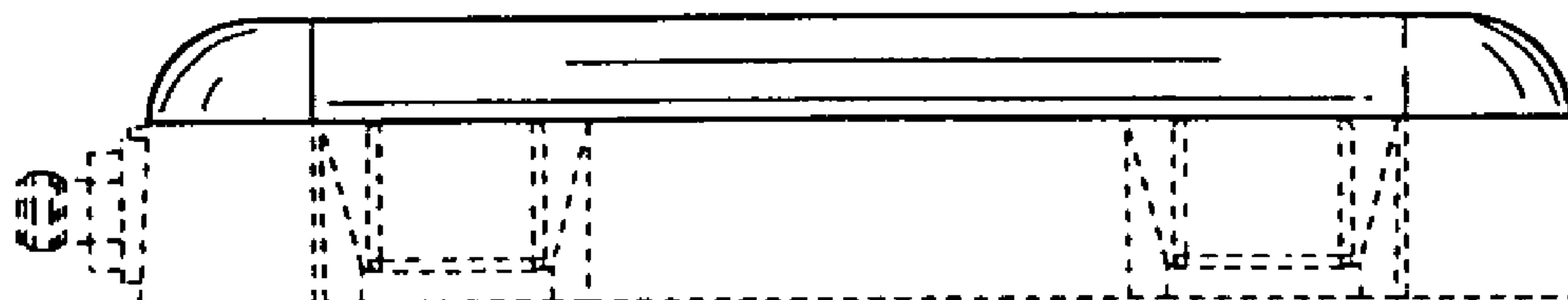

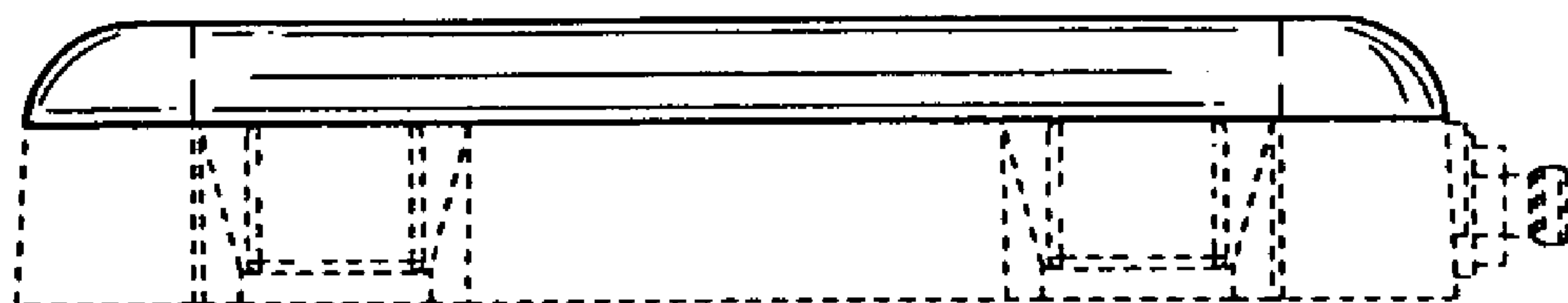

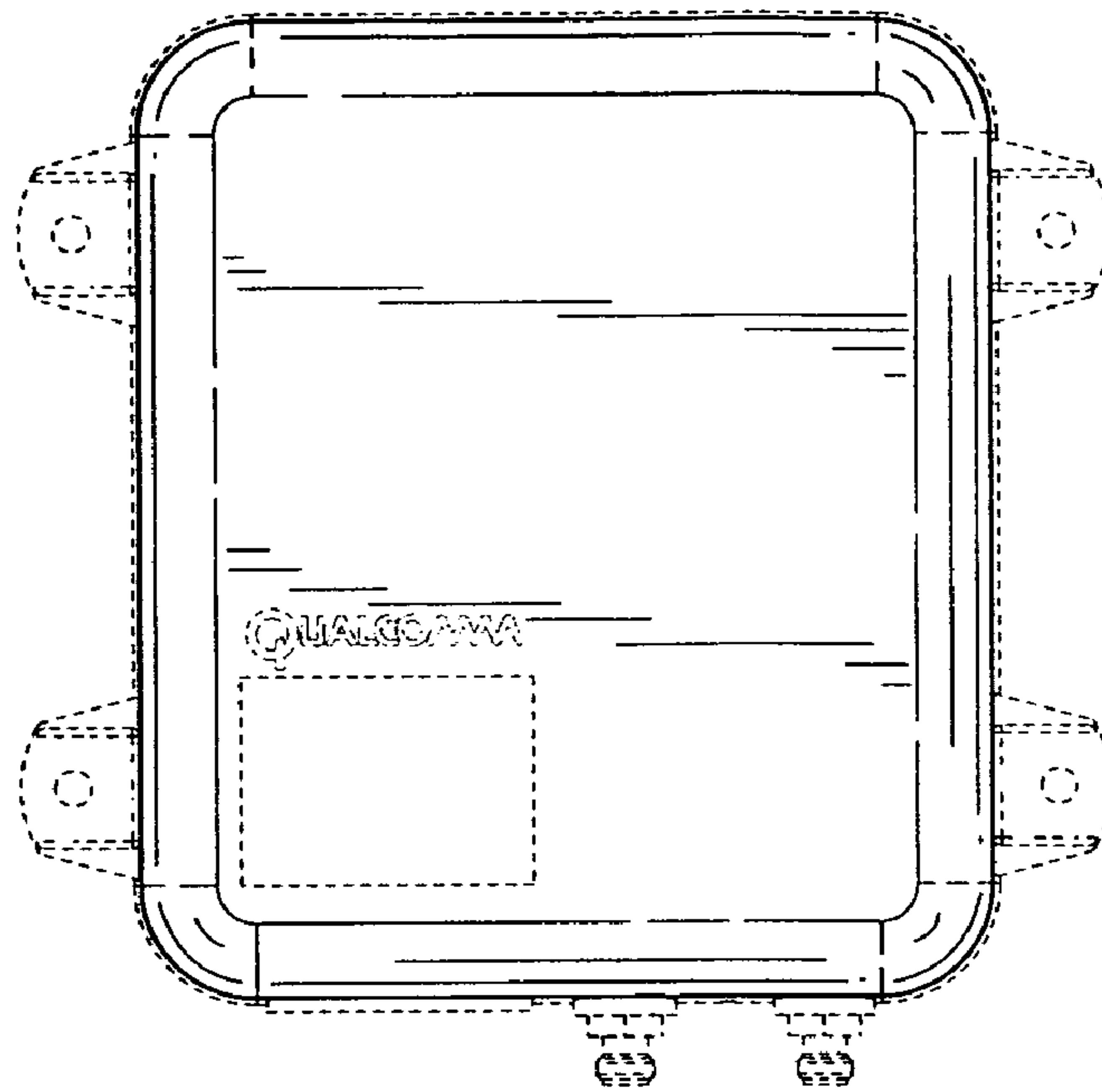

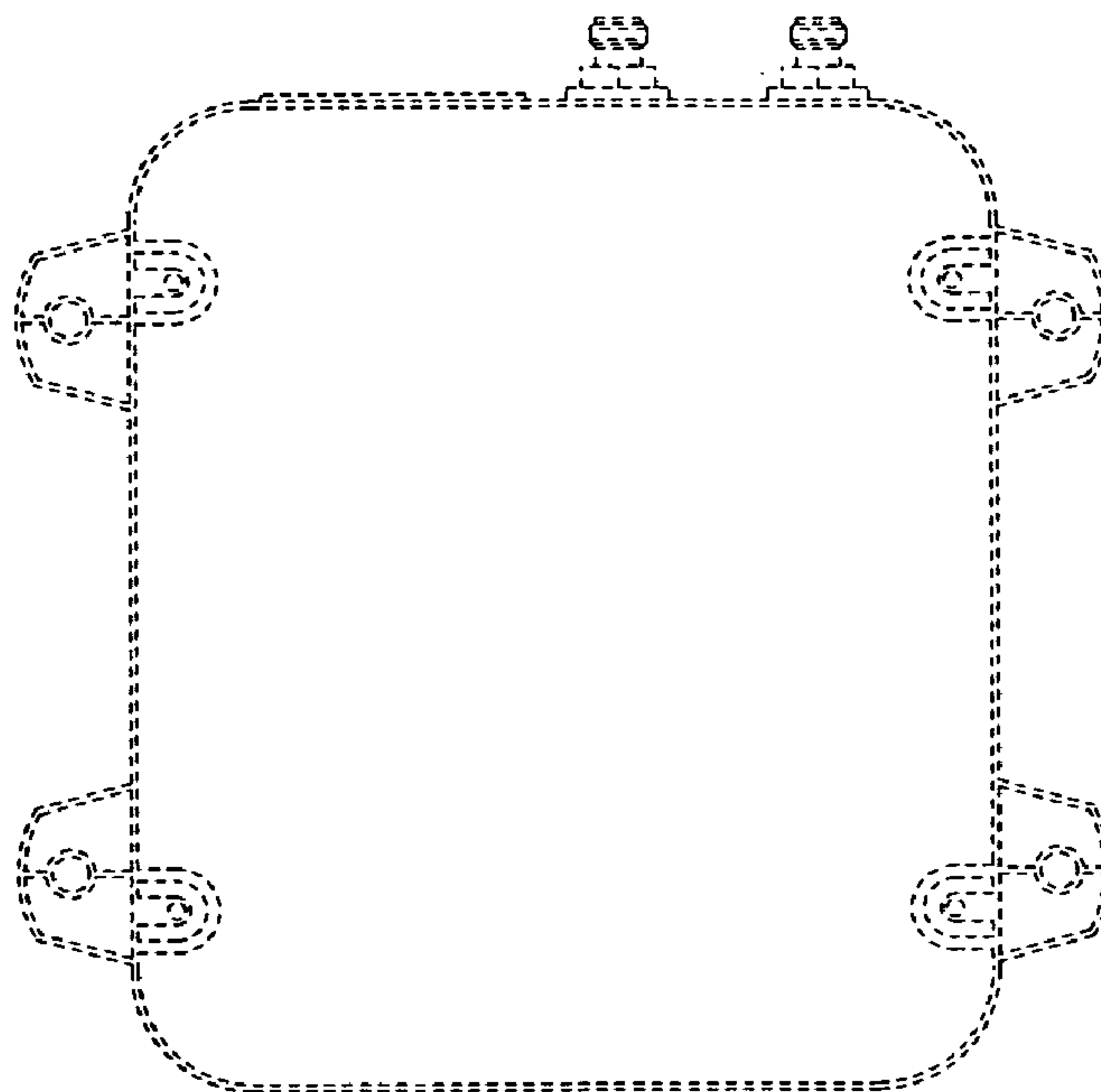
