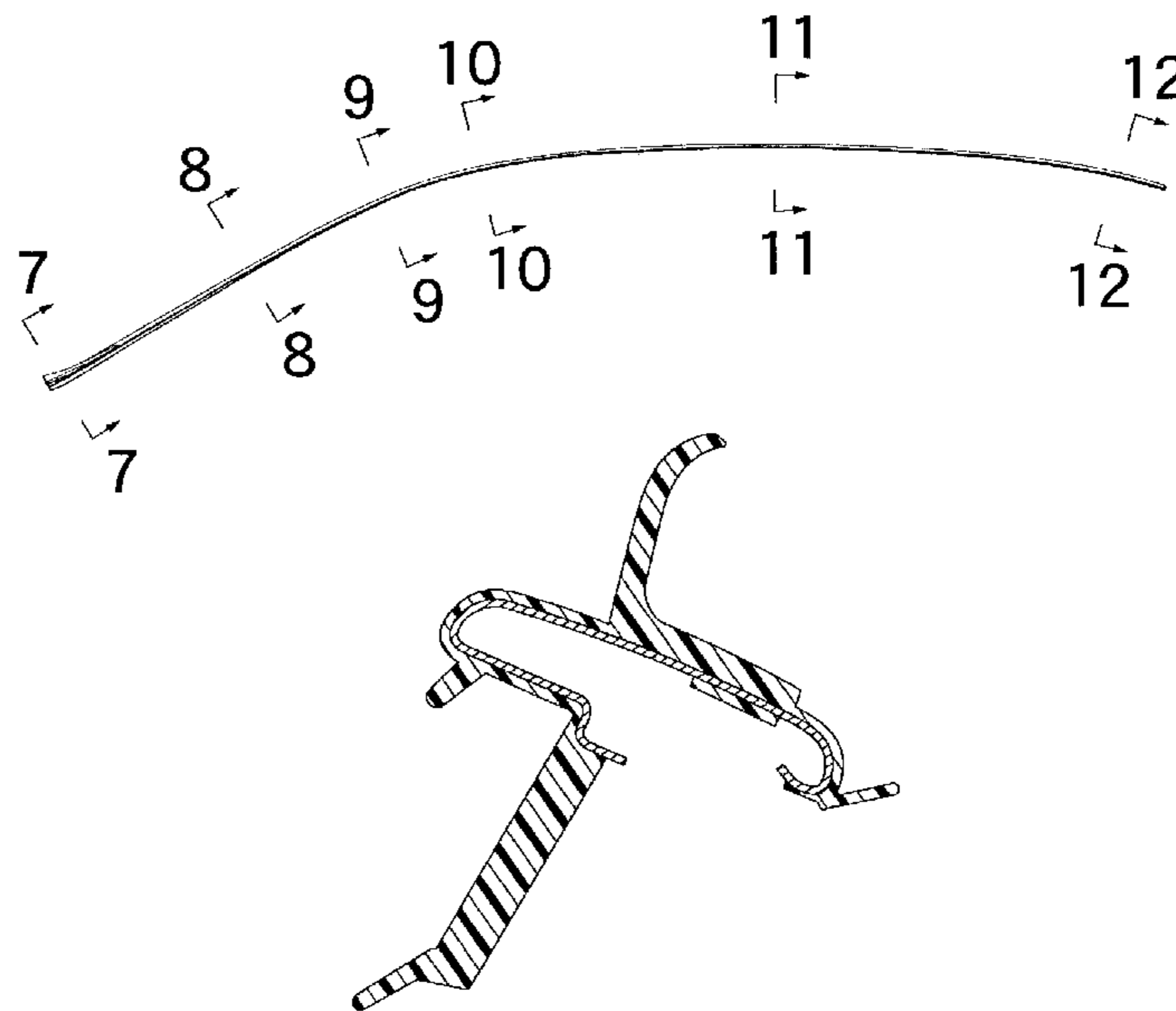


FIG. 17 is a front view of the drip mold;

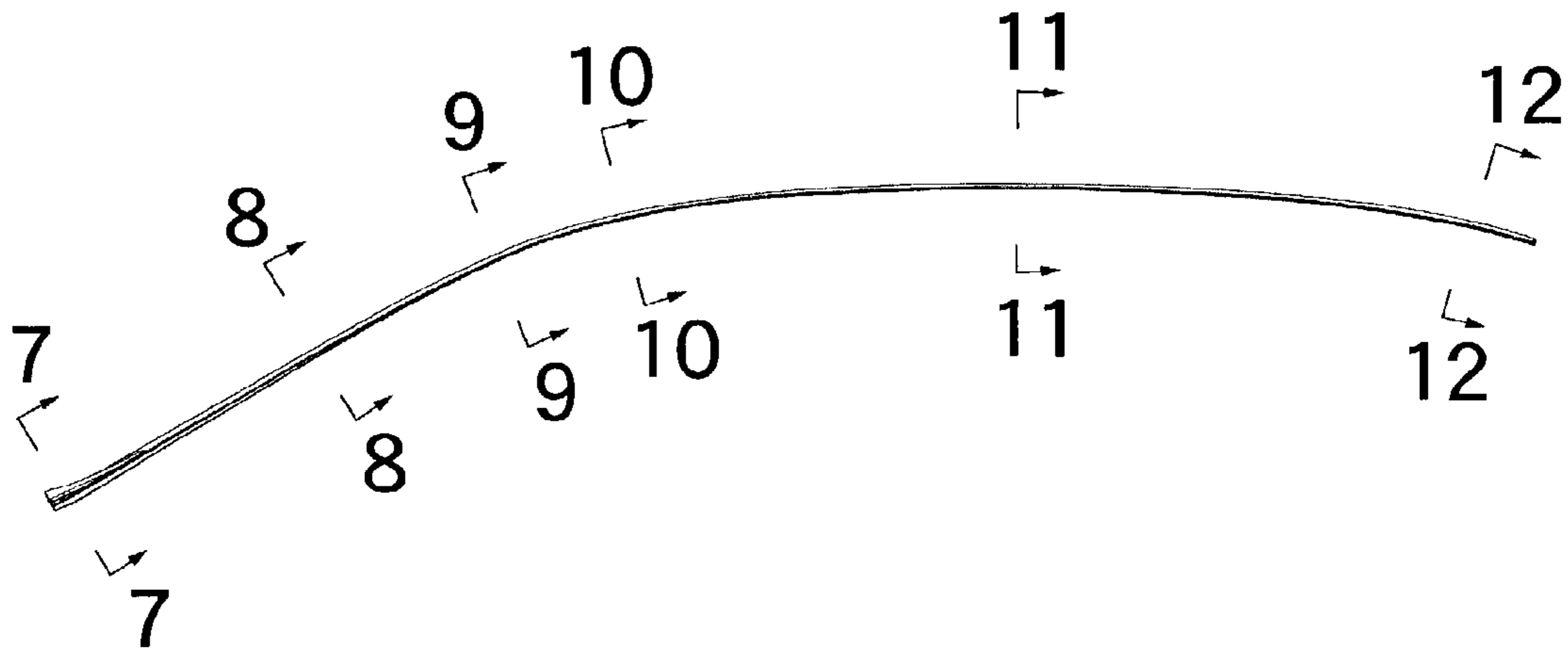

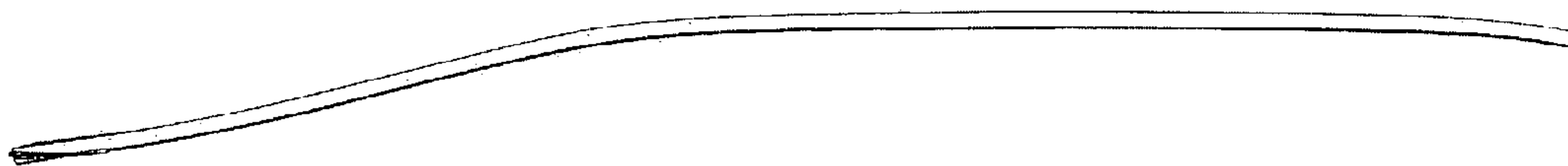

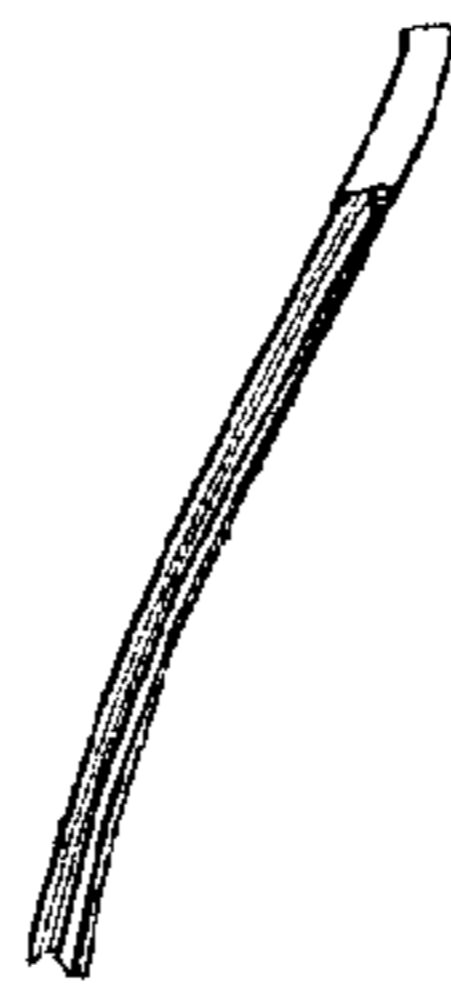

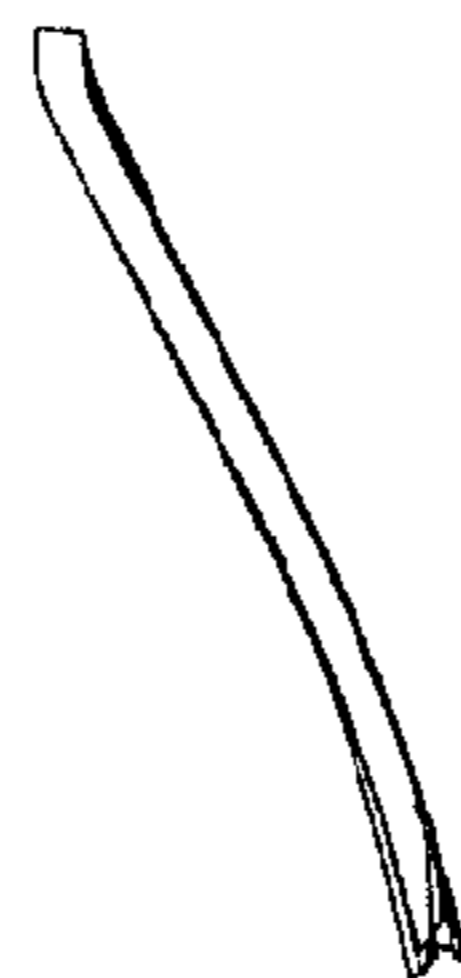

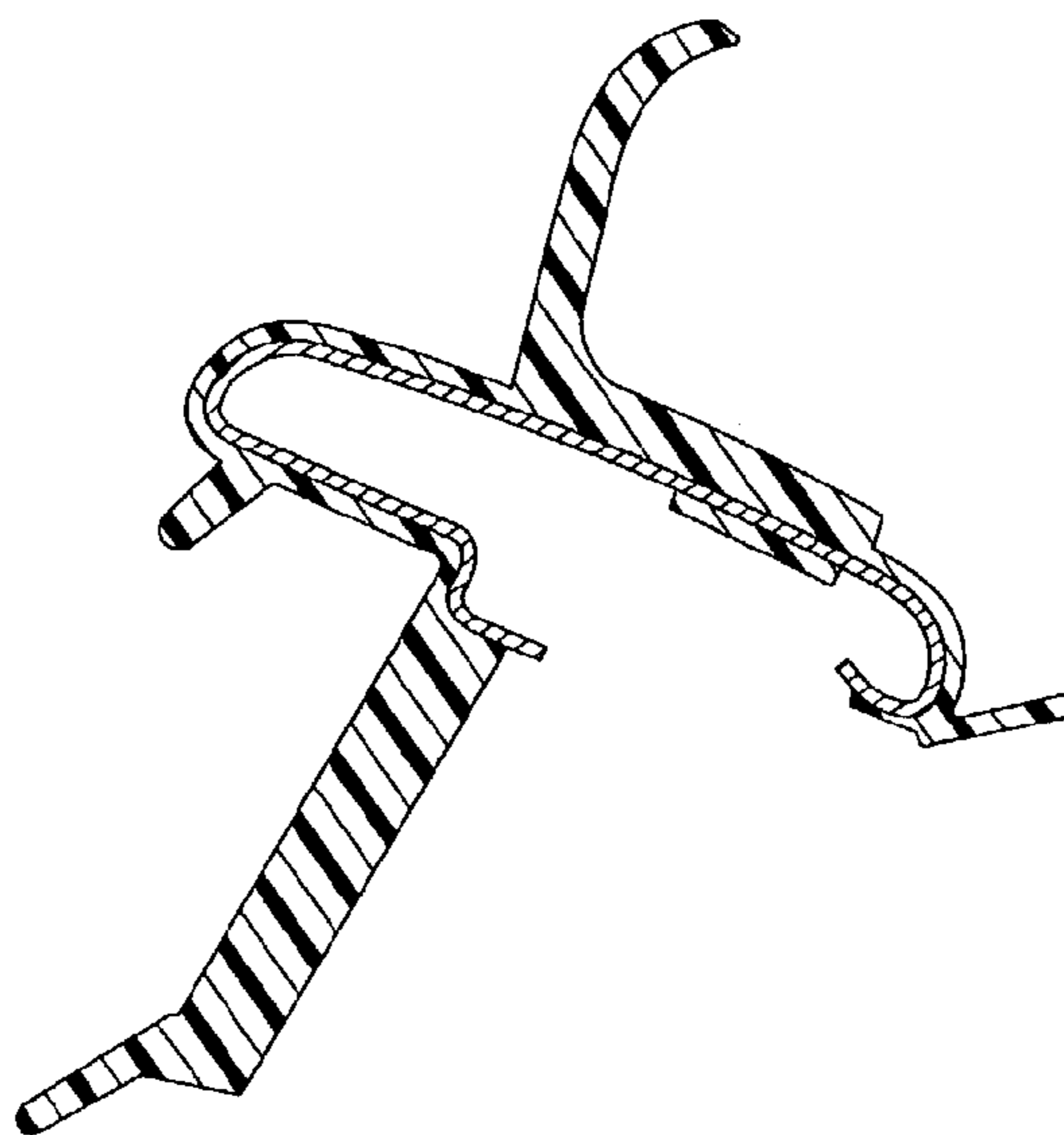

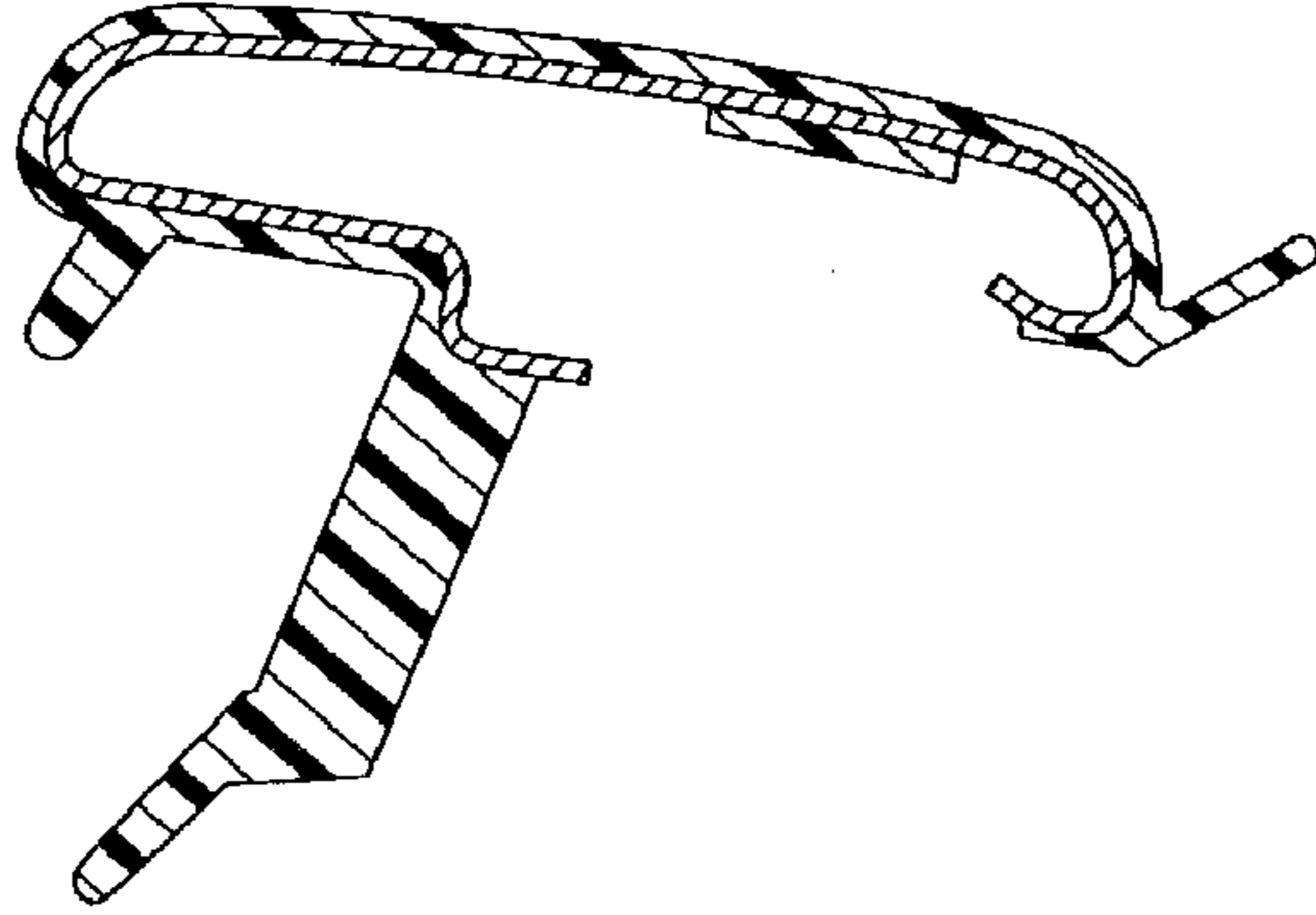

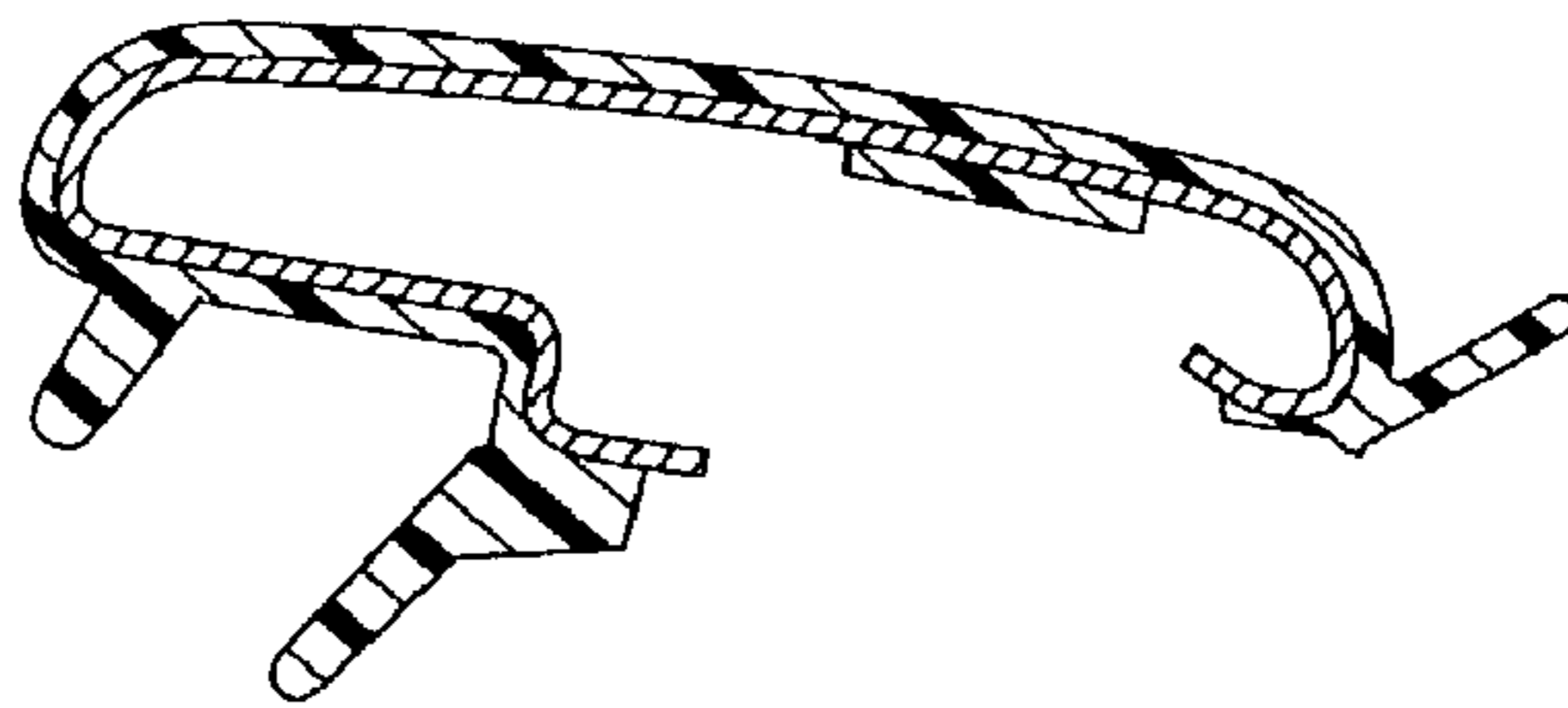

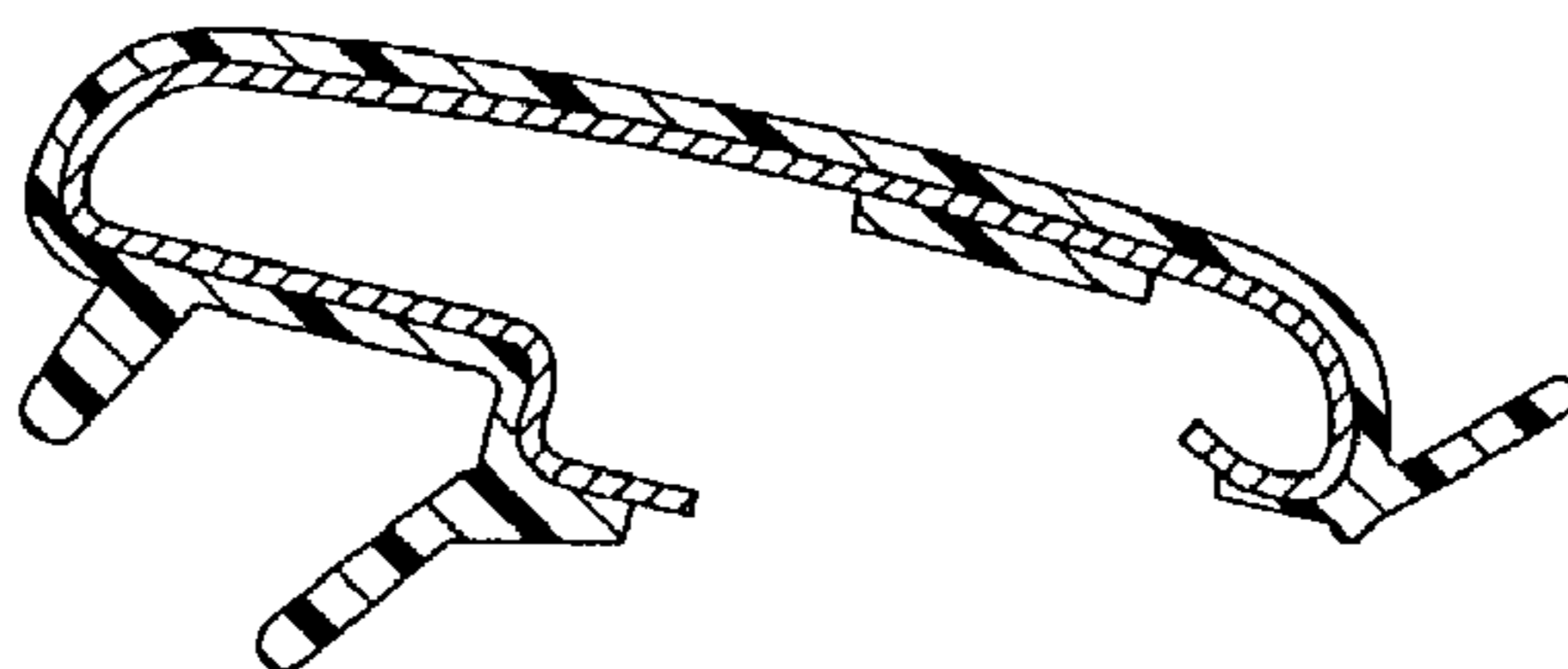

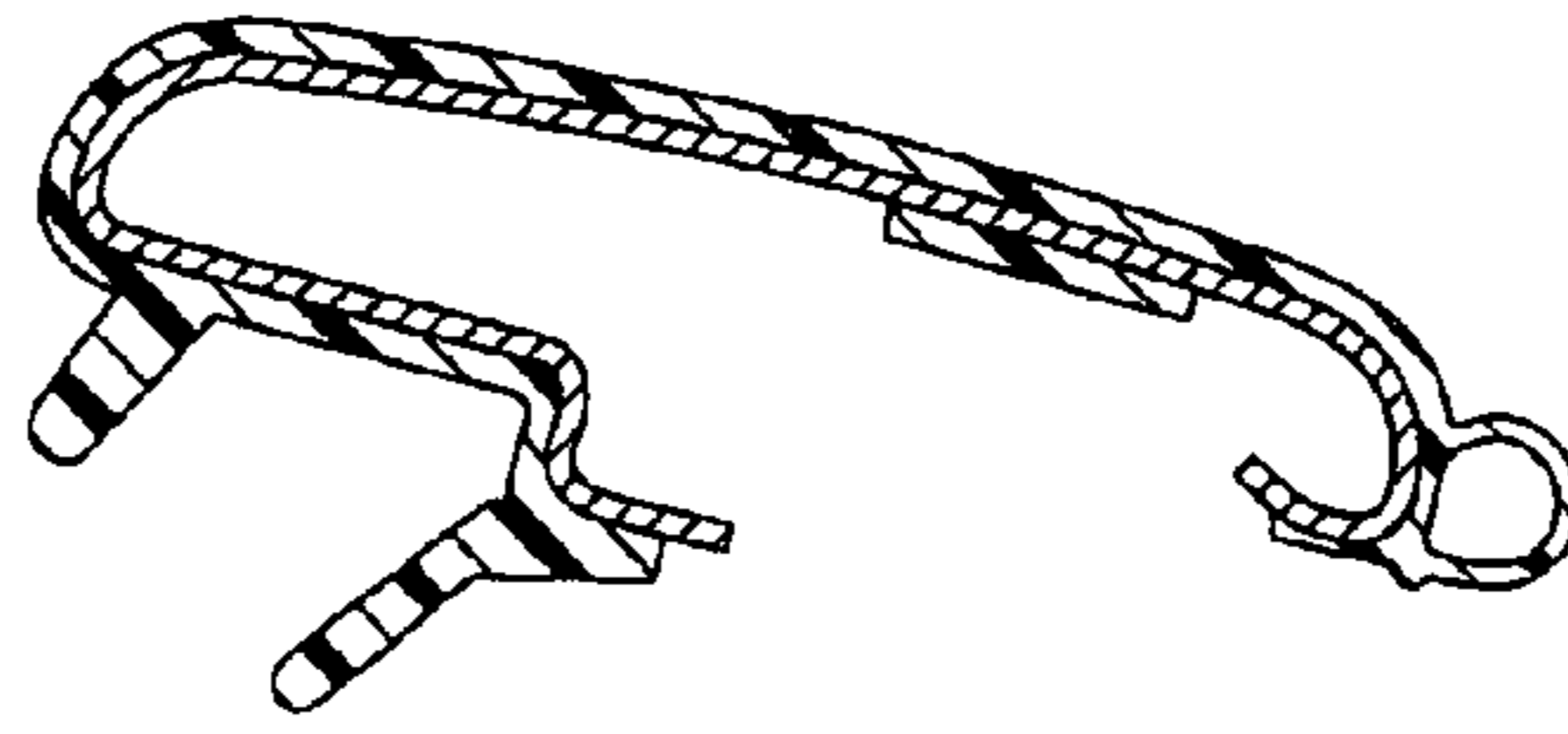

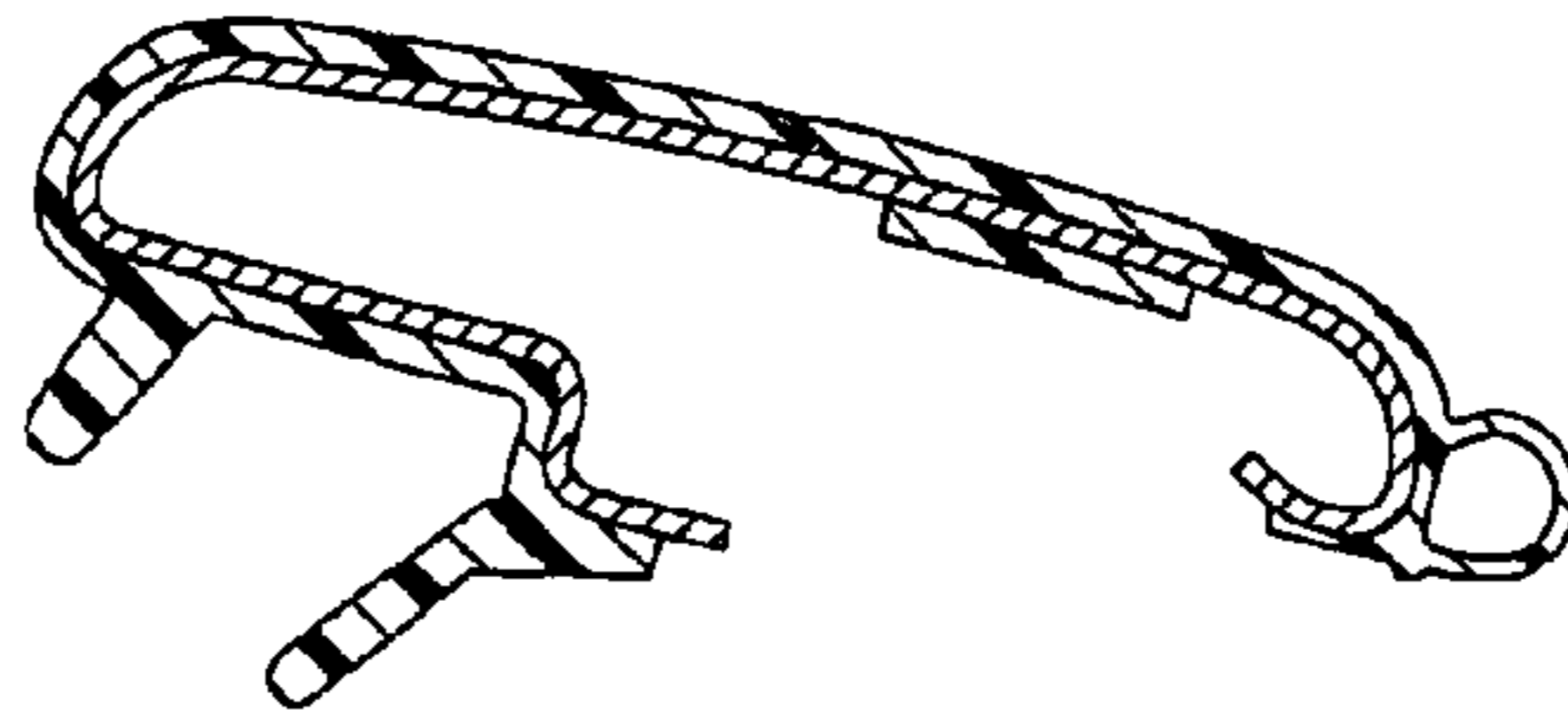

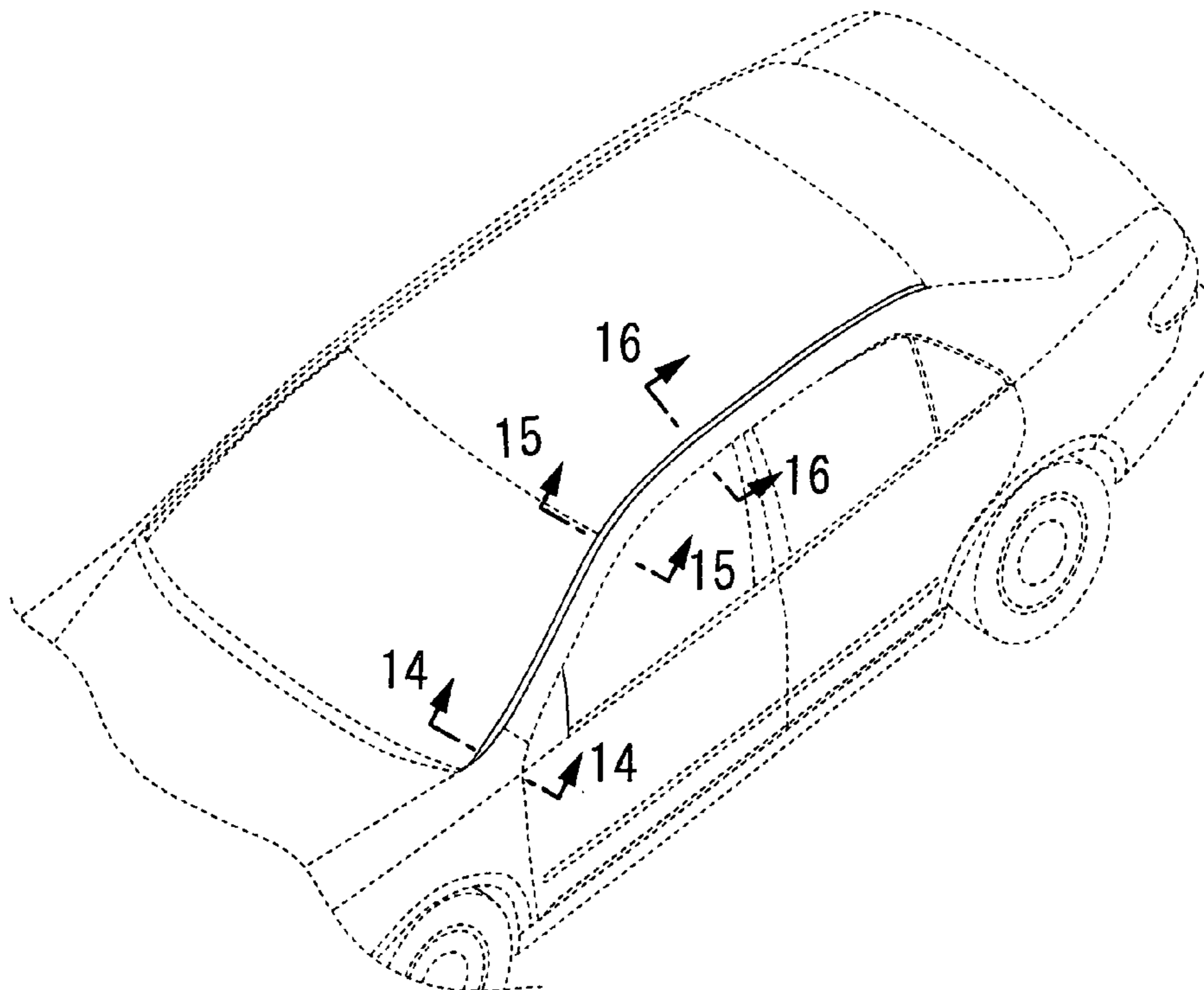

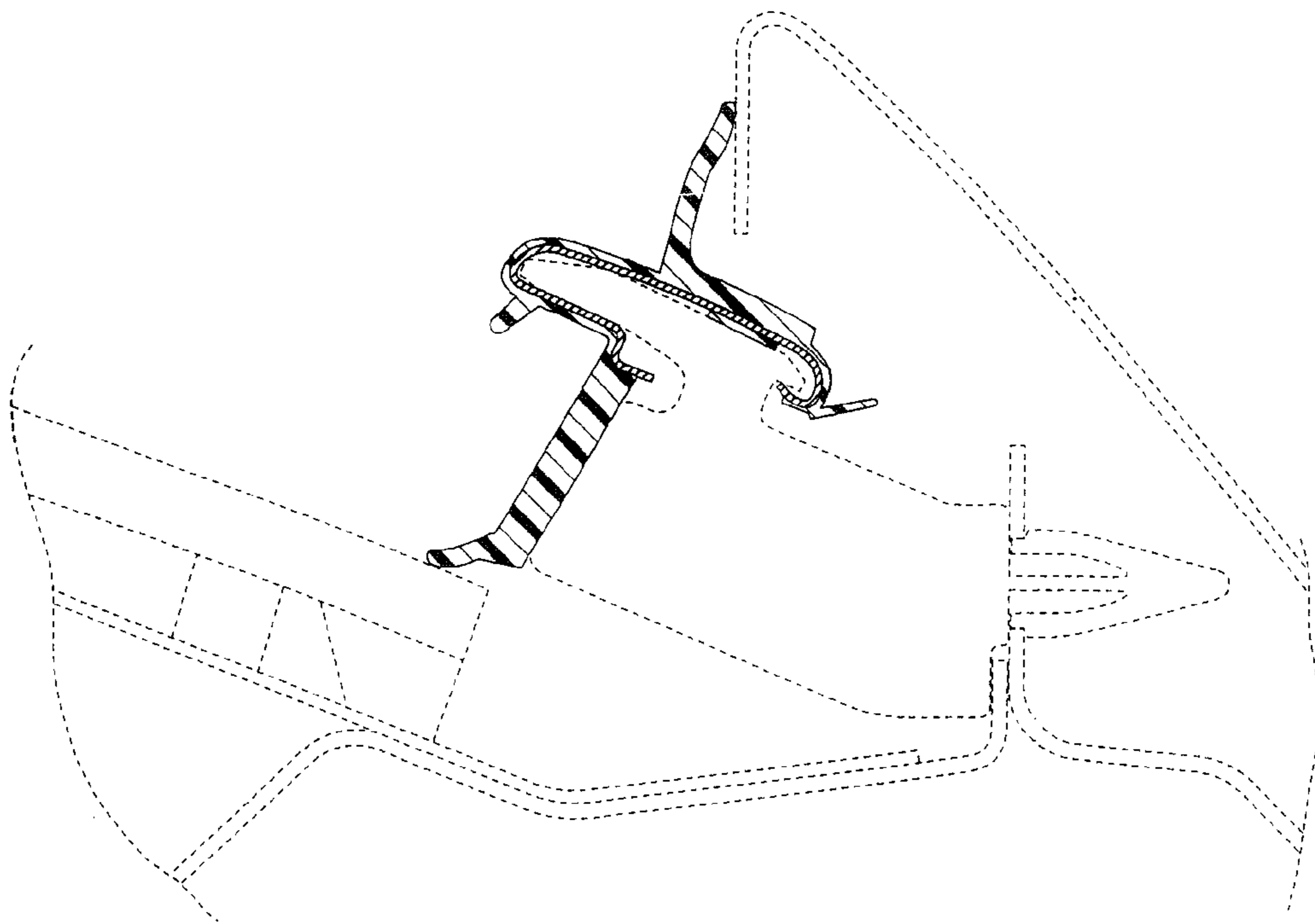

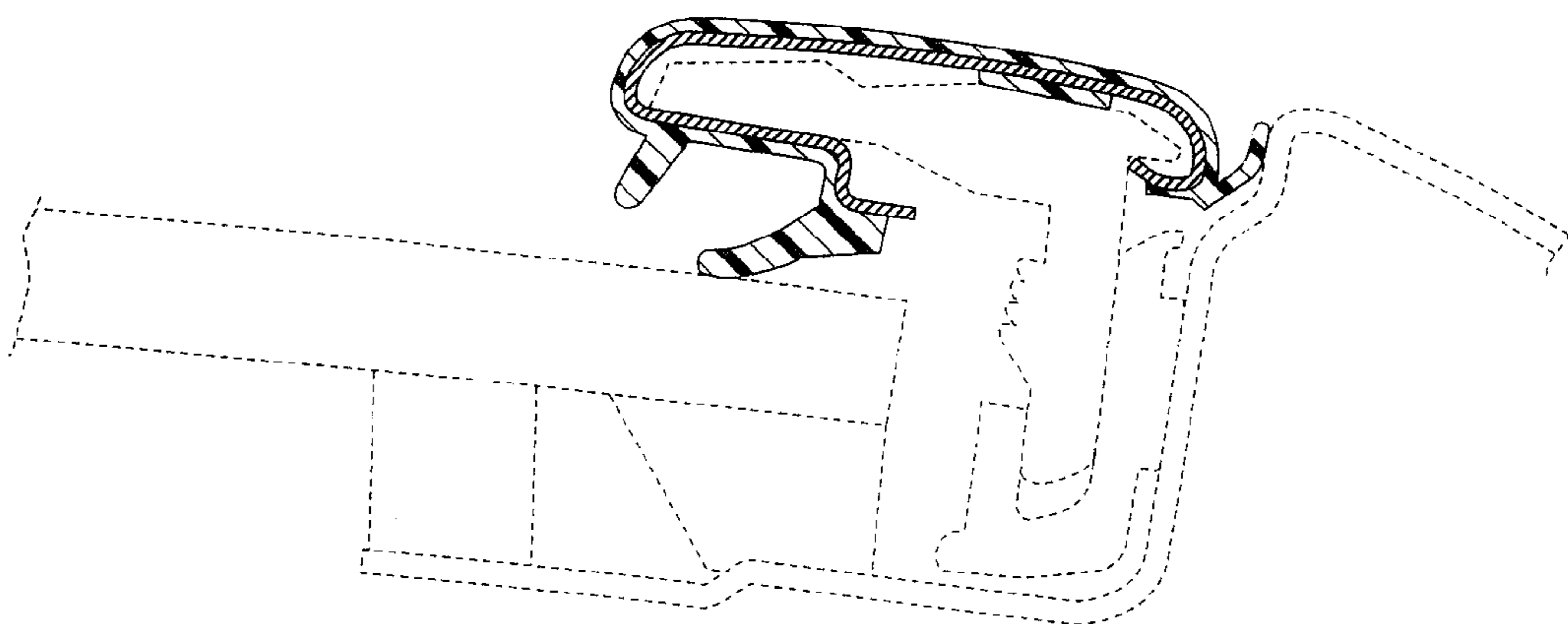

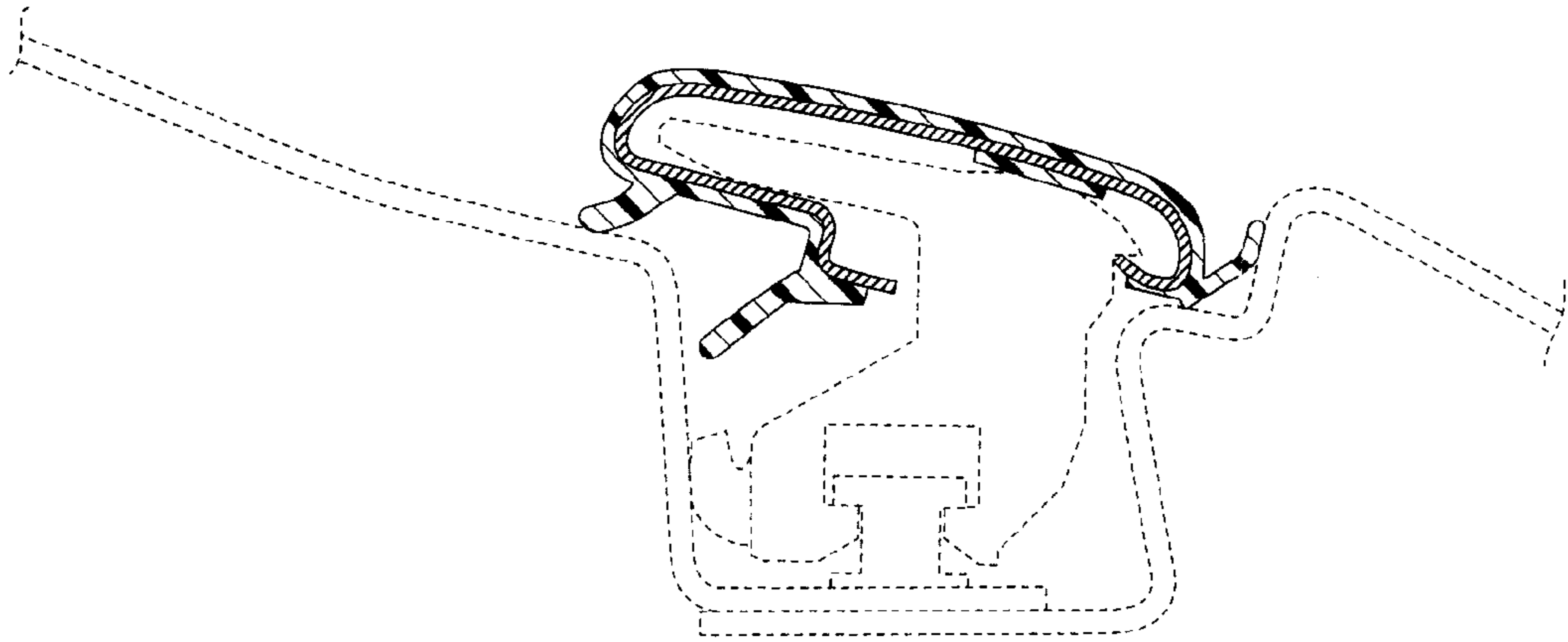

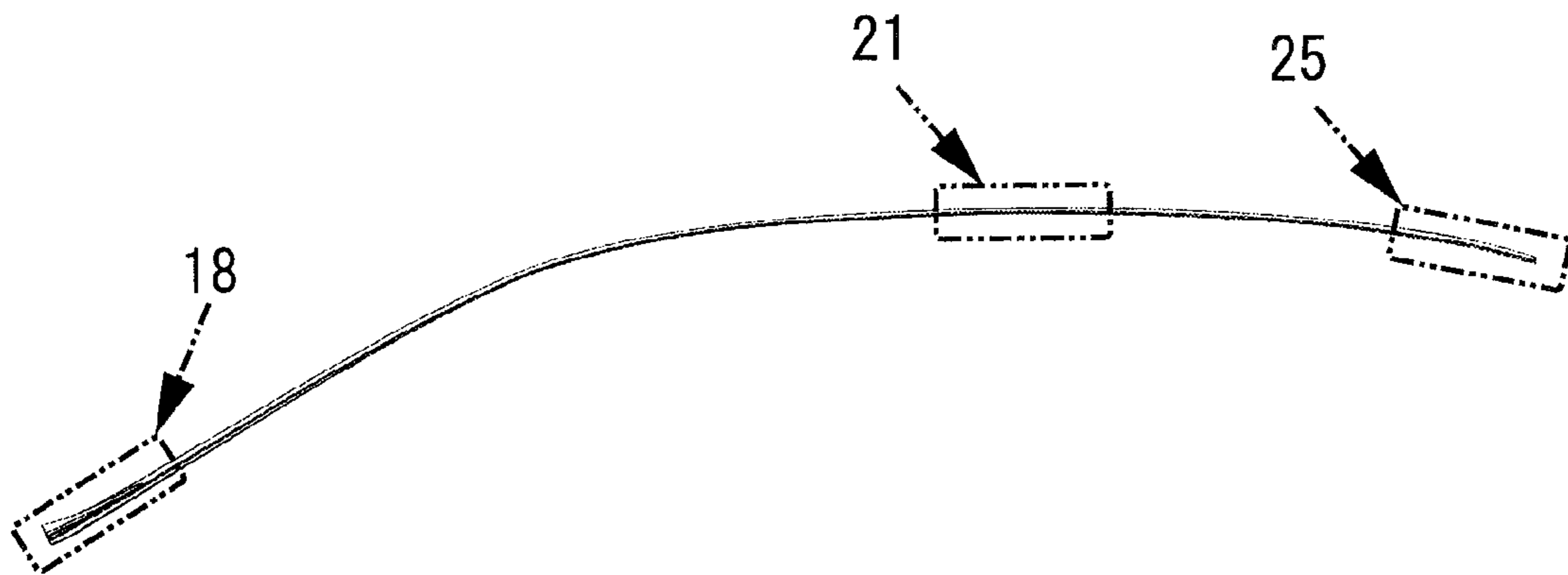

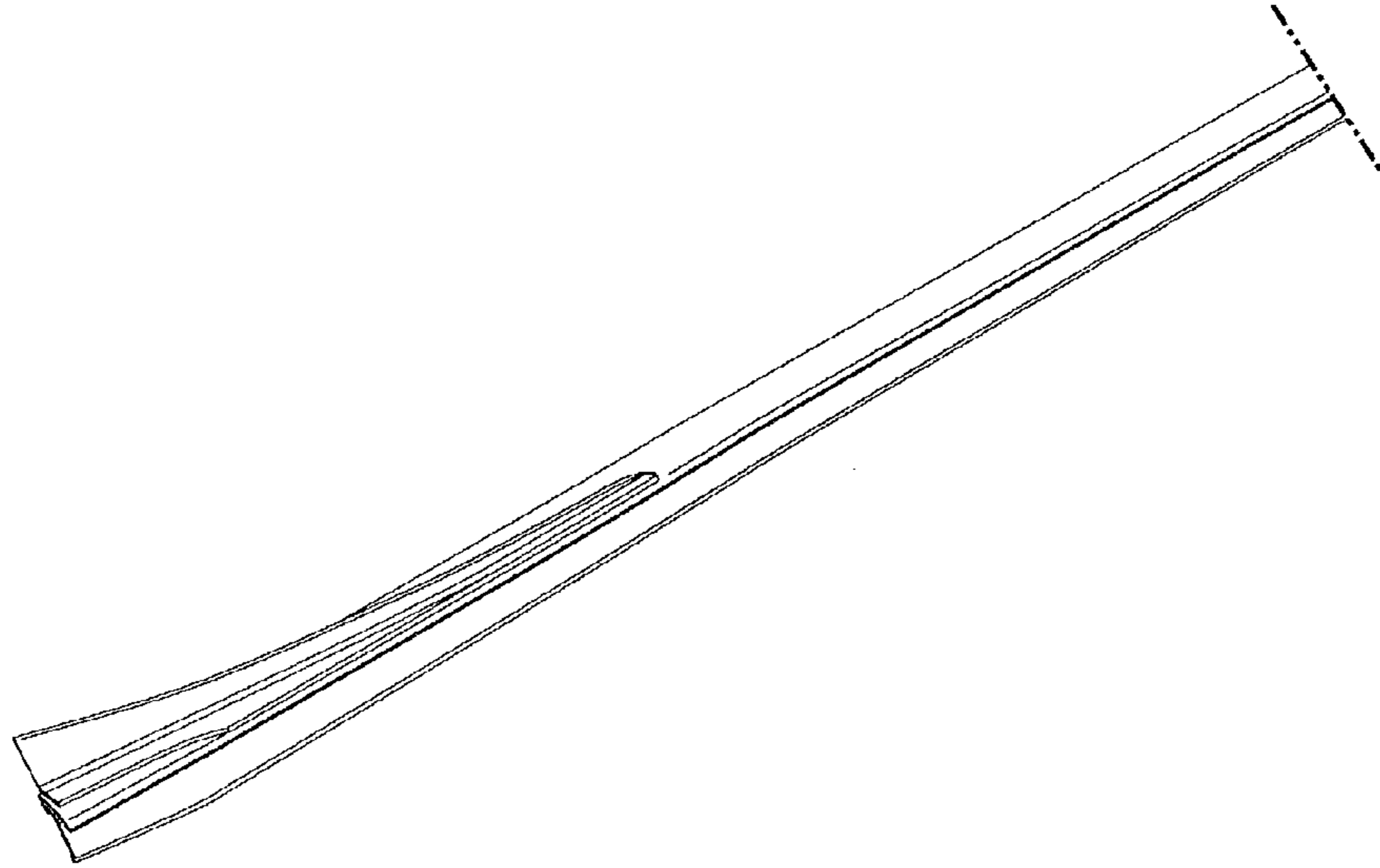

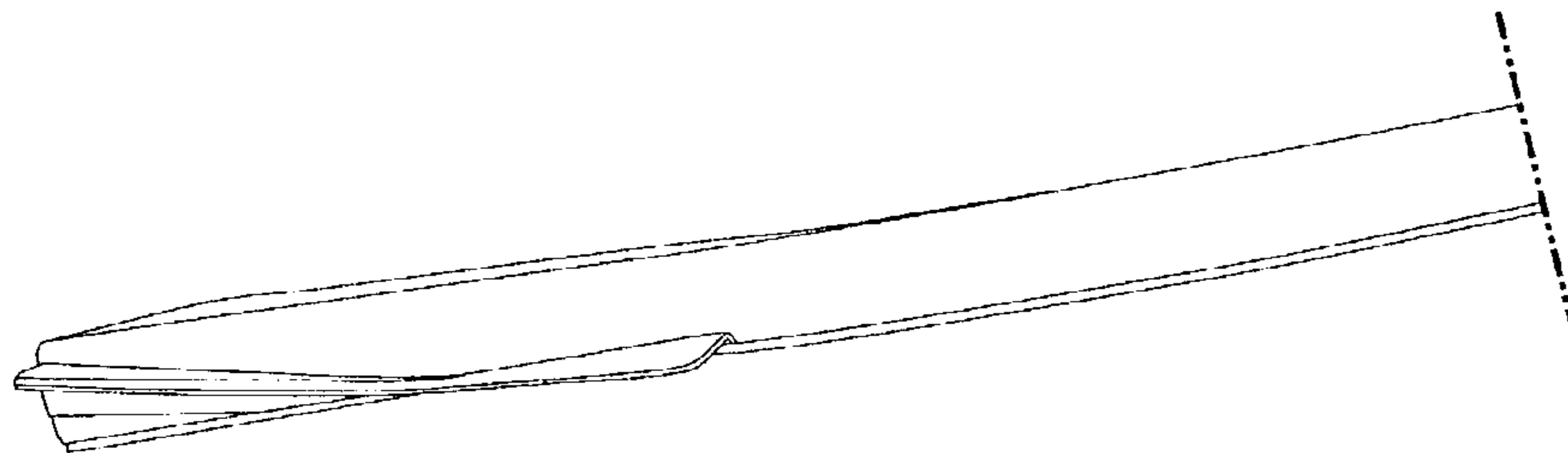

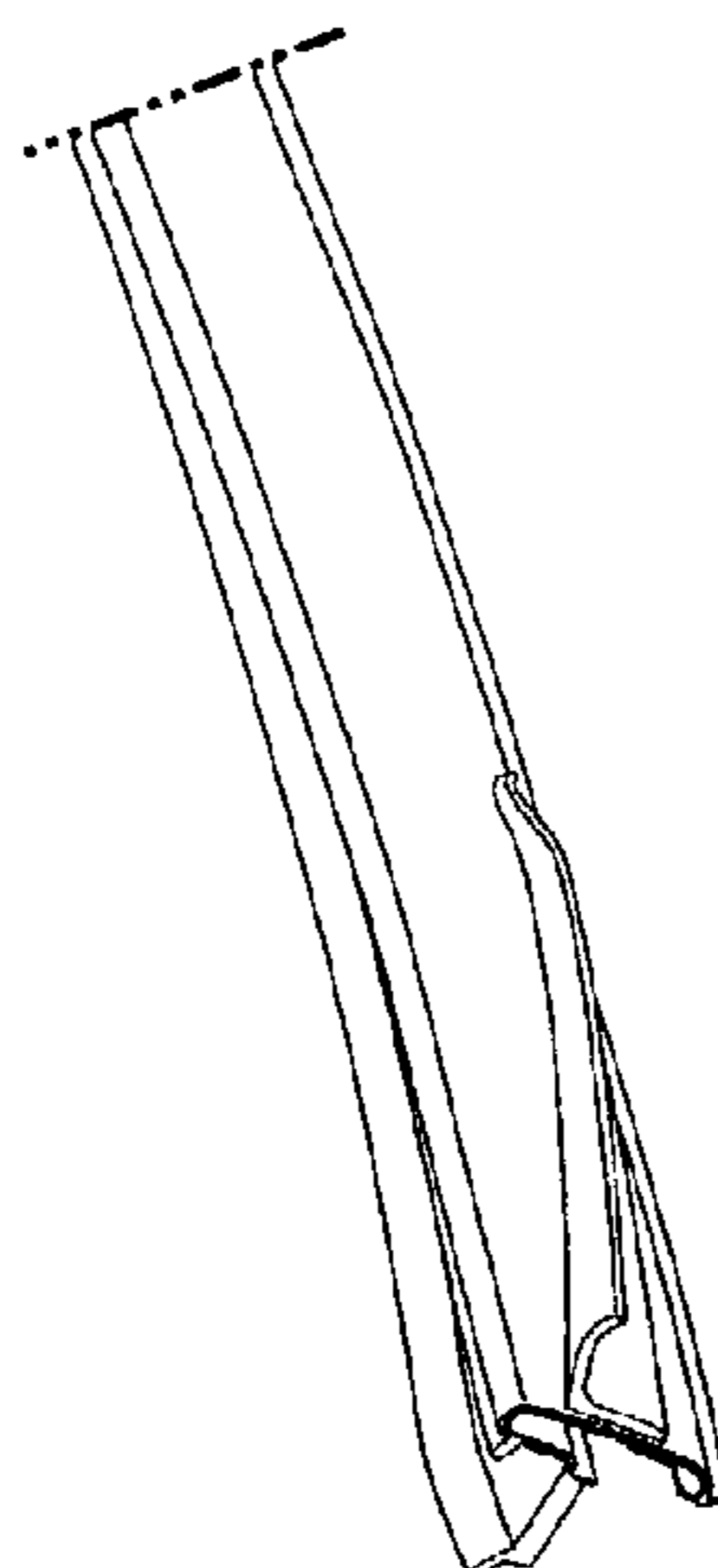

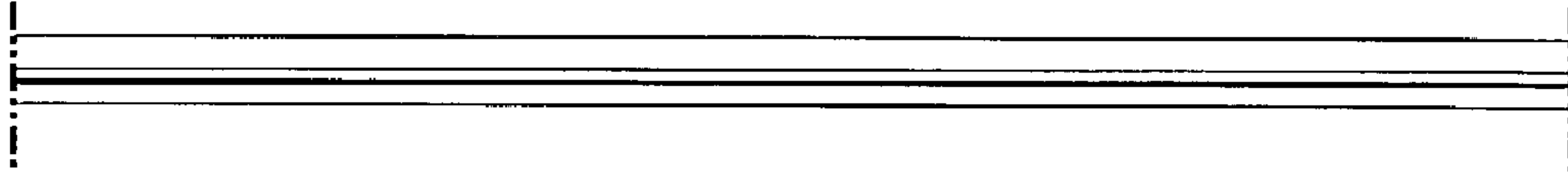

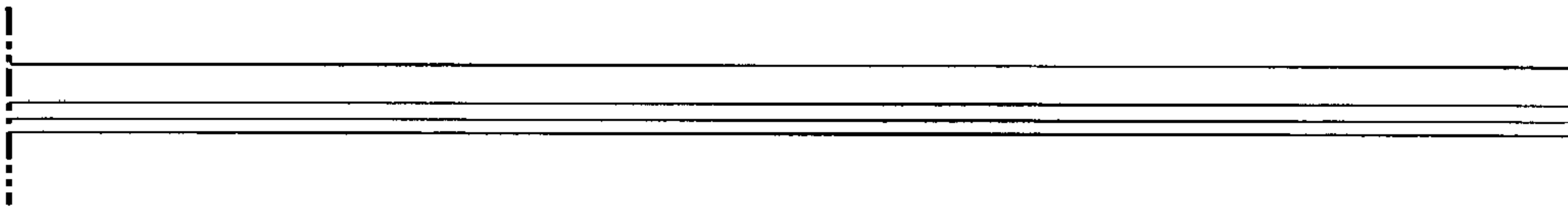

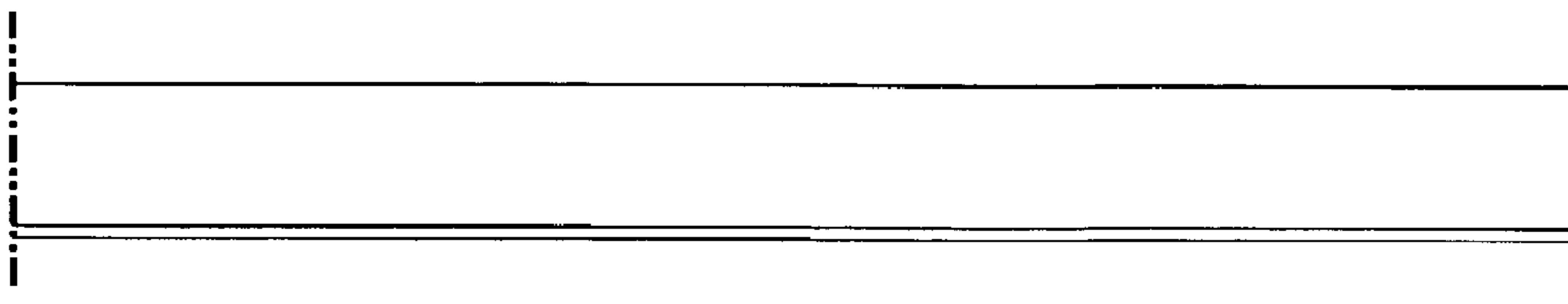

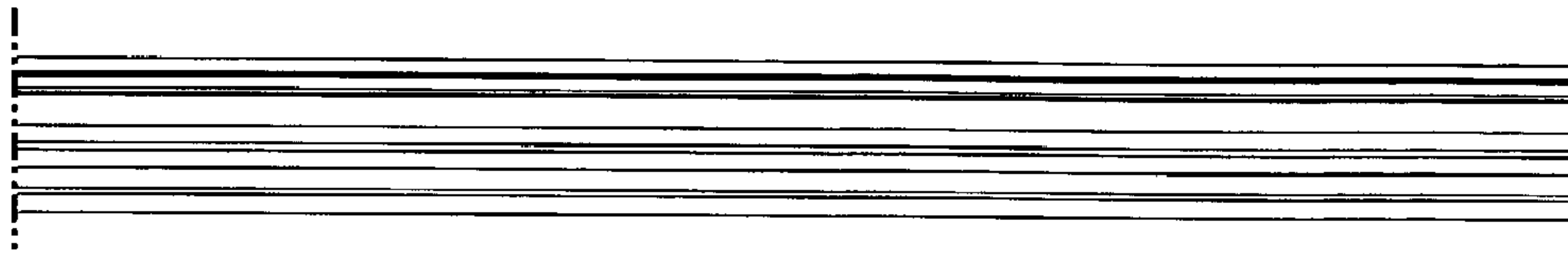

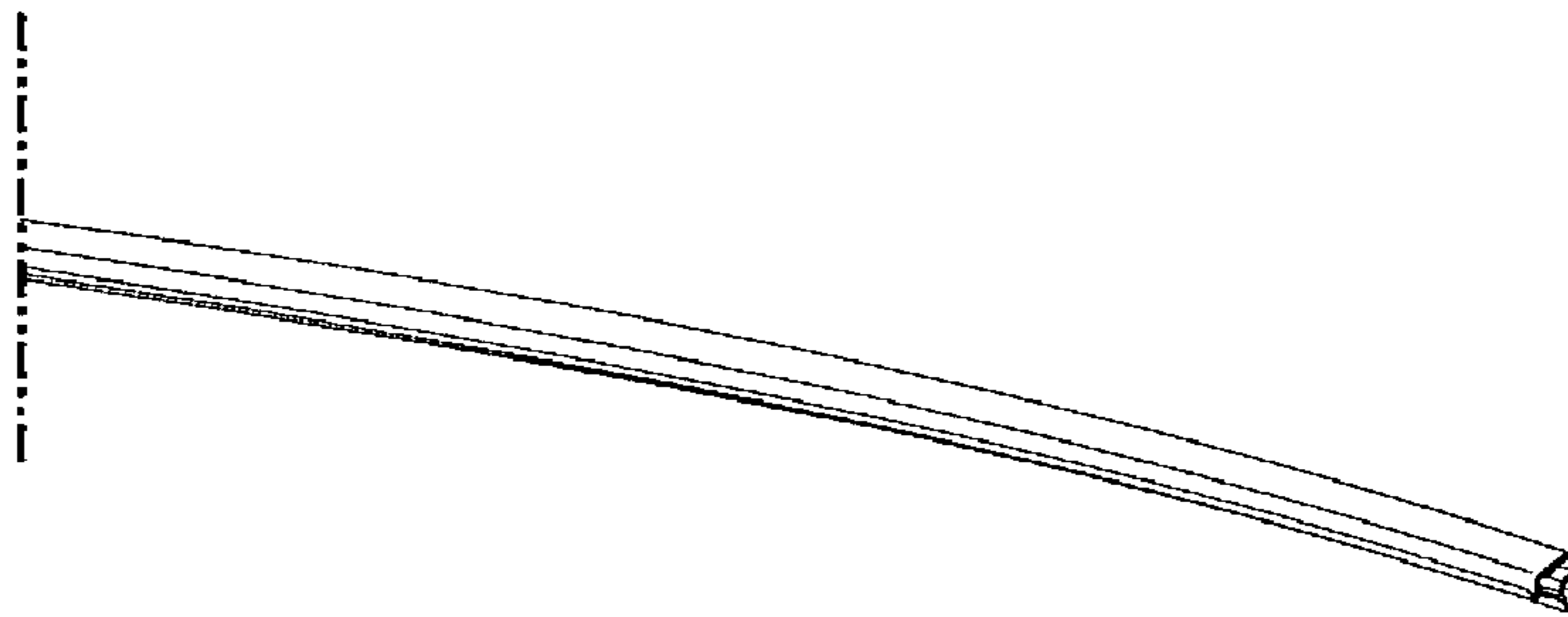

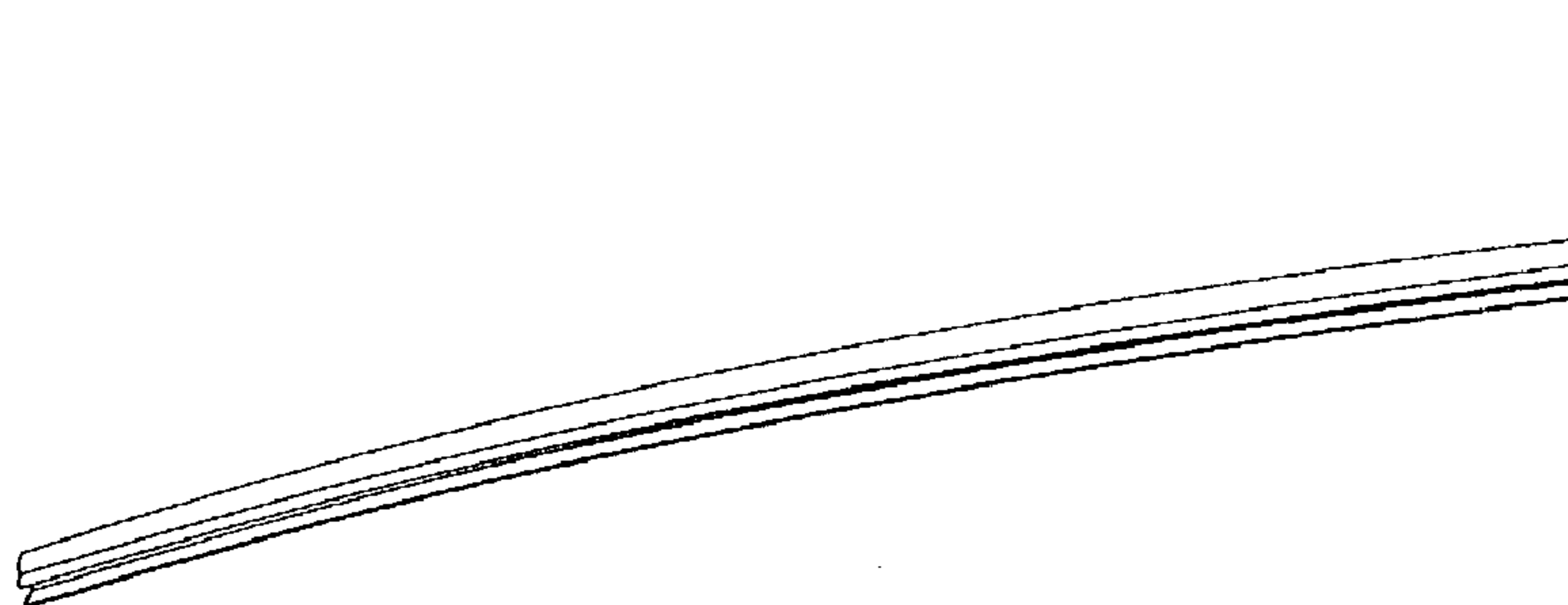

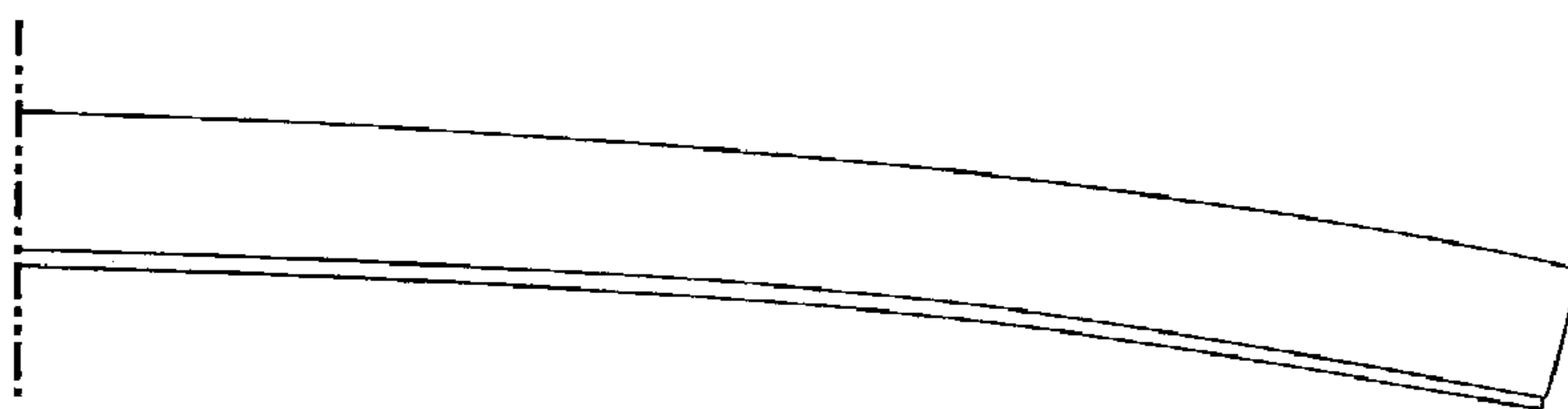
