FIG. 7 is a bottom view of the design shown in FIG. 1.

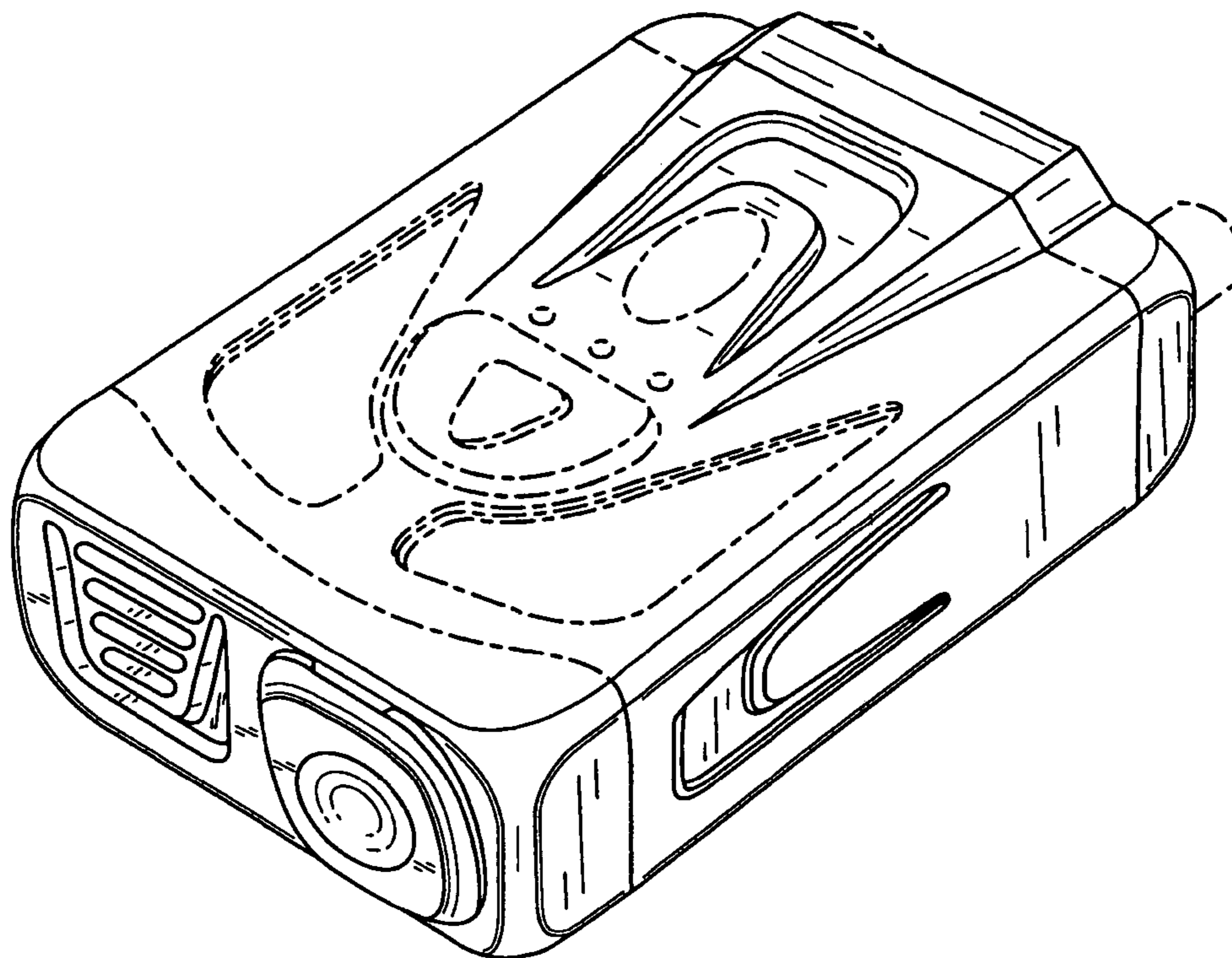

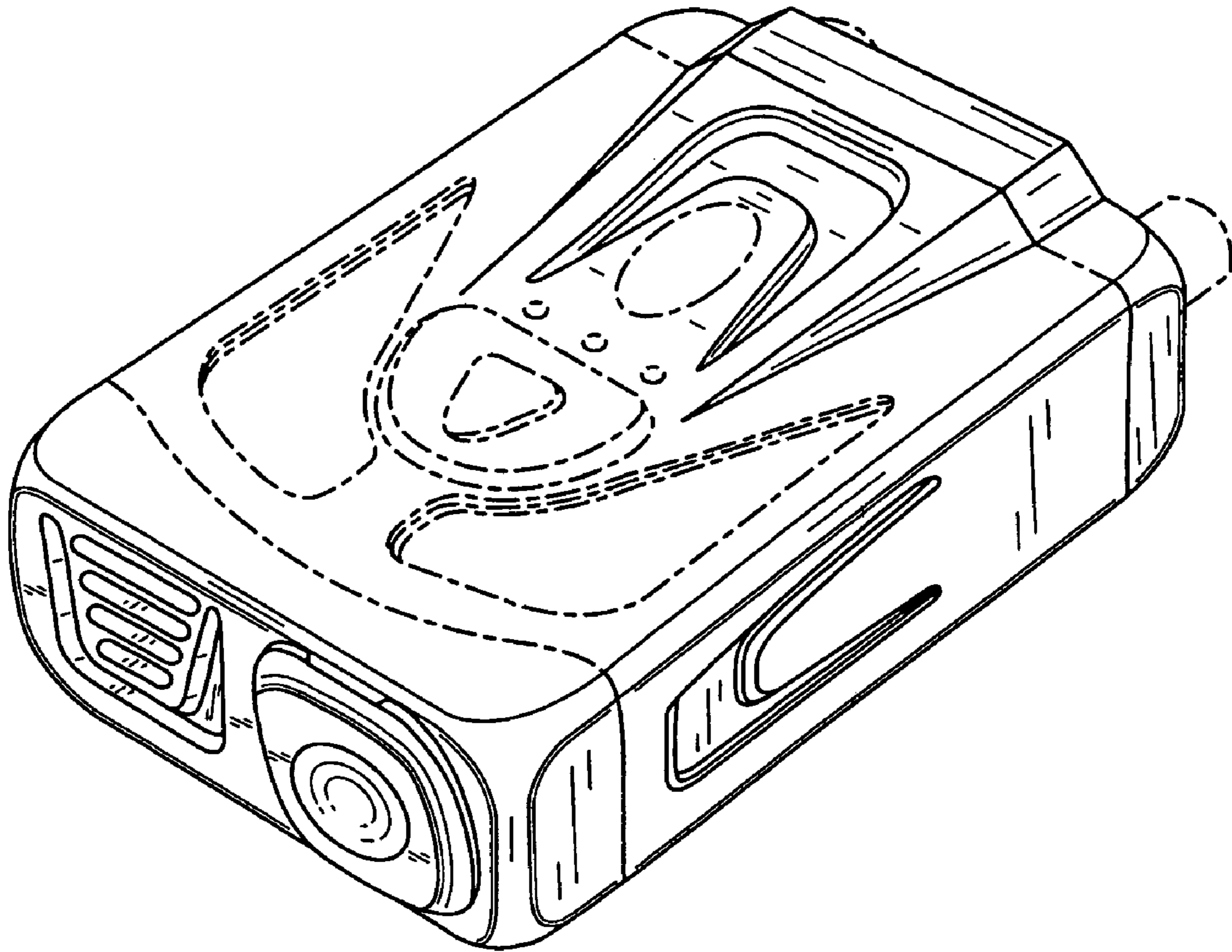

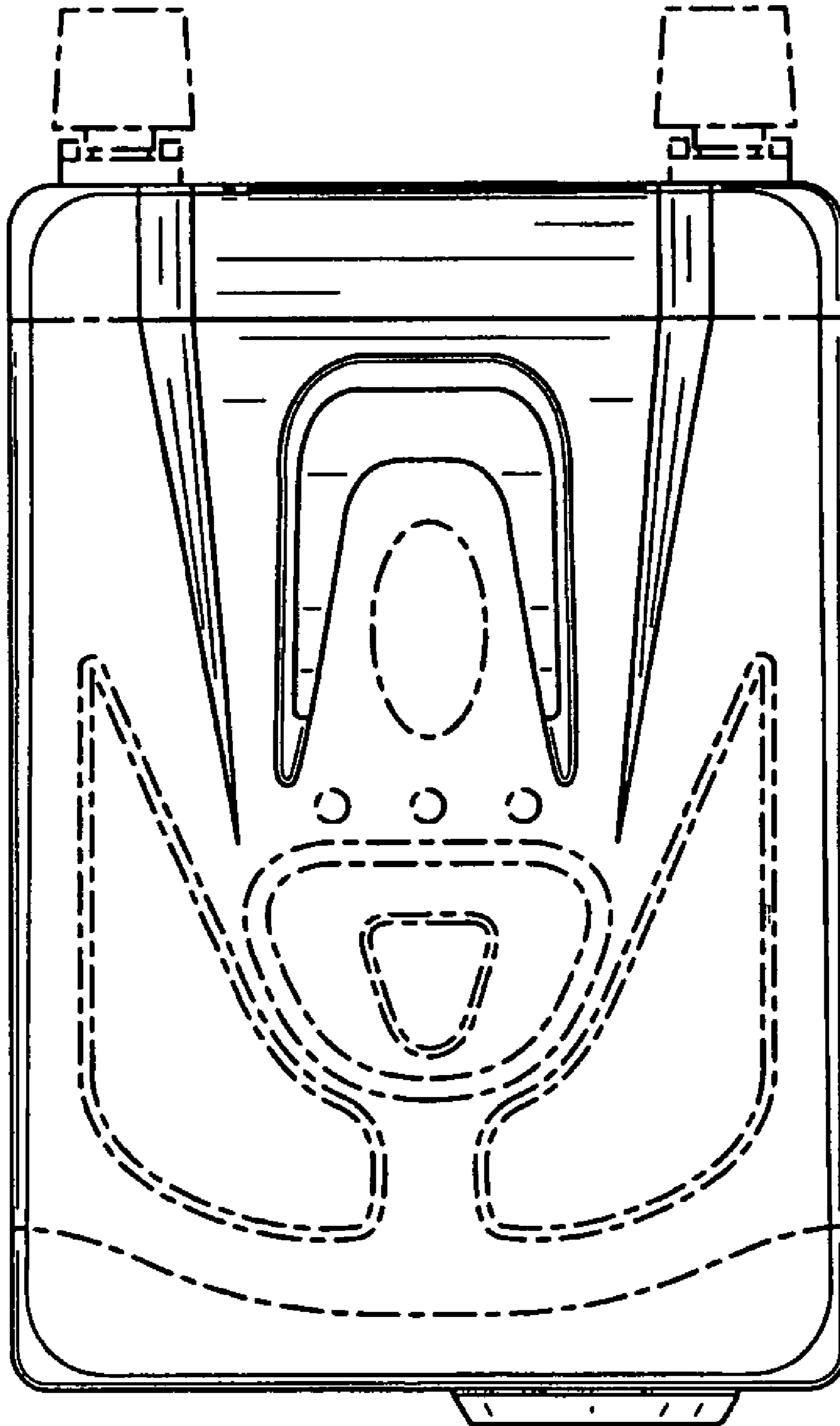

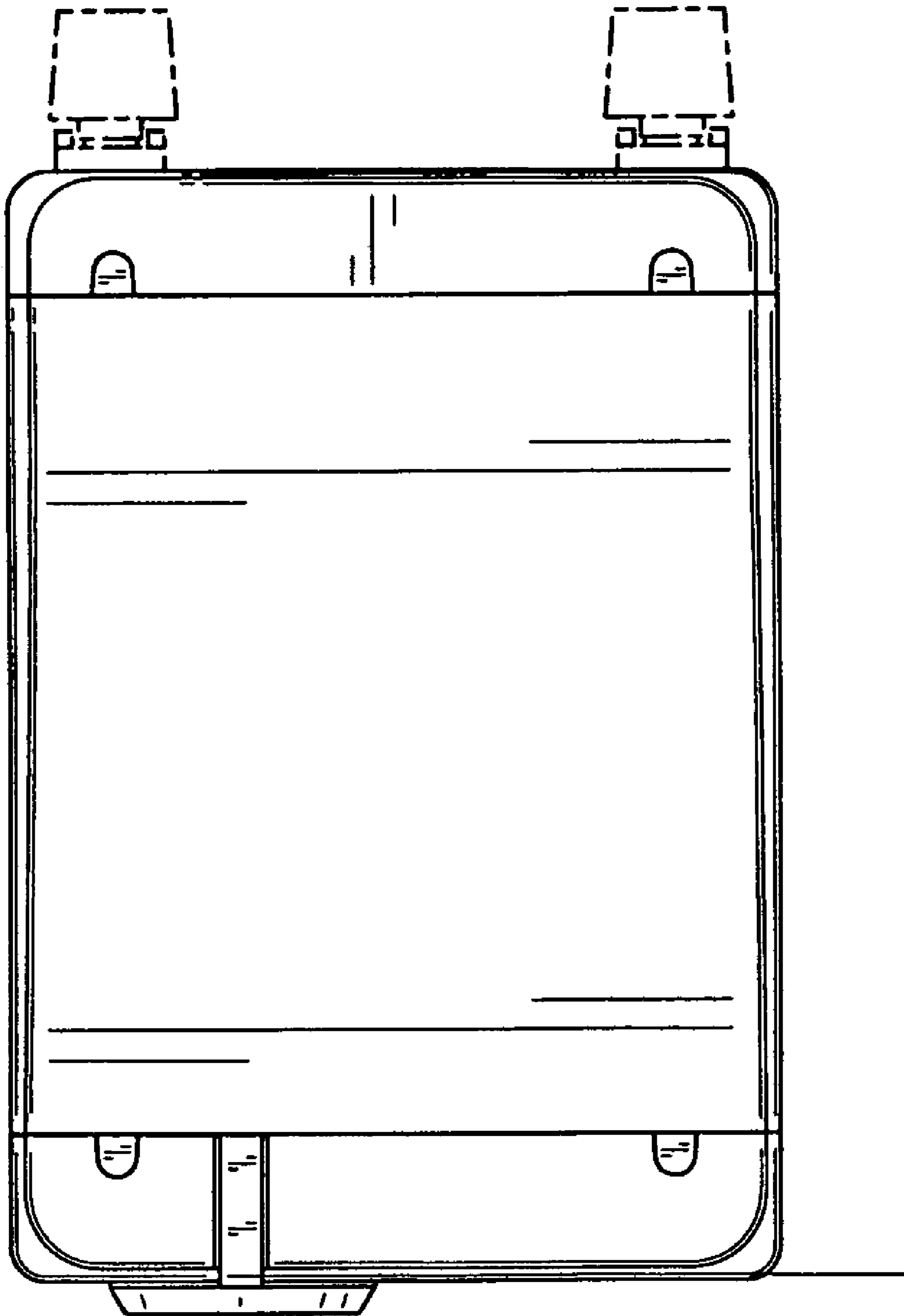

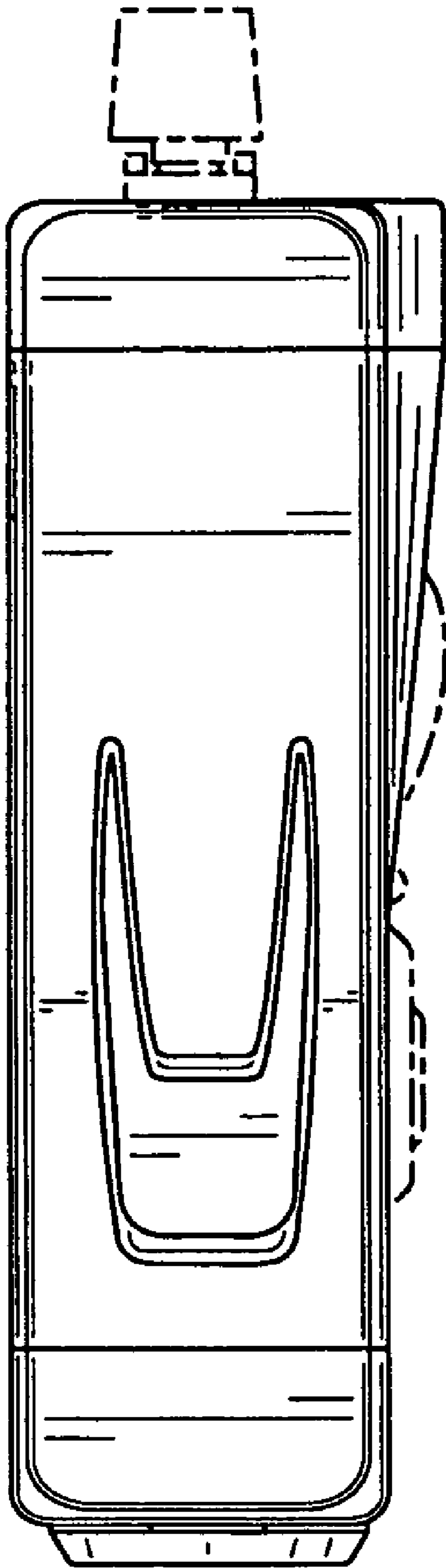

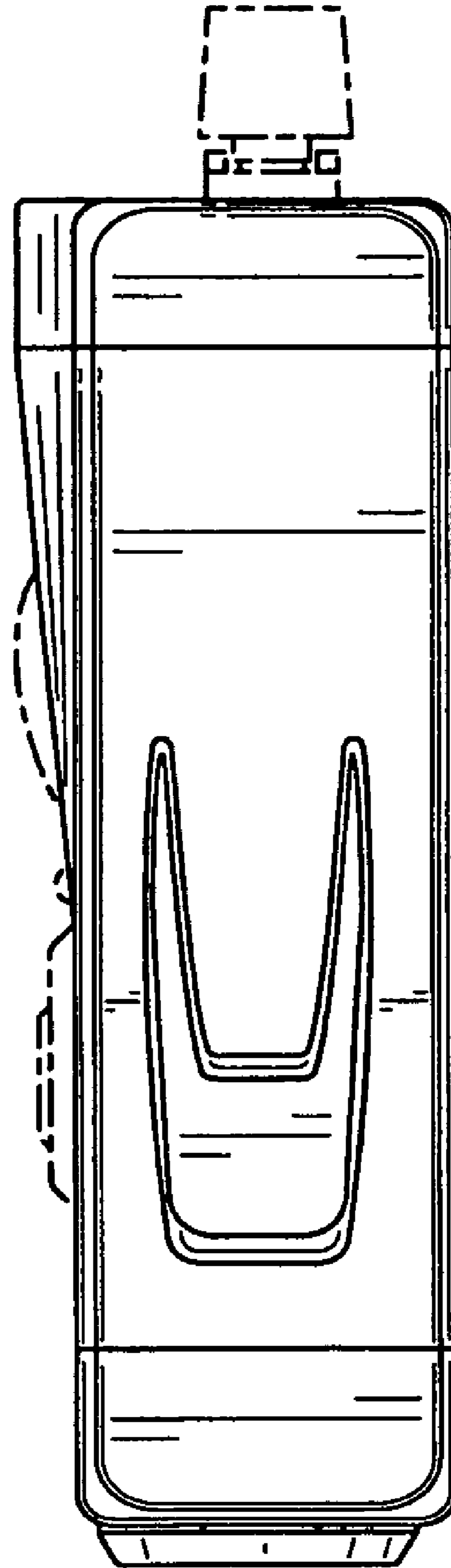

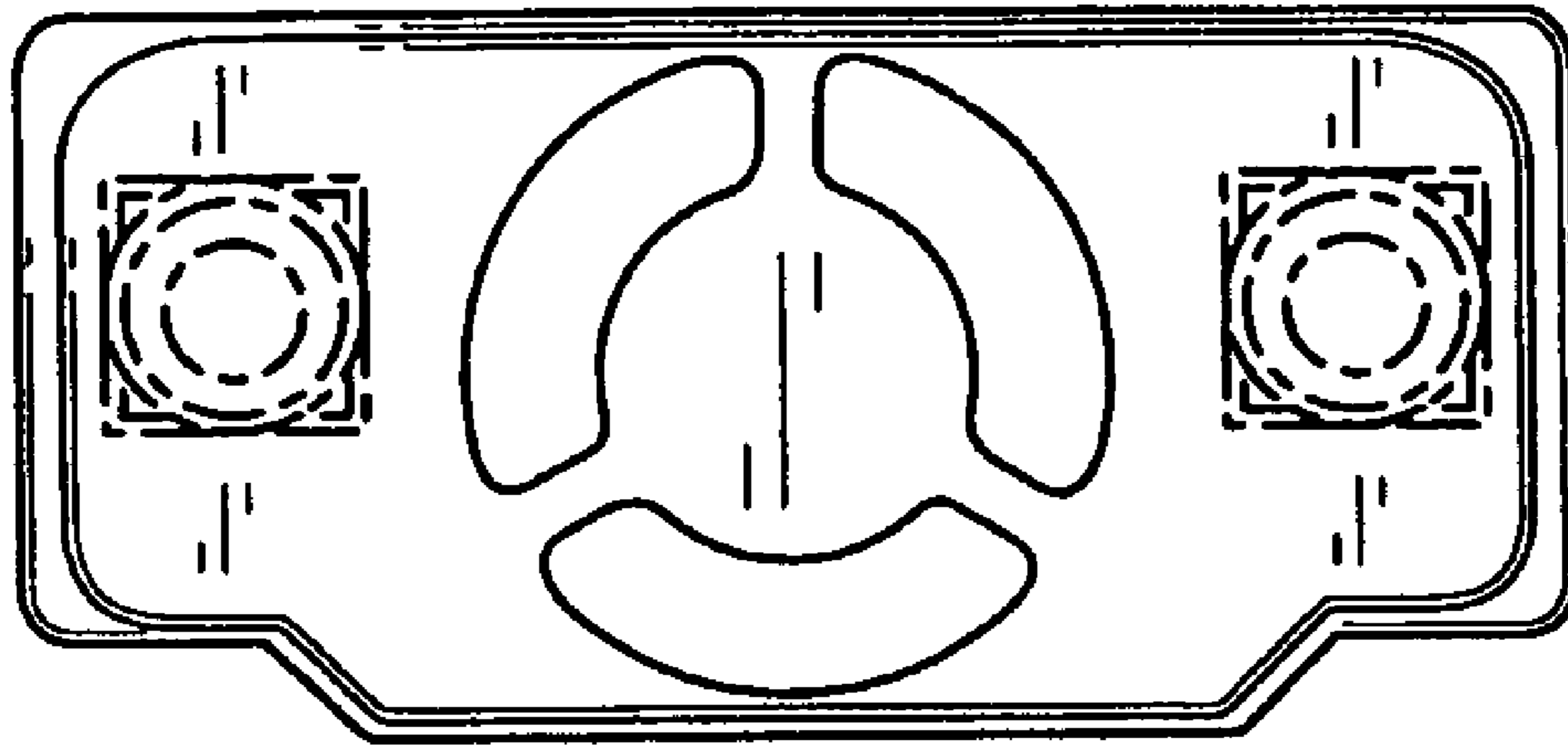

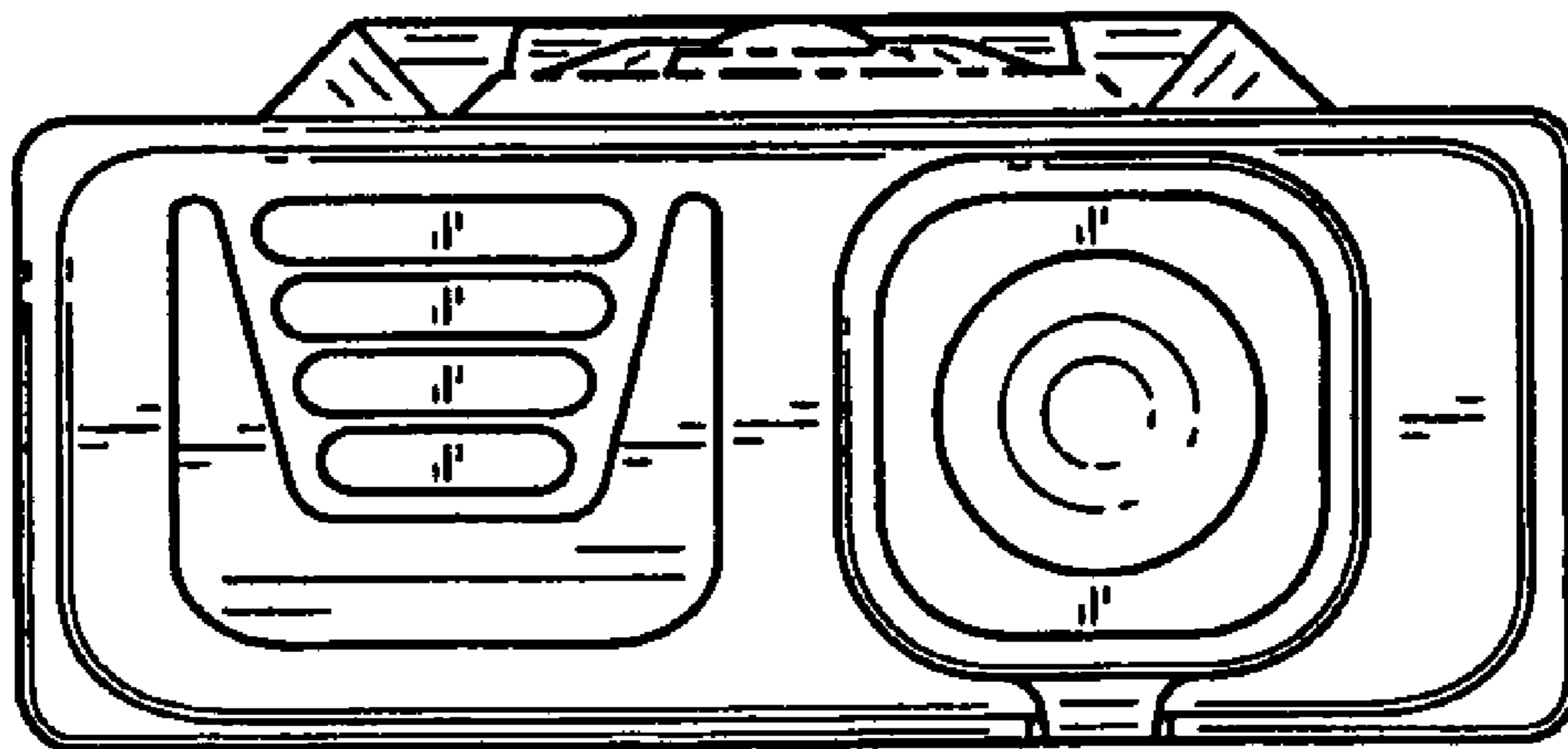
