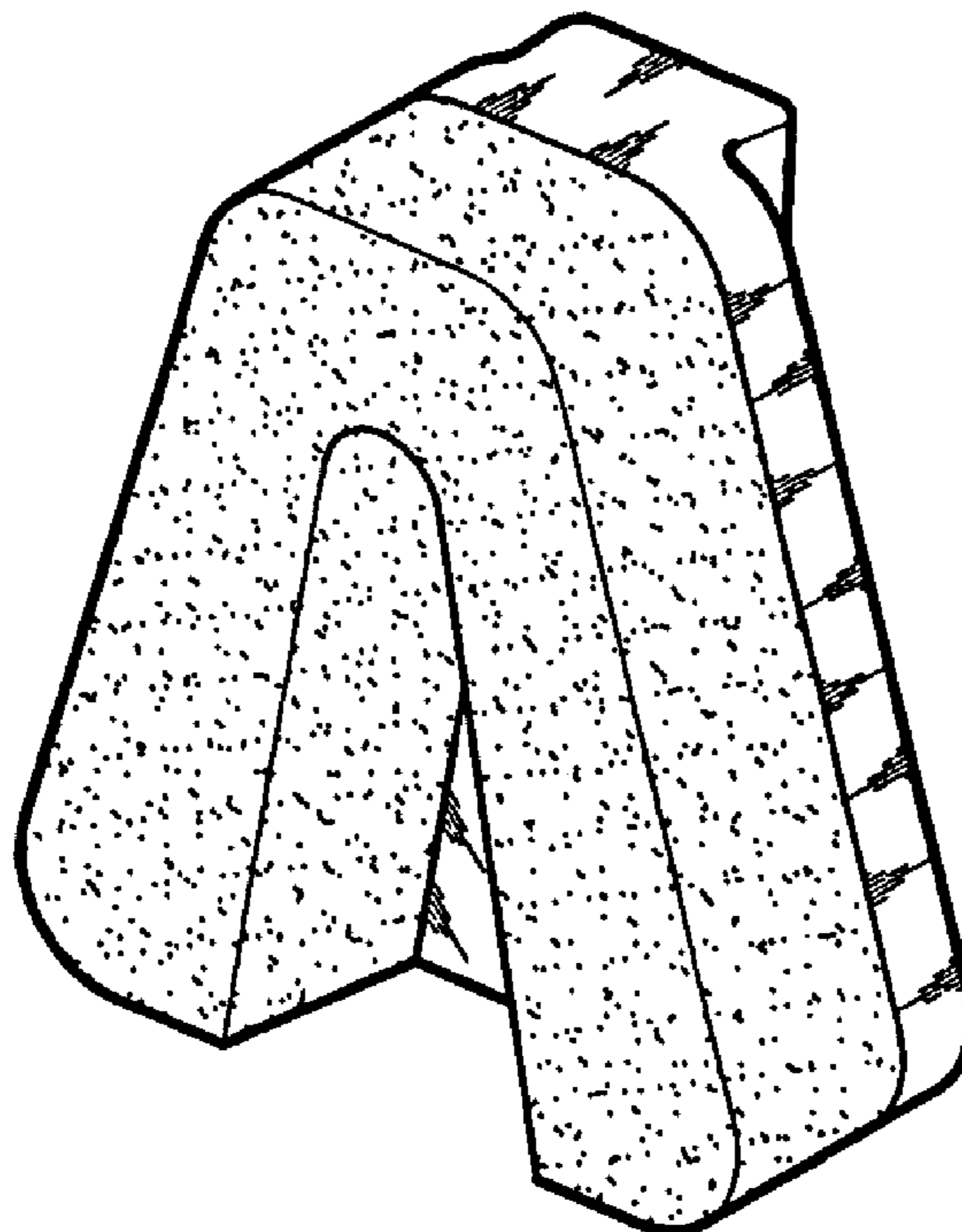
FIG. 6 is a top plan view thereof;

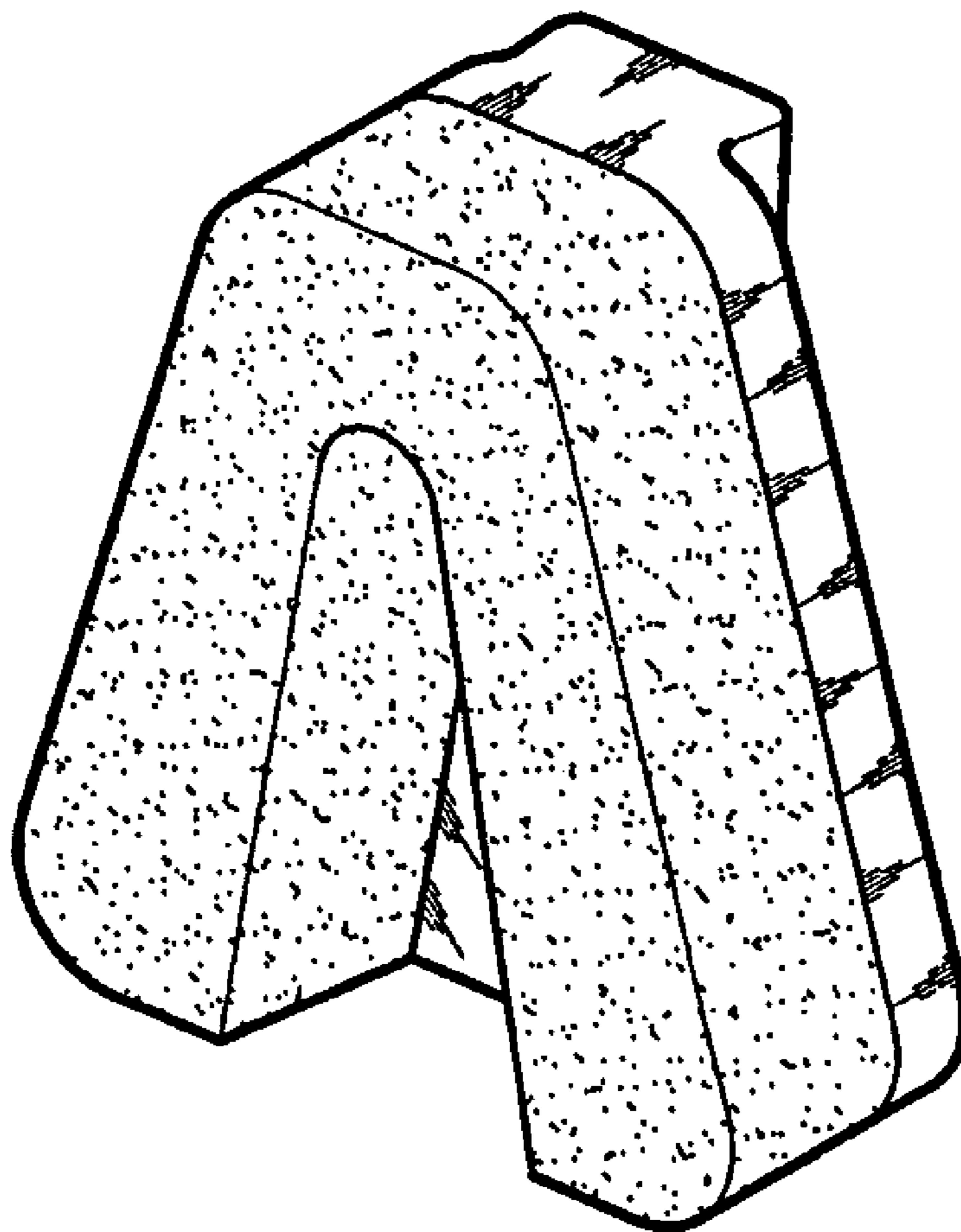
FIG. 8 is a perspective view of a grinding wheel to which the

part of the claimed design.

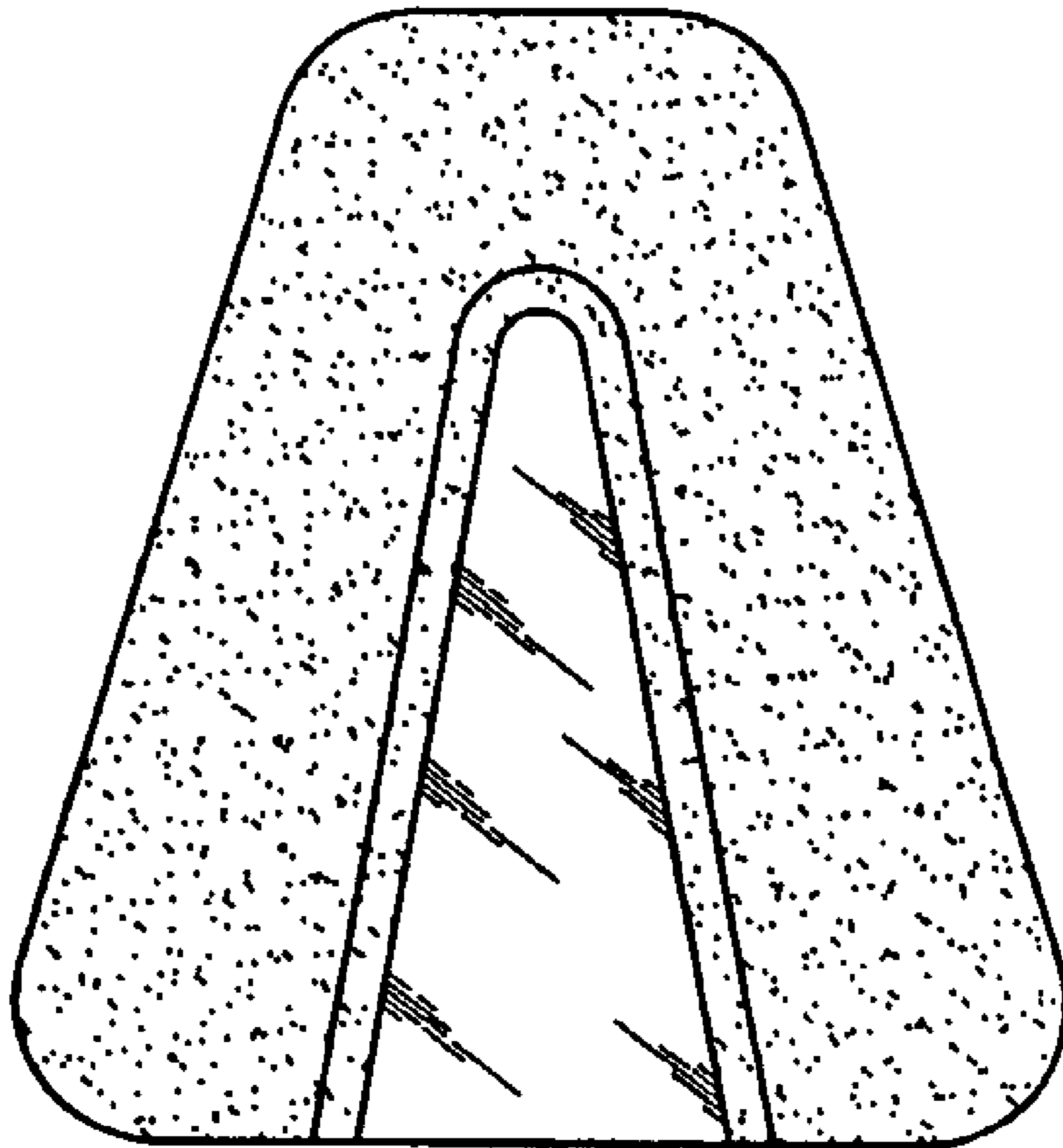

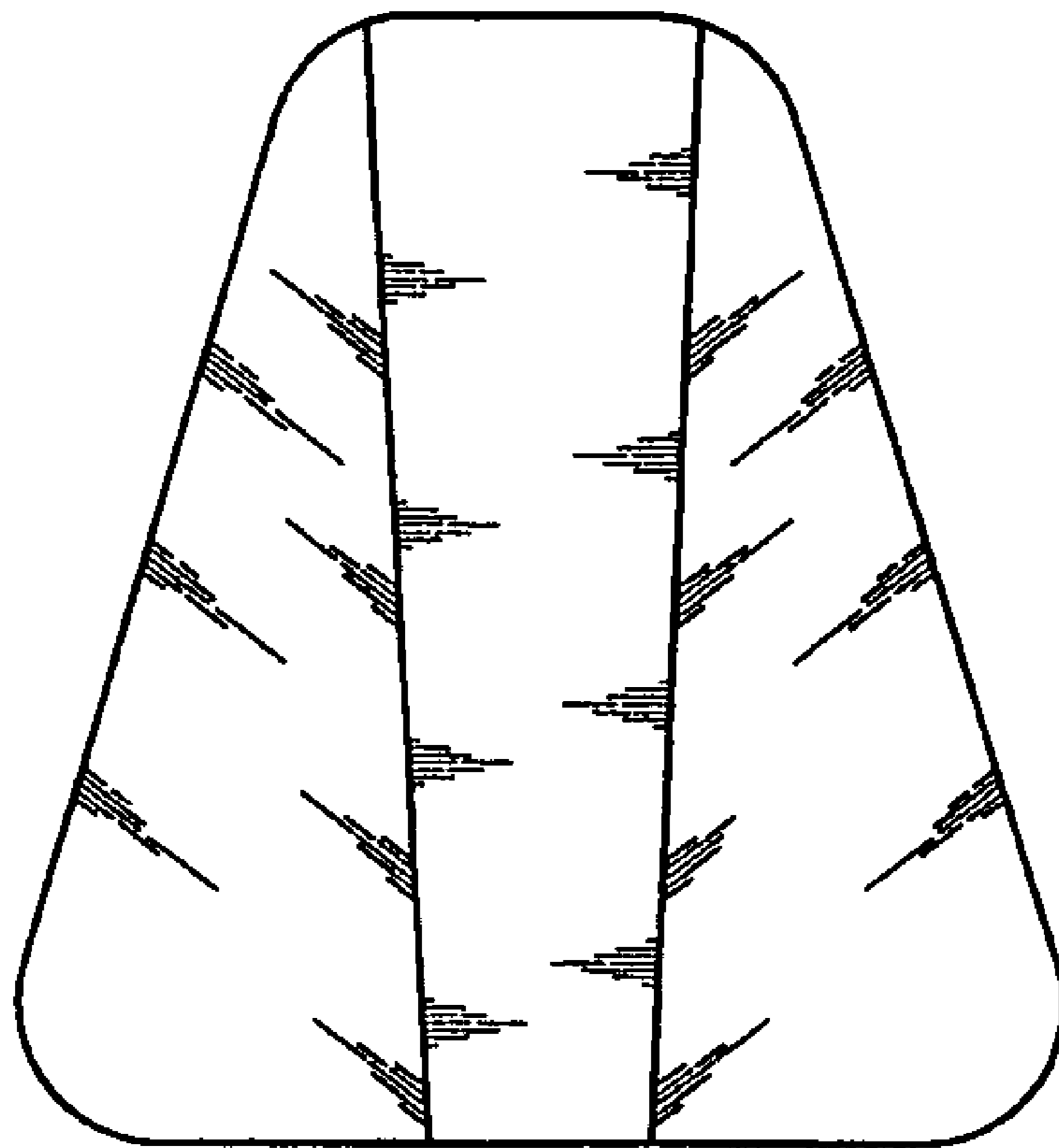

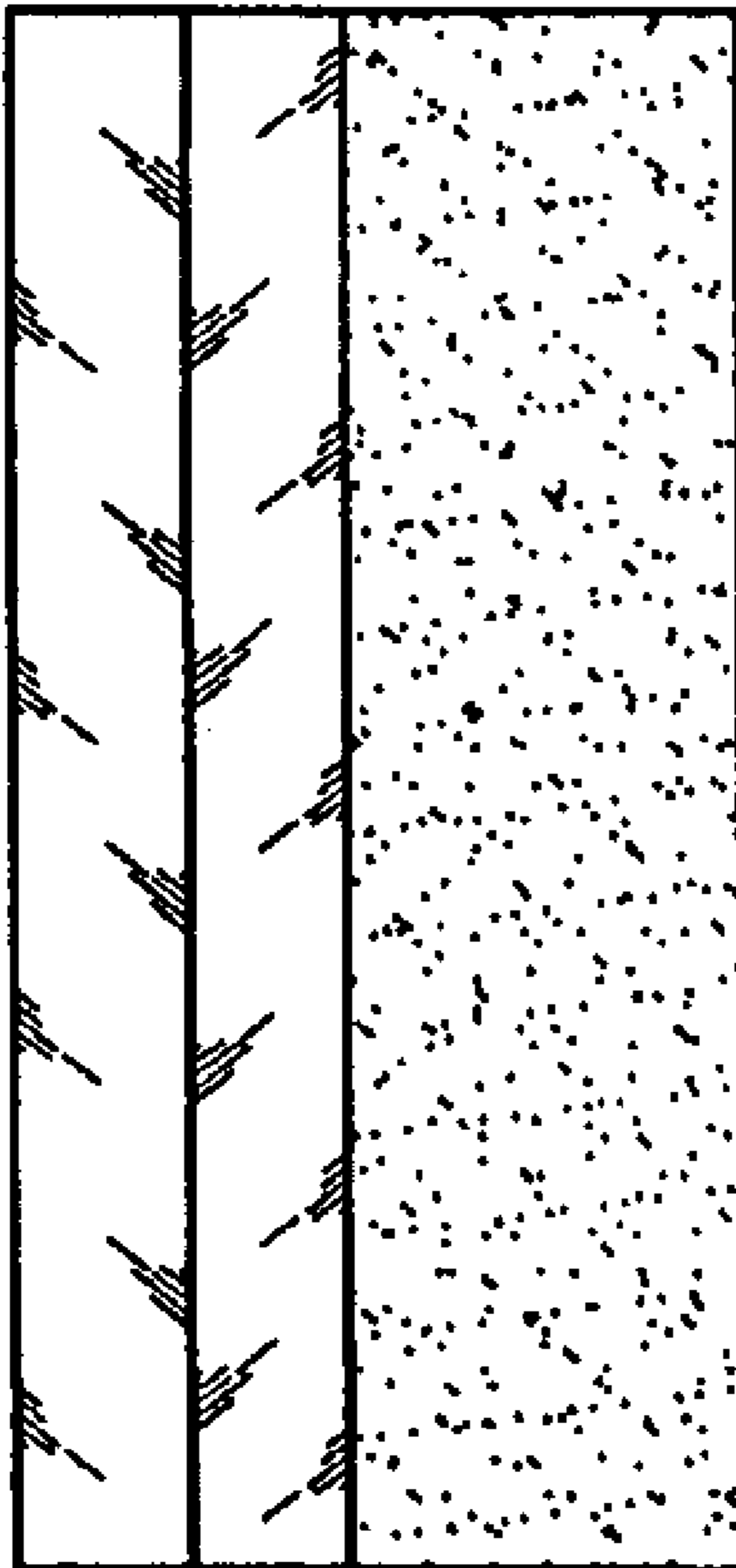

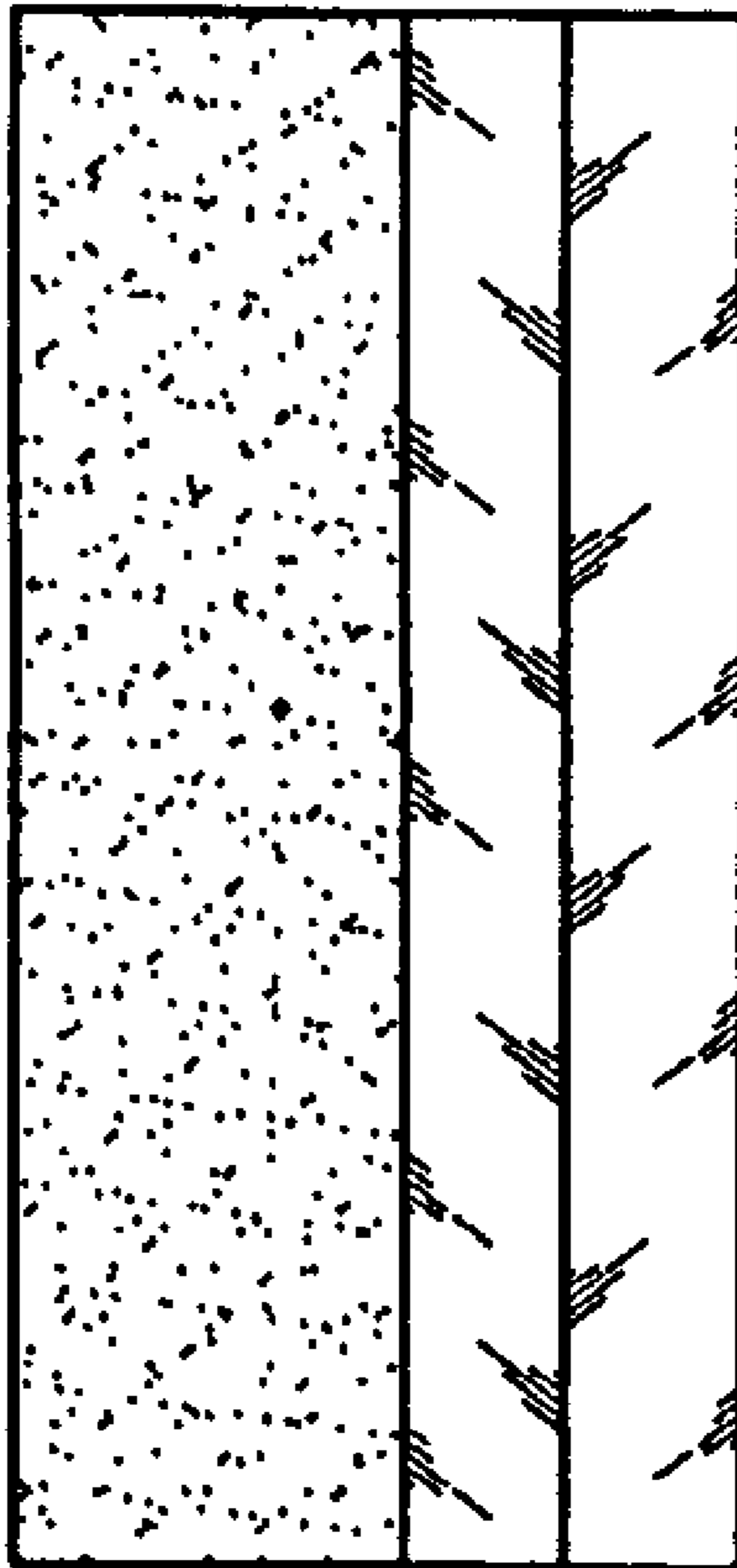

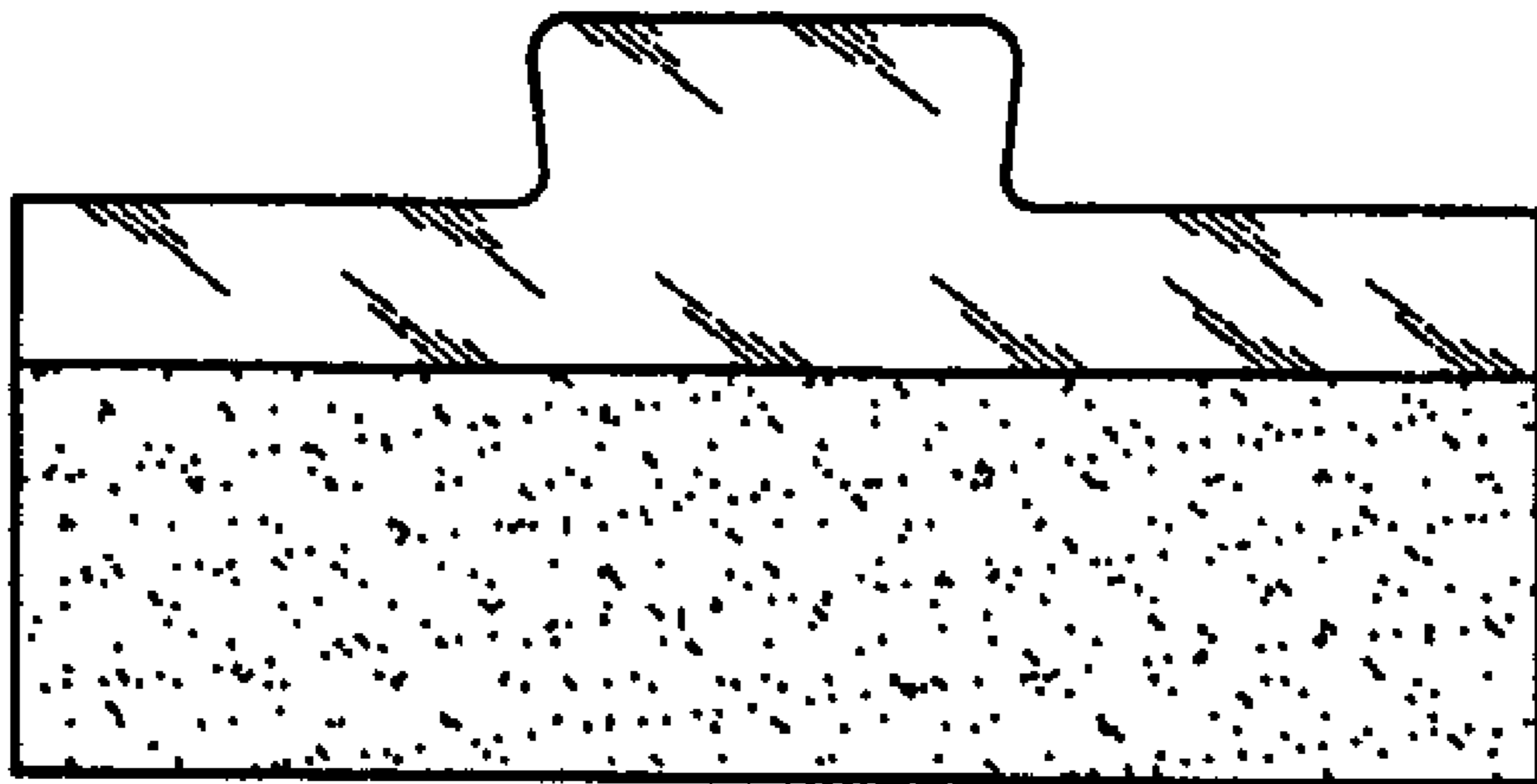

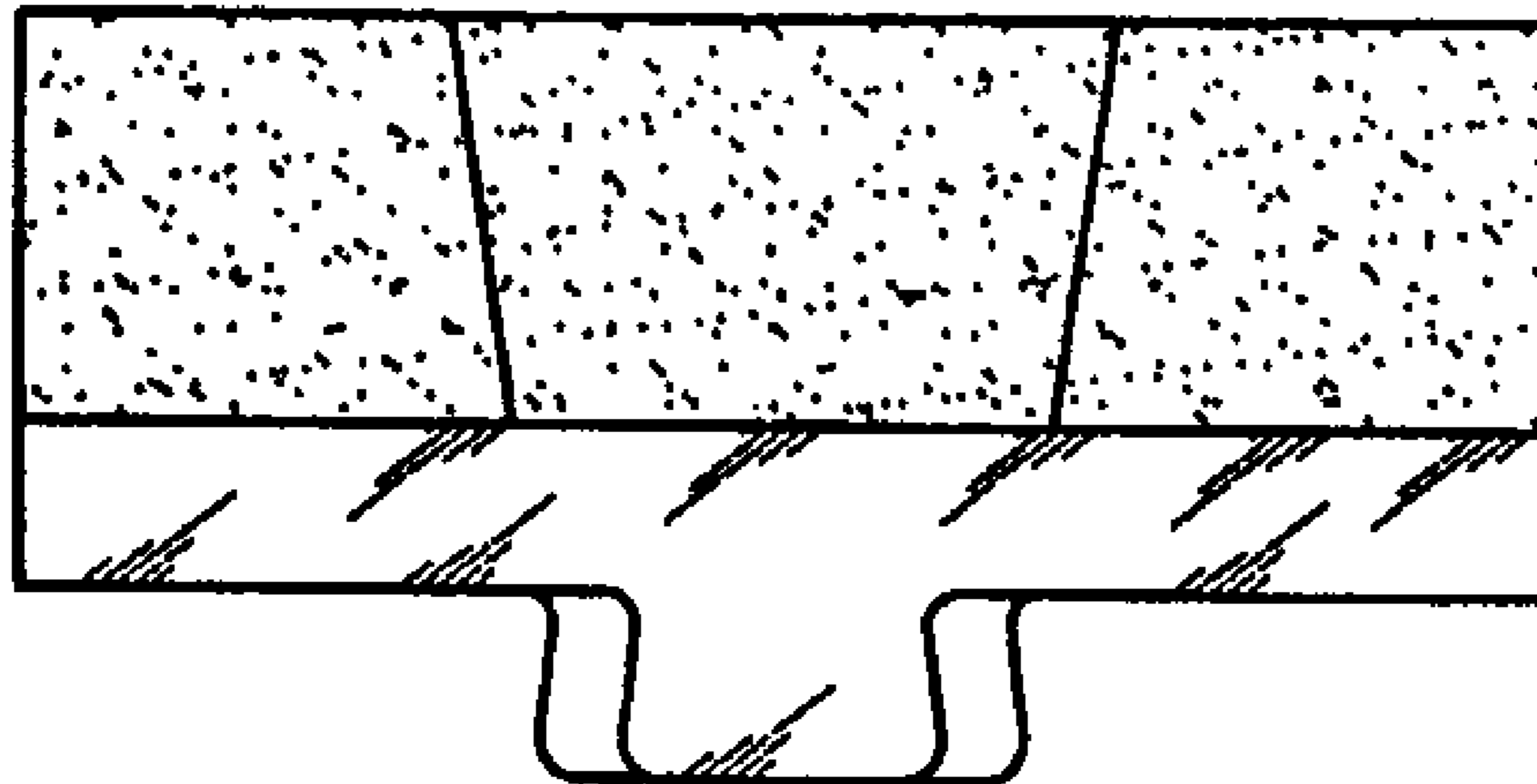
