(57) **CLAIM**

The ornamental design for a postcard and mailer for optical media, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view, in a folded position of a postcard and mailer for optical media showing my new design;

FIG. 2 is a rear view, in a folded position, thereof;

FIG. 3 is a left side elevational view, in a folded position, thereof;

FIG. 4 is a right side elevational view, in a folded position, thereof;

FIG. 5 is a top plan view, in a folded position, thereof;

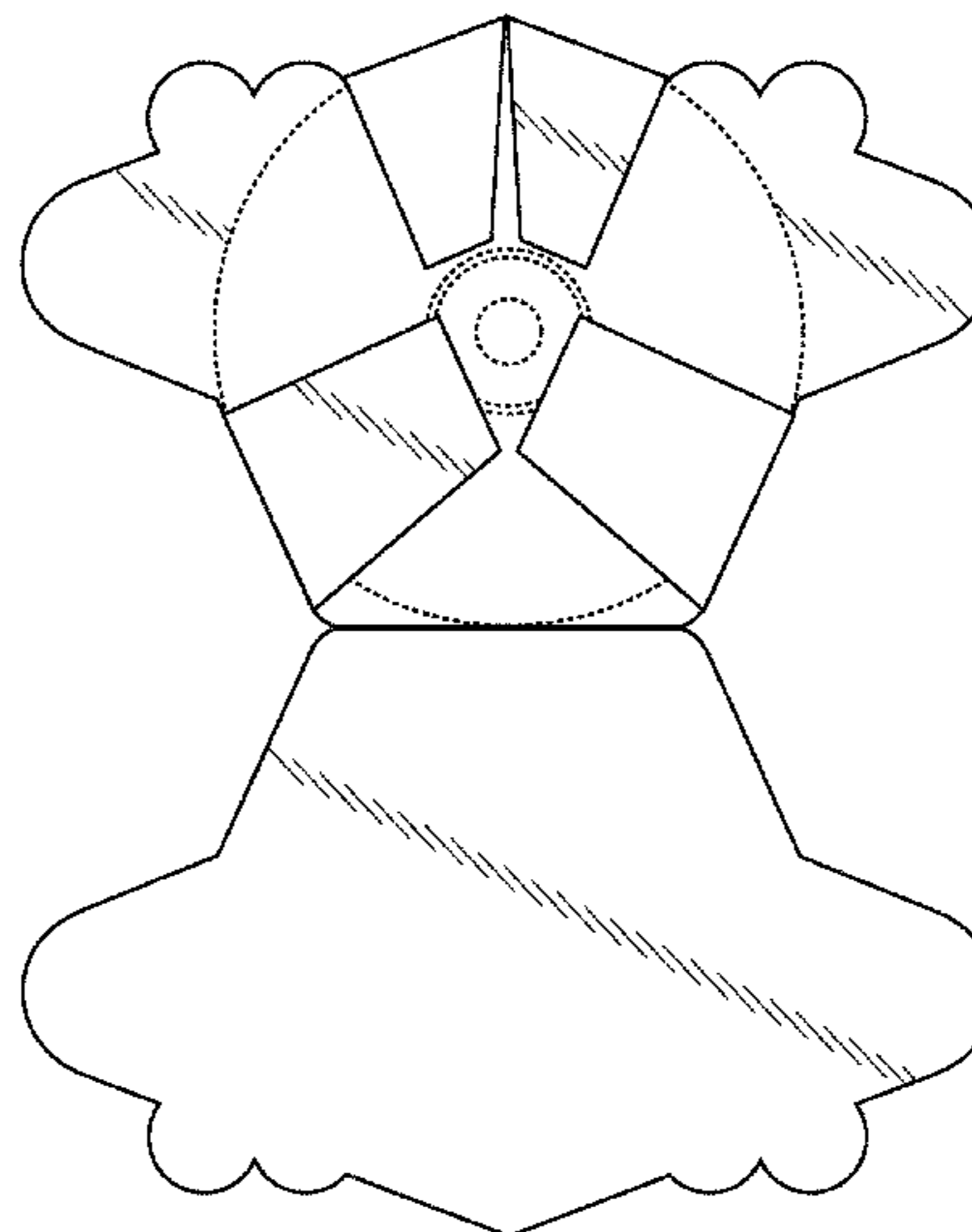
FIG. 6 is a bottom plan view, in a folded position, thereof;

FIG. 7 is a front and rear outside view, unfolded with the tabs in an open position, thereof; and,

FIG. 8 is an interior view, unfolded with the tabs in a fold position, thereof.

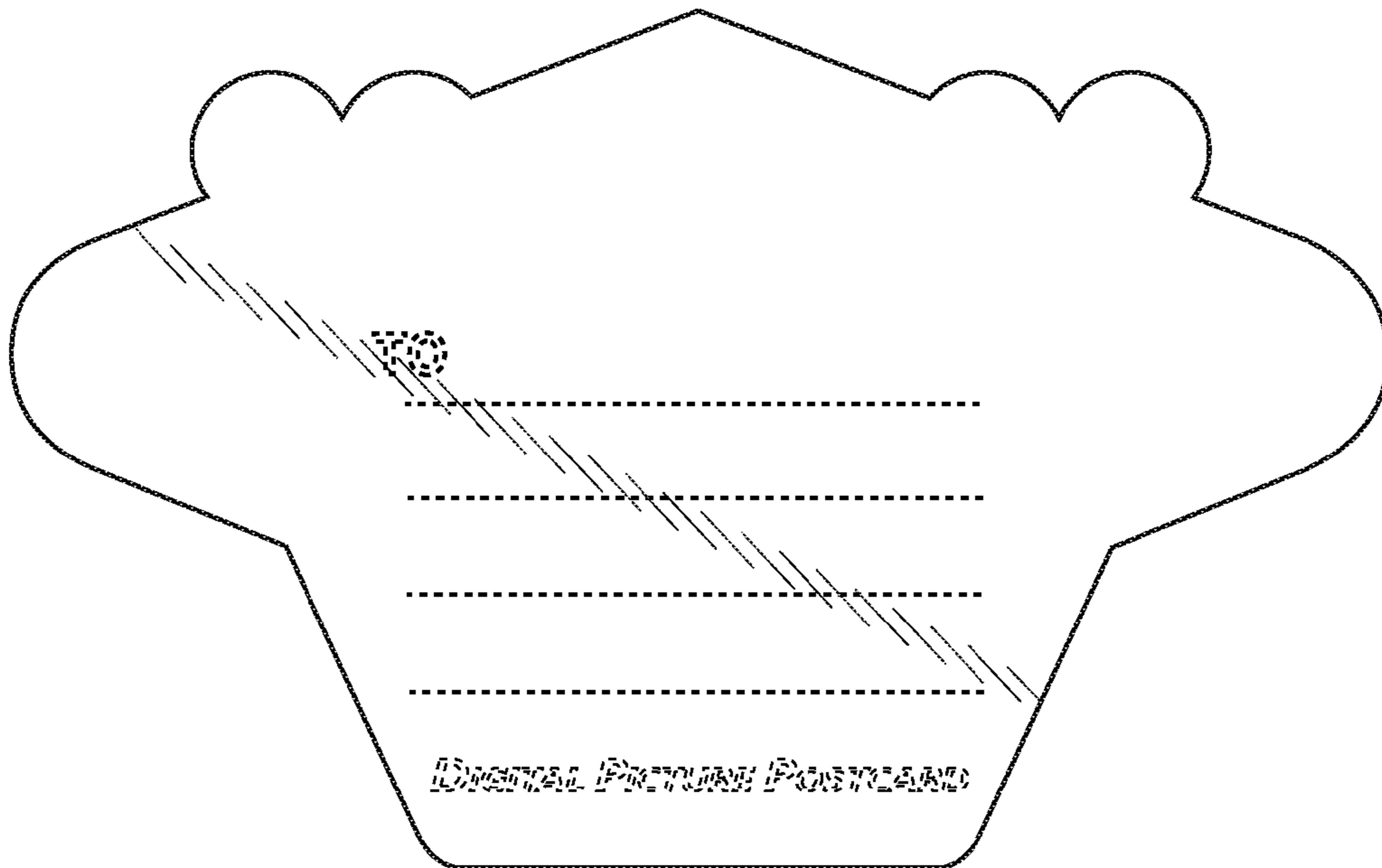
The broken line showing of surface indicia and optical media are included for the purpose of illustrating environmental structure and forms no part of the claimed design.

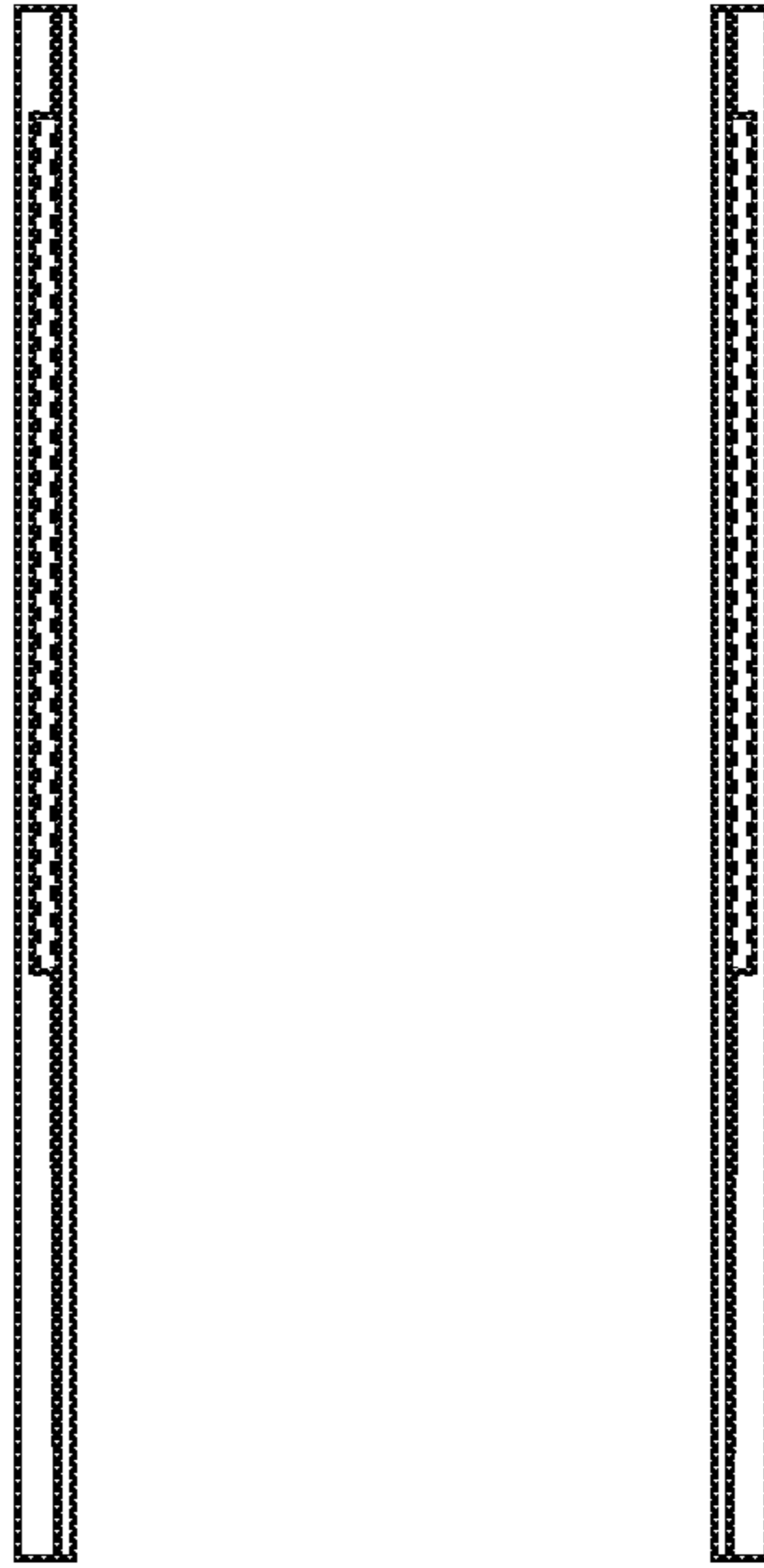

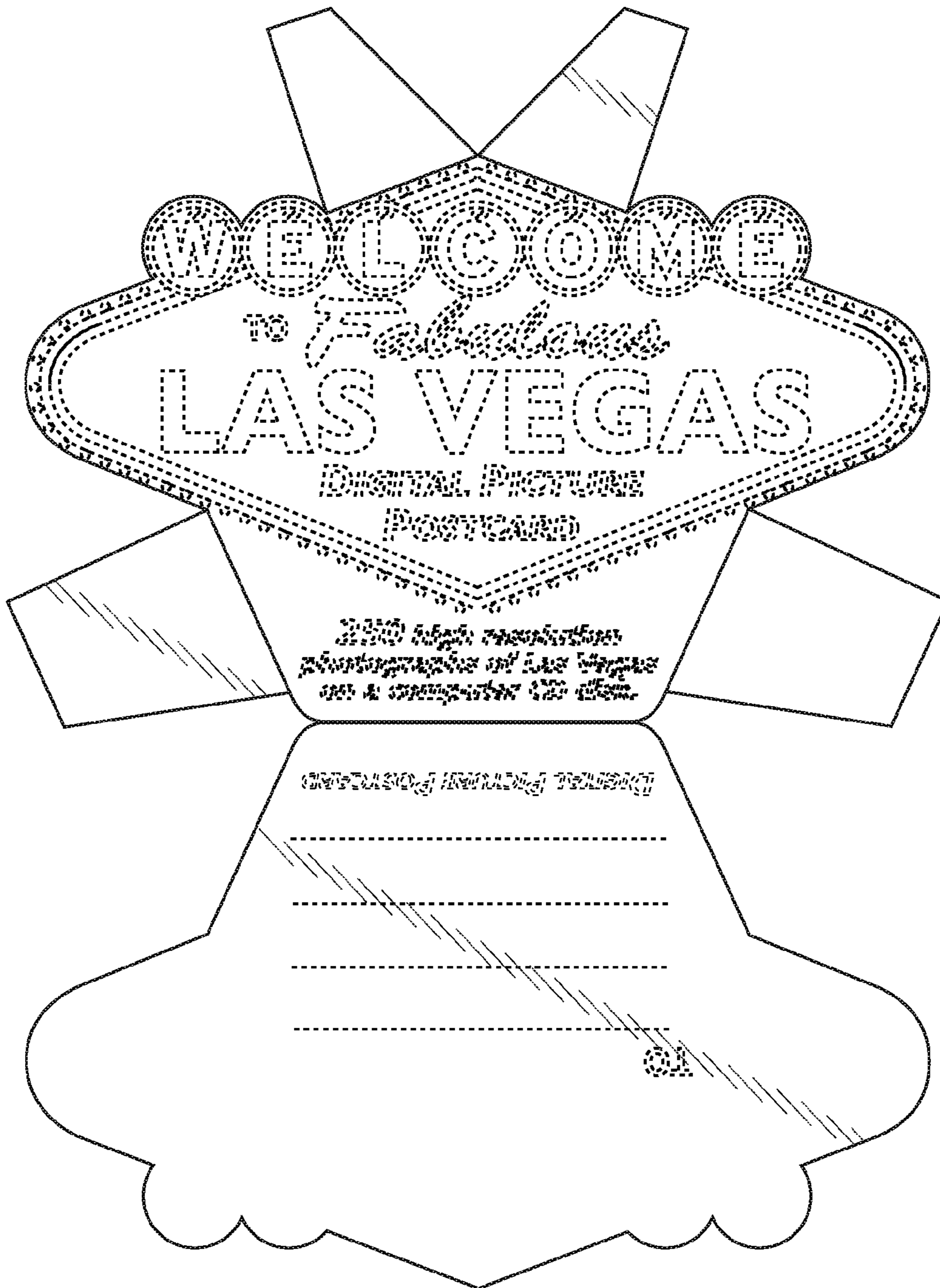

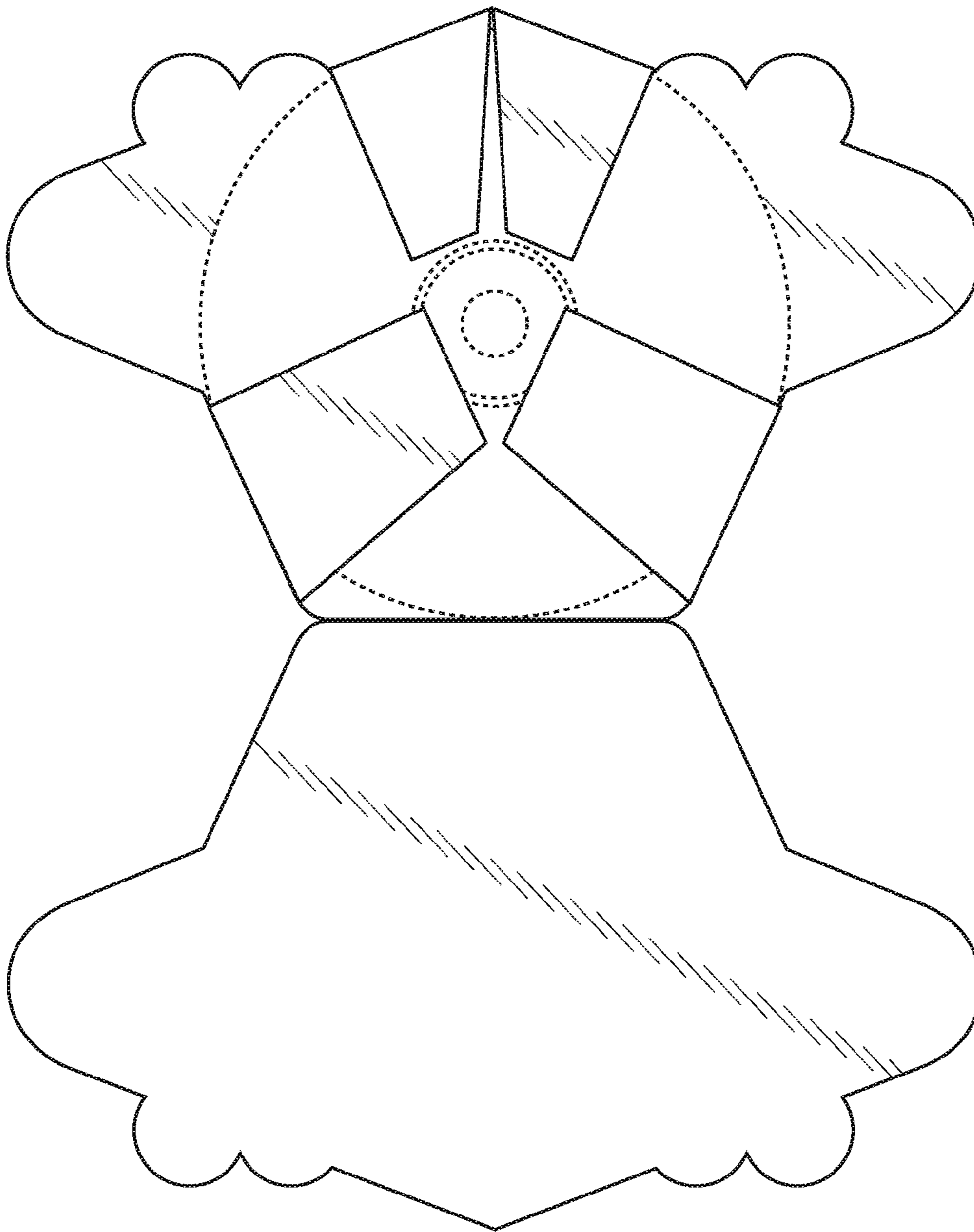
