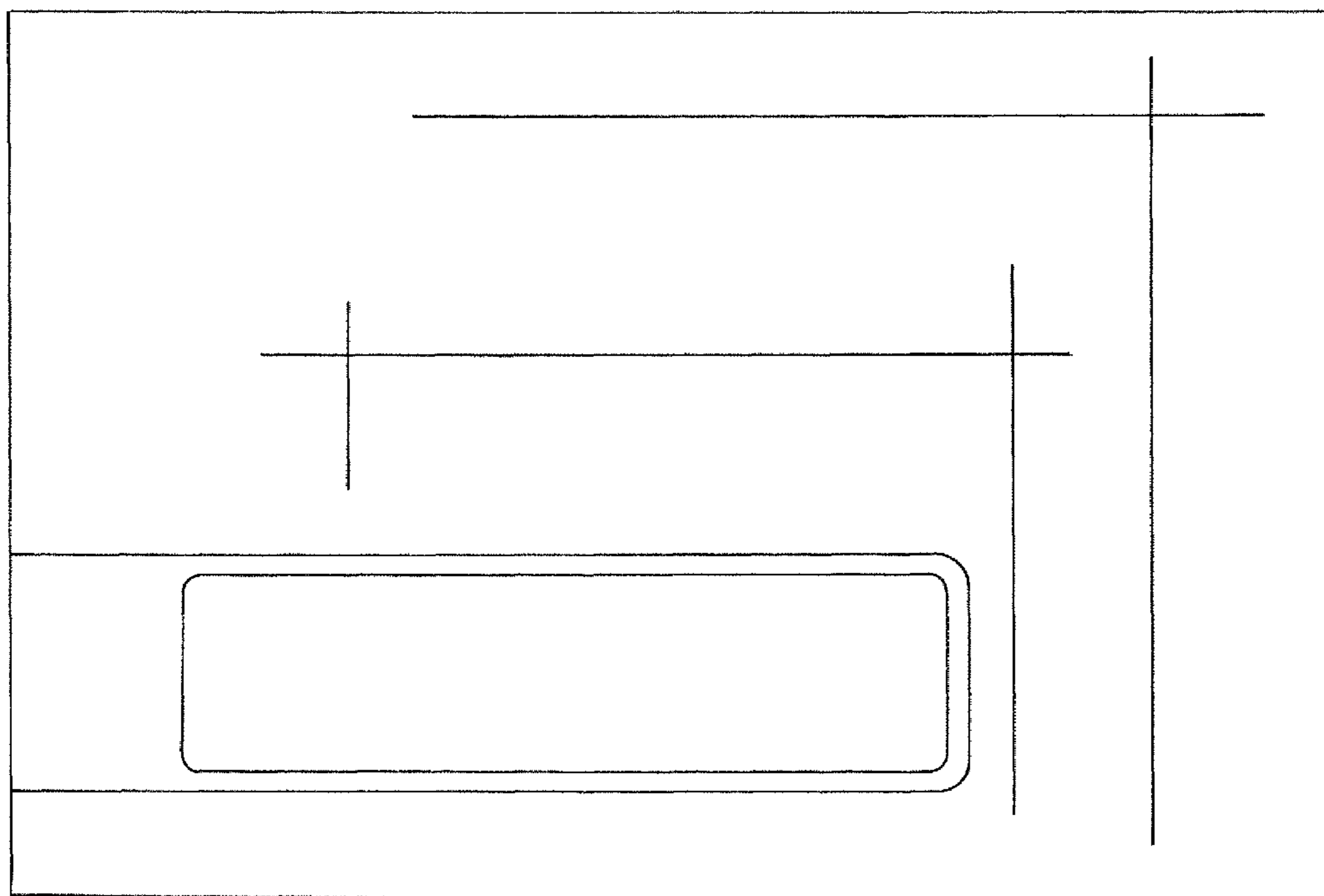
The ornamental design for store folder for an instruction manual, as shown and described.

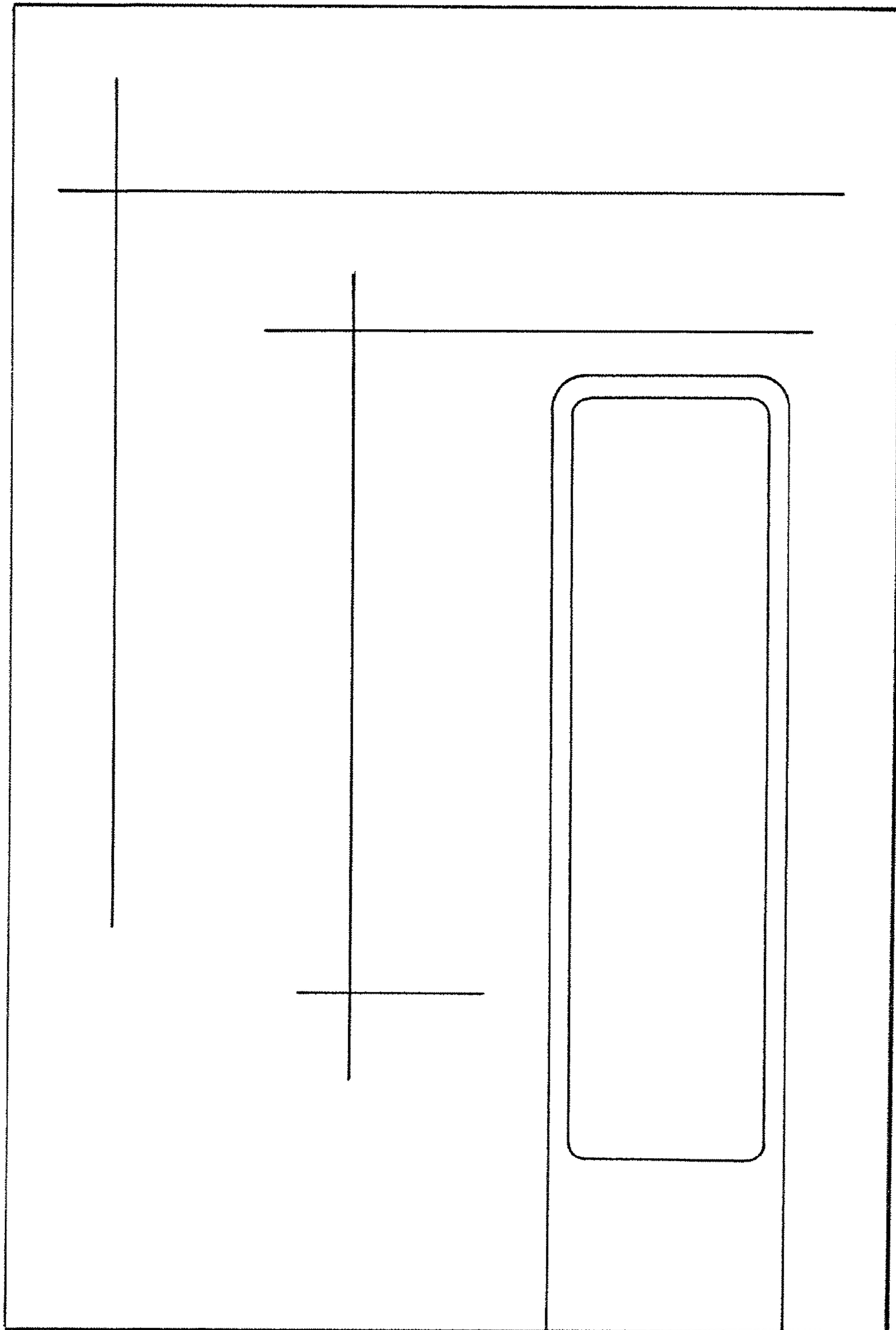

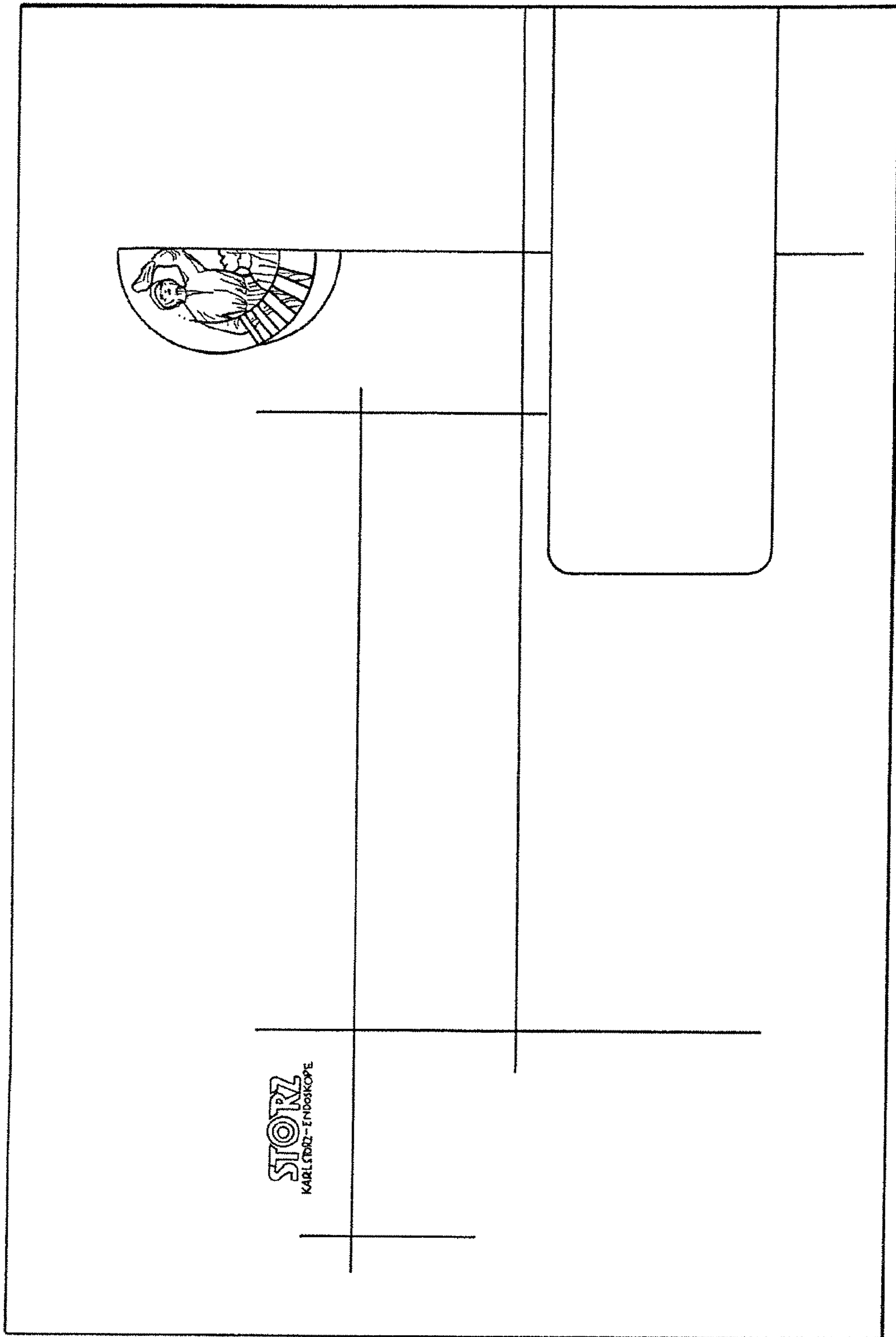
