**DESCRIPTION**

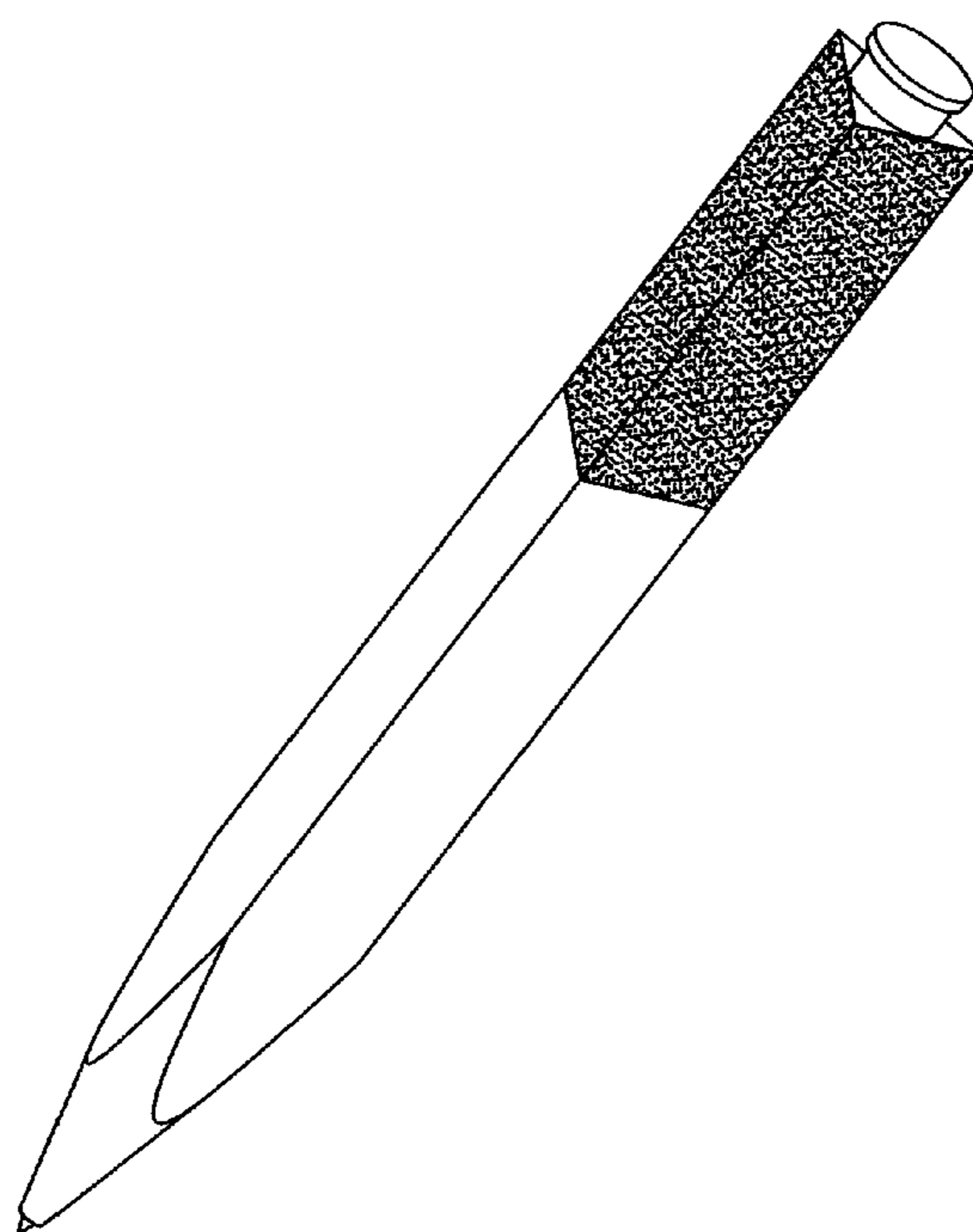
FIG. 1 is a top plan view of a triangular-shaped writing instrument with abrasive surface on upper portion showing our new design;

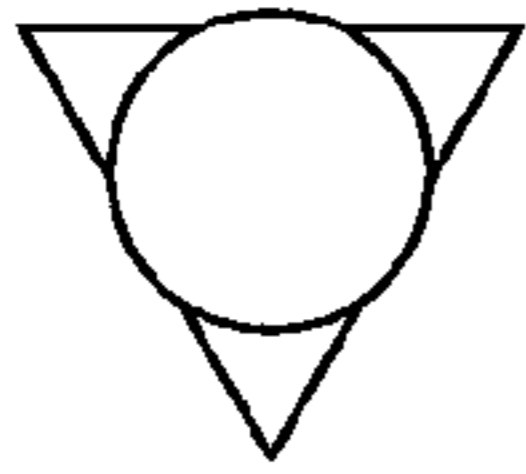

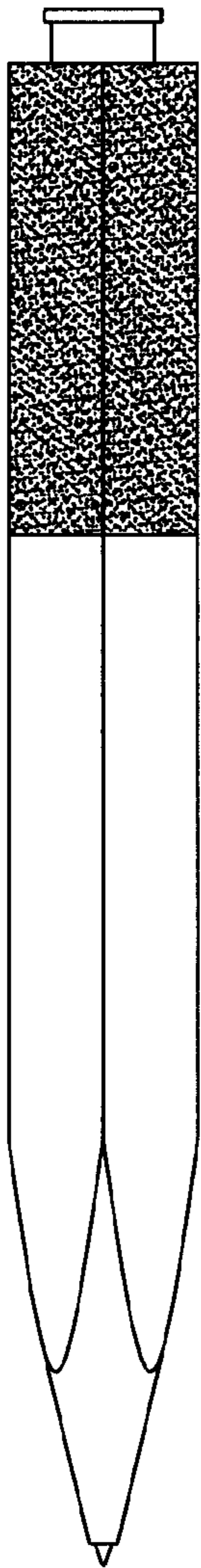

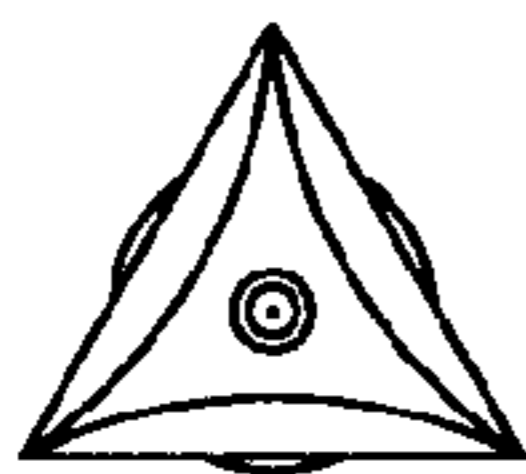

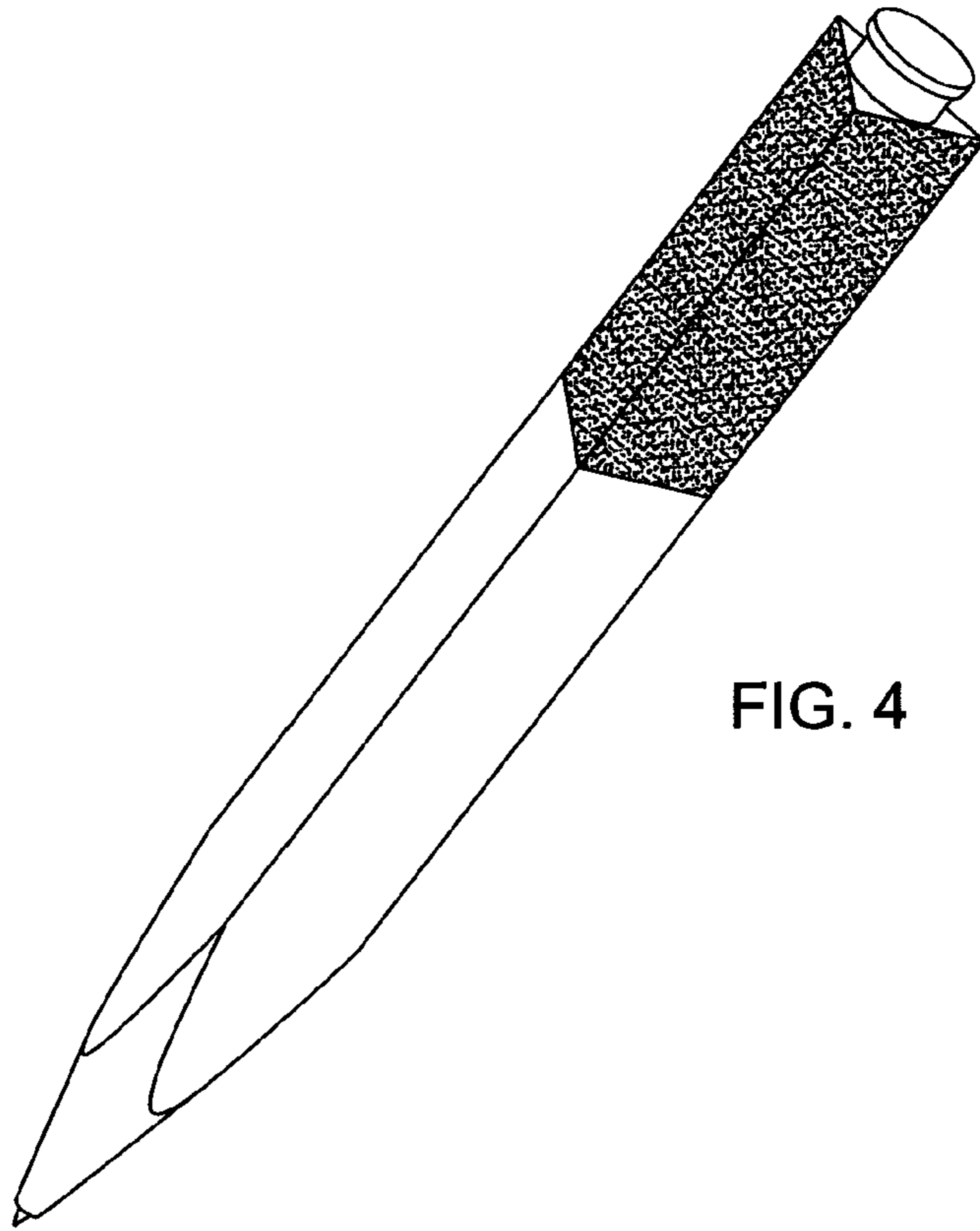
