We claim the ornamental design for a birdfeeder, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the birdfeeder showing our new design;

FIG. 2 is a reduced front view in elevation thereof;

FIG. 3 is a reduced right side view in elevation thereof;

FIG. 4 is a reduced left side view in elevation thereof;

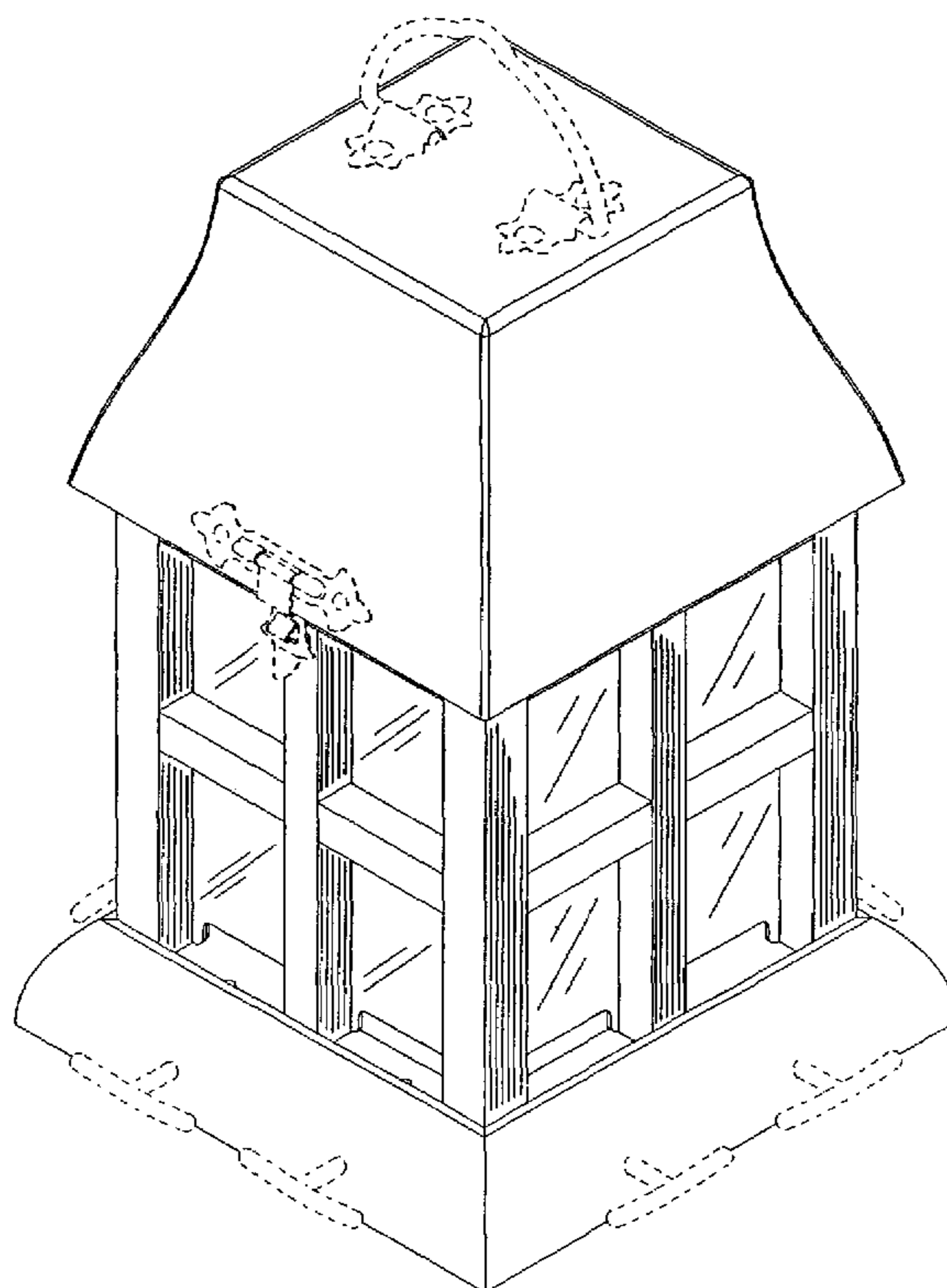
FIG. 5 is a reduced back view in elevation thereof;

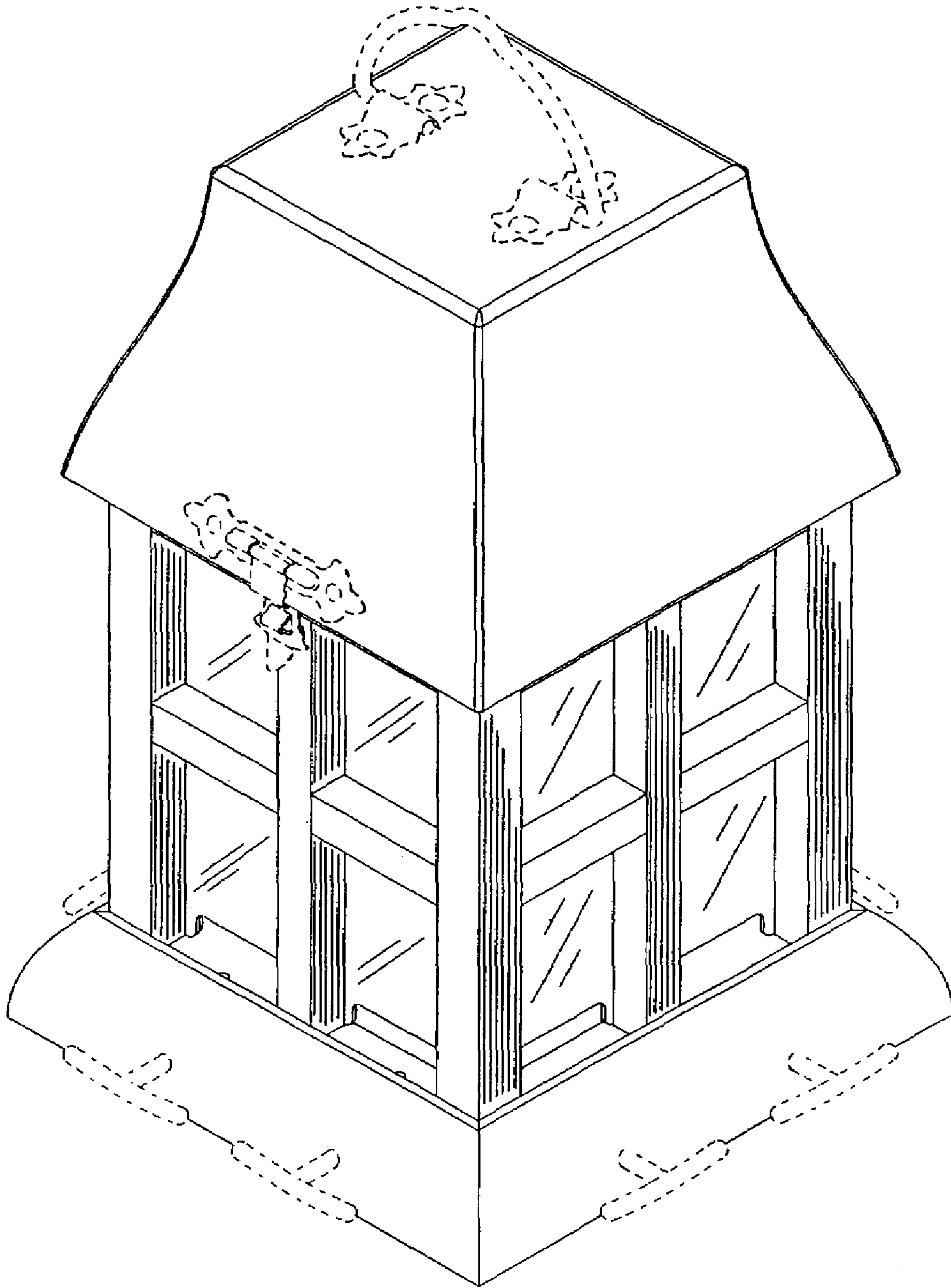

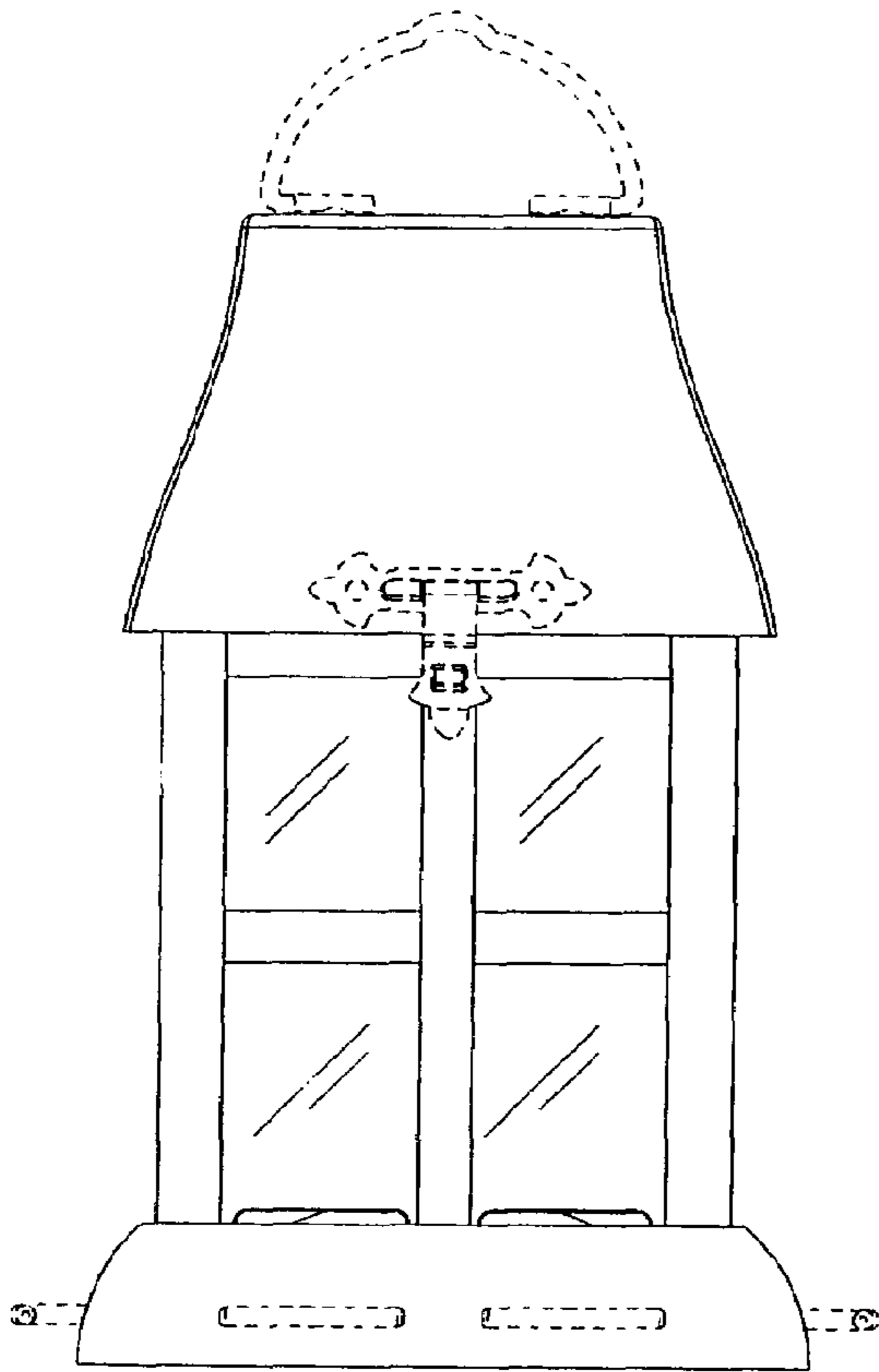

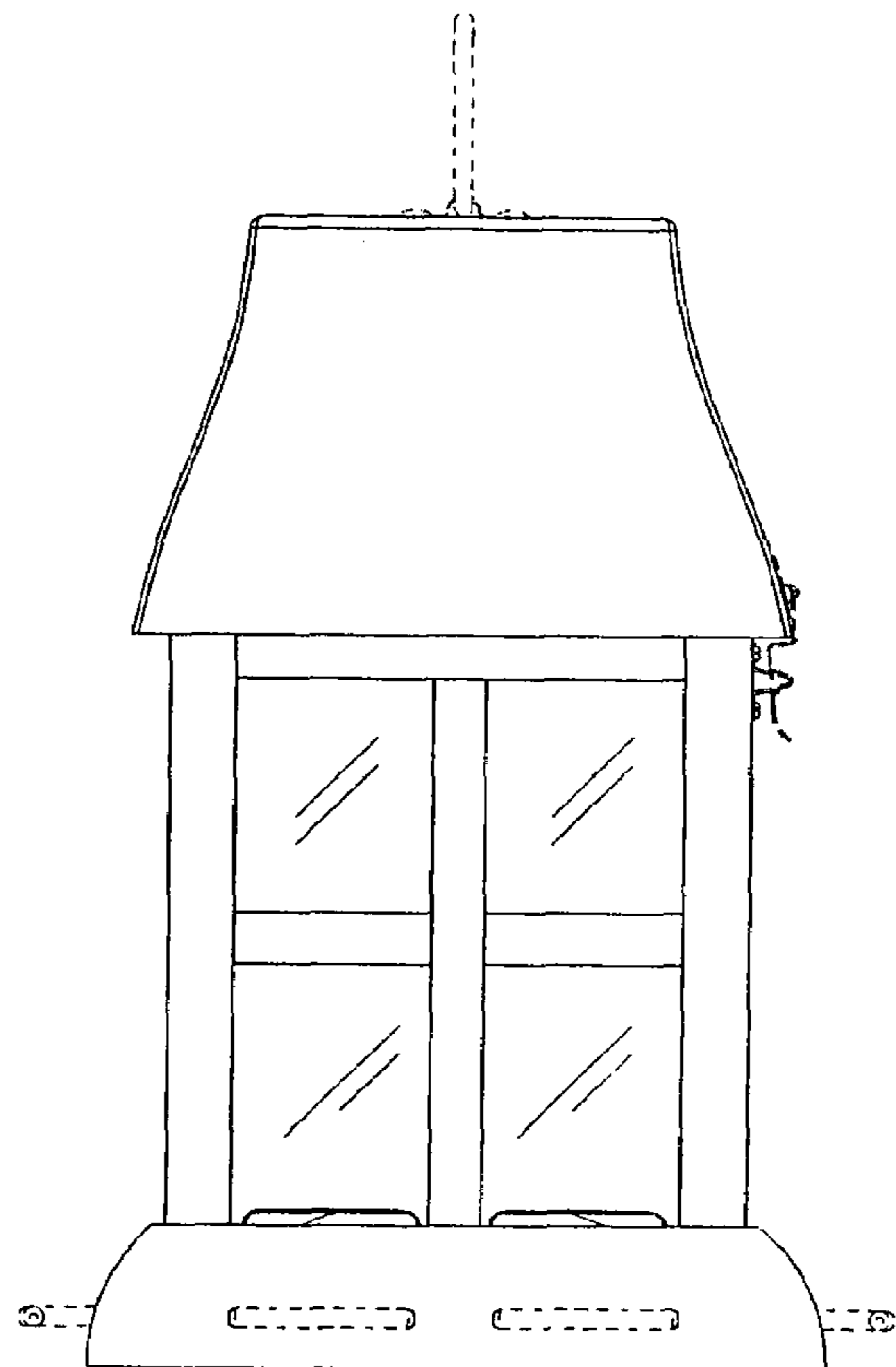

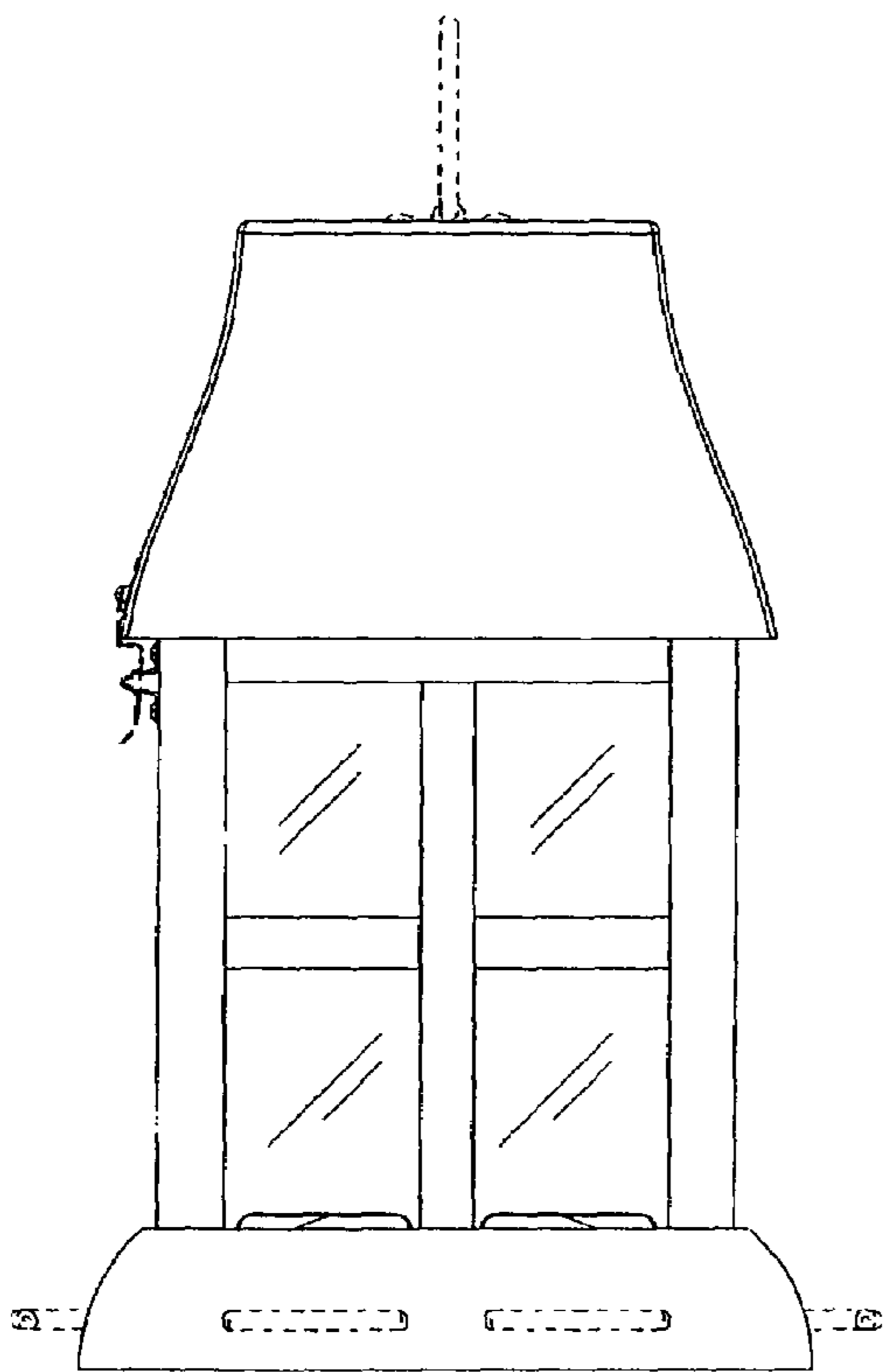

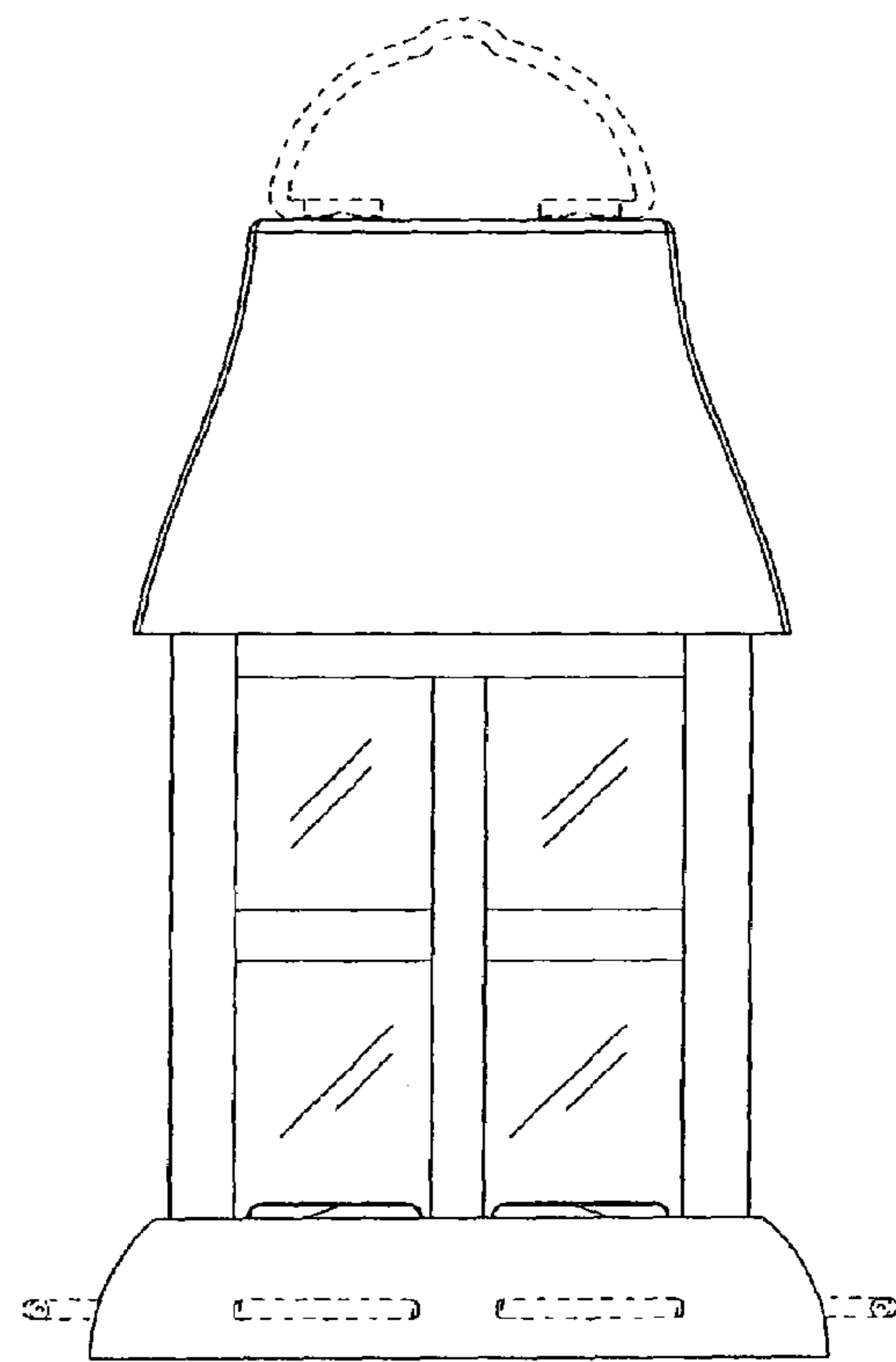

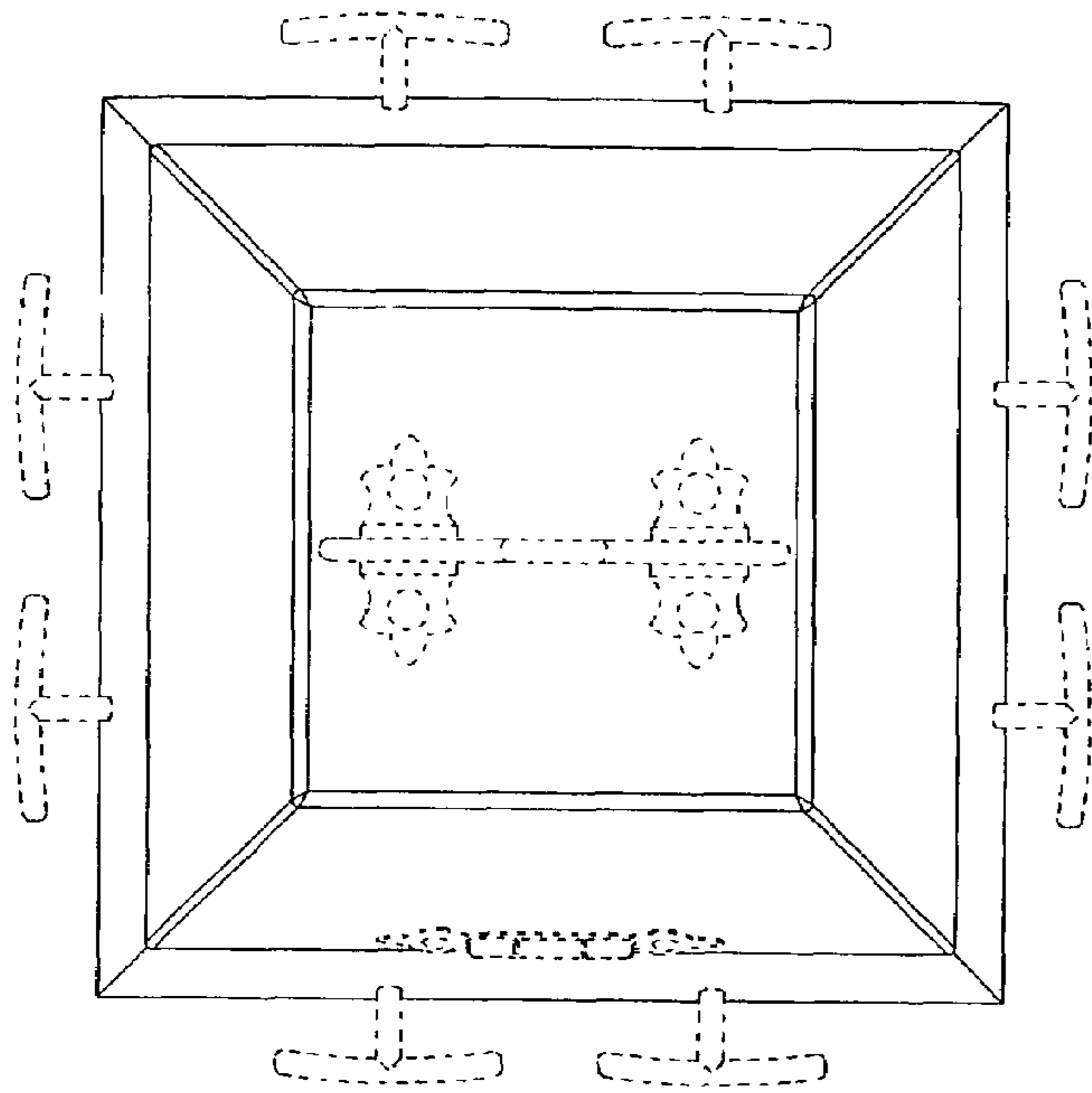

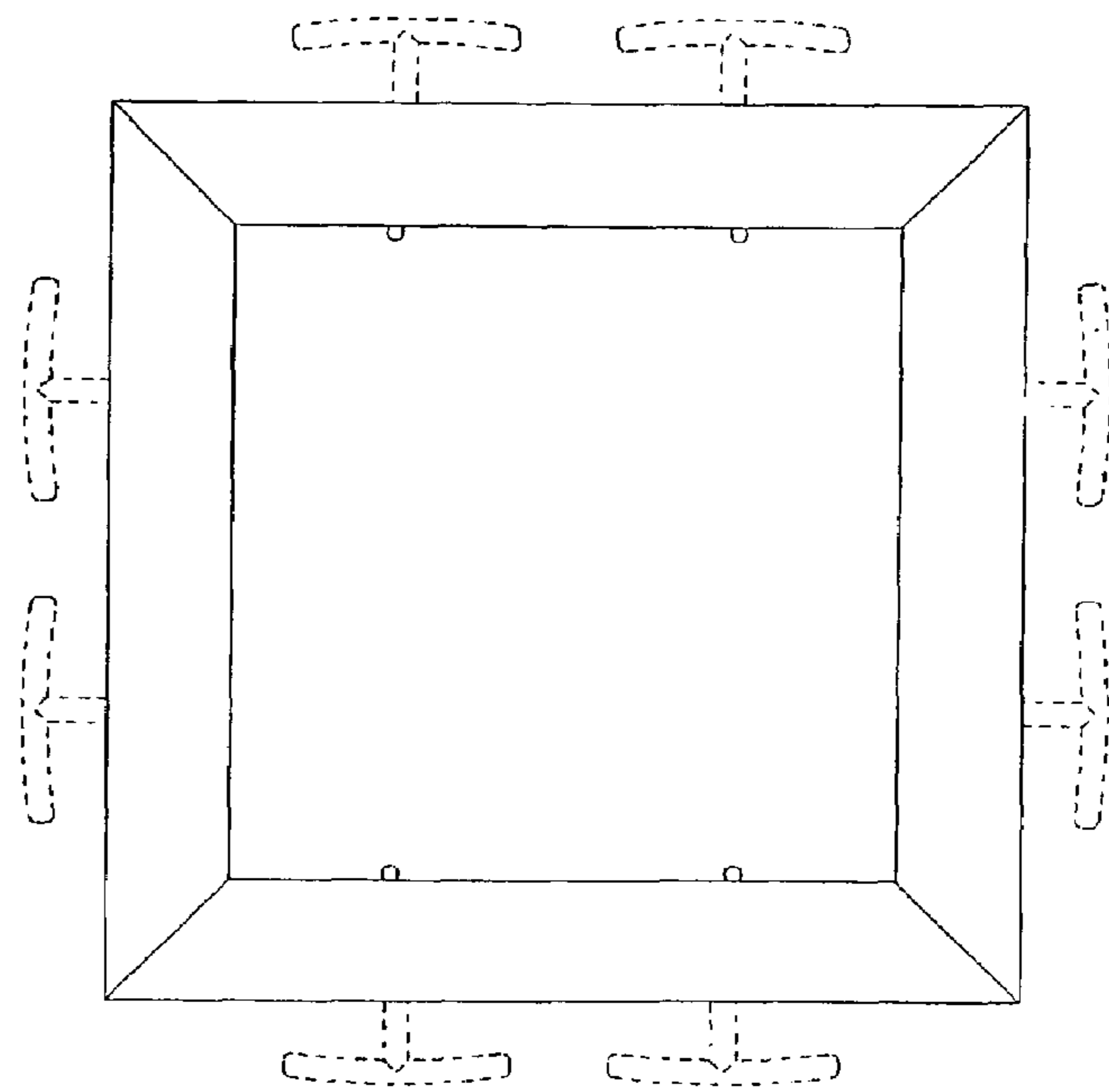
