DESCRIPTION

FIG. 1 is a front perspective view of one embodiment of a
foam-dispensing nozzle of the present invention.

FIG. 2 is a top view of the foam-dispensing nozzle of FIG.
1, the bottom view of the foam-dispensing nozzle being
identical to the top view.

FIG. 3 is a right-side view of the foam-dispensing nozzle of
FIG. 1, the left-side view of the foam-dispensing nozzle
being identical to the right-side view.

FIG. 4 is a front view of the foam-dispensing nozzle of FIG.
1.

FIG. 5 is a rear view of the foam-dispensing nozzle of FIG.
1.

FIG. 6 is a front perspective view of another embodiment of
a foam-dispensing nozzle of the present invention.

FIG. 7 is a top view of the foam-dispensing nozzle of FIG.
6, the bottom view of the foam-dispensing nozzle being
identical to the top view.

FIG. 8 is a right-side view of the foam-dispensing nozzle of
FIG. 6, the left-side view of the foam-dispensing nozzle
being identical to the right-side view.

FIG. 9 is a front view of the foam-dispensing nozzle of FIG.
6; and,

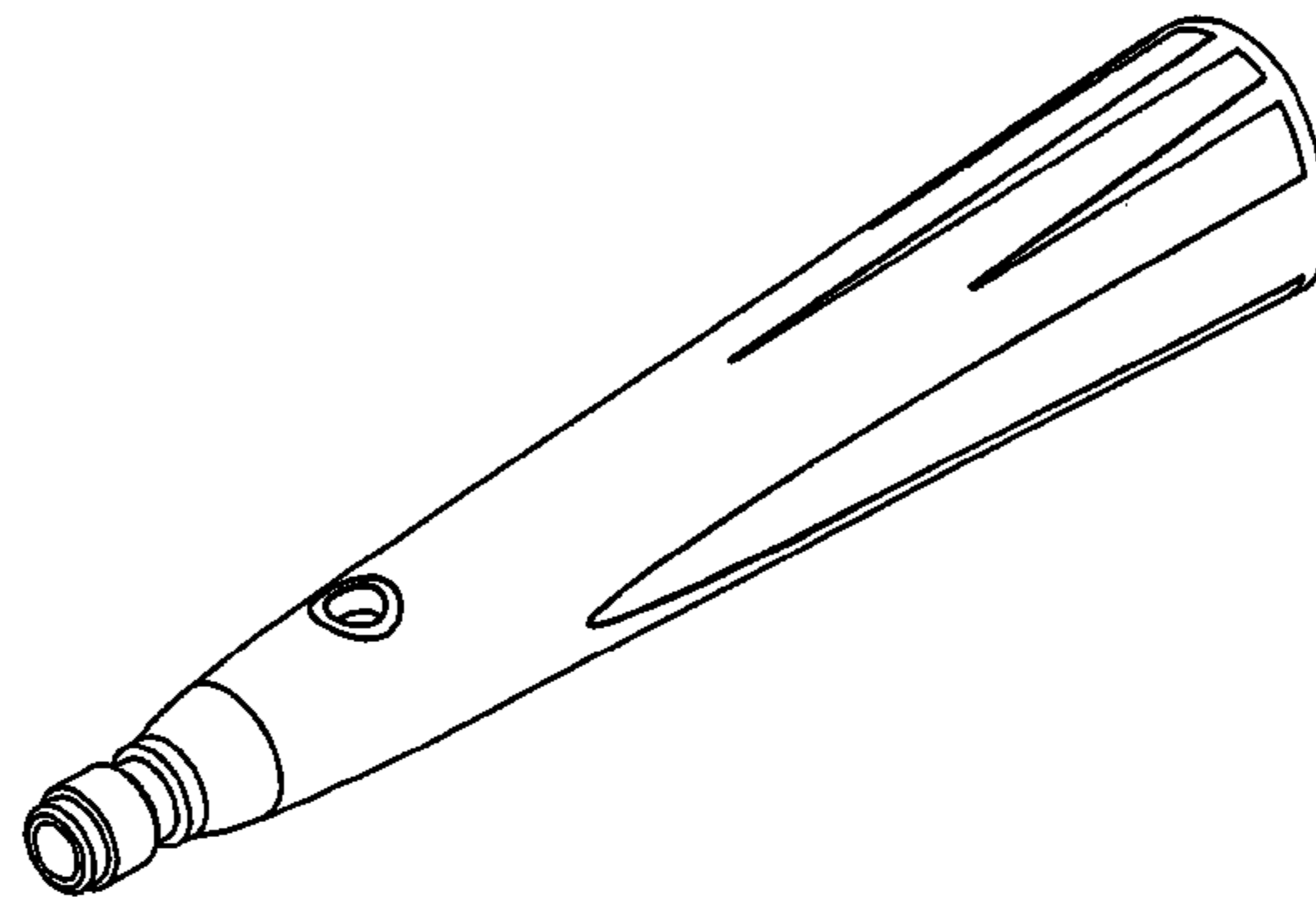
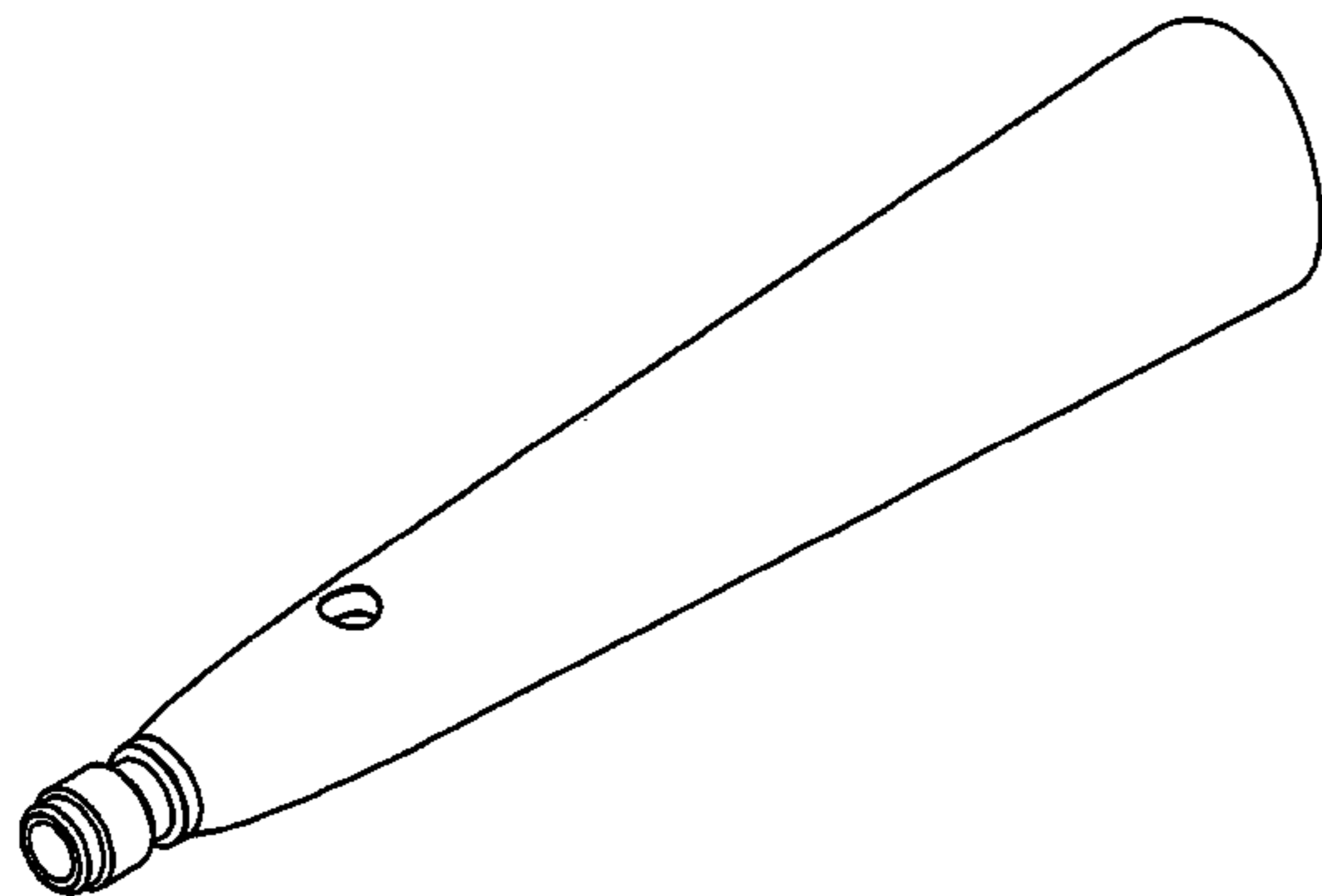
FIG. 10 is a rear view of the foam-dispensing nozzle of FIG.

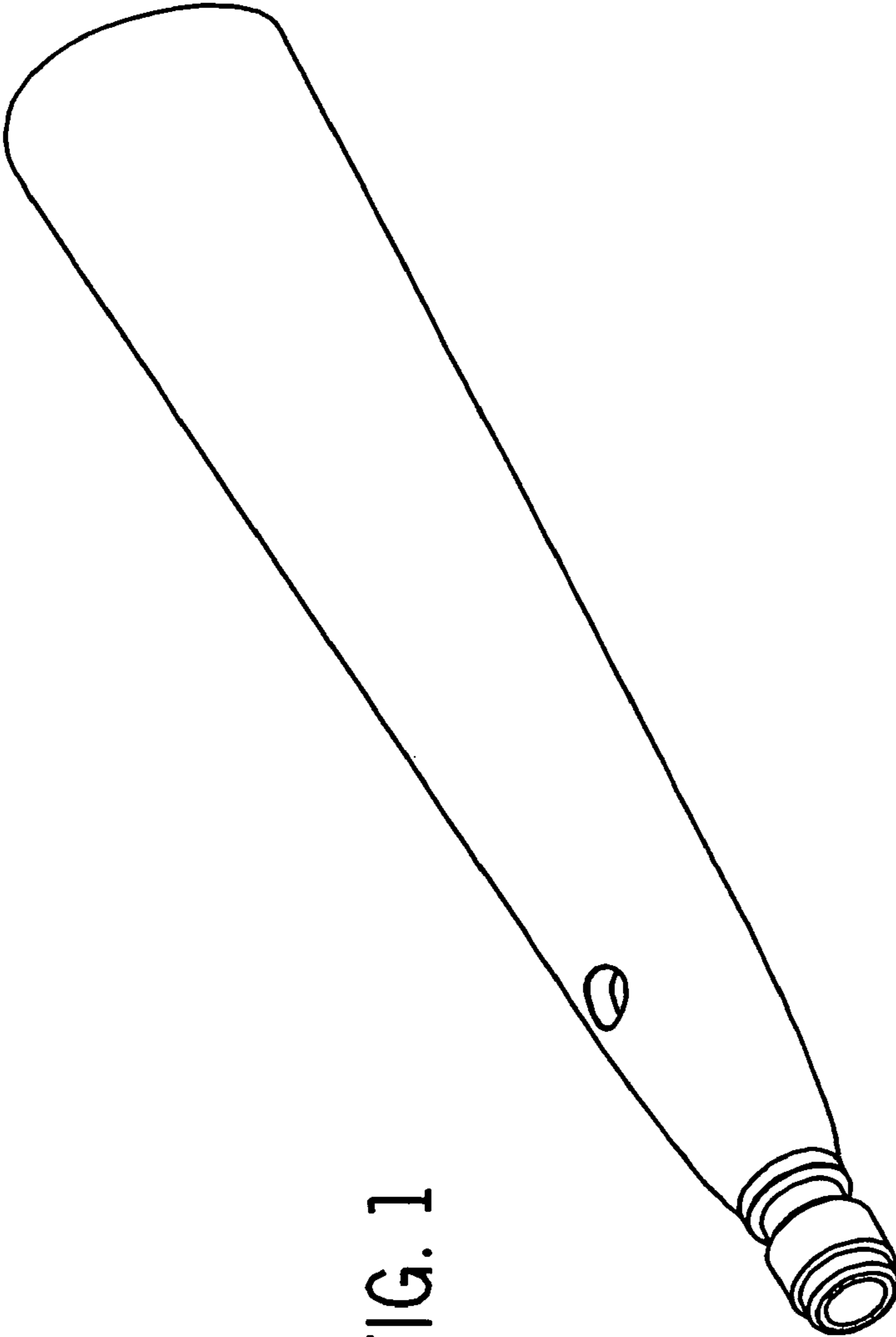
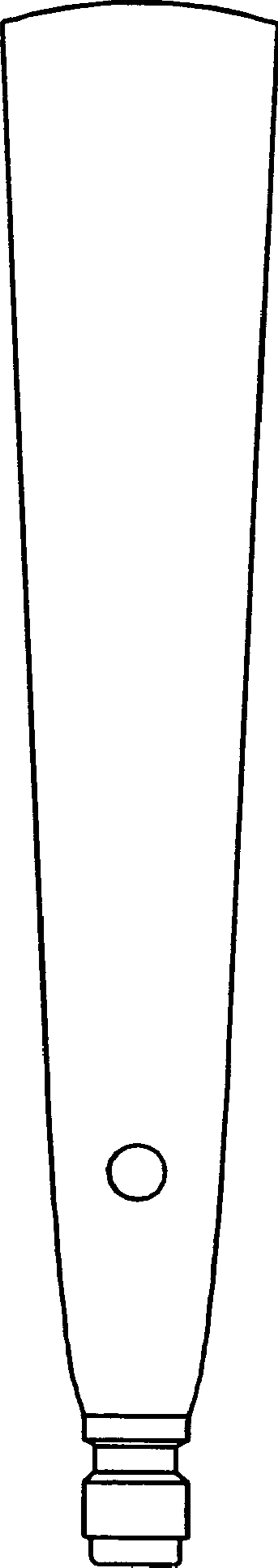

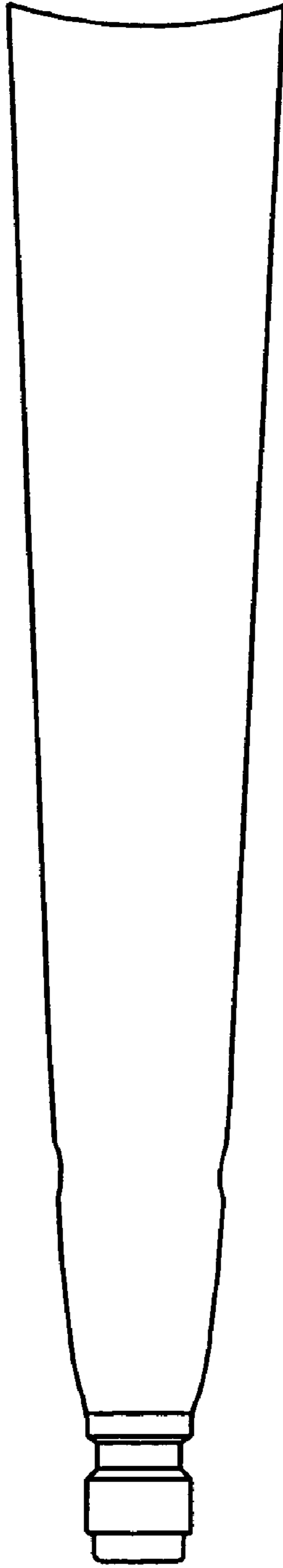

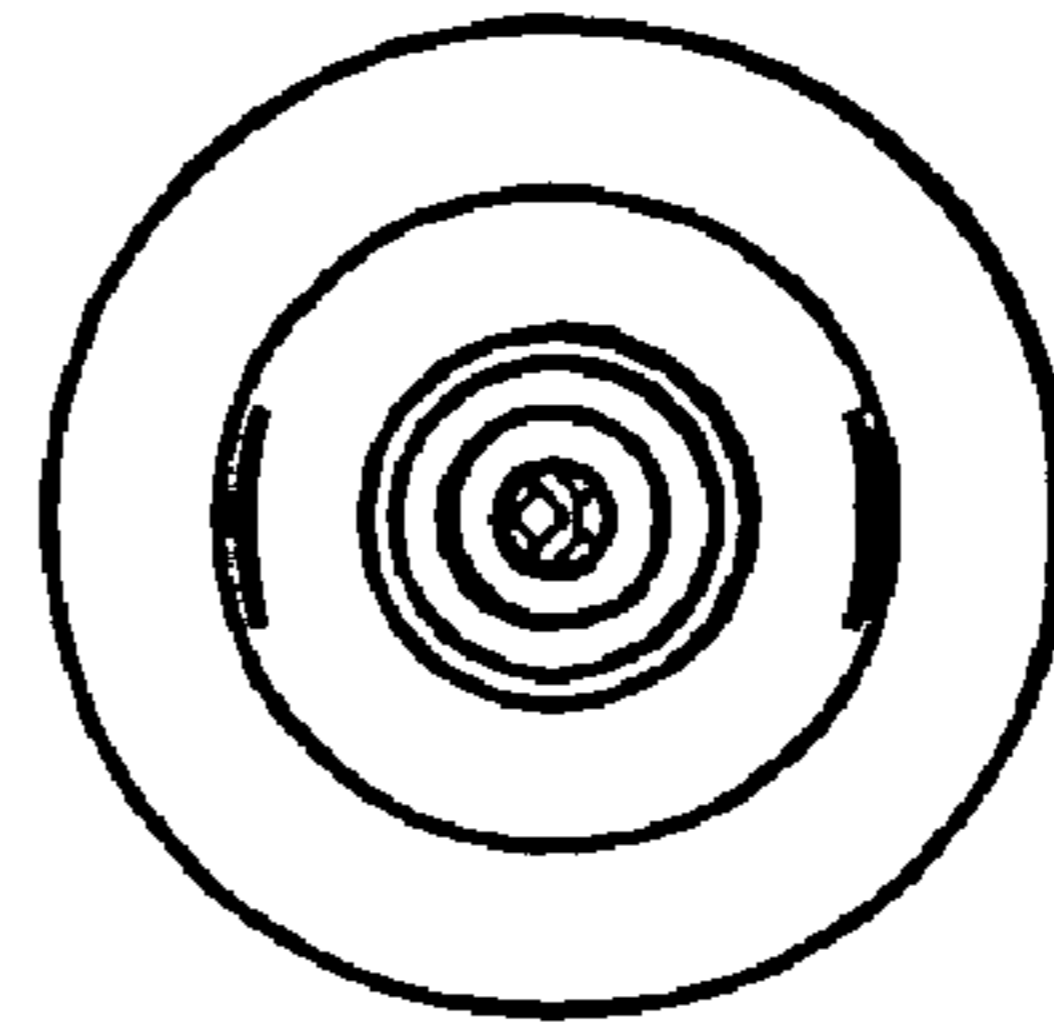

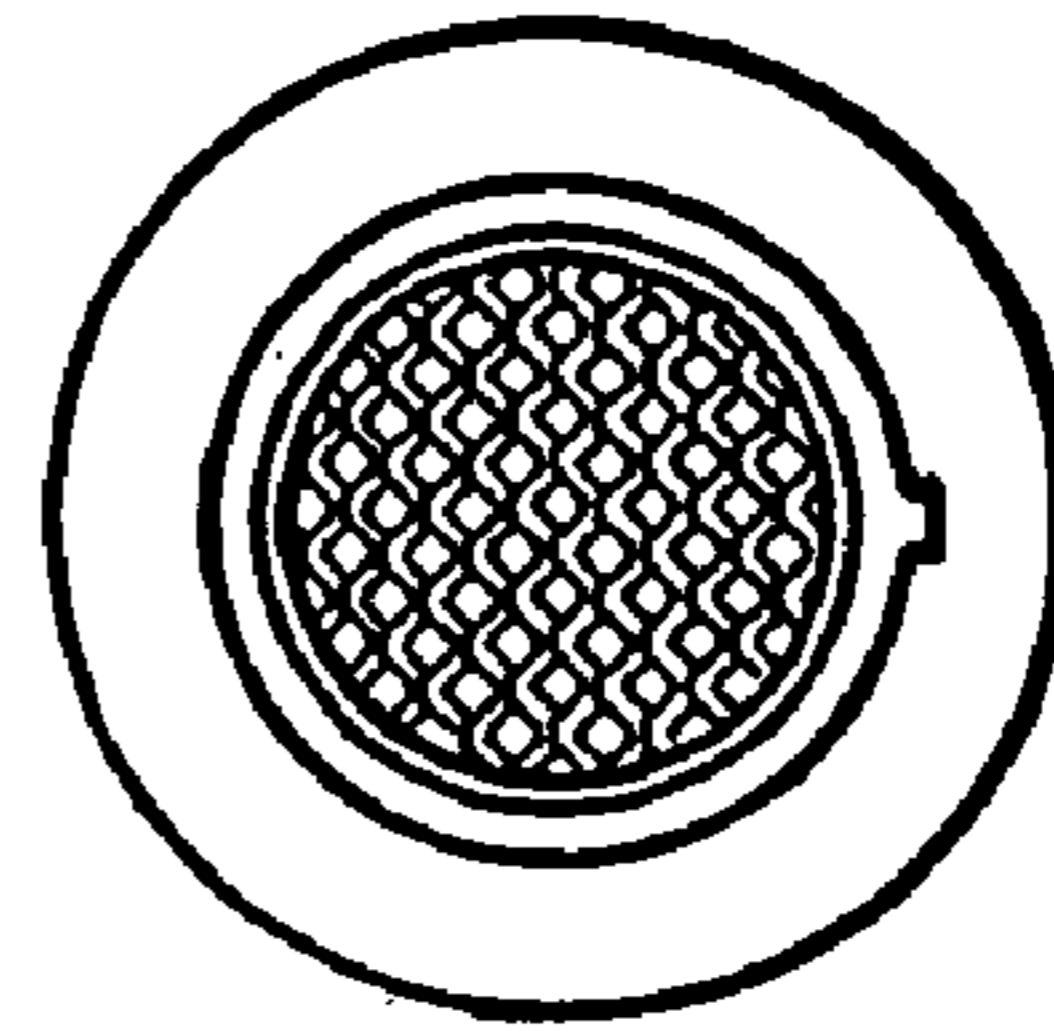

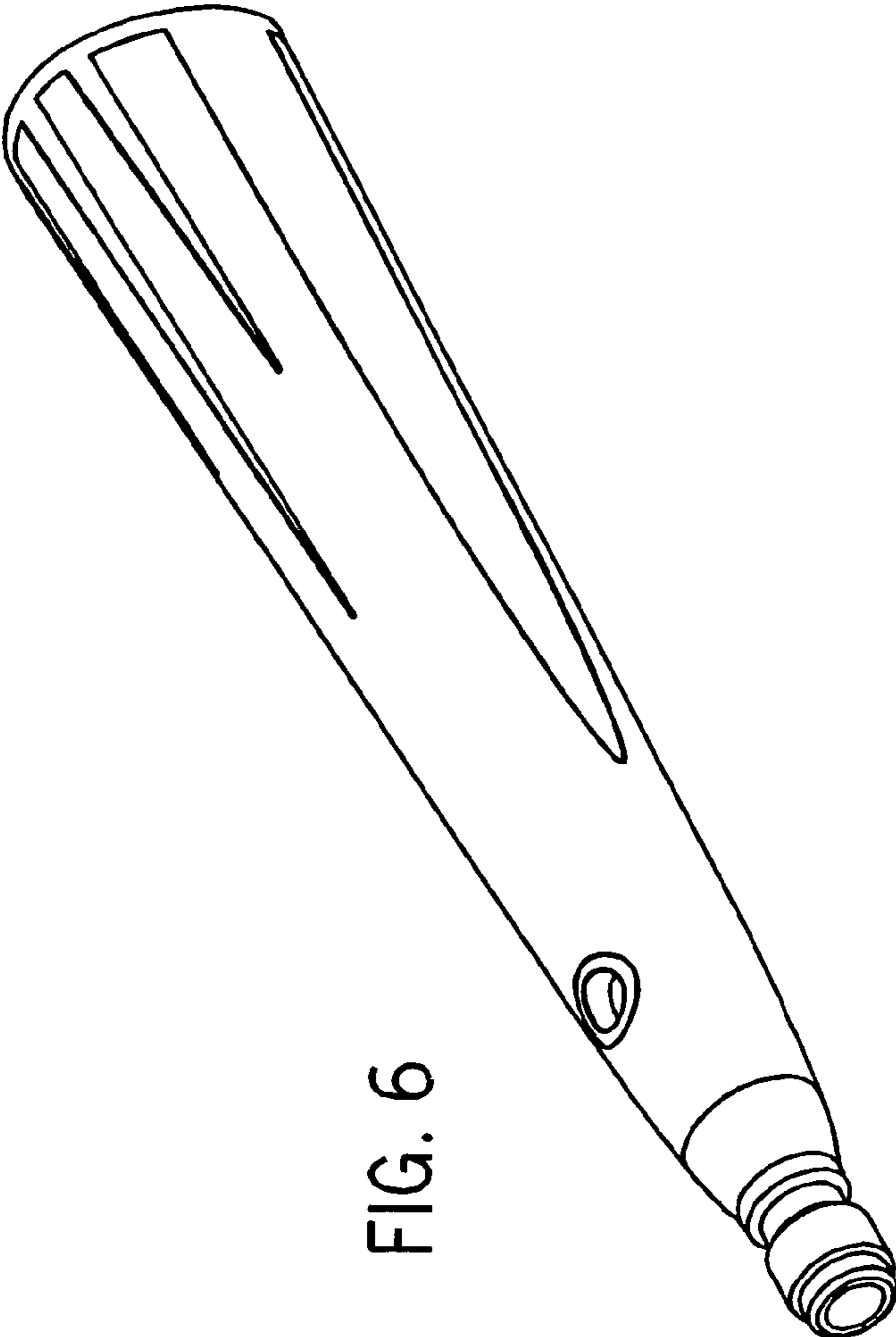

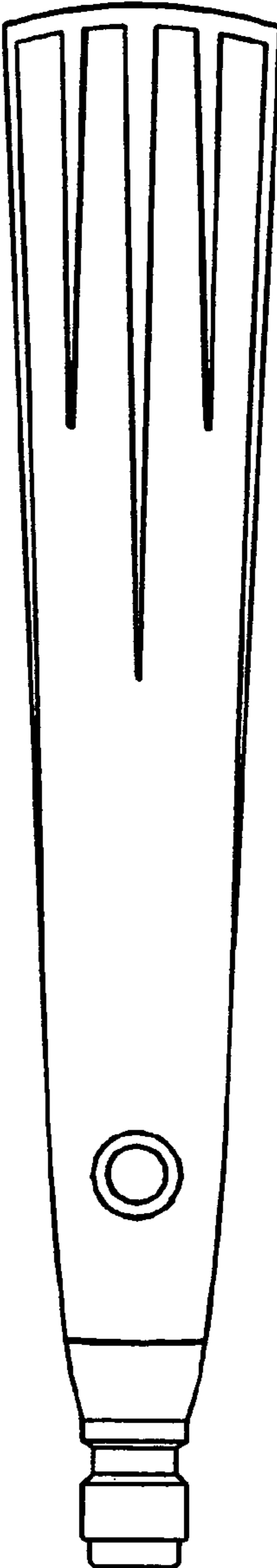

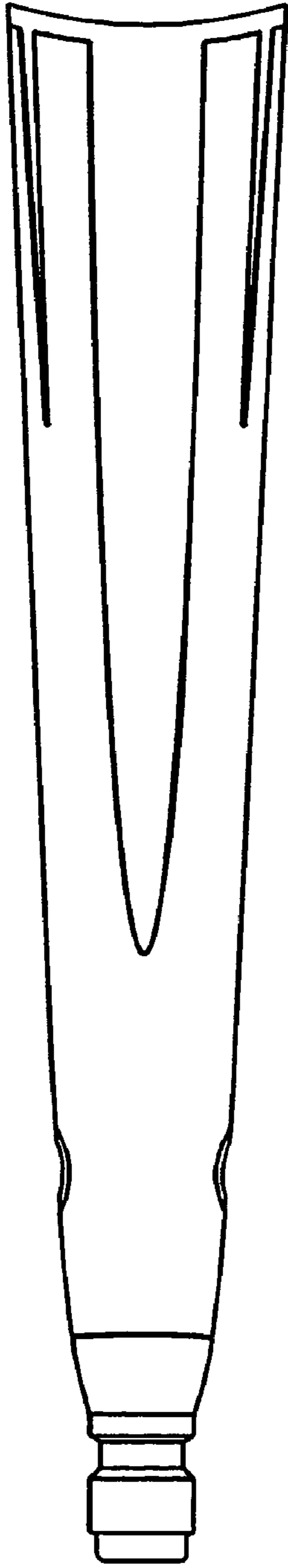

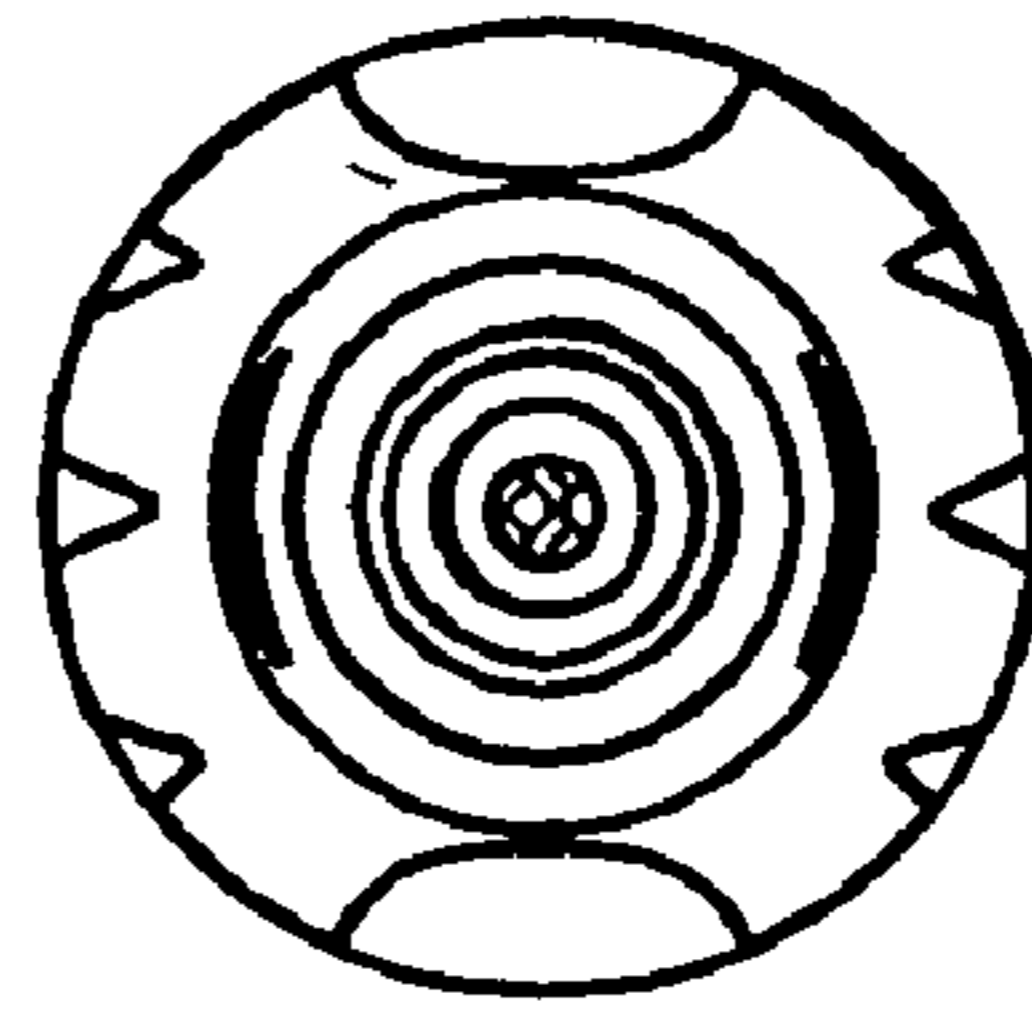

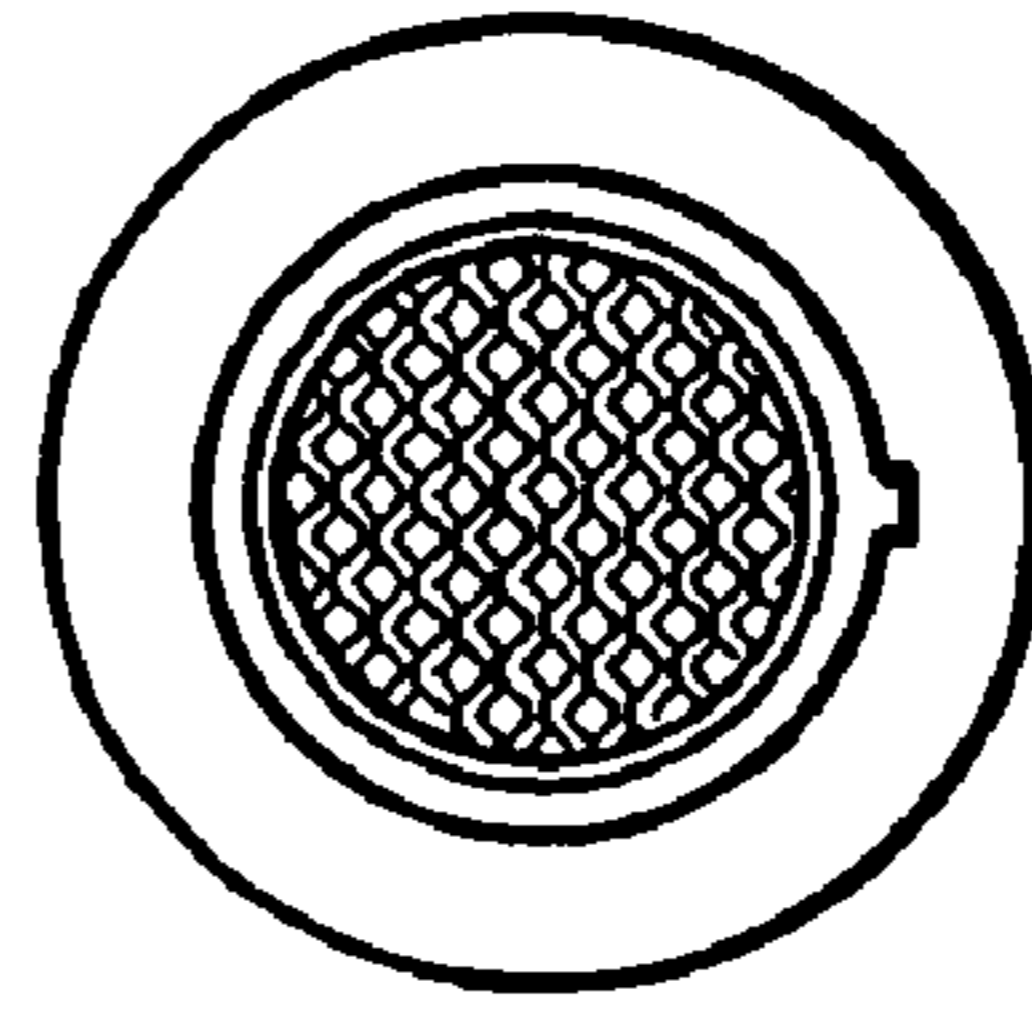
