The ornamental design for a fork lift truck, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the fork lift truck;

FIG. 2 is a front elevational view of the fork lift truck;

FIG. 3 is an elevational view of the fork lift truck from the left side;

FIG. 4 is an elevational view of the fork lift truck from the right side;

FIG. 5 is an elevational view of the fork lift truck from the rear side; and,

FIG. 6 is a bottom view of the fork lift truck.

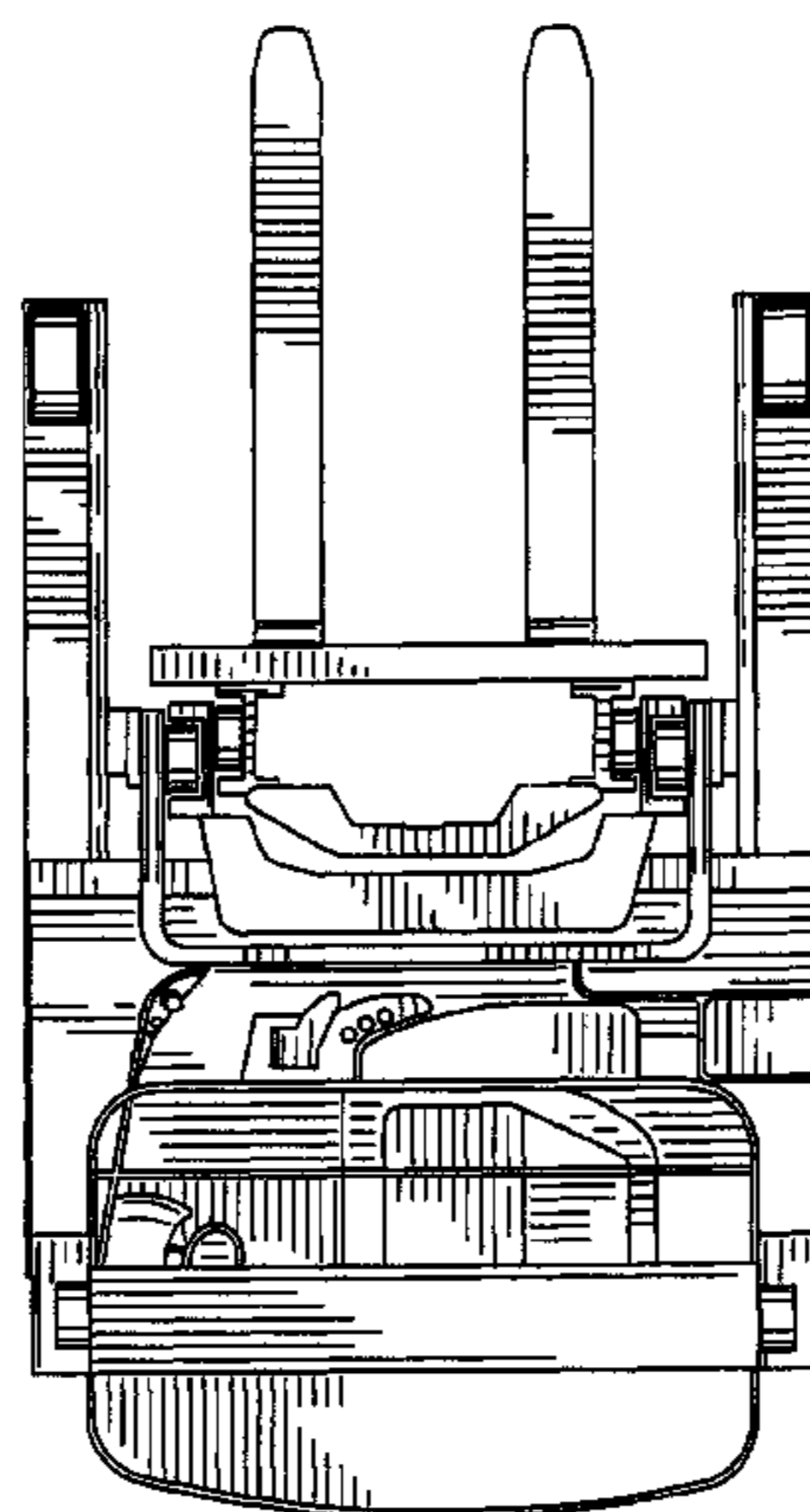

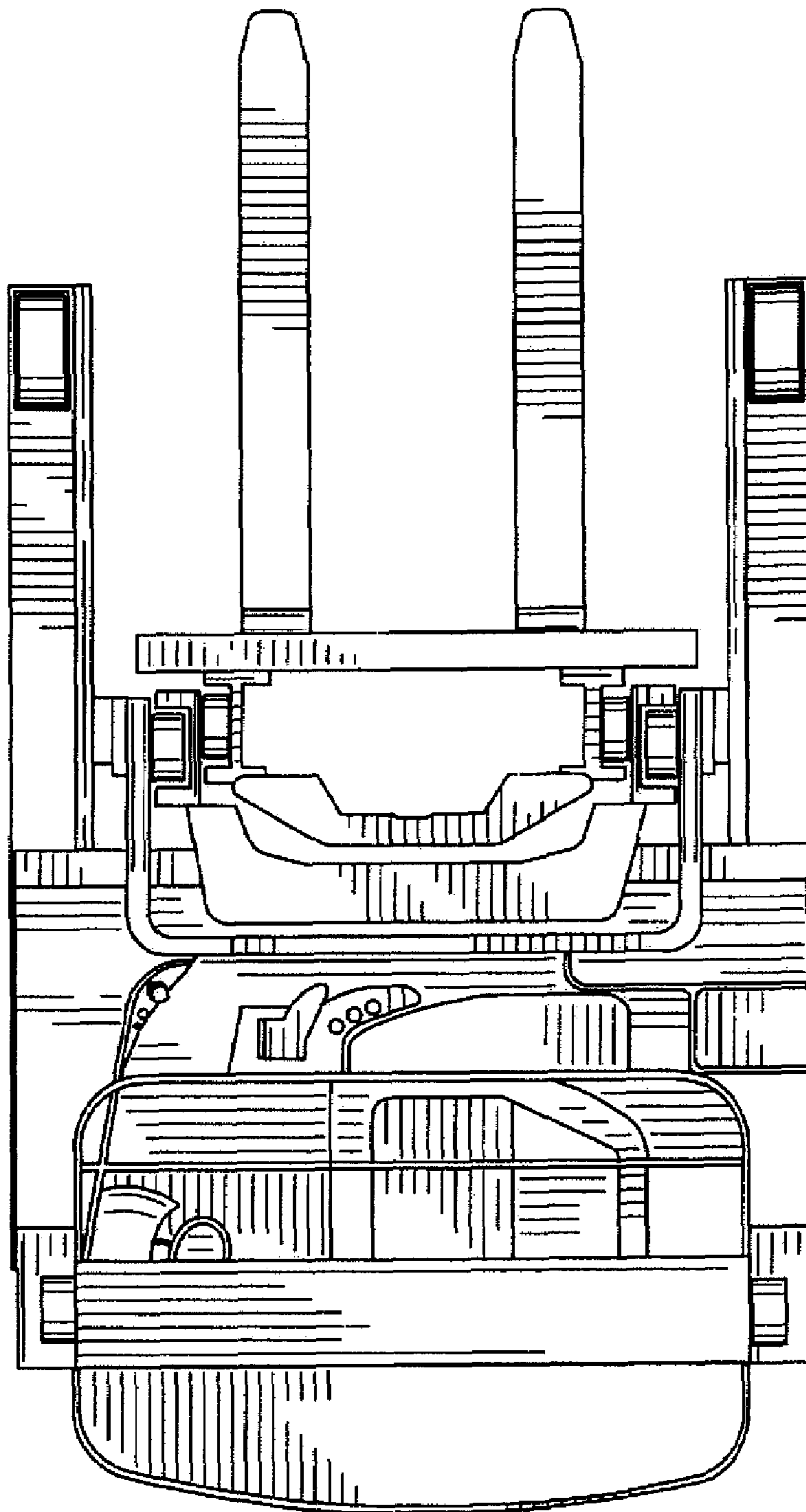

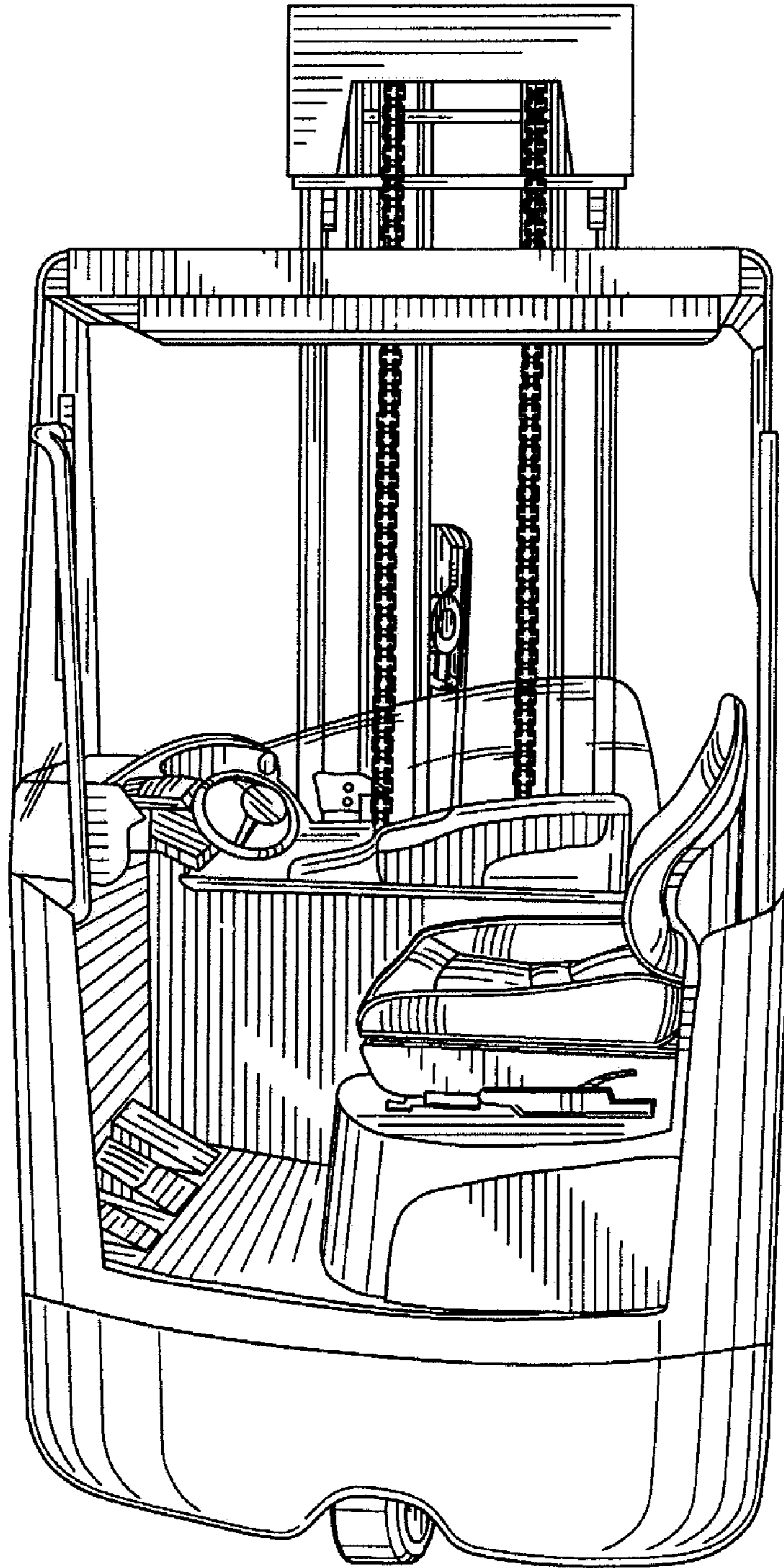

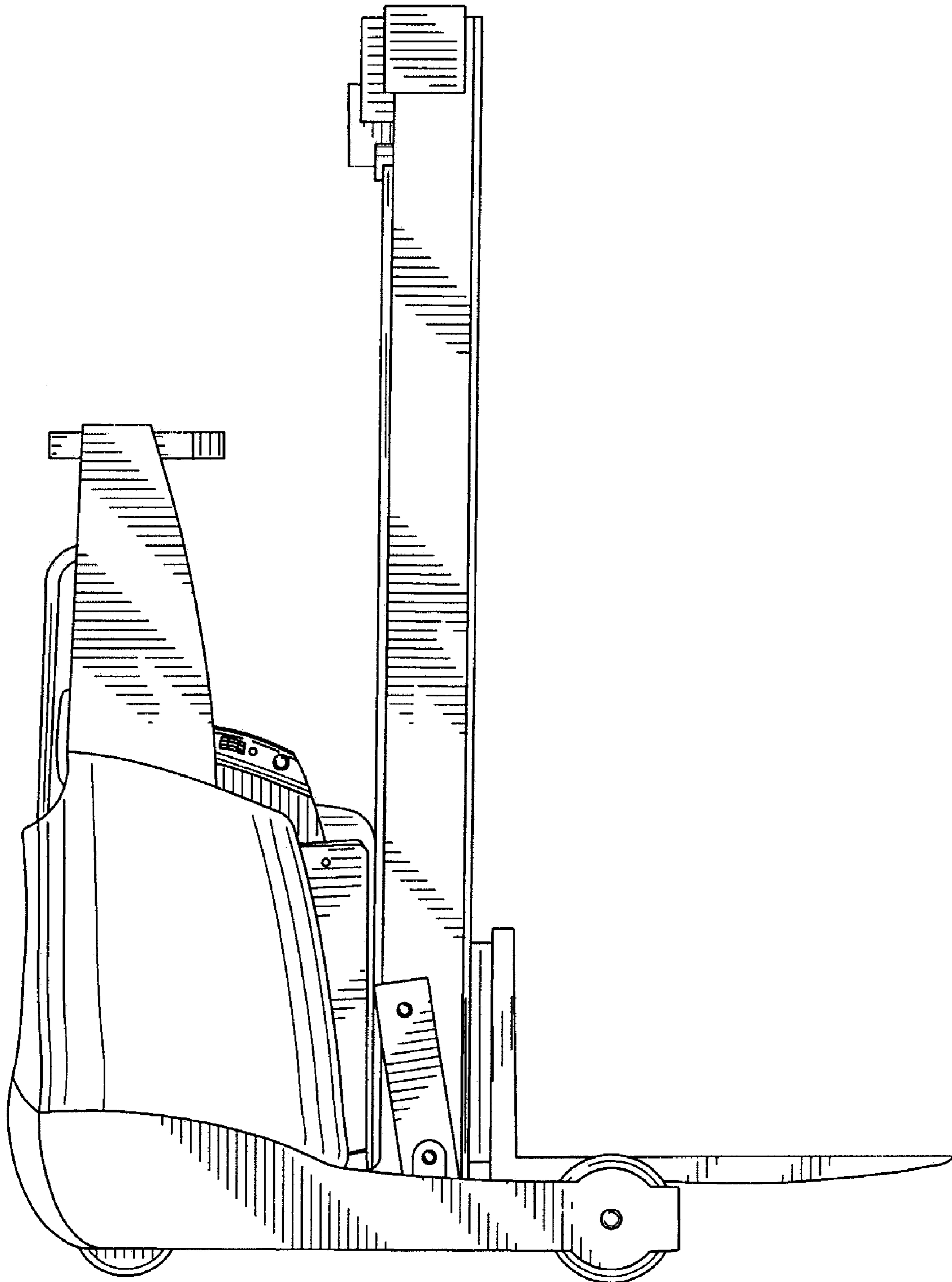

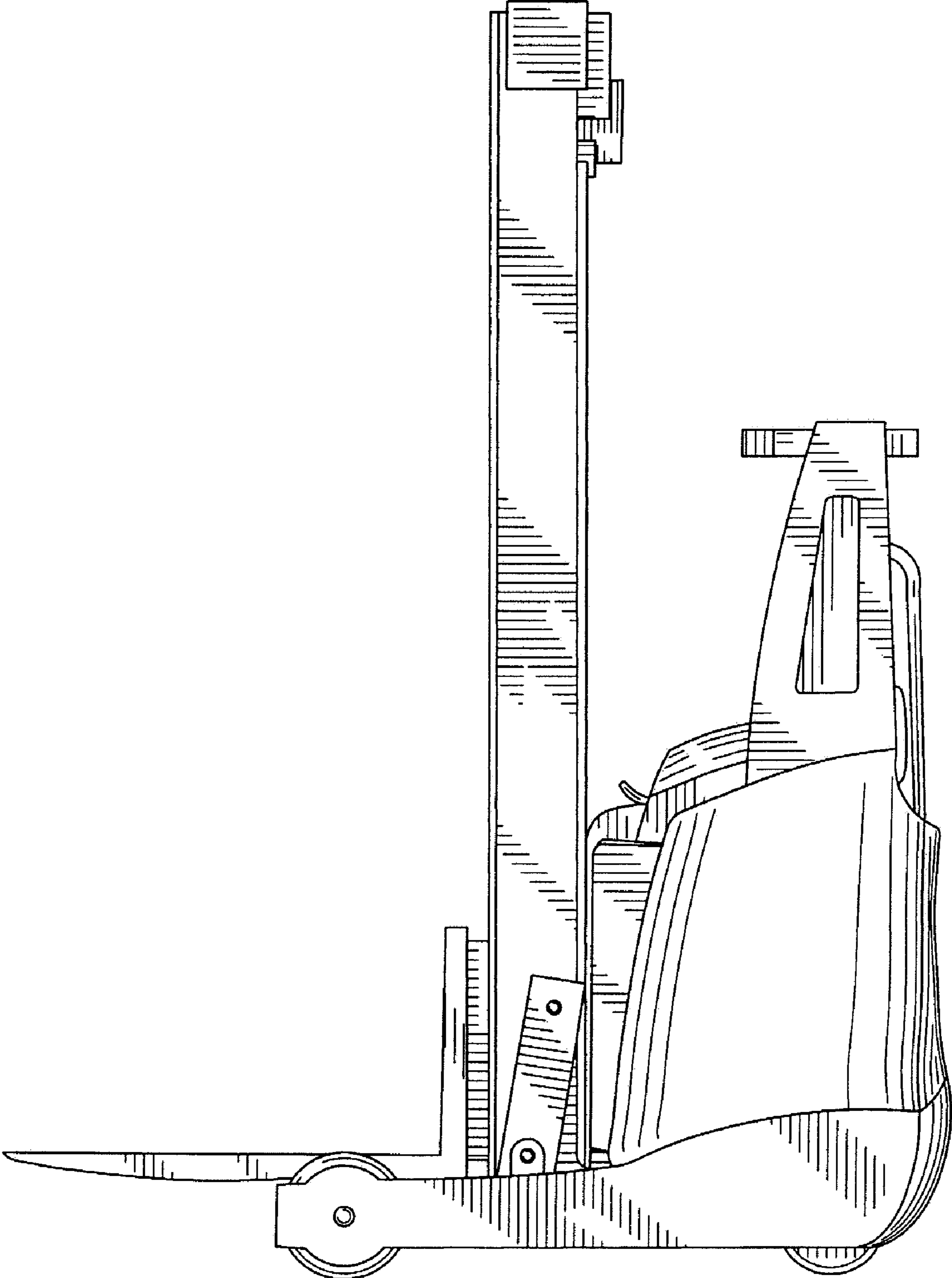

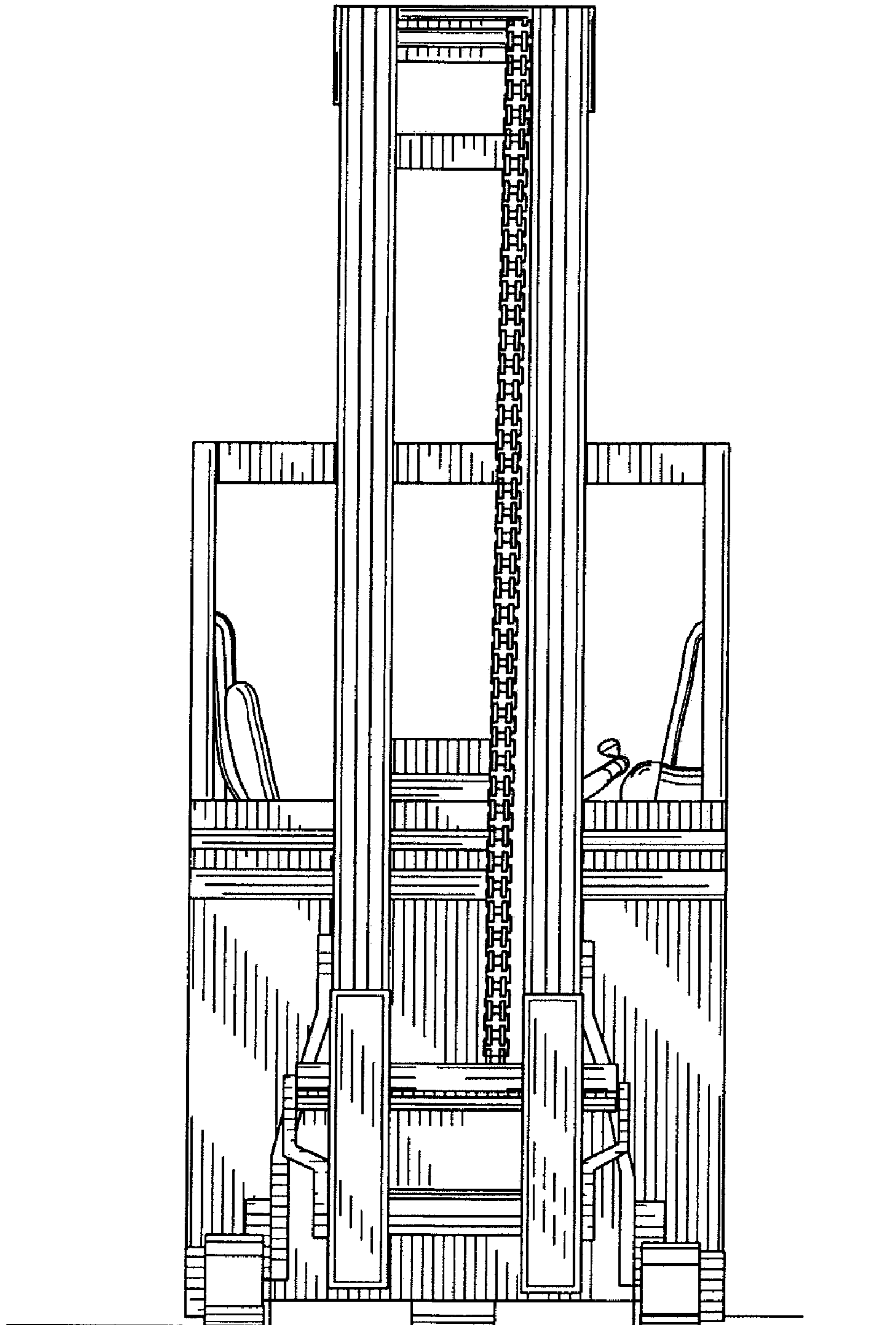
