The ornamental design for a display unit, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the display unit, with half of its arms to the left and half to the right;

FIG. 2 is a front view of the display unit, with all of its arms to the left;

FIG. 3 is a right side view of the display unit, with all of its arms to the left;

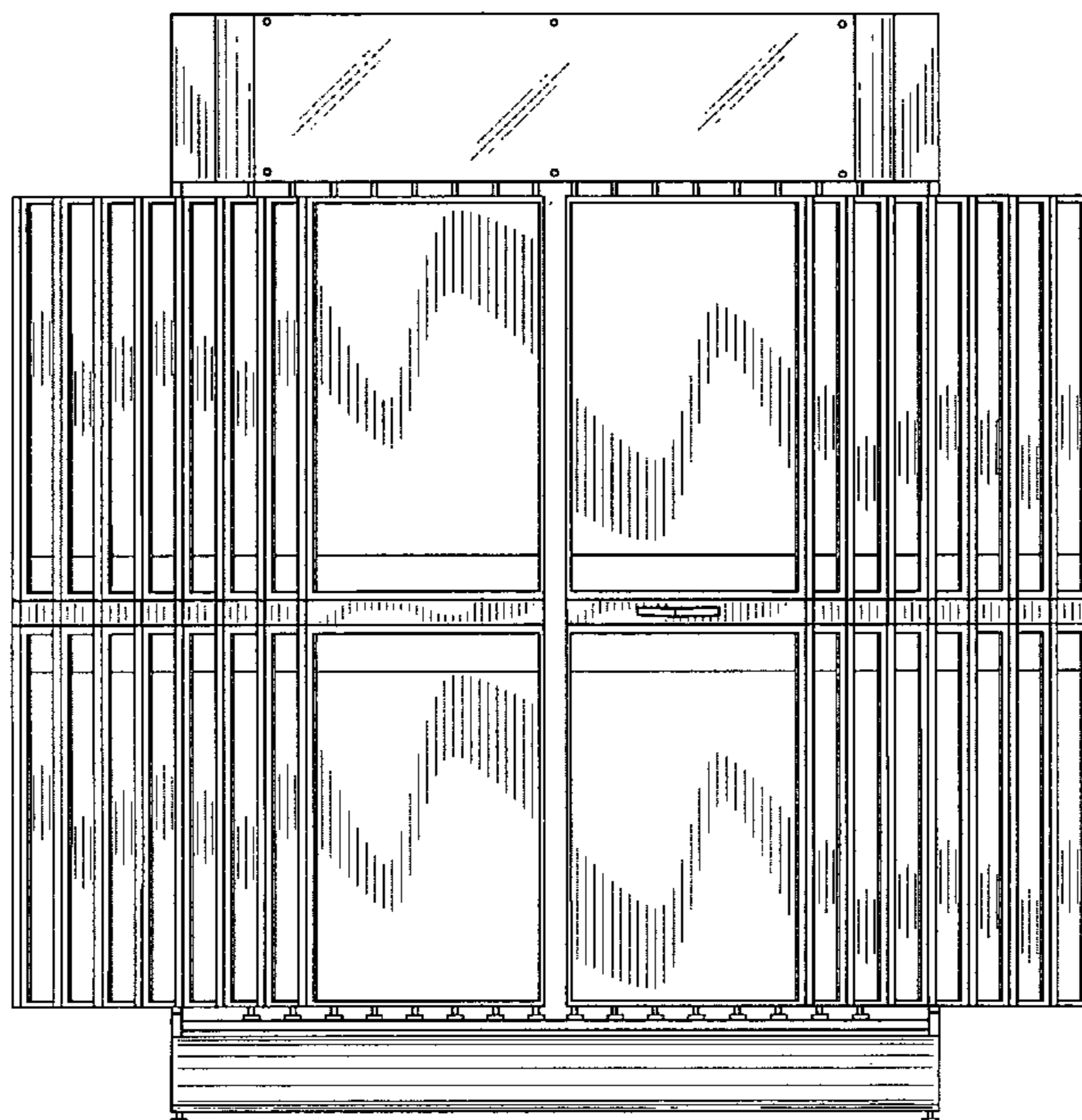
FIG. 4 is a left side view of the display unit, with all of its arms to the right;

FIG. 5 is a rear side view of the display unit of FIG. 2;

FIG. 6 is a top view of the display unit of FIG. 2; and,

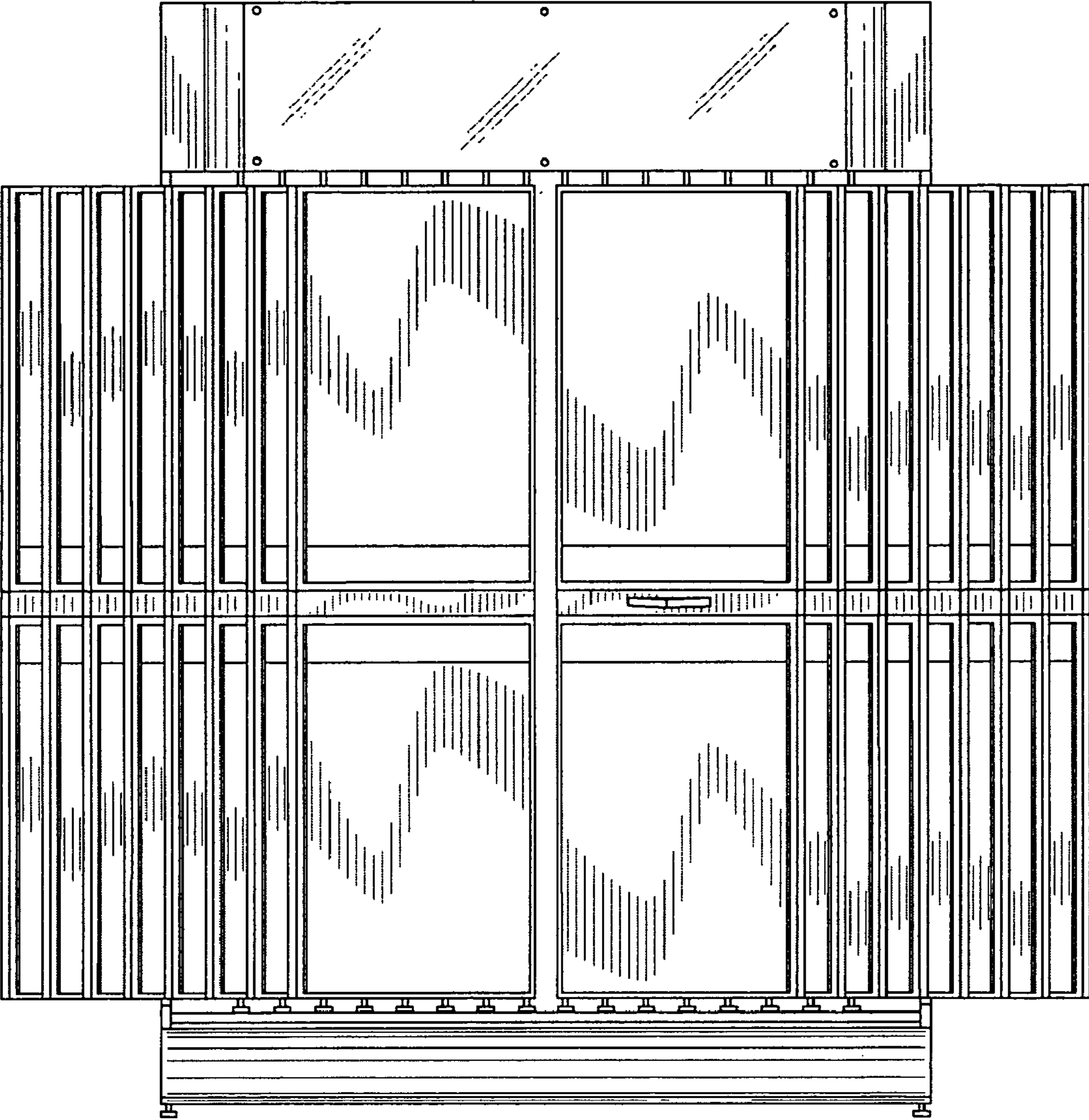

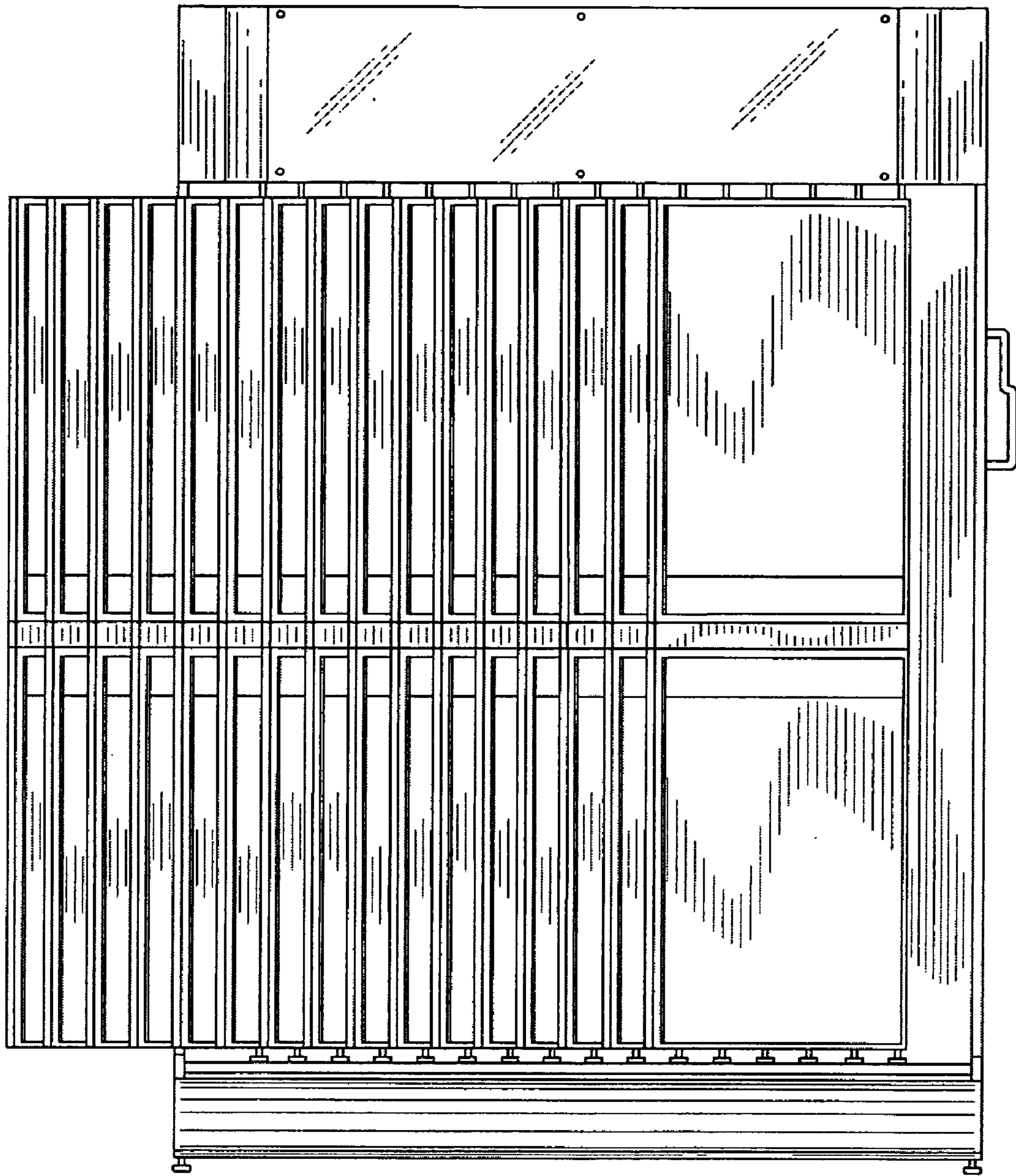

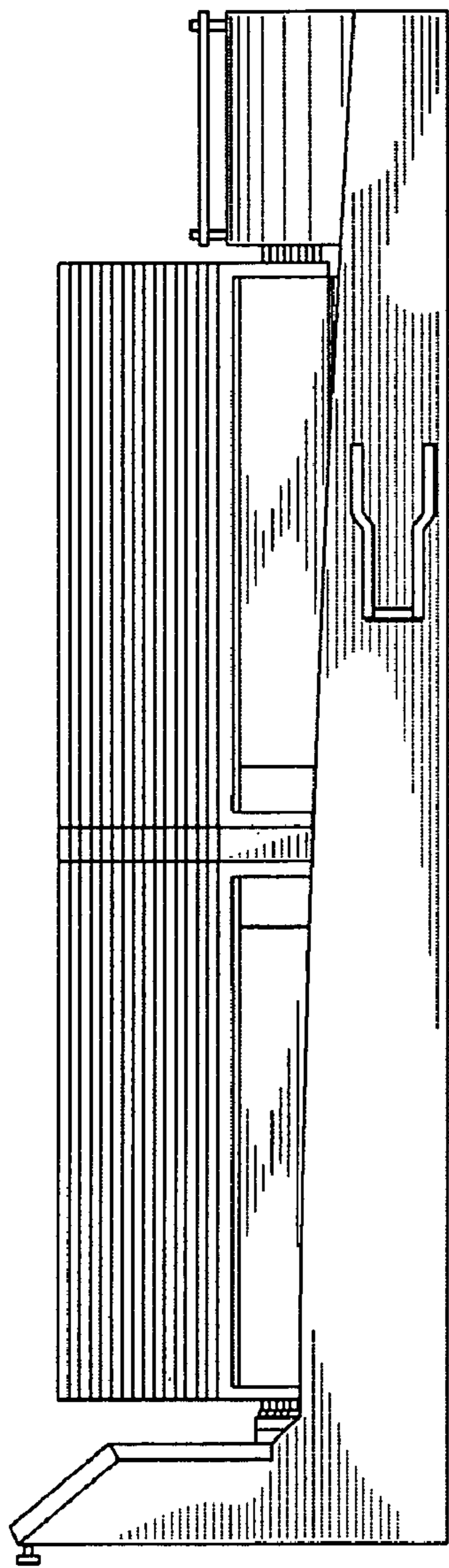

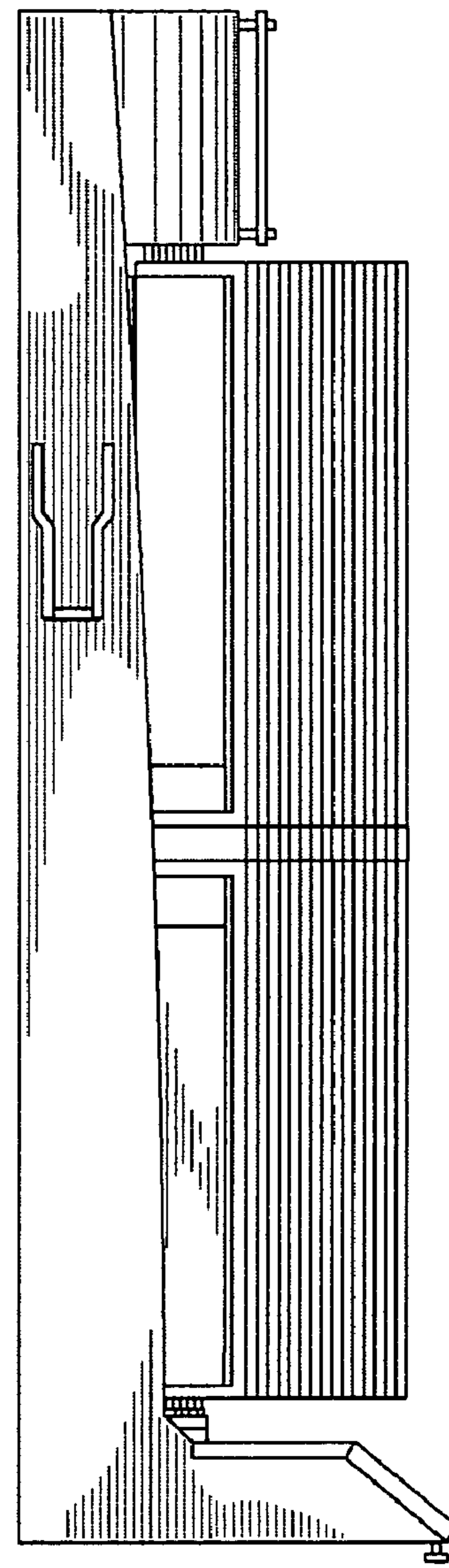

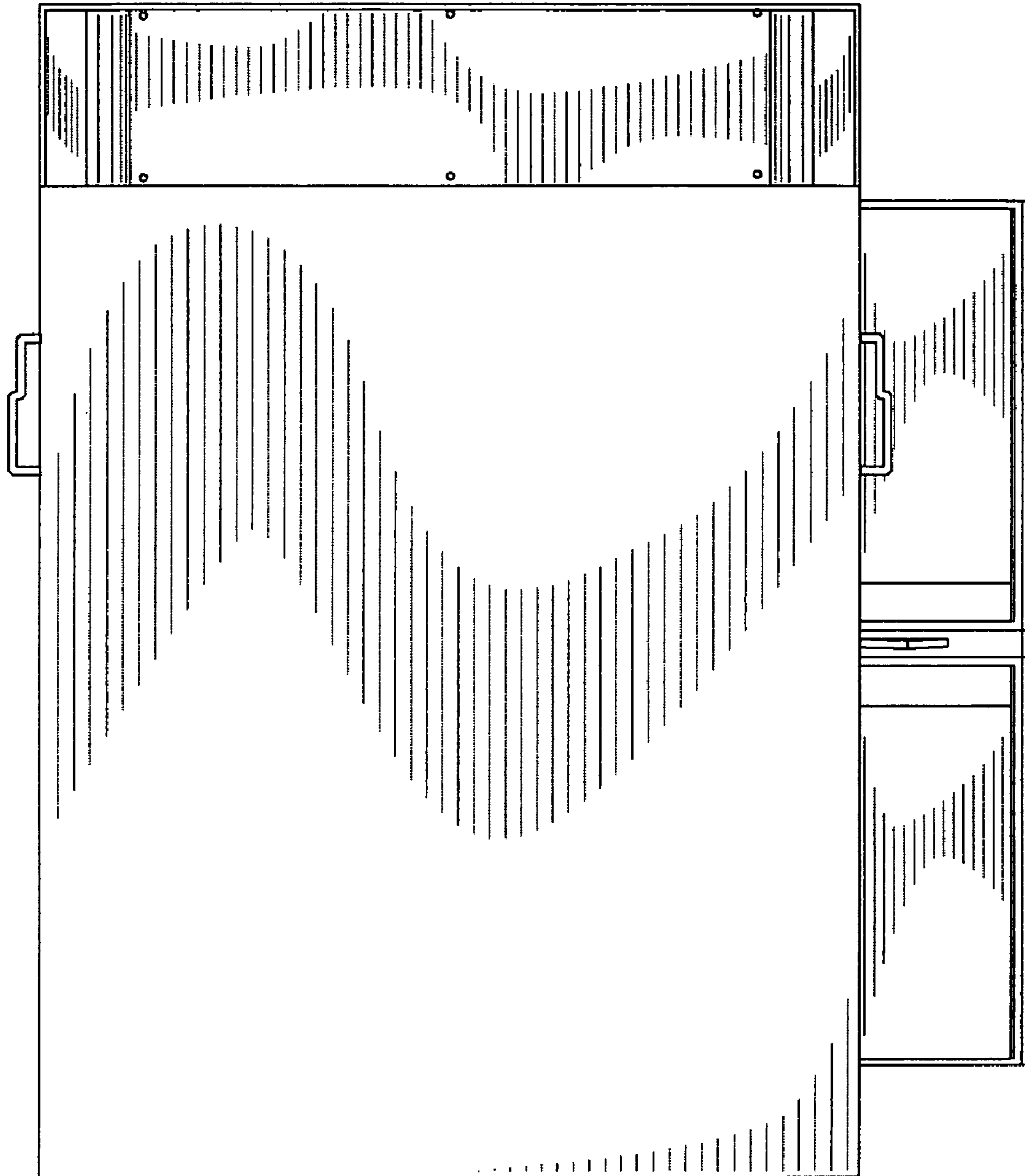

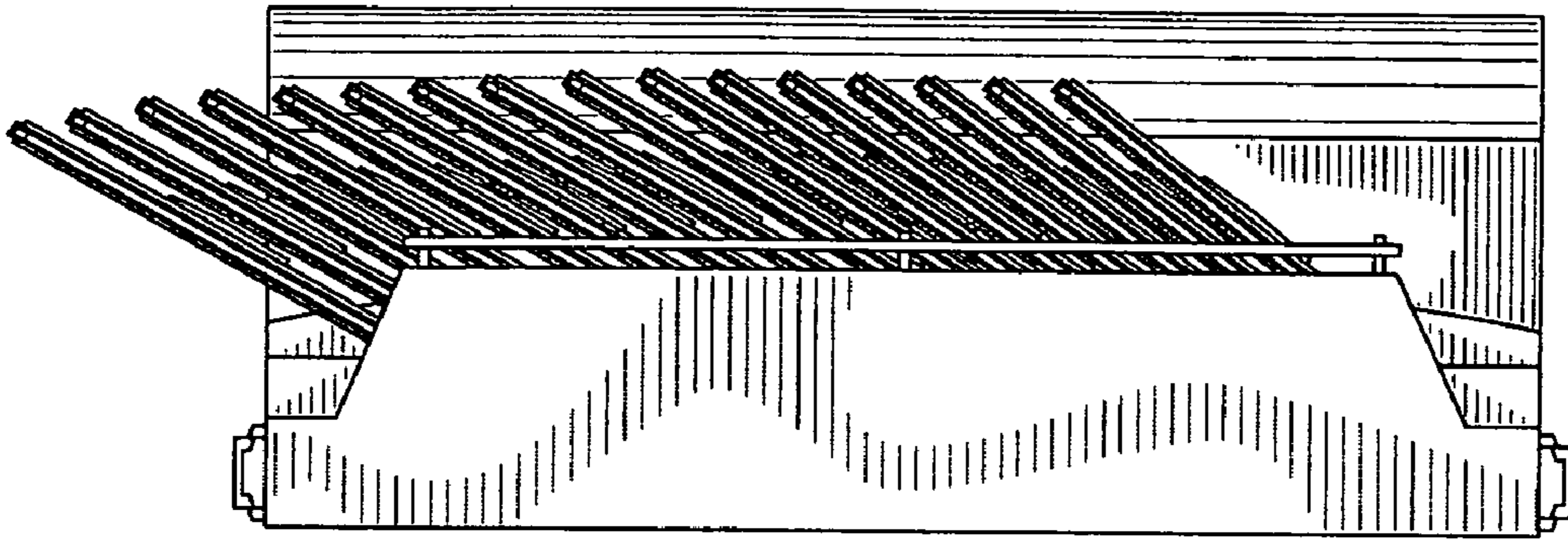

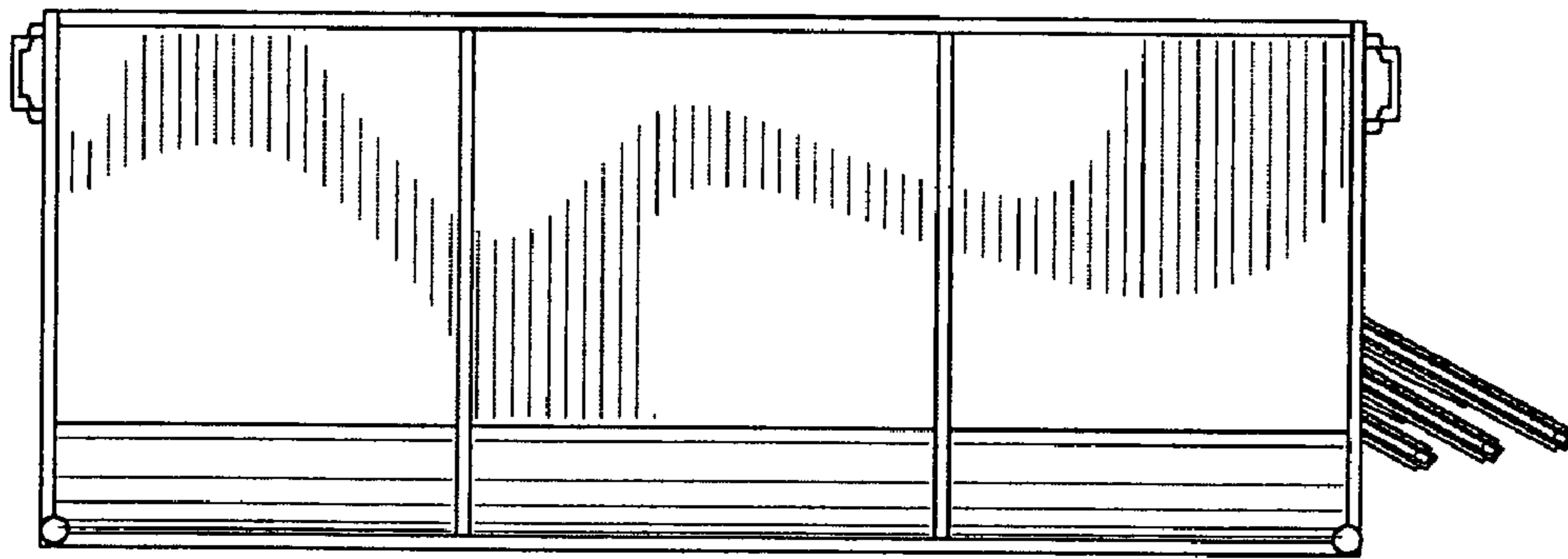
