**DESCRIPTION**

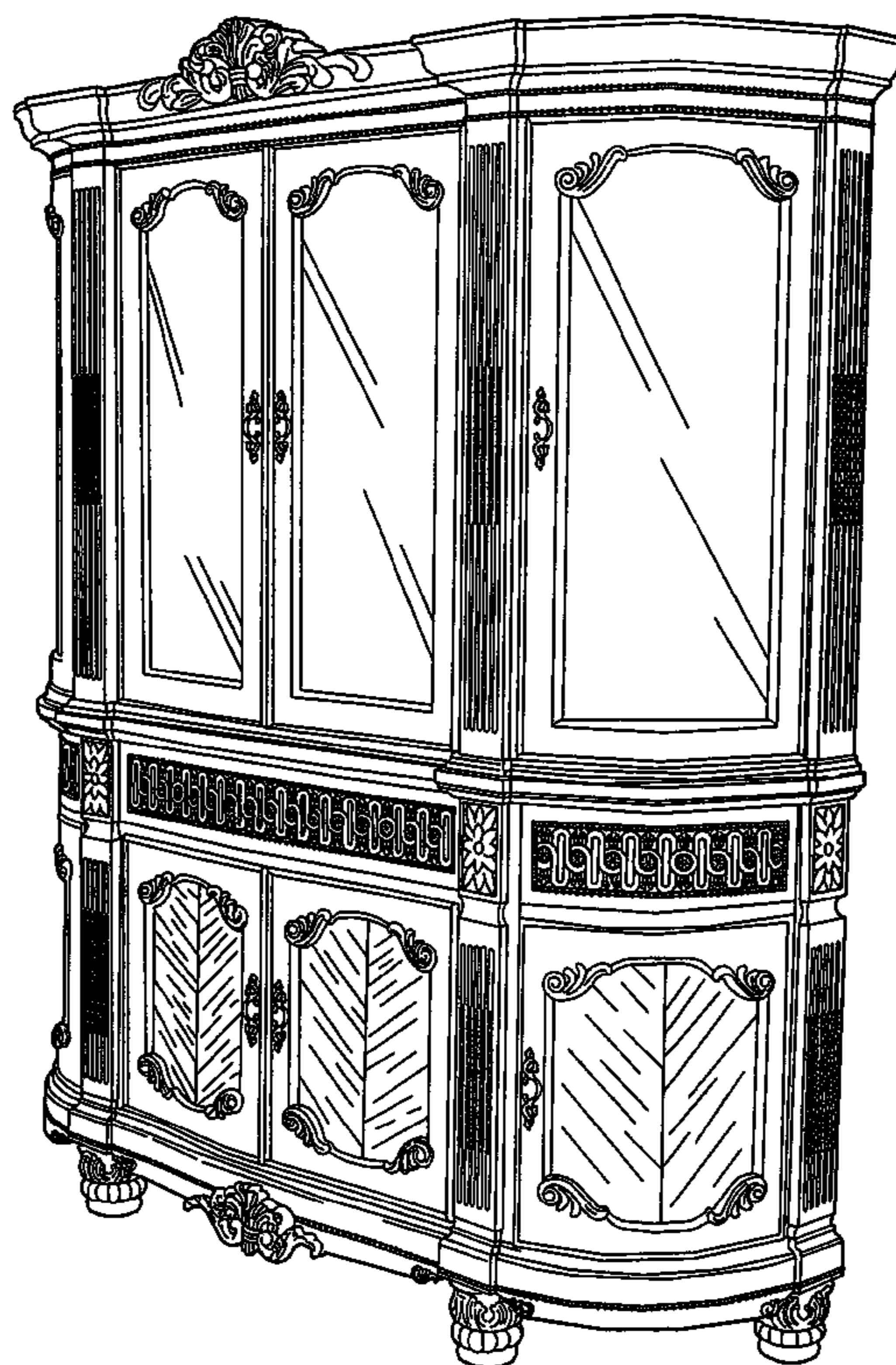
FIG. 1 is a perspective view of a buffet and china cabinet according to an embodiment of the invention.

FIG. 2 is a front view of a buffet and china cabinet according to an embodiment of the invention.

FIG. 4 is an overhead view of a buffet and china cabinet according to an embodiment of the invention.

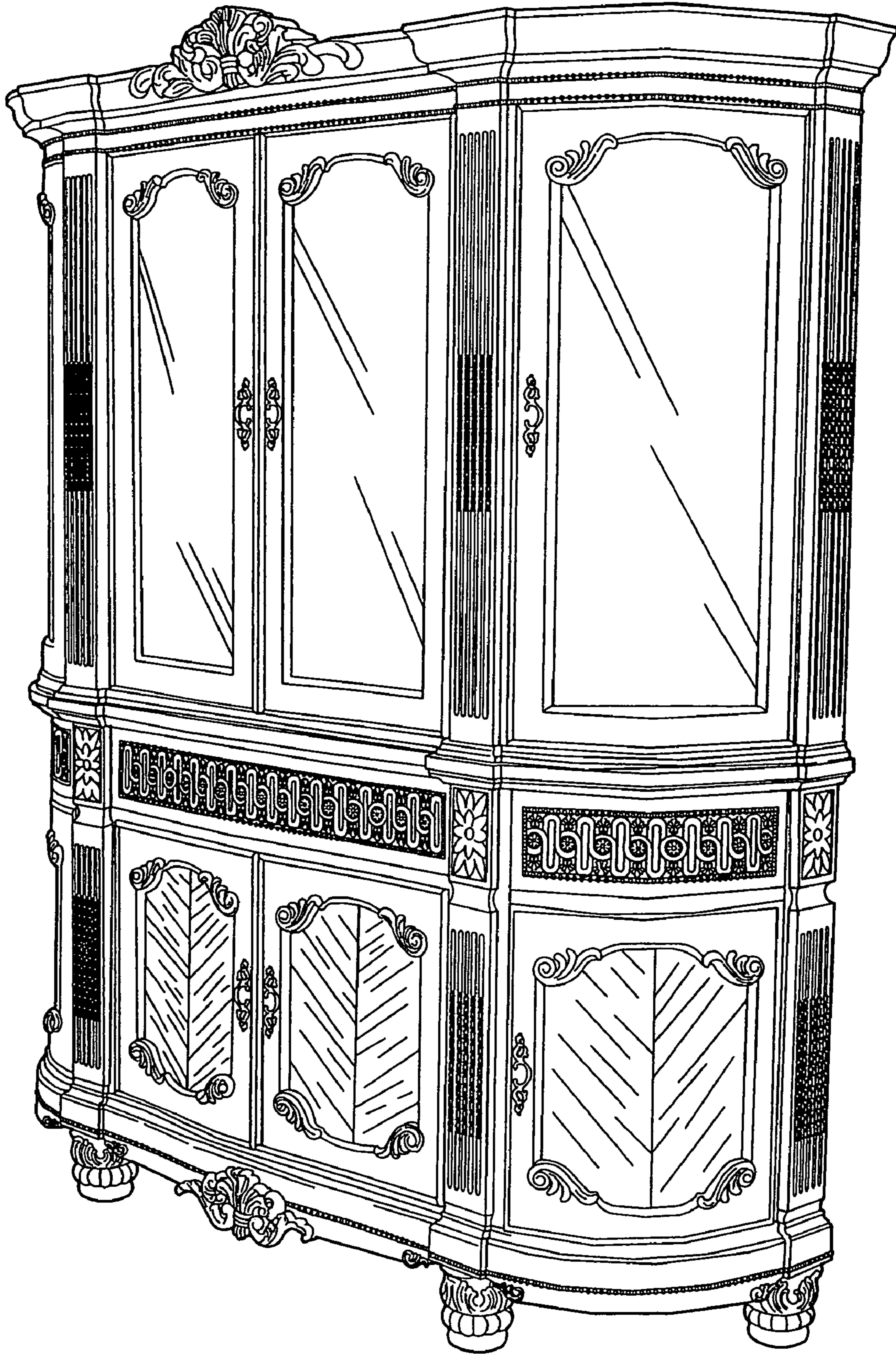

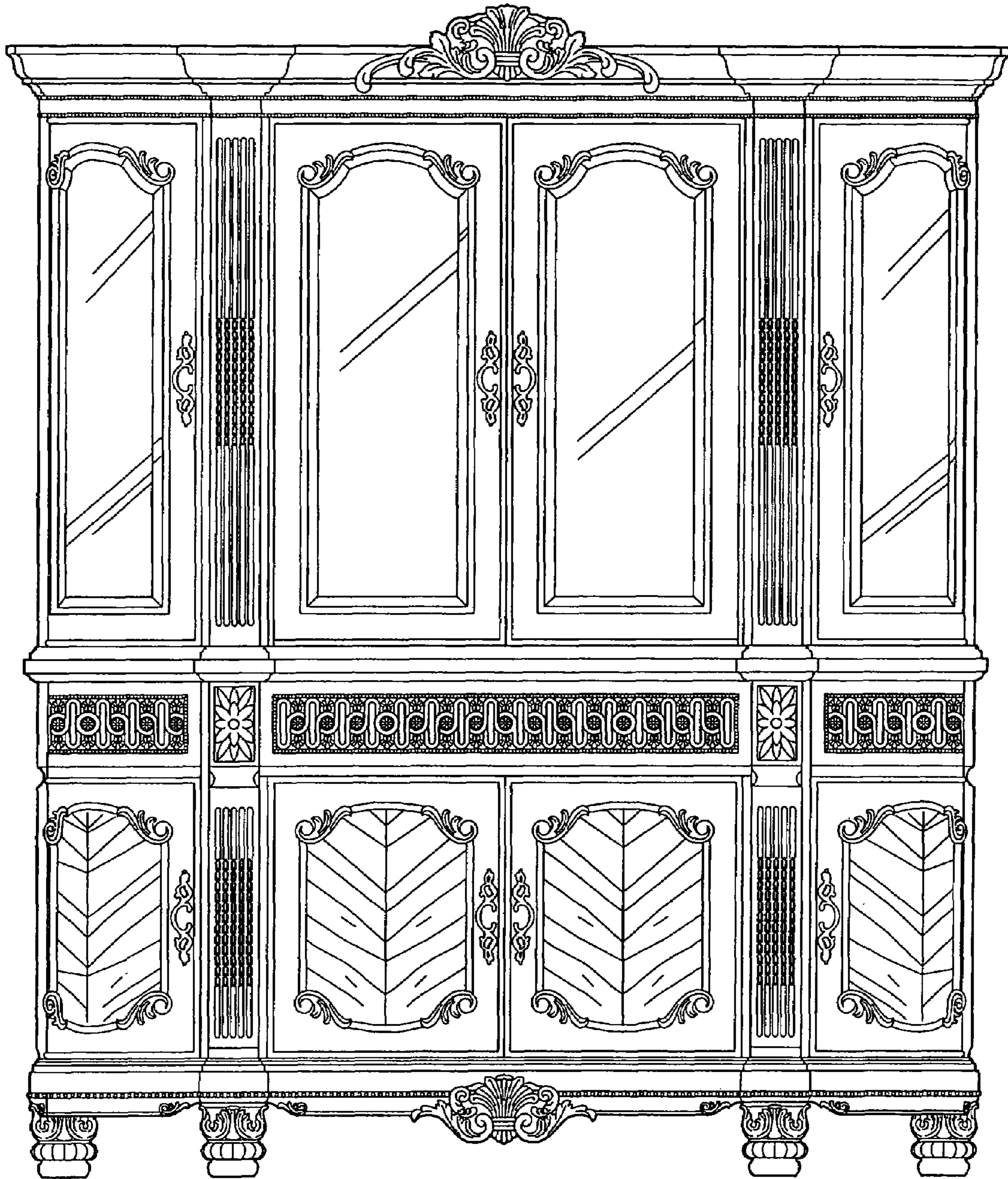

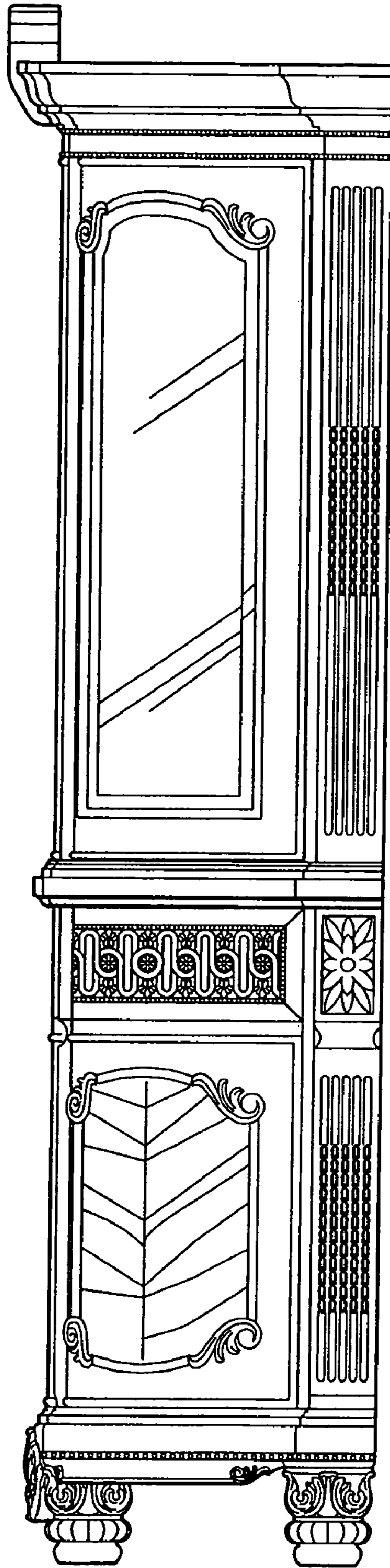

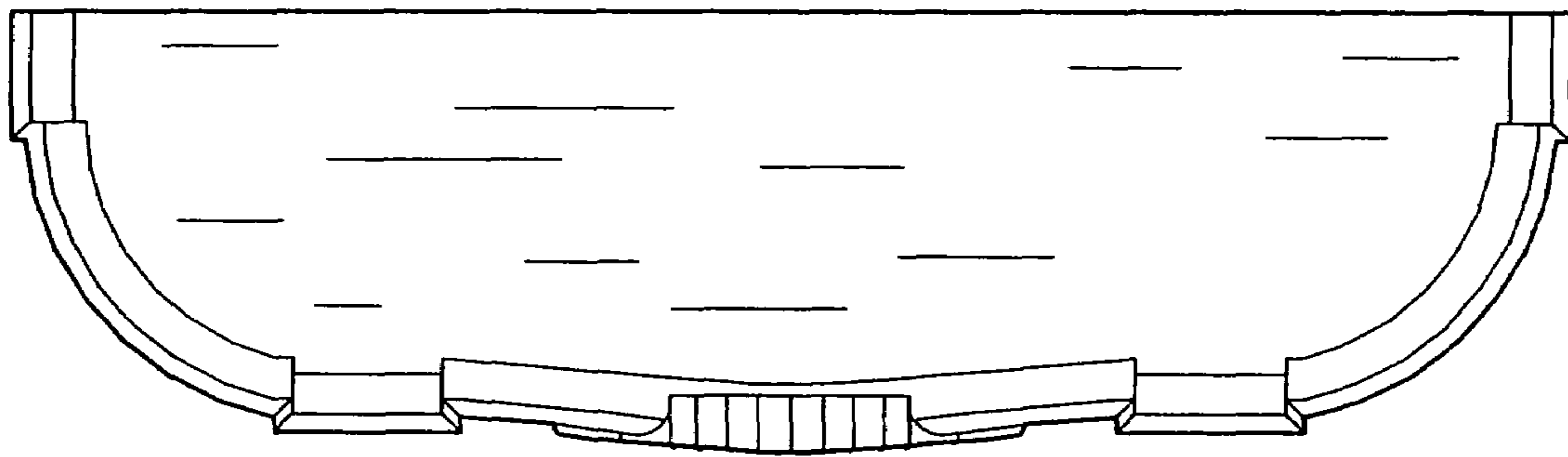
