DESCRIPTION

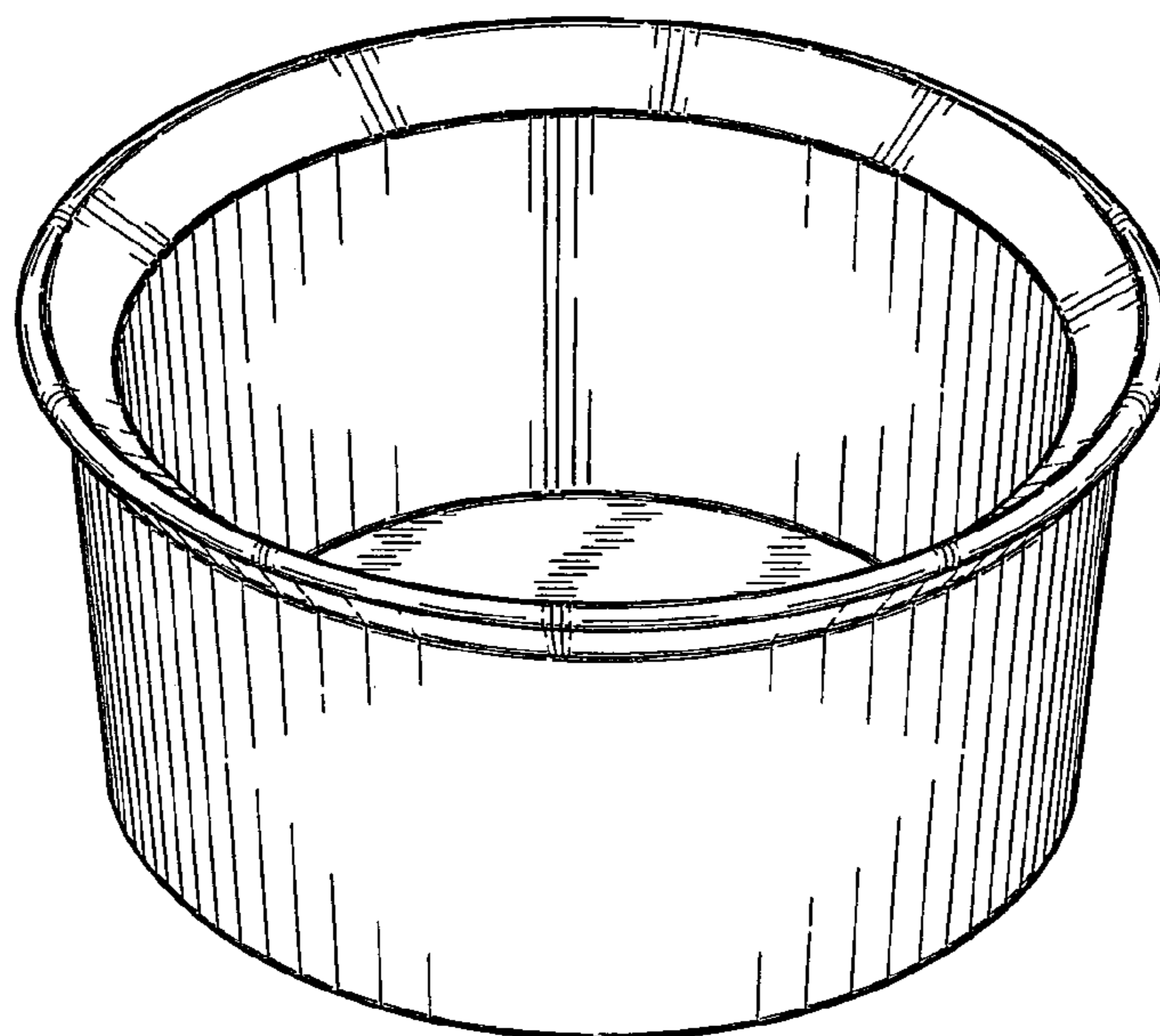
FIG. 1 is a front perspective view showing the present invention.

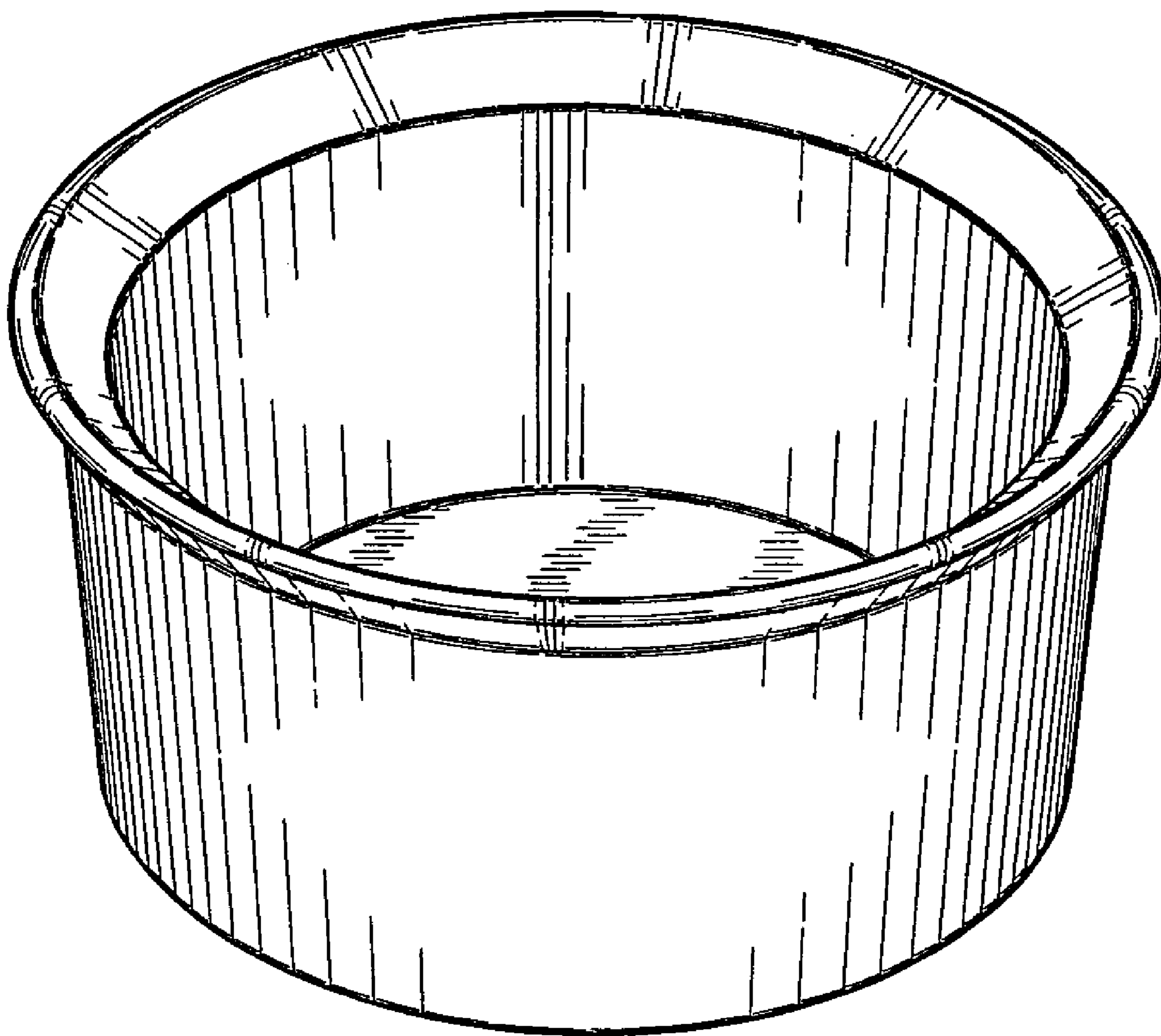

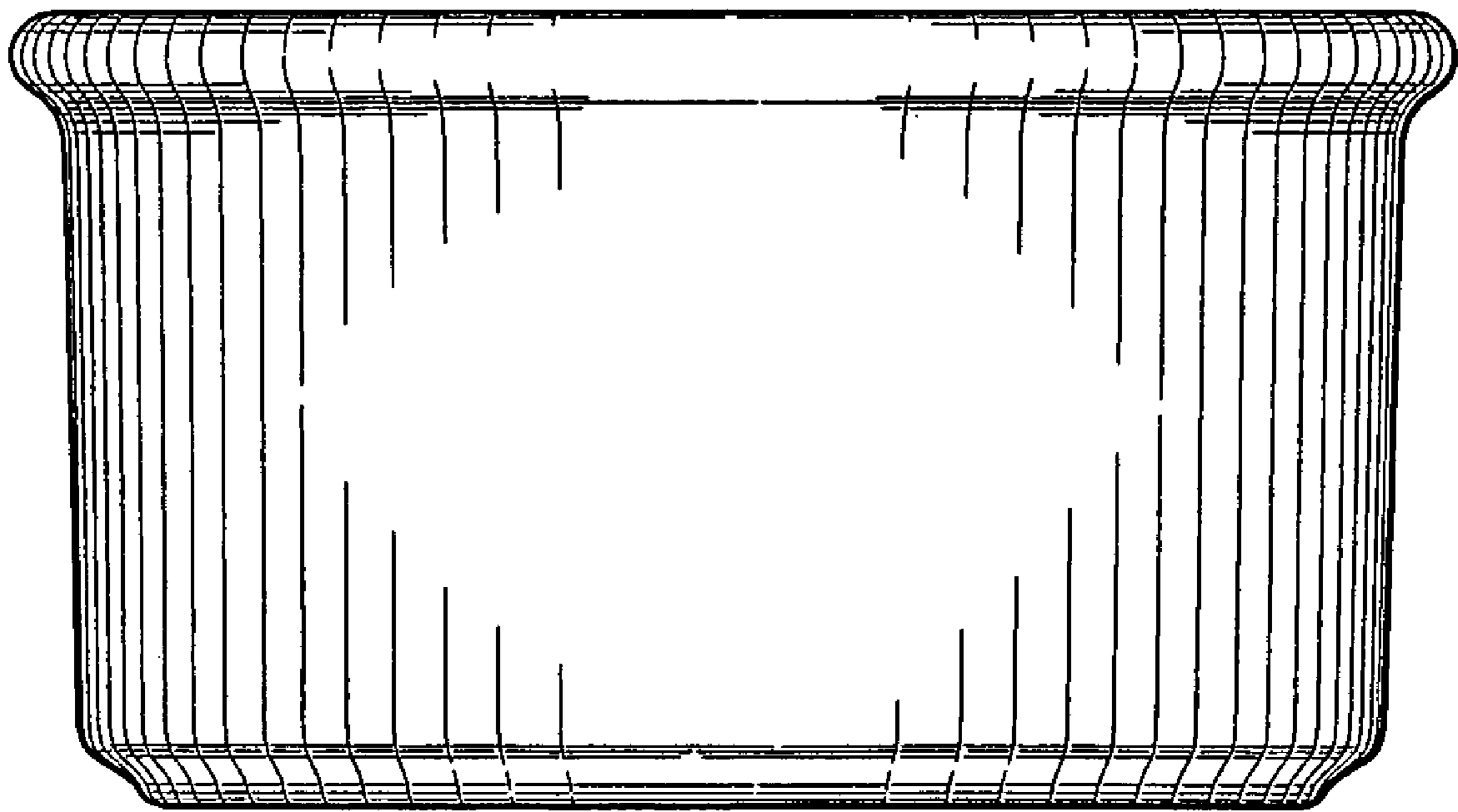

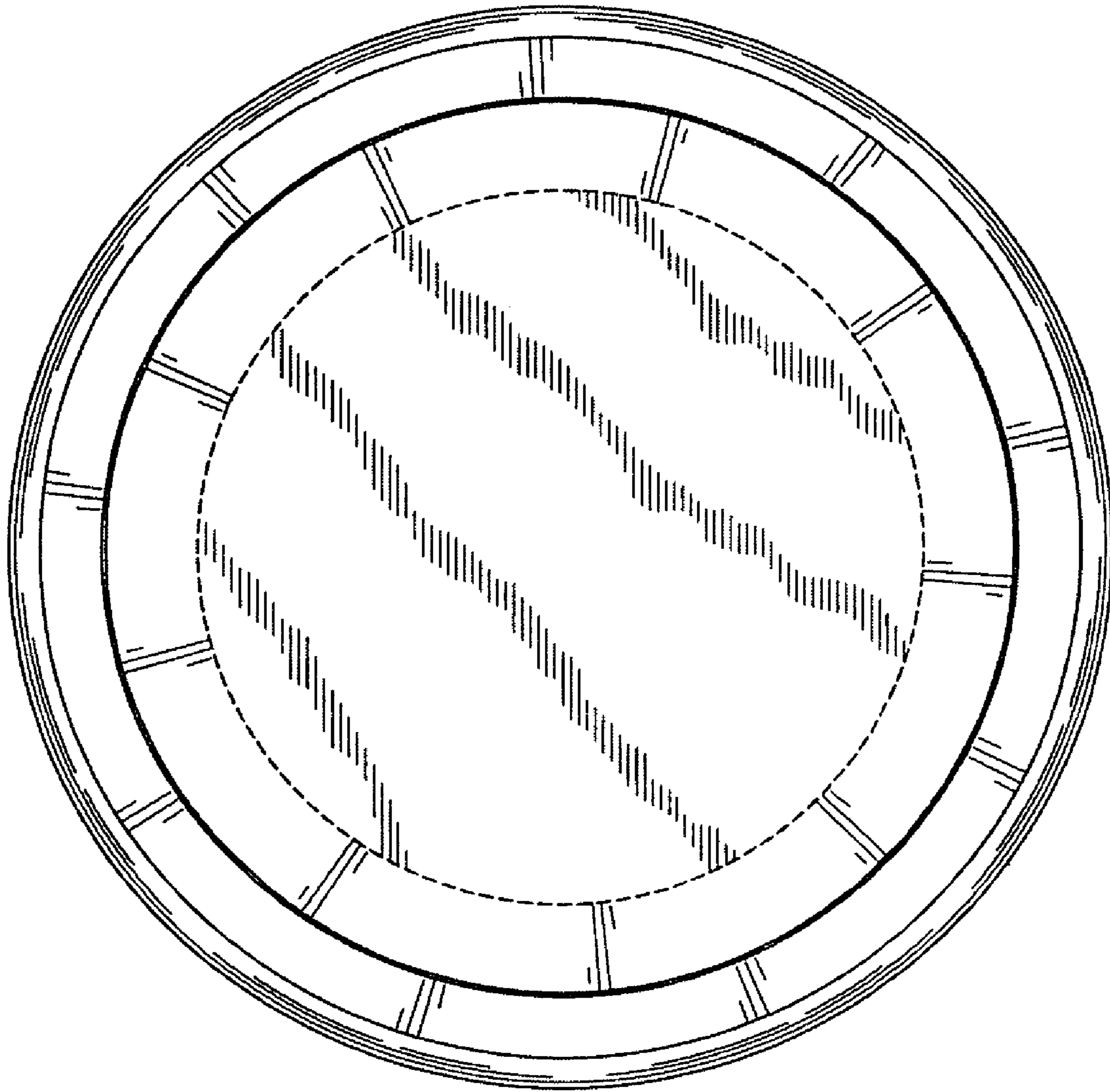

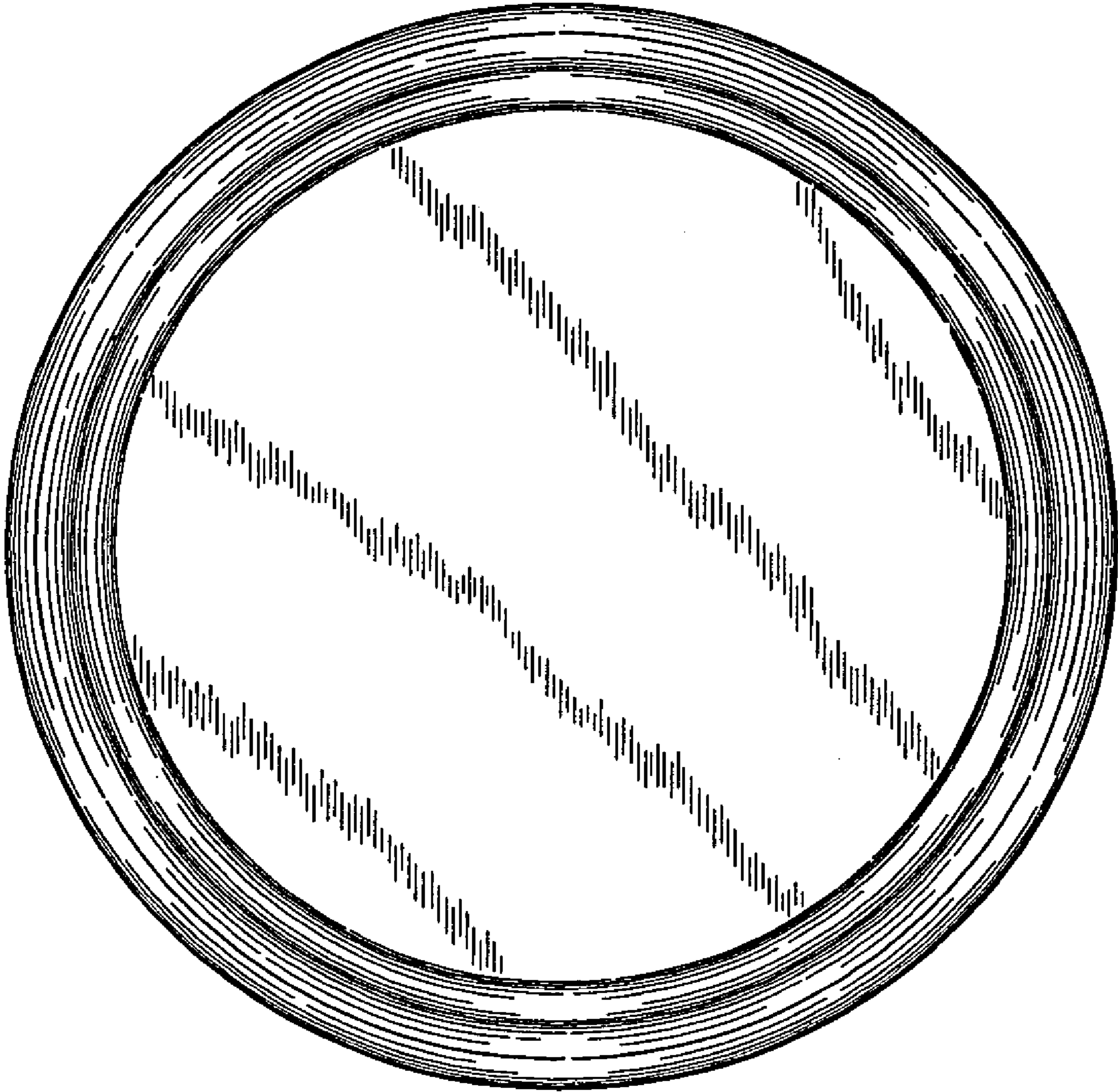
