(57) **CLAIM**

The ornamental design for a sports bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front,top,left side perspective view of a sports bottle showing a first embodiment of our new design;

FIG. 10 is an enlarged rear elevational view thereof;

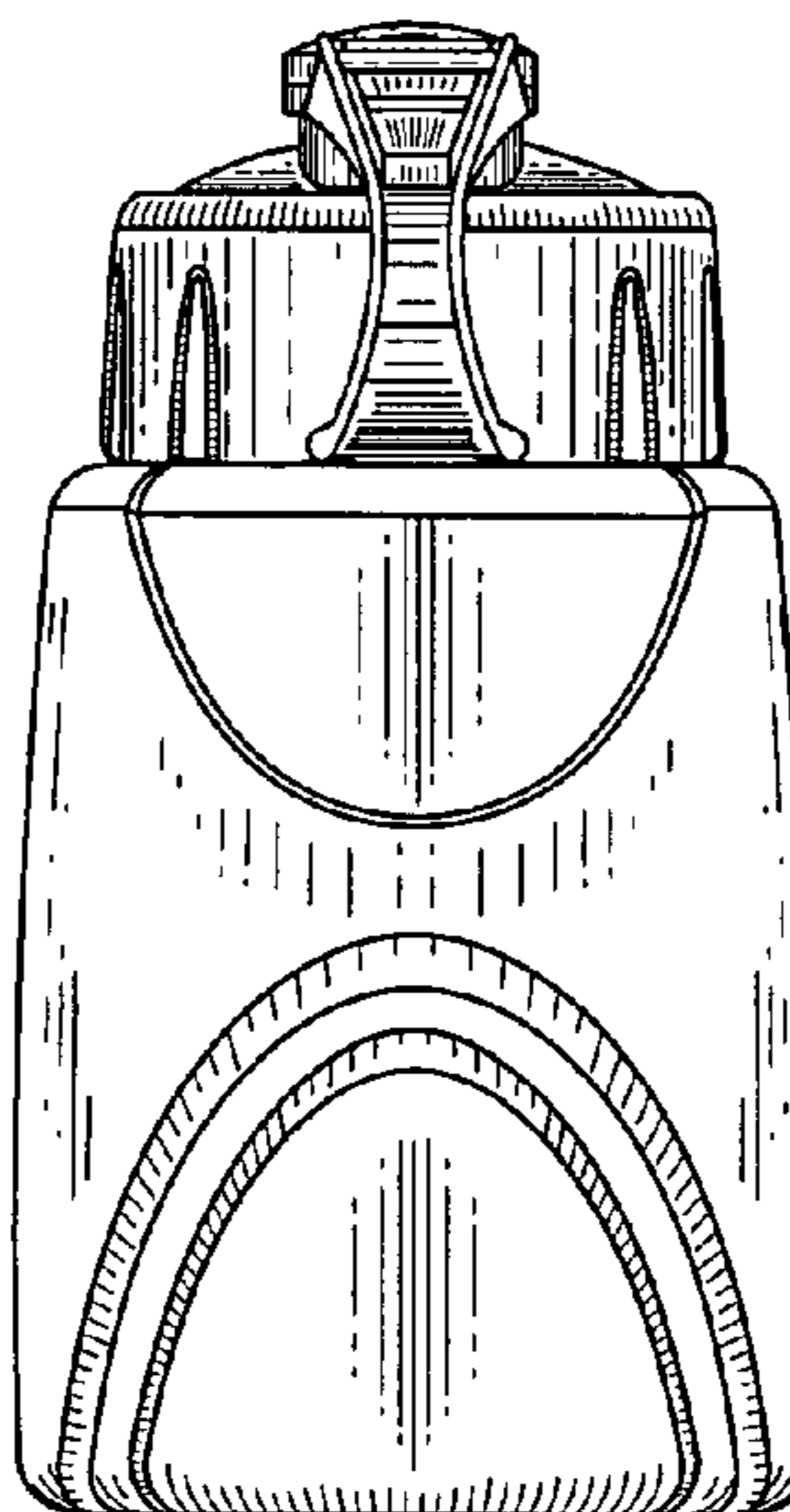
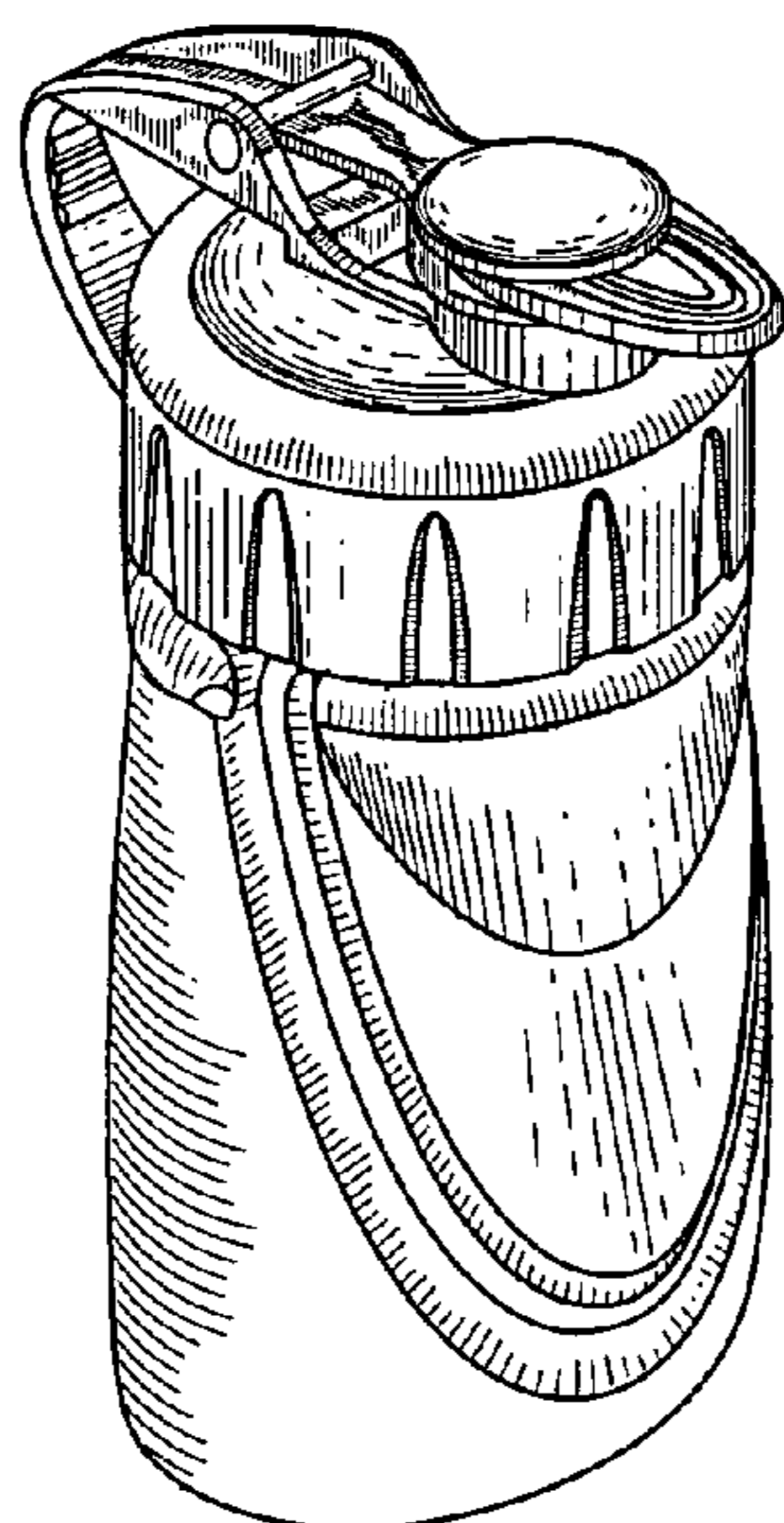
FIG. 11 is an enlarged right side elevational view thereof;

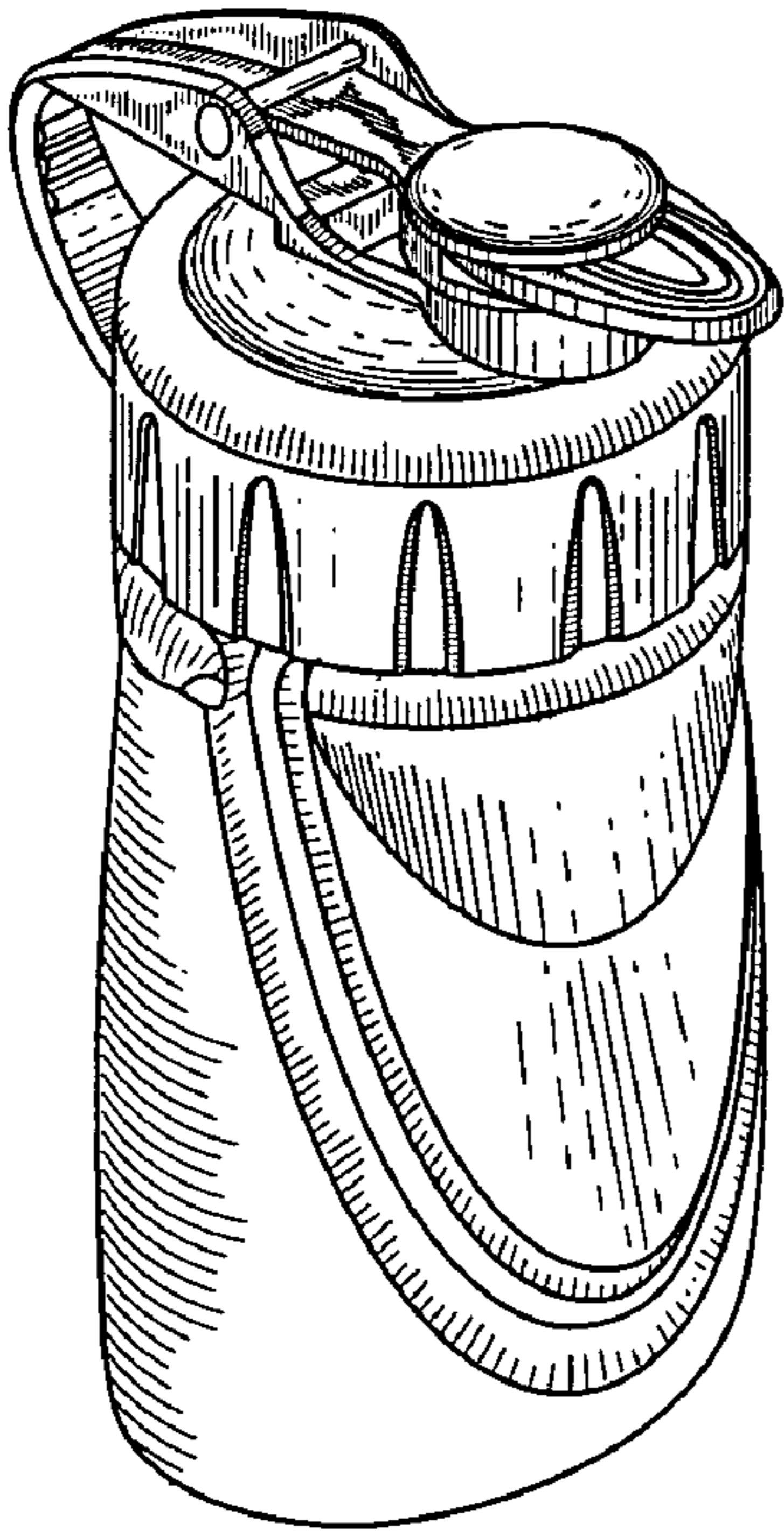

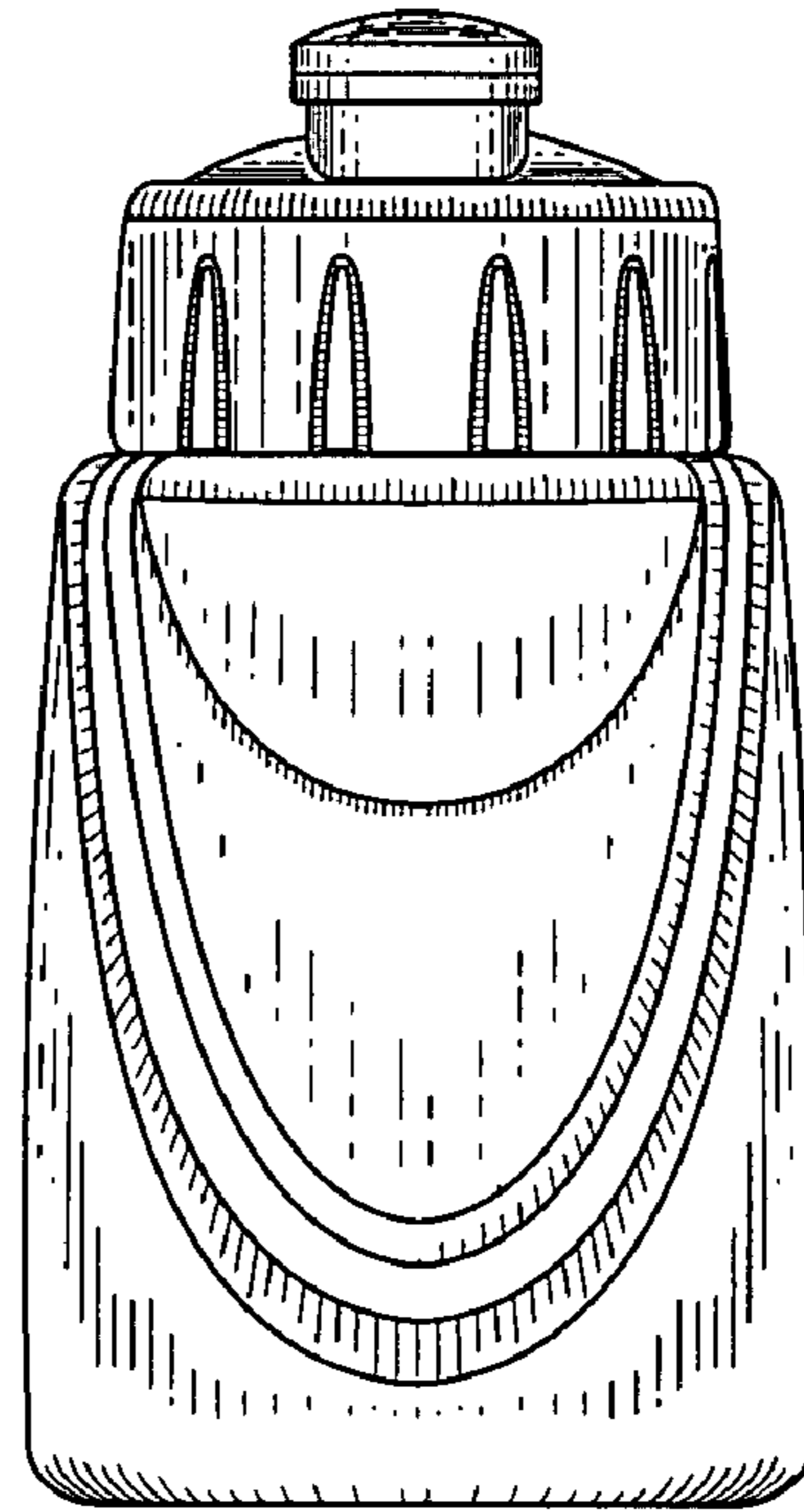

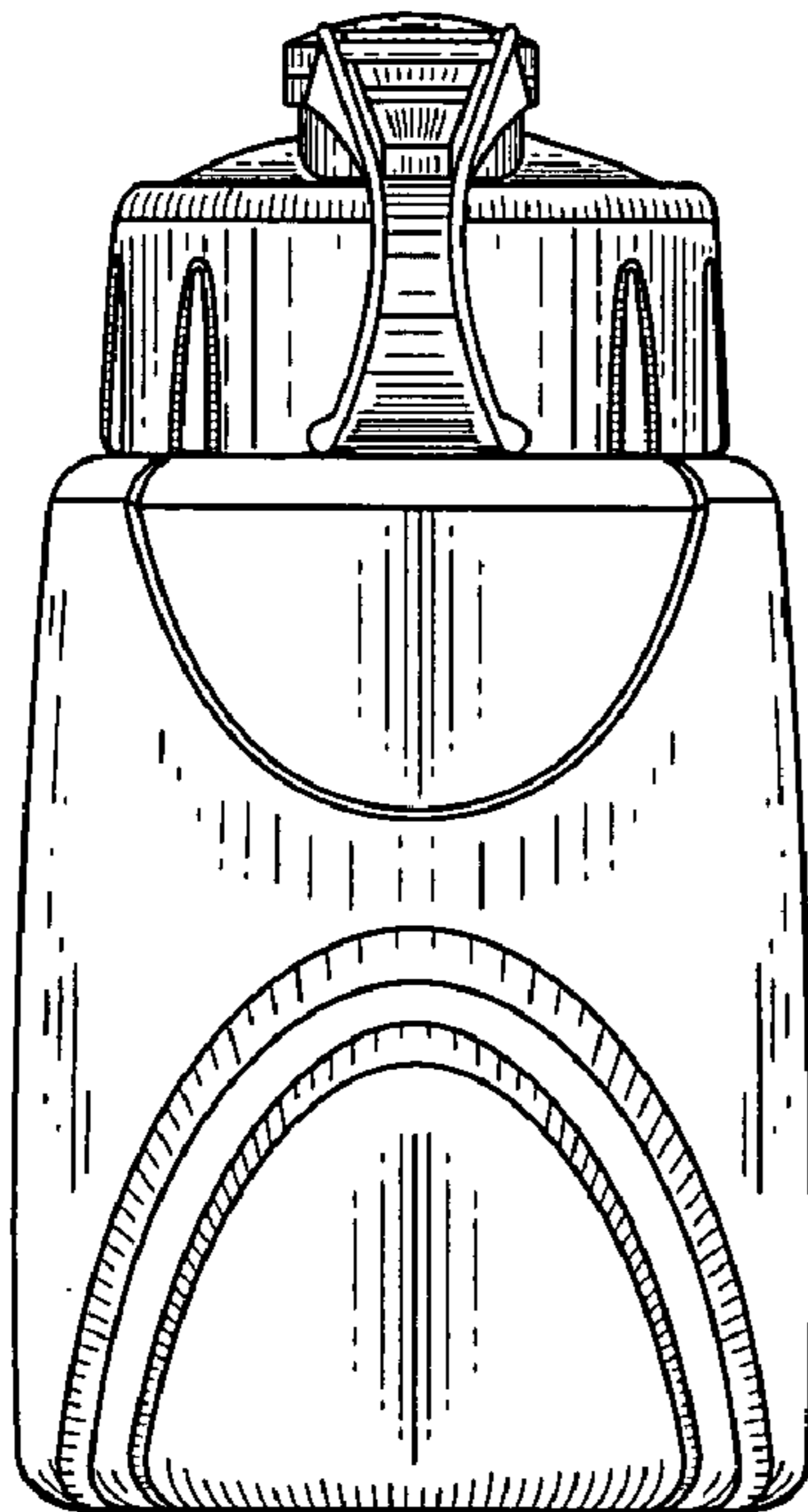

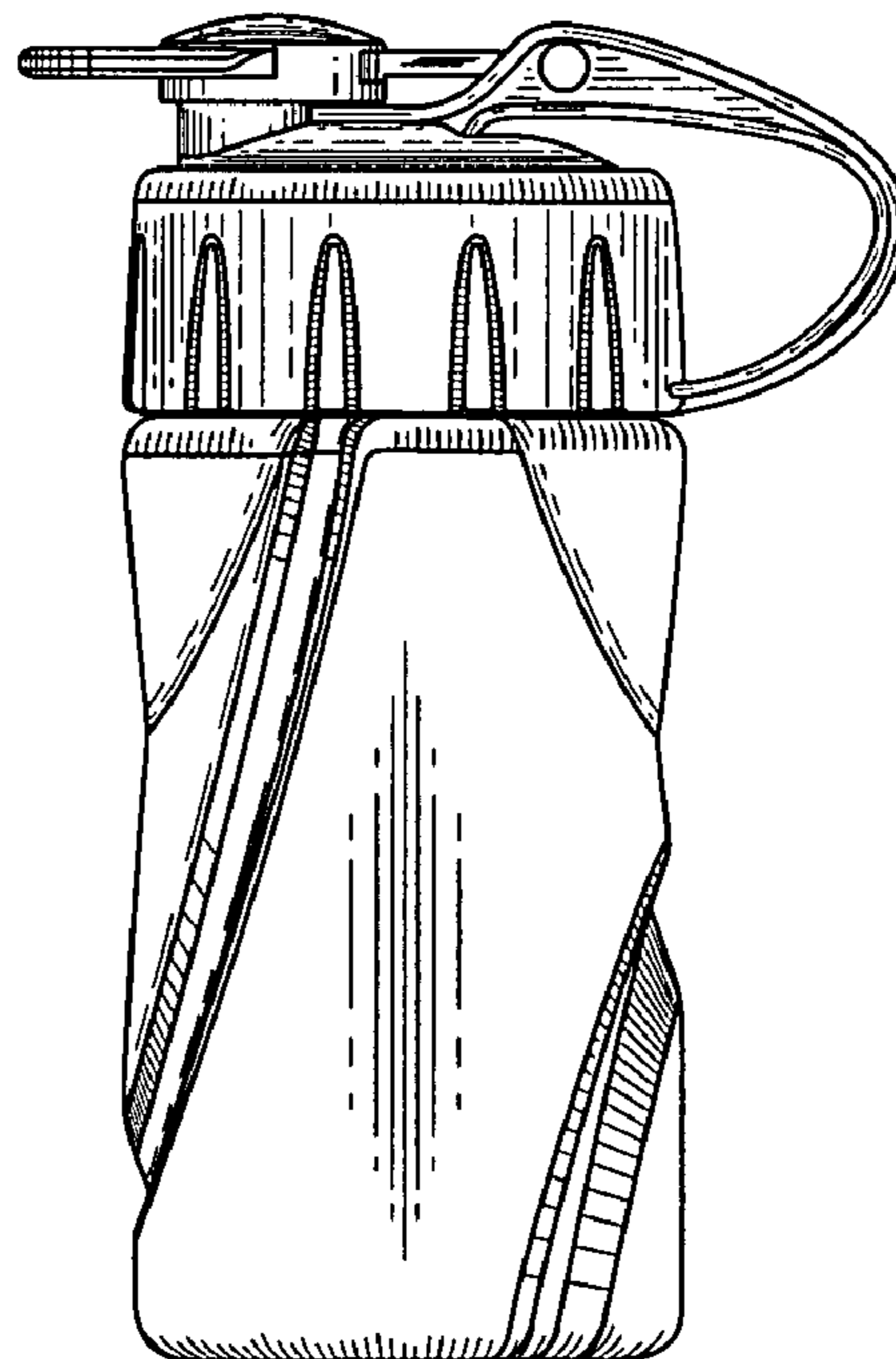

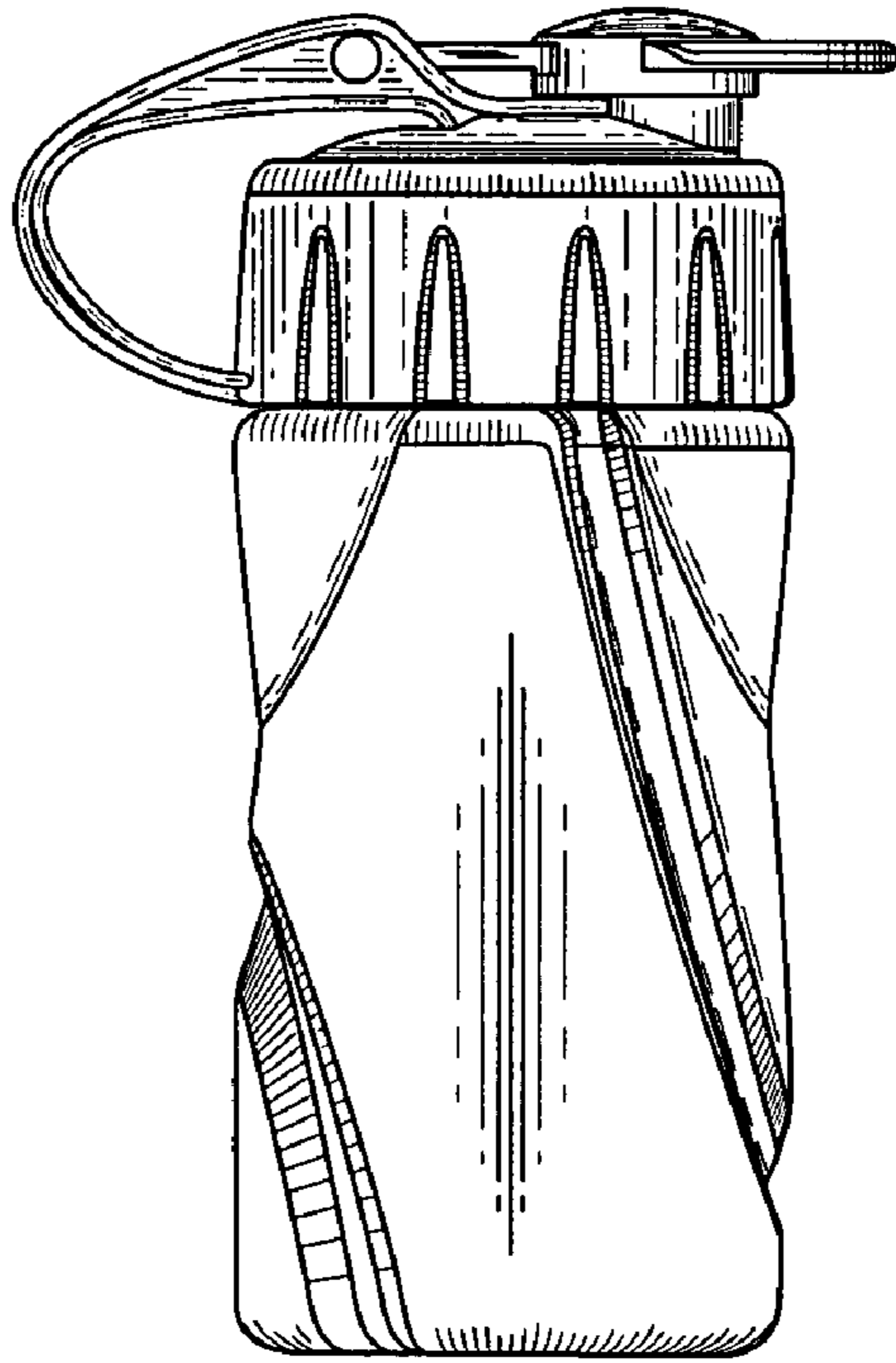

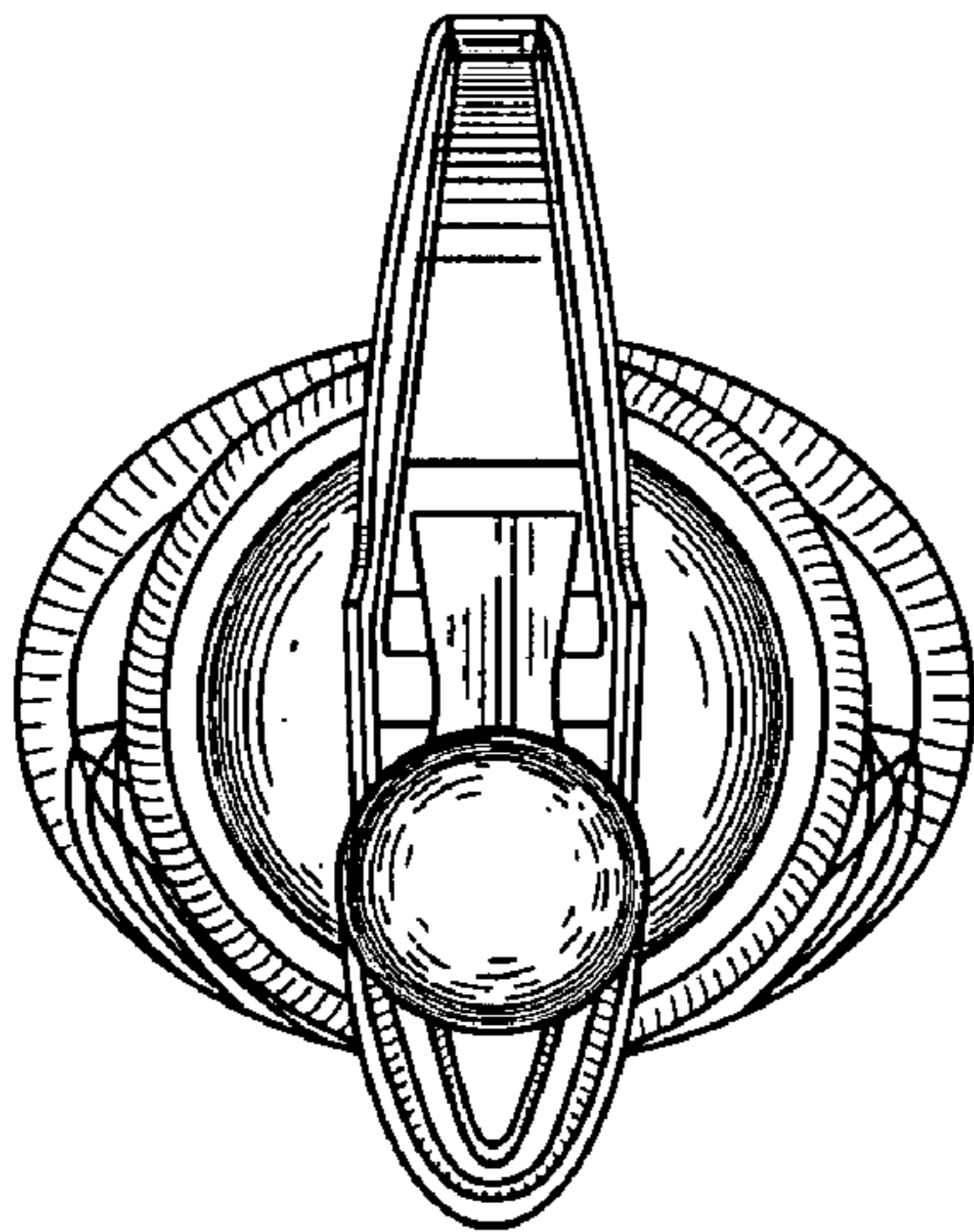

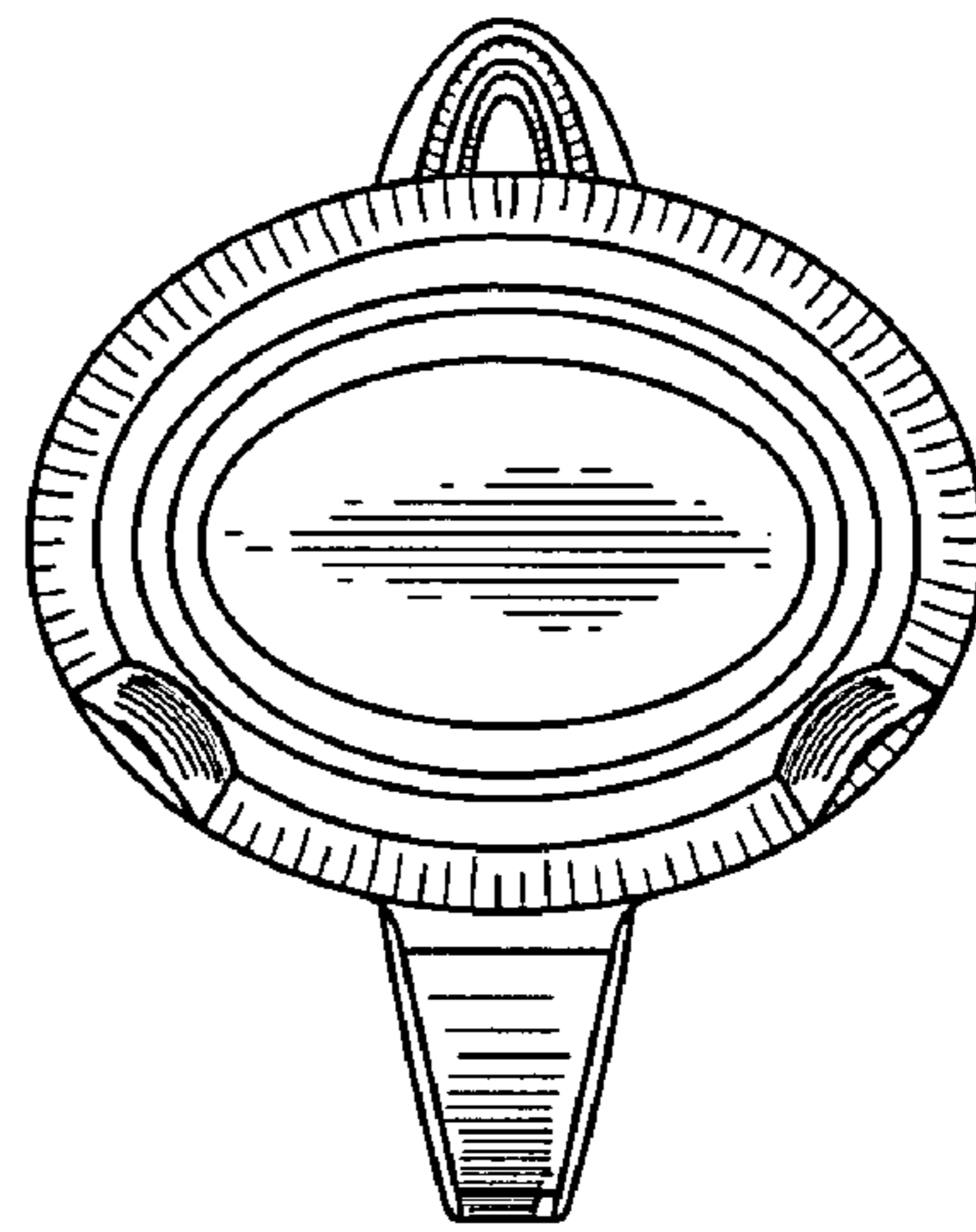

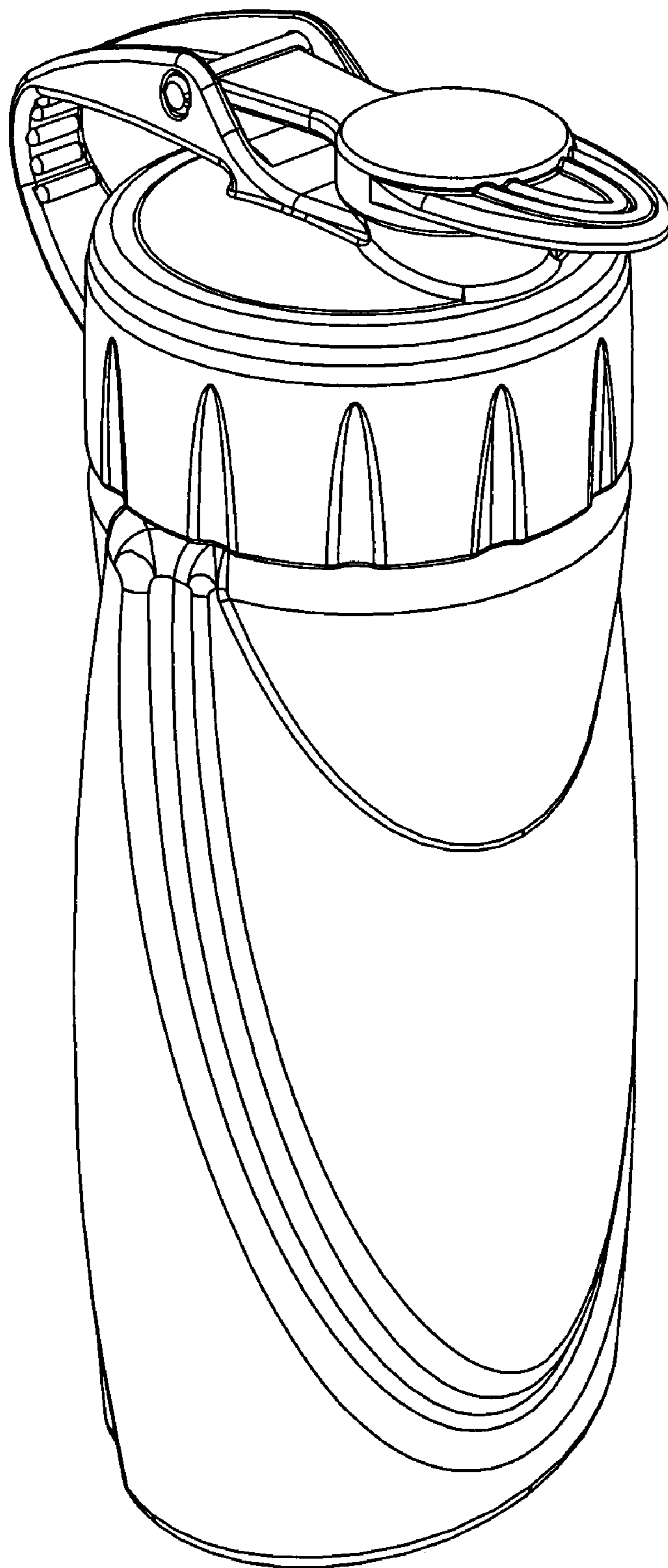

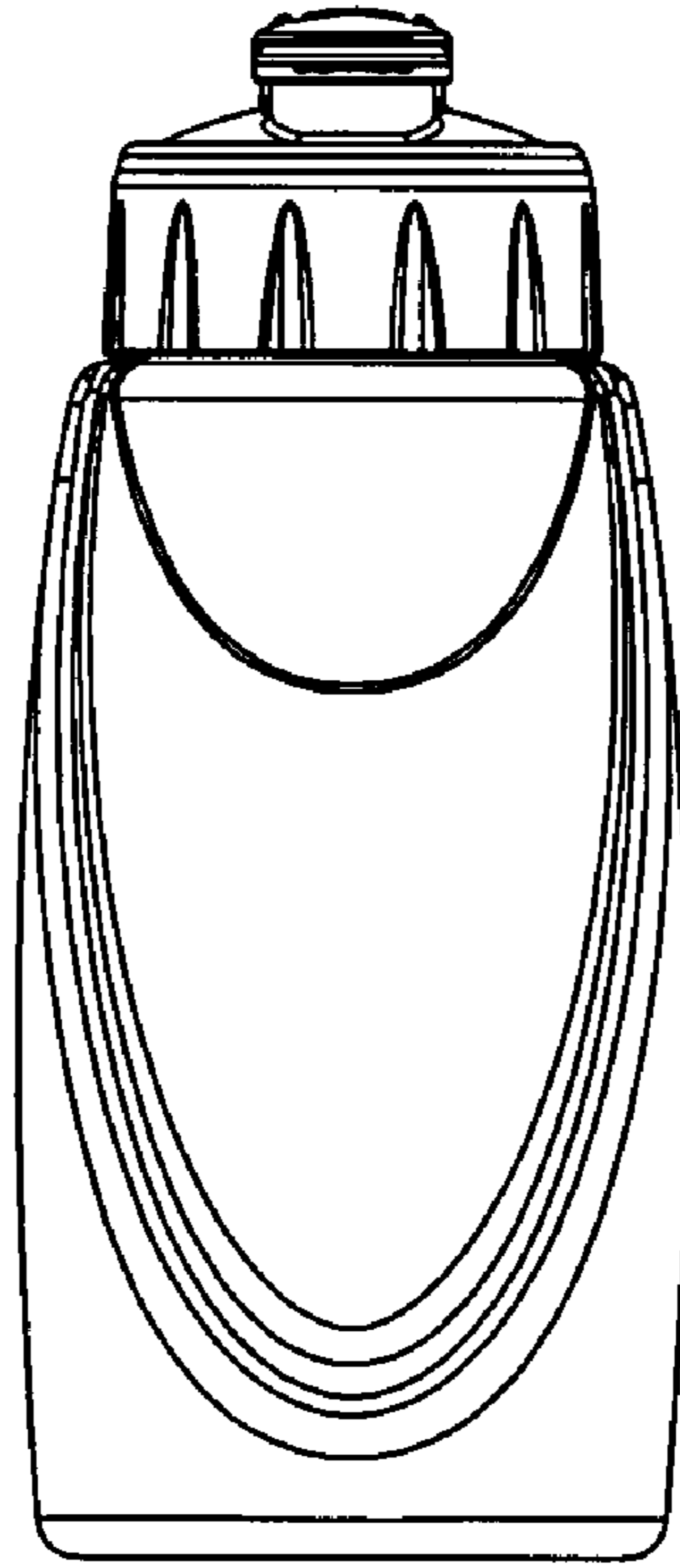

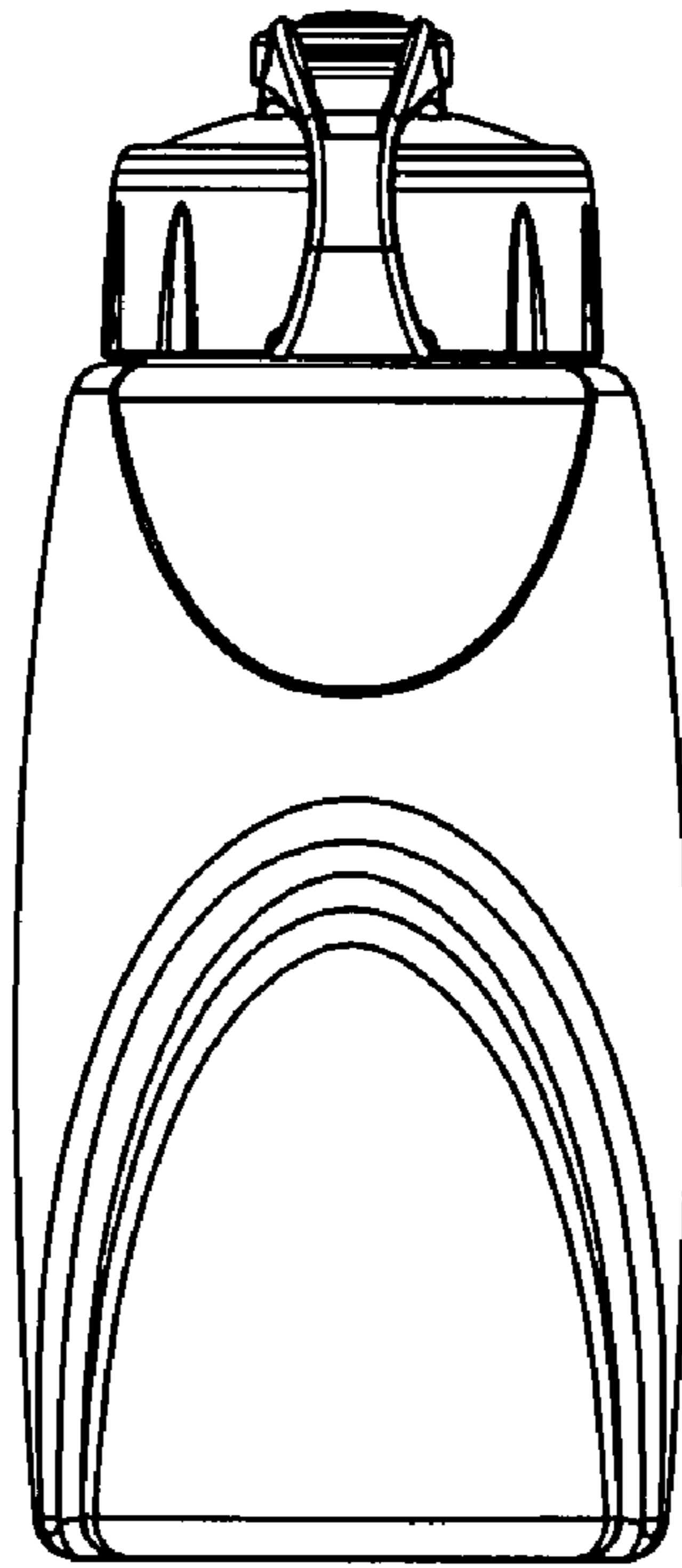

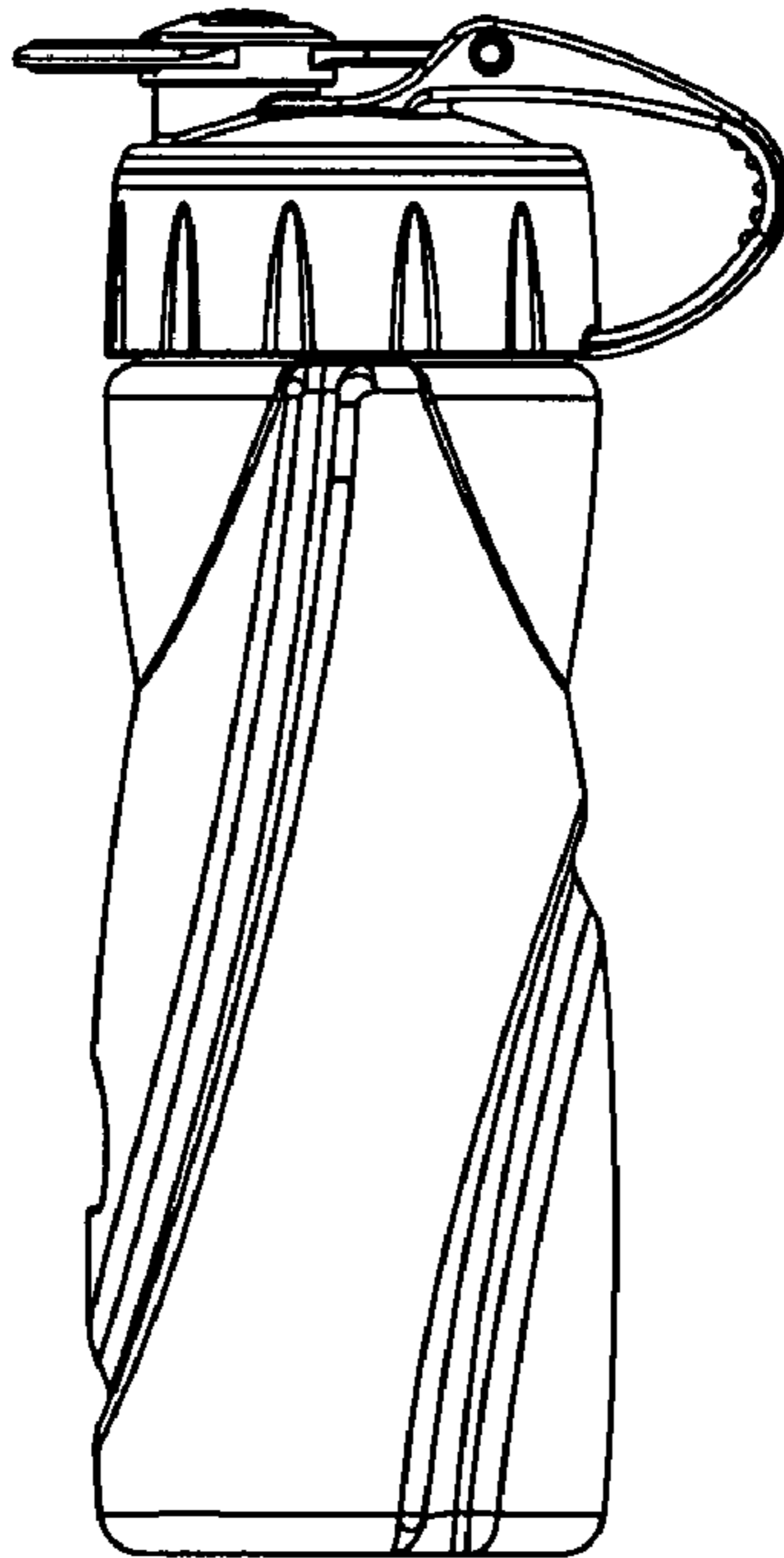

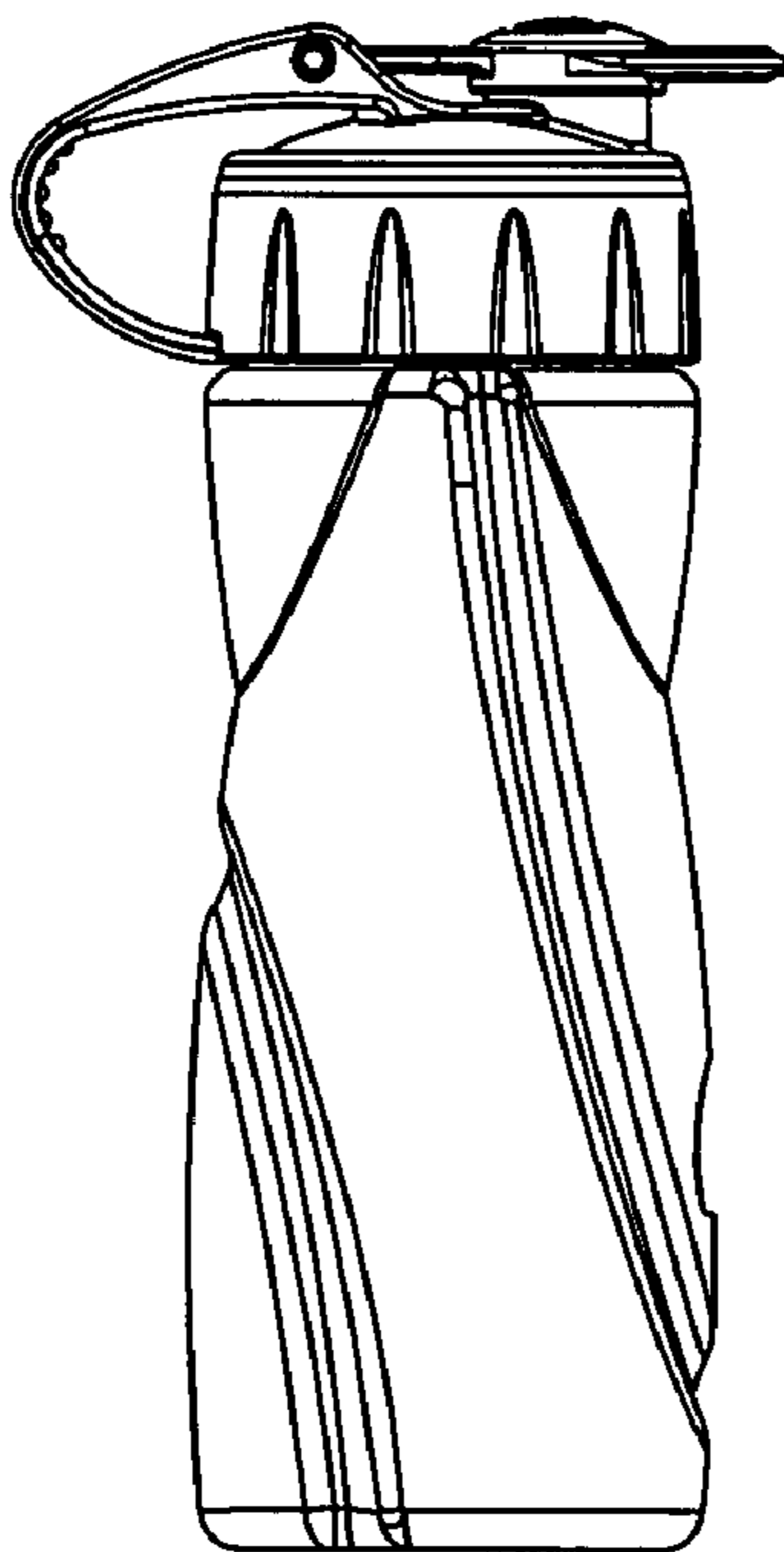

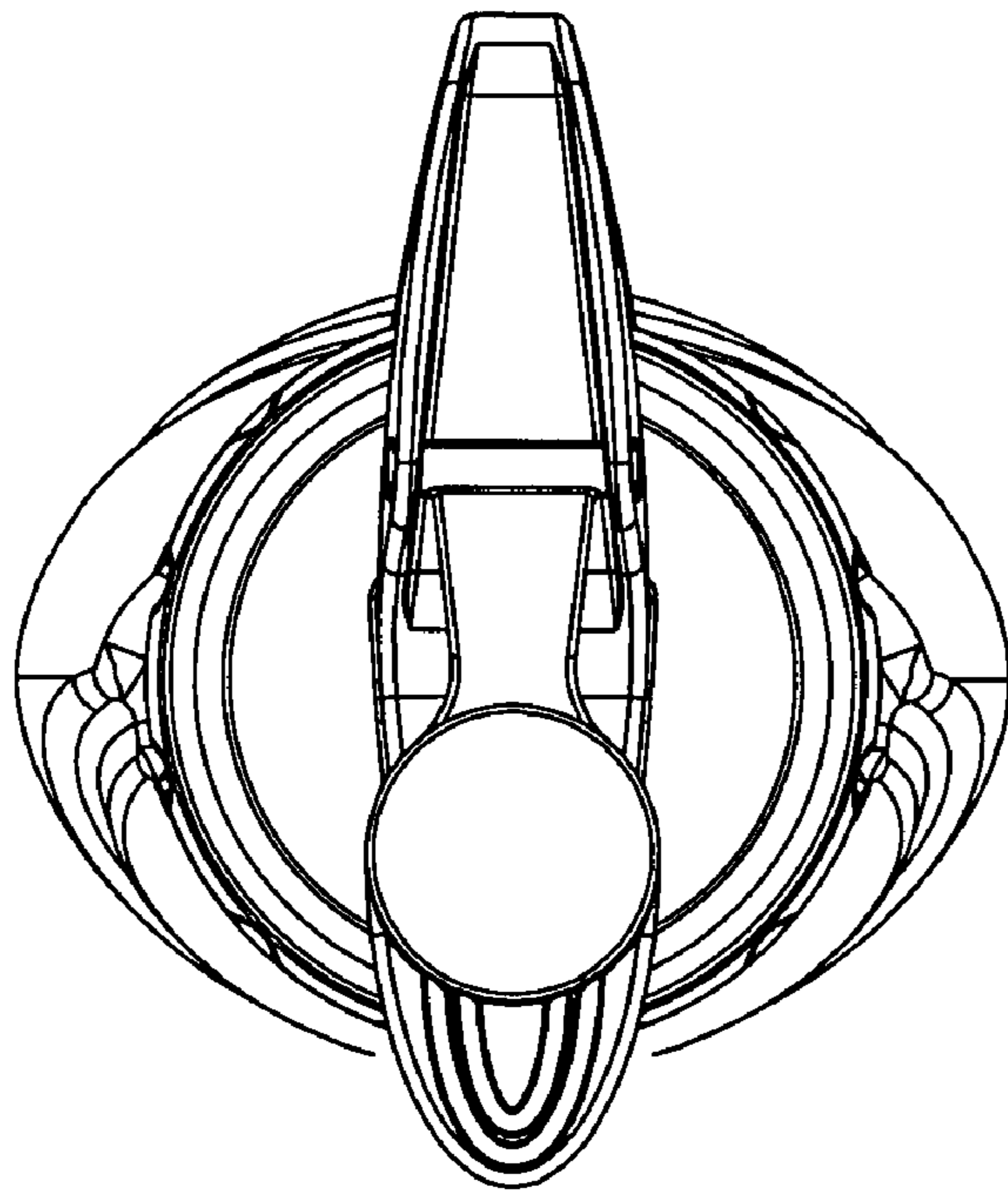

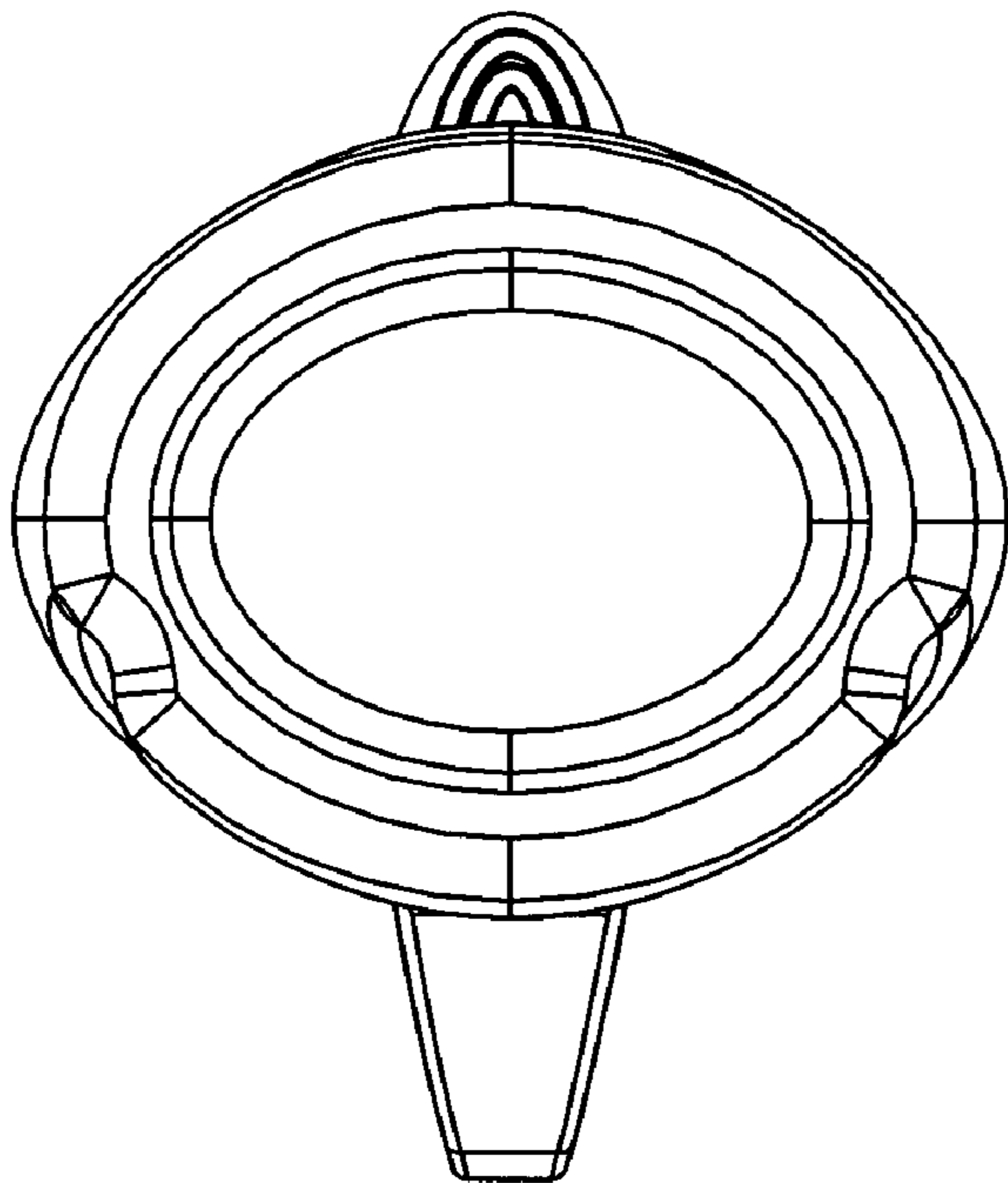
