FIG. 1 is a front elevation view of a sheetrock lifting and retaining apparatus showing our new design;

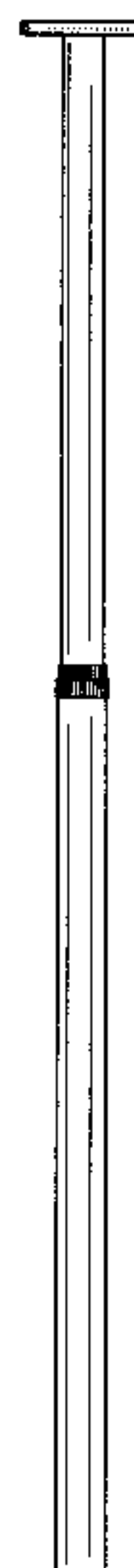
FIG. 2 is a side elevation view;

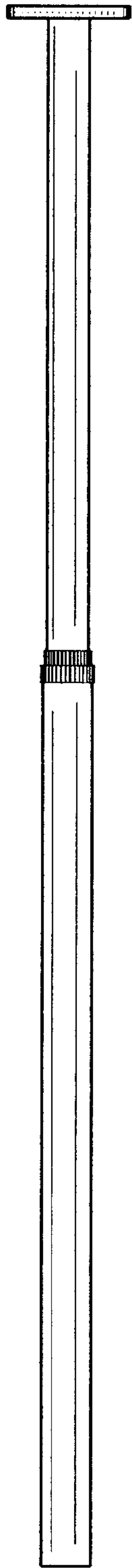

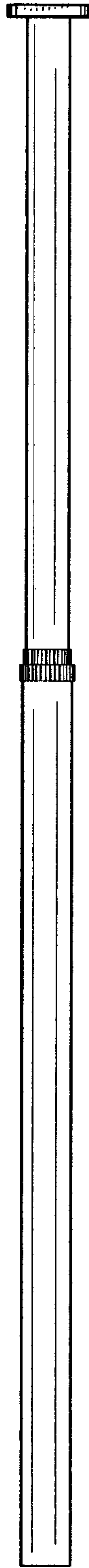

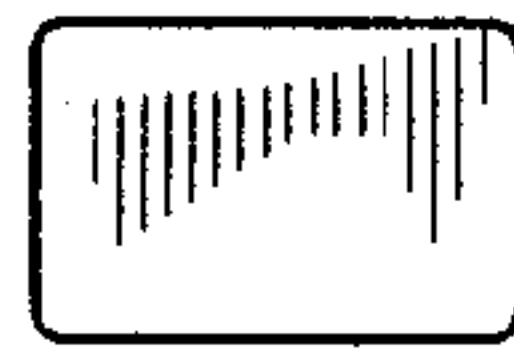

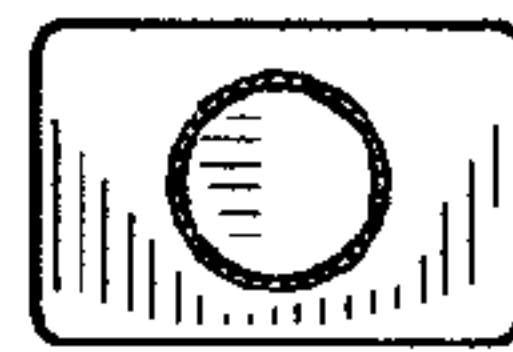
