FIG. 4 is a back view thereof;

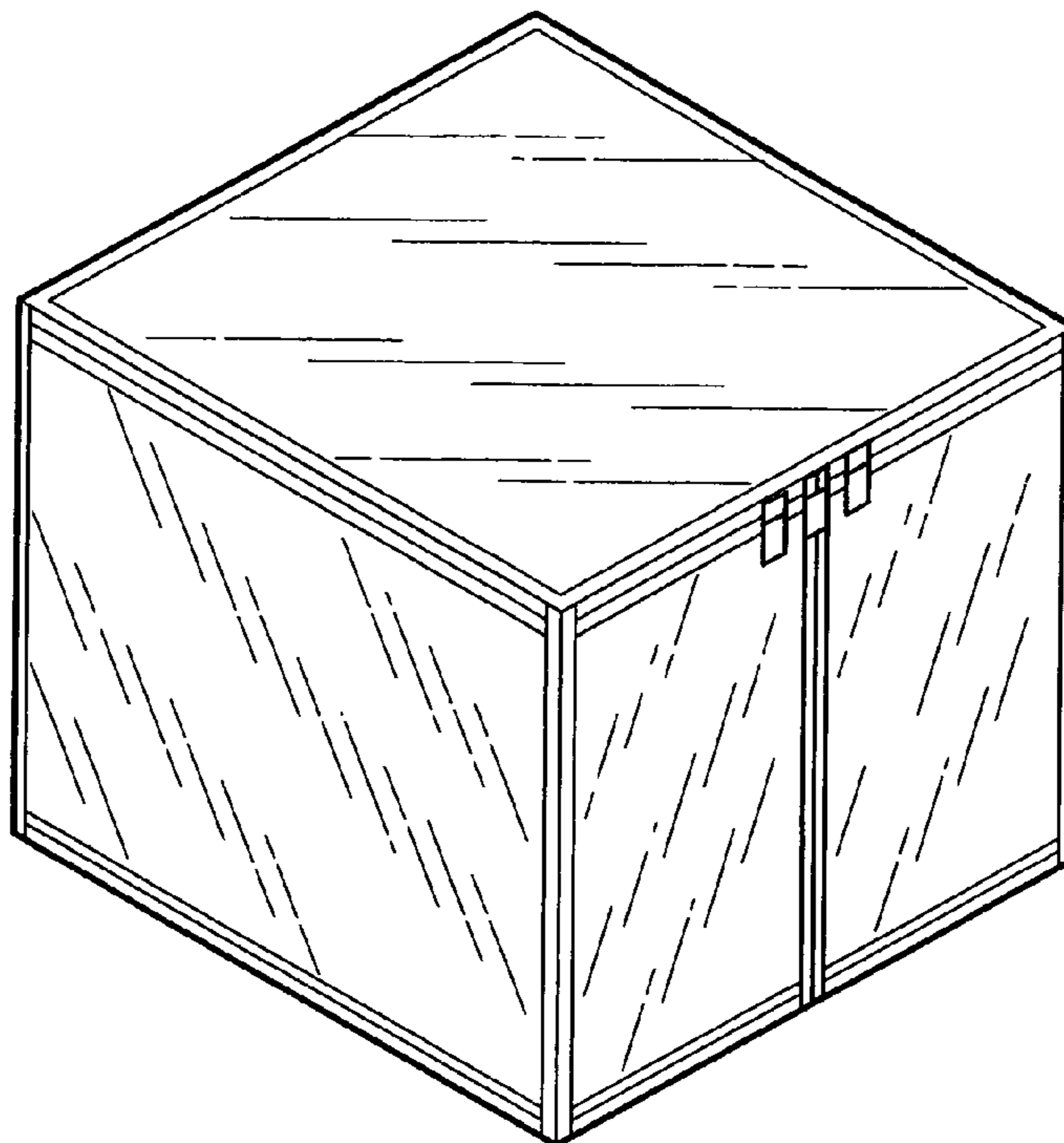
FIG. 5 is a top plan view of the storage container thereof;

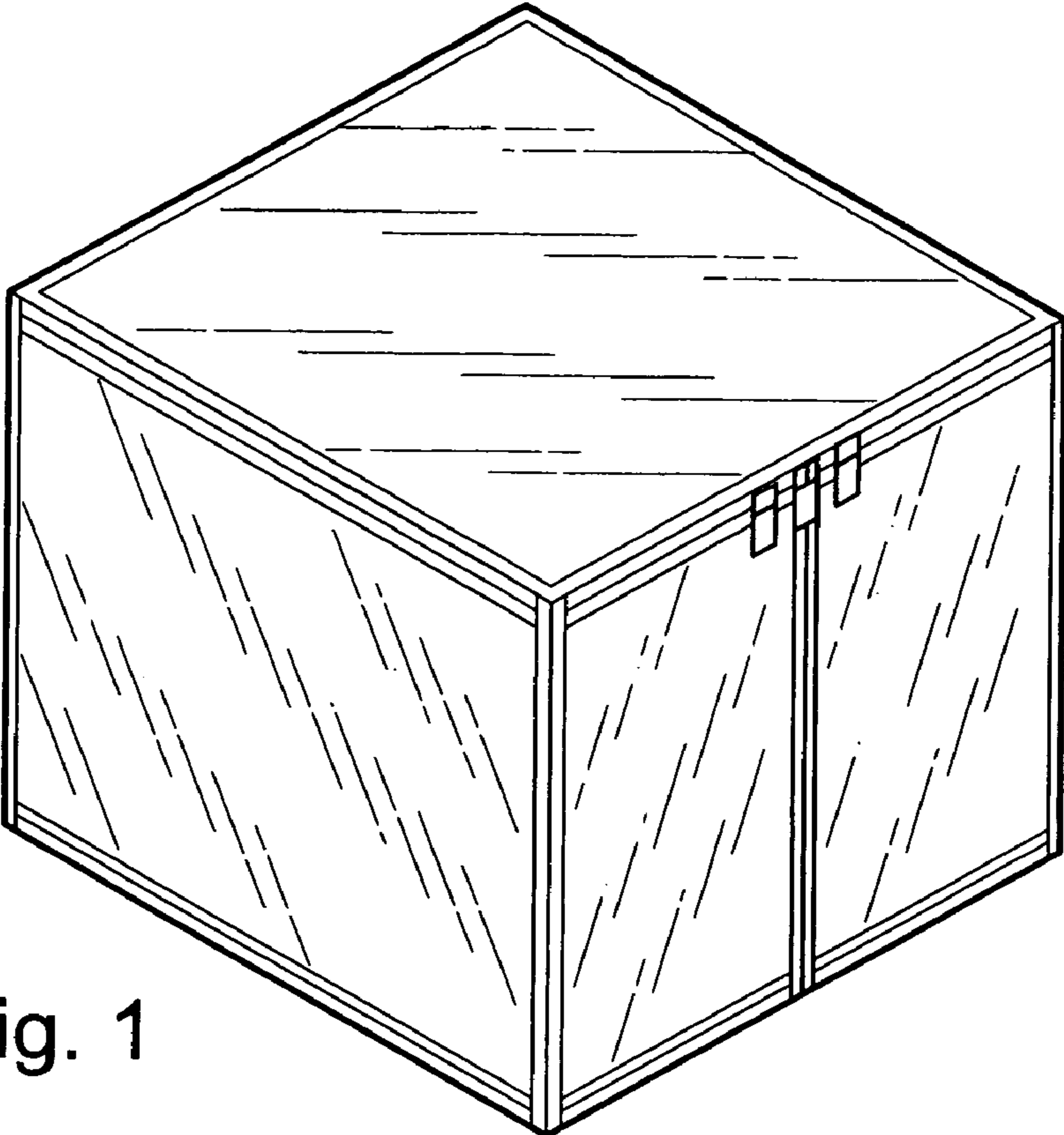

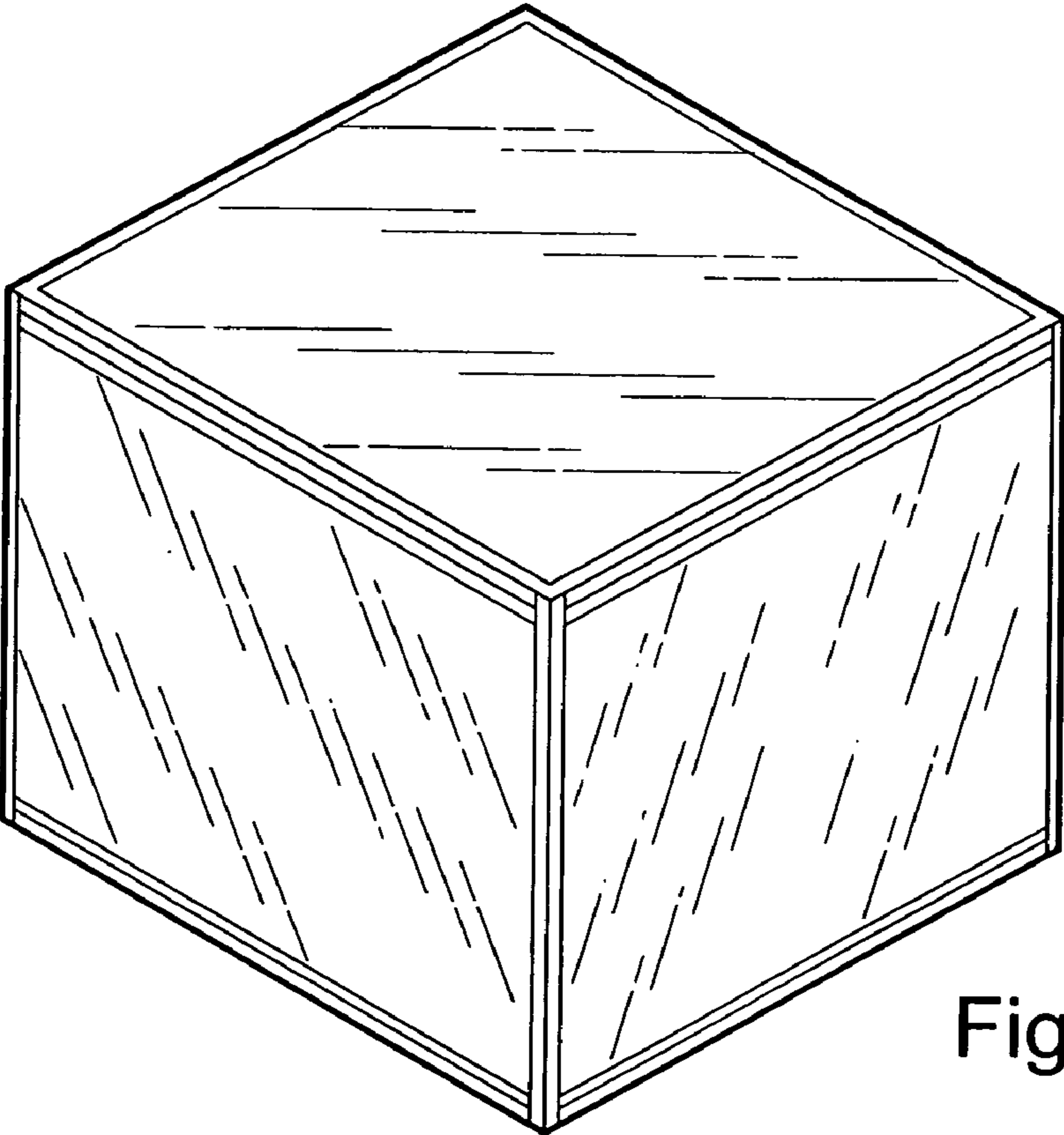

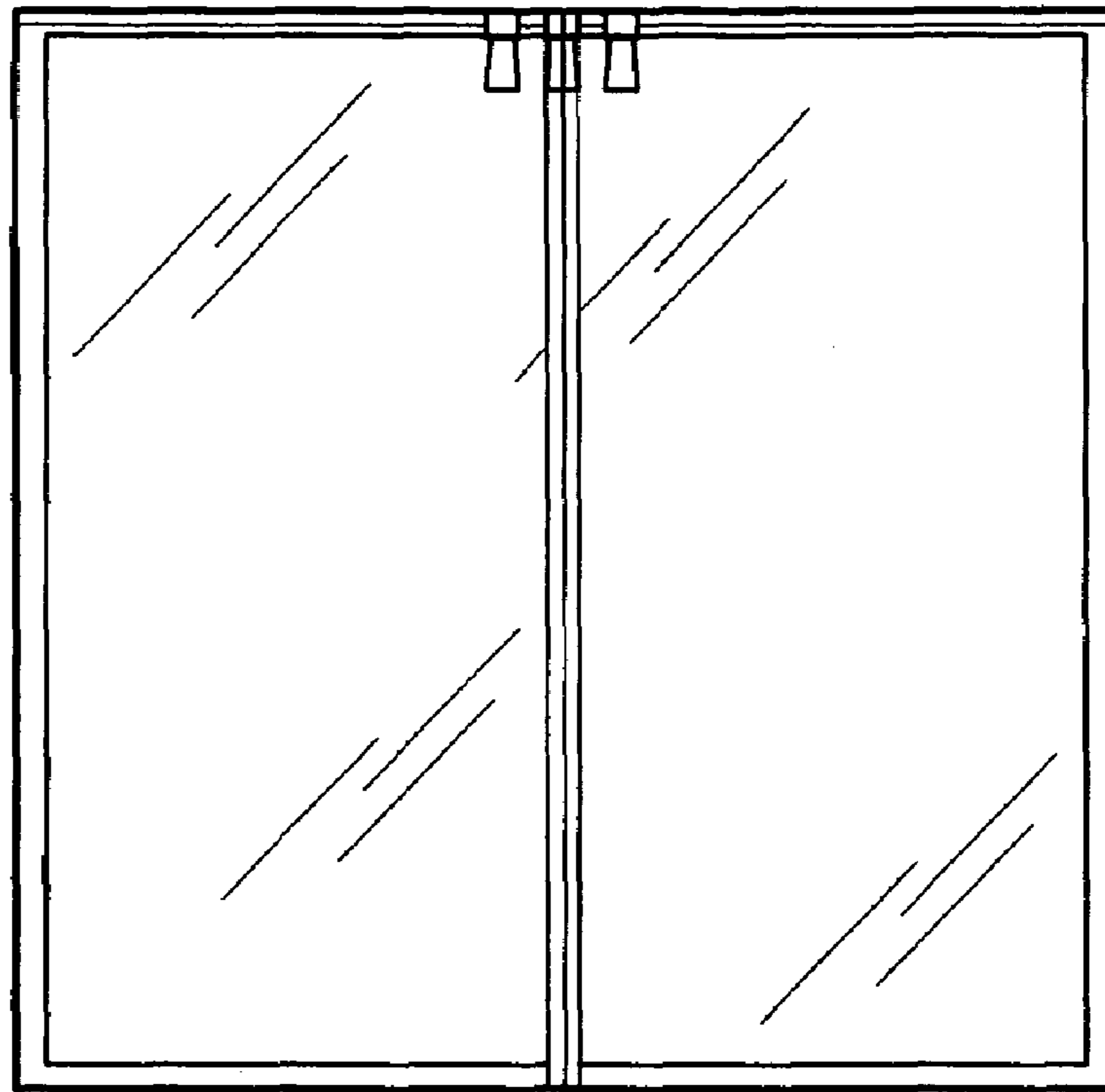

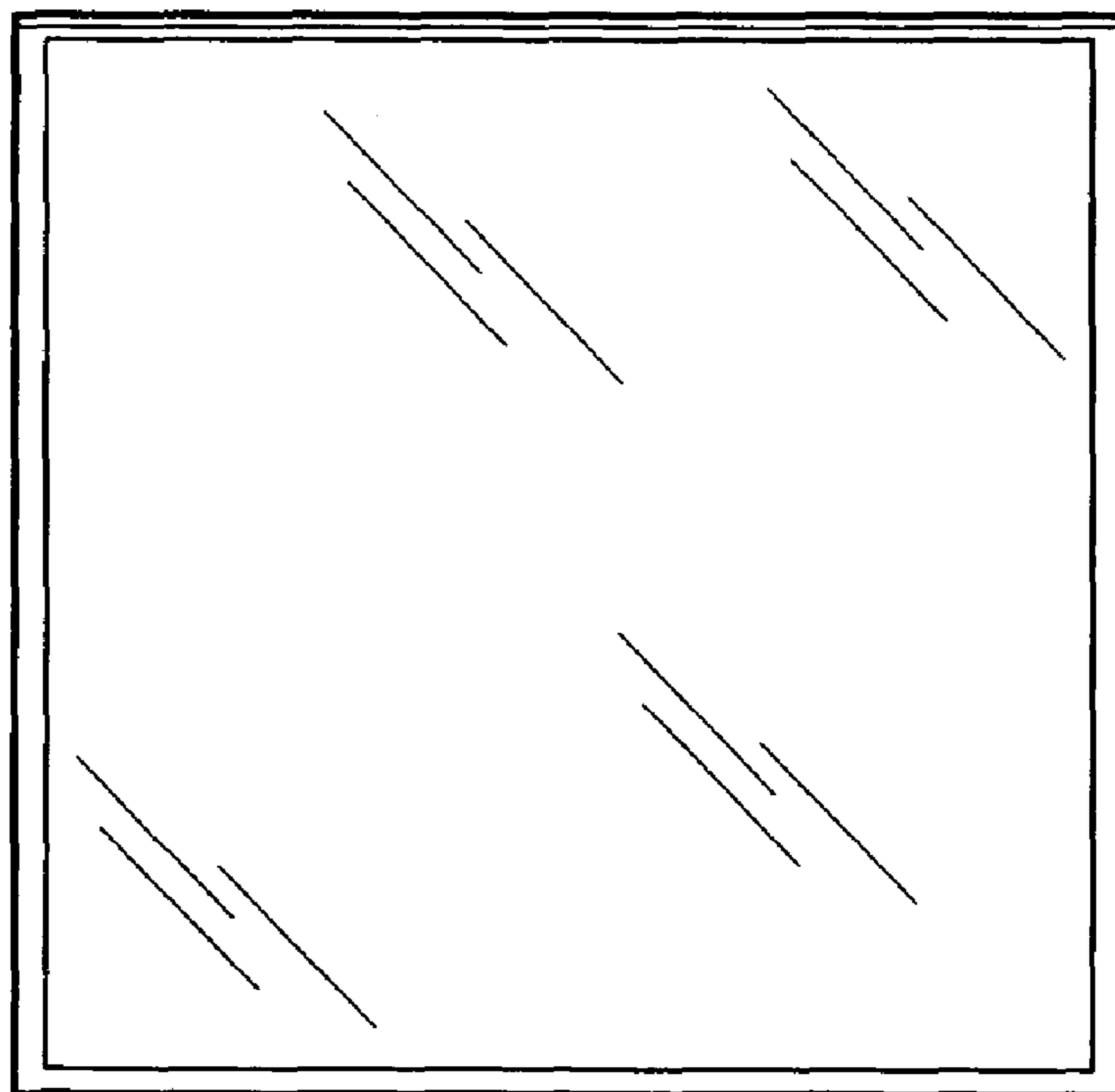

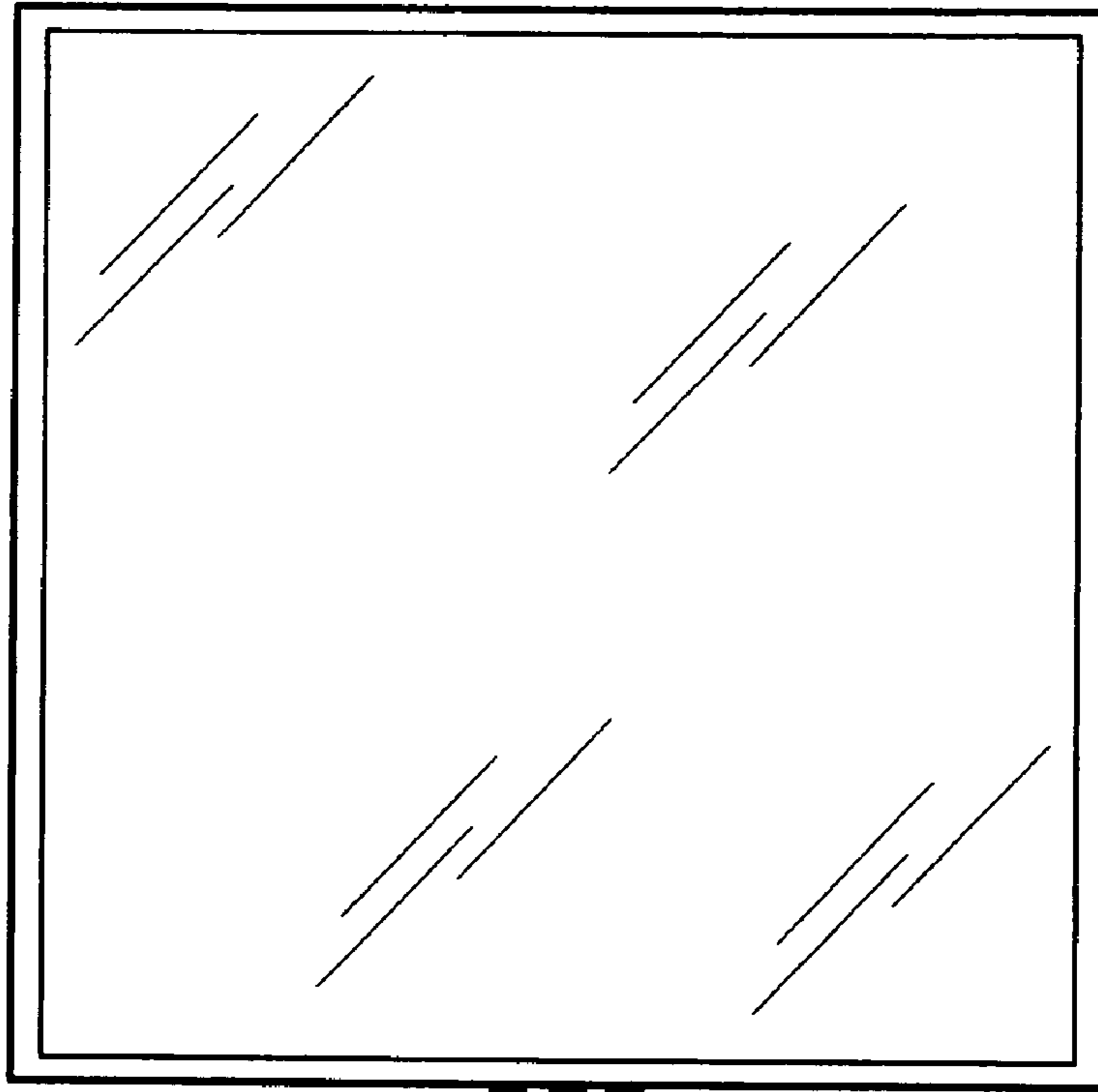

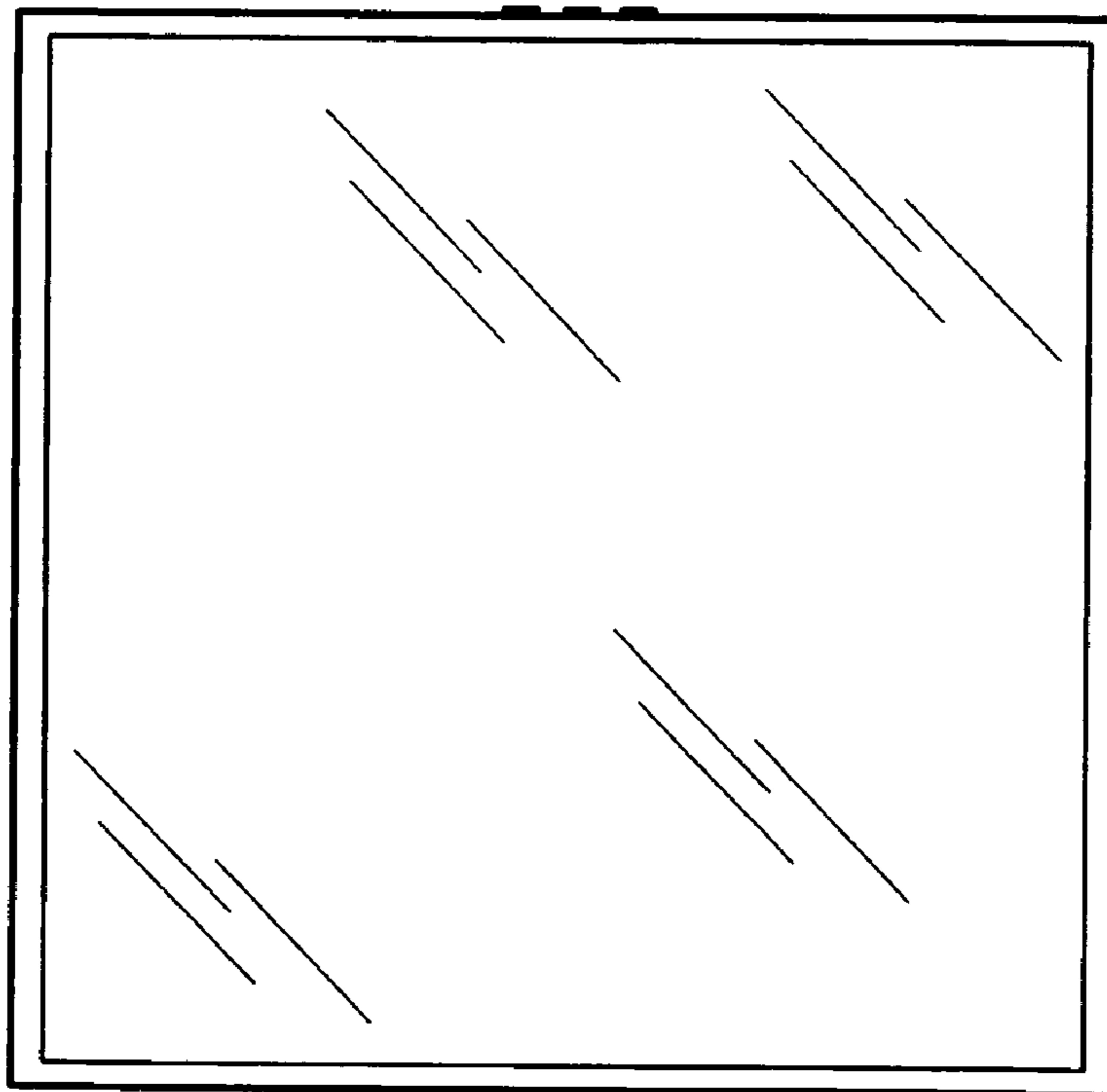

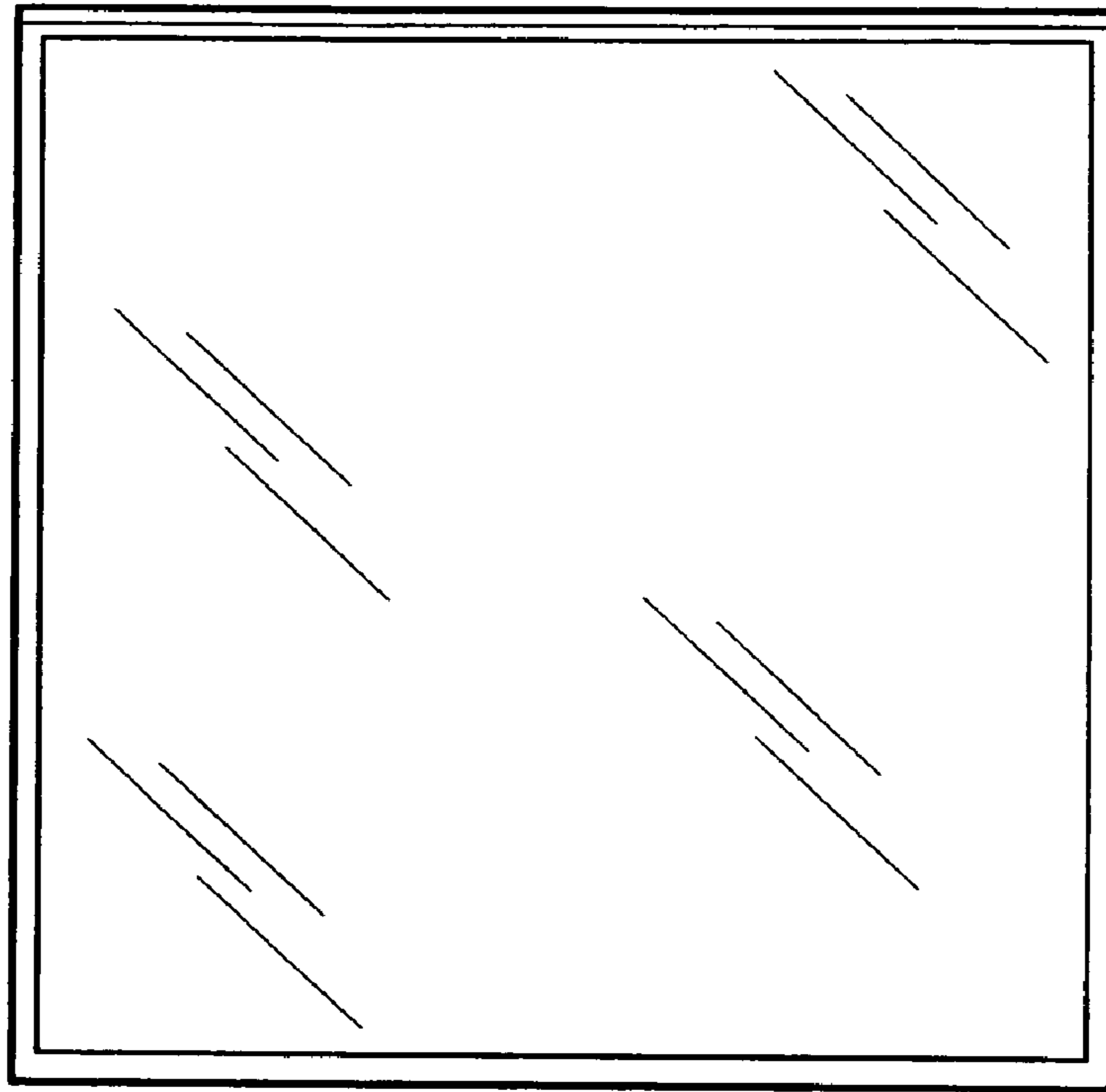

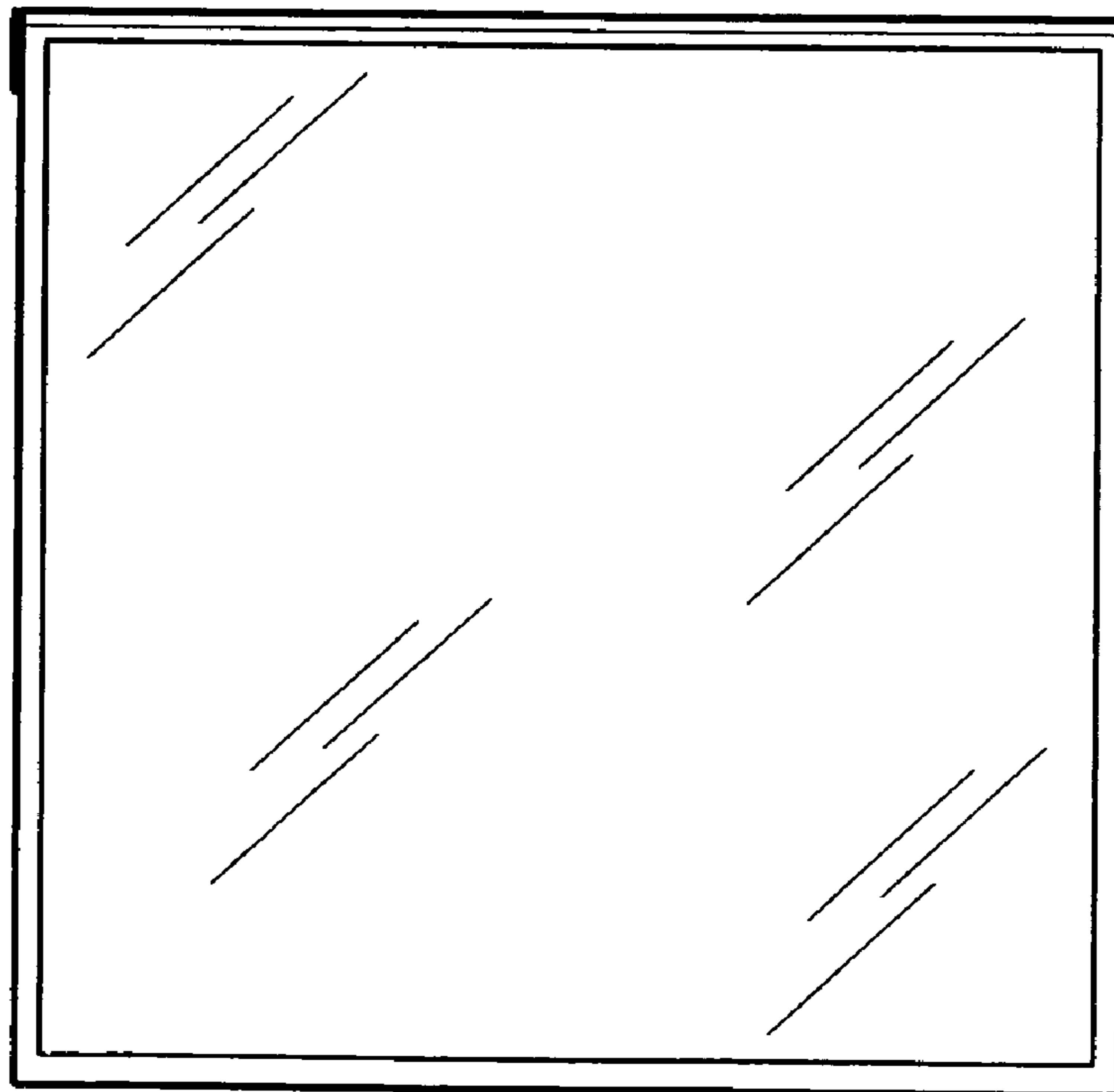
