(57) **CLAIM**

The ornamental design for packaging for a bag dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and side perspective view of packaging for a bag dispenser embodying my new design, illustrated in place over exterior surfaces of an exemplary bag dispenser shown in phantom;

FIG. 2 is a front, top and side perspective view of the packaging for a bag dispenser illustrated in FIG. 1;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side elevational view thereof;

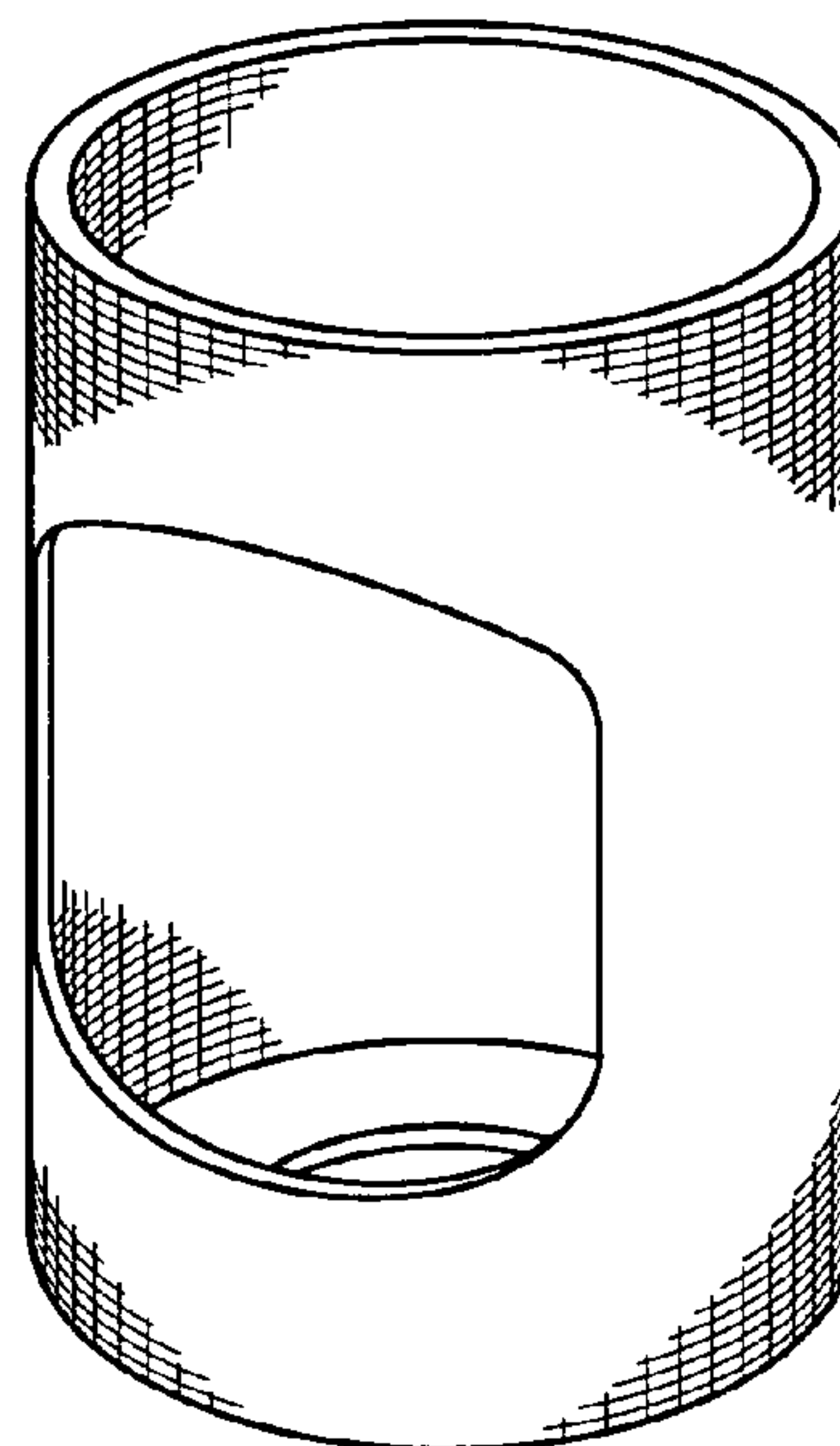
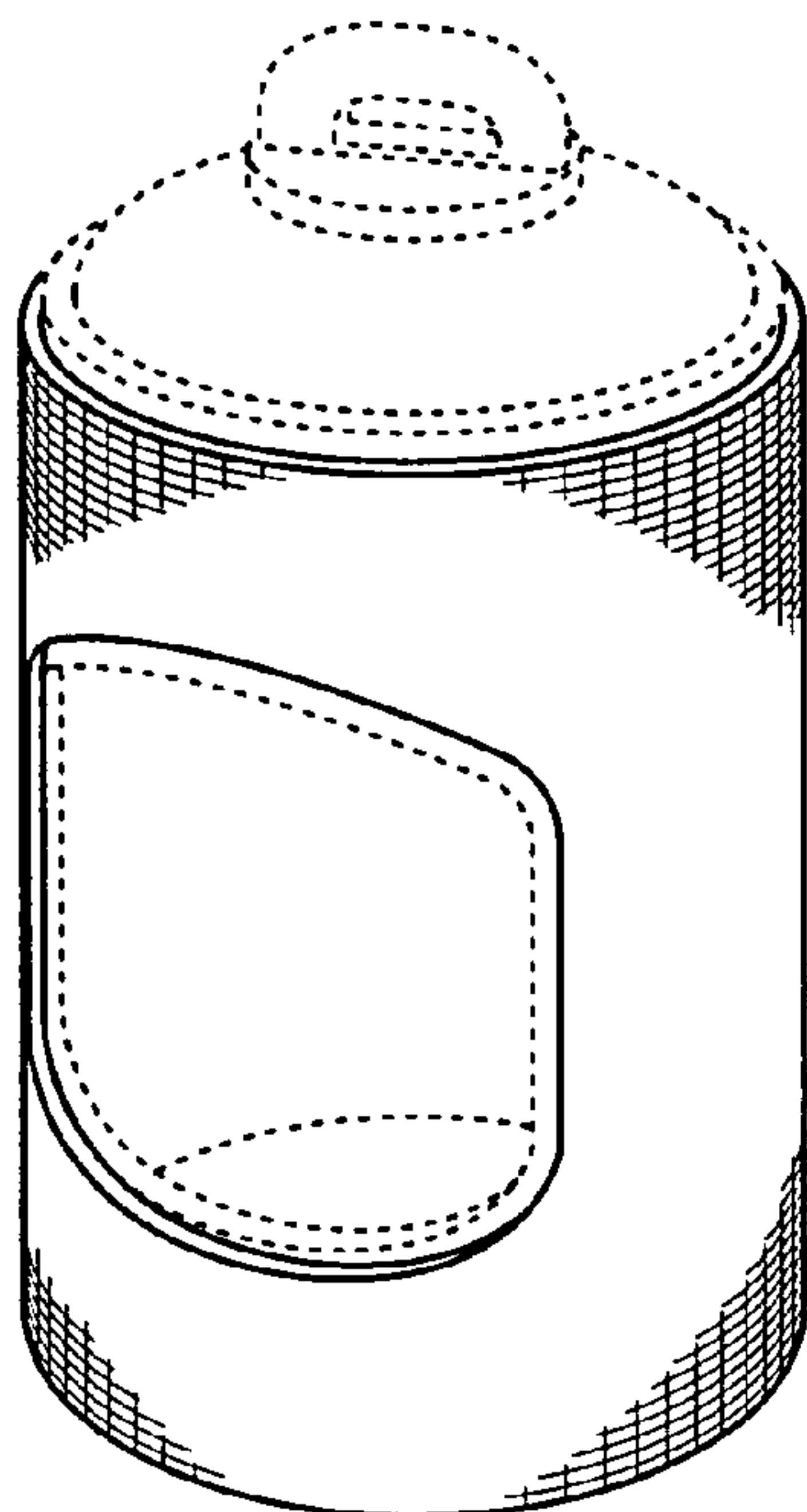
FIG. 6 is a right-side elevational view thereof;

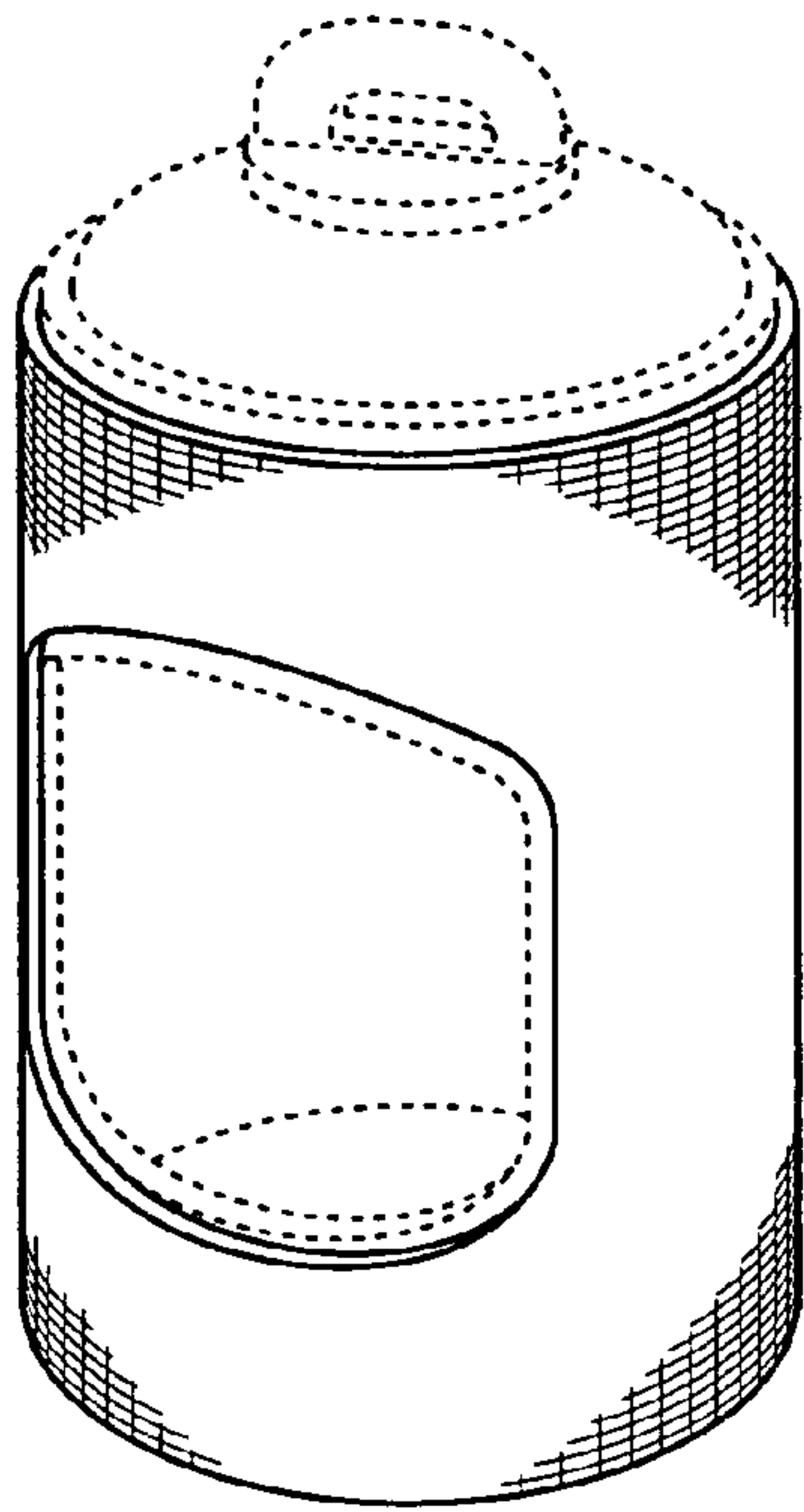

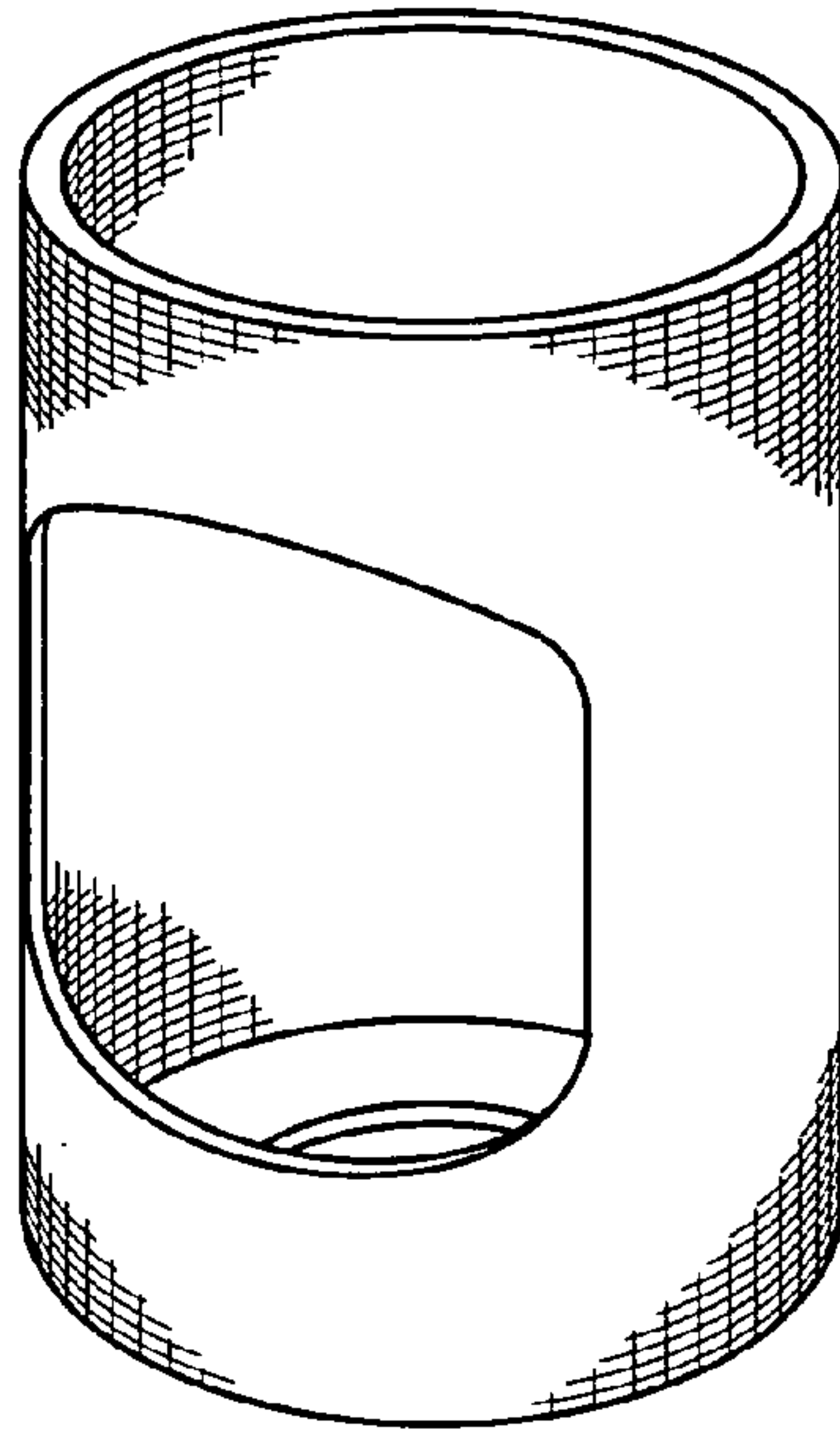

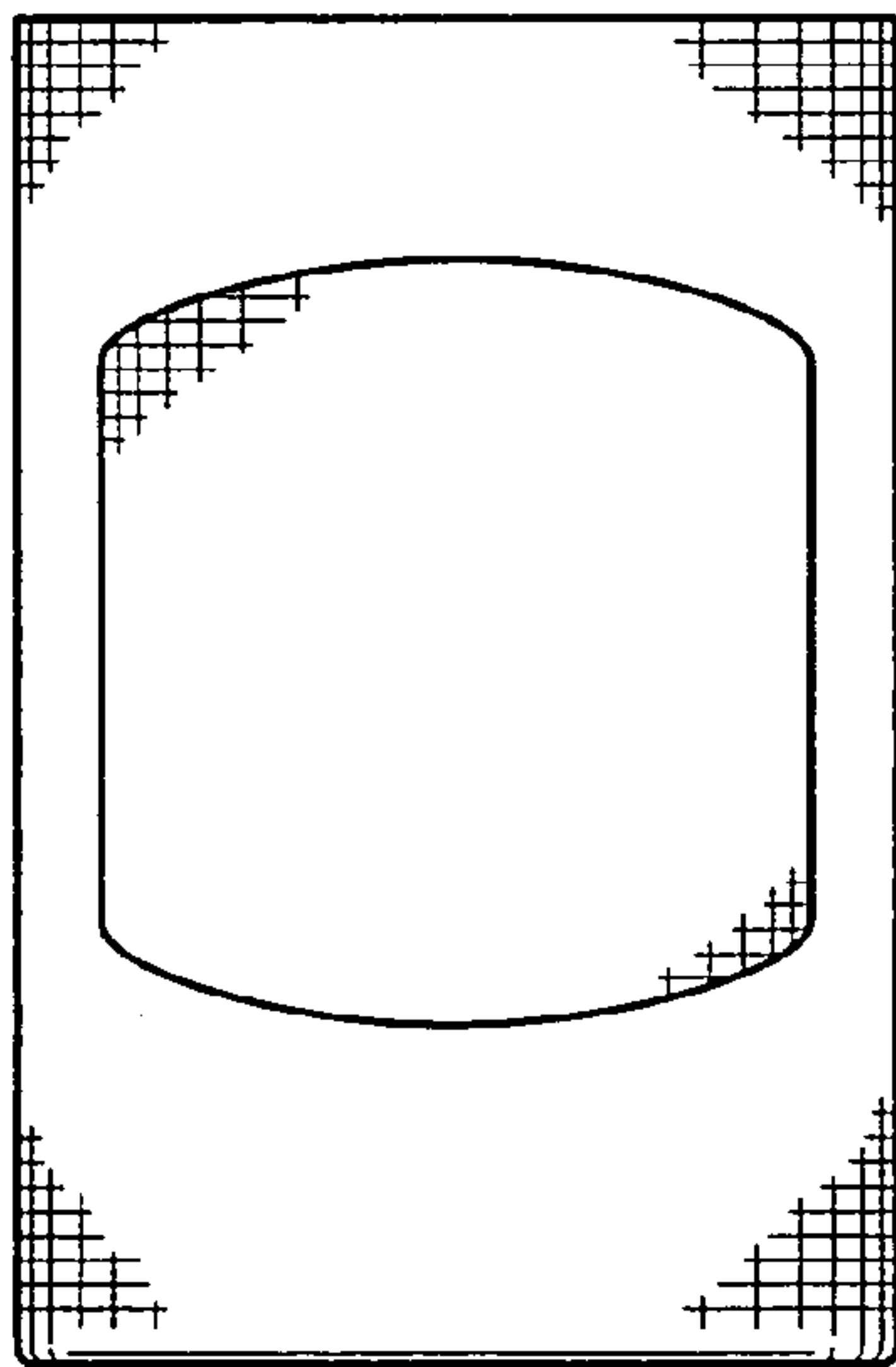

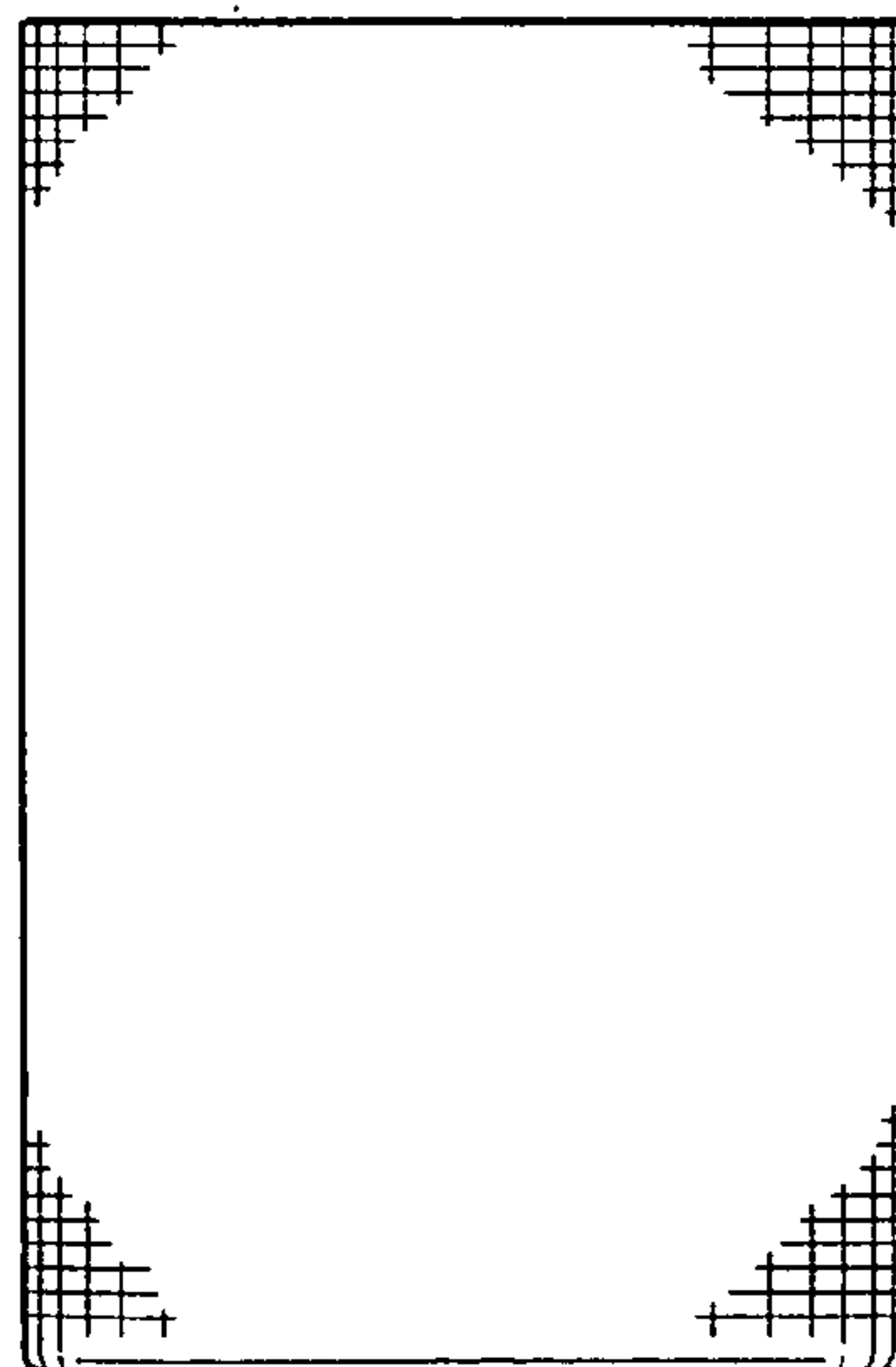

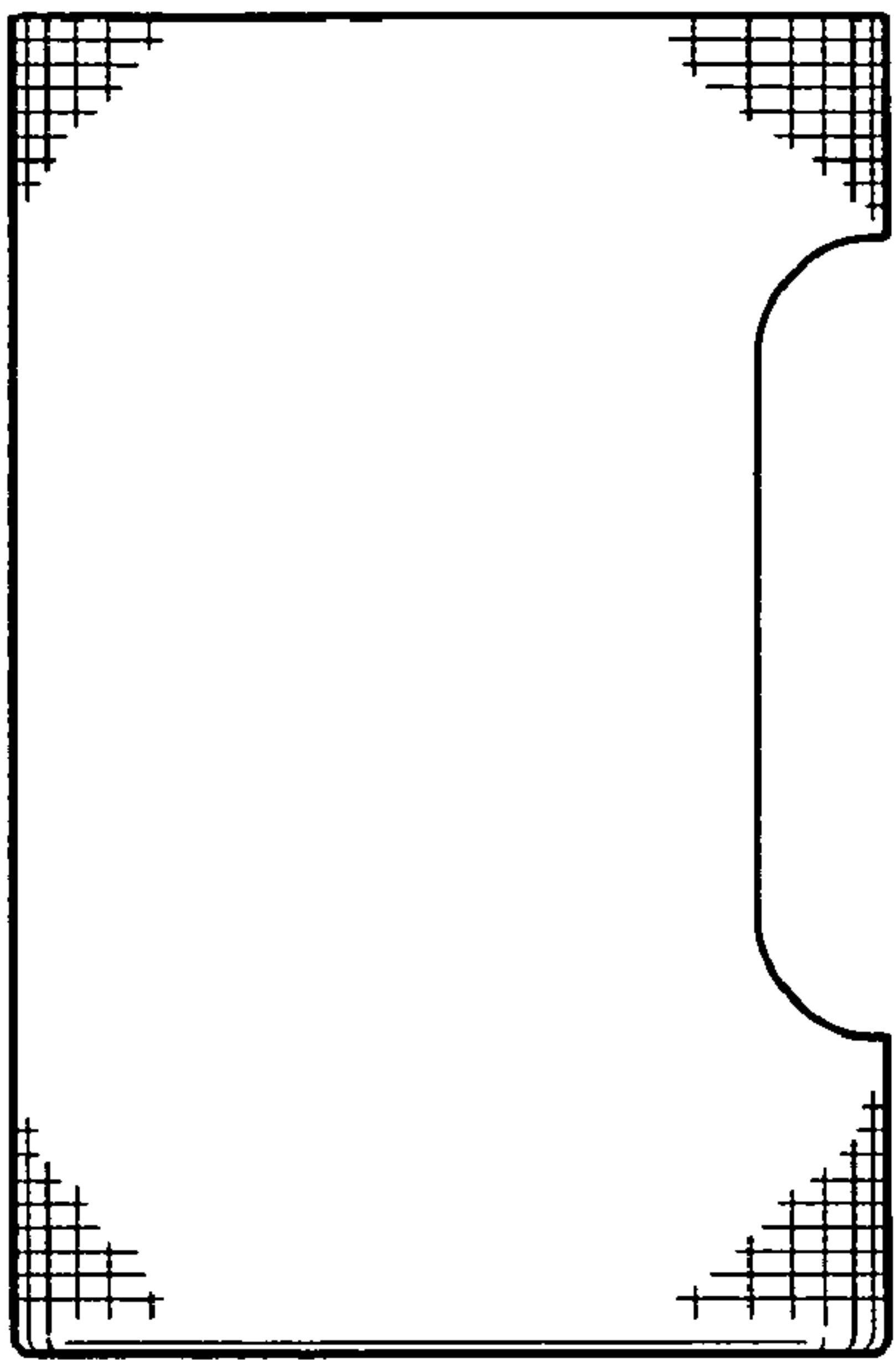

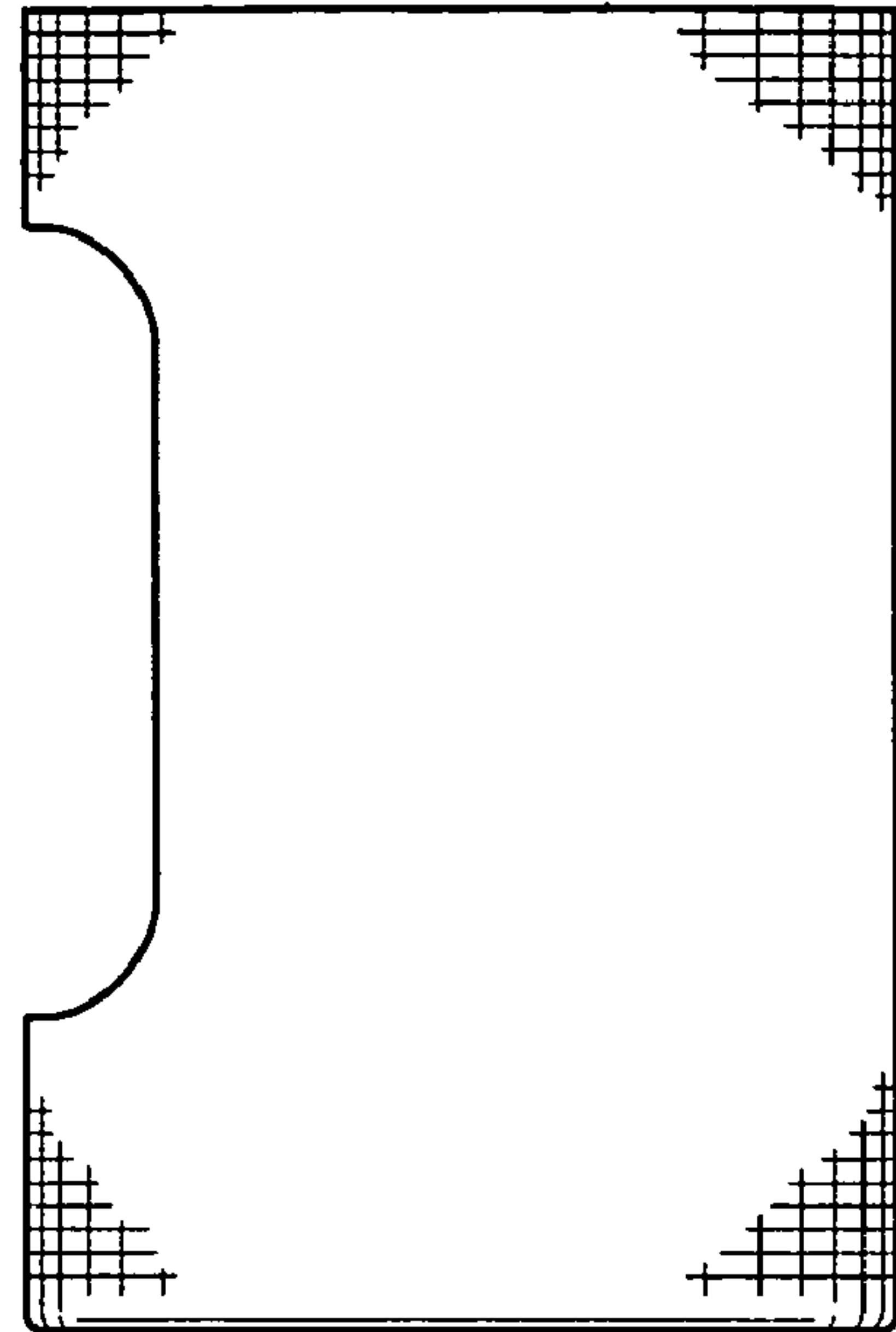

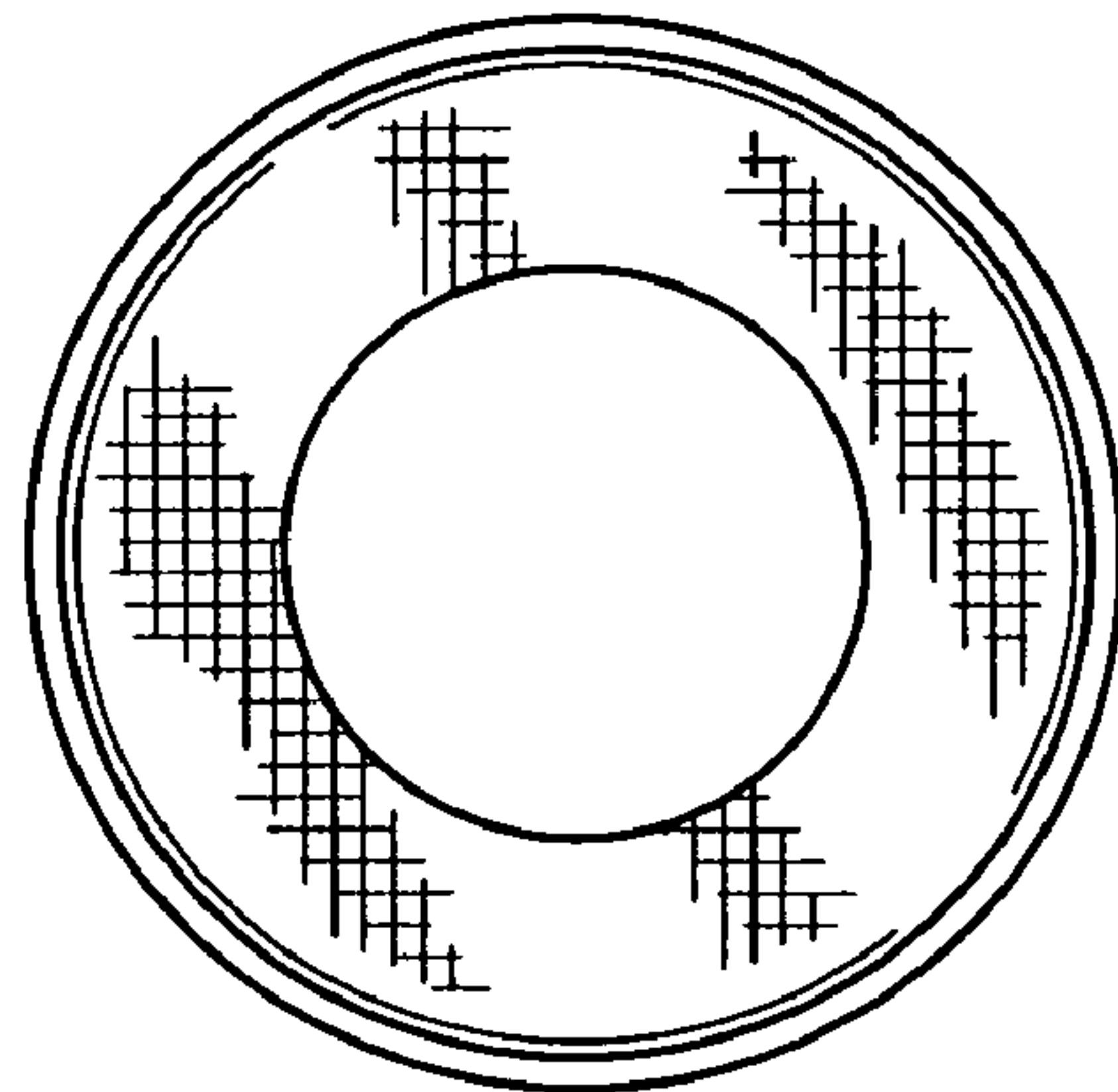

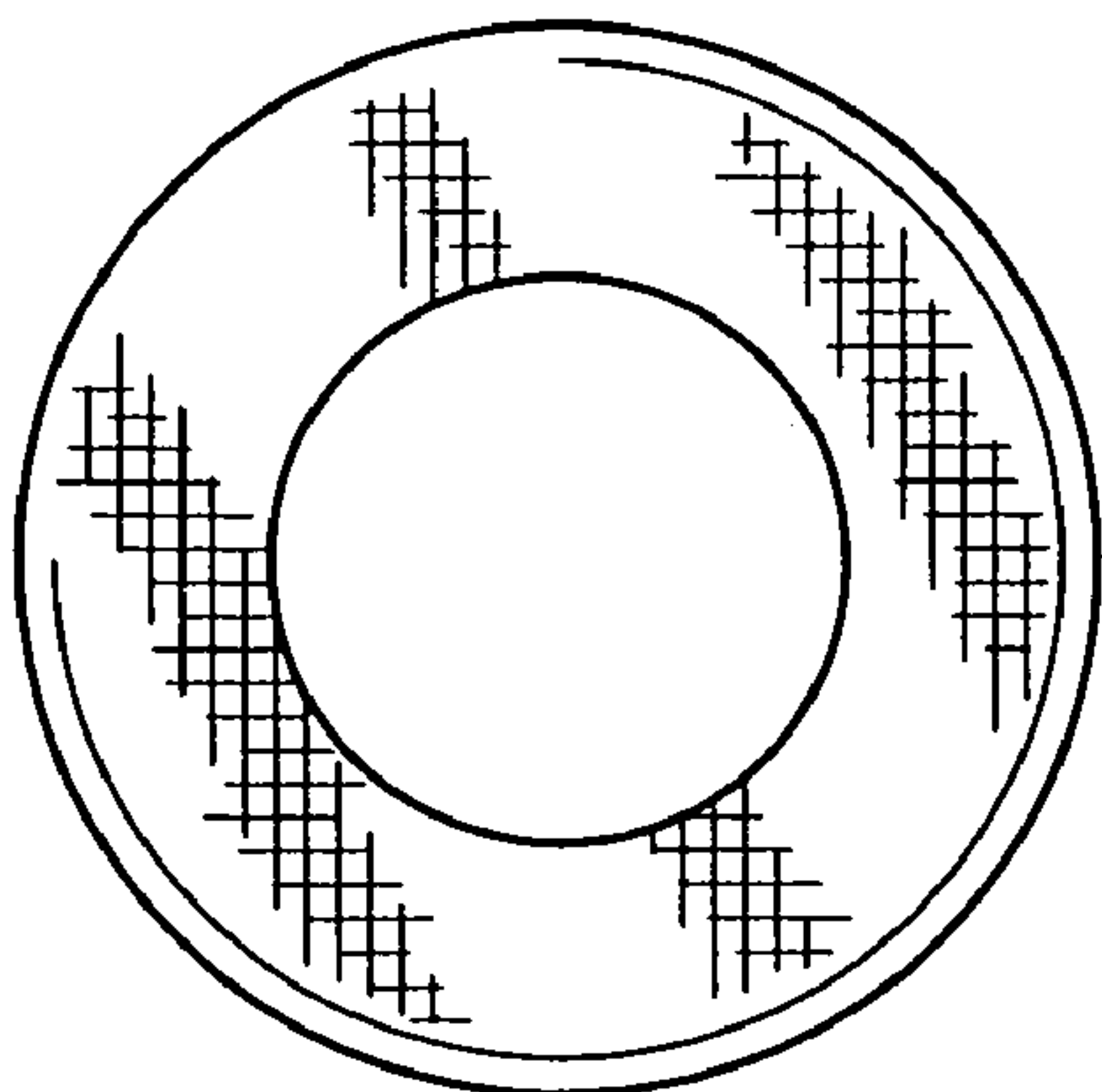
