The ornamental design for a door chime, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the door chime showing our new design;

FIG. 2 front elevational view thereof;

FIG. 3 is a bottom plan view thereof, the top plan view being a mirror image thereof;

FIG. 4 is a rear elevational view thereof; and,

FIG. 5 is a right side elevational view thereof, the left side elevational view being a mirror image.

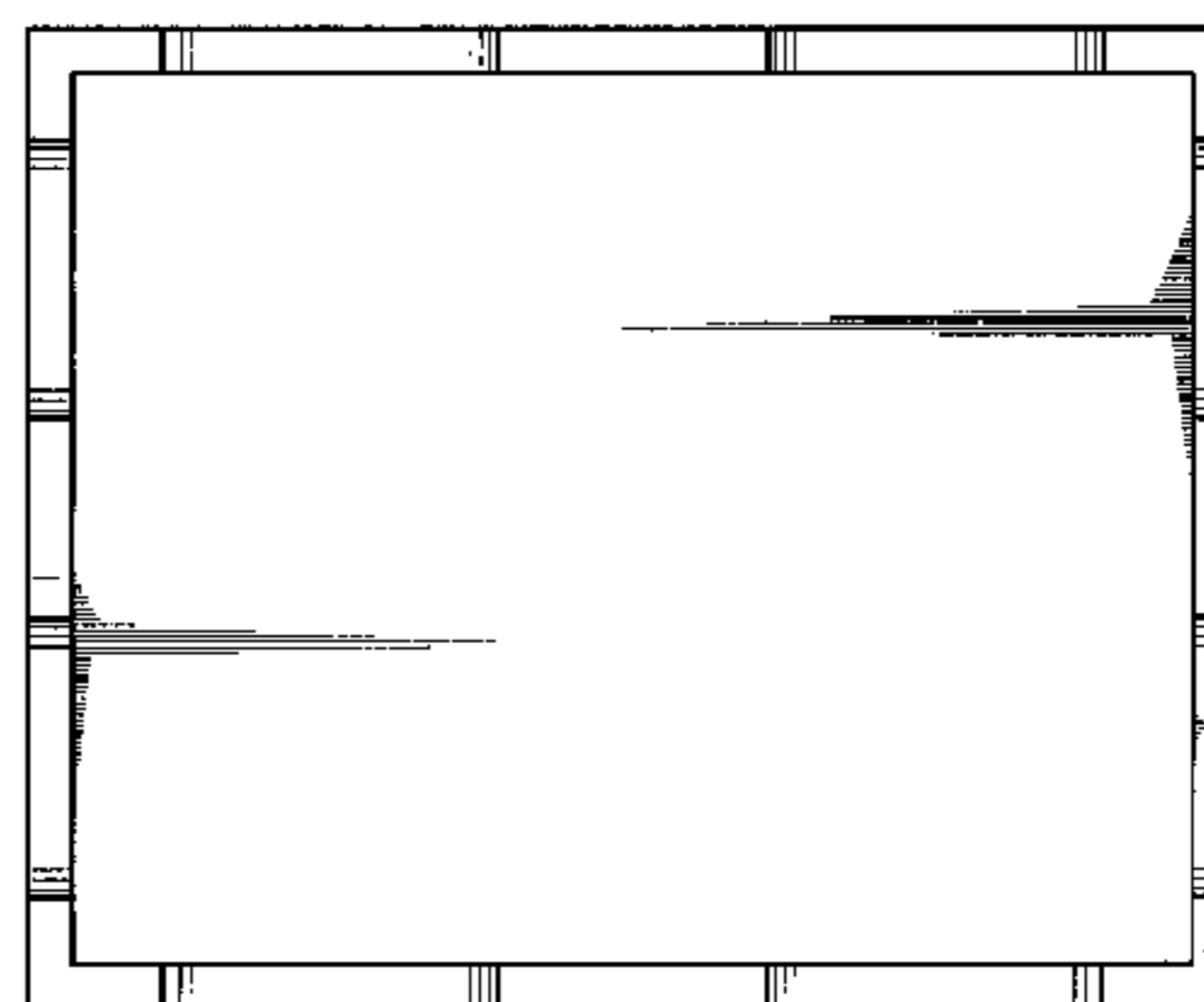
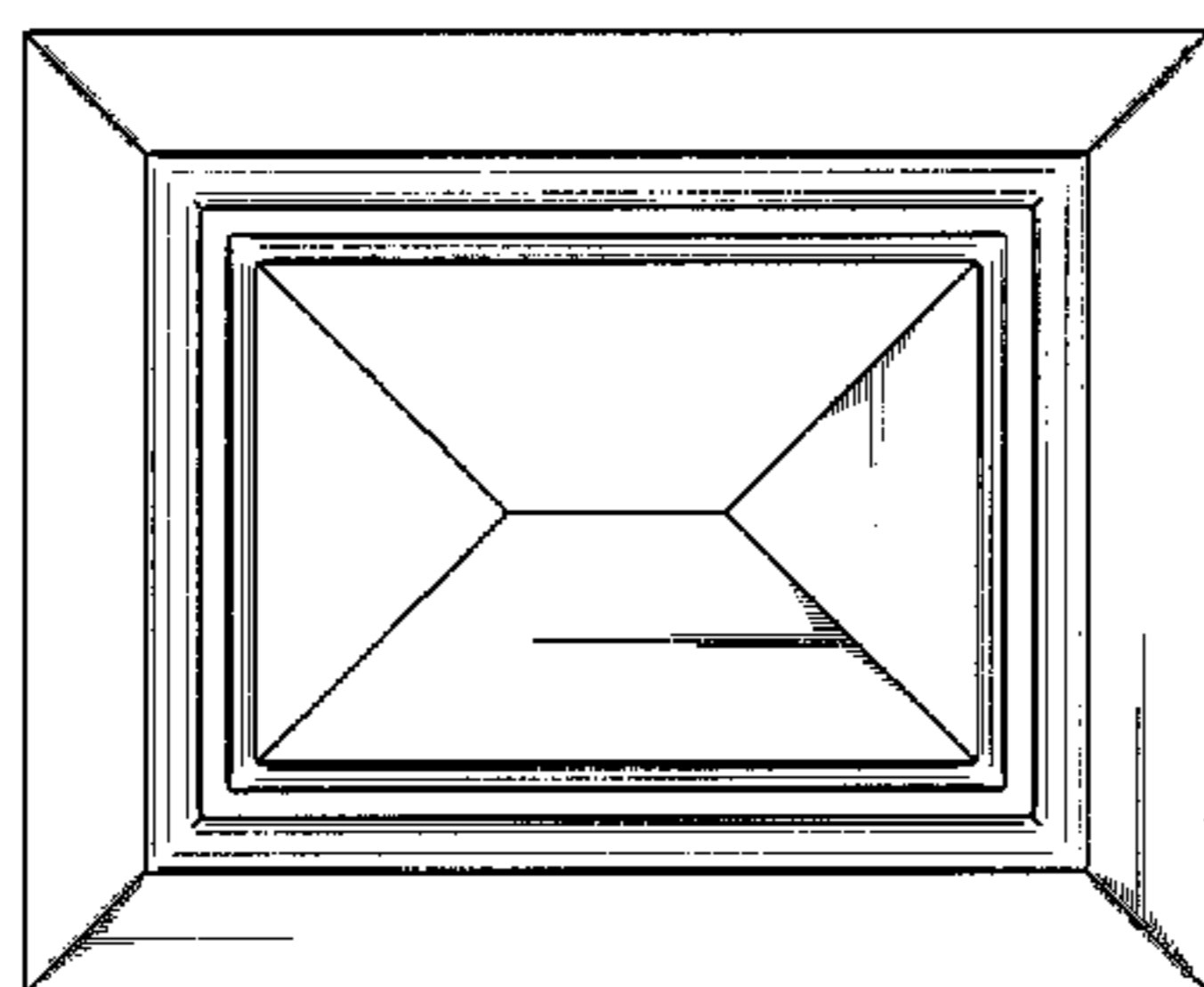
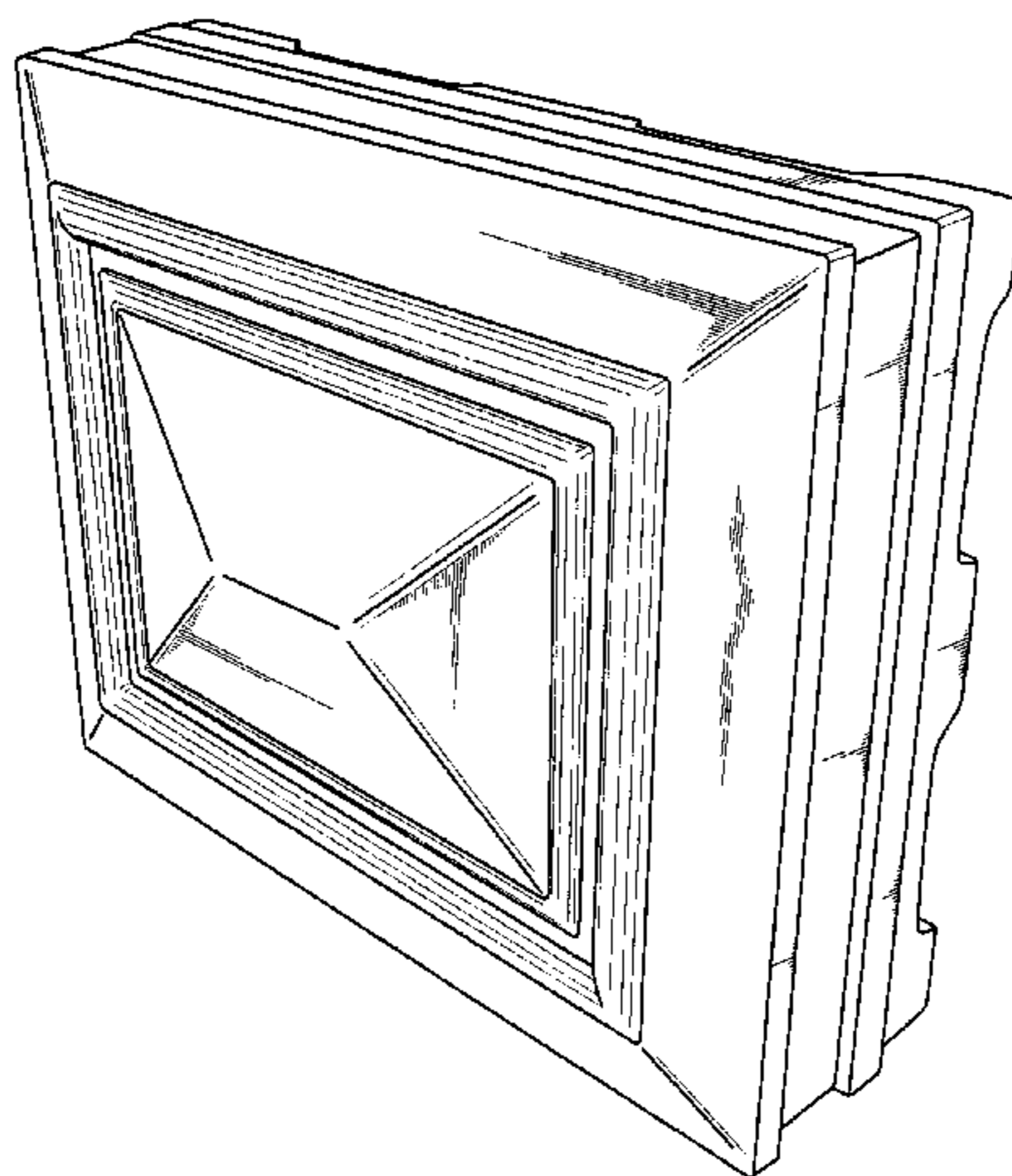

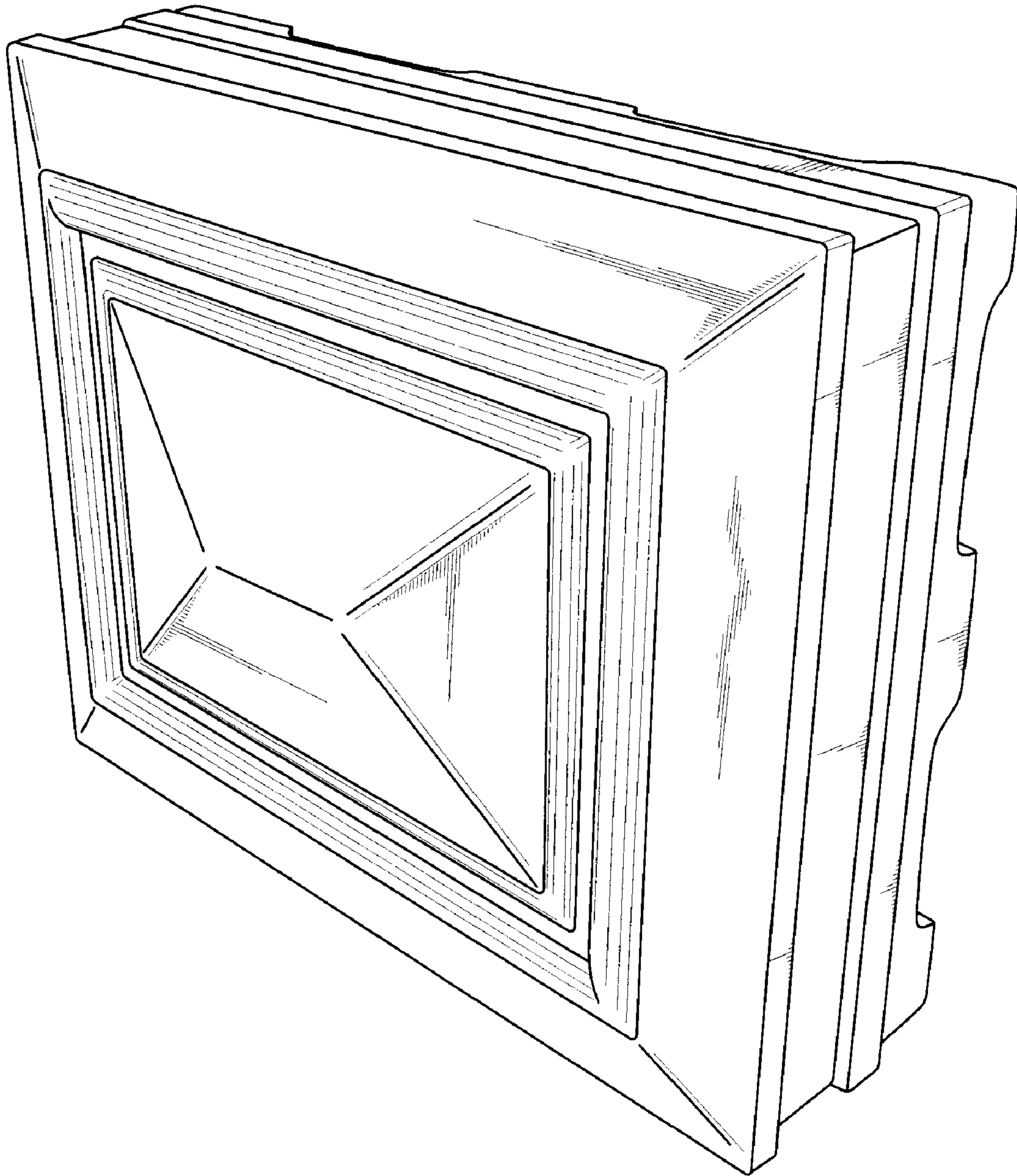

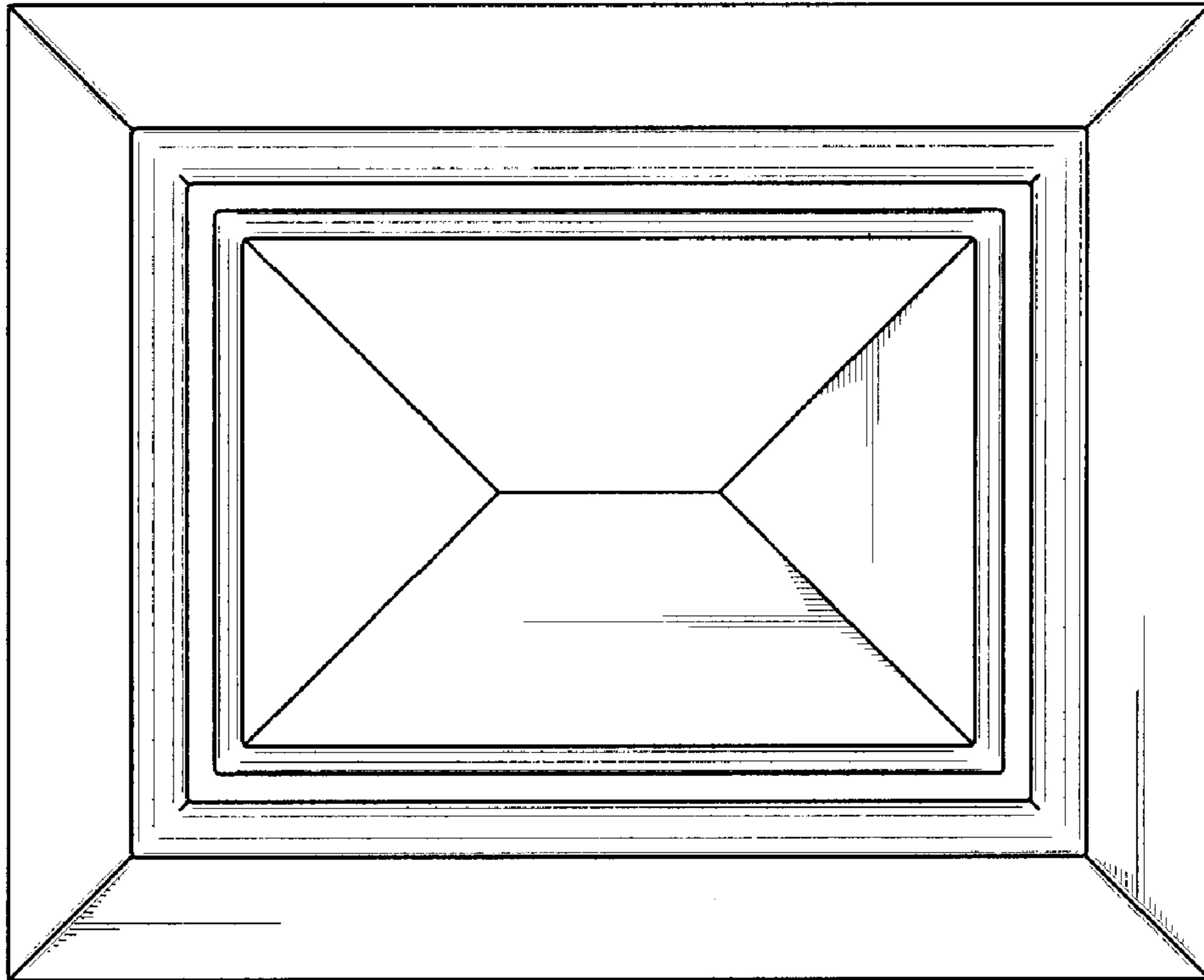

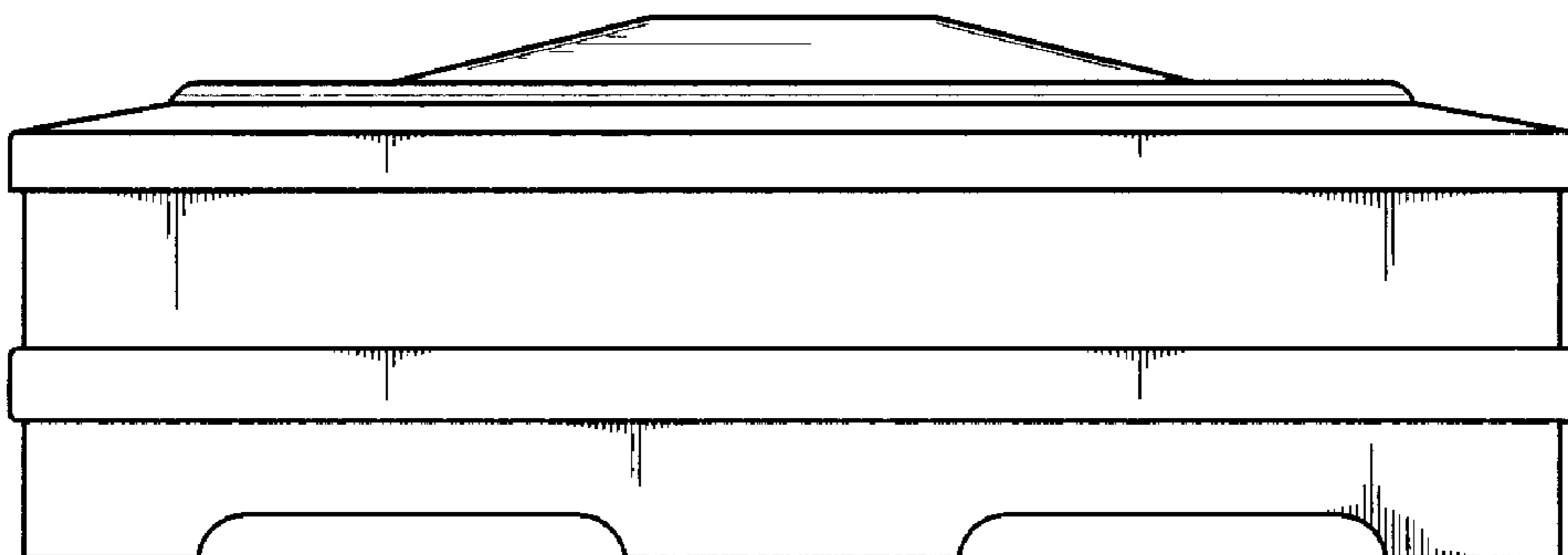

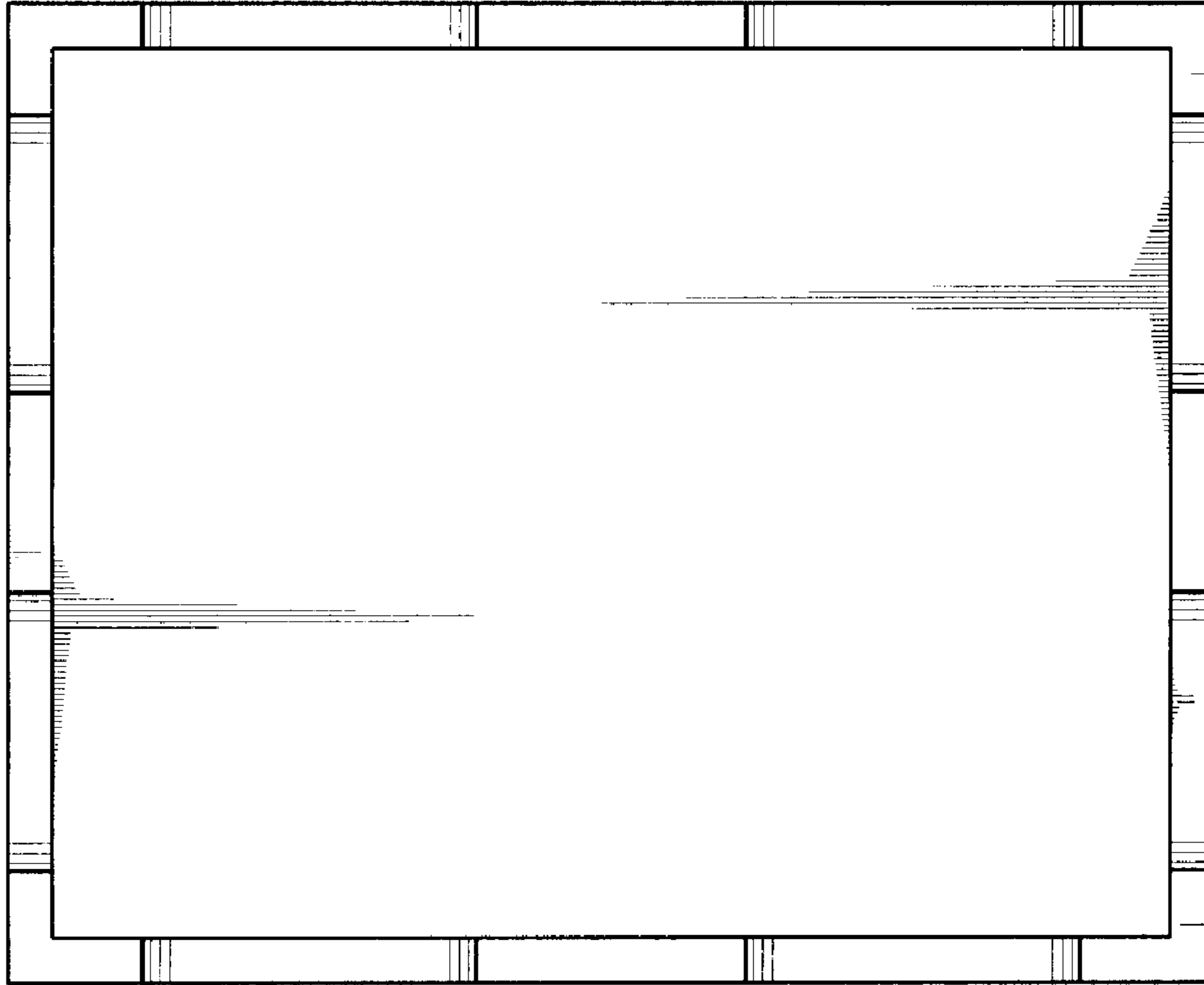
