FIG. 3 is a right side view of a condenser lens for a light emitting diode, showing my new design, the left side view being a mirror image;

FIG. 4 is a top plan view of a condenser lens for a light emitting diode, showing my new design, the bottom plan view being a mirror image;

FIG. 5 is a cross sectional view, taken along a center line 5—5 of FIG. 1, of a condenser lens for a light emitting diode, showing my new design;

FIG. 6 is a front perspective view of a condenser lens for a light emitting diode, showing my new design;

FIG. 7 is a rear perspective view of a condenser lens for a light emitting diode, showing my new design; and,

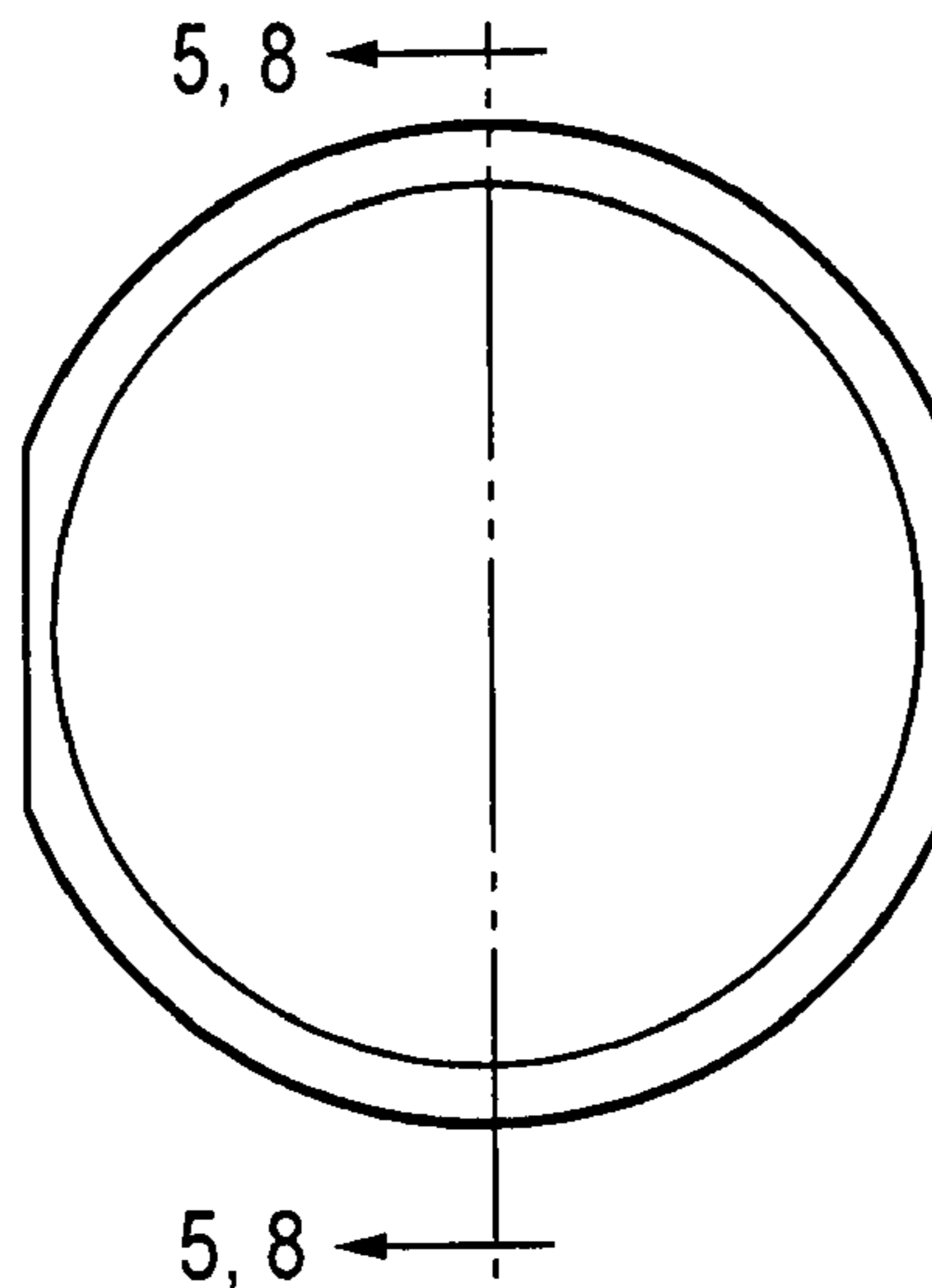

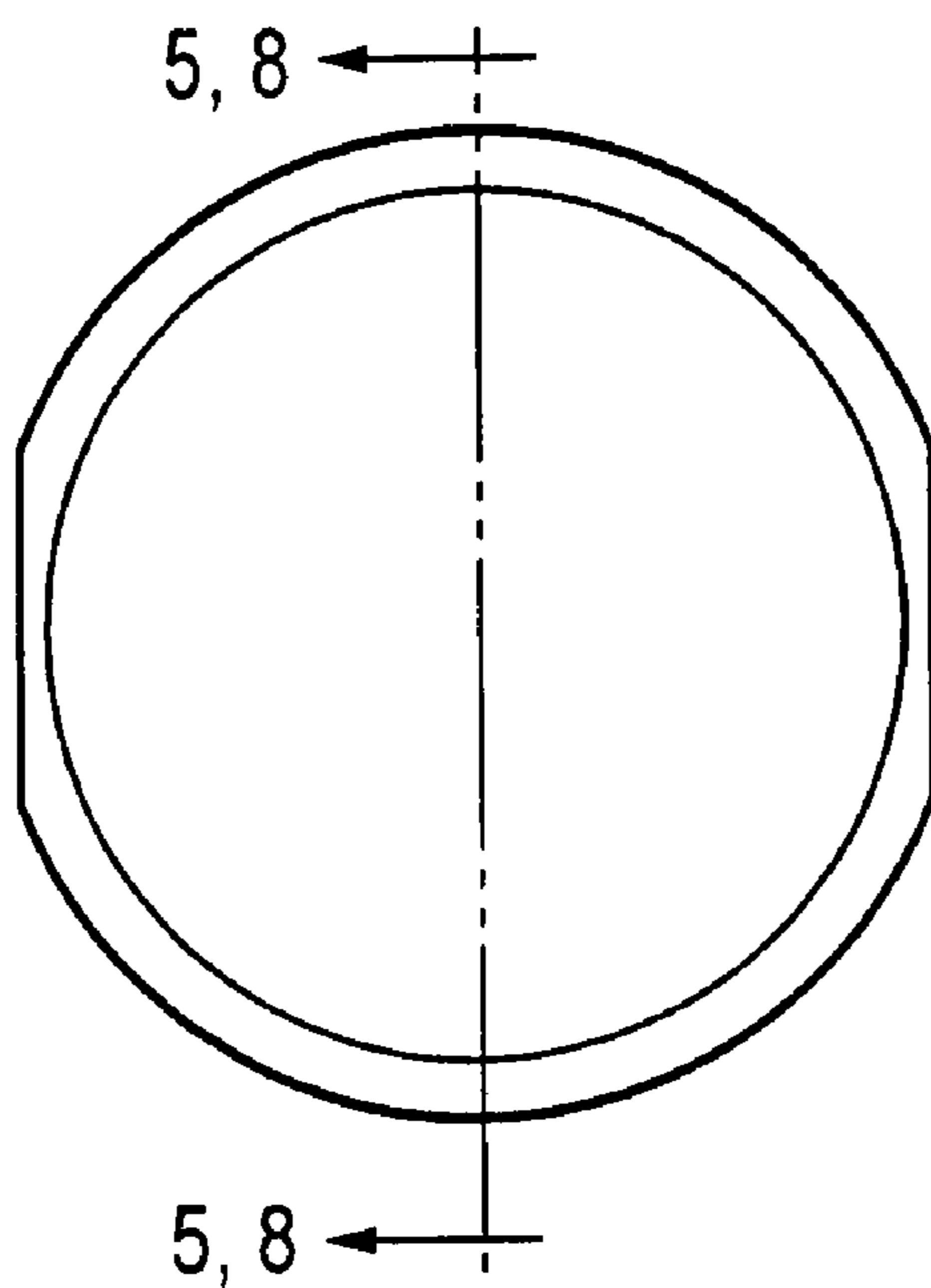

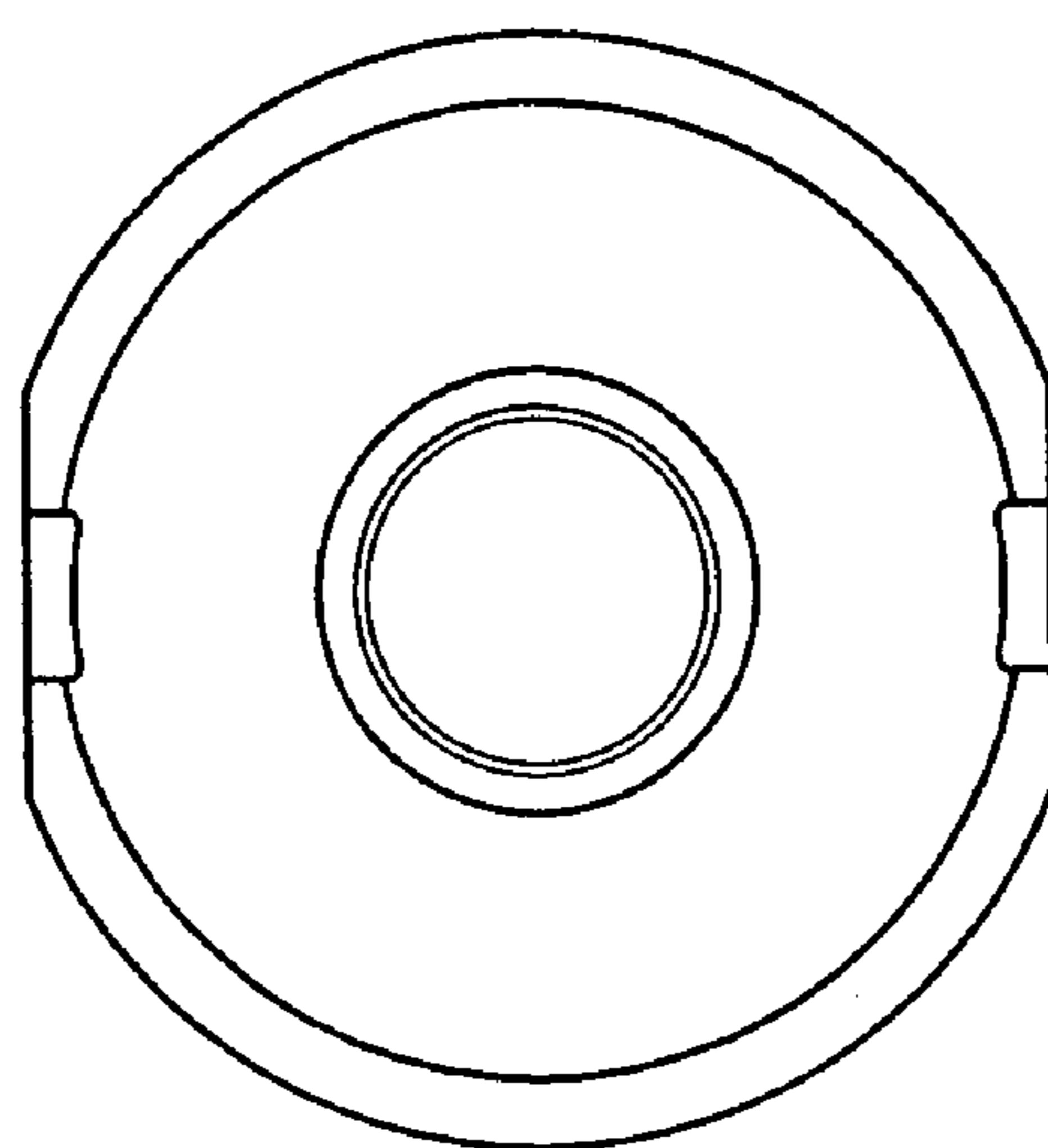

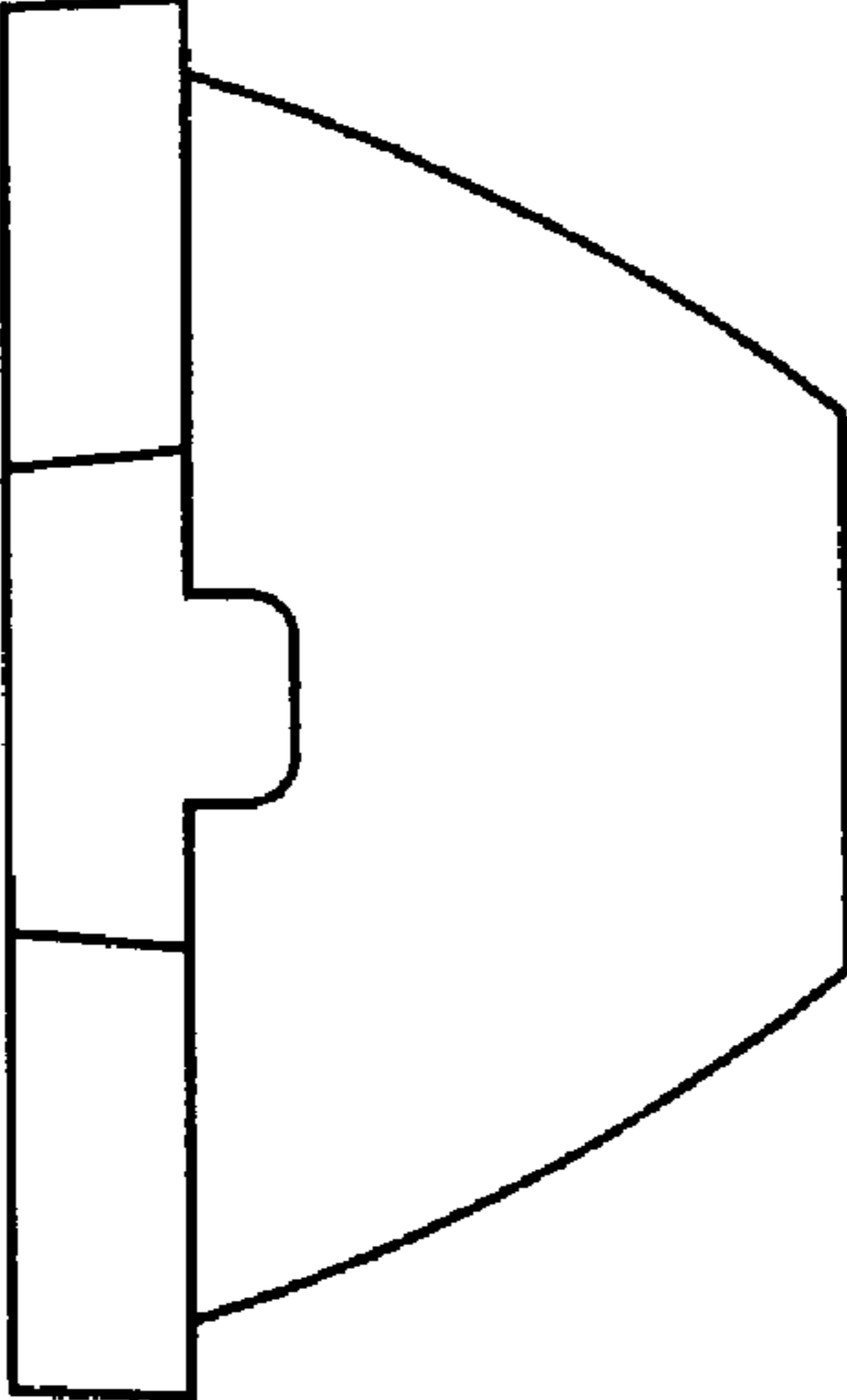

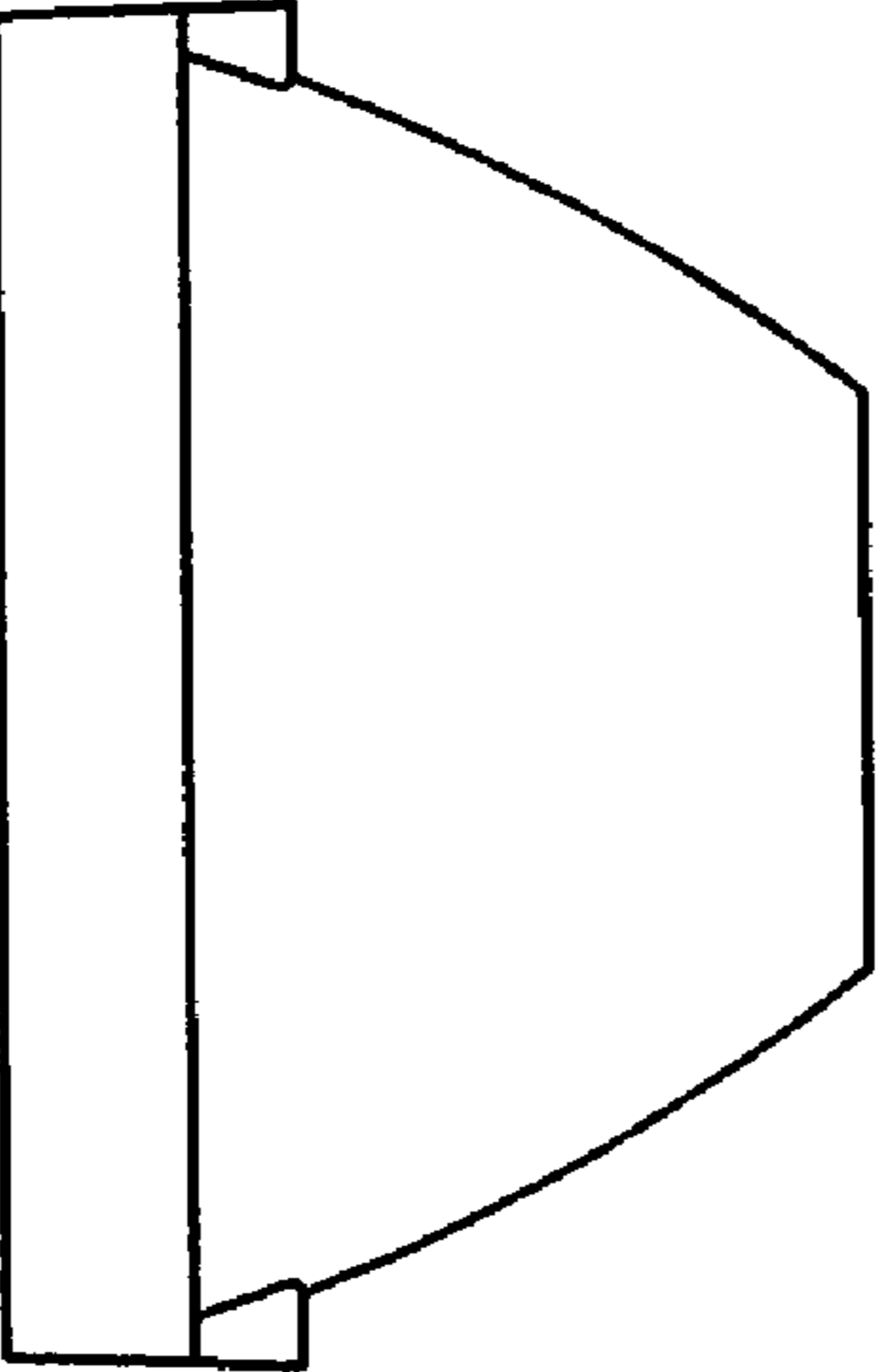

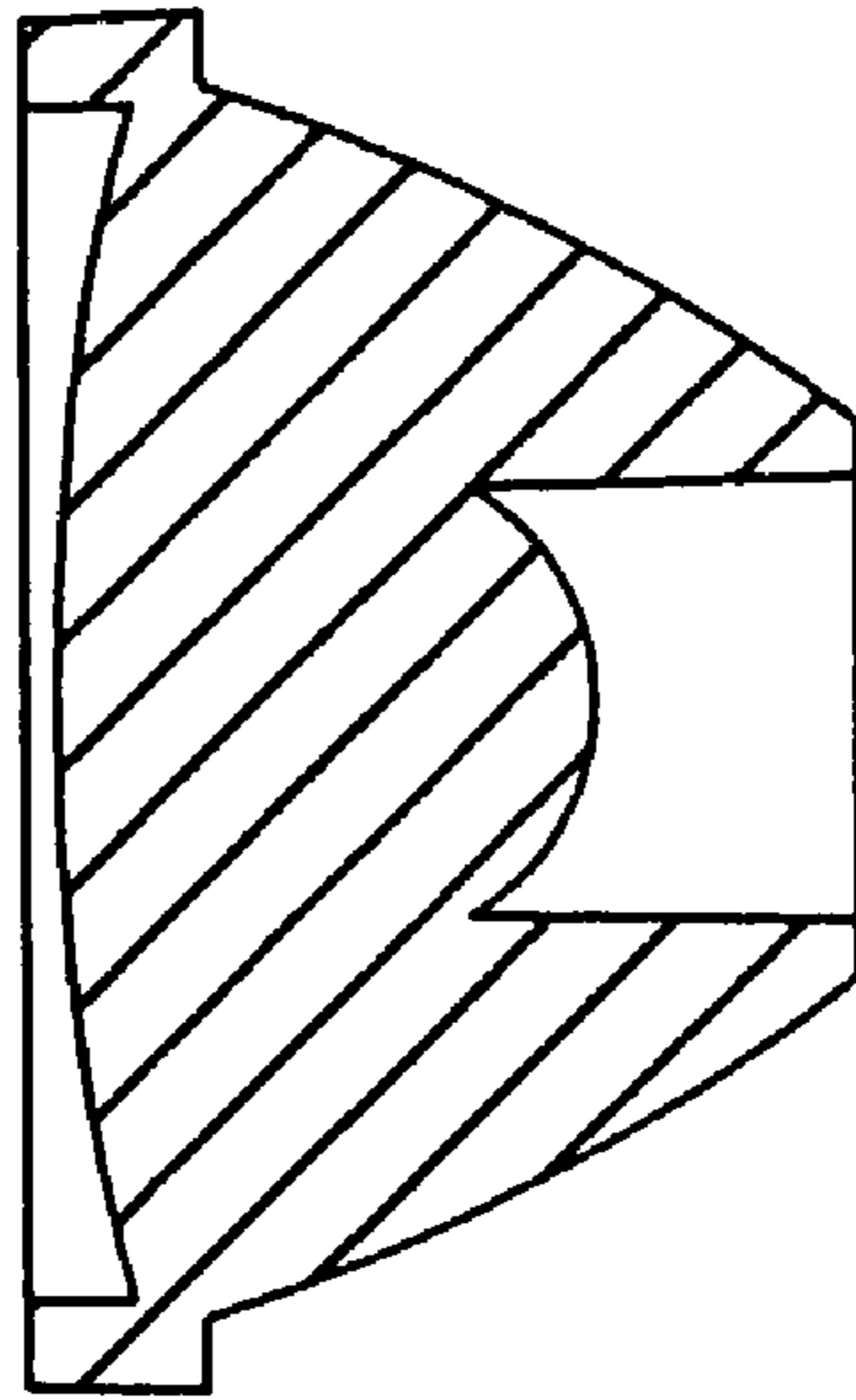

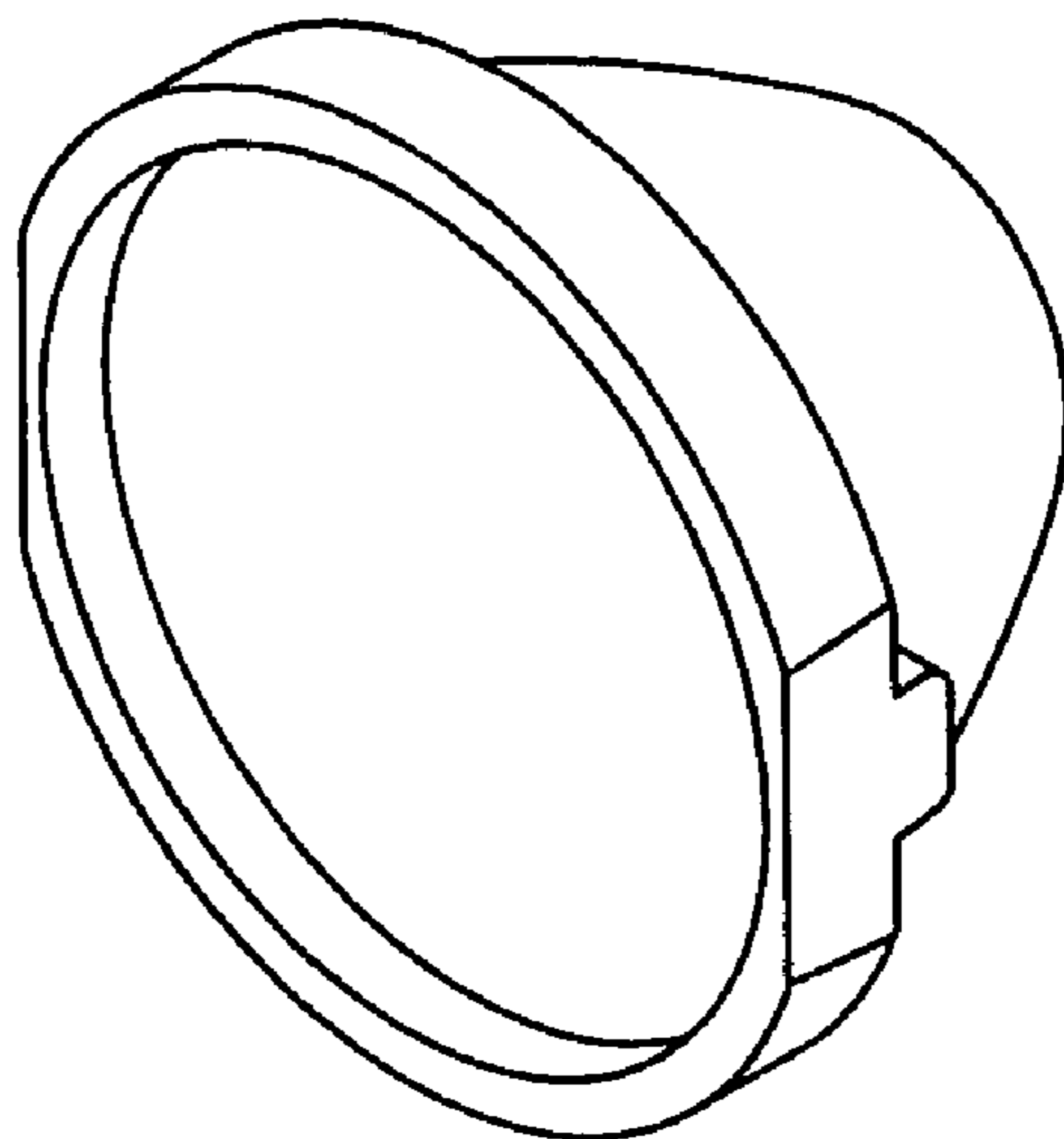

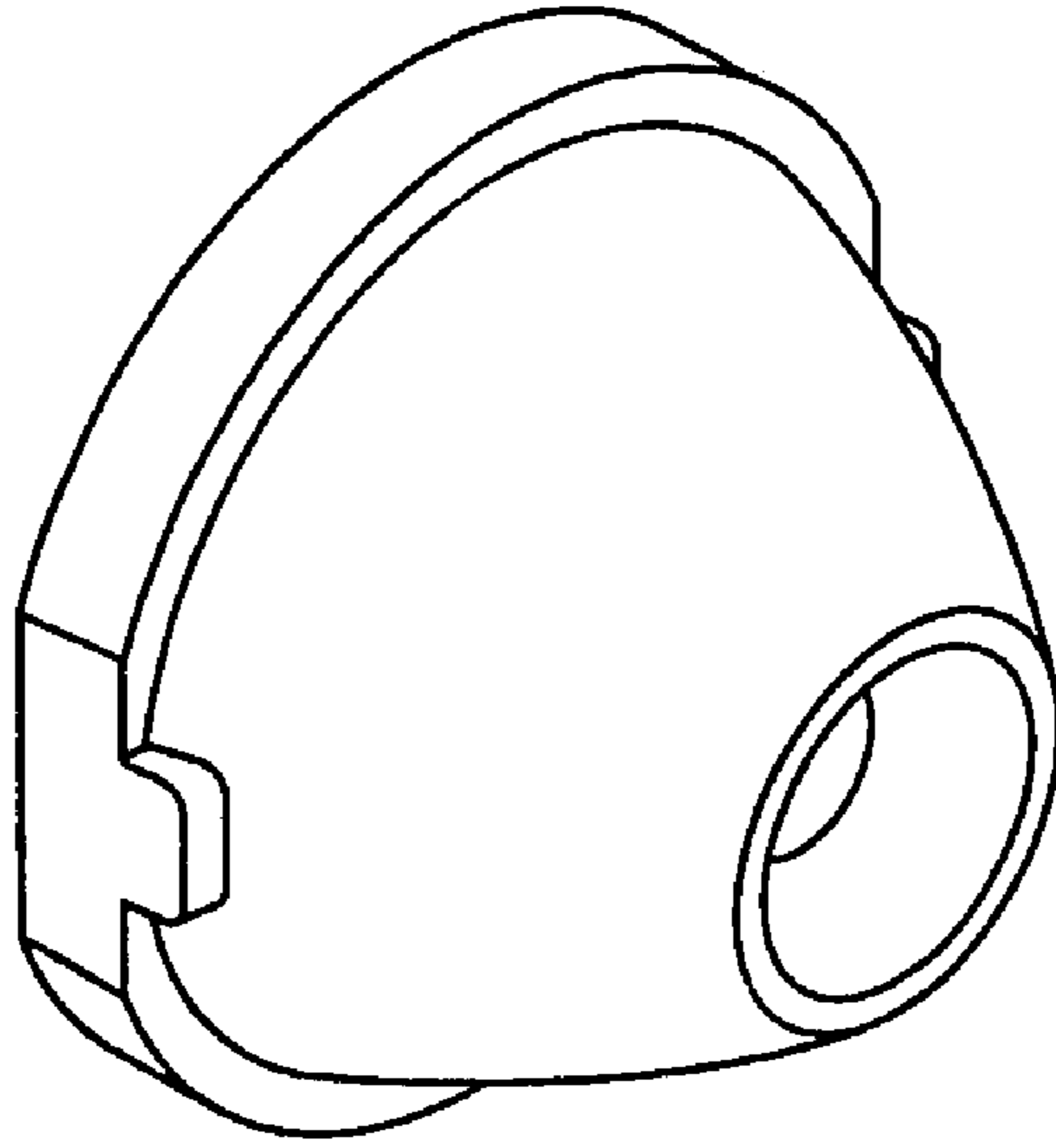

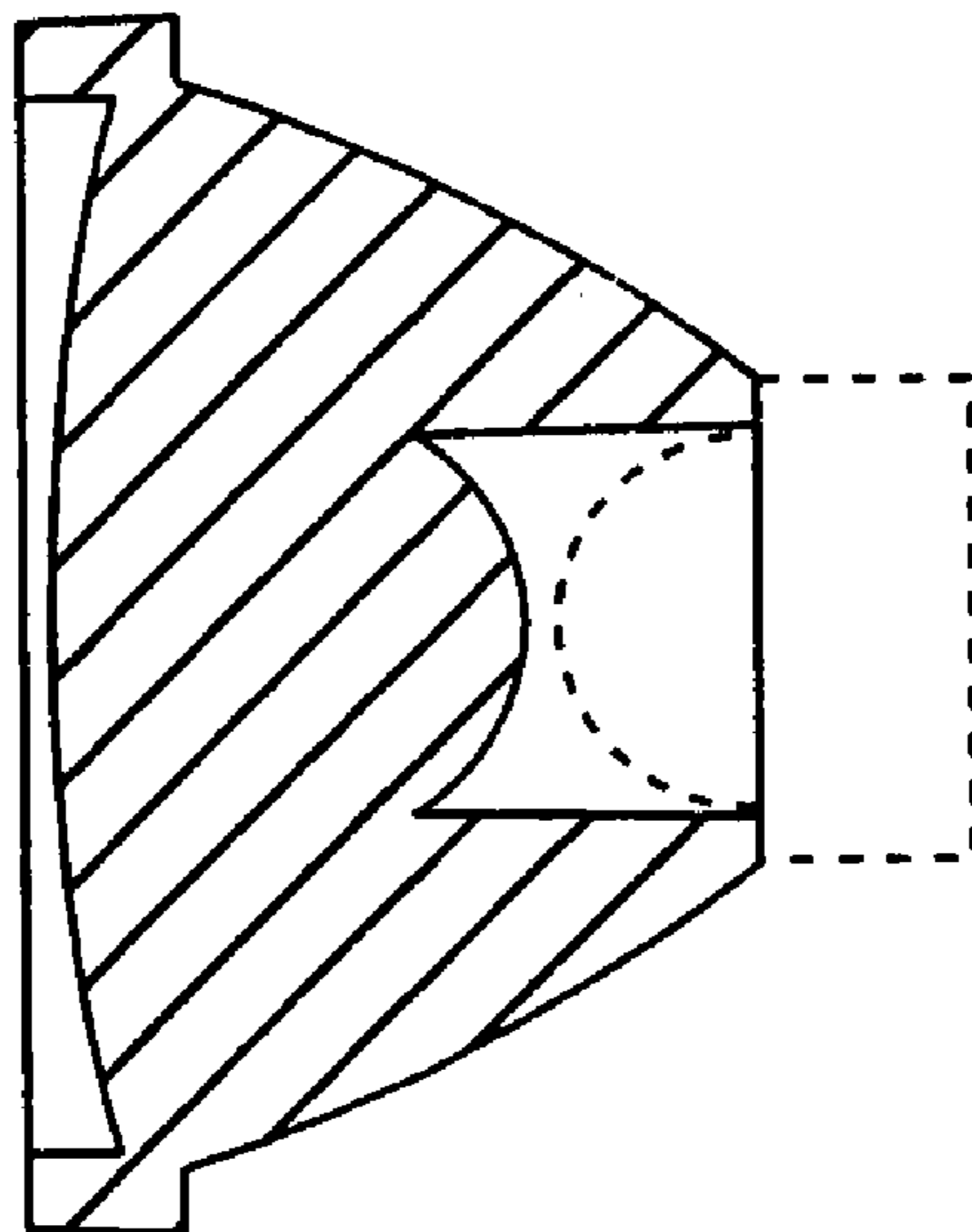
