FIG. 13 is a right side open view thereof.

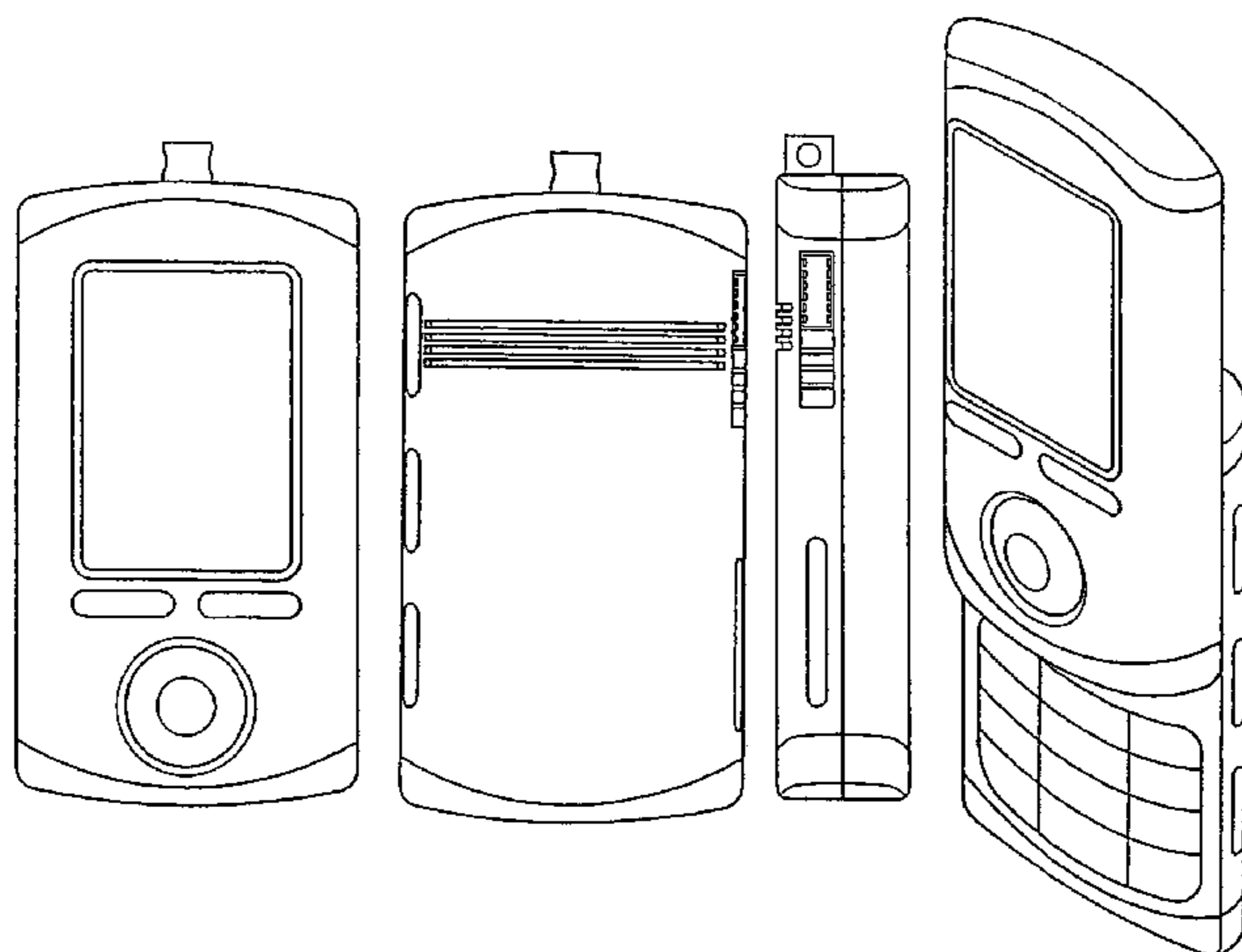

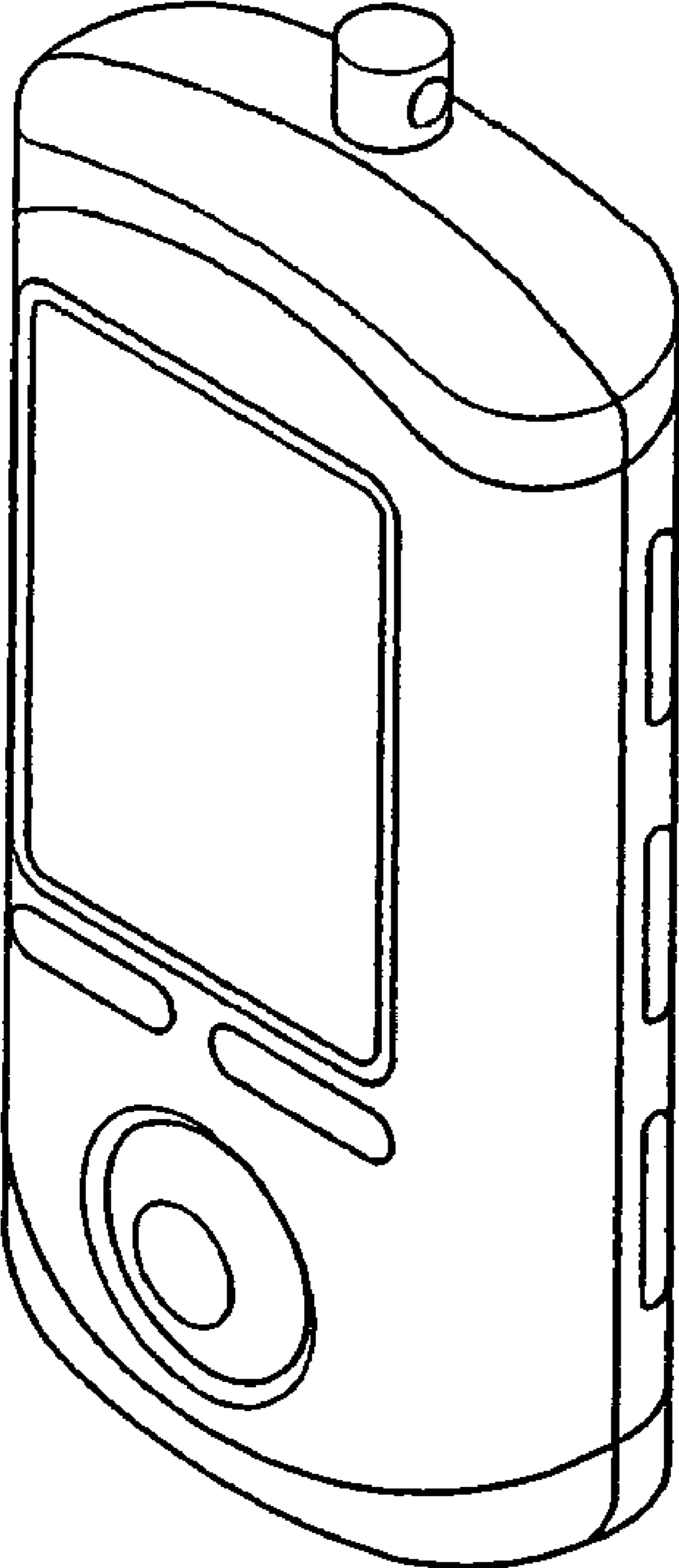

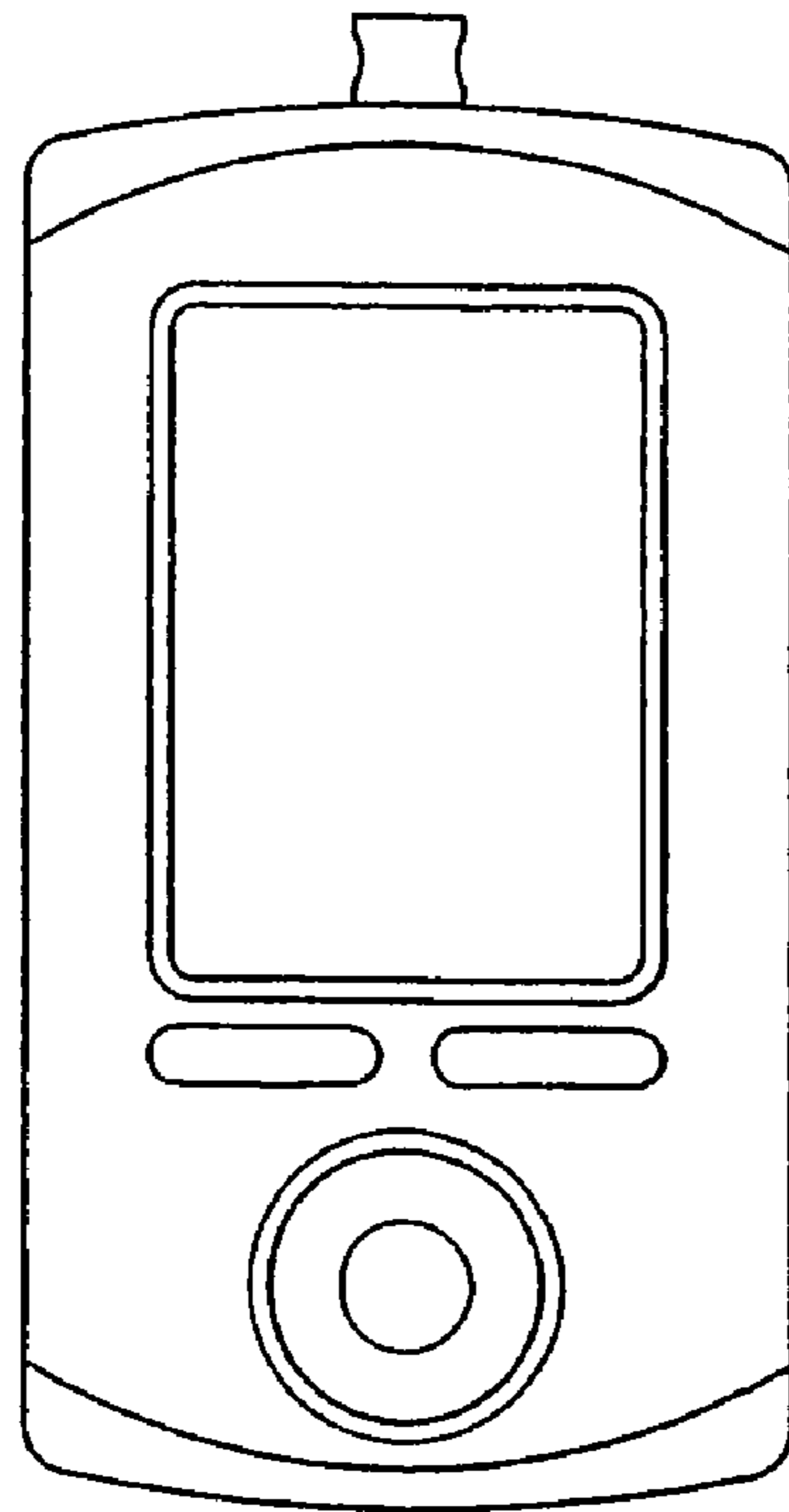

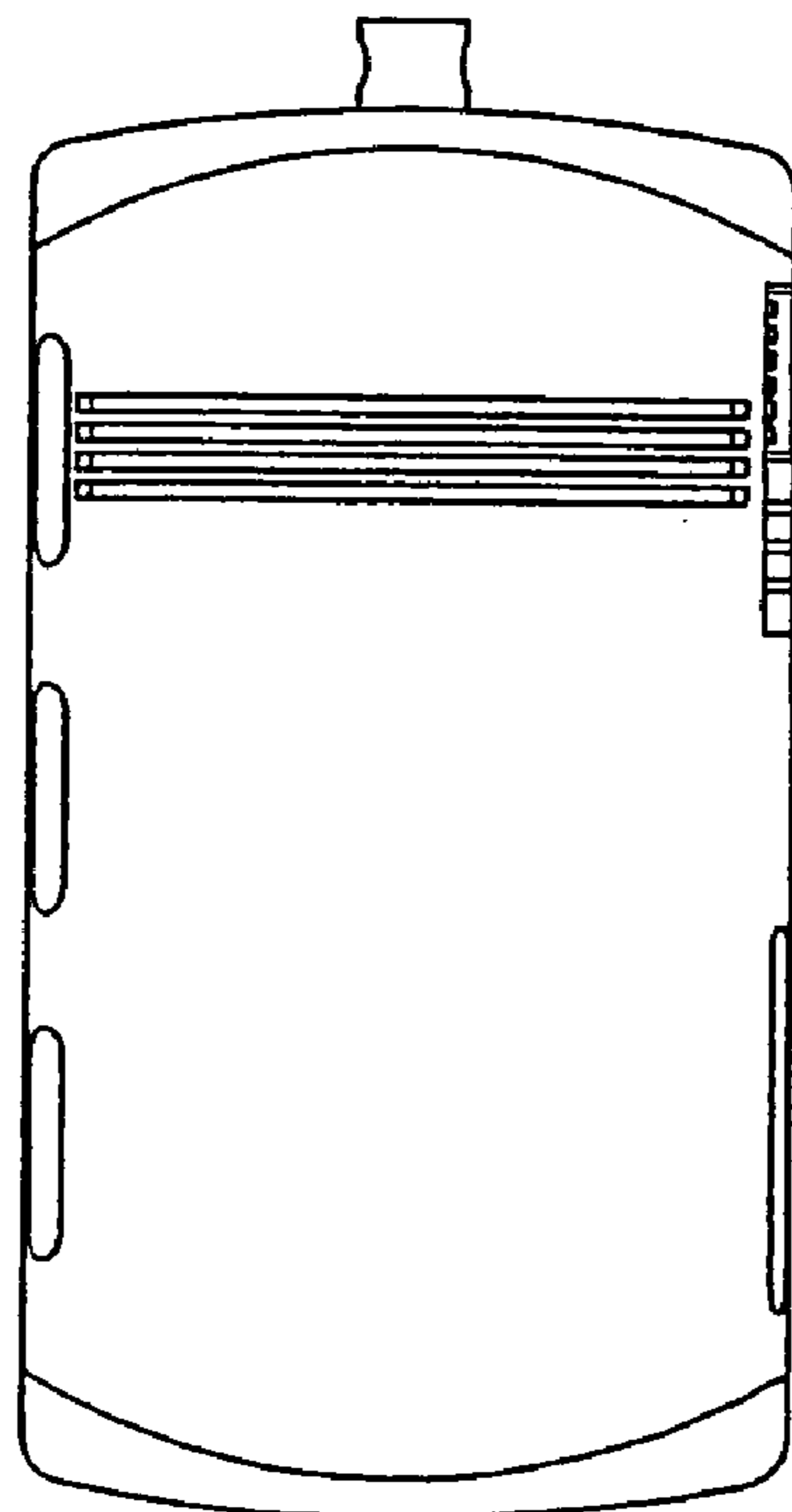

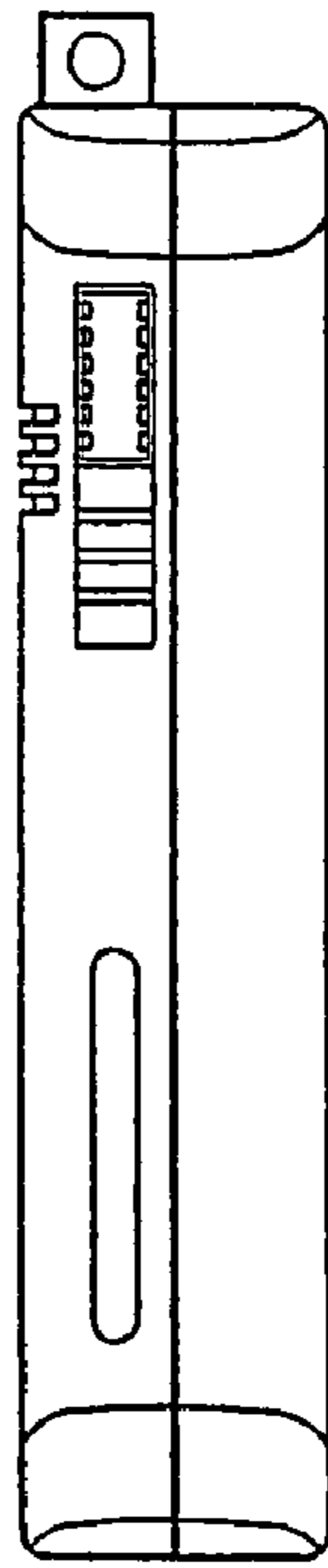

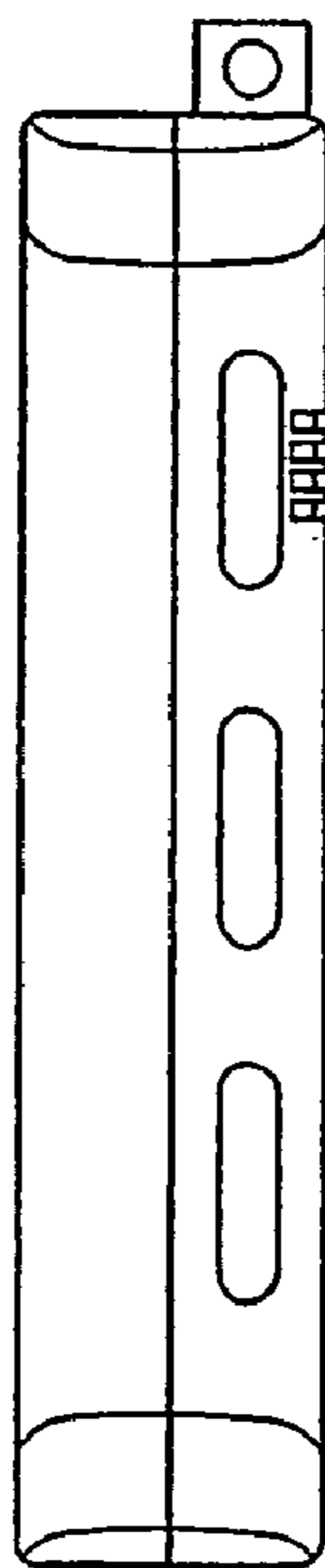

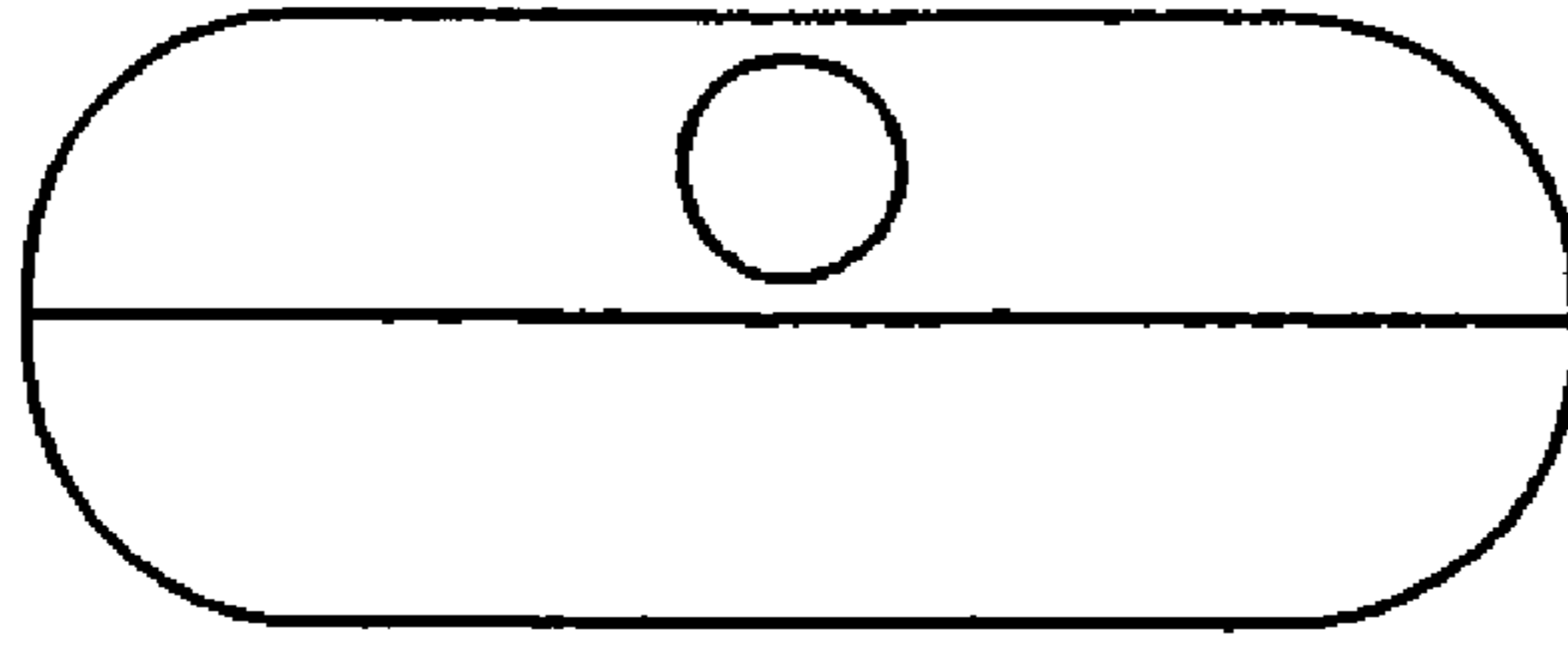

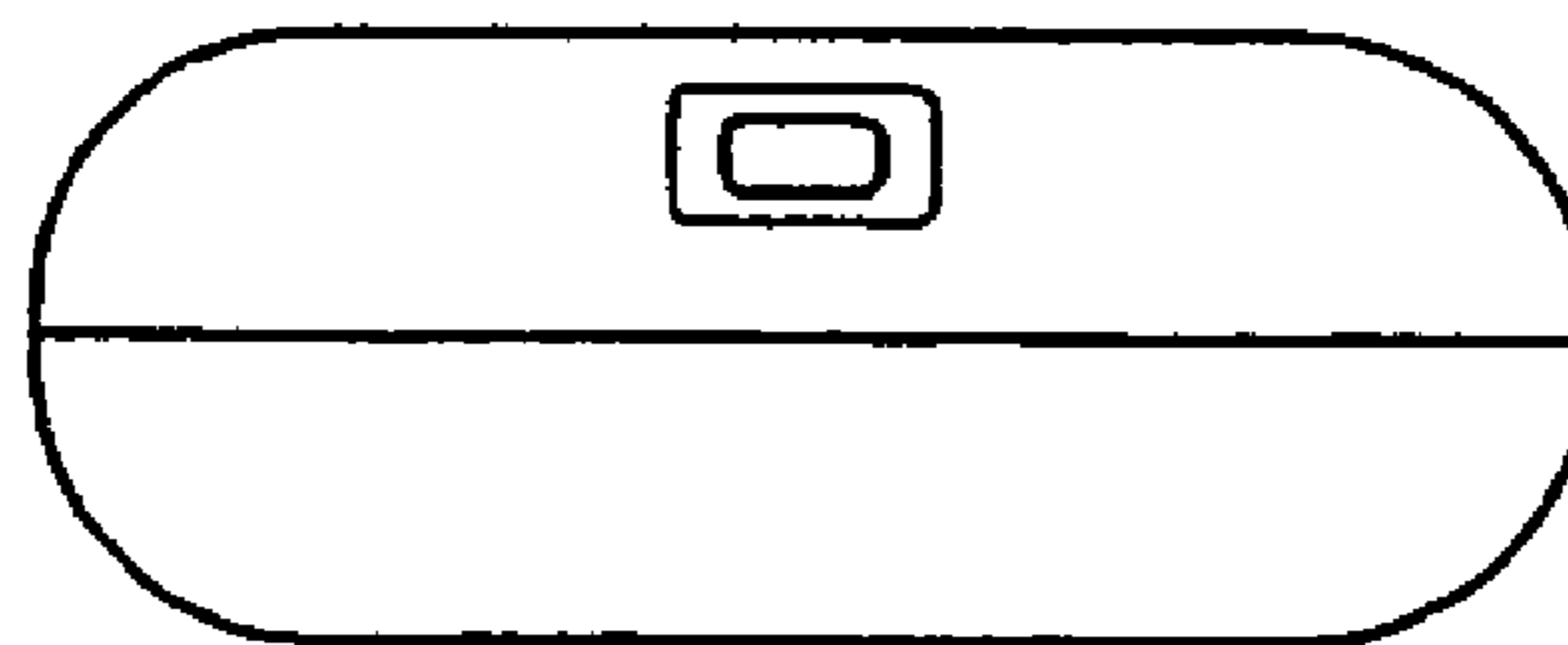

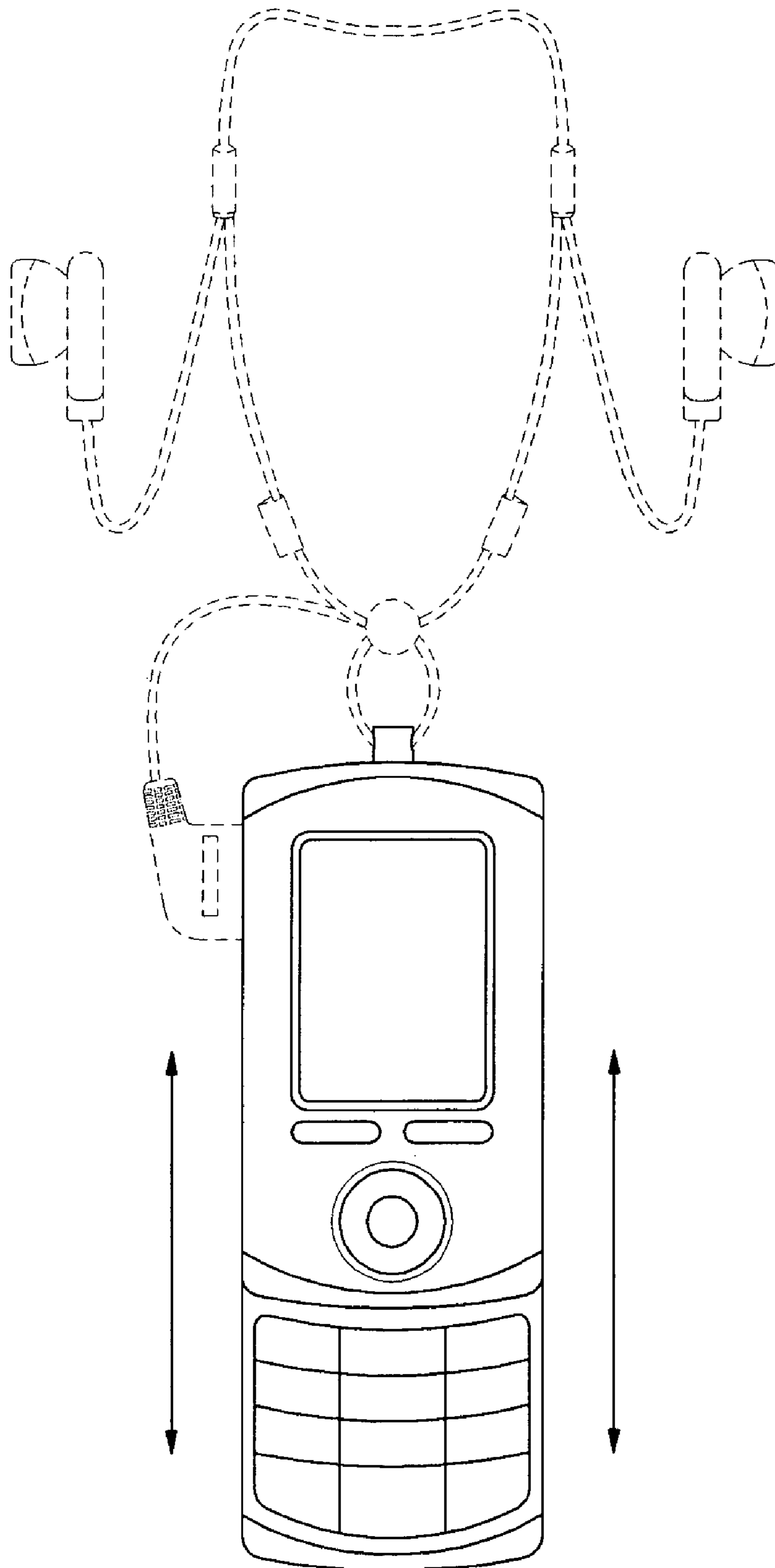

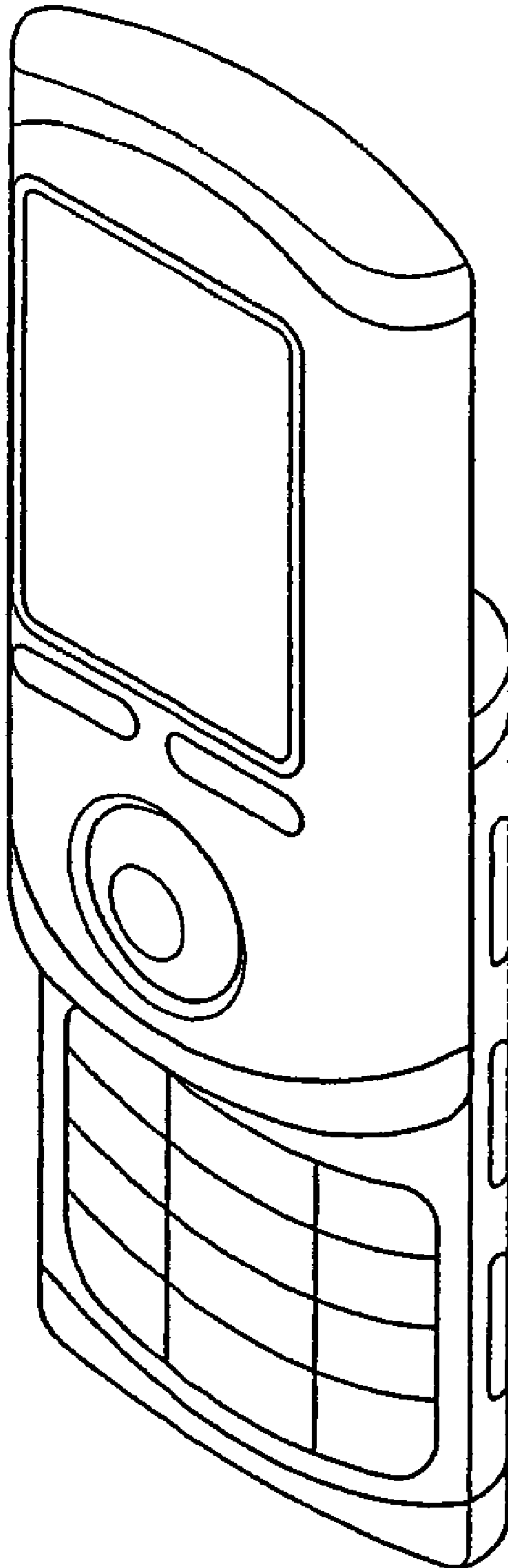

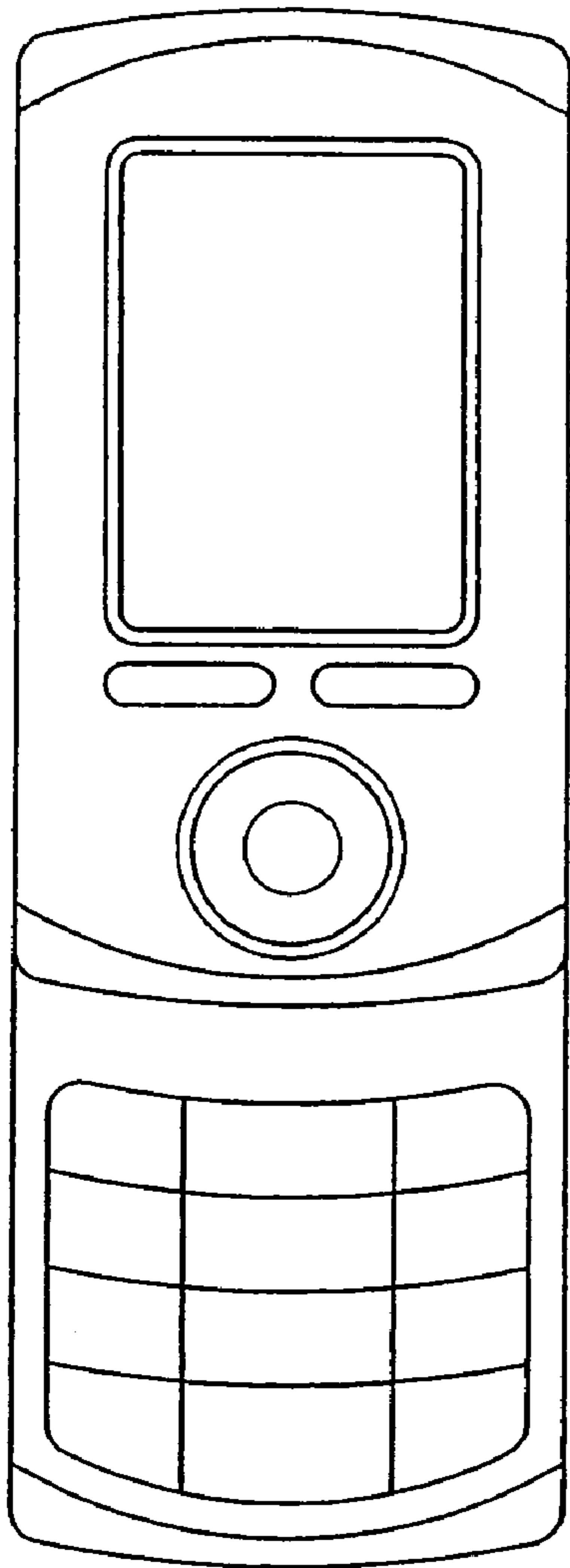

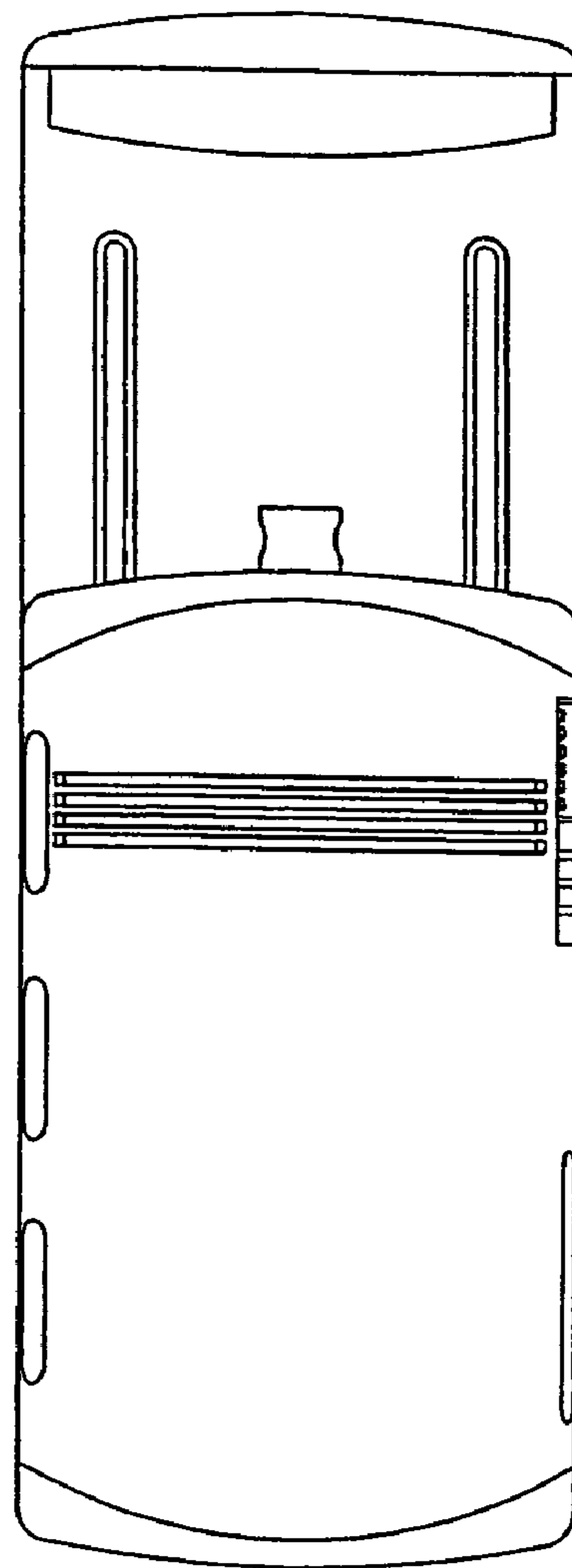

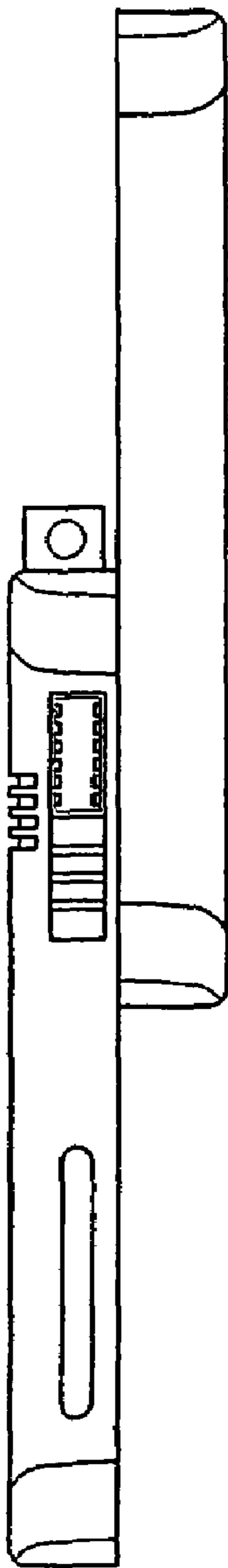
