(57) **CLAIM**

The ornamental design for portable speakers, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of portable speakers in accordance with the present design, in an open configuration;

FIG. 2 is a front view of the portable speakers as shown in FIG. 1;

FIG. 3 is a rear view of the portable speakers as shown in FIG. 1;

FIG. 4 is a top view of the portable speakers as shown in FIG. 1;

FIG. 5 is a bottom view of the portable speakers as shown in FIG. 1;

FIG. 6 is a top view of the portable speakers as shown in a closed configuration;

FIG. 7 is a bottom view of the portable speakers of FIG. 6;

FIG. 8 is a front view of the portable speakers as shown in FIG. 6;

FIG. 9 is a rear view of the portable speakers as shown in FIG. 6;

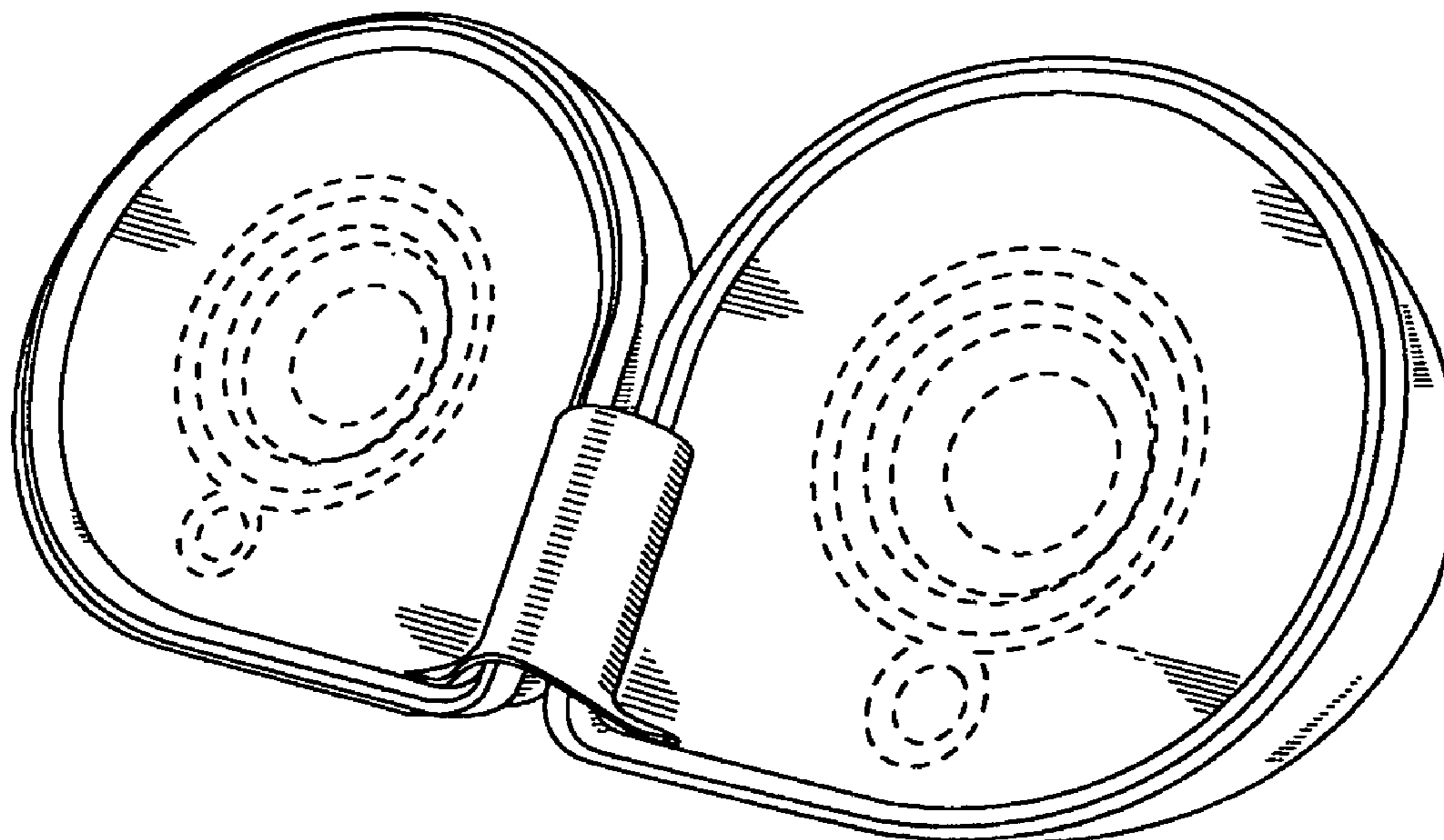
FIG. 10 is a right side of the portable speakers as shown in FIG. 6; and,

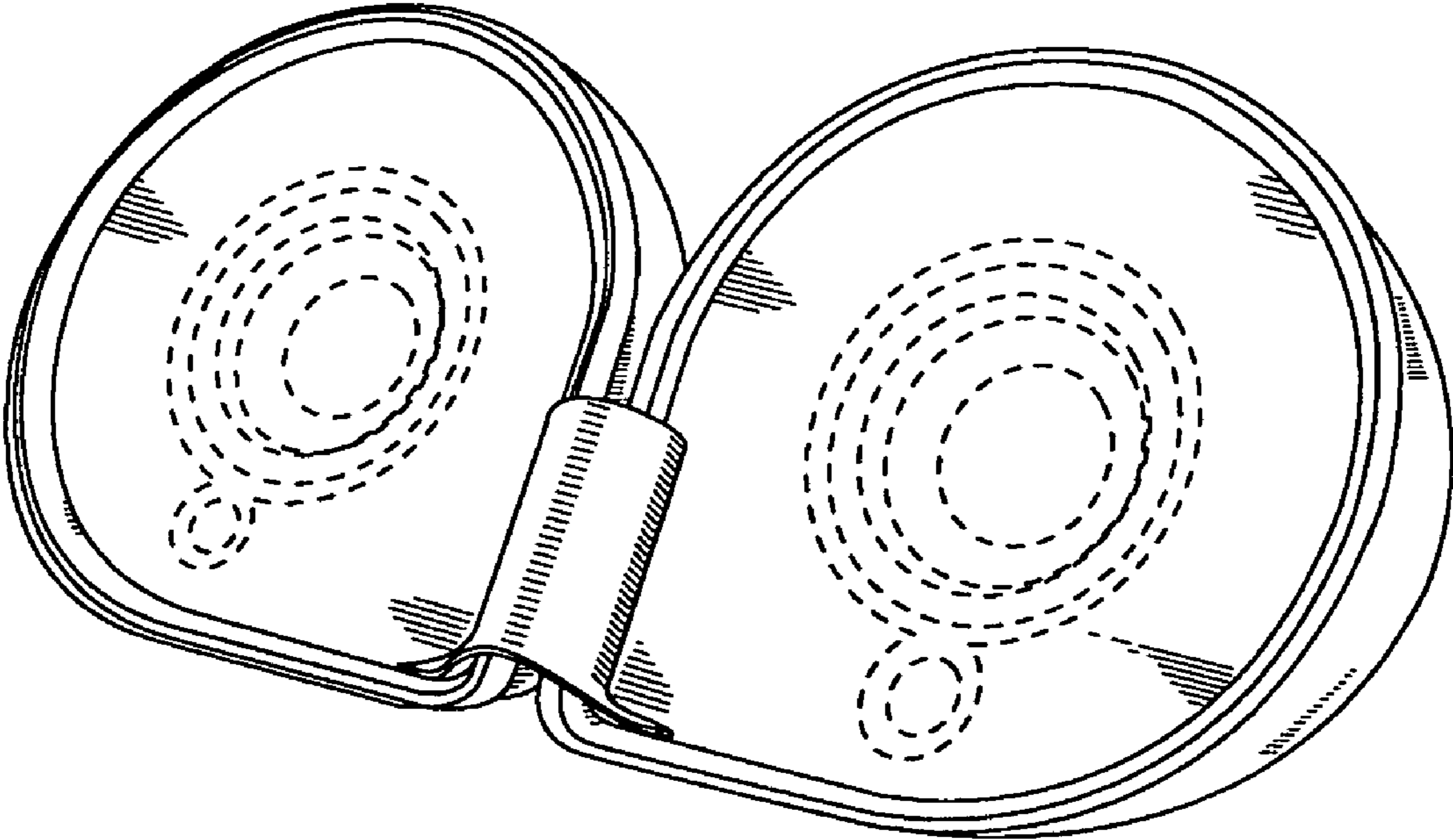

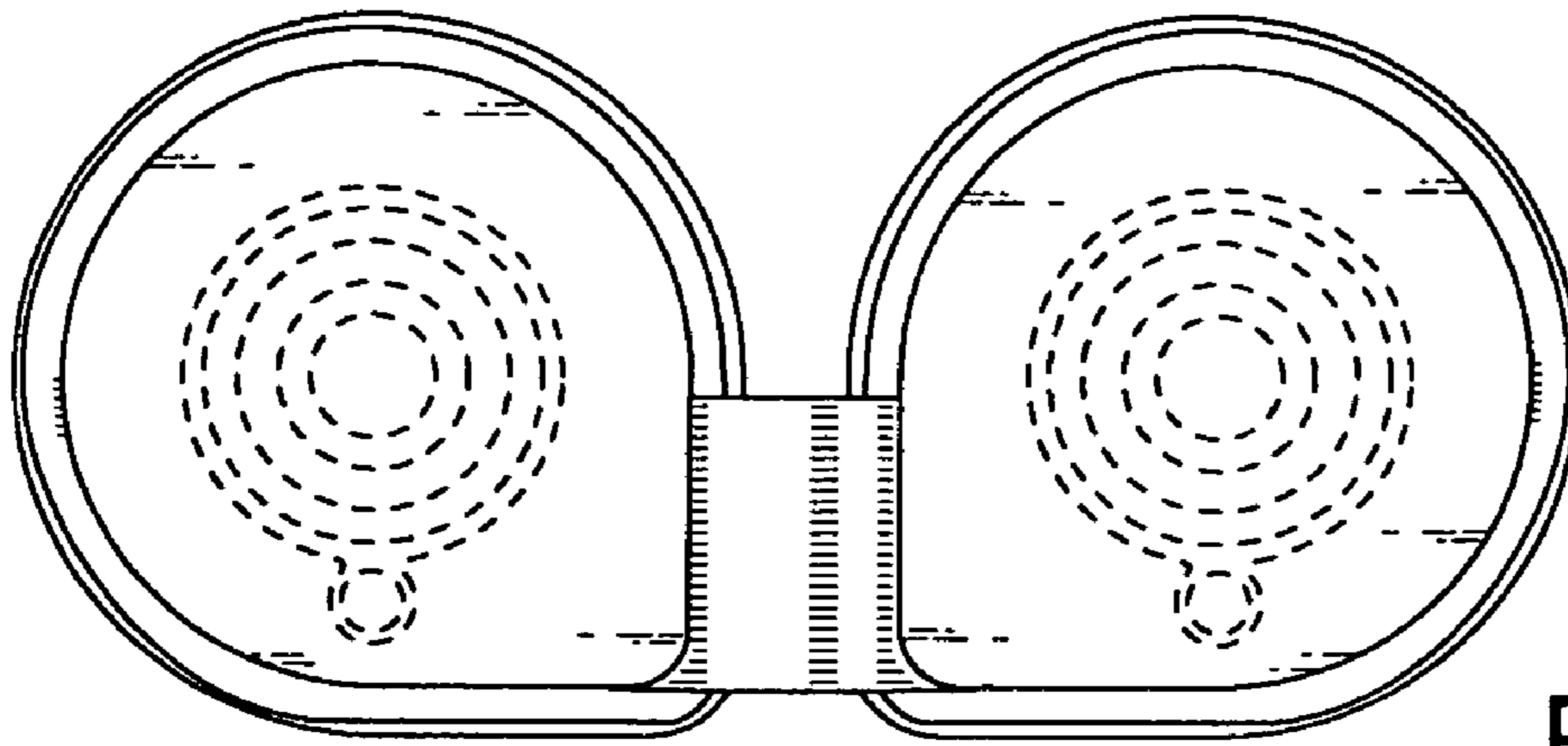

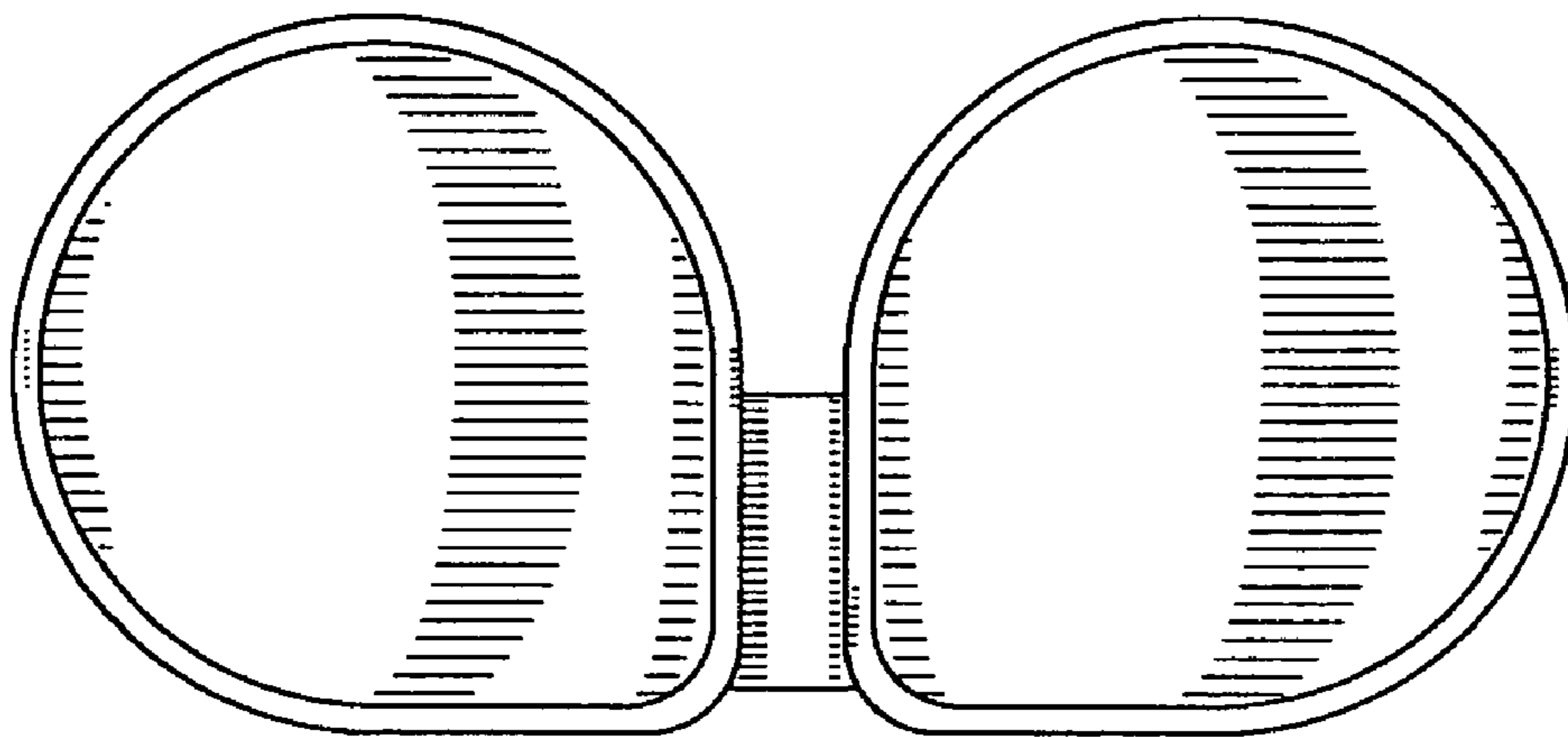

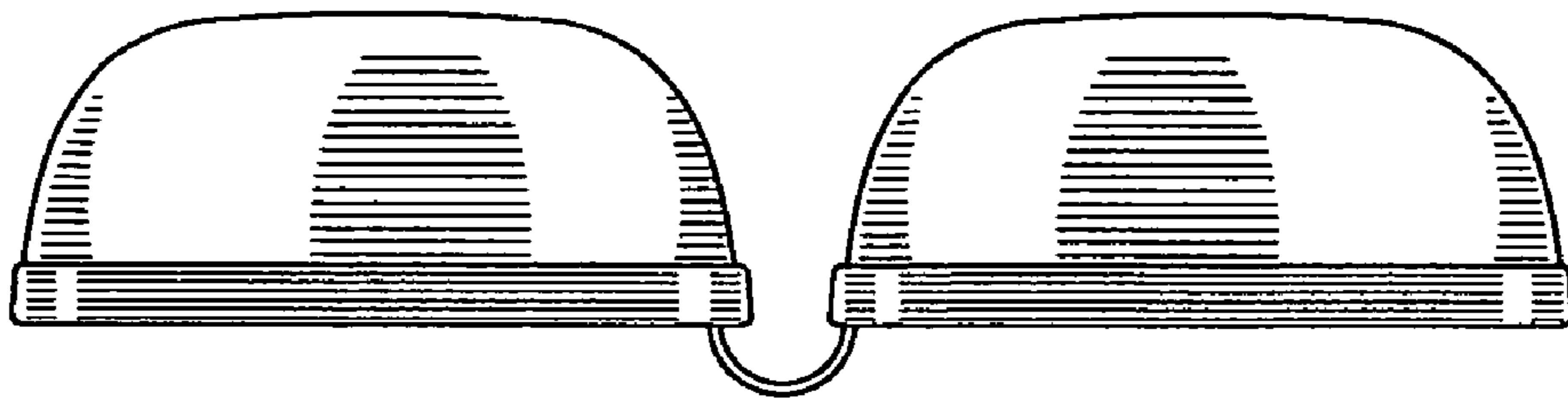

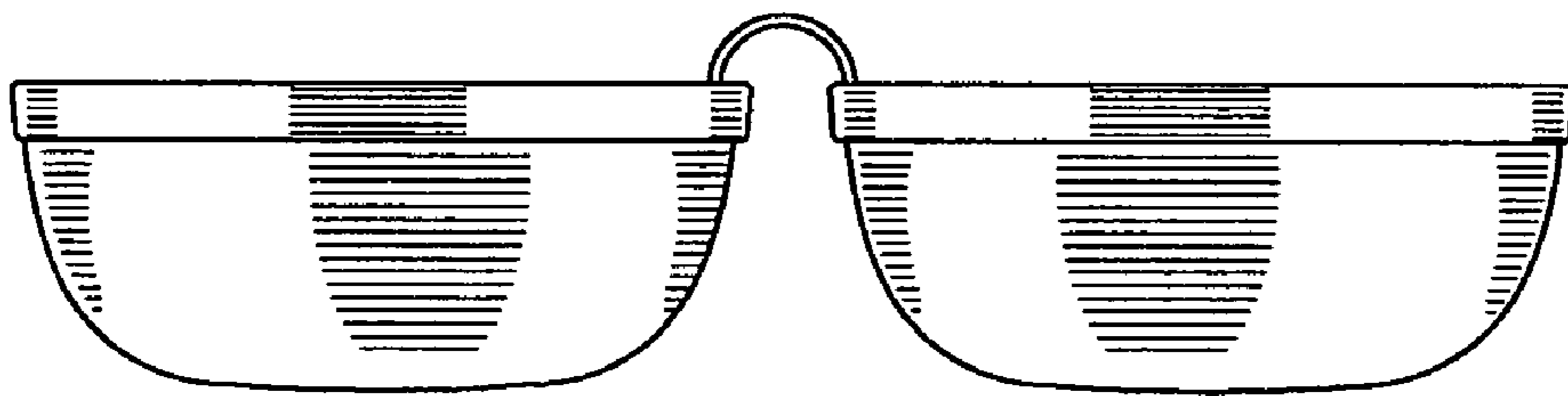

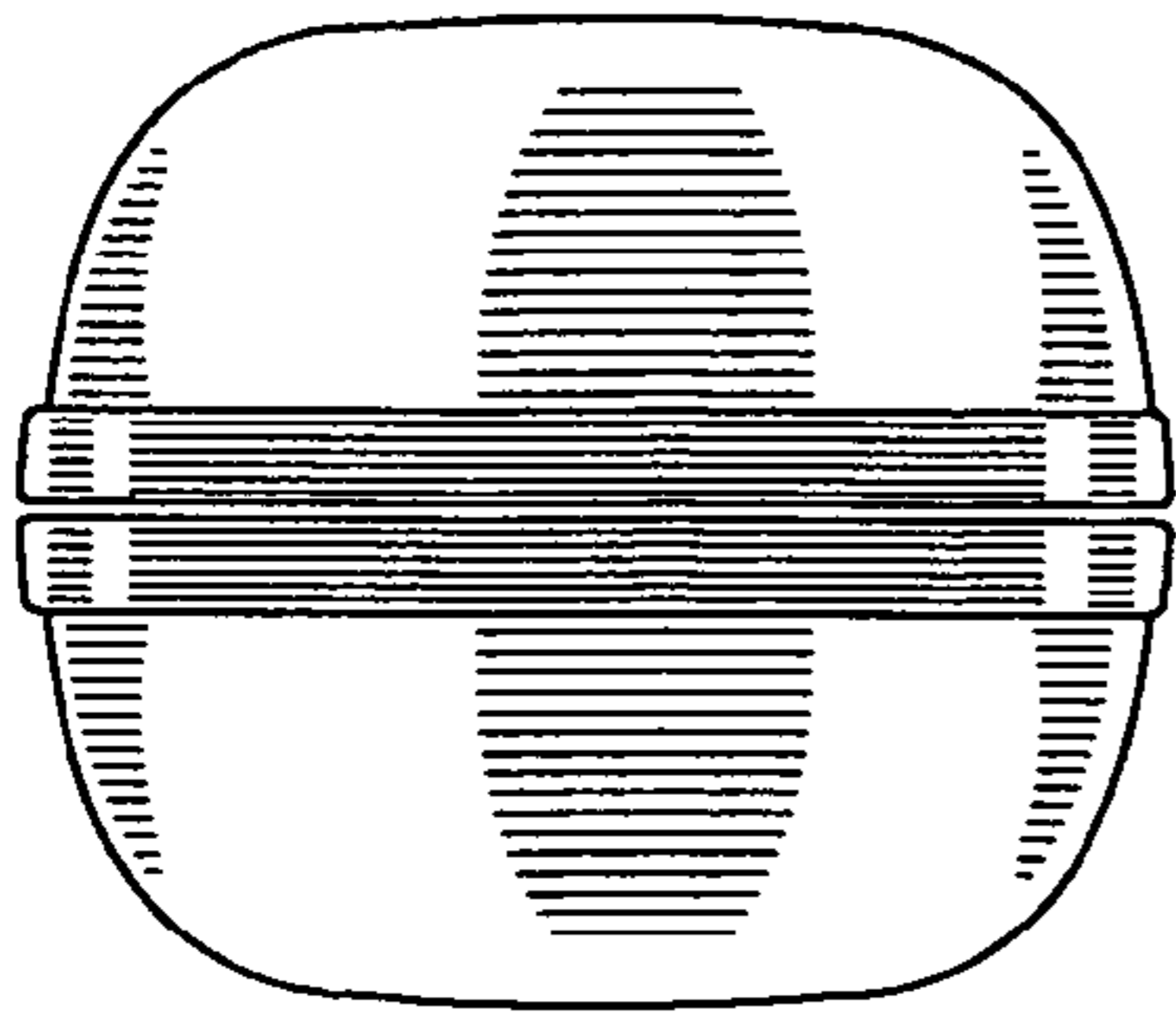

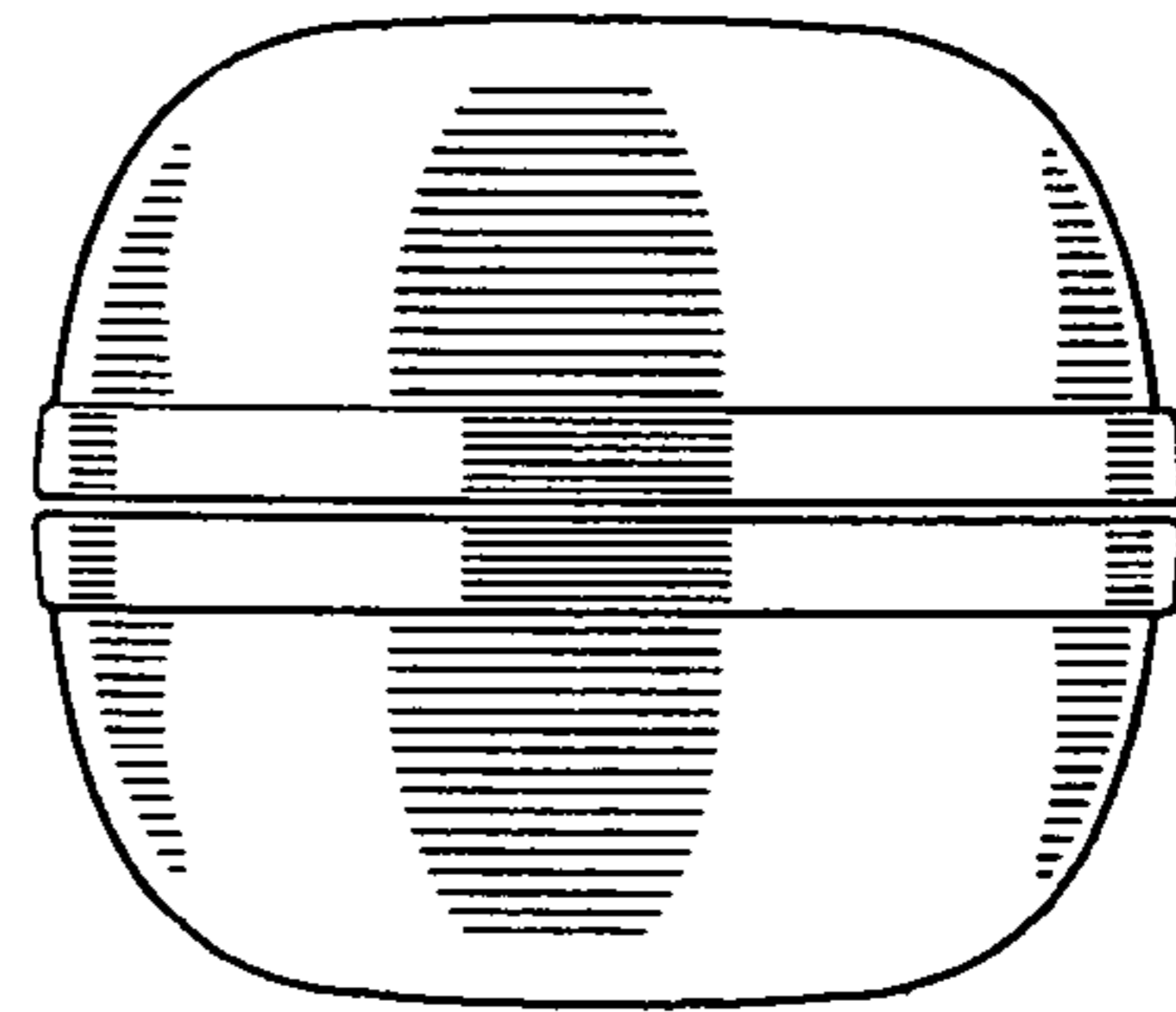

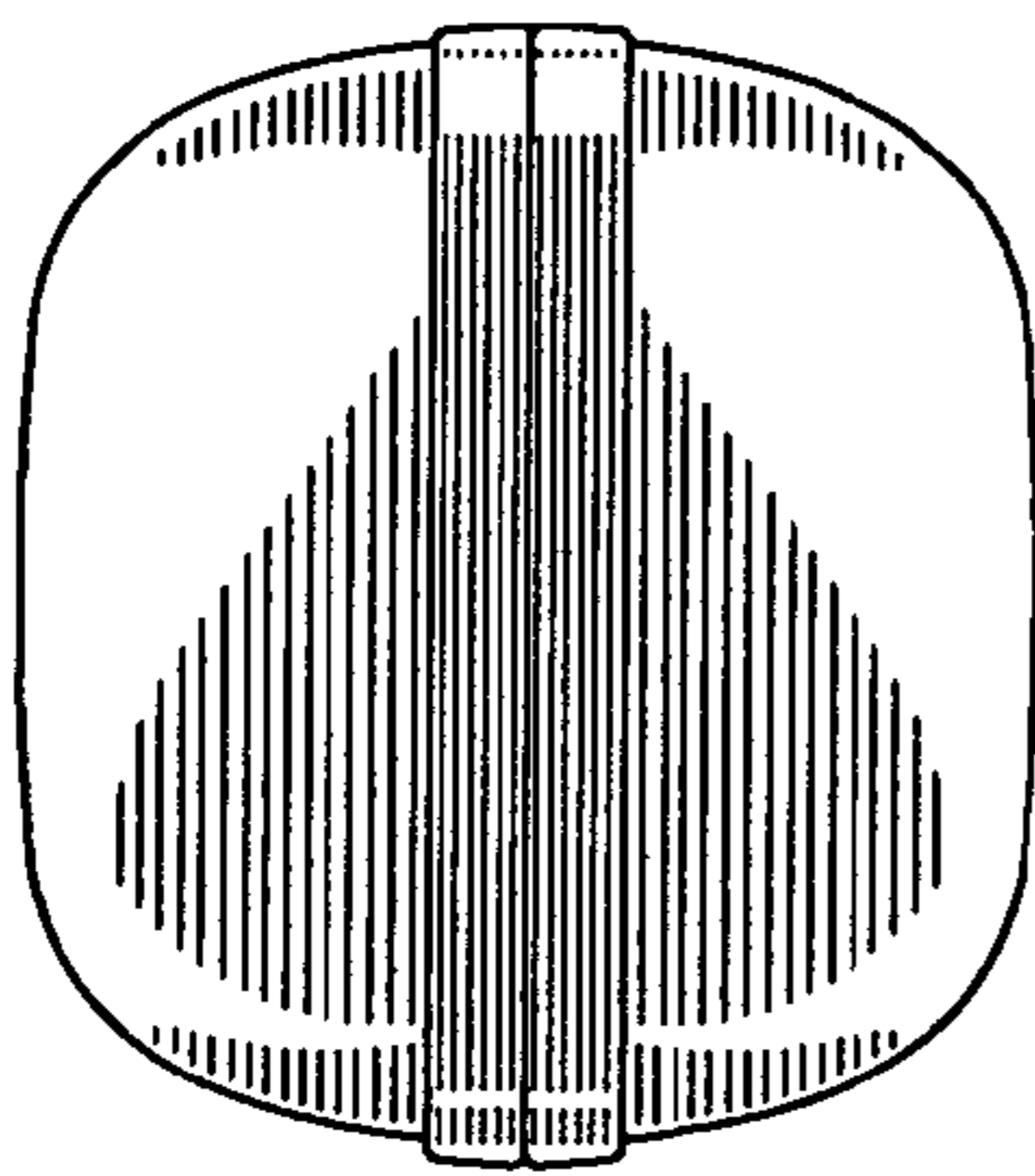

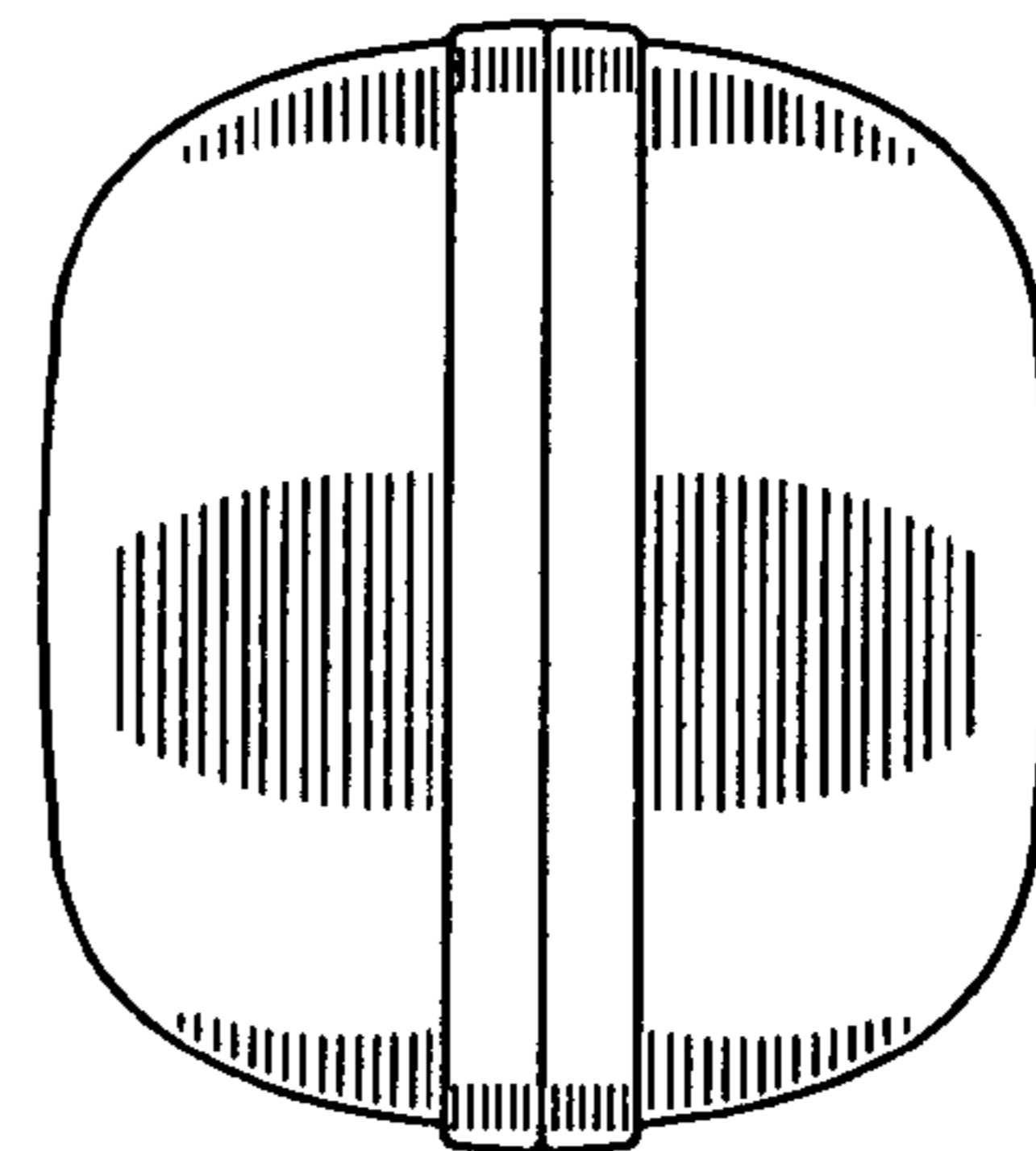

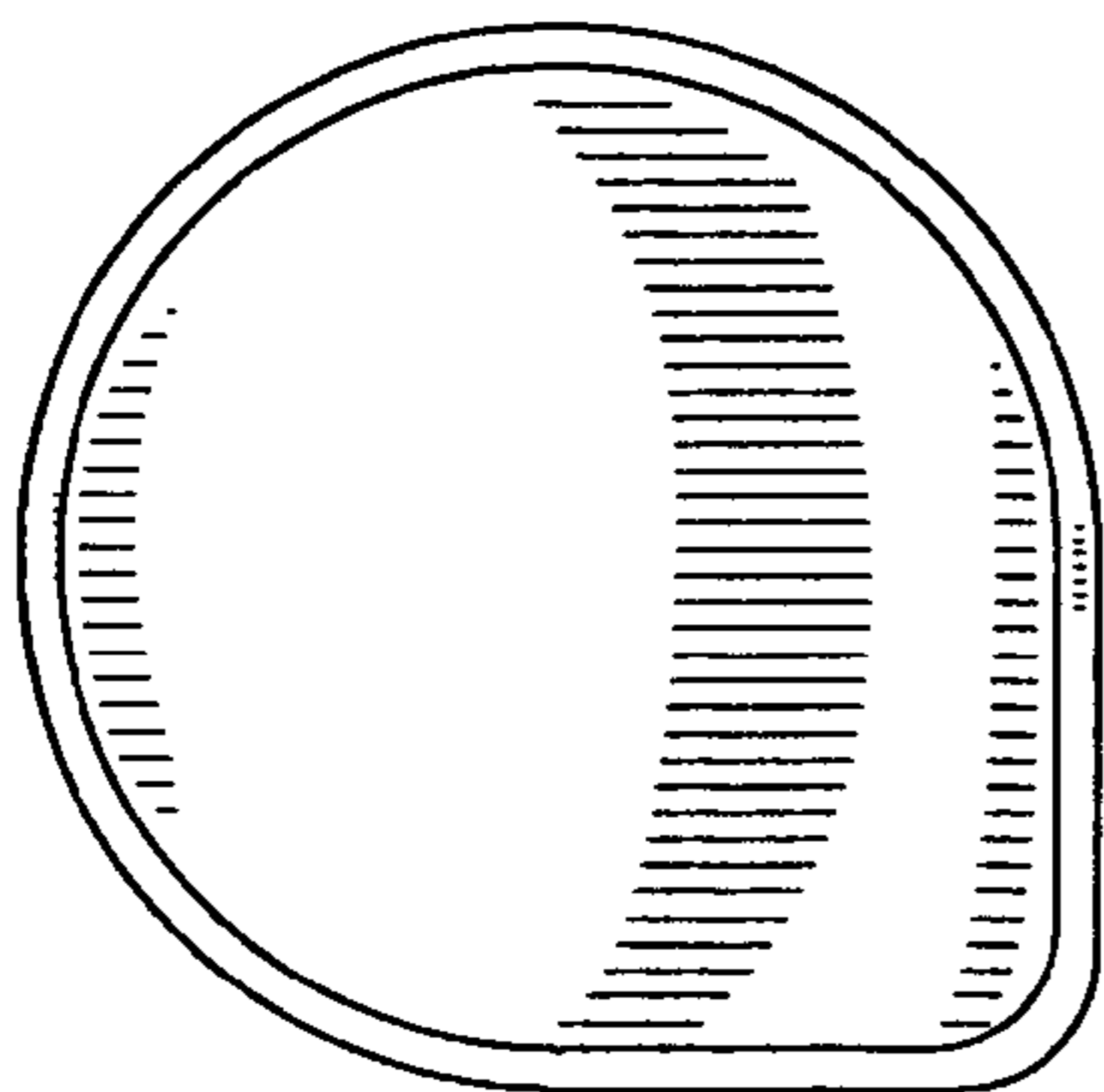

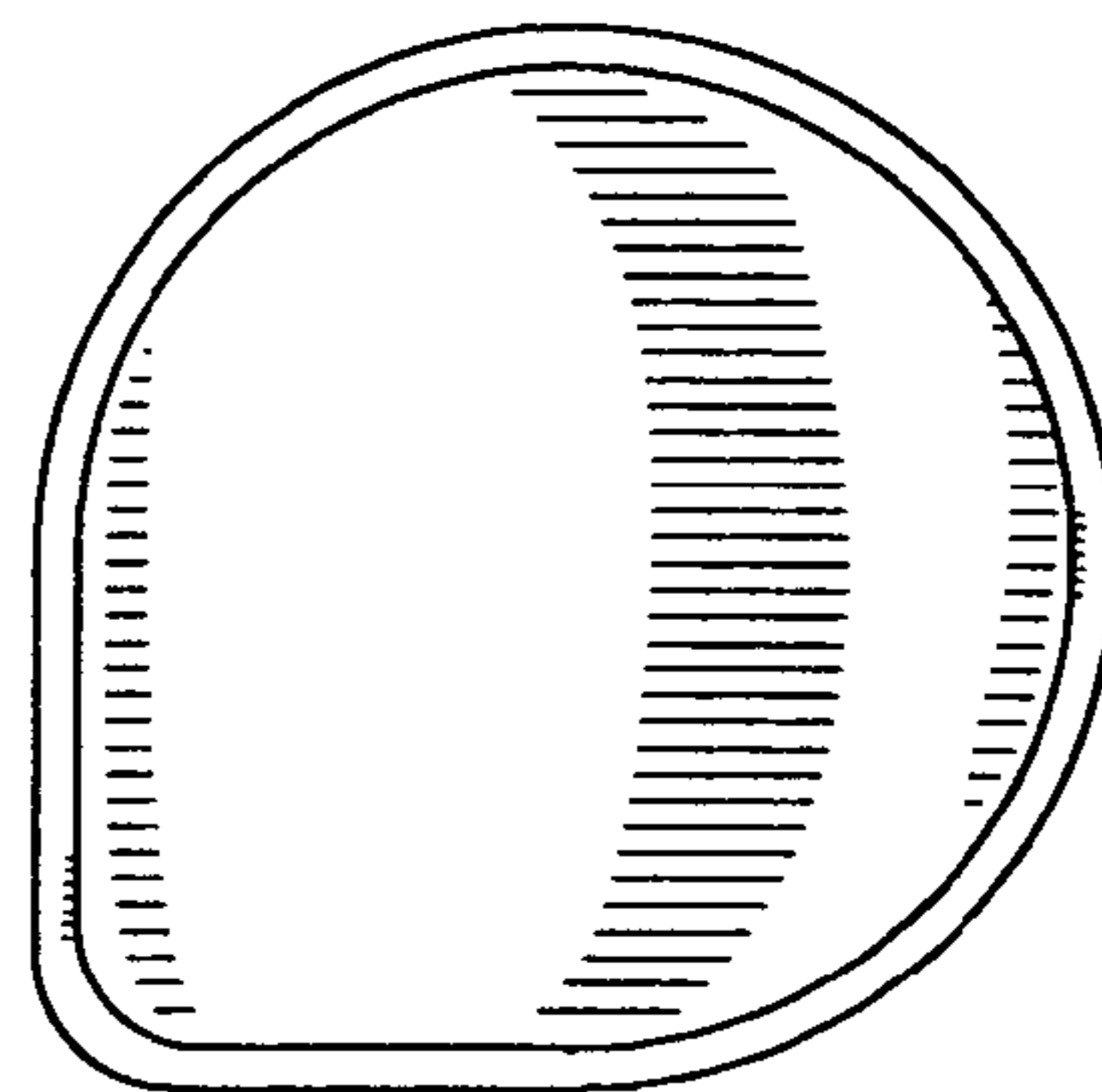
