FIG. 5 is a left side elevational view of the preferred embodiment of the building of the instant invention of FIG. 1;

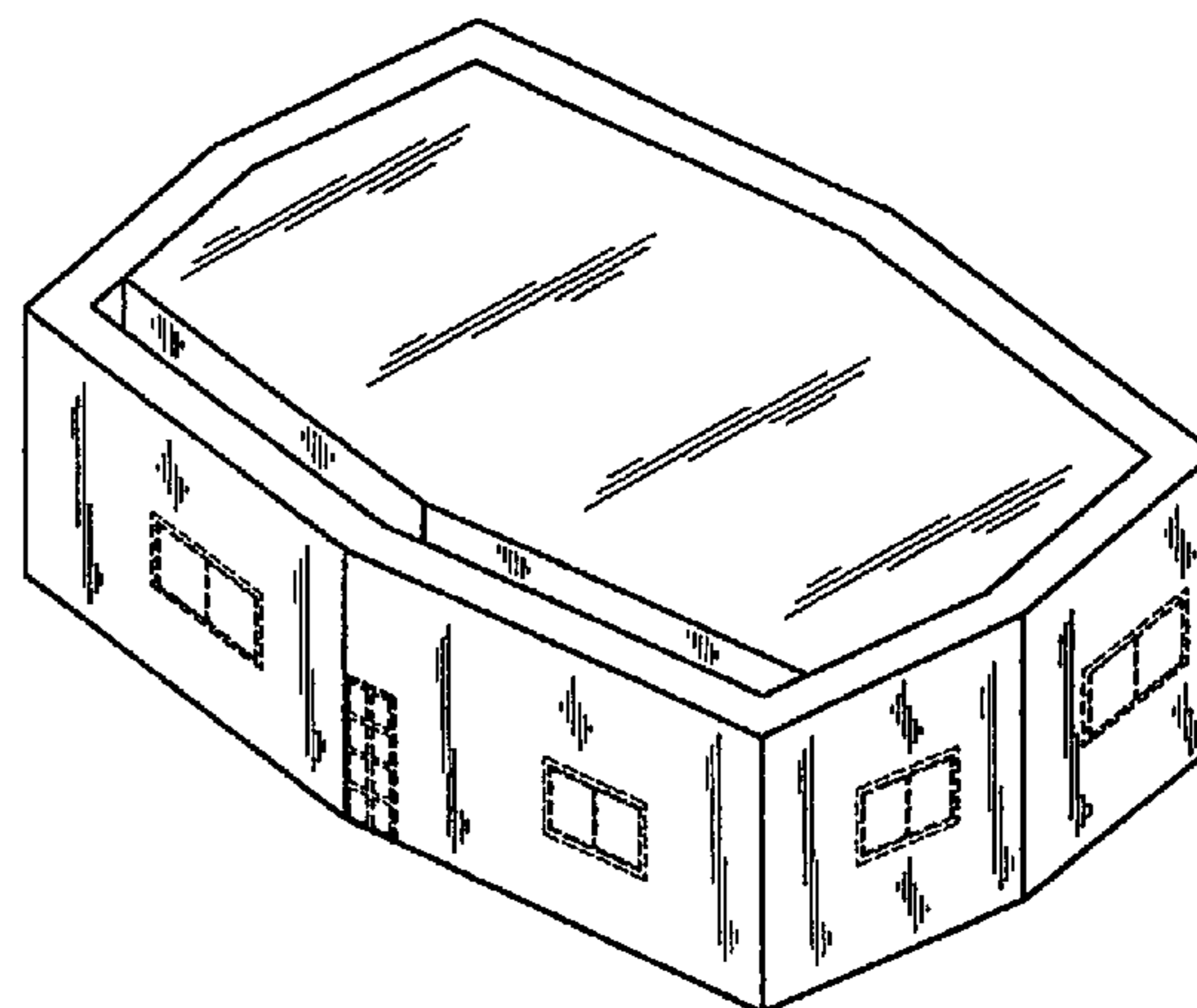
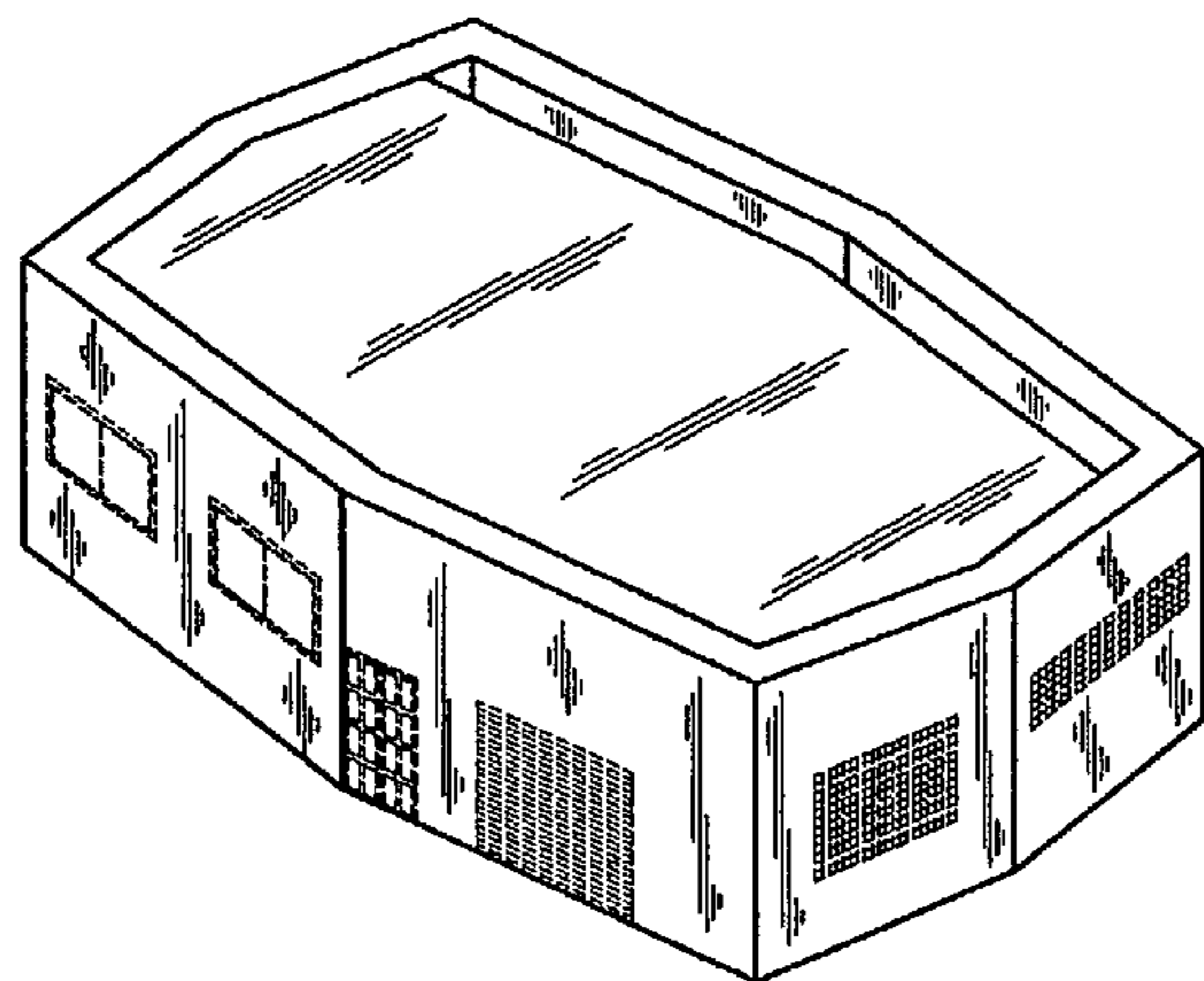
FIG. 6 is a right side elevational view of the preferred embodiment of the building of the instant invention of FIG. 1;

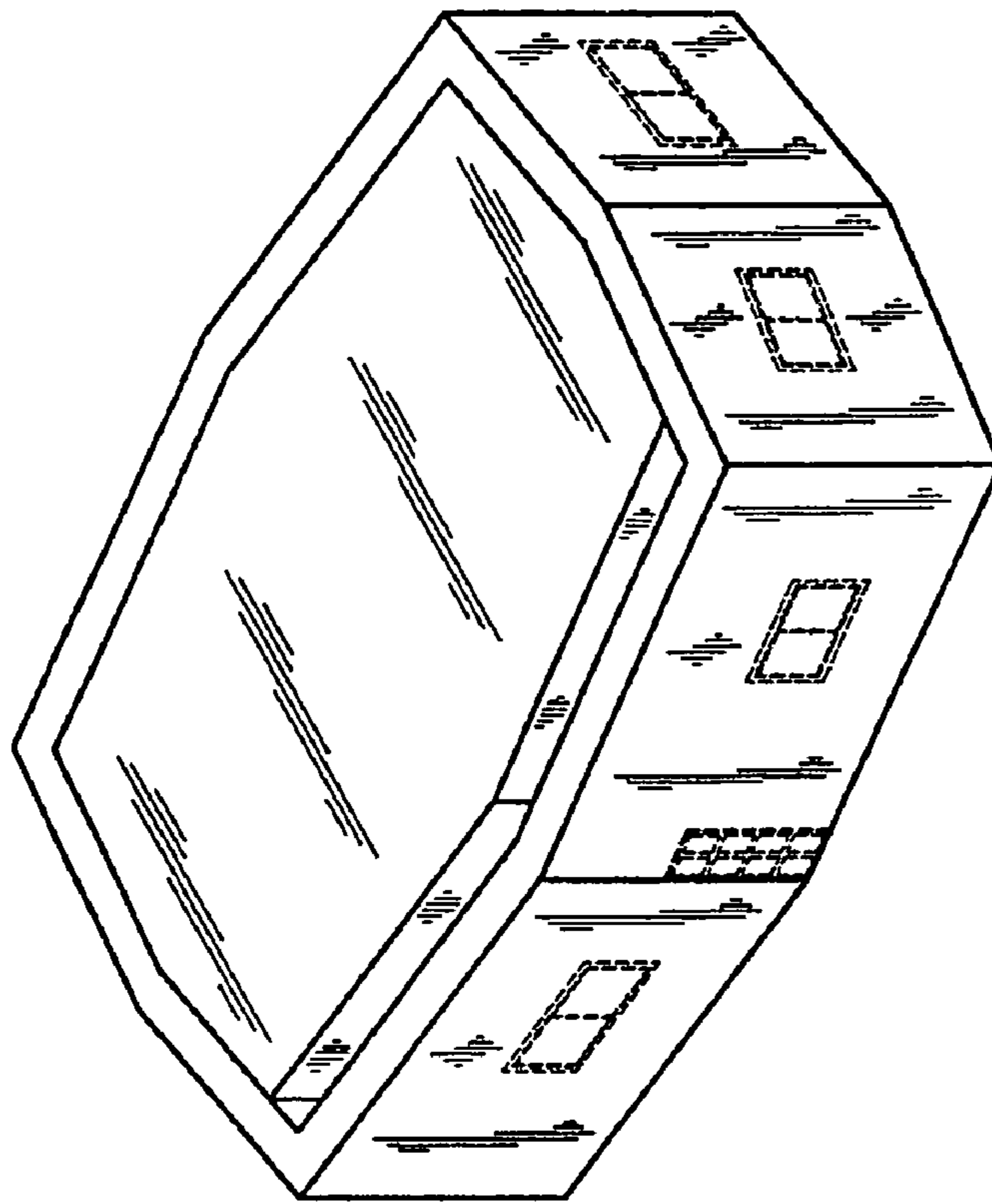

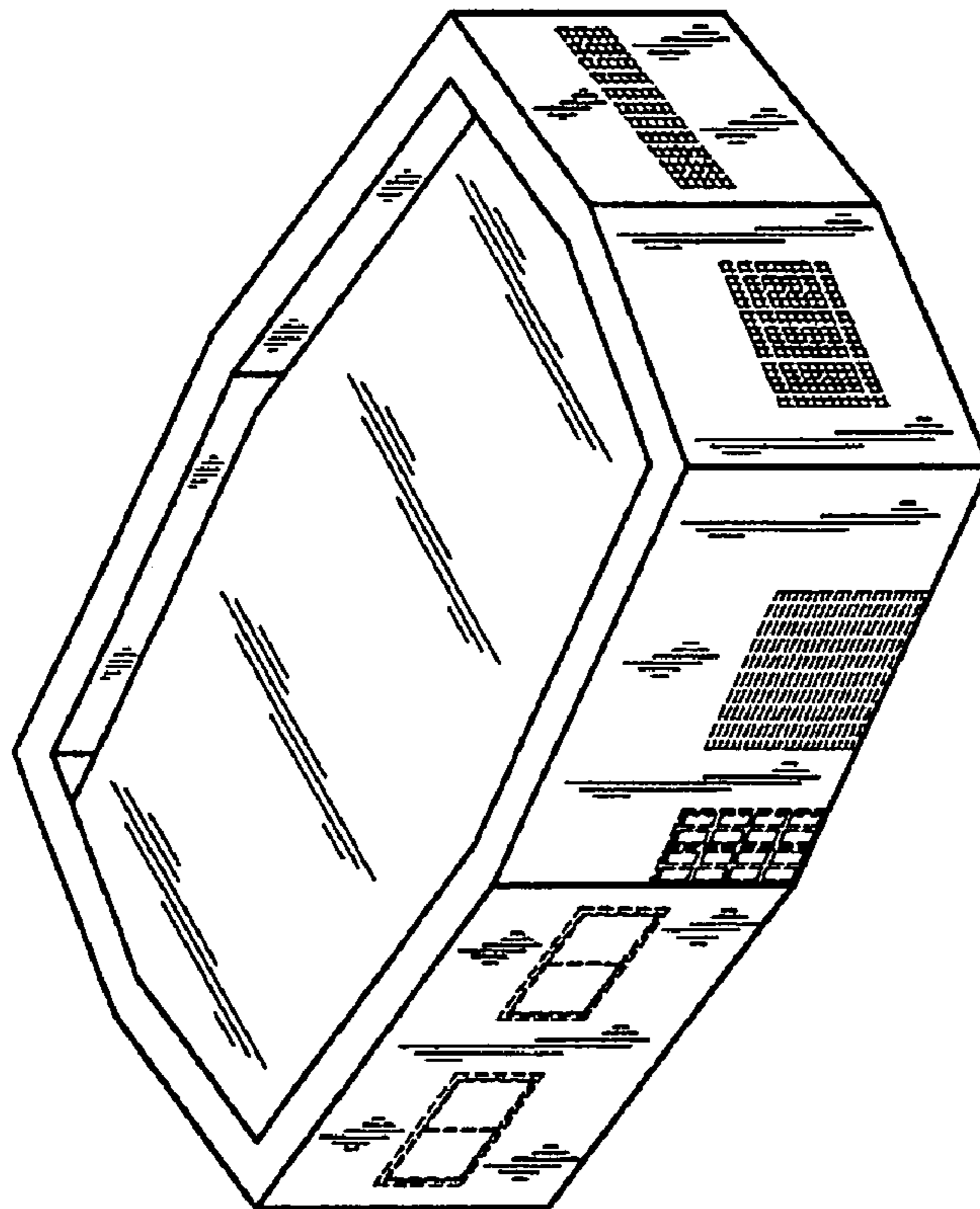

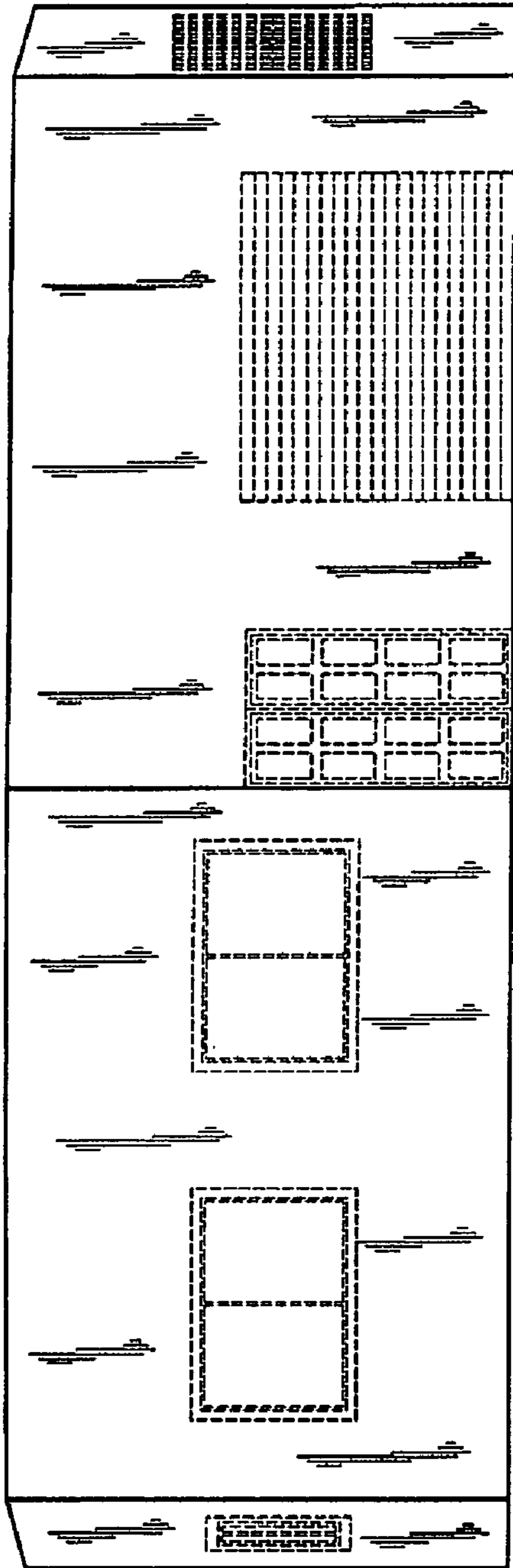

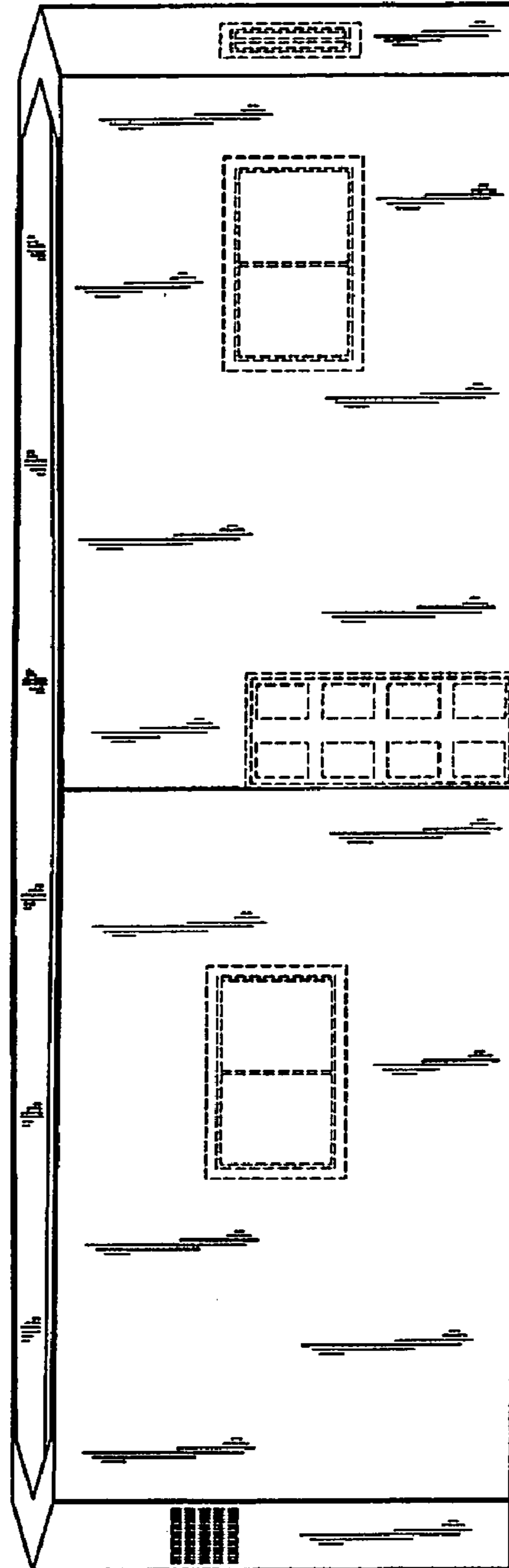

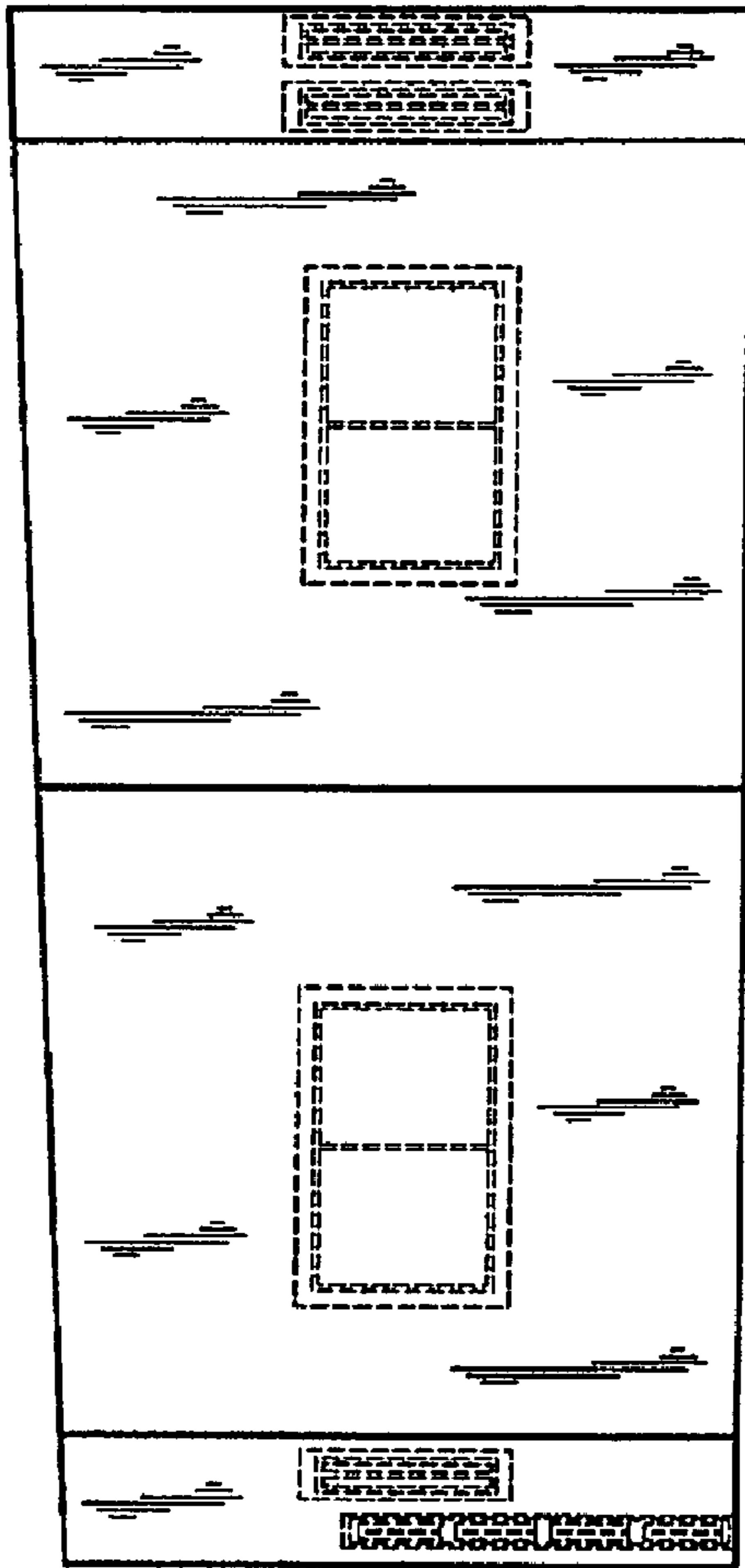

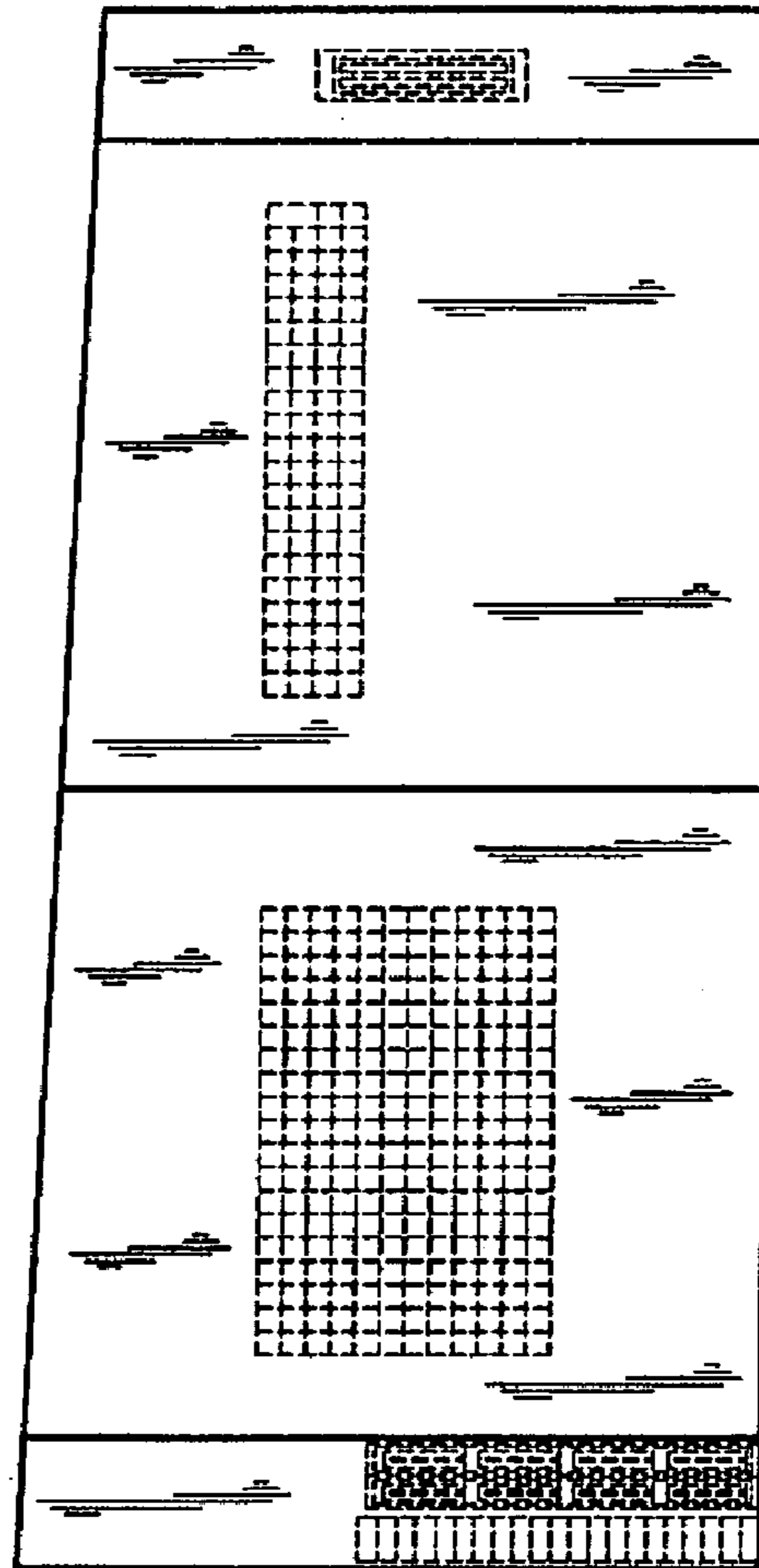

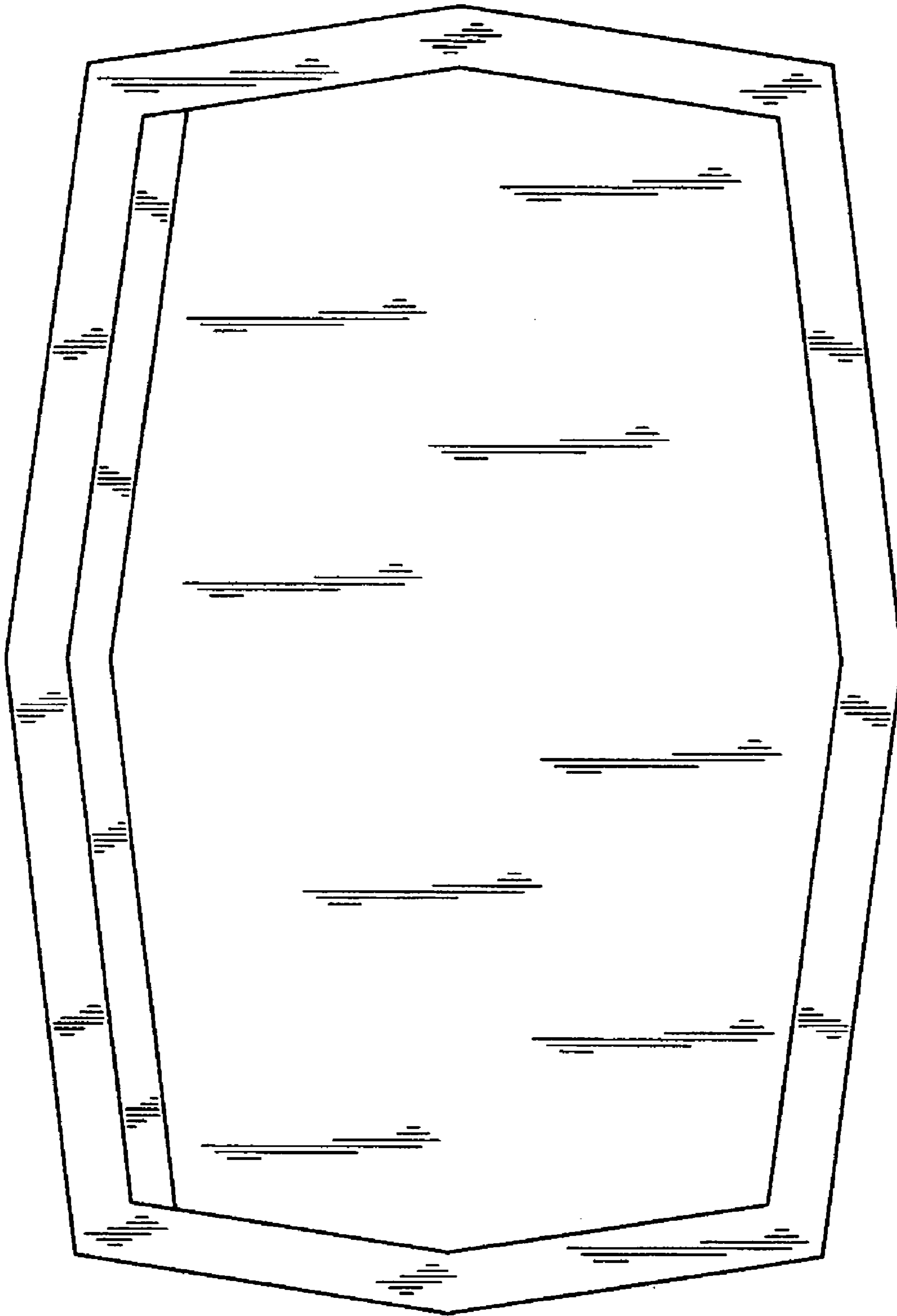

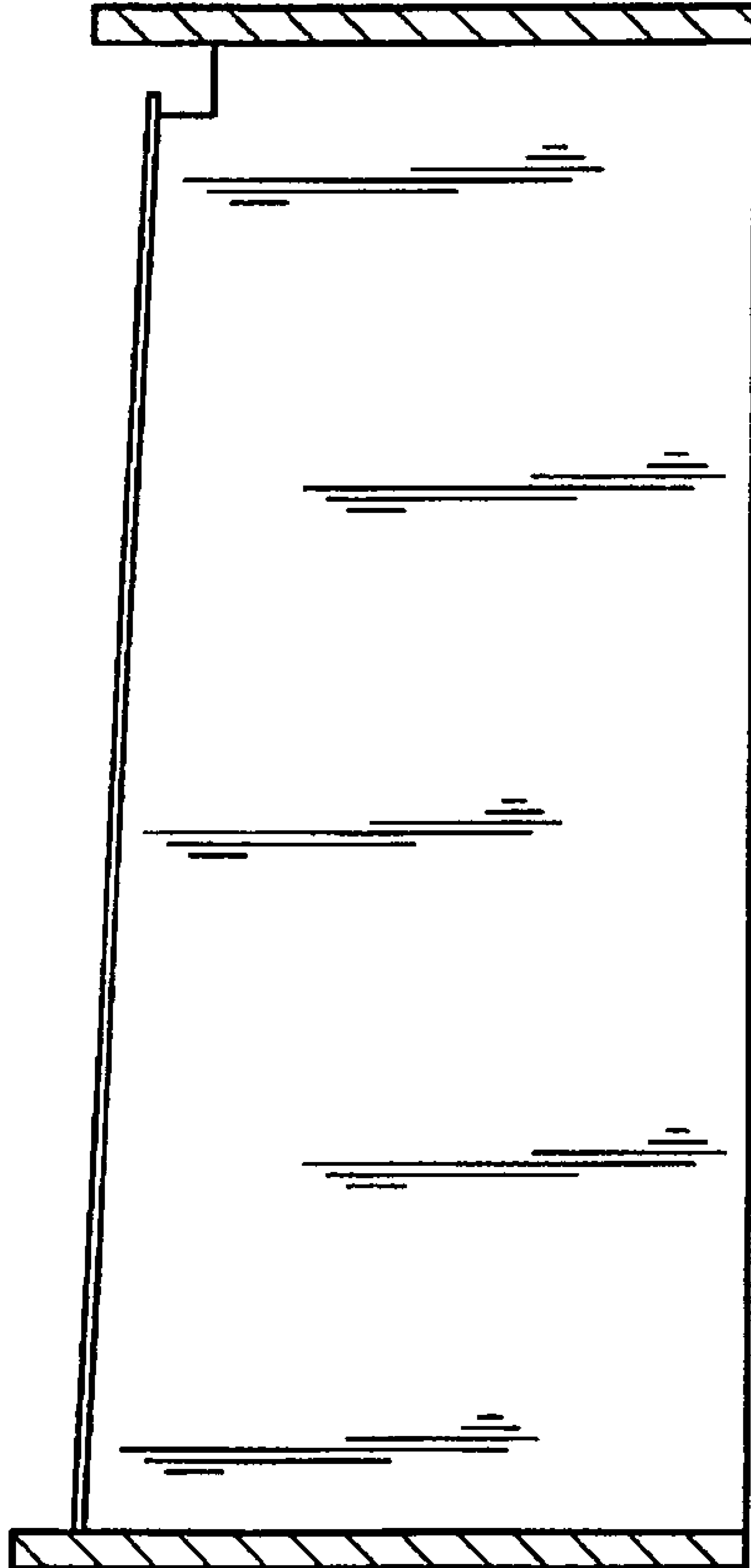
