**DESCRIPTION**

light of FIG. 1;

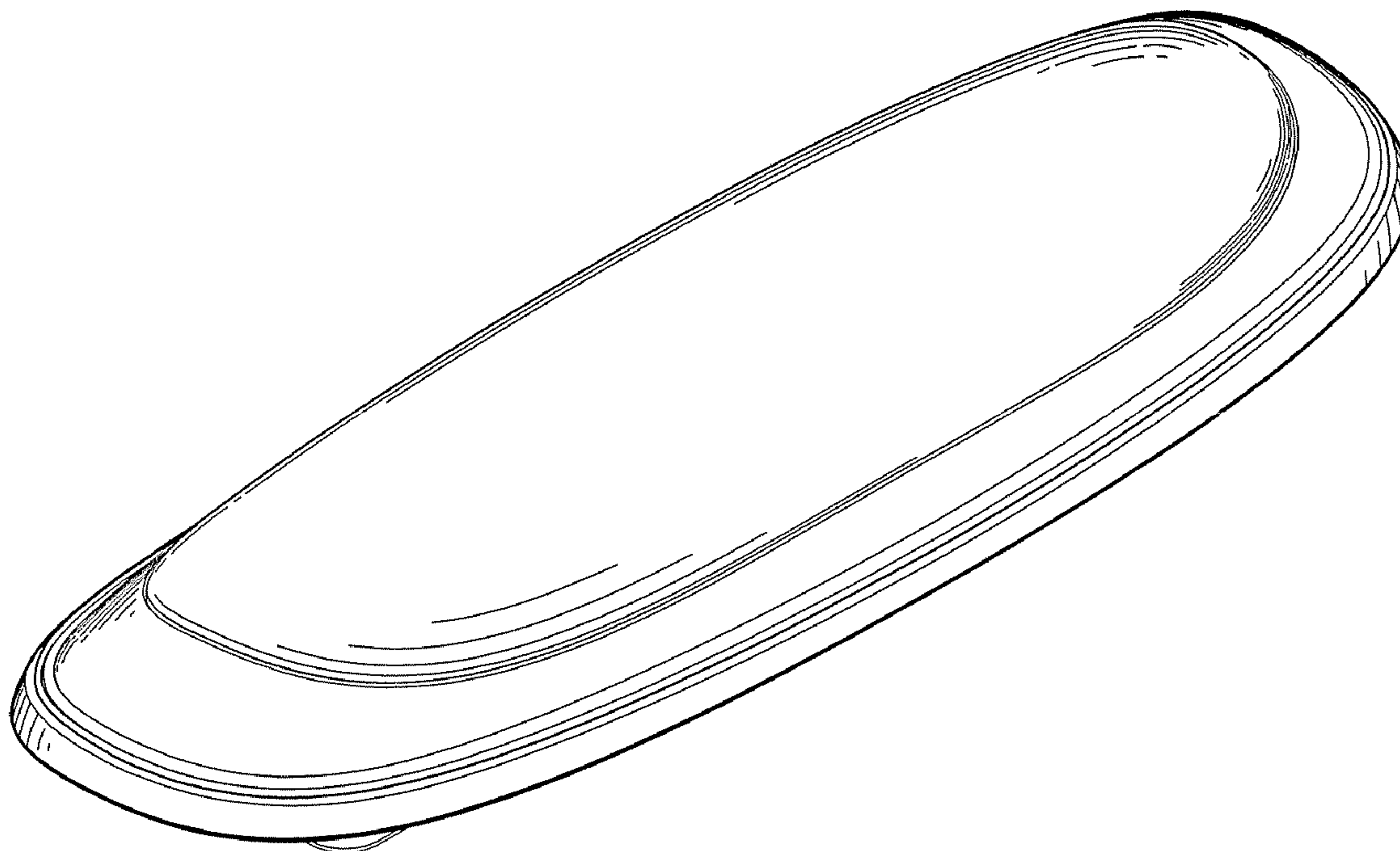
FIG. 6 is a front elevational view of the vehicle interior light  
of FIG. 1;

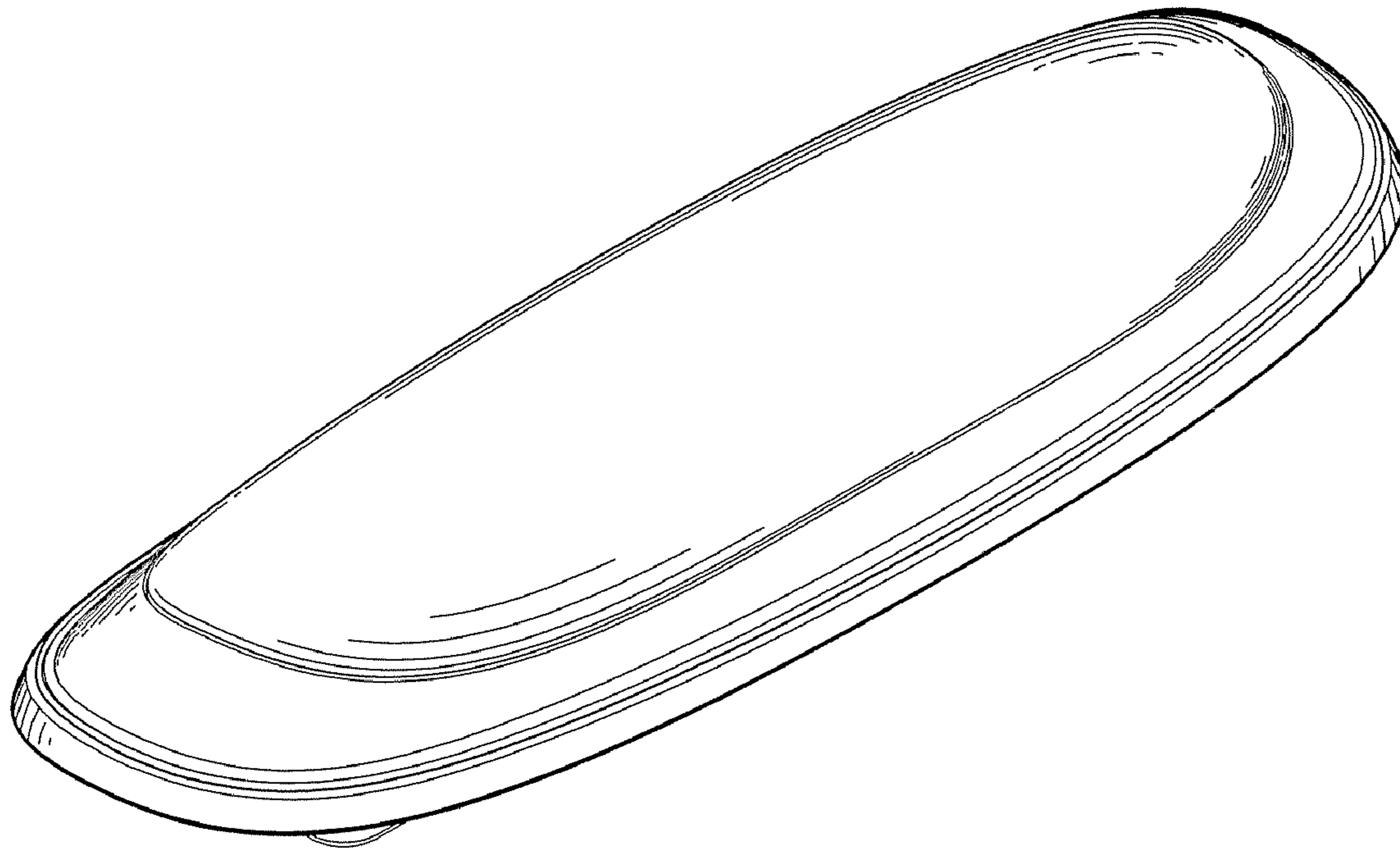
FIG. 7 is a left side elevational view of the vehicle interior

of FIG. 1.

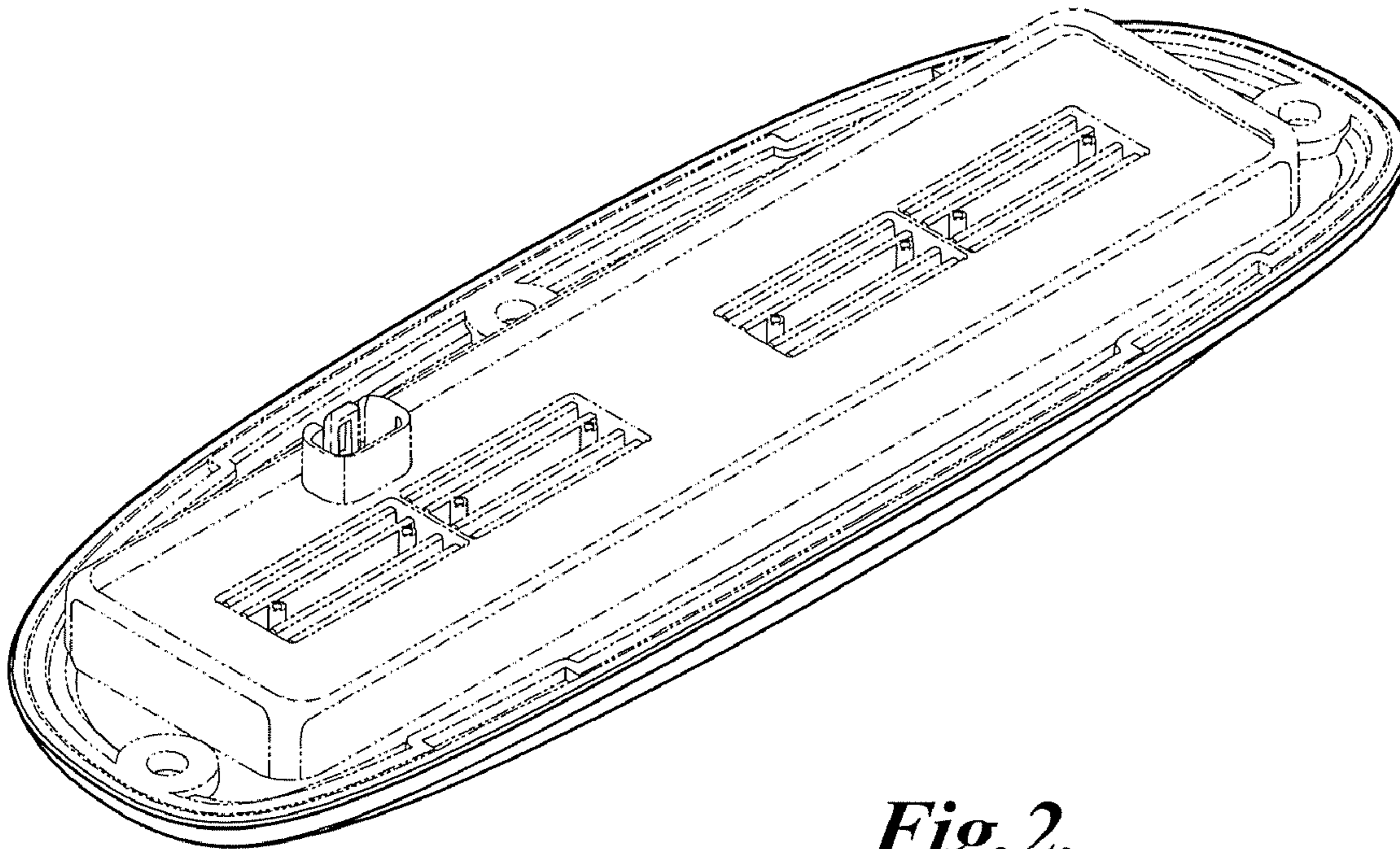

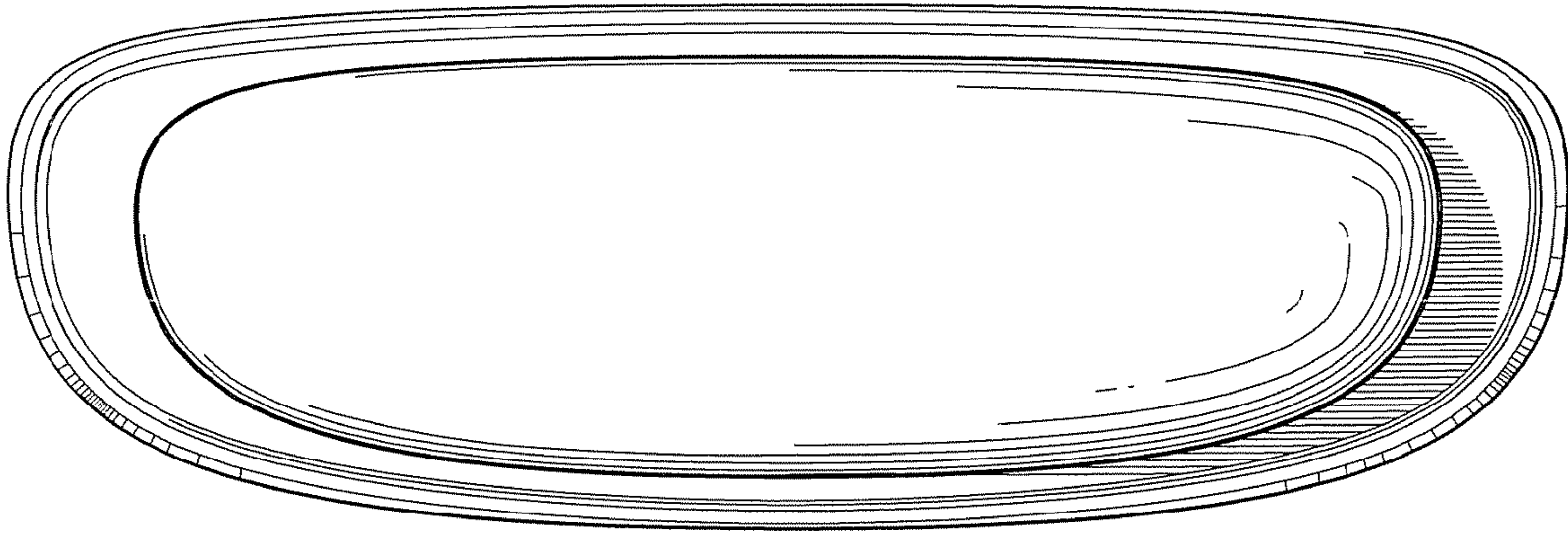




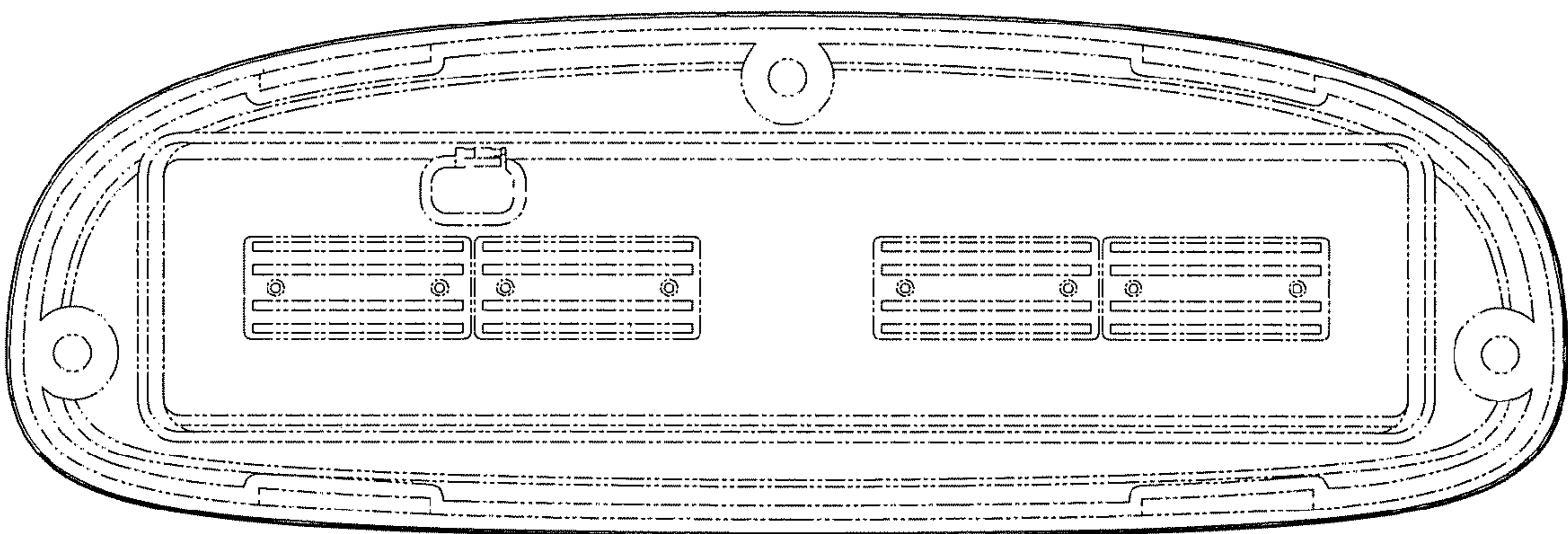

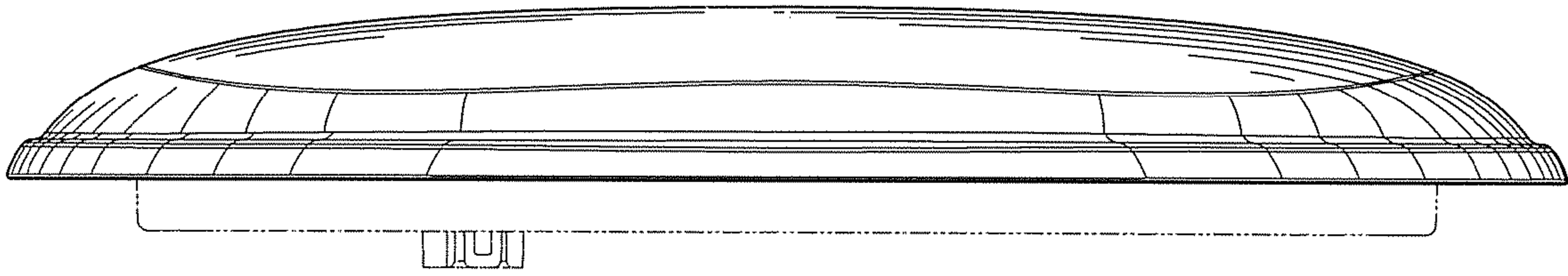

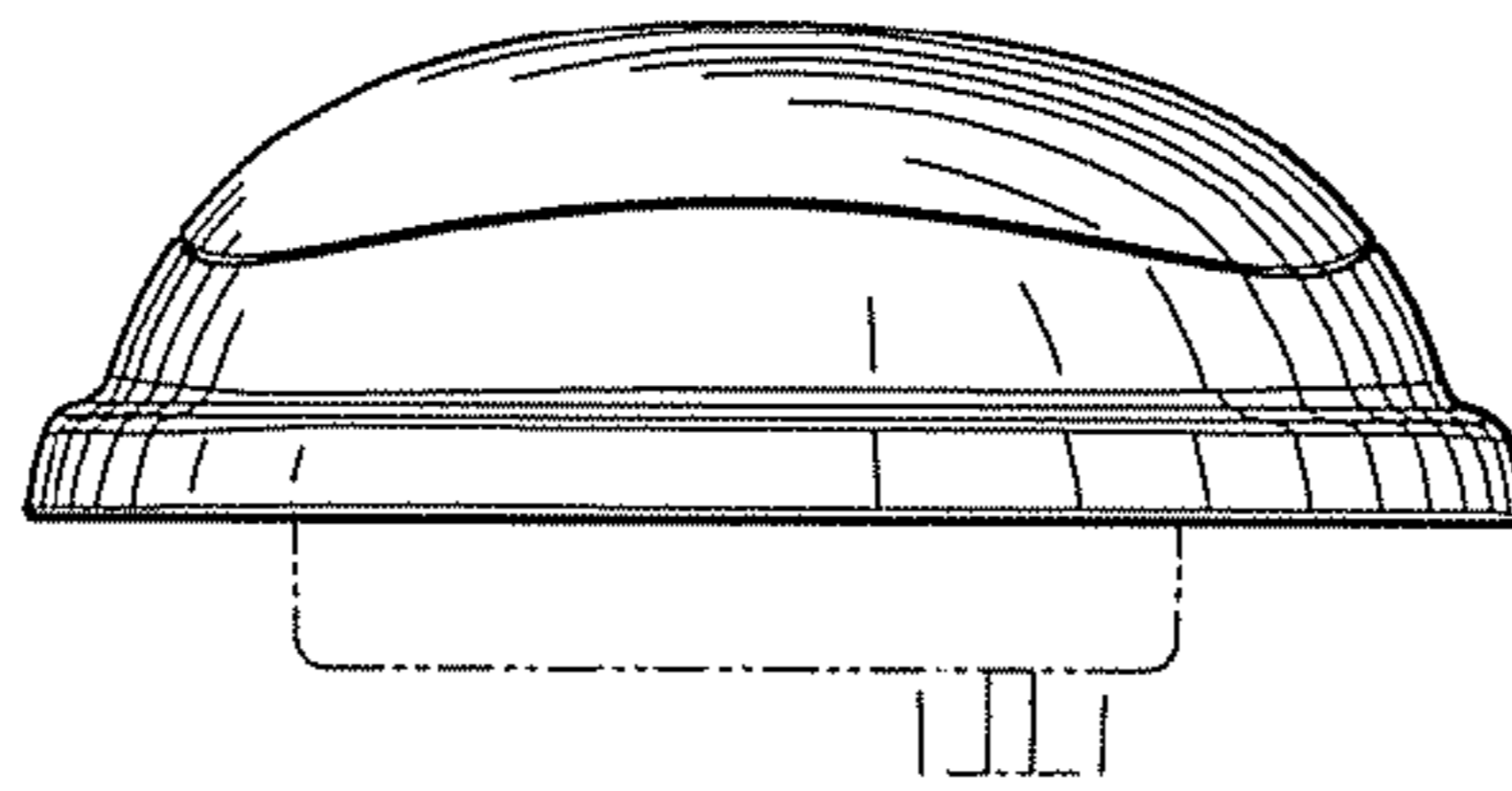

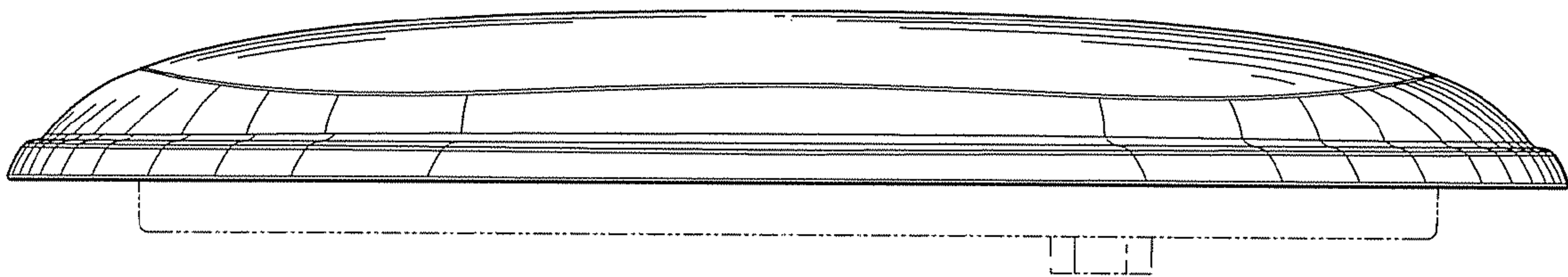




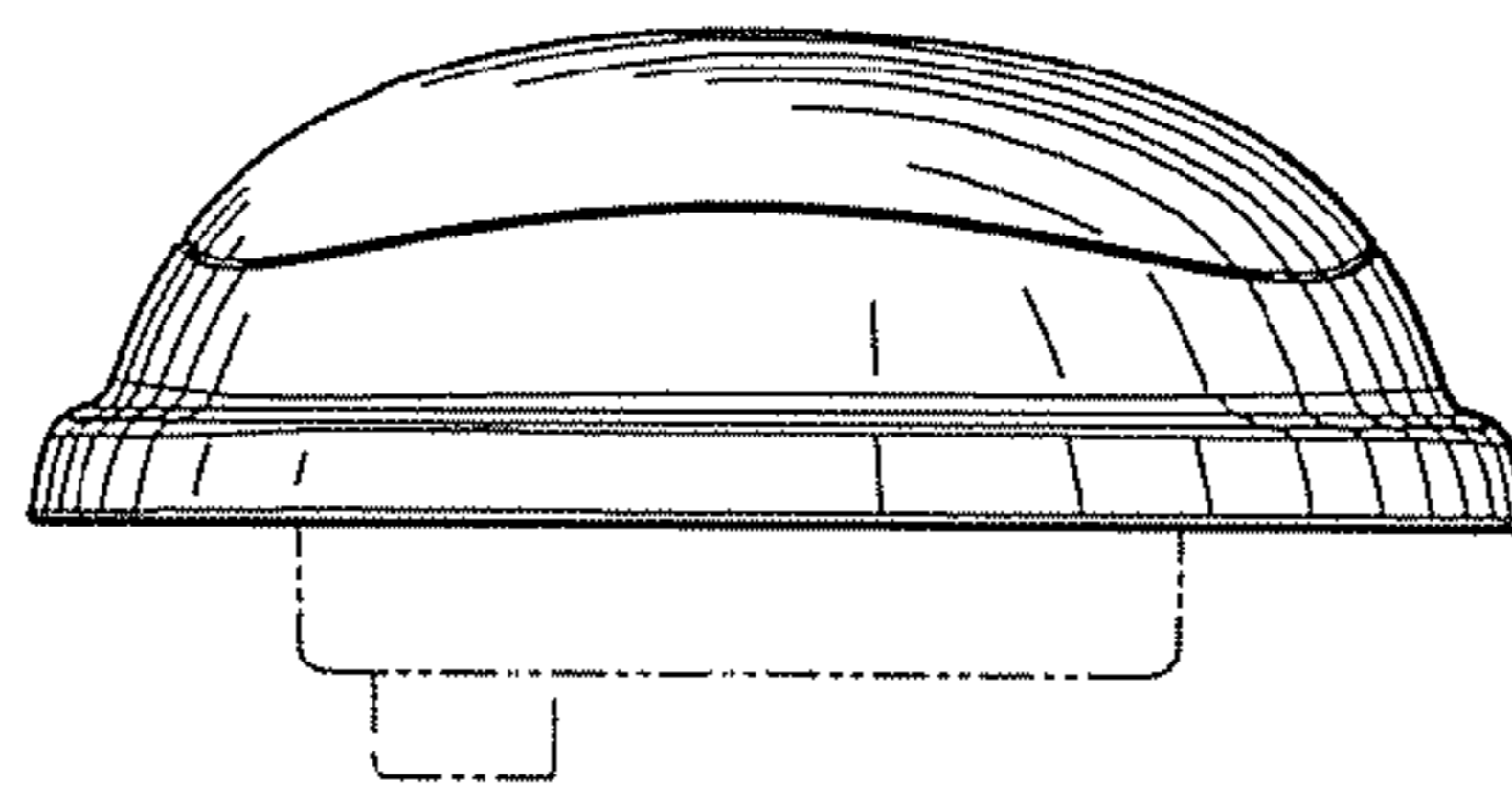
