FIG. 3 is a left side view thereof, the right side view being a mirror image;

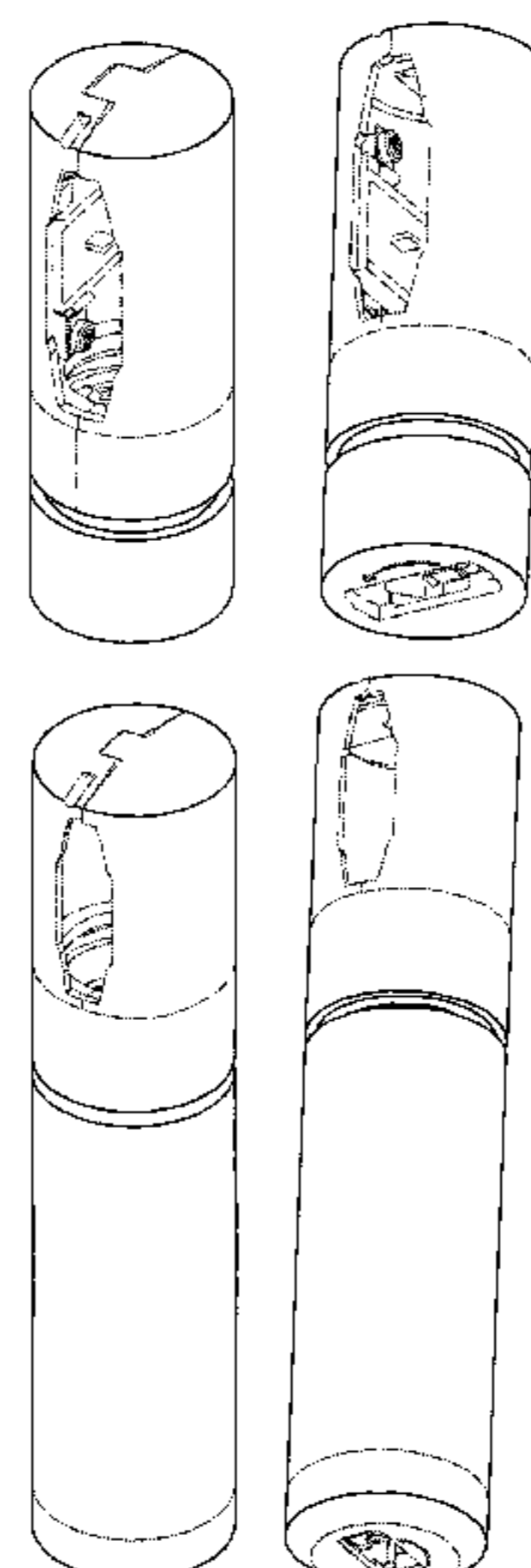
FIG. 4 is a top, front perspective view of a second embodiment of a track adaptor showing our new design;

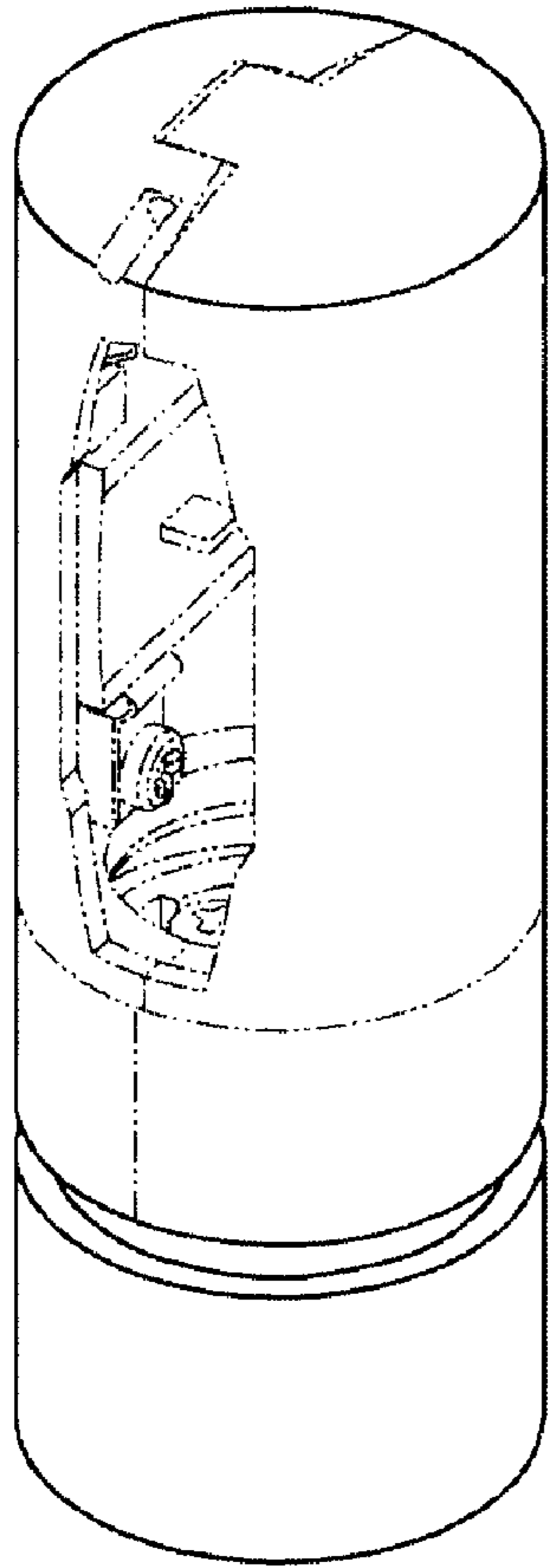

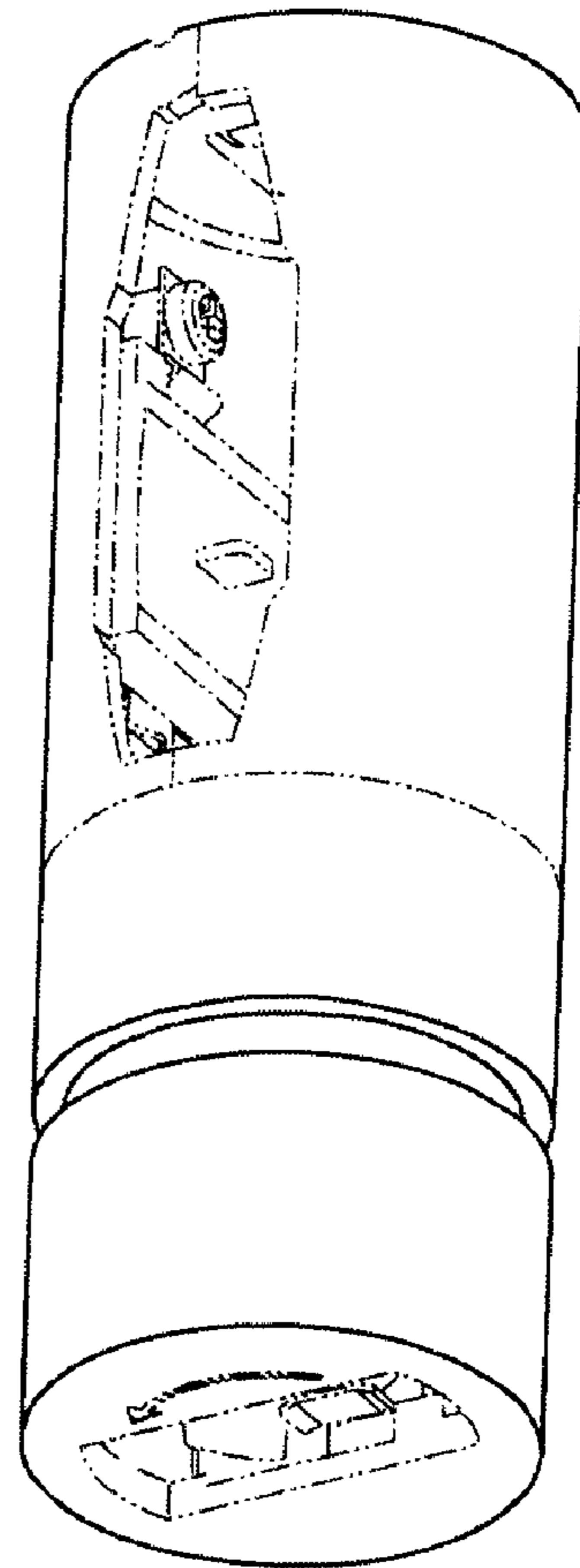

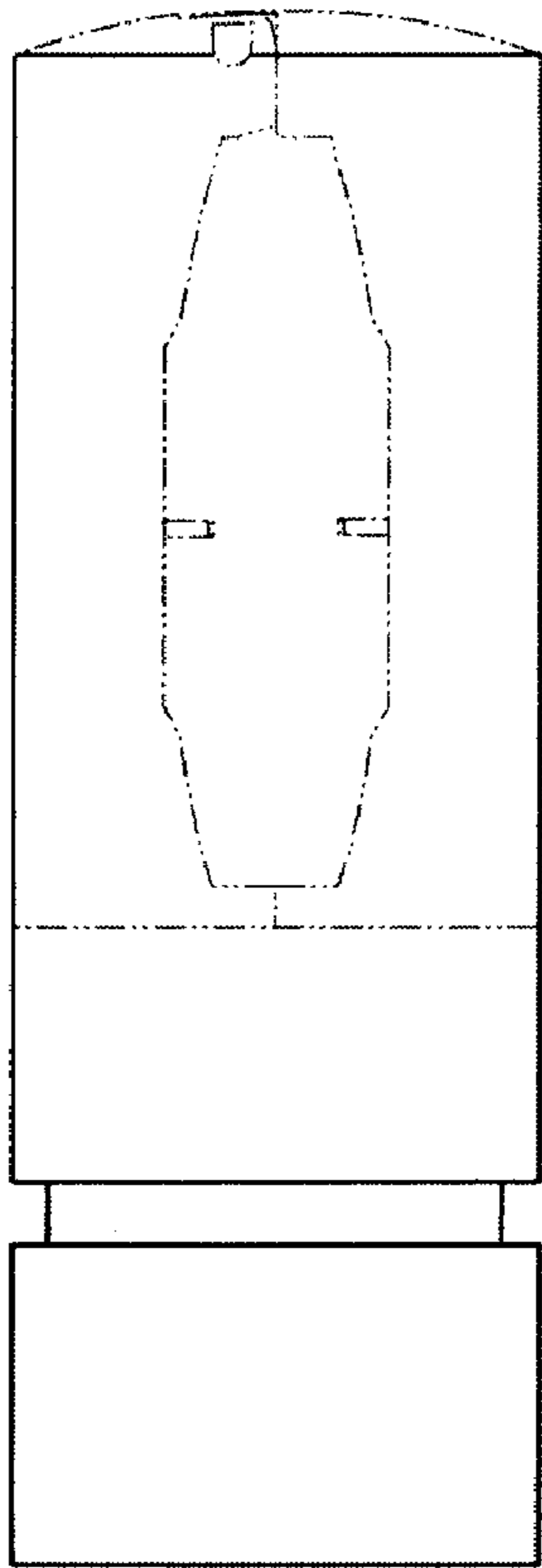

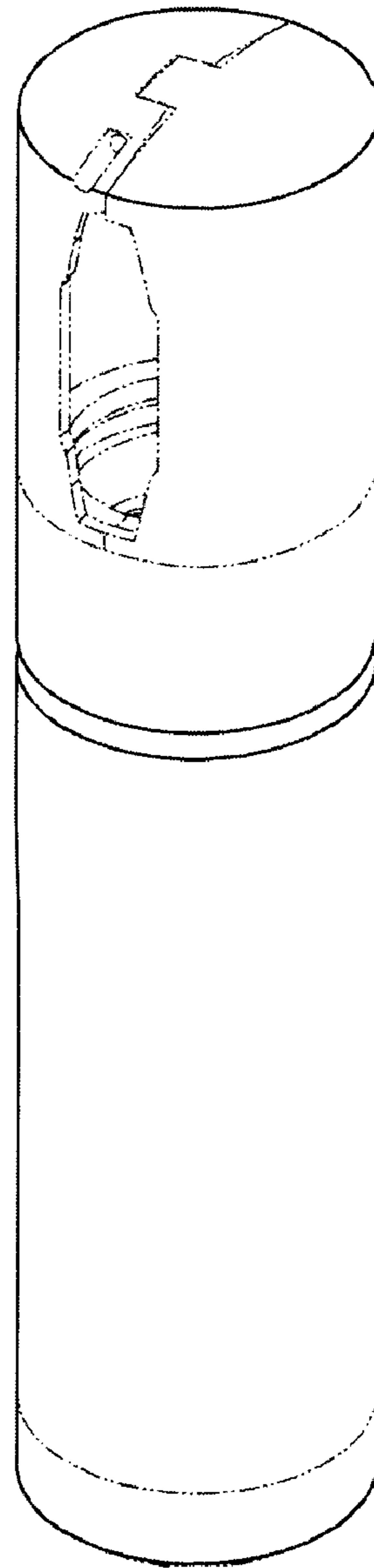

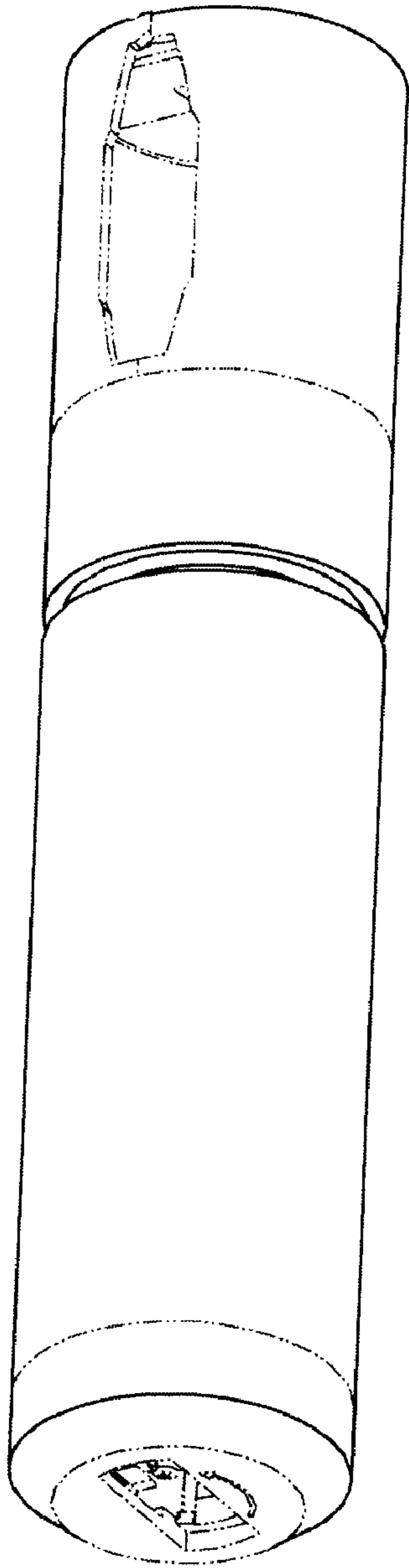

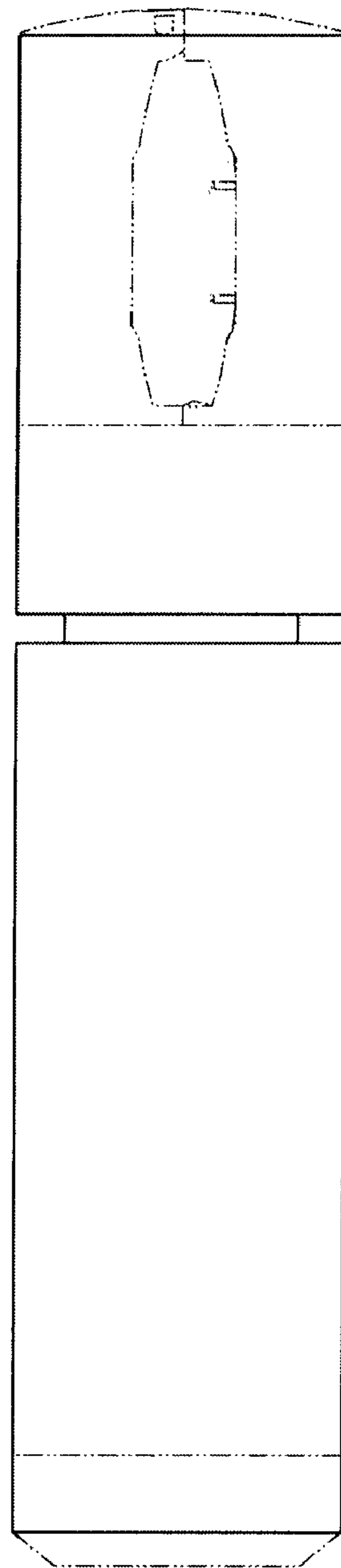
